FIG. 4 is a back elevational view thereof;

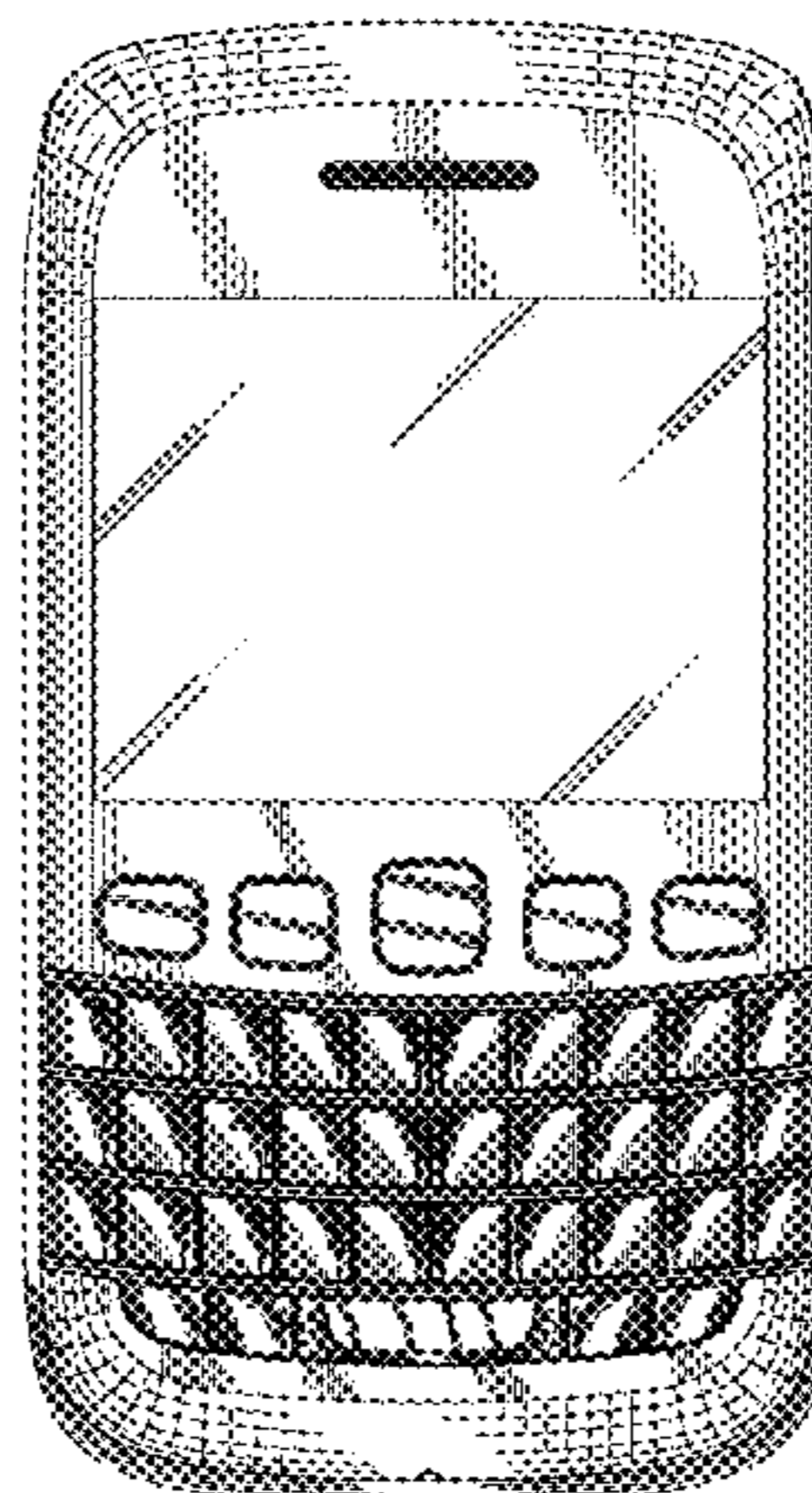
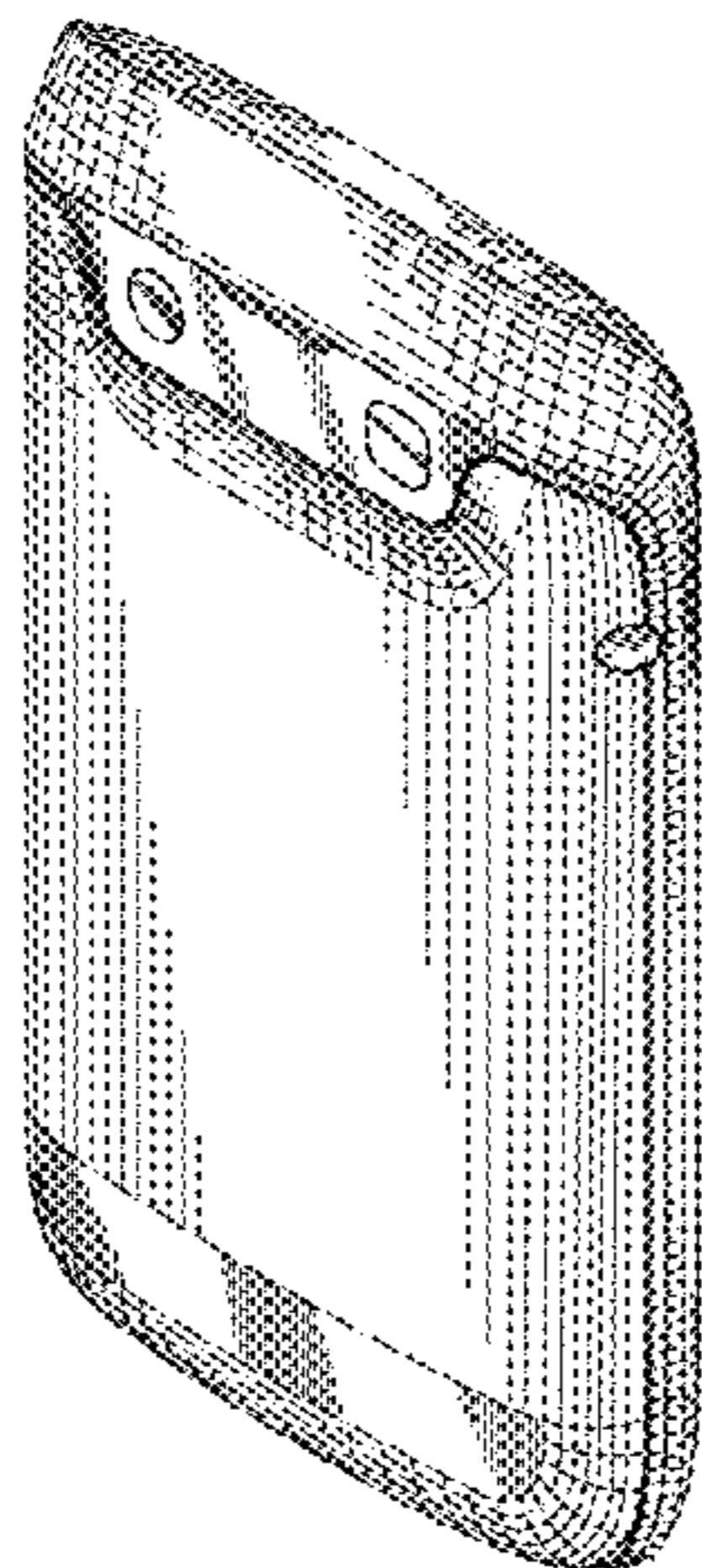
FIG. 5 is a right elevational view thereof;

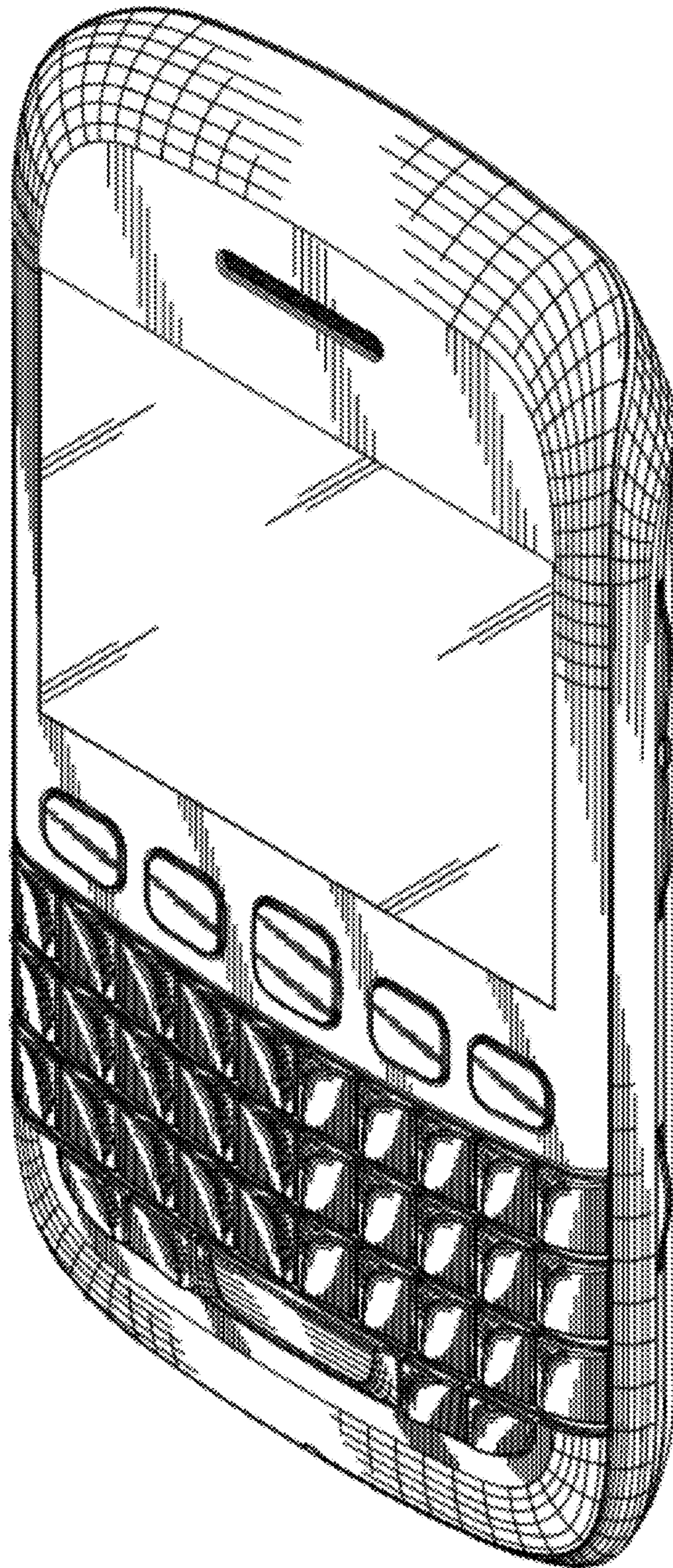

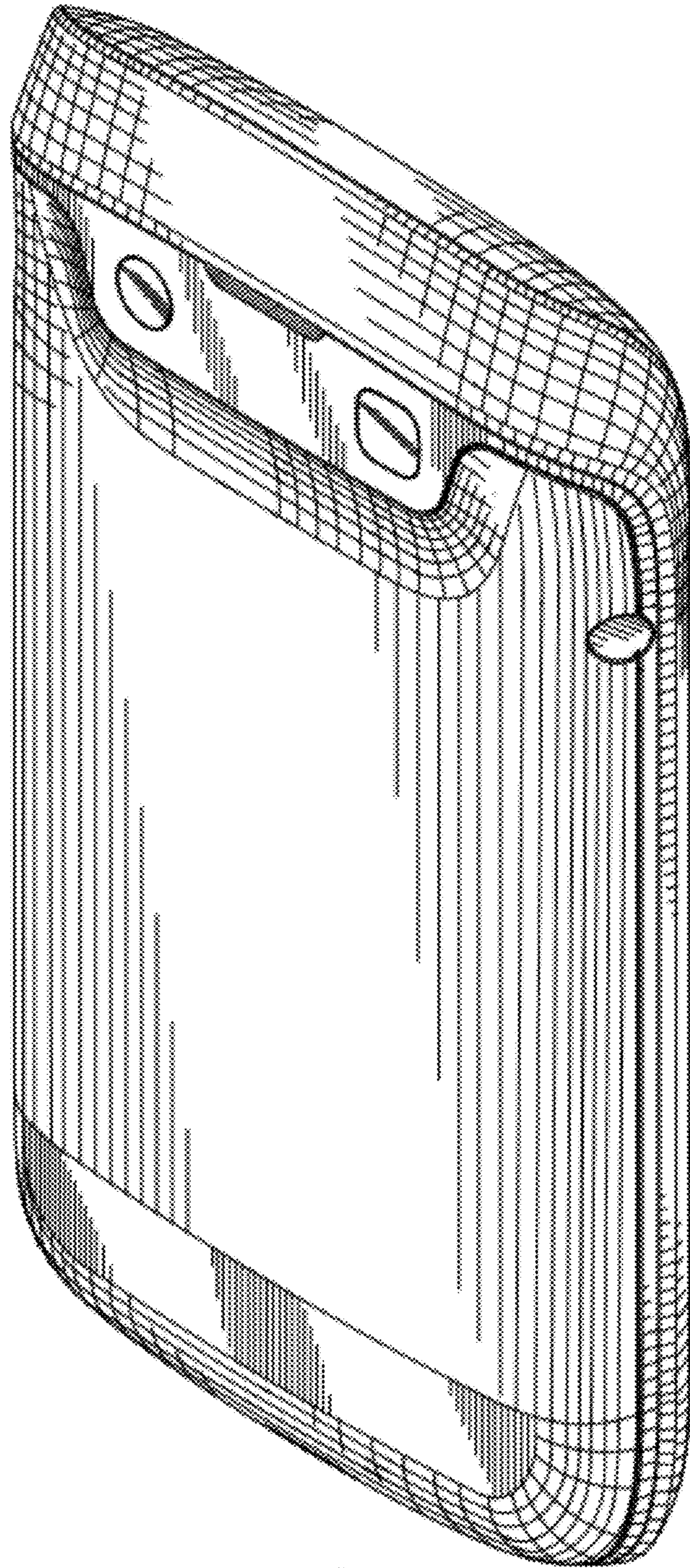

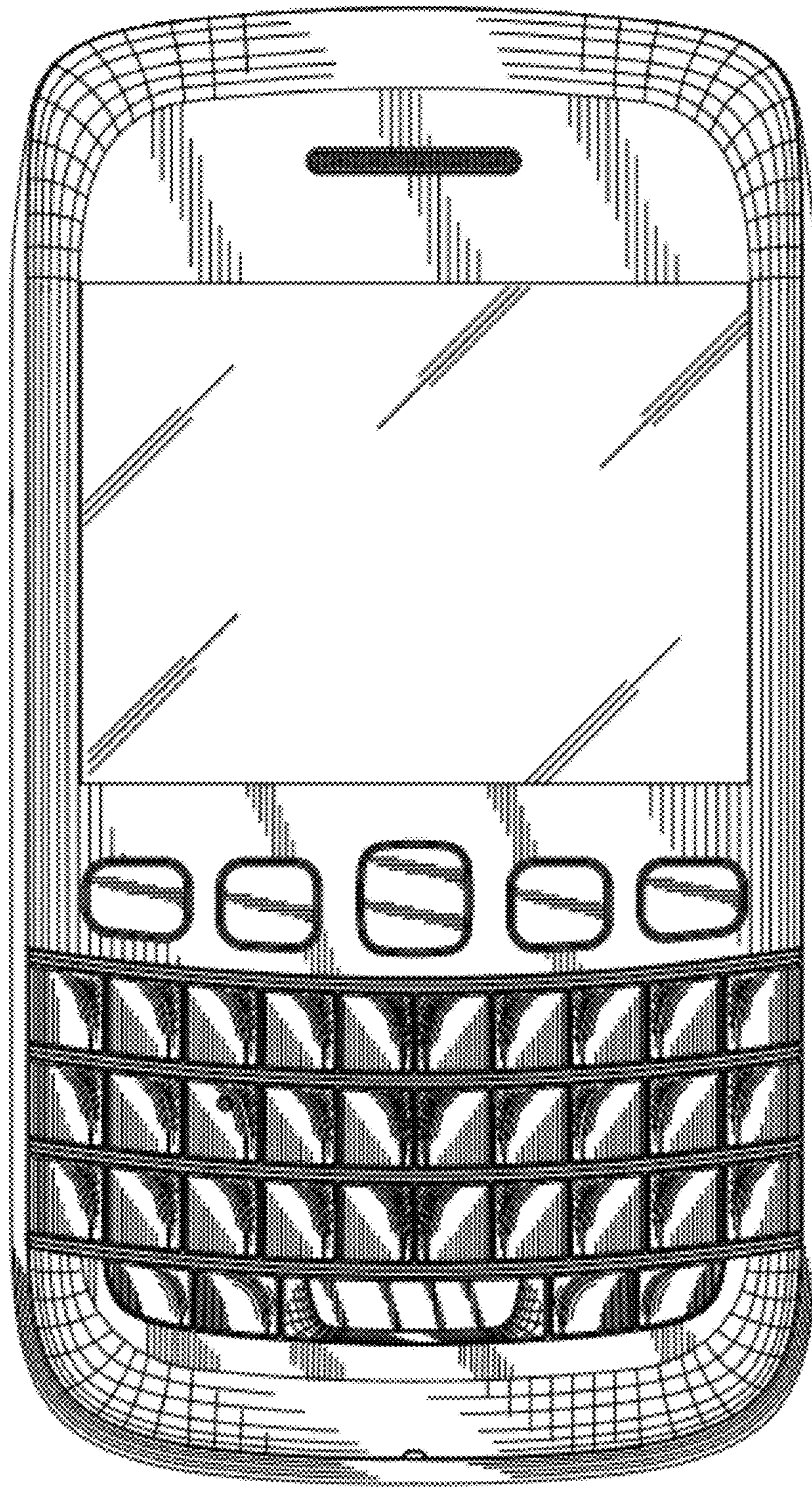

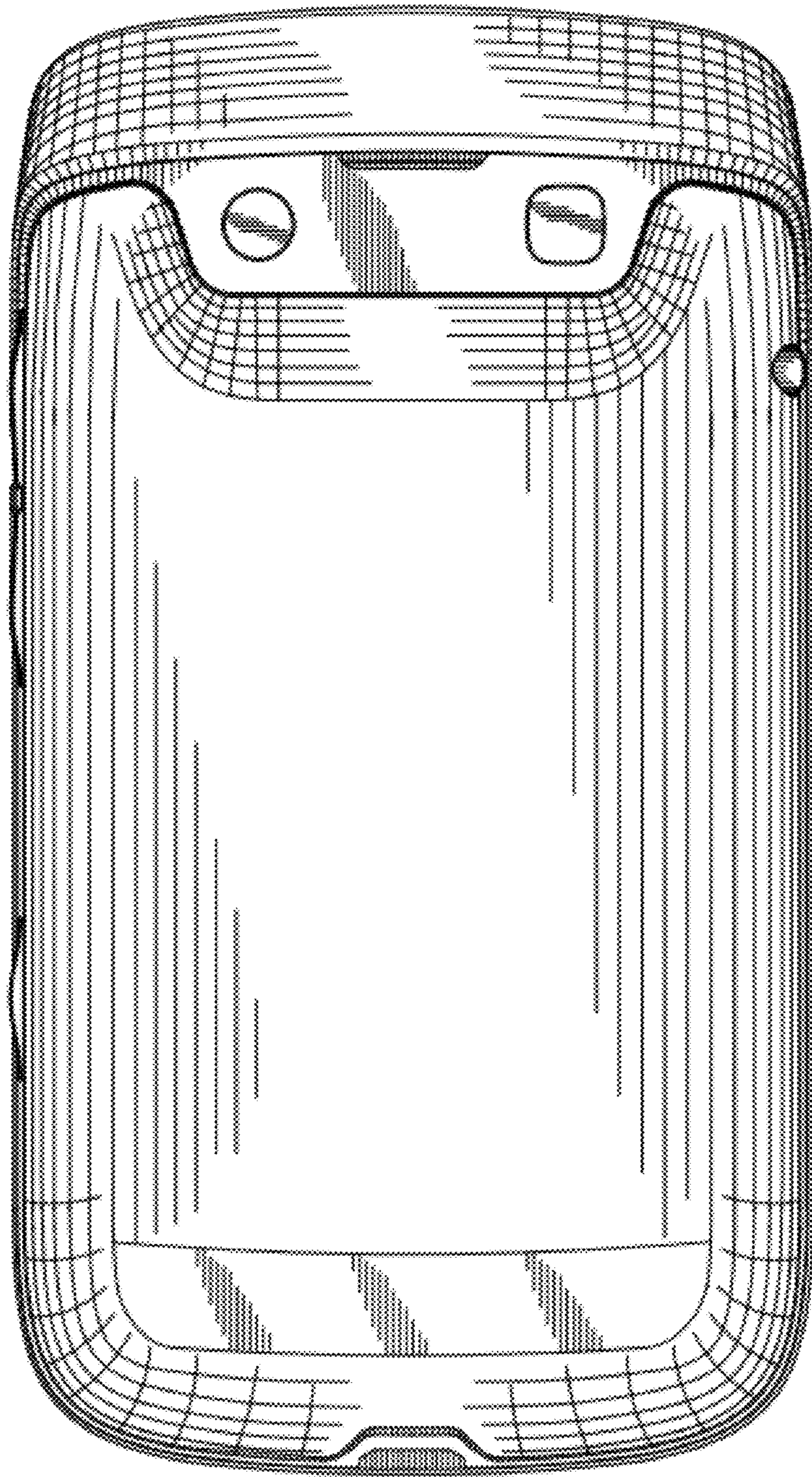

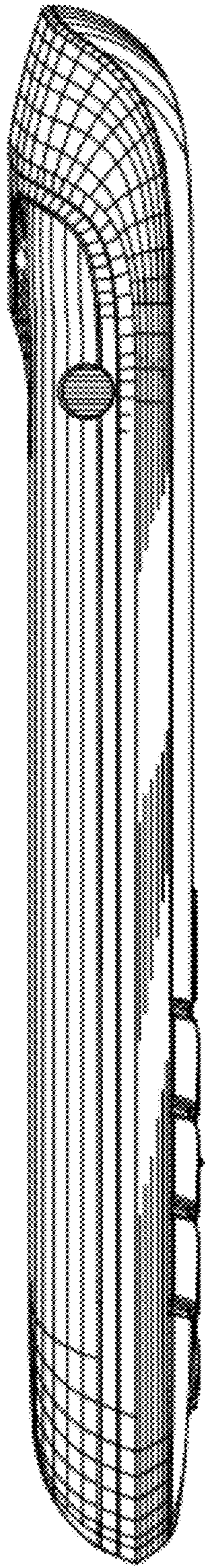

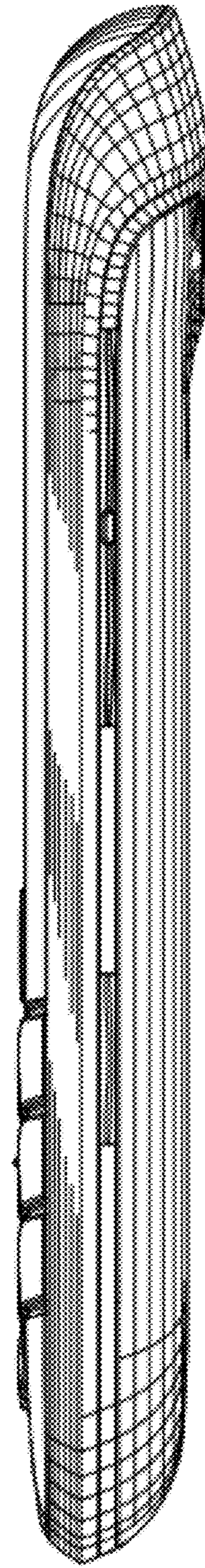

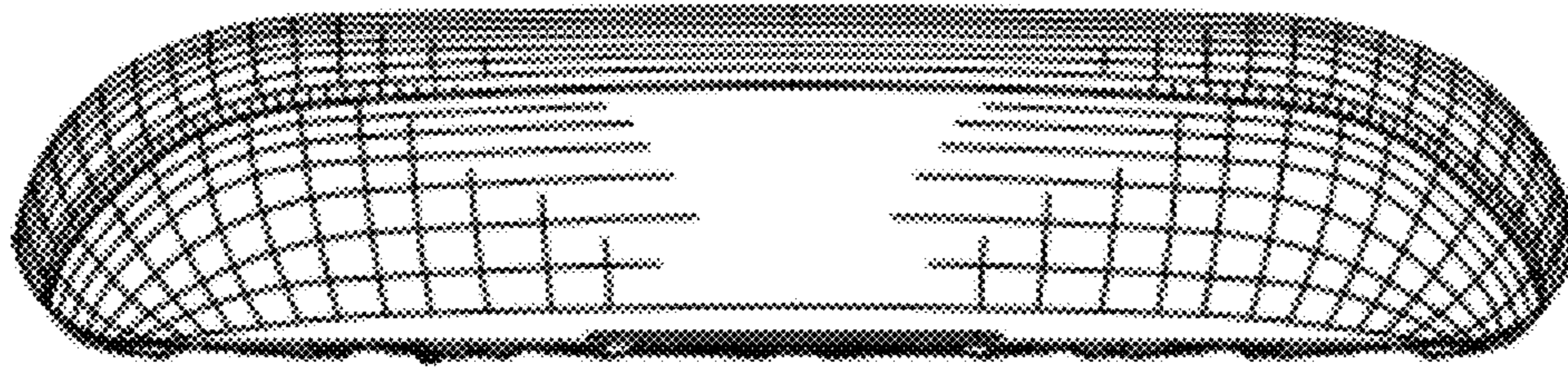

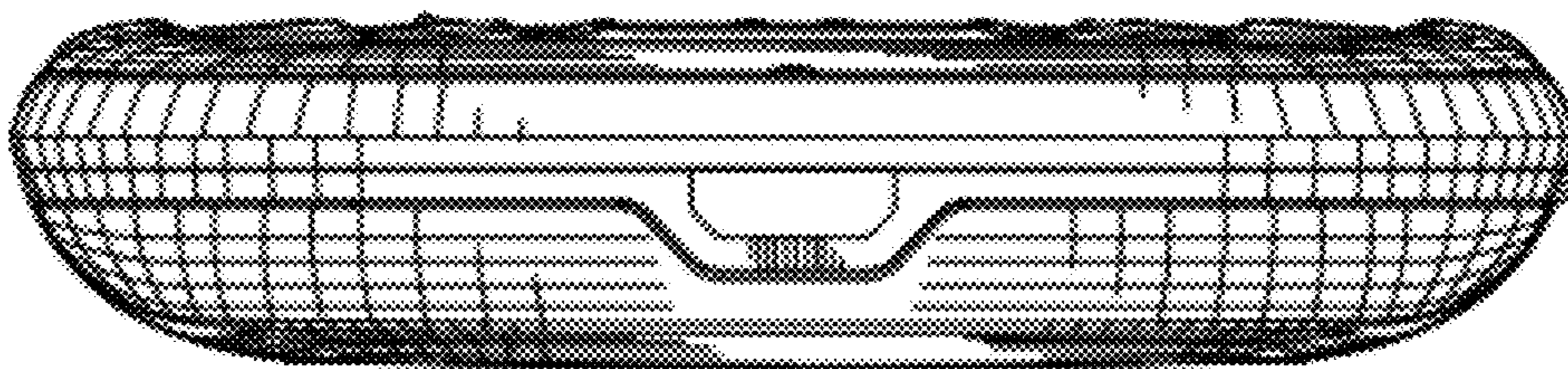
