The ornamental design for a display screen with group of icons, as shown and described.

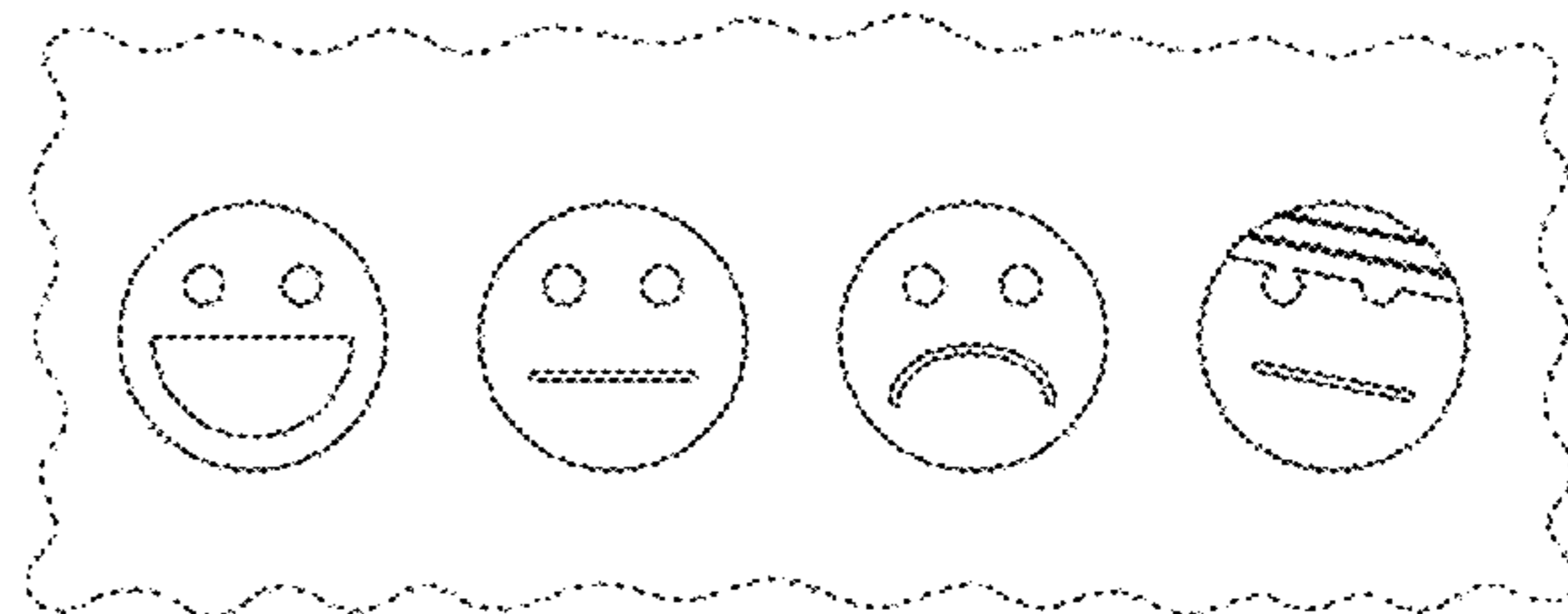
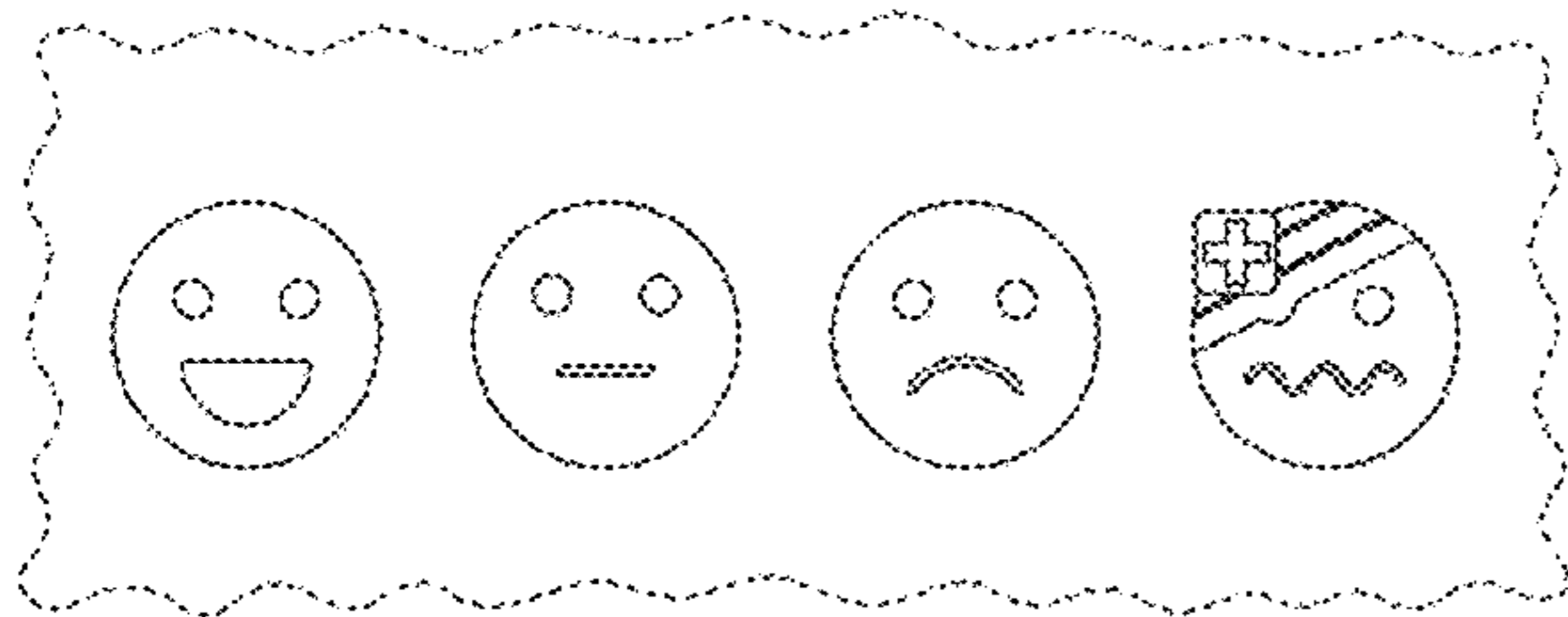
DESCRIPTION

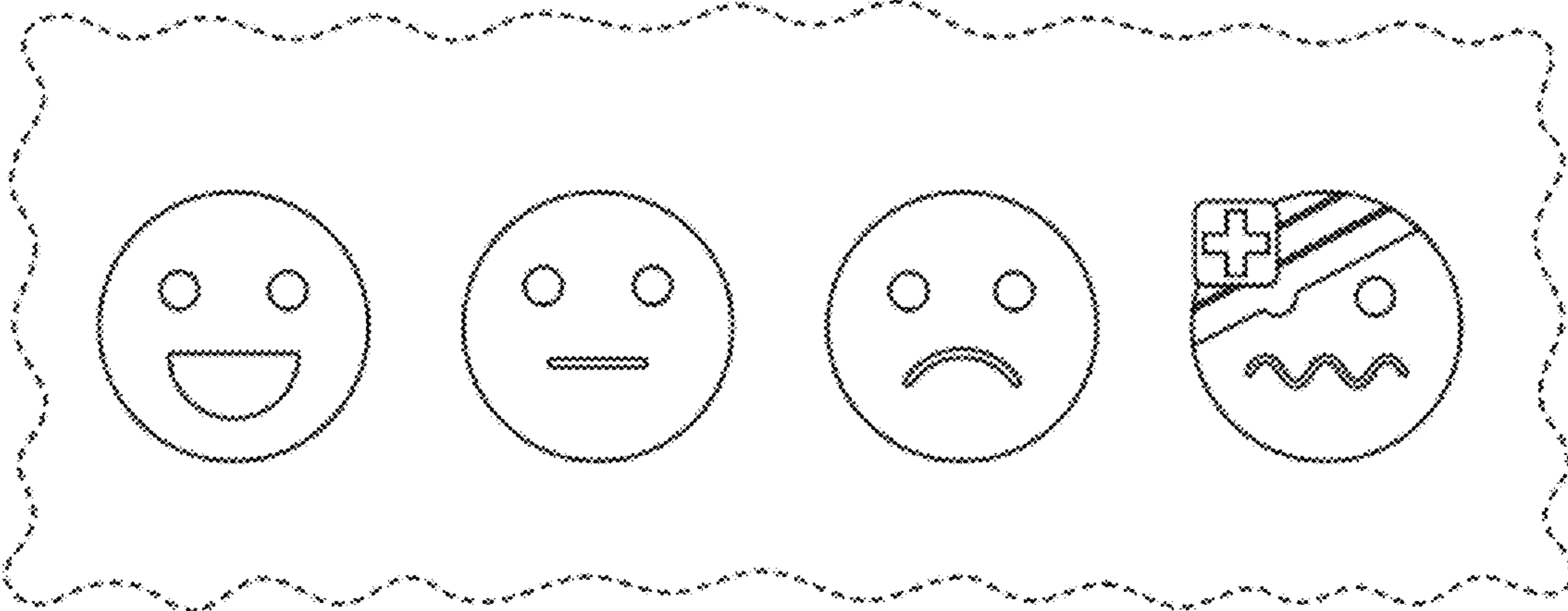

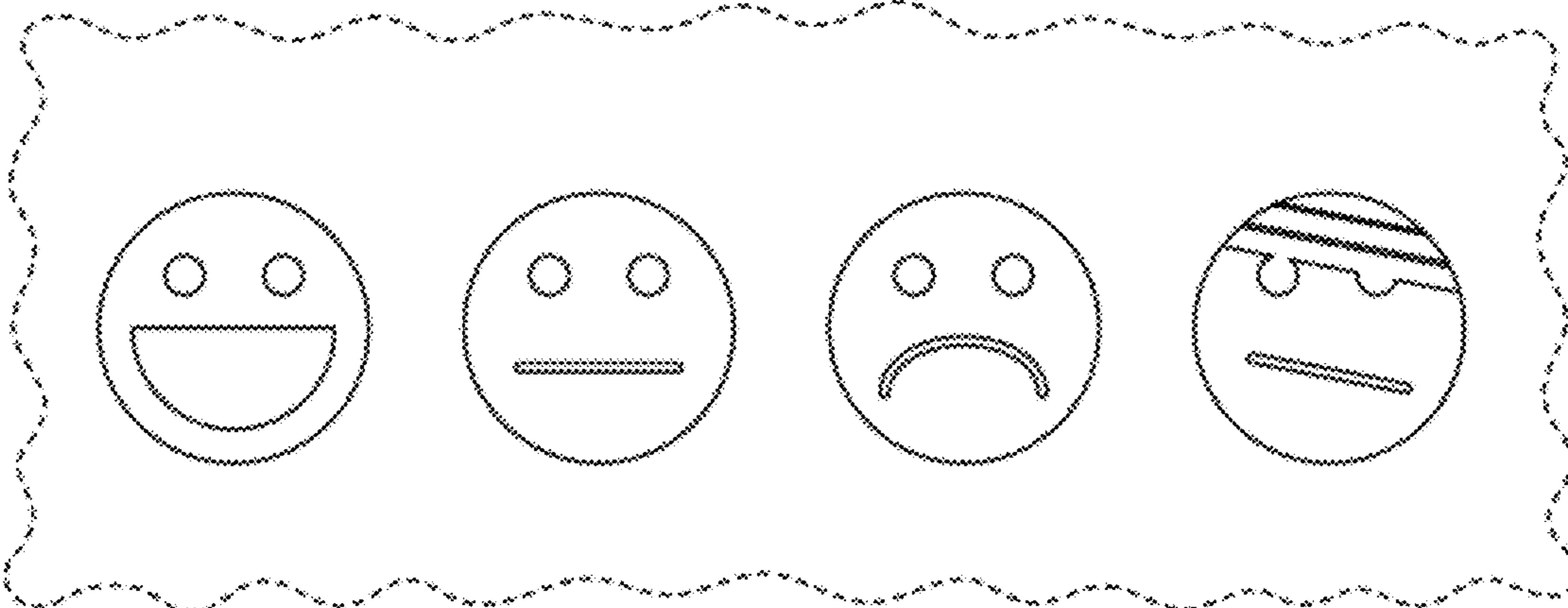
