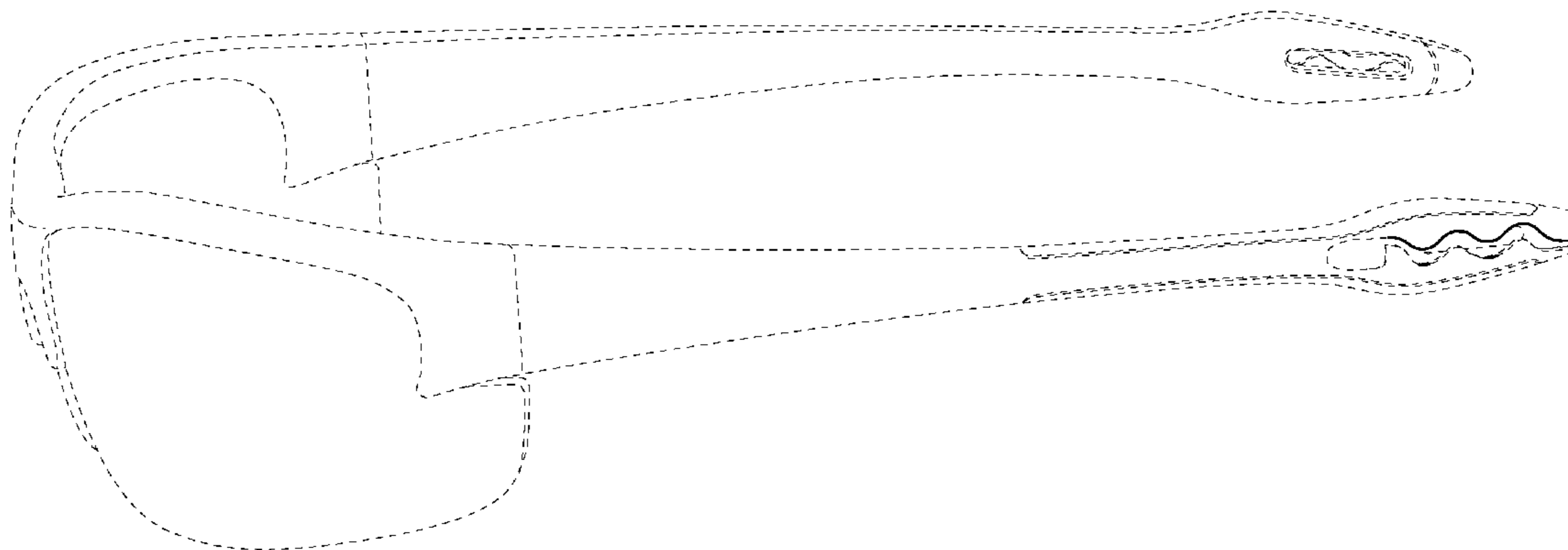

FIG. 1 is a perspective view of a new design for a headgear-earwear assembly;
FIG. 2 is a close-up perspective view thereof;
FIG. 3 is a close-up front elevational view thereof;
FIG. 4 is a close-up rear elevational view thereof;
FIG. 5 is a close-up top plan view thereof, the close-up bottom plan view being a mirror image of the top plan view;

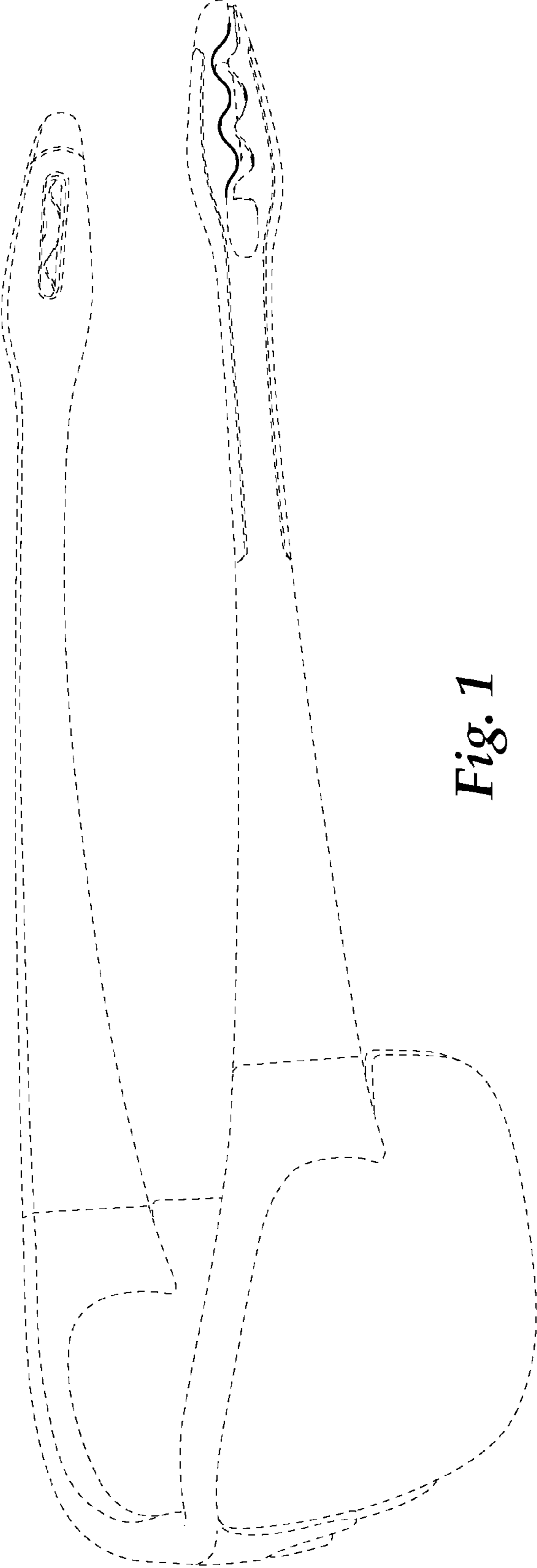

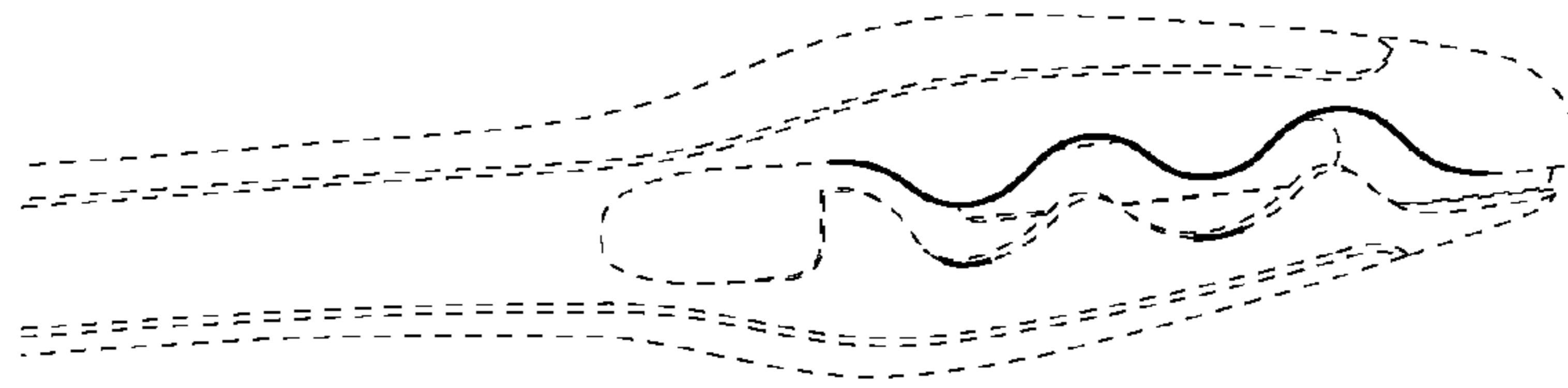

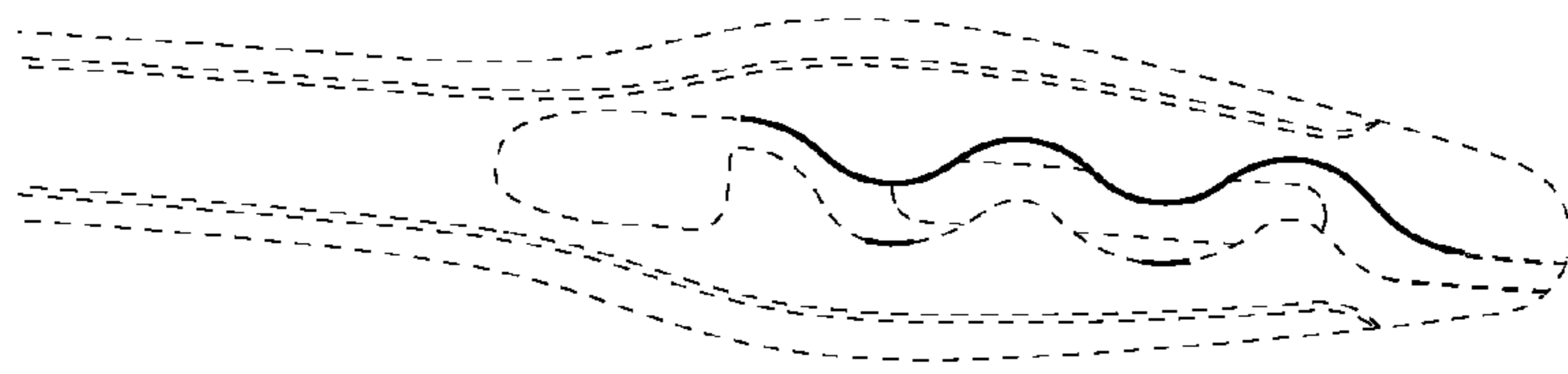

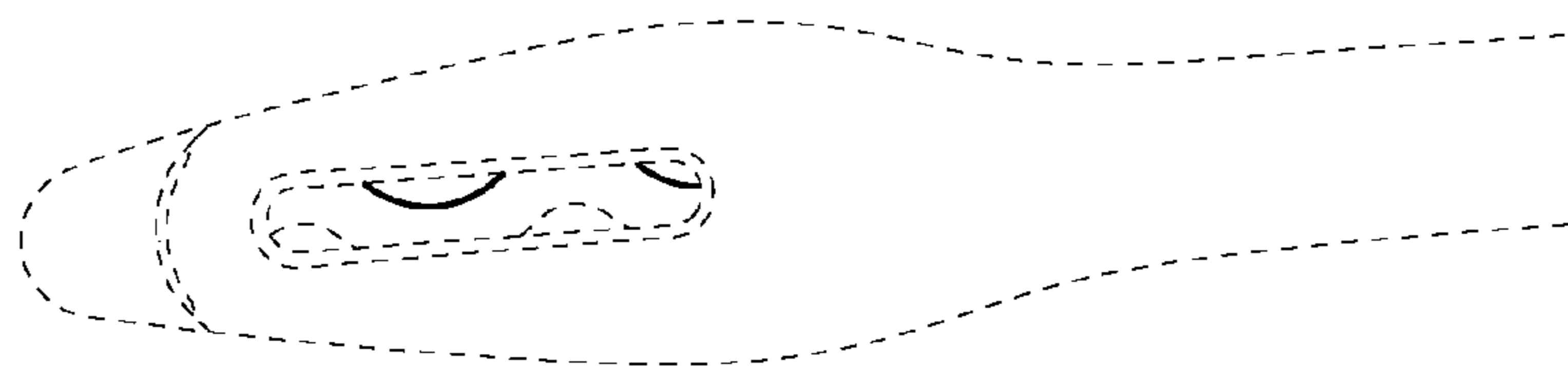

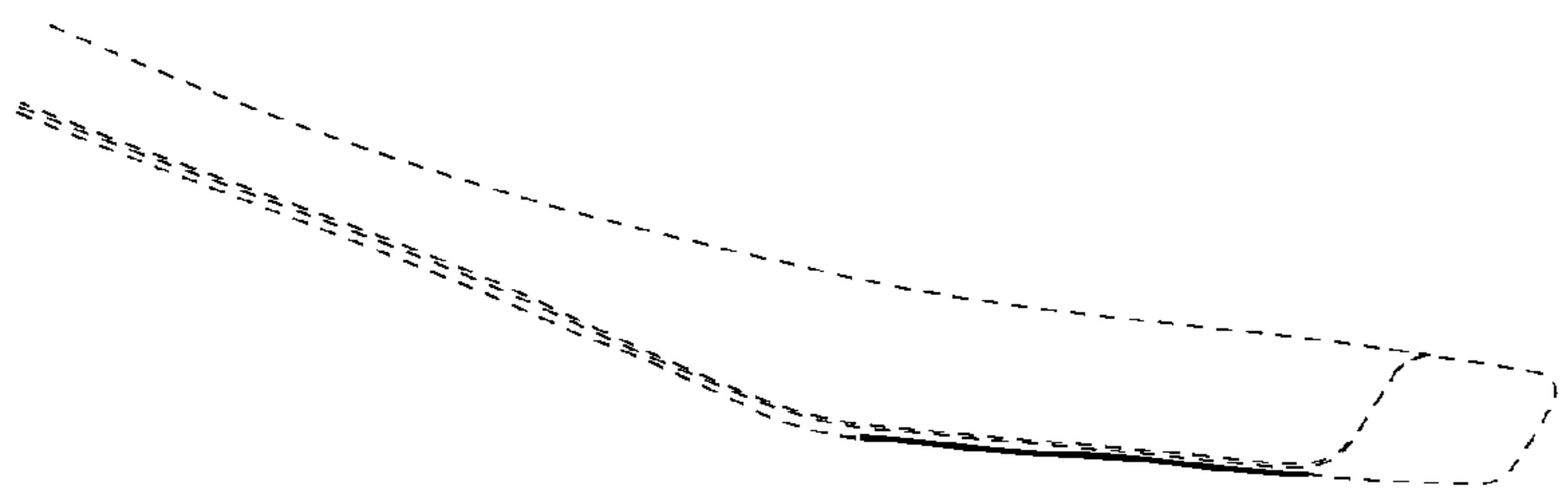

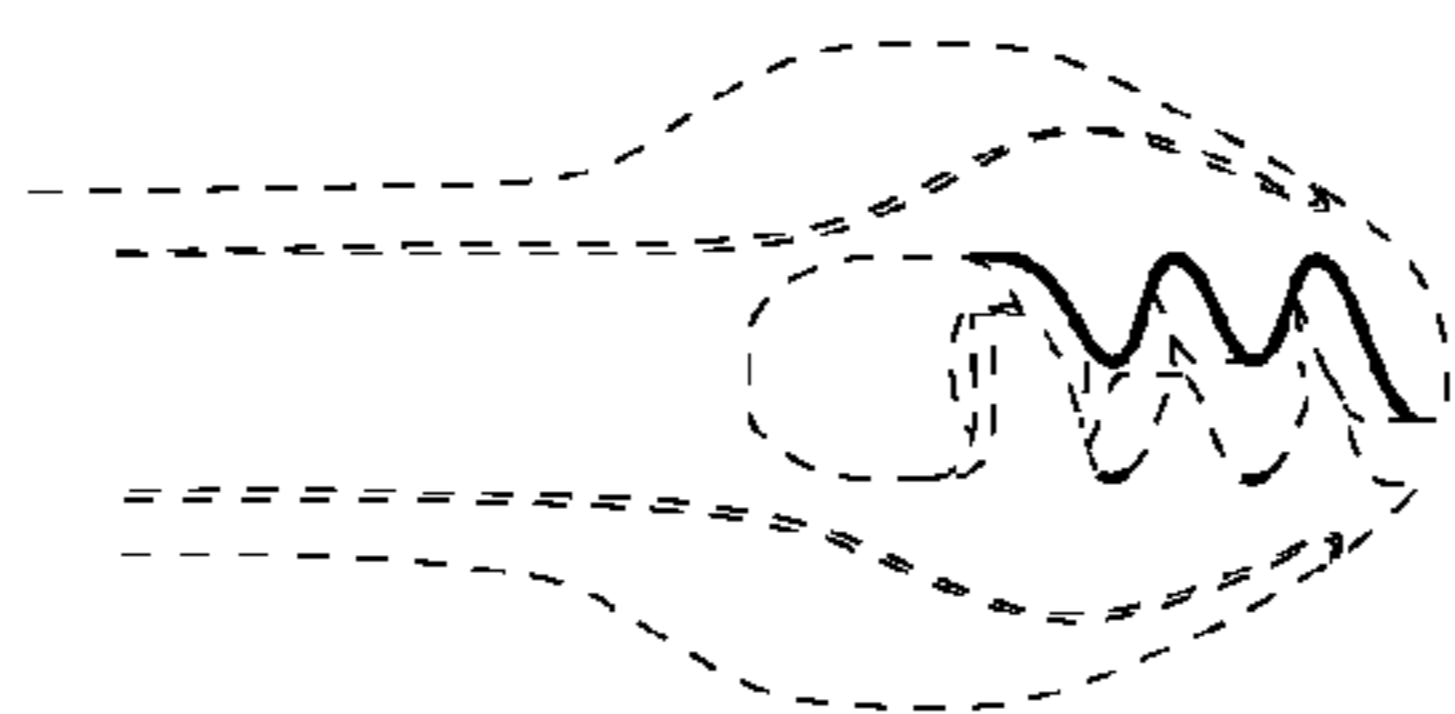

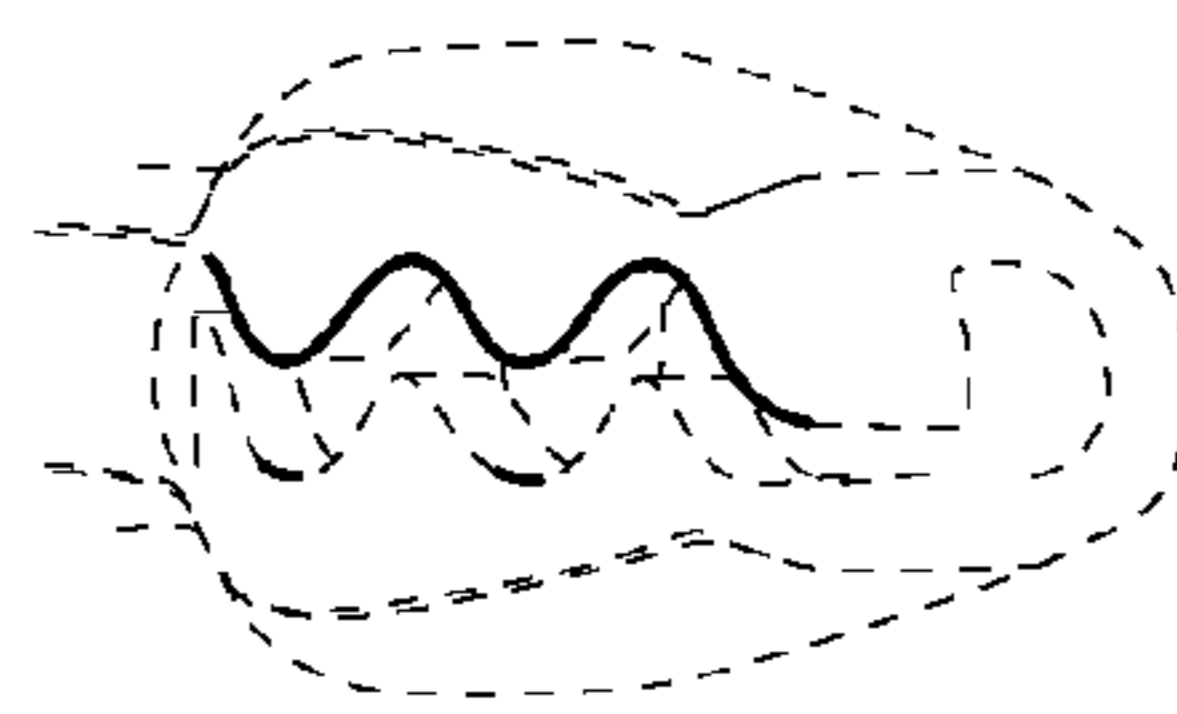
