The ornamental design for decorative arm for eyewear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the decorative arm for eyewear showing my new design;

FIG. 2 is a right side view of the decorative arm for eyewear shown in FIG. 1 (with the left side view being a mirror image thereof);

FIG. 15 is a front view of the decorative element shown in FIG. 13;

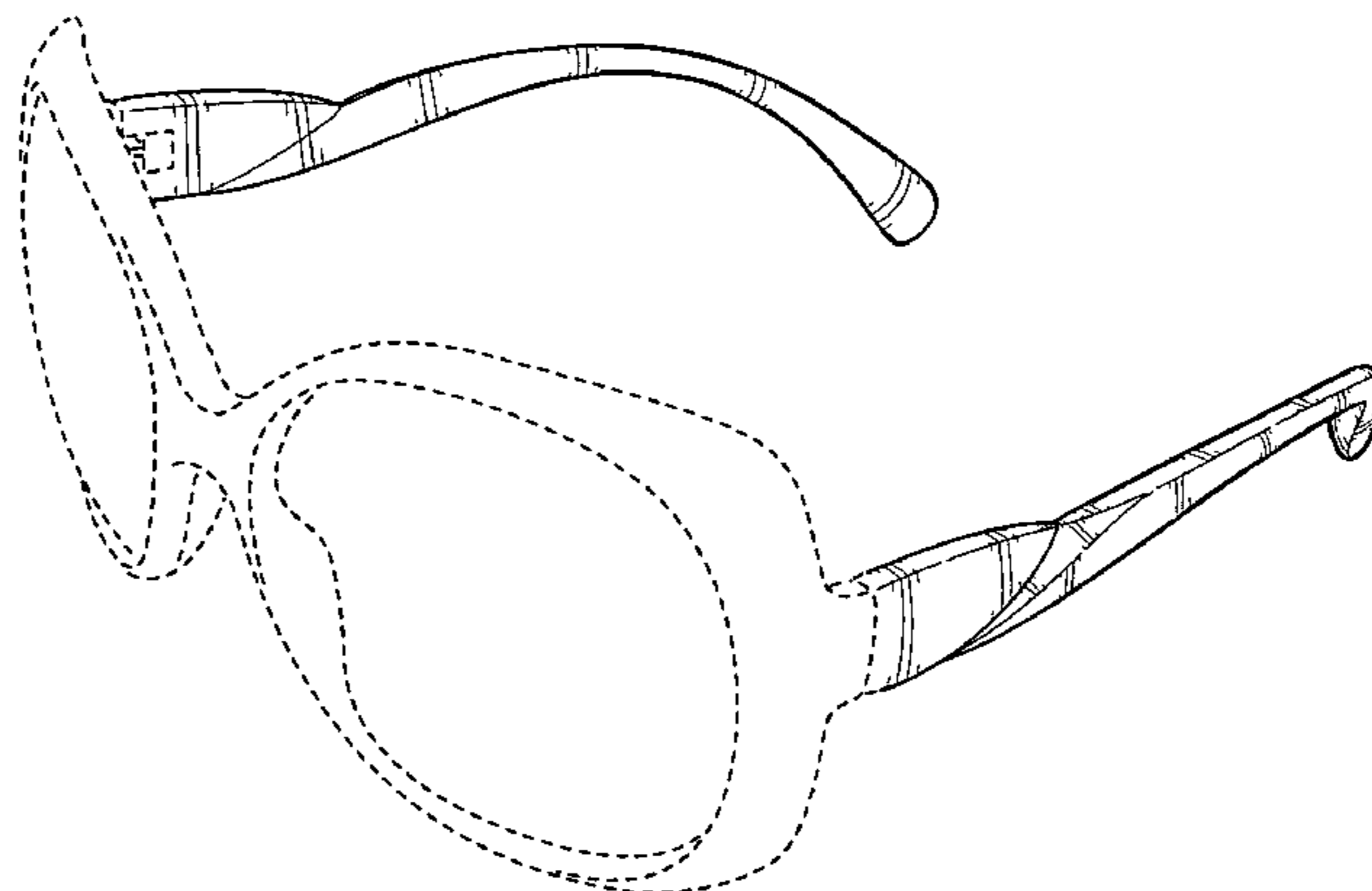
FIG. 16 is a rear view of the decorative element shown in FIG. 13;

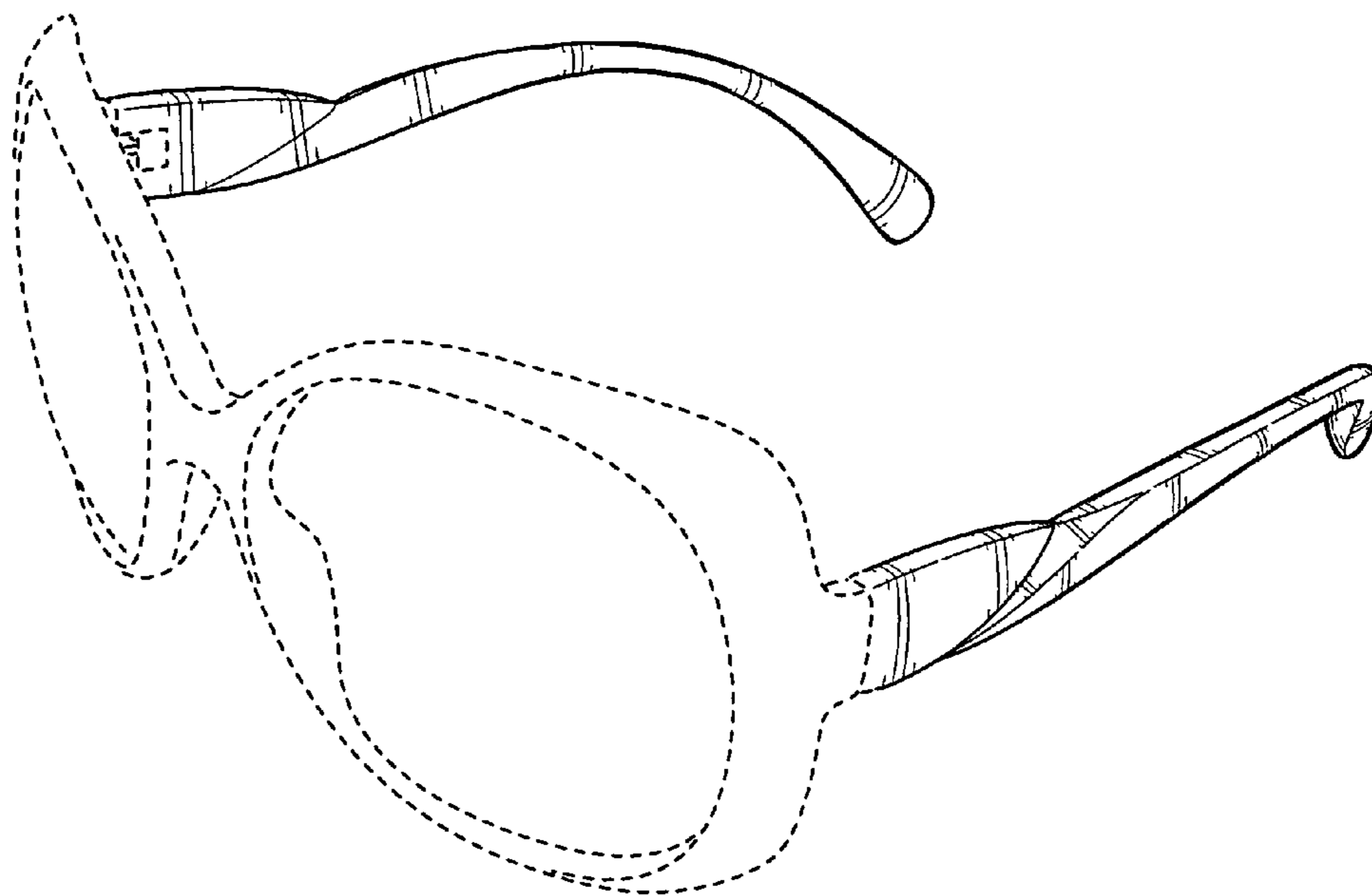

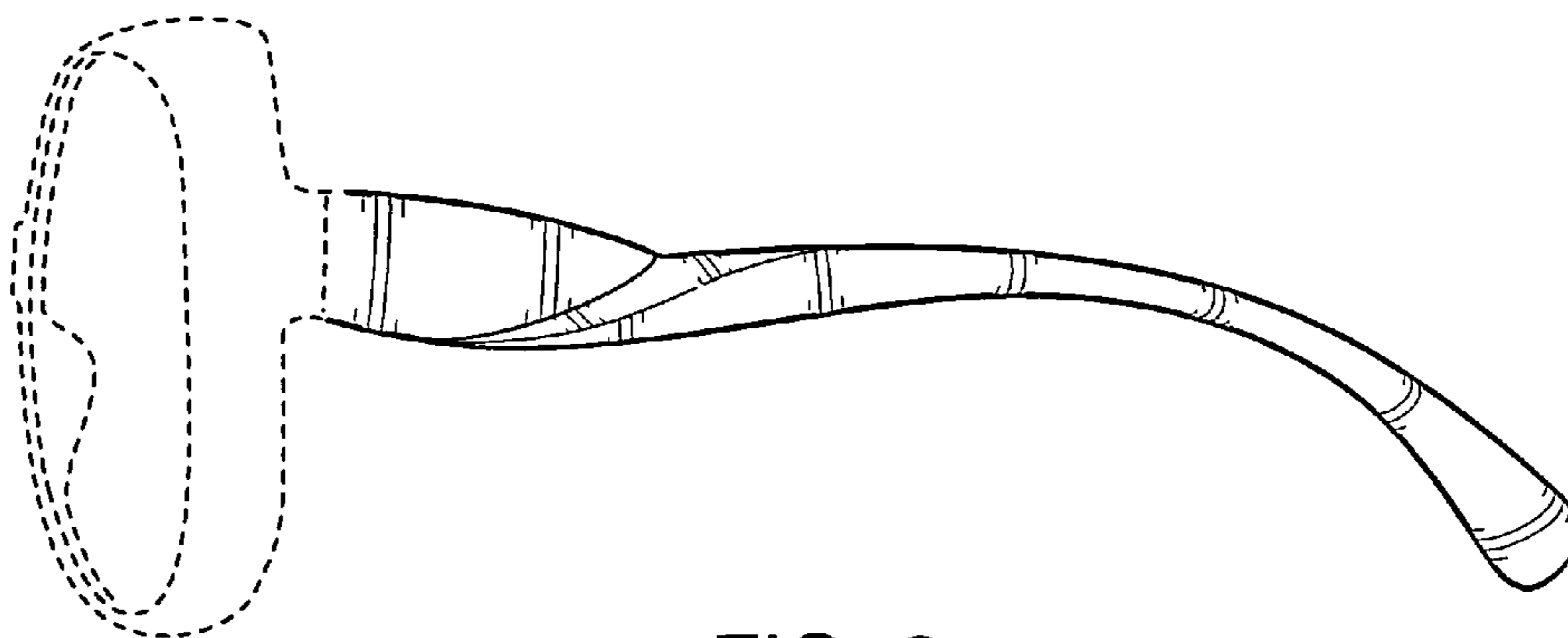

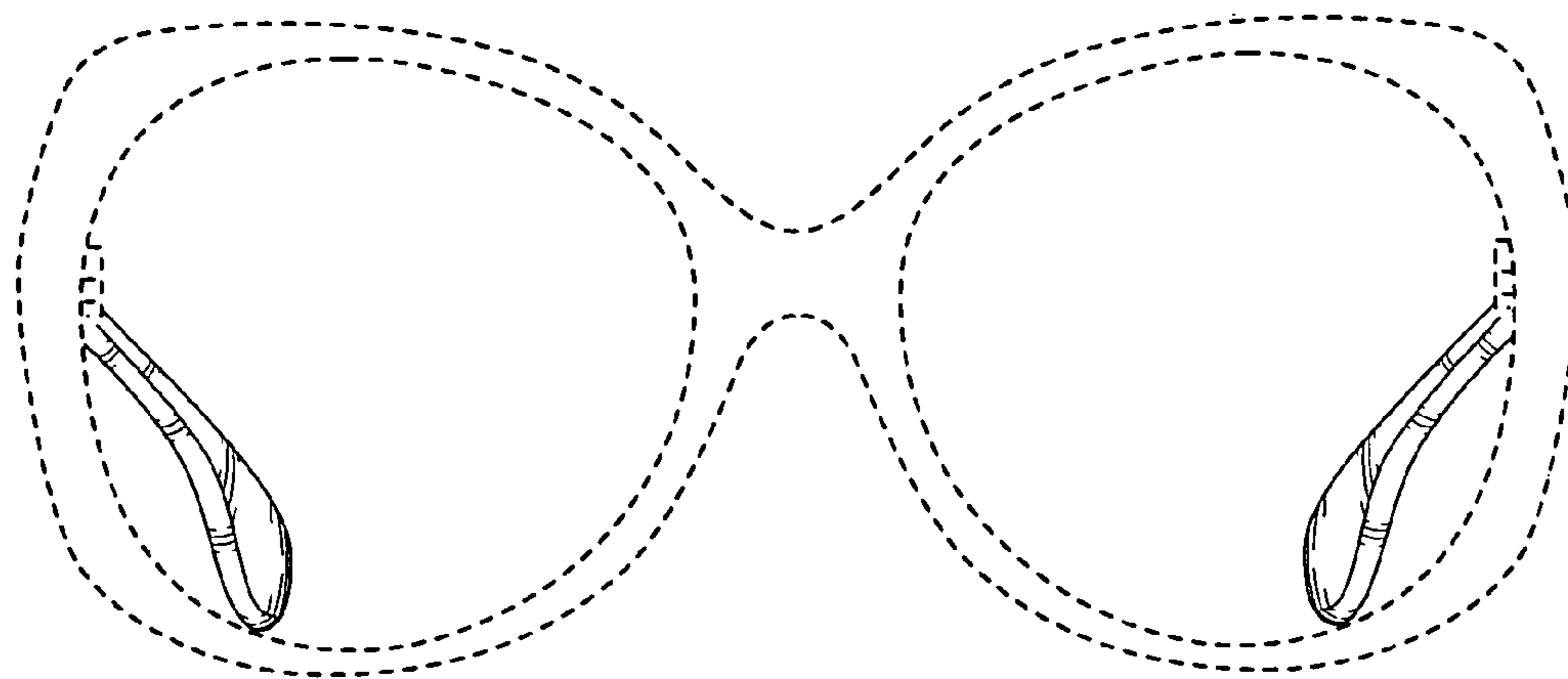

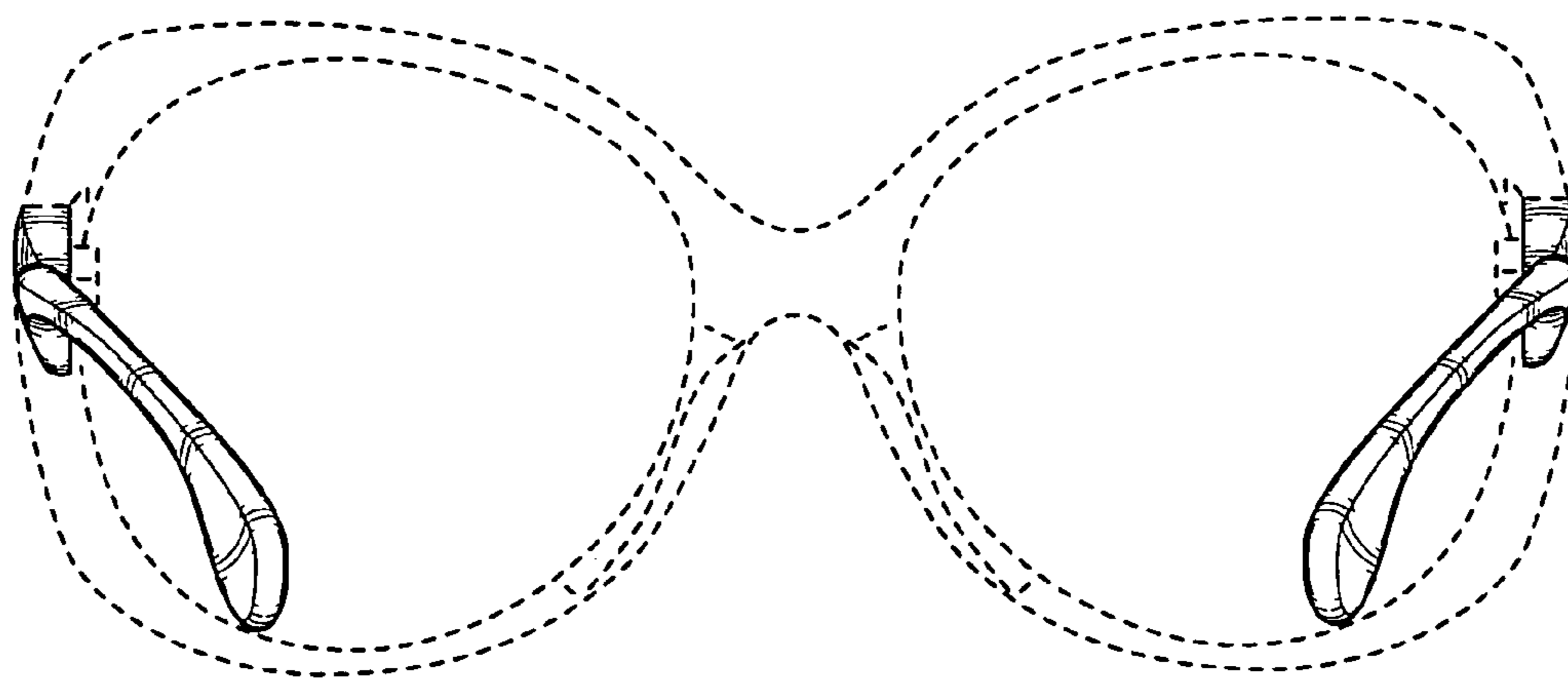

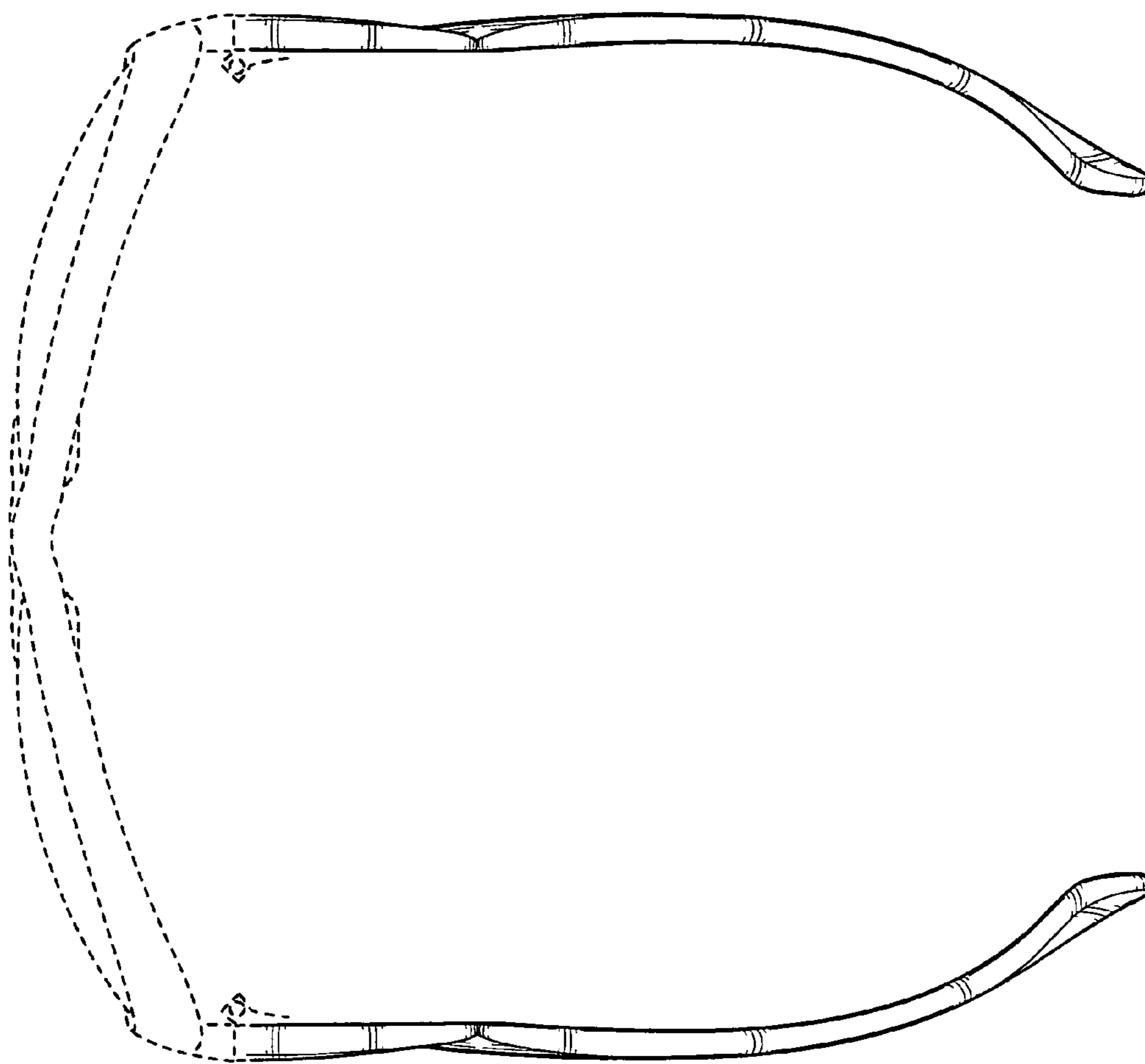

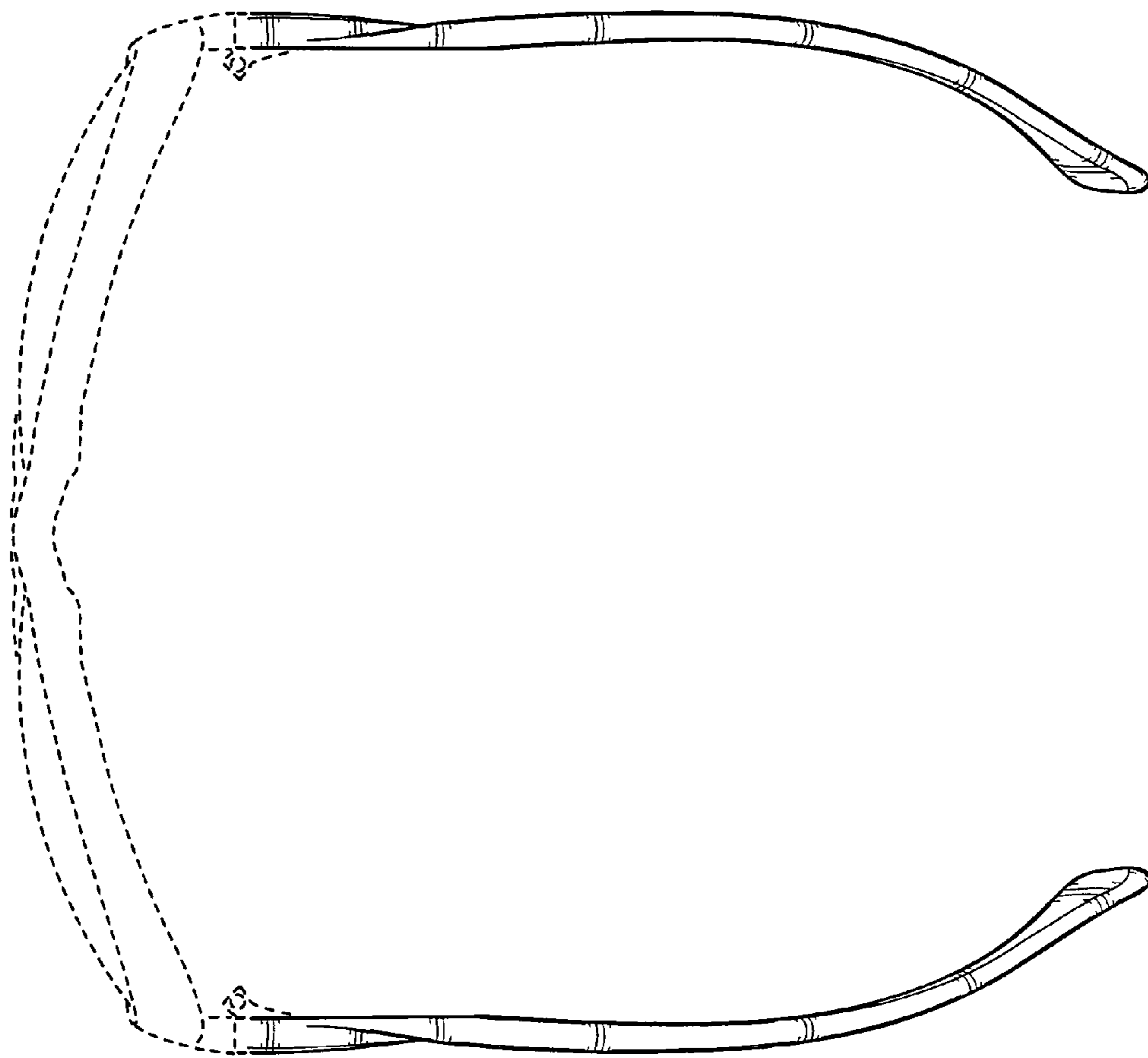

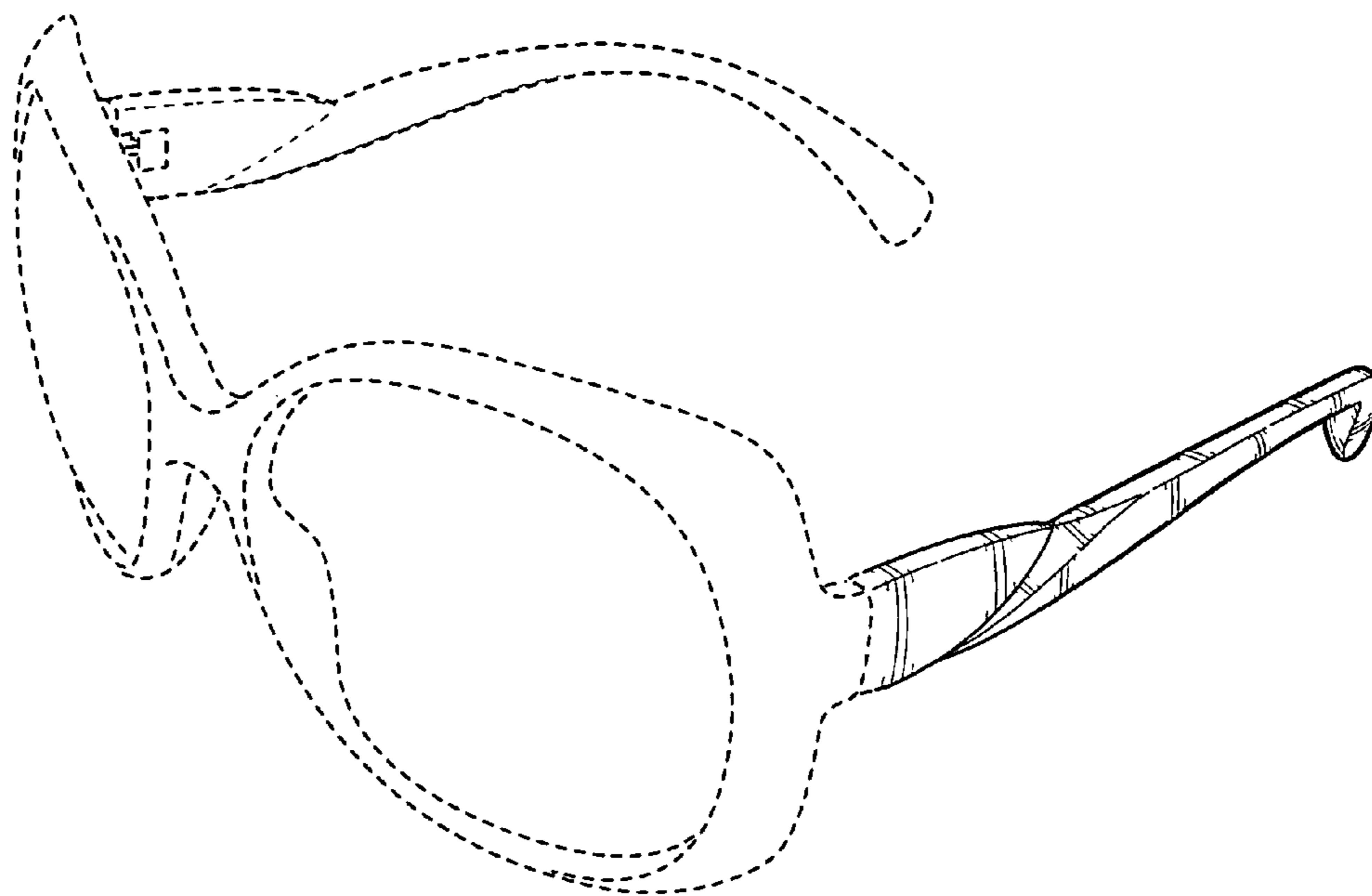

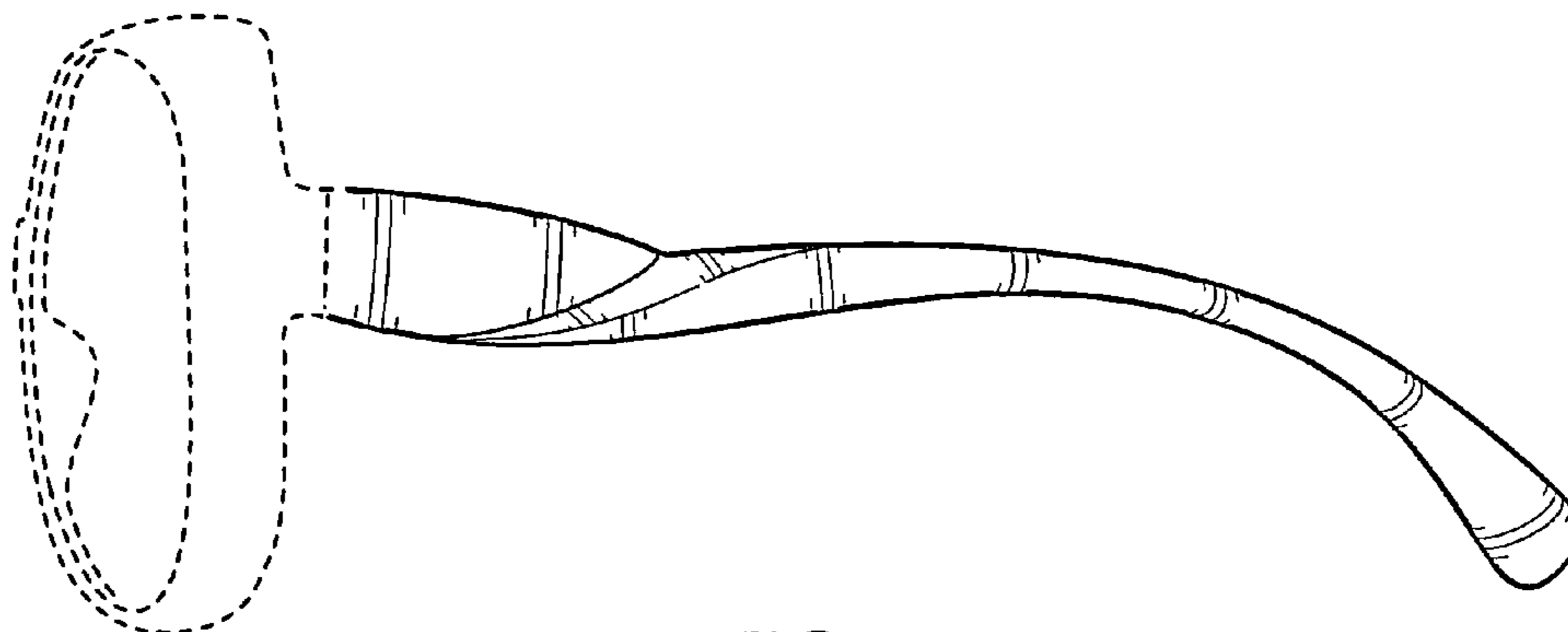

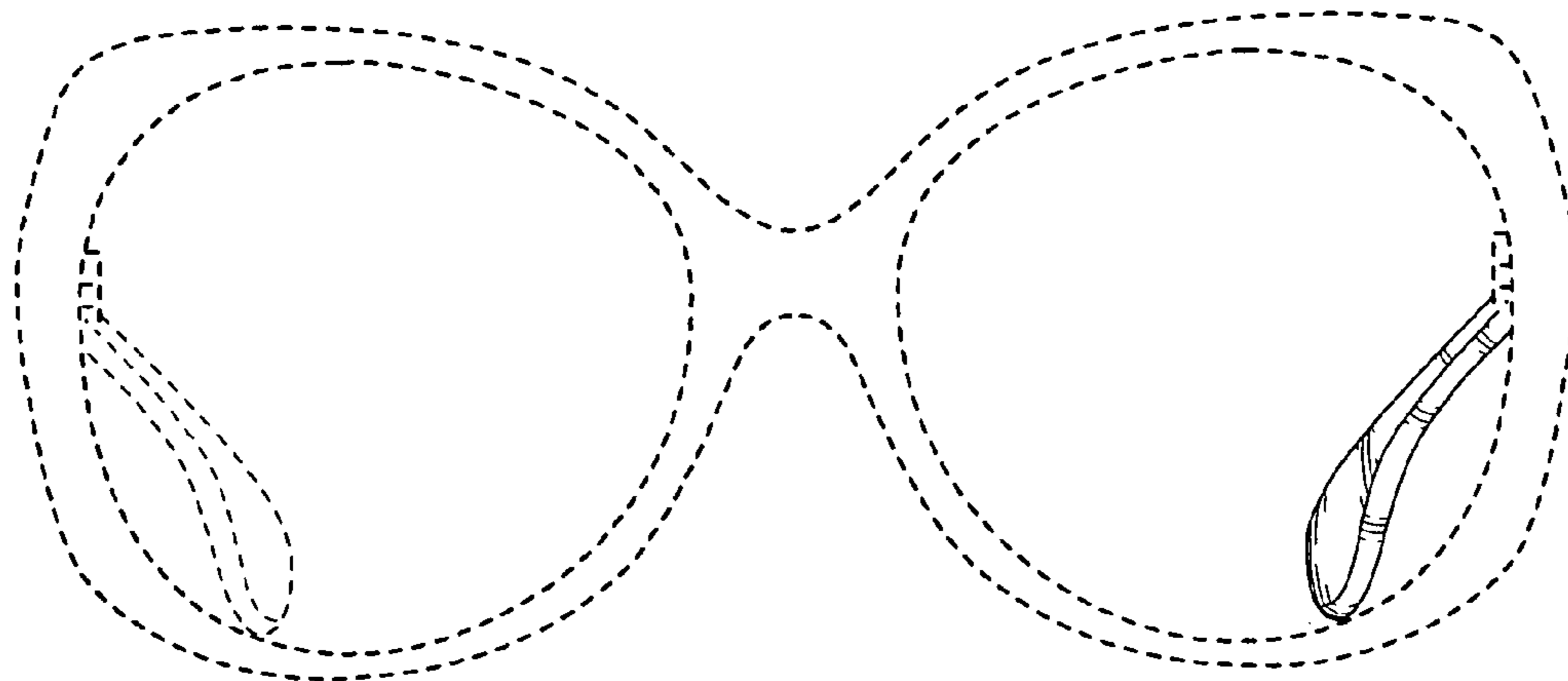

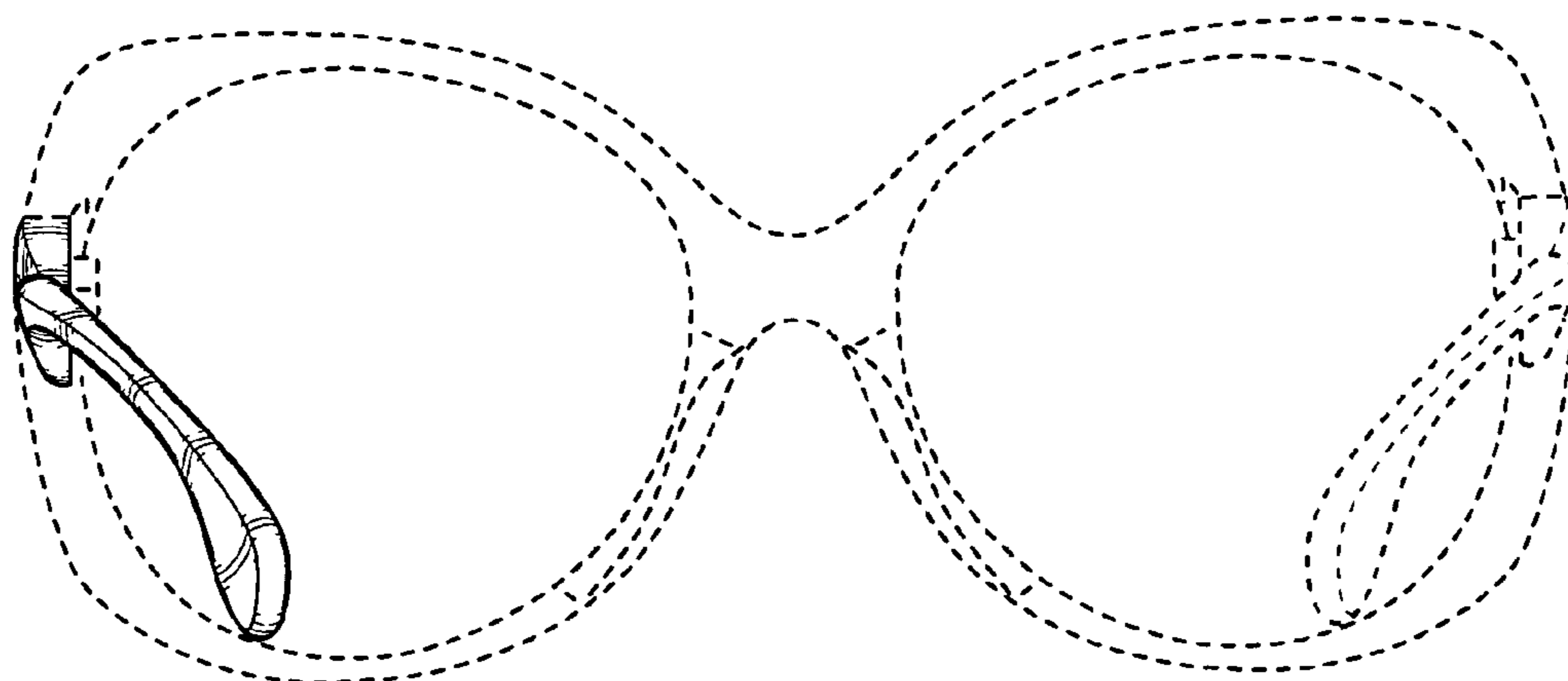

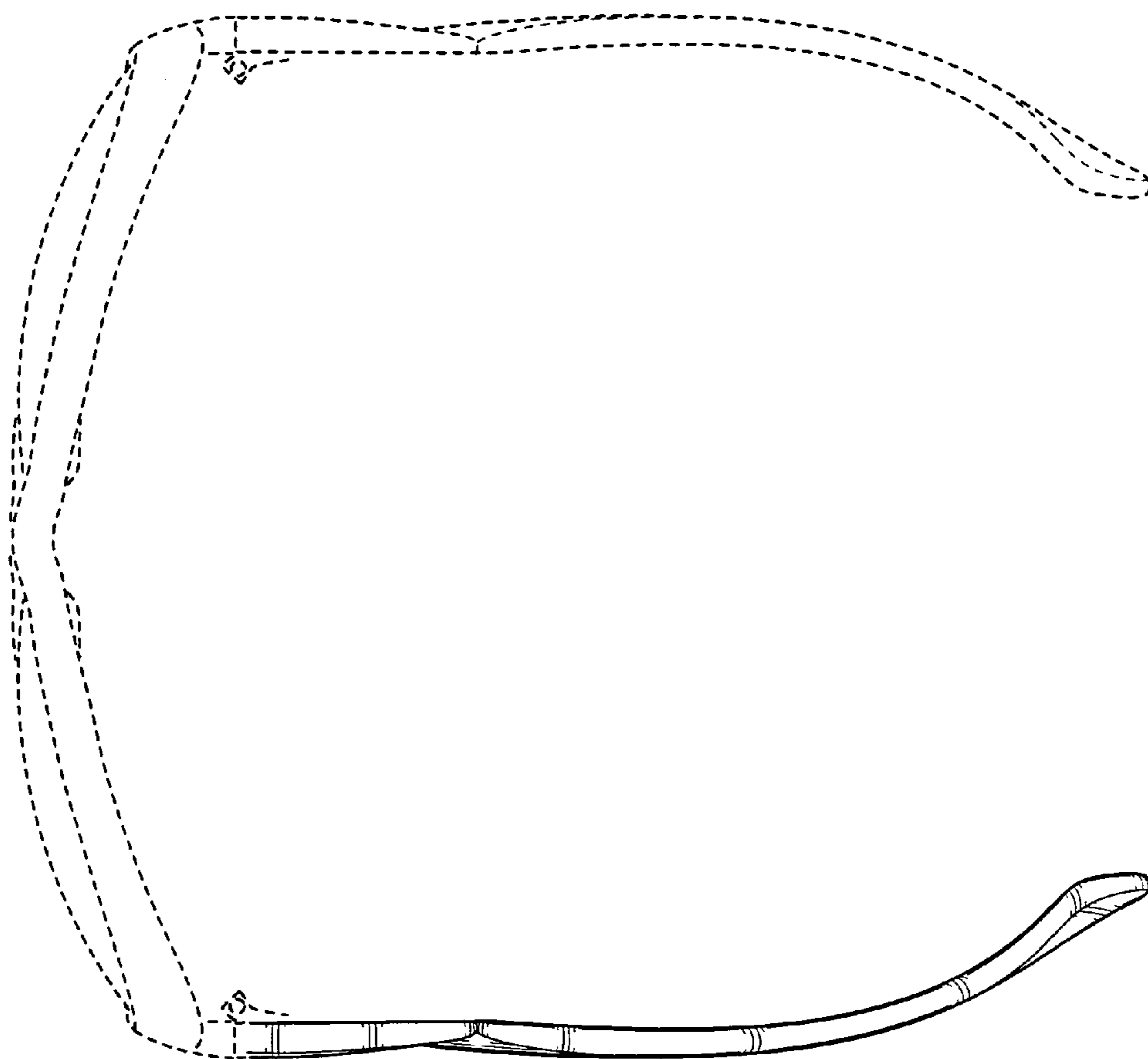

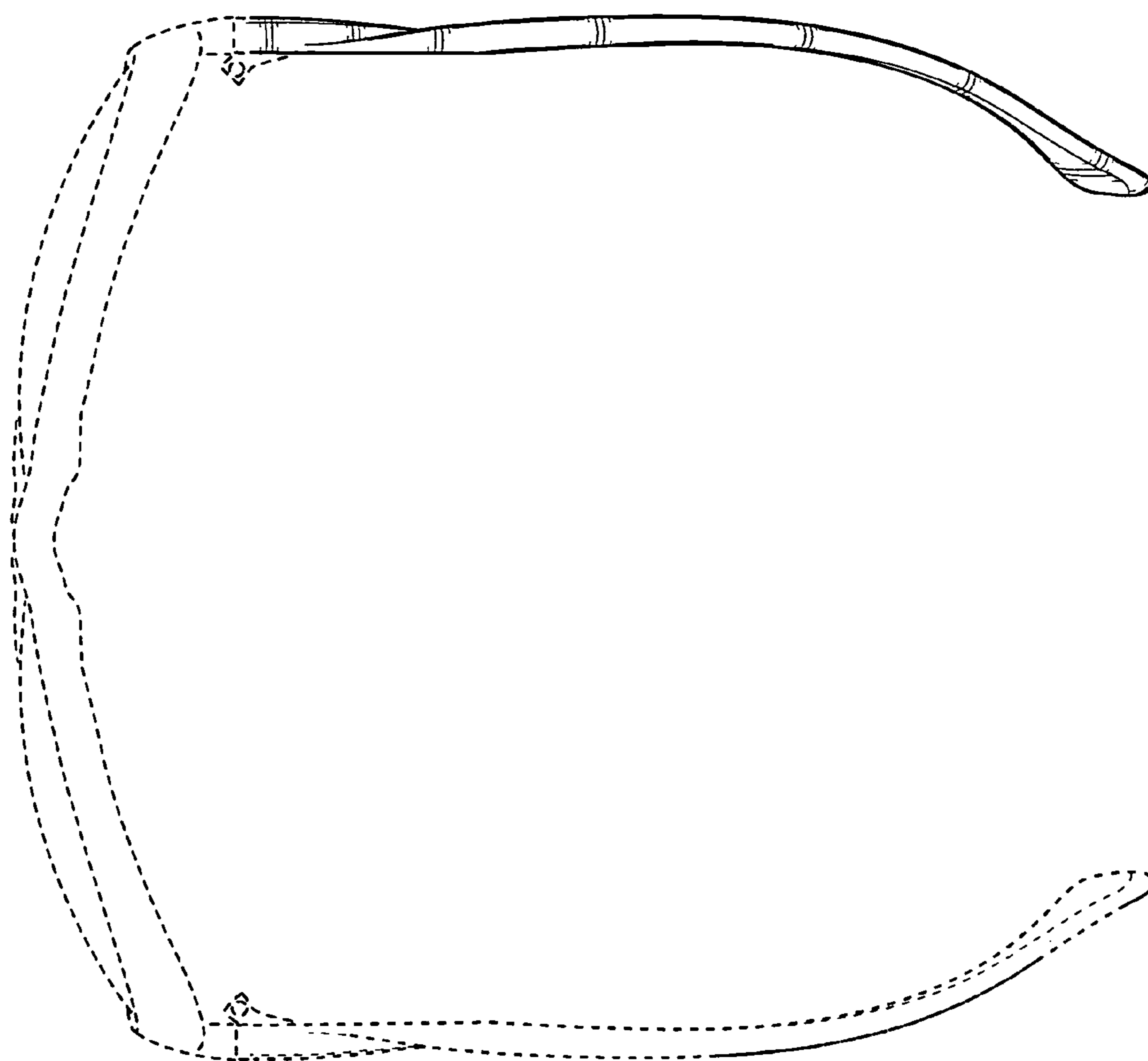

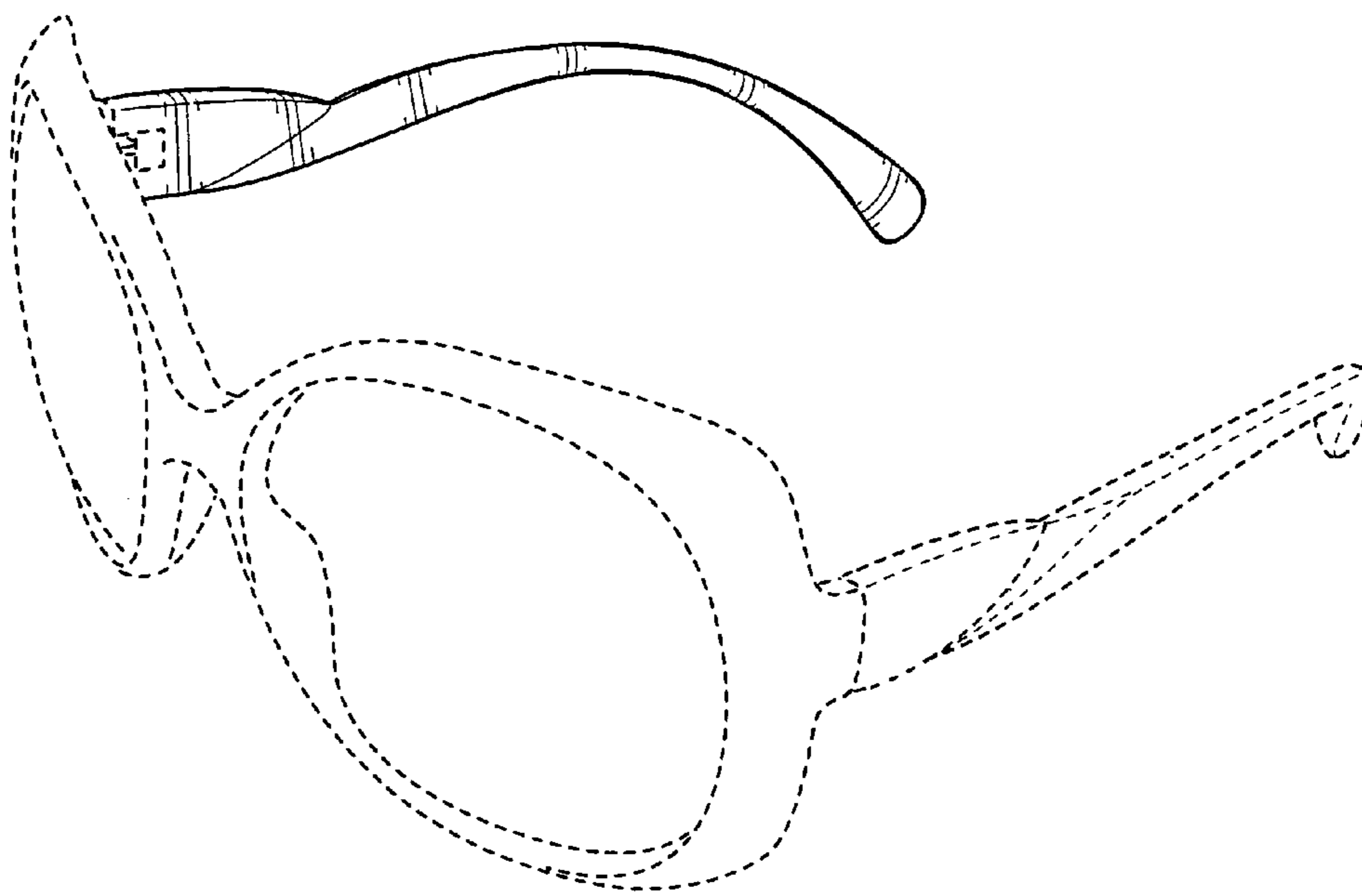

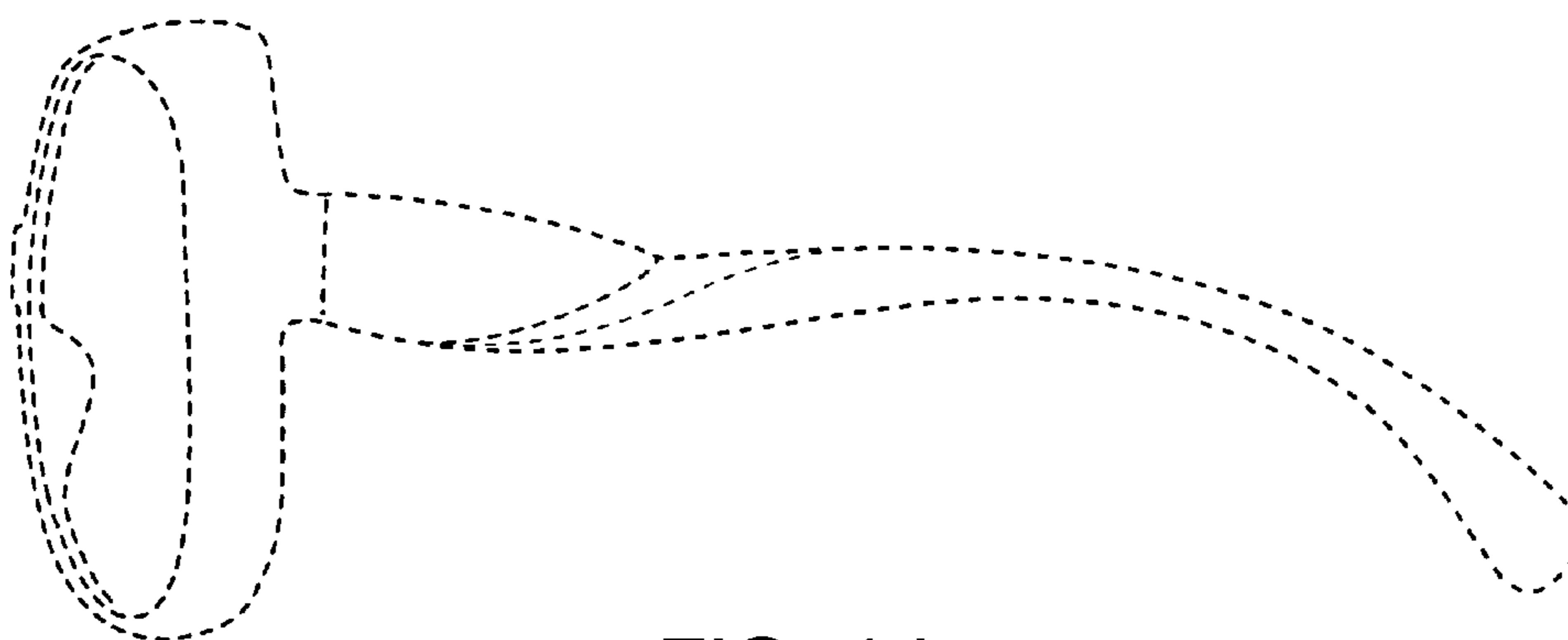

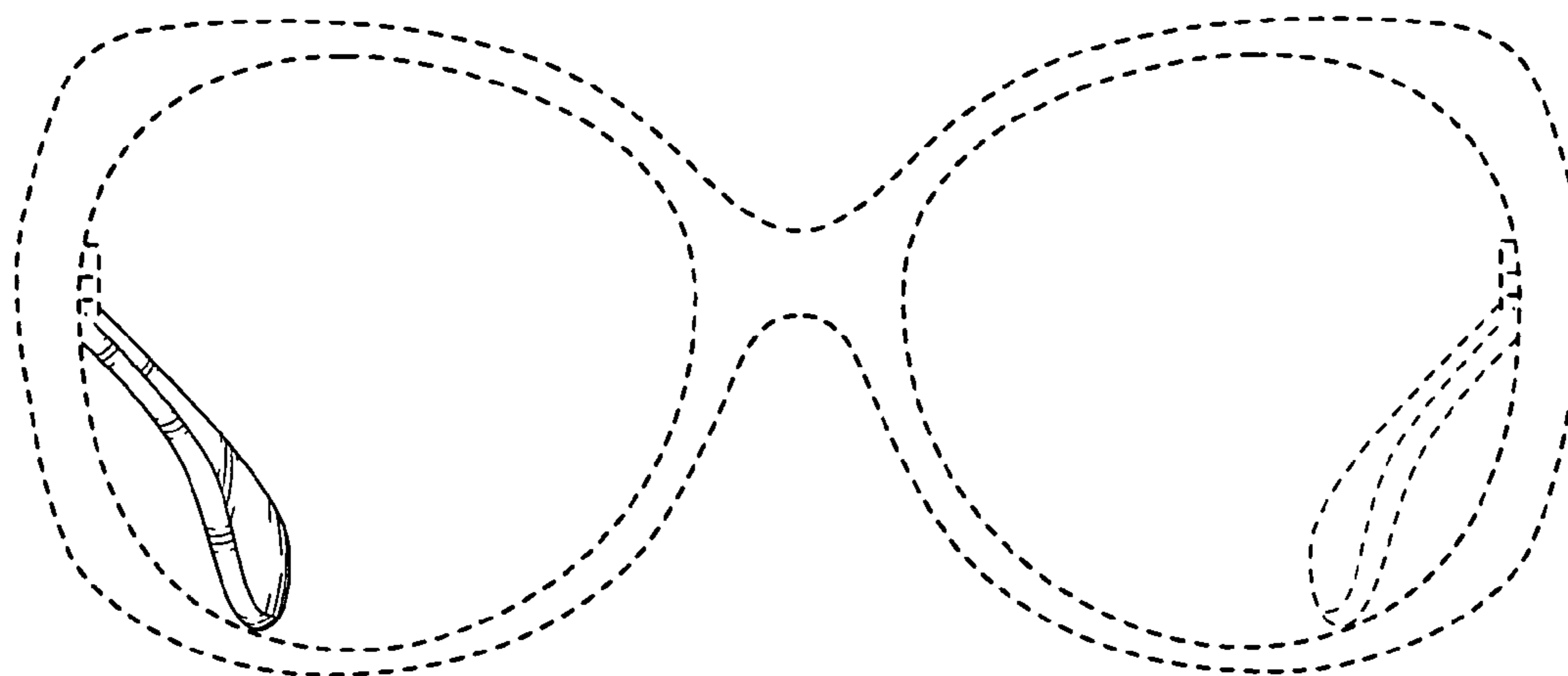

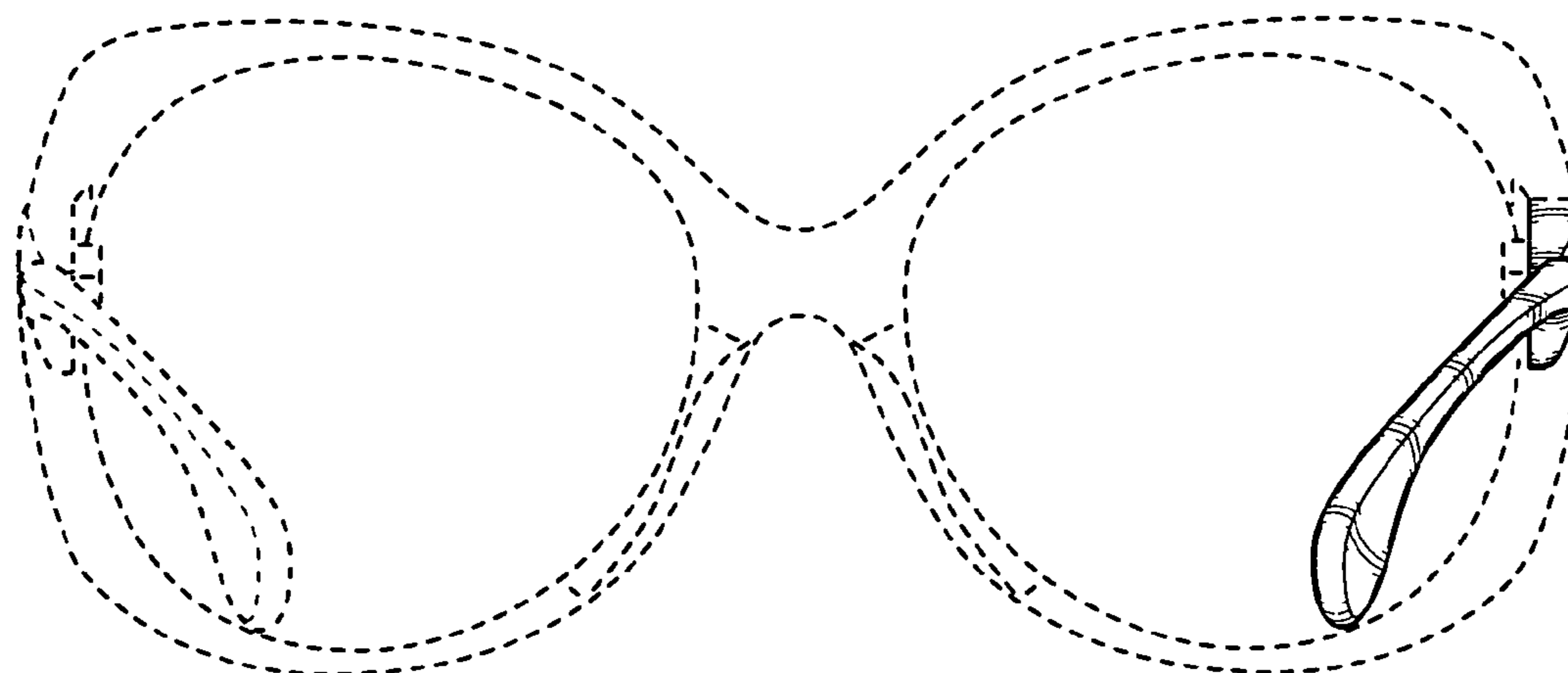

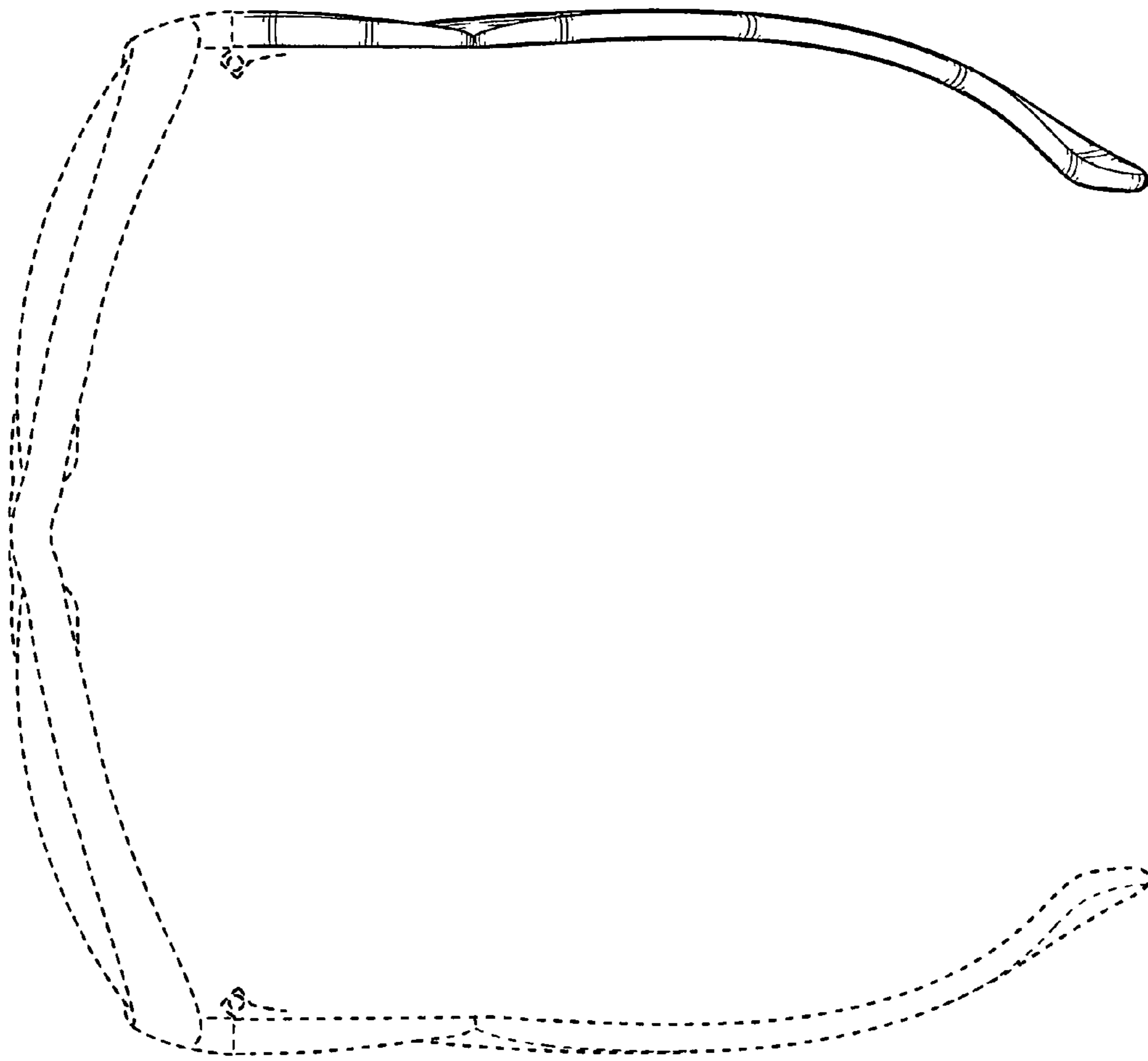

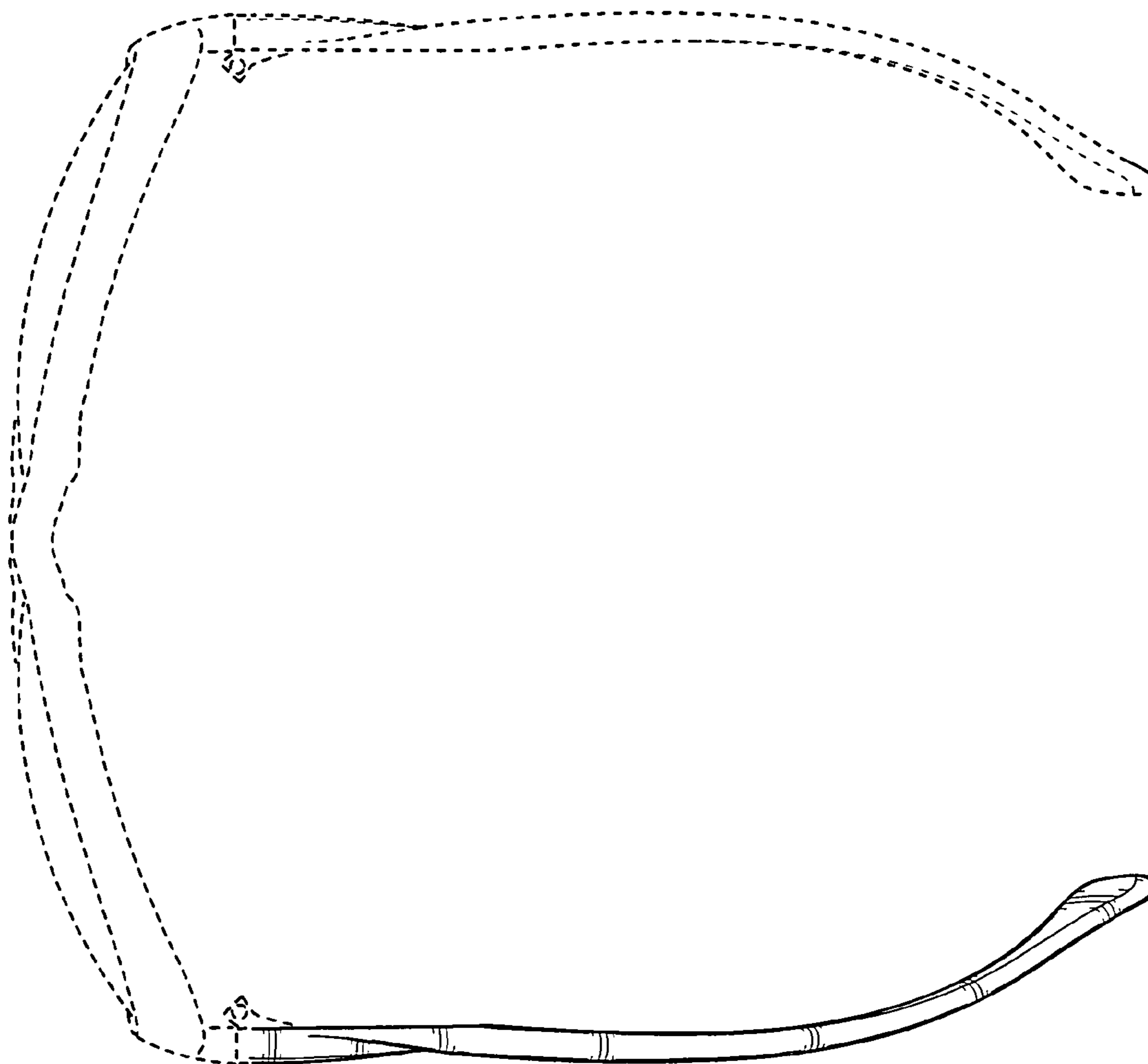
