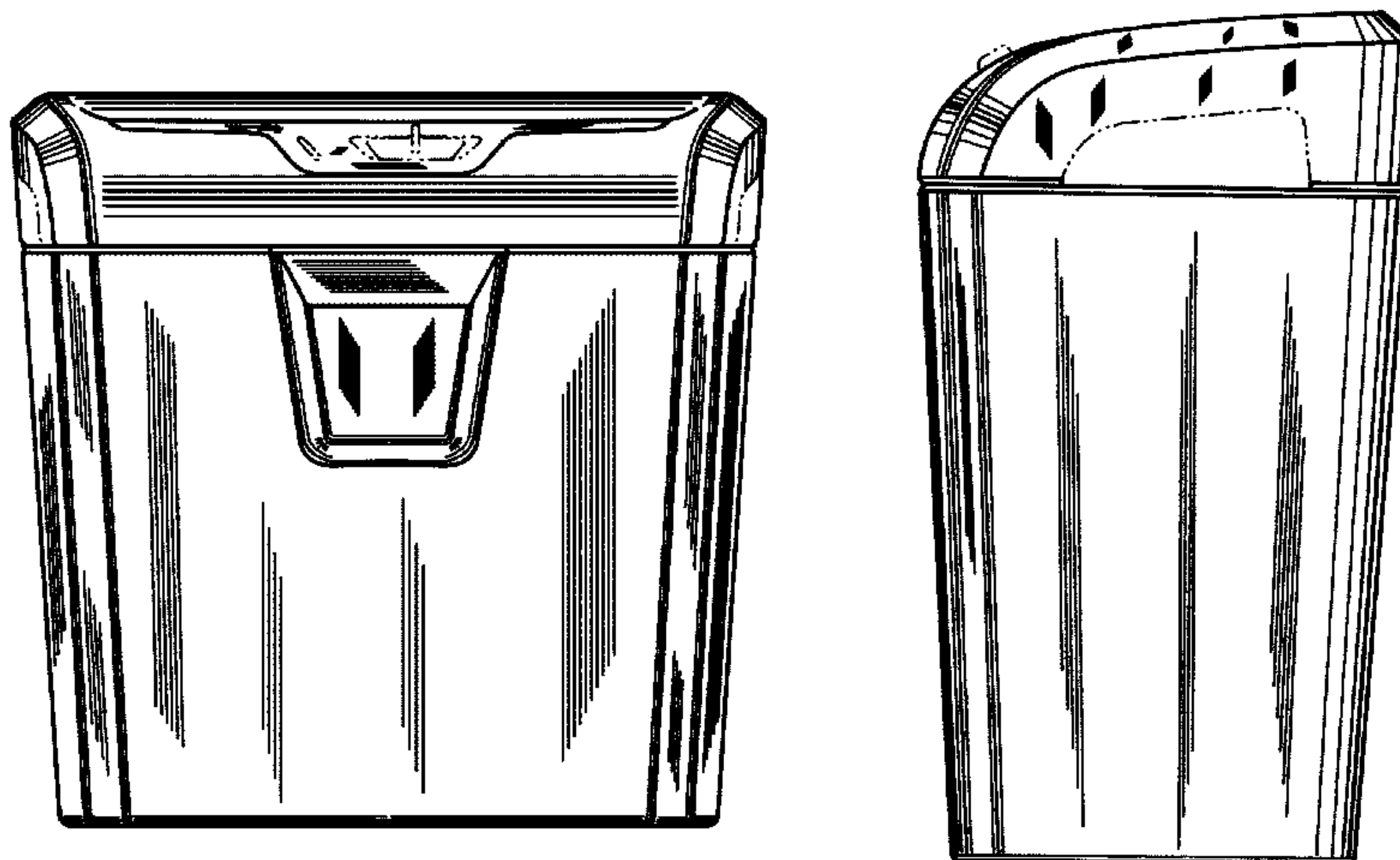
(57) **CLAIM**

The ornamental design for a media shredder, as shown and described.

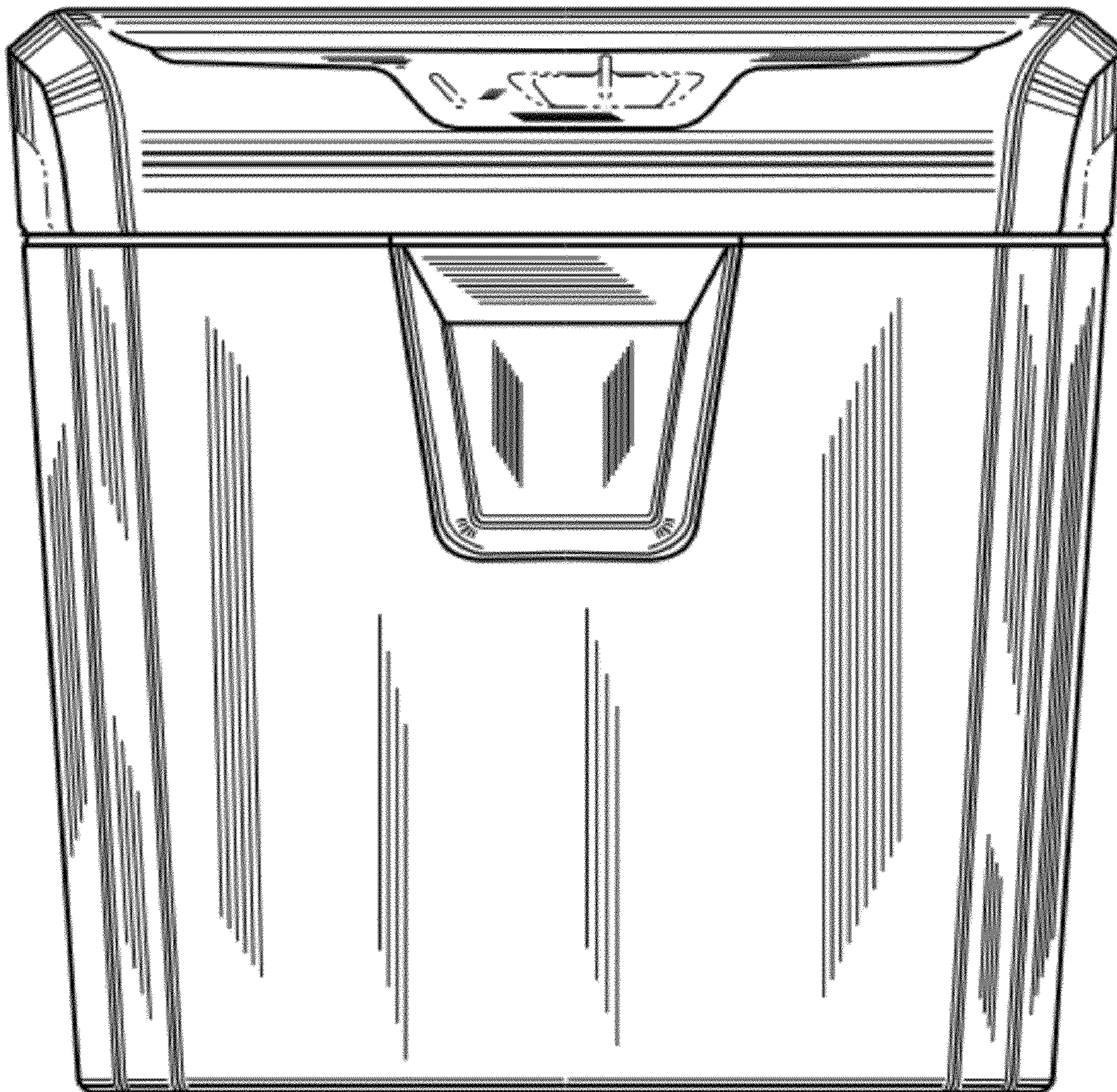
**DESCRIPTION**

FIG. 1 is a front elevational view of a media shredder; FIG. 2 is a left front perspective view thereof; FIG. 3 is right front perspective view thereof; FIG. 4 is a right rear perspective view thereof; FIG. 5 is a right side elevational view thereof, with the left side elevational view being a mirror image thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

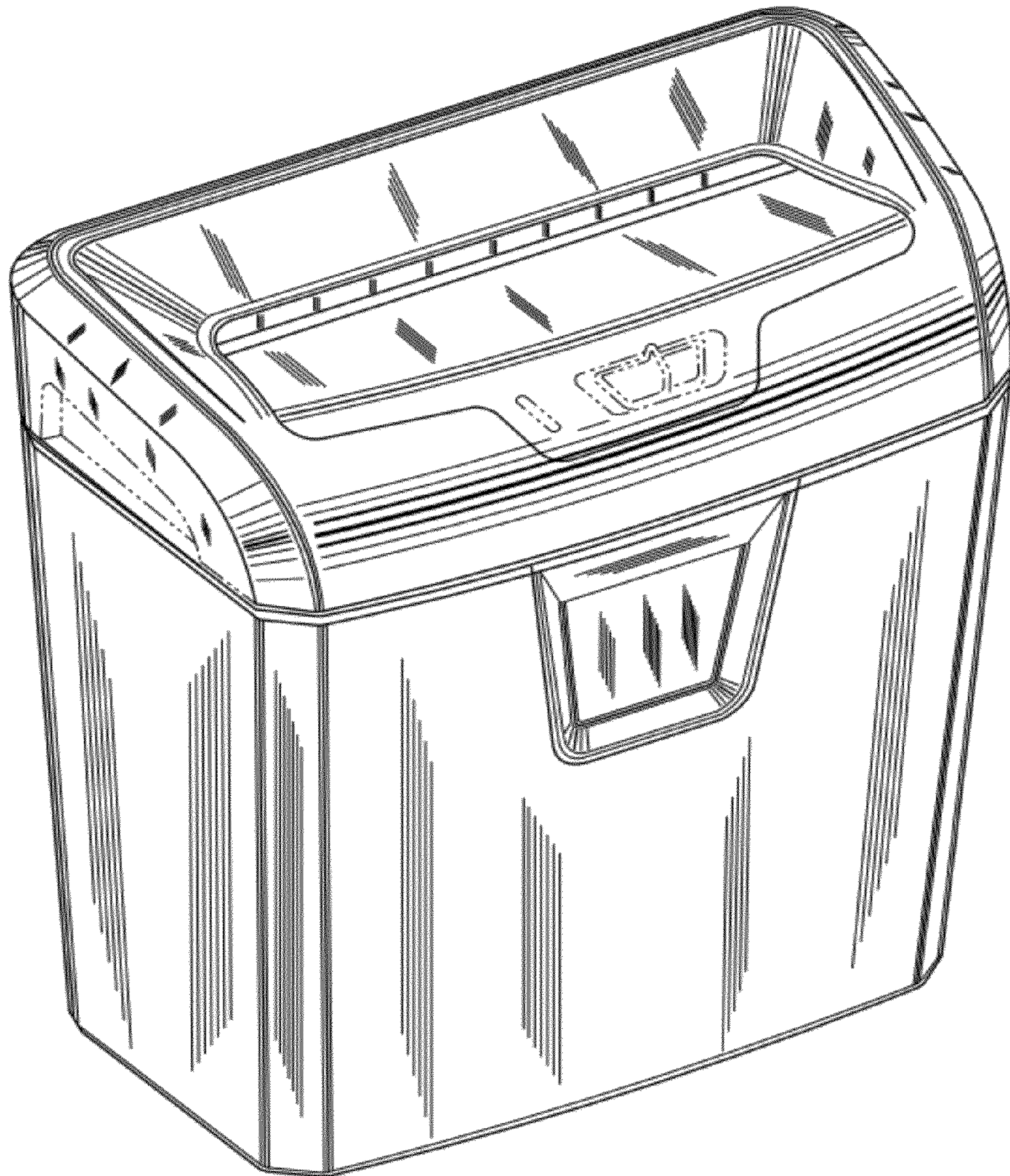






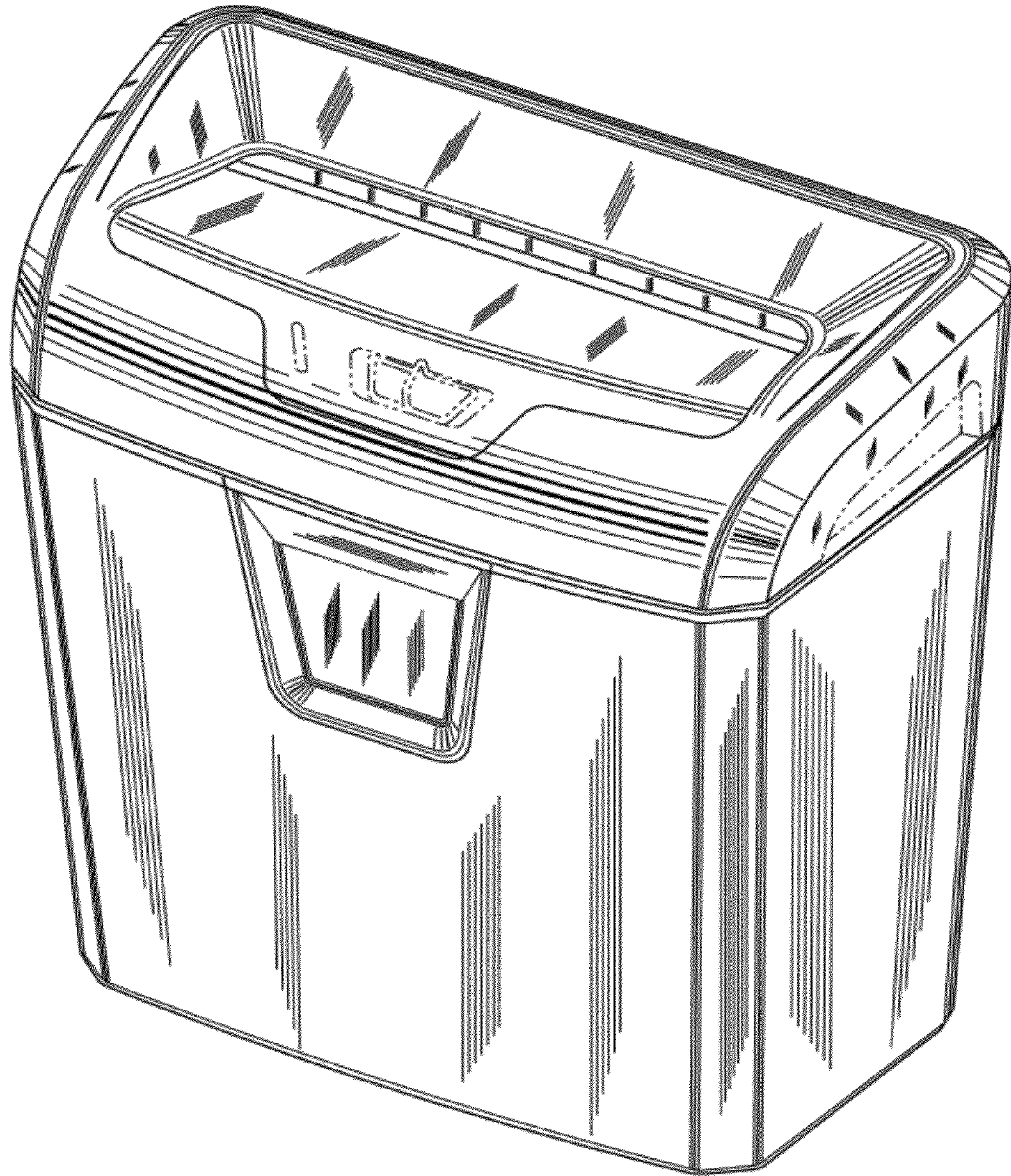

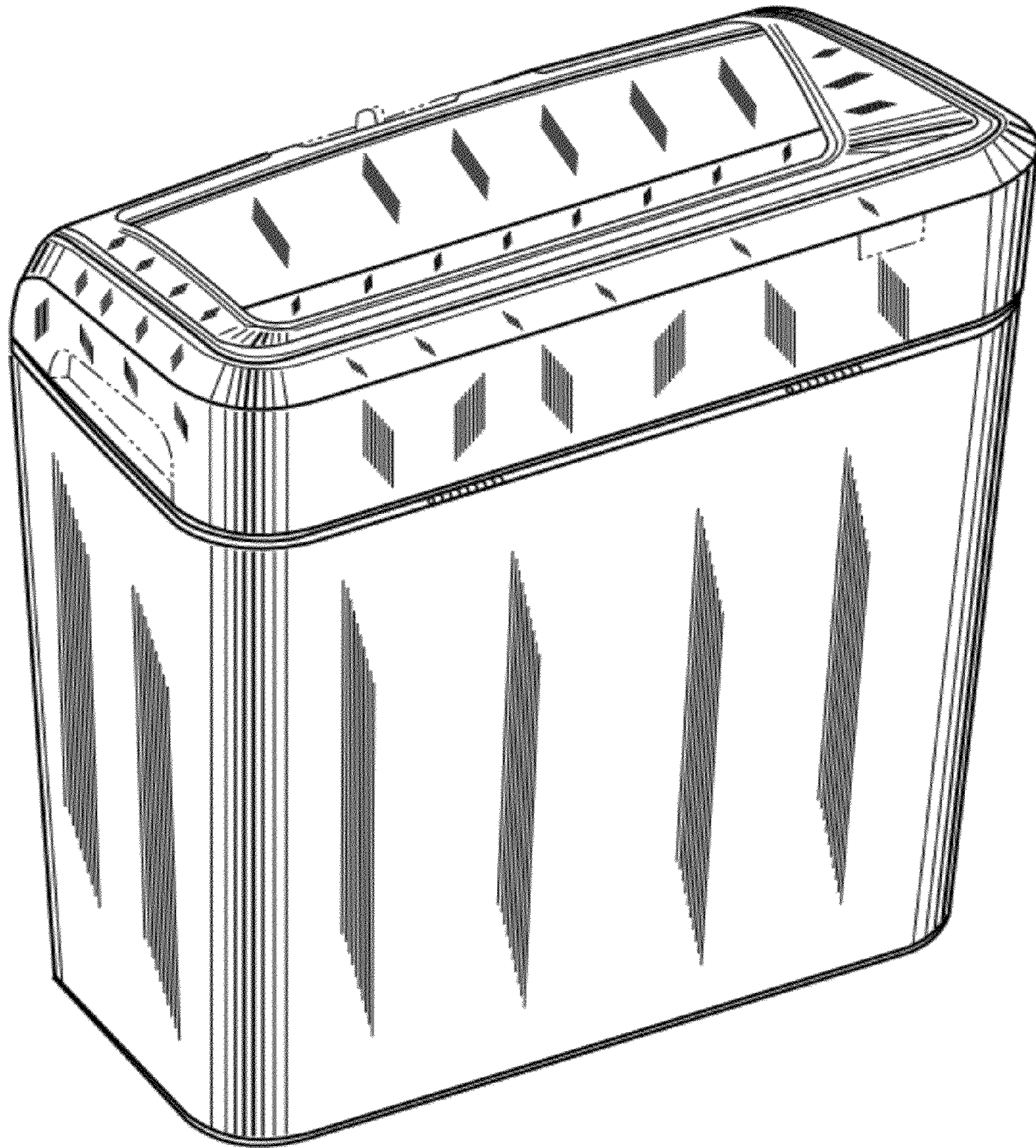

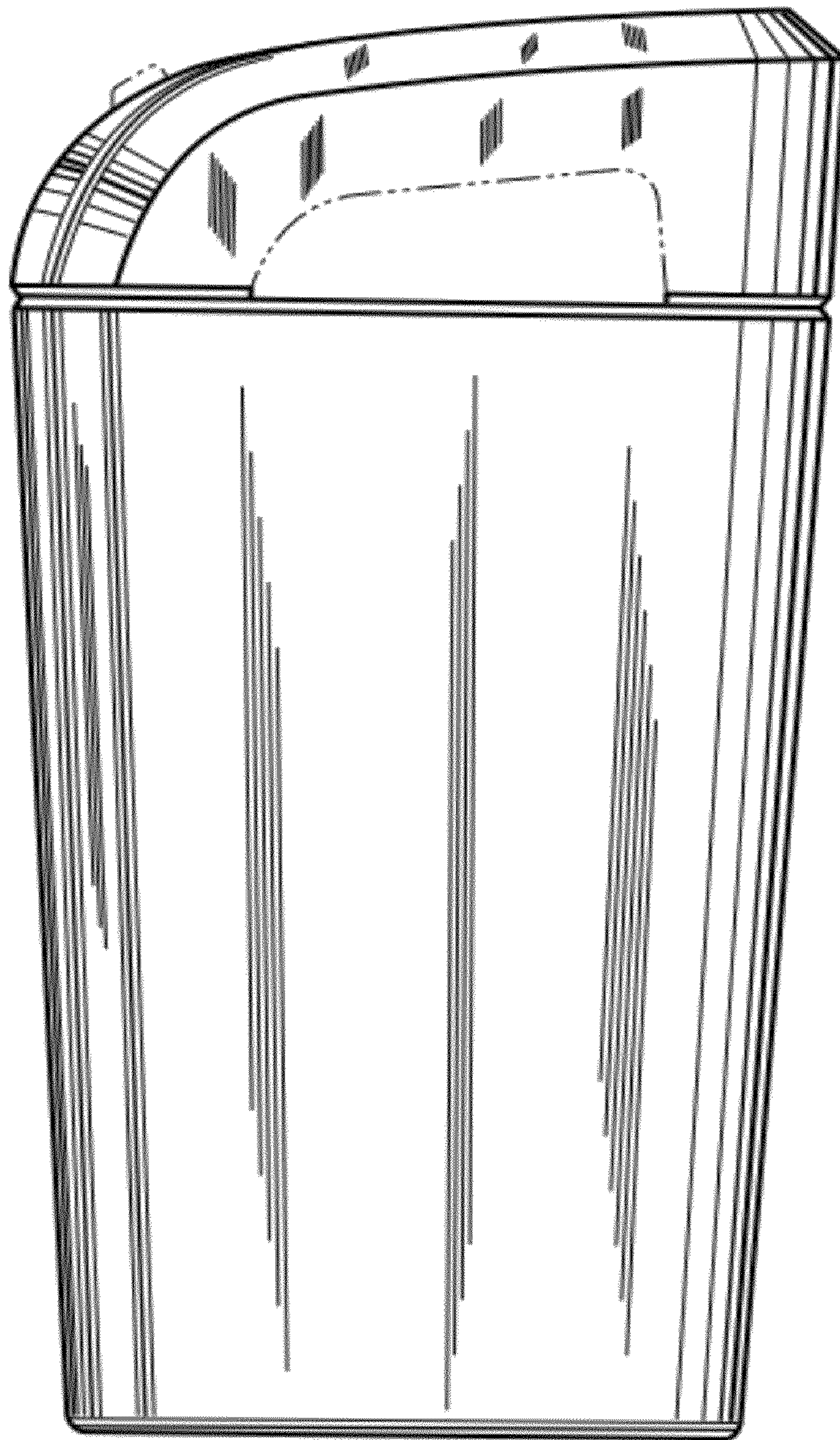
