(57) **CLAIM**

The ornamental design for the scratch ticket, as shown and described.

DESCRIPTION

FIG. 3 is a top view of a third embodiment of the scratch ticket.

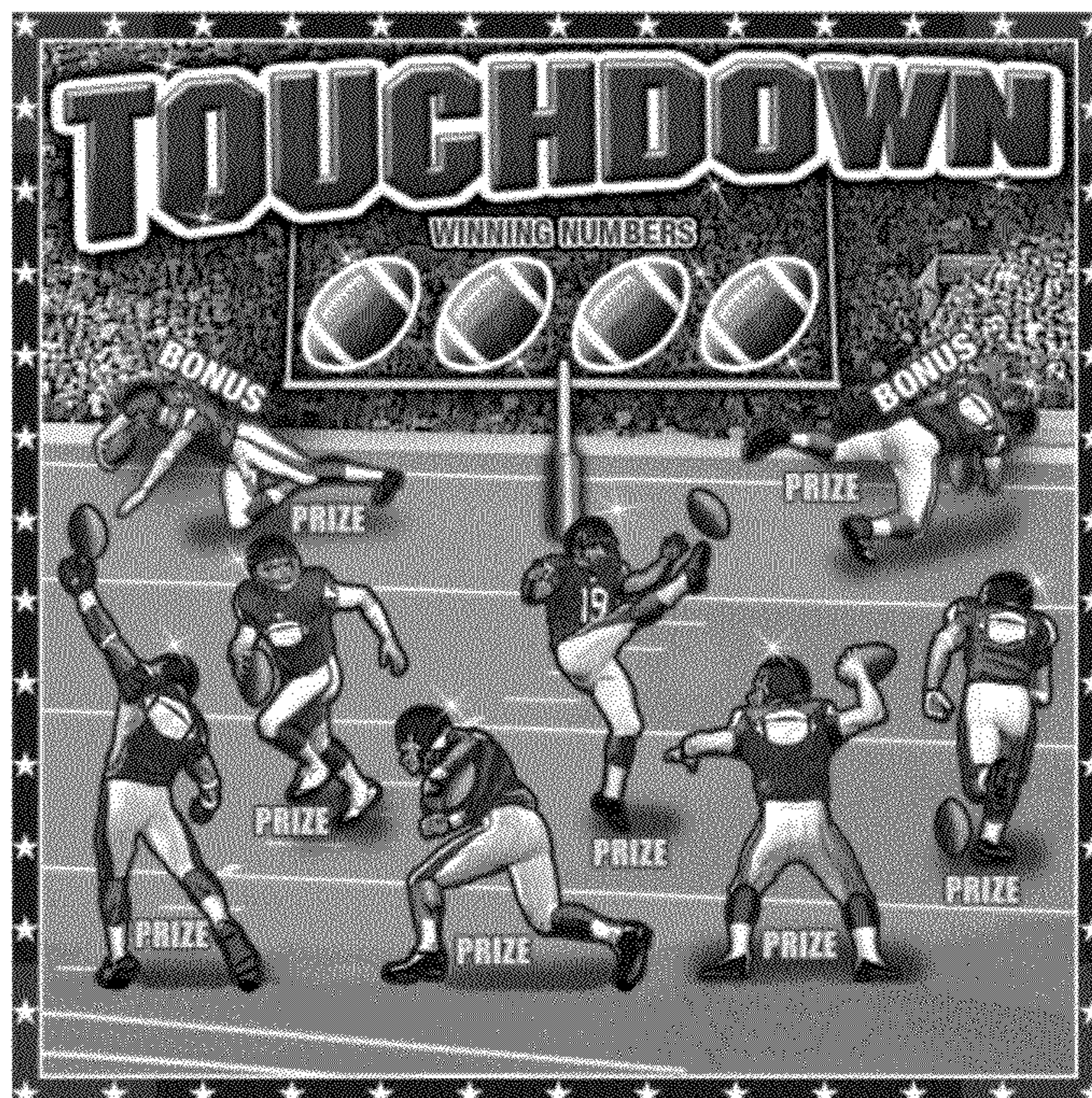
FIG. 4 is a top view of a fourth embodiment of the scratch ticket, exhibiting a particular combination of colors.

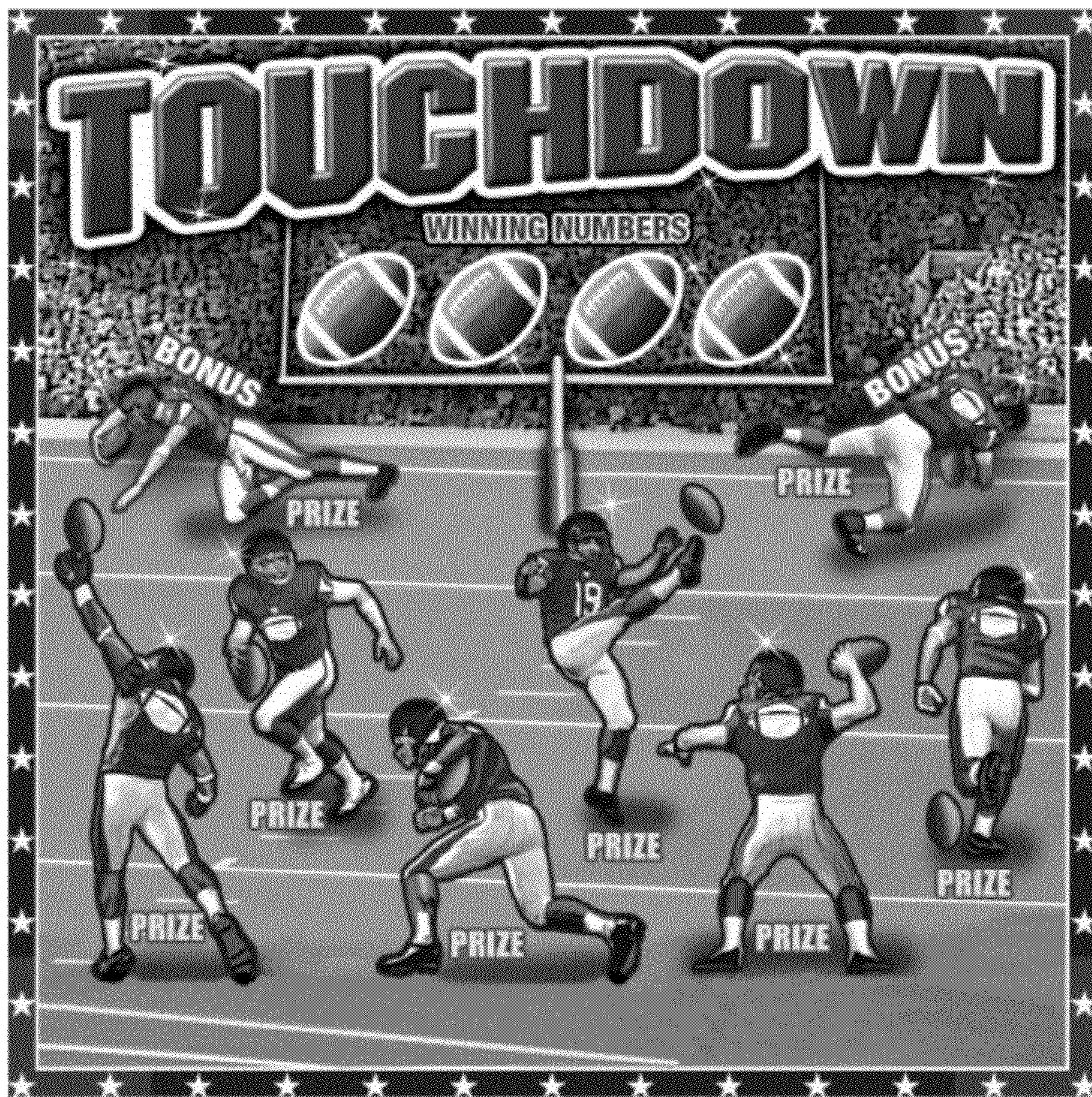

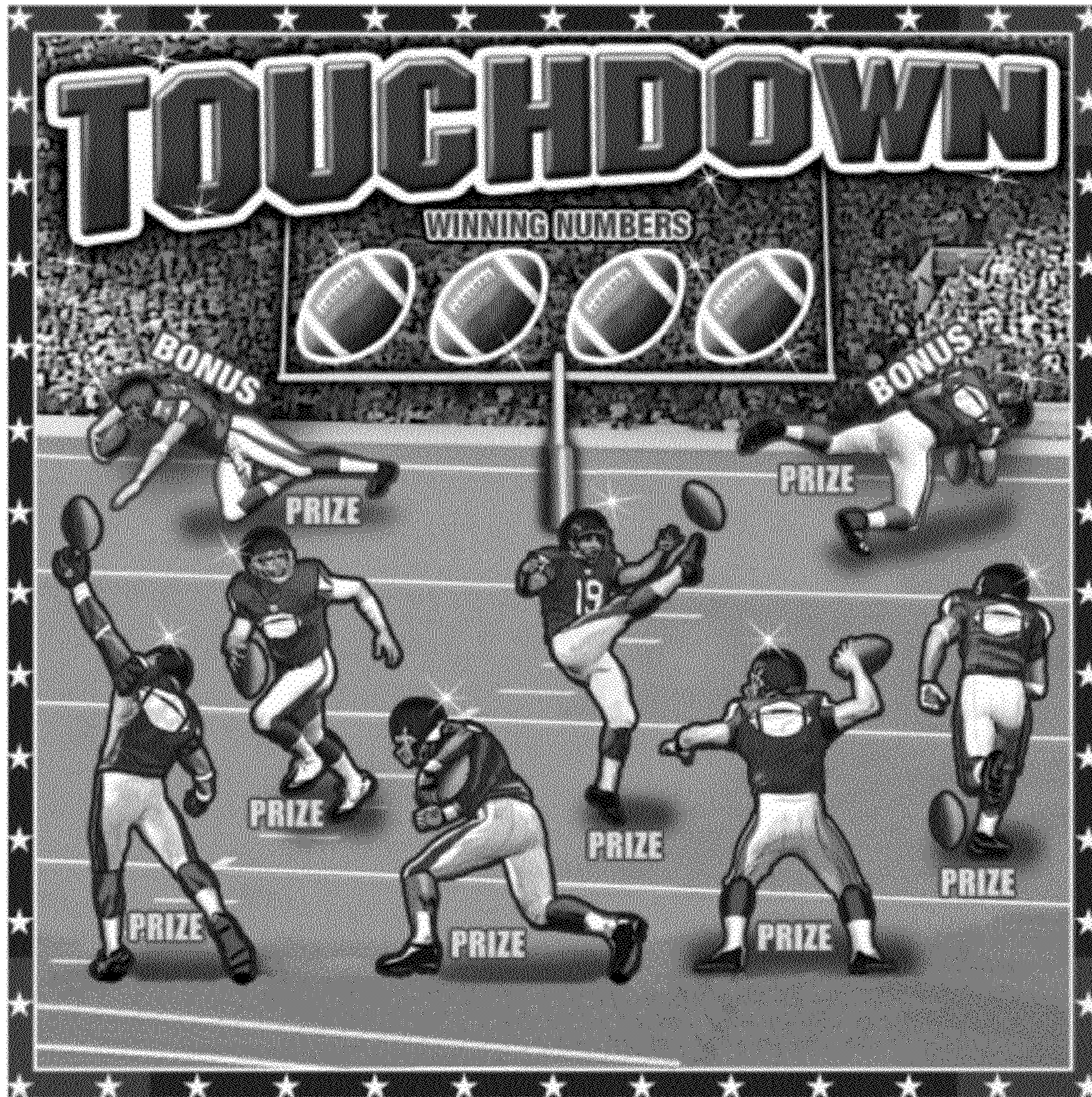

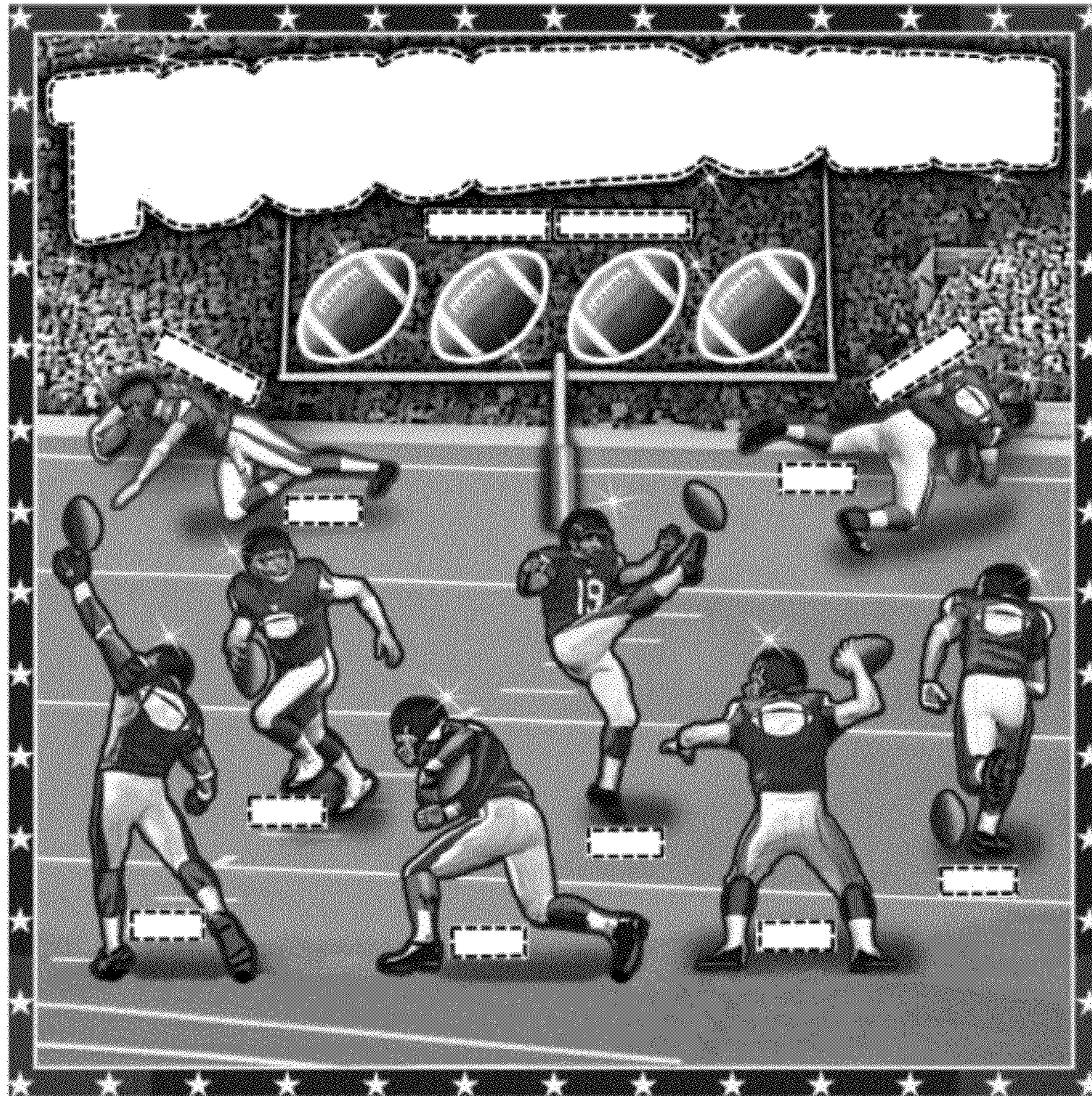

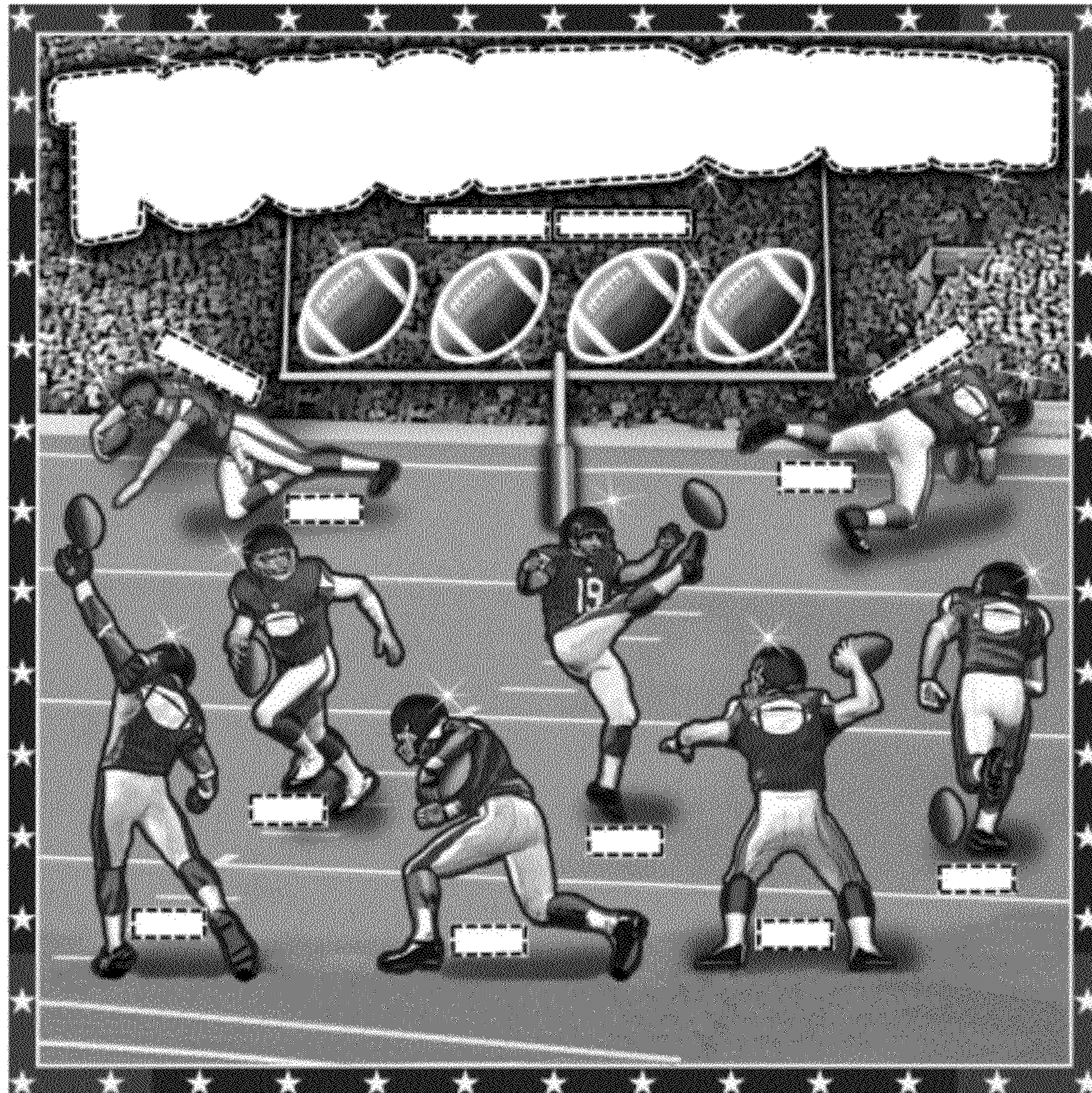

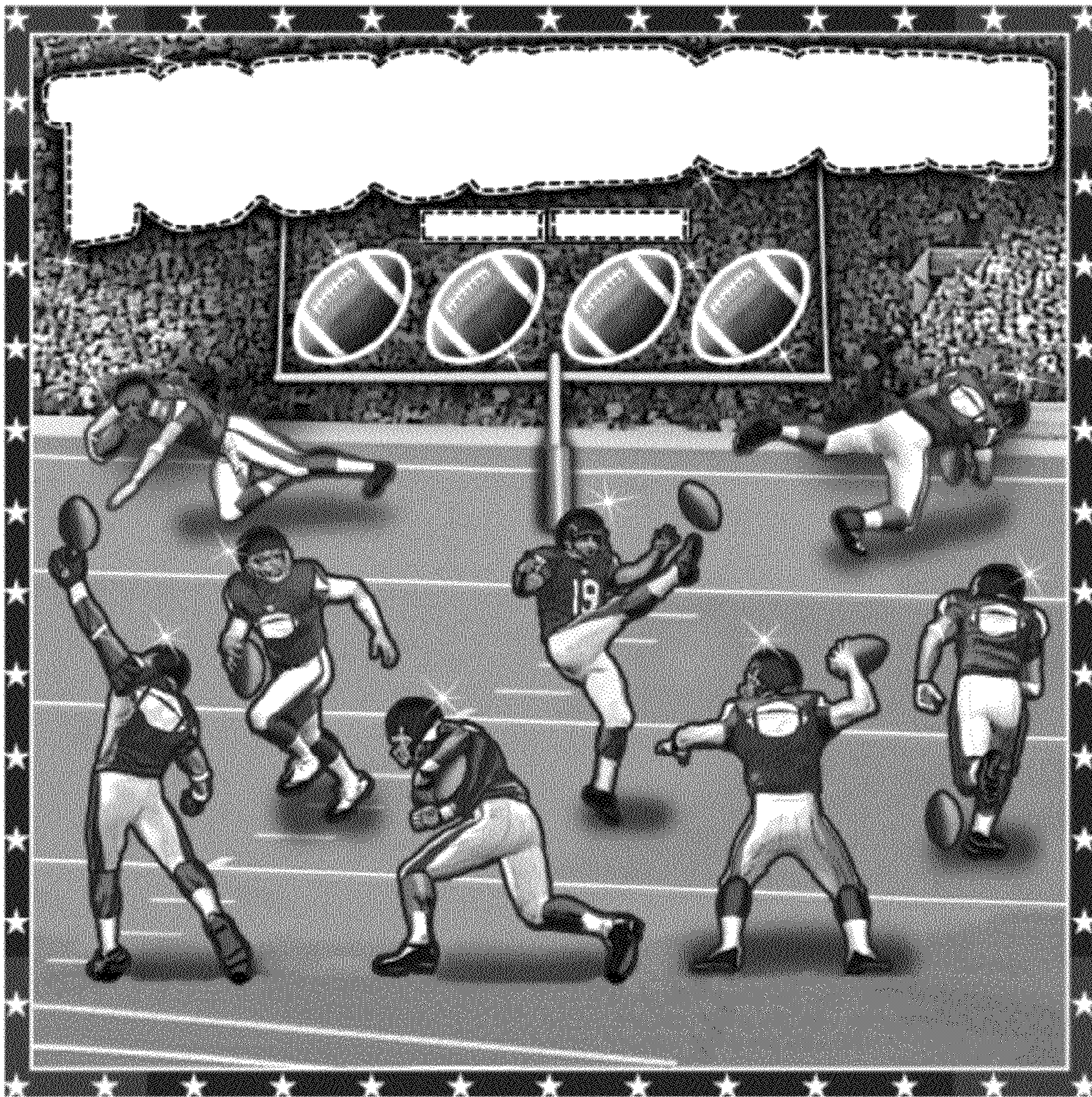

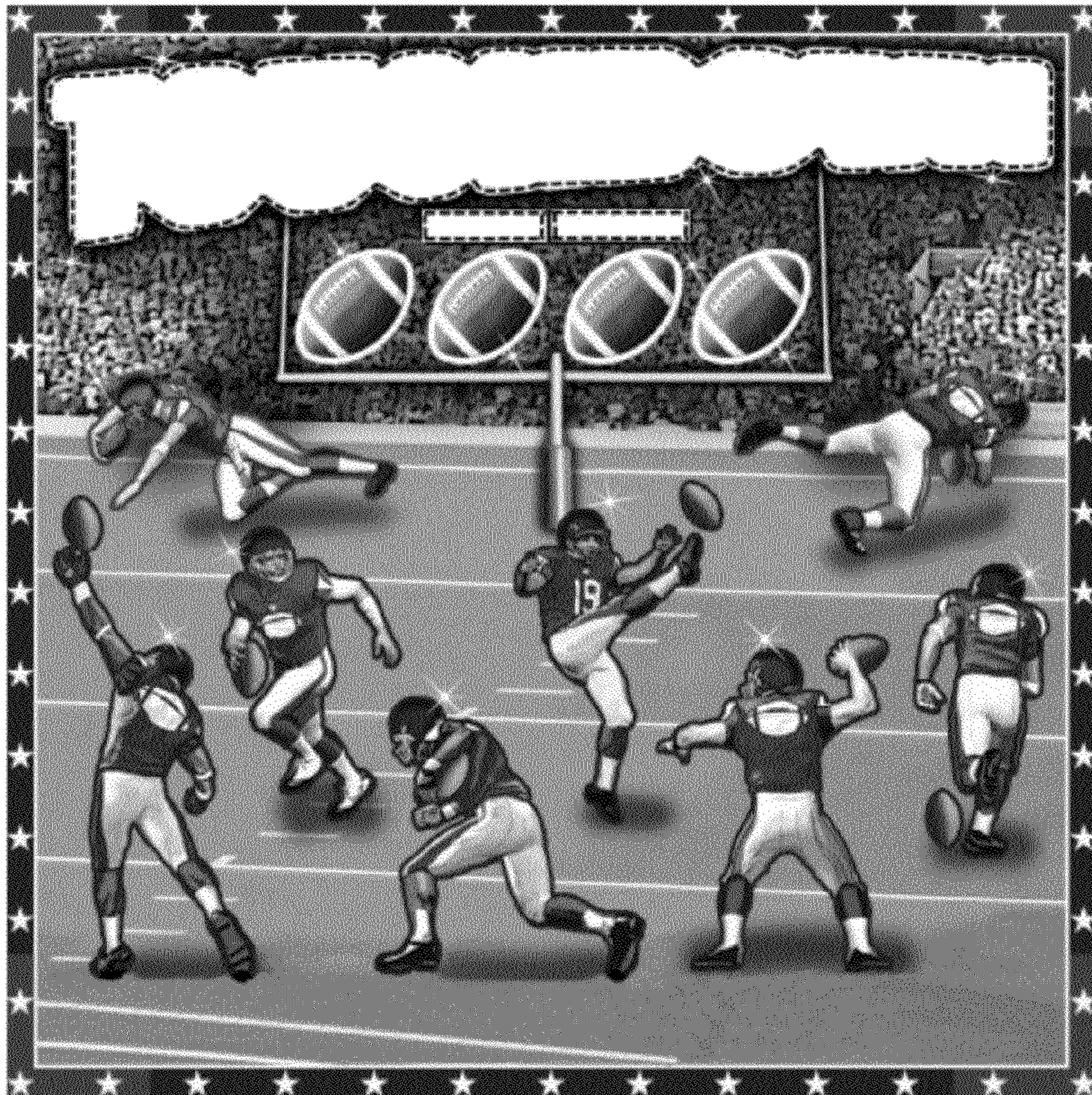
