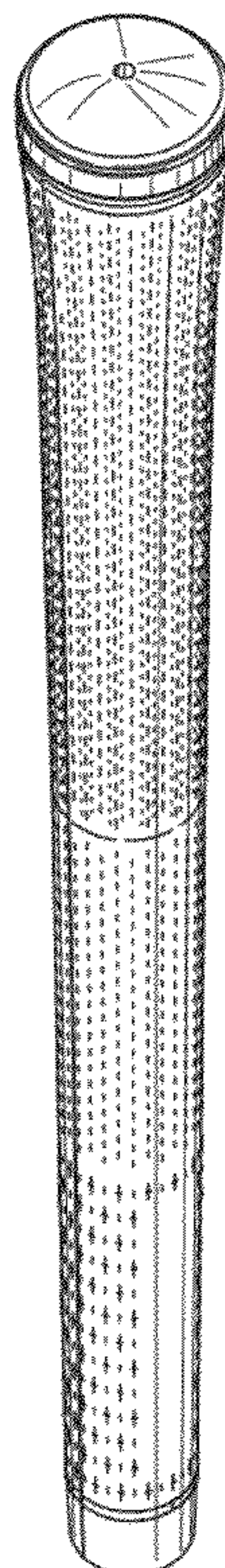
(57) **CLAIM**

The ornamental design for a golf grip, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the golf grip;

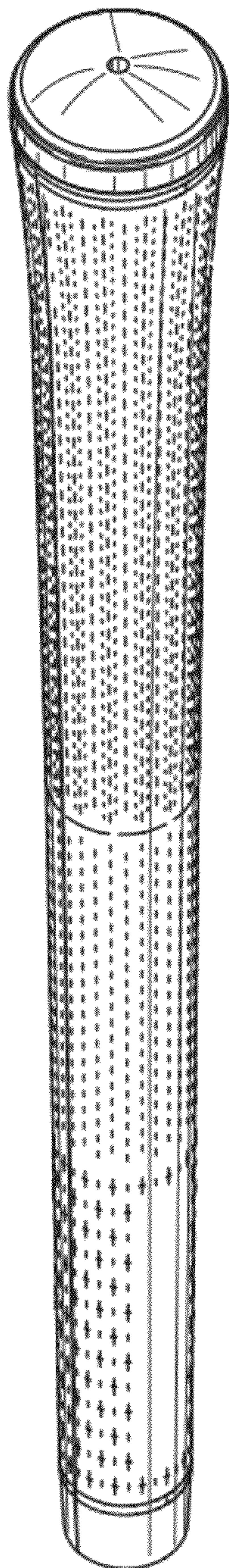

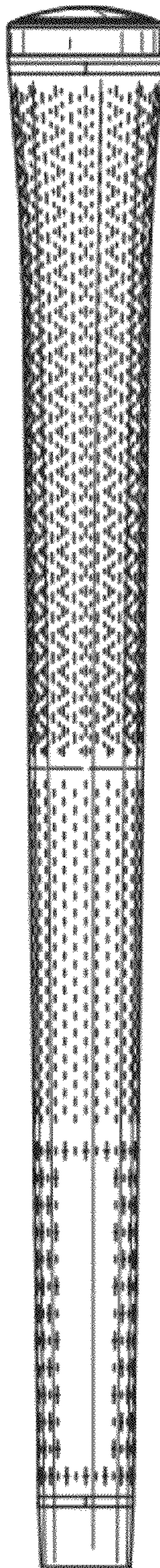

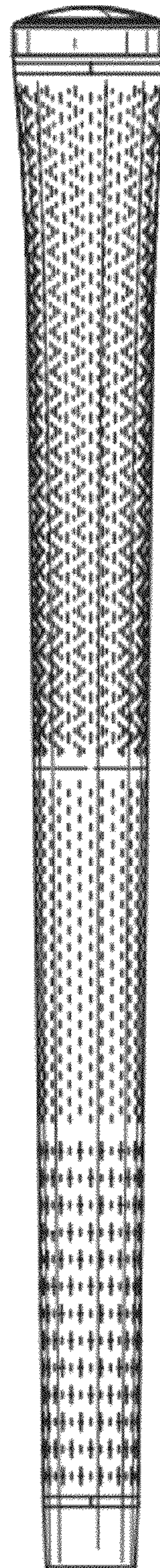

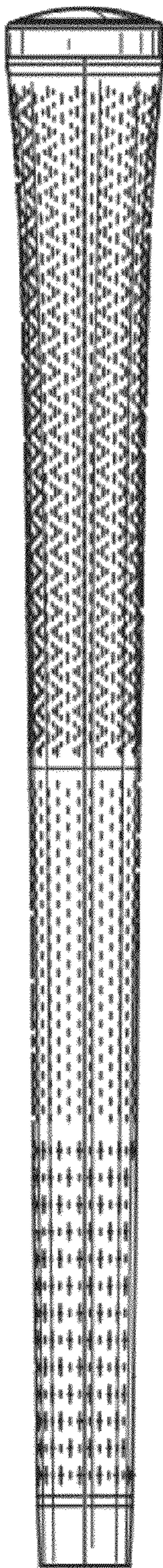

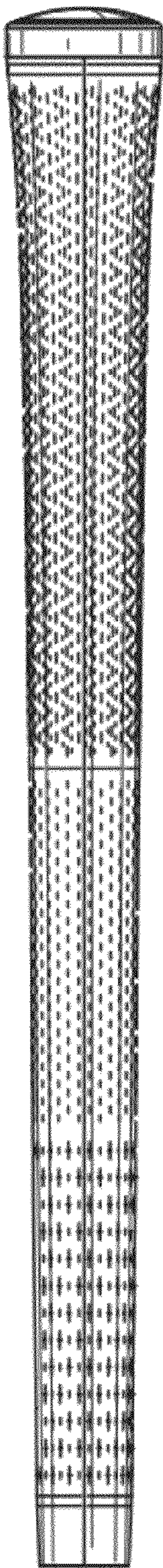

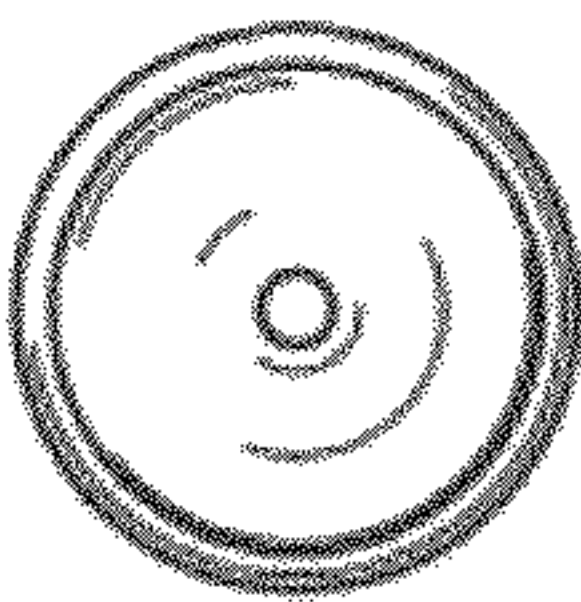

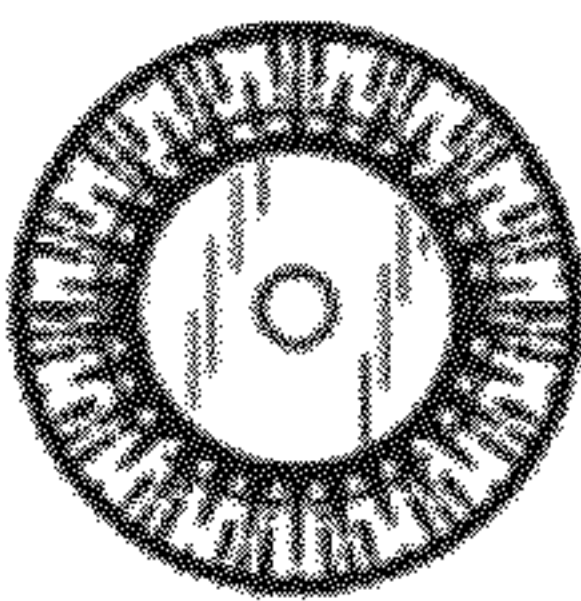
