The ornamental design for a tool grip, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a tool grip showing our new design;

FIG. 2 is a front elevation view thereof;

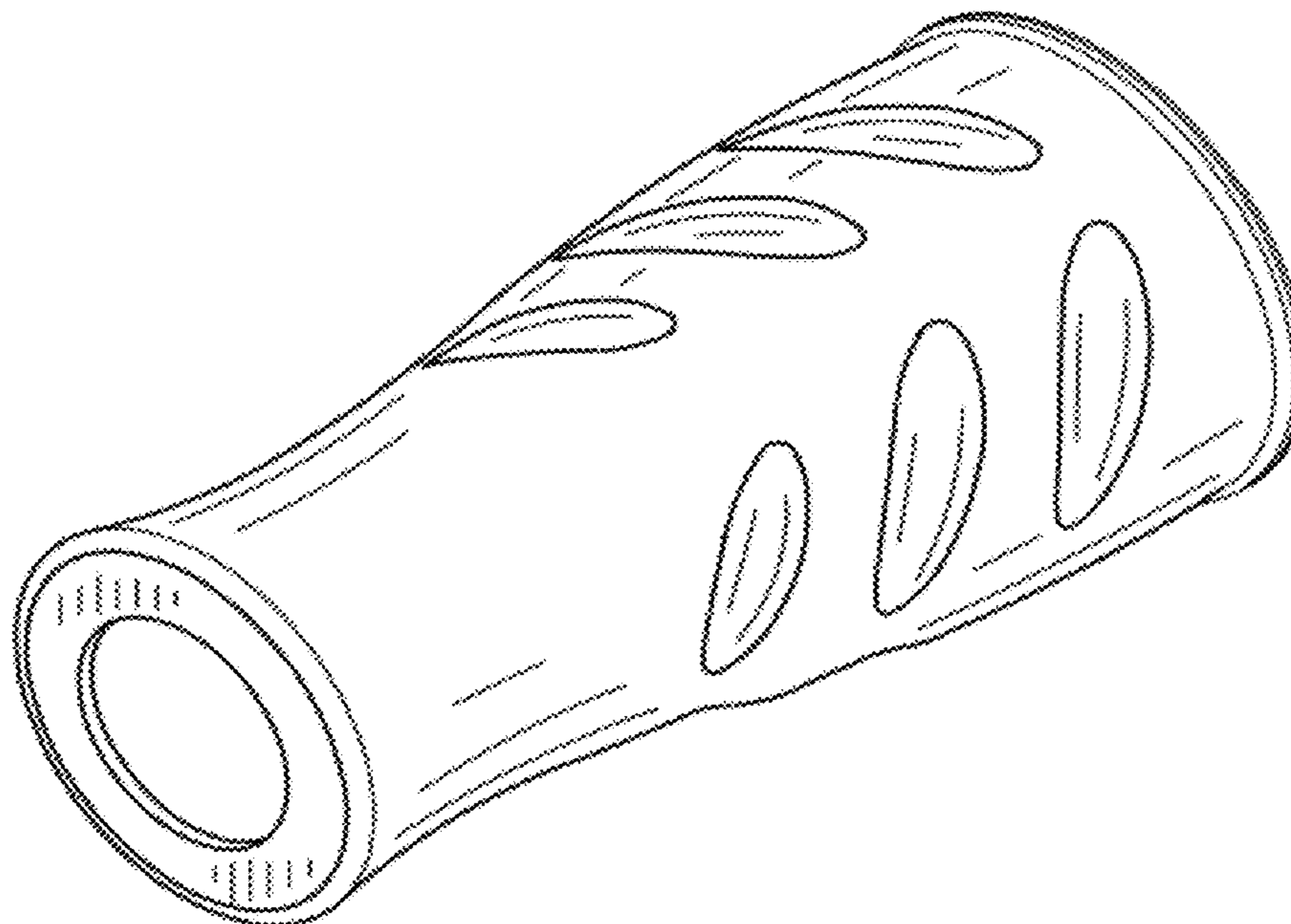
FIG. 3 is a rear elevation view thereof;

FIG. 4 is a top plan view thereof, the bottom plan view being a mirror image thereof; and,

FIG. 5 is a right side elevation view thereof, the left side view being a mirror image thereof.

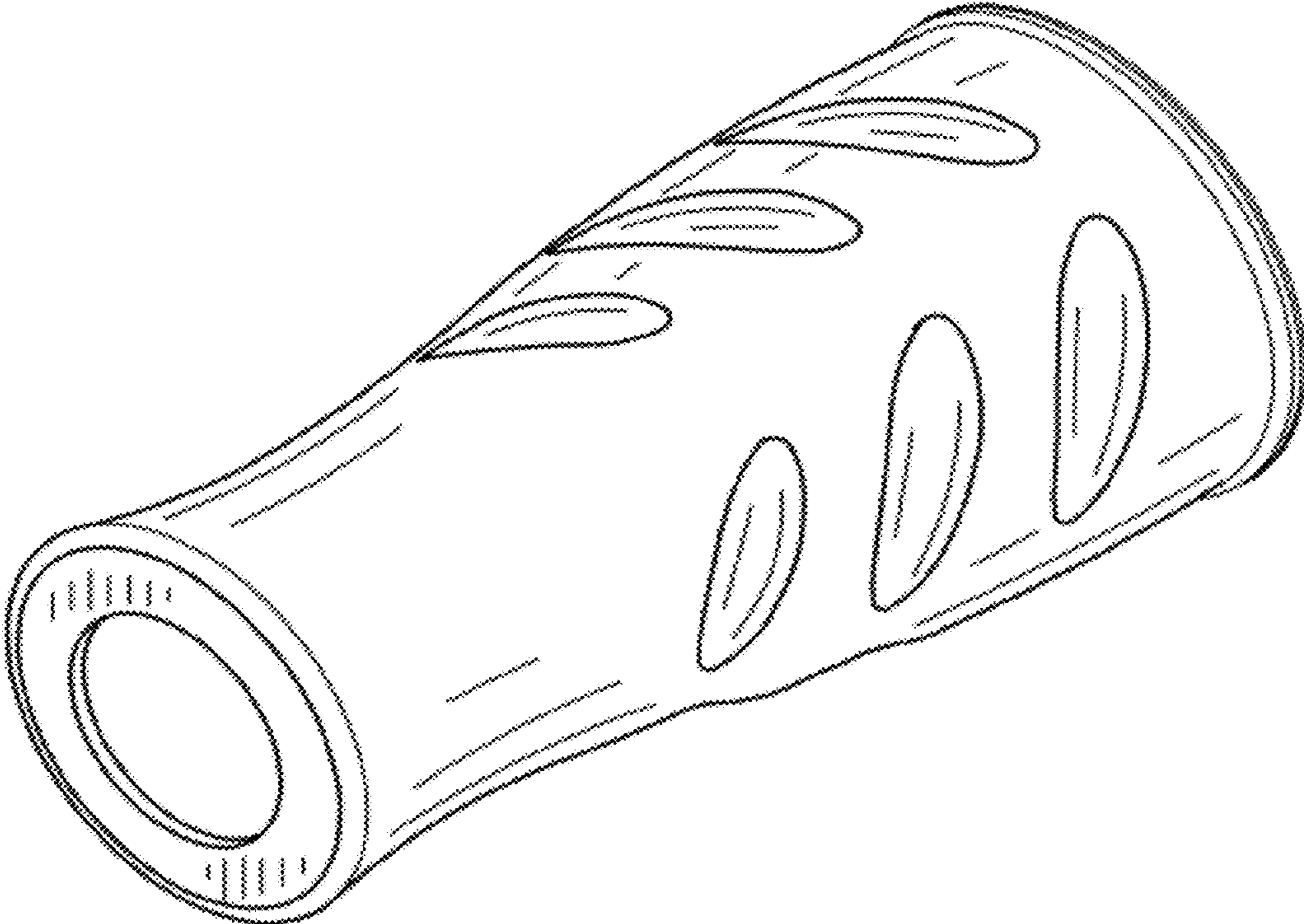

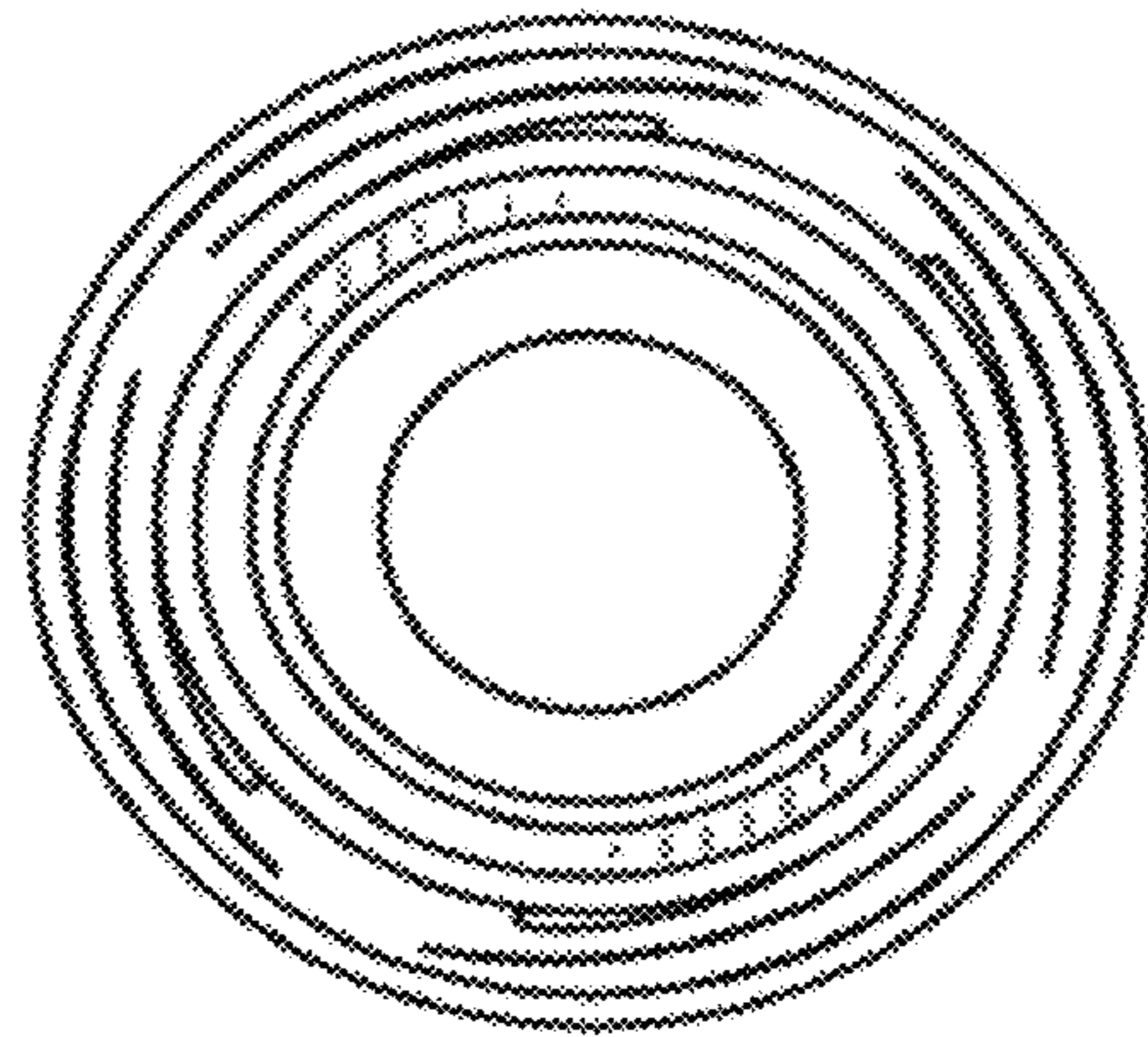

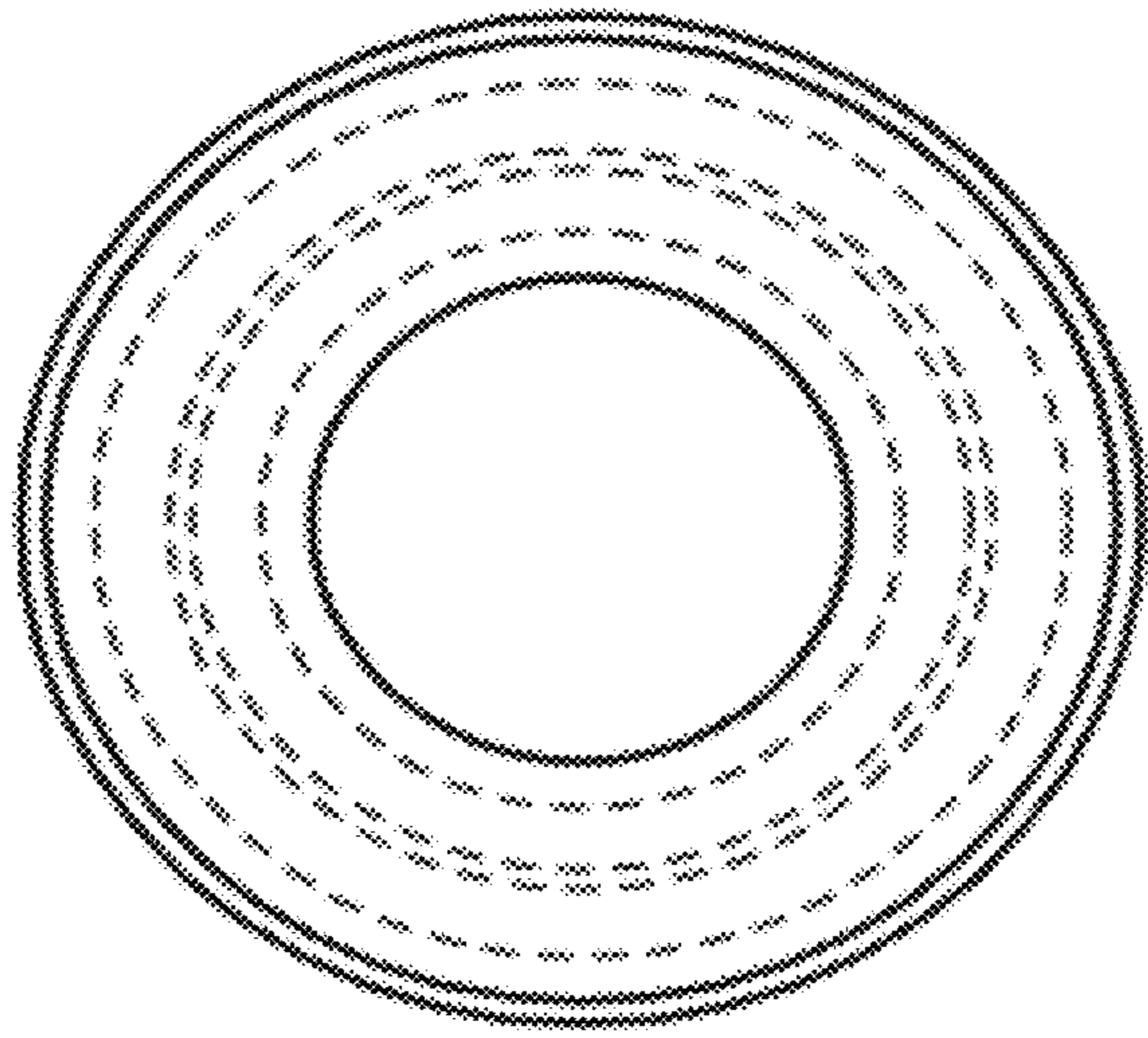

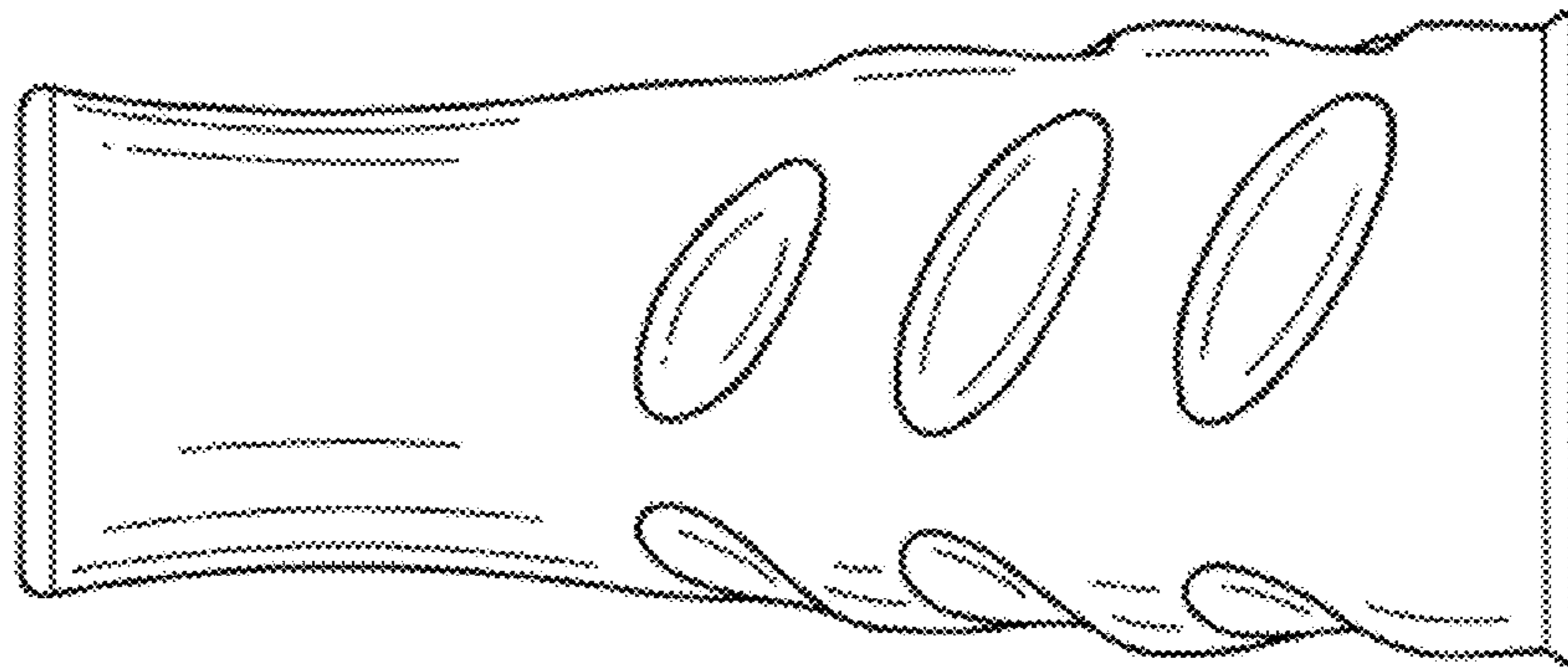

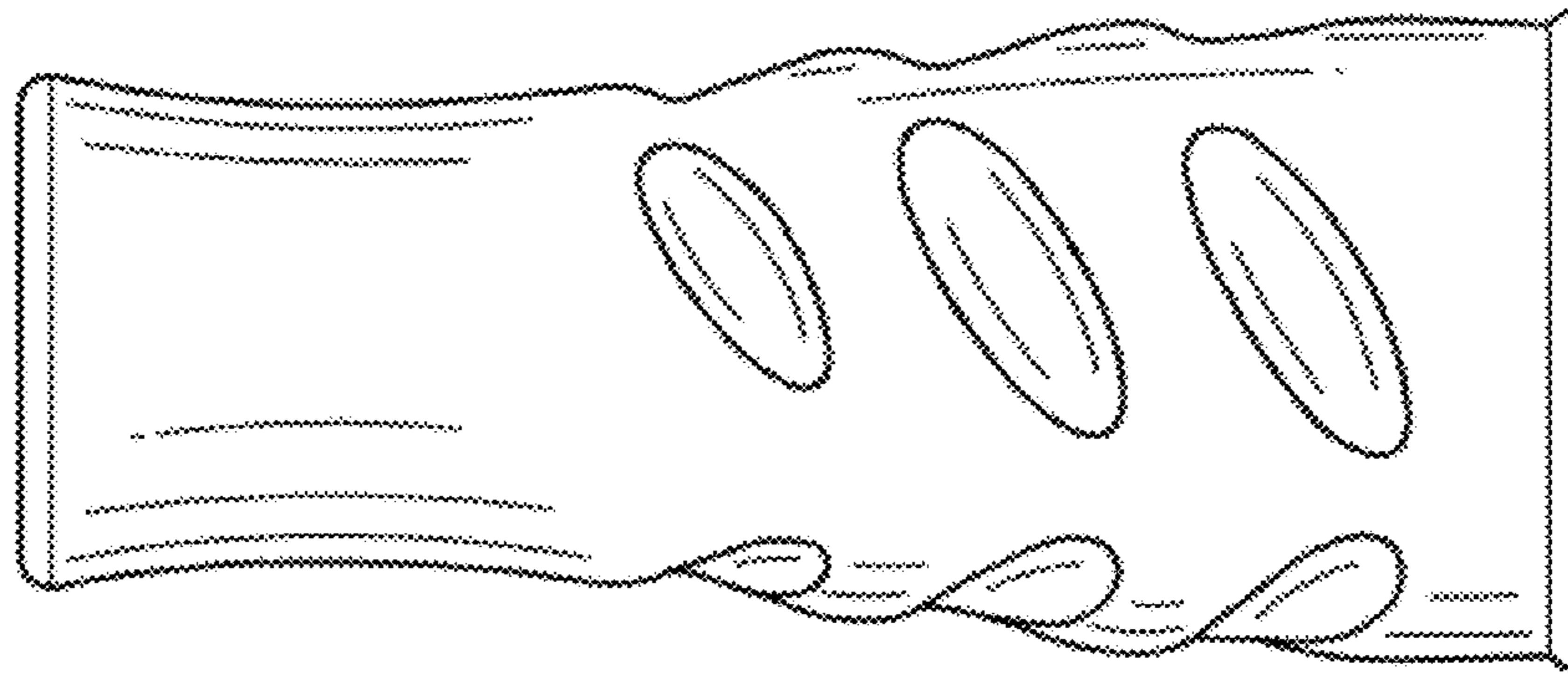
