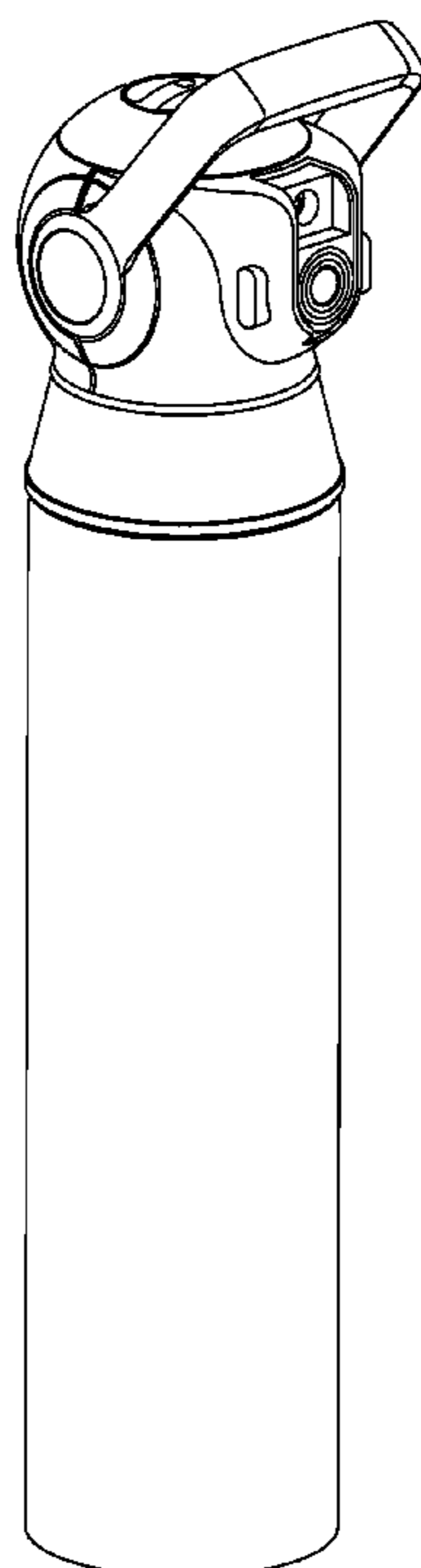
(57) **CLAIM**

The ornamental design for a gas cylinder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a gas cylinder in accordance with the design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a rear view thereof with a cover removed;  
FIG. 6 is an enlarged top view thereof;  
FIG. 7 is a front and left side perspective view thereof;  
FIG. 8 is a front and right side perspective view thereof; and,  
FIG. 9 is a rear and right side perspective view thereof.  
The broken lines in FIG. 6 are included for the purpose of illustrating a portion of the gas cylinder that forms no part of the claimed design.

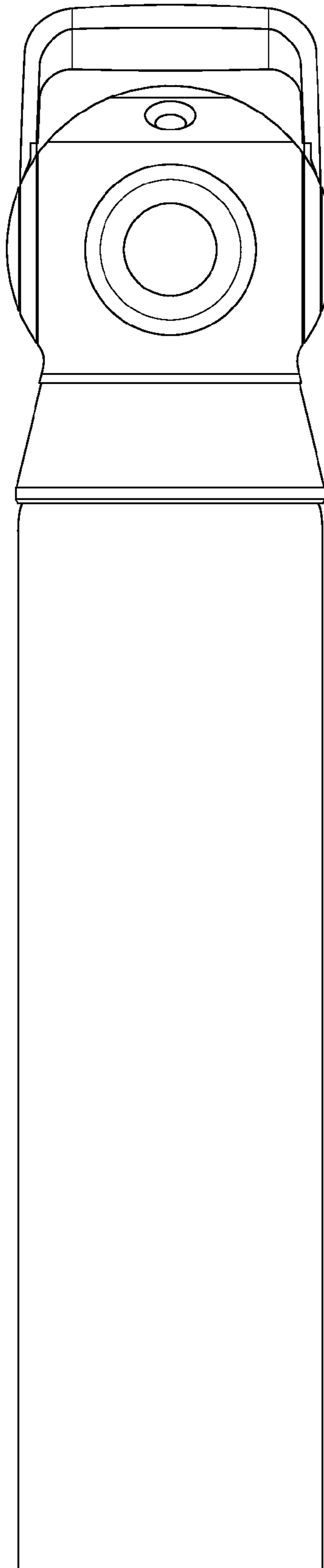

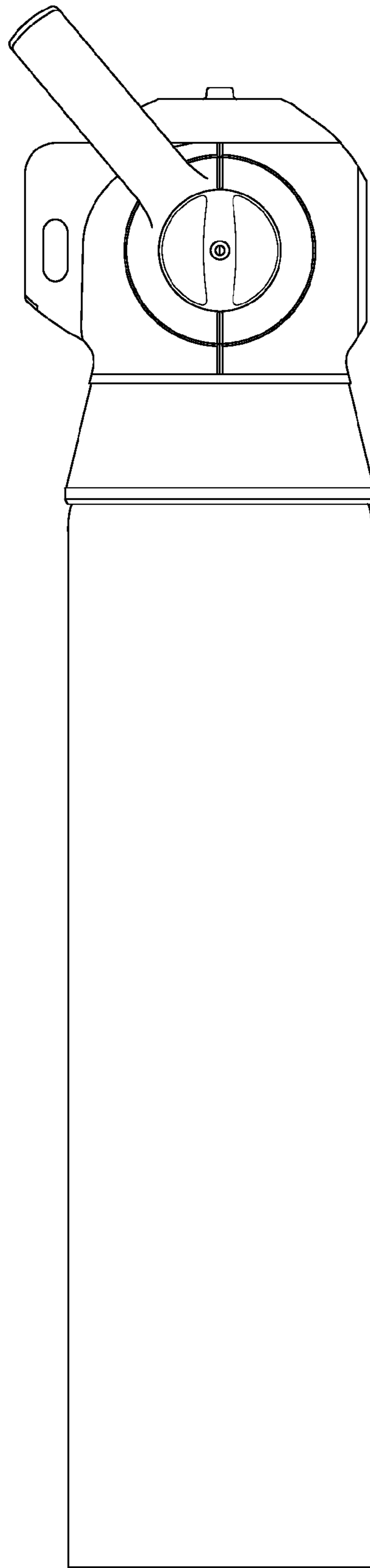

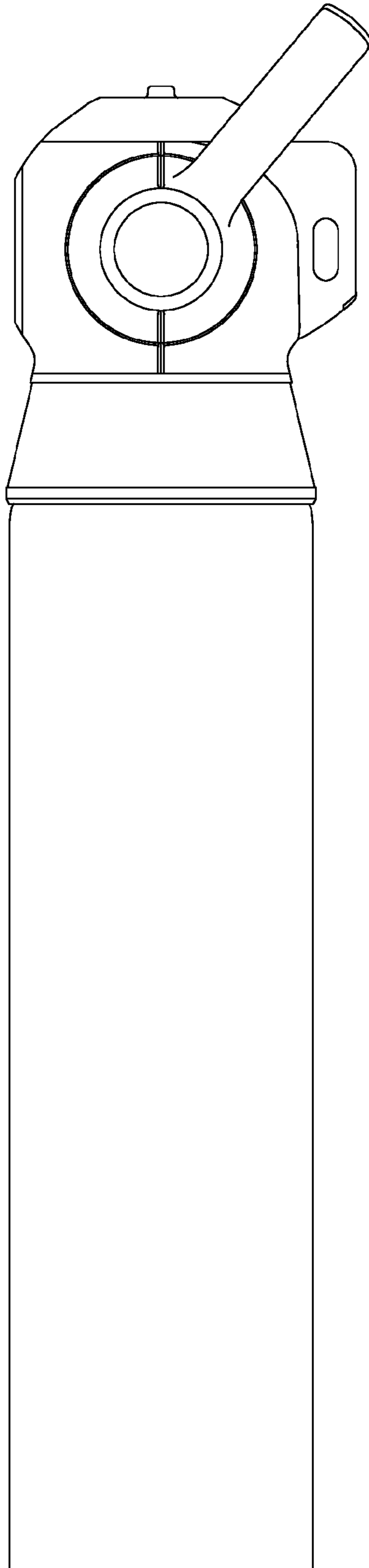

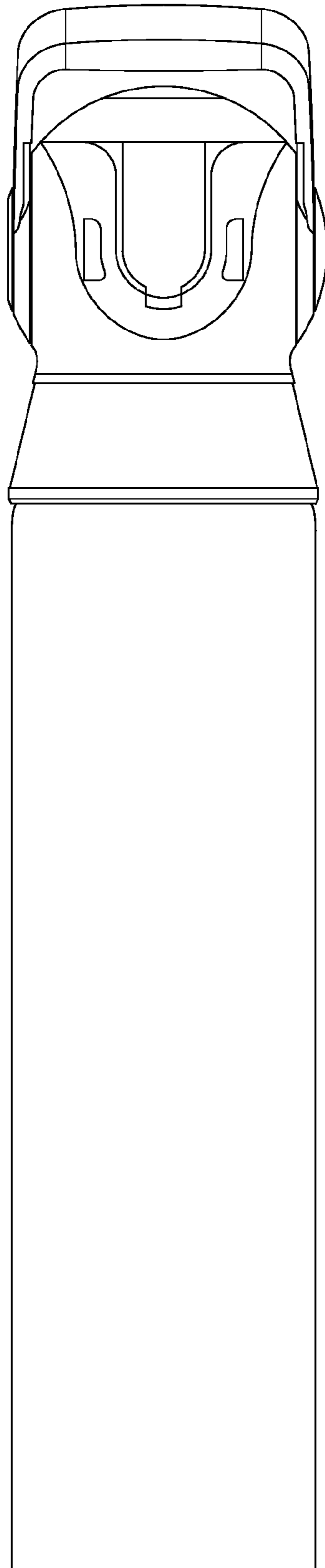

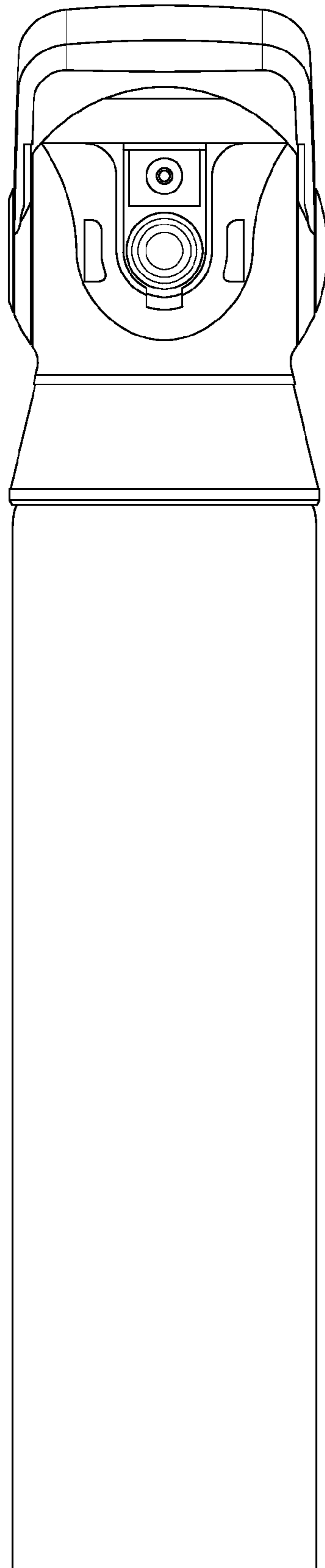

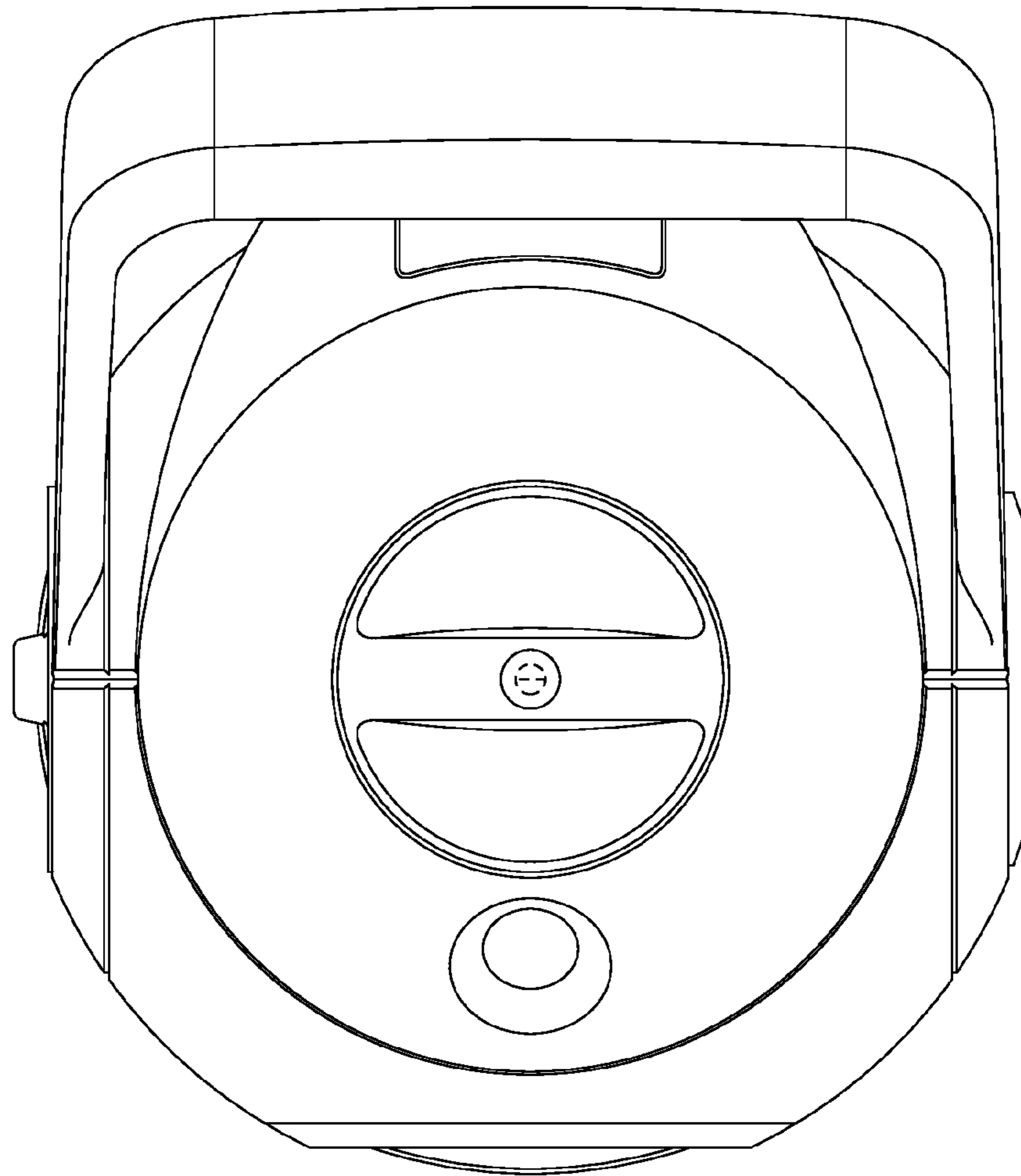

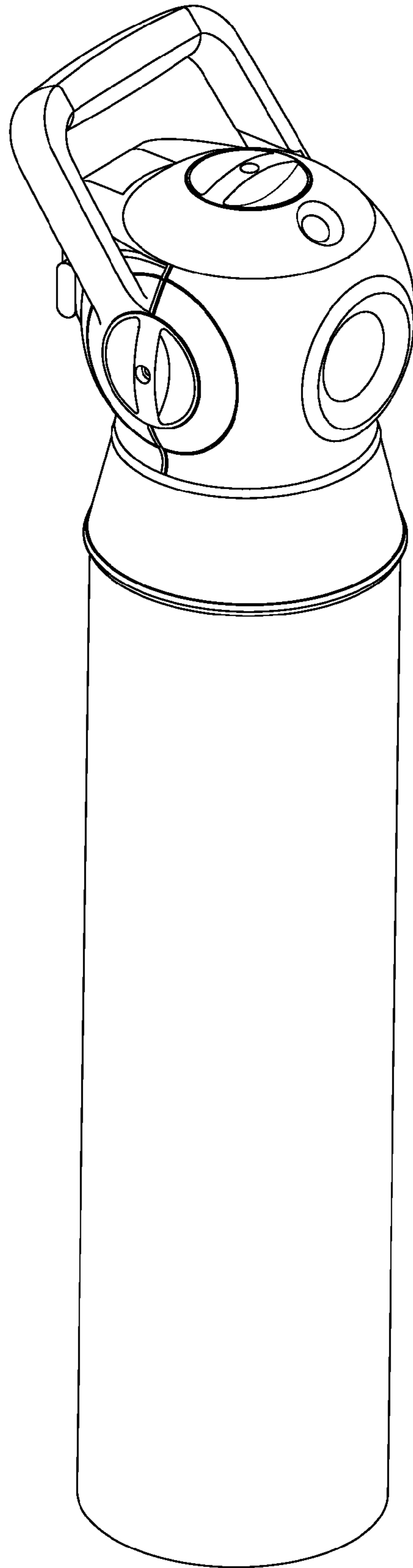

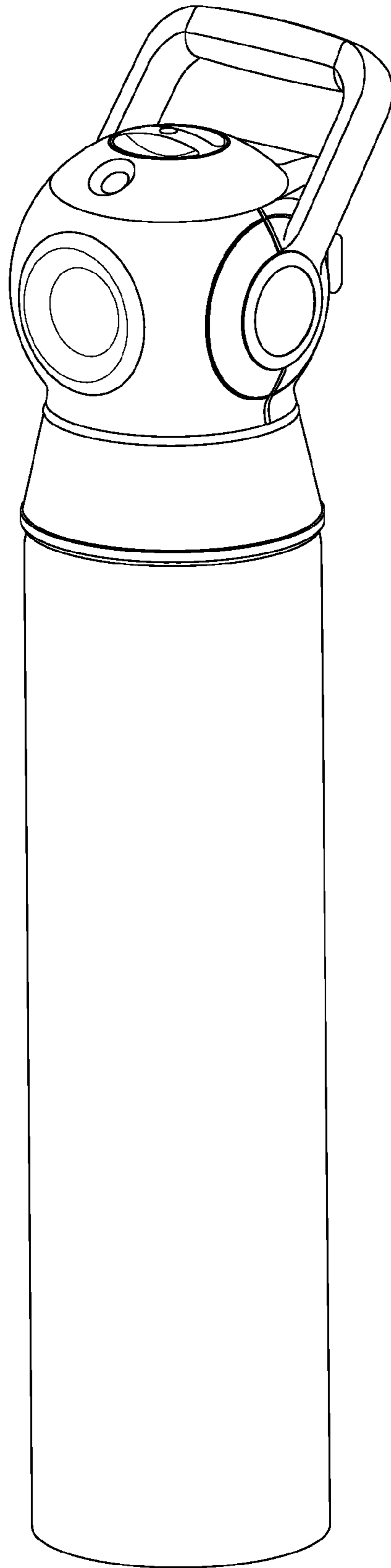

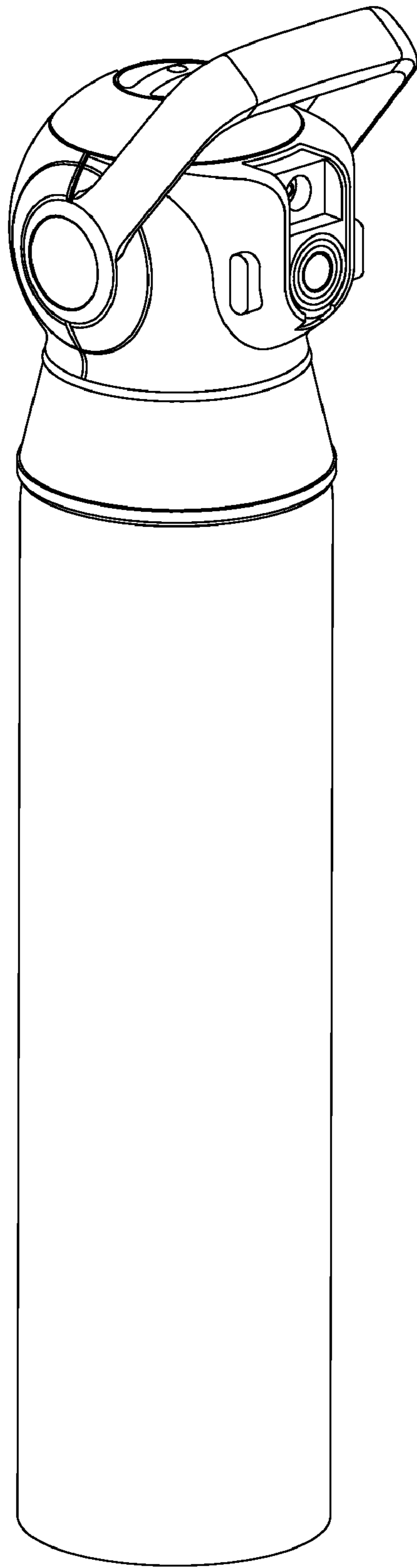
