The ornamental design for a mop, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a mop showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a rear view thereof;

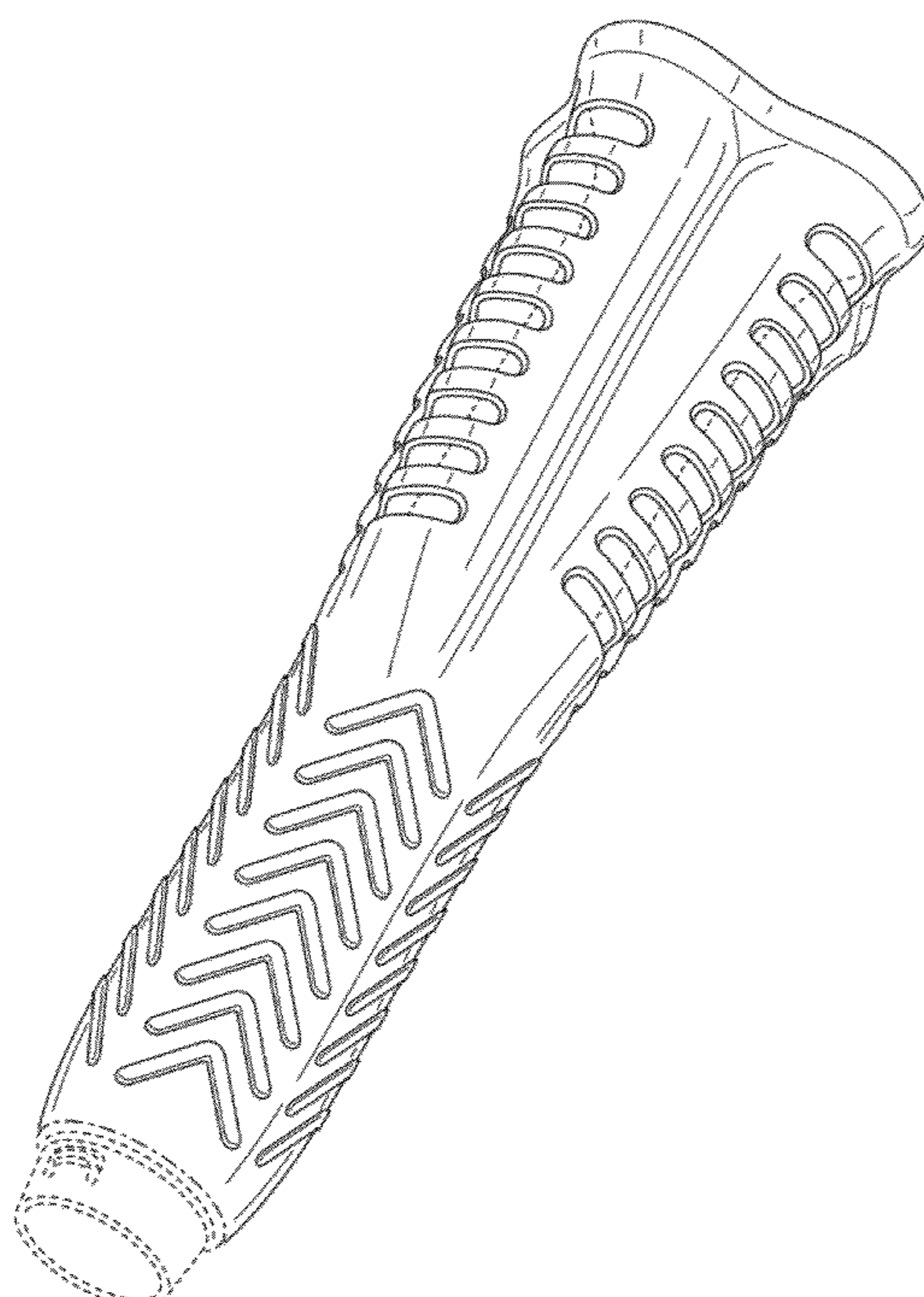
FIG. 5 is a left side view thereof;

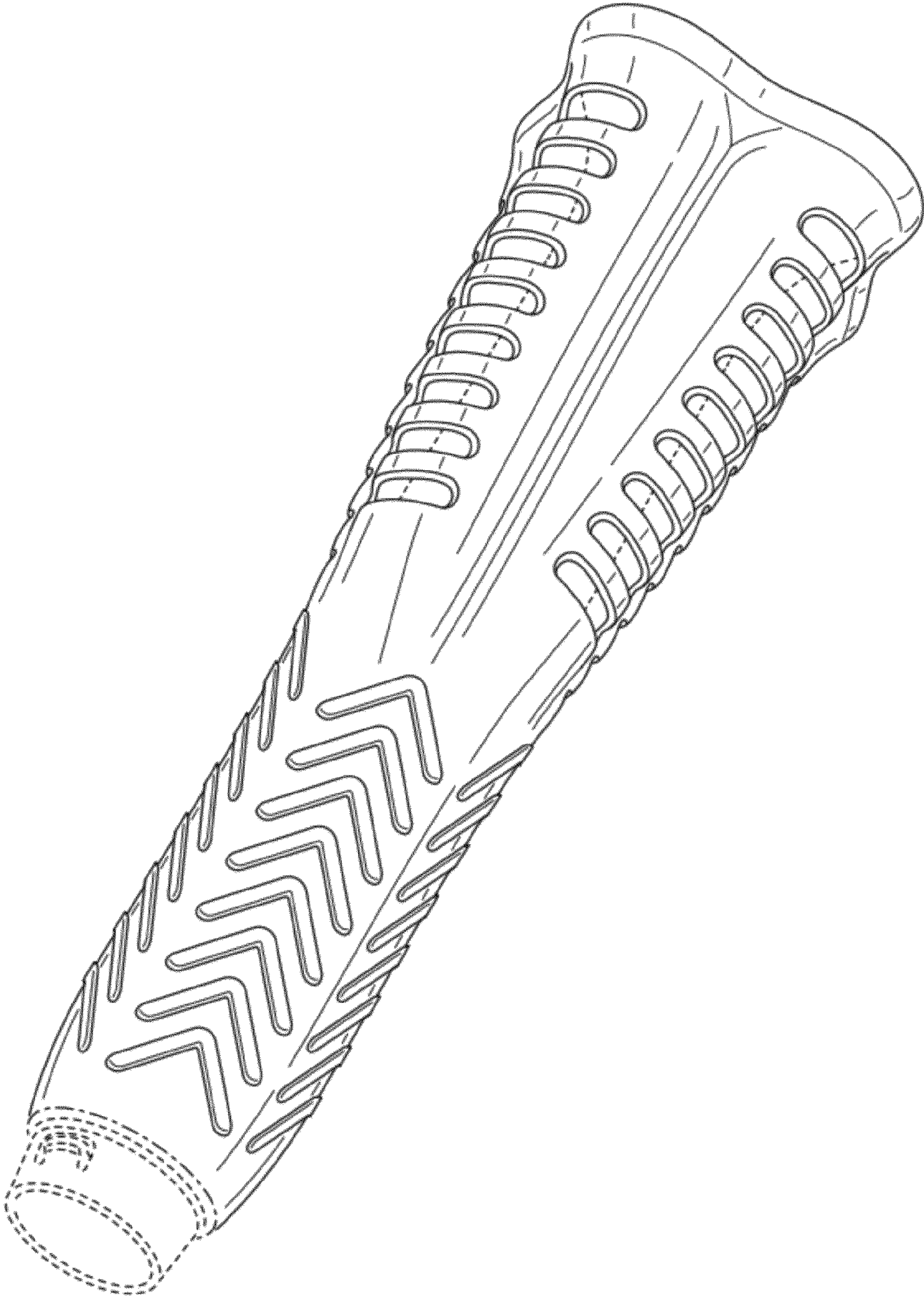

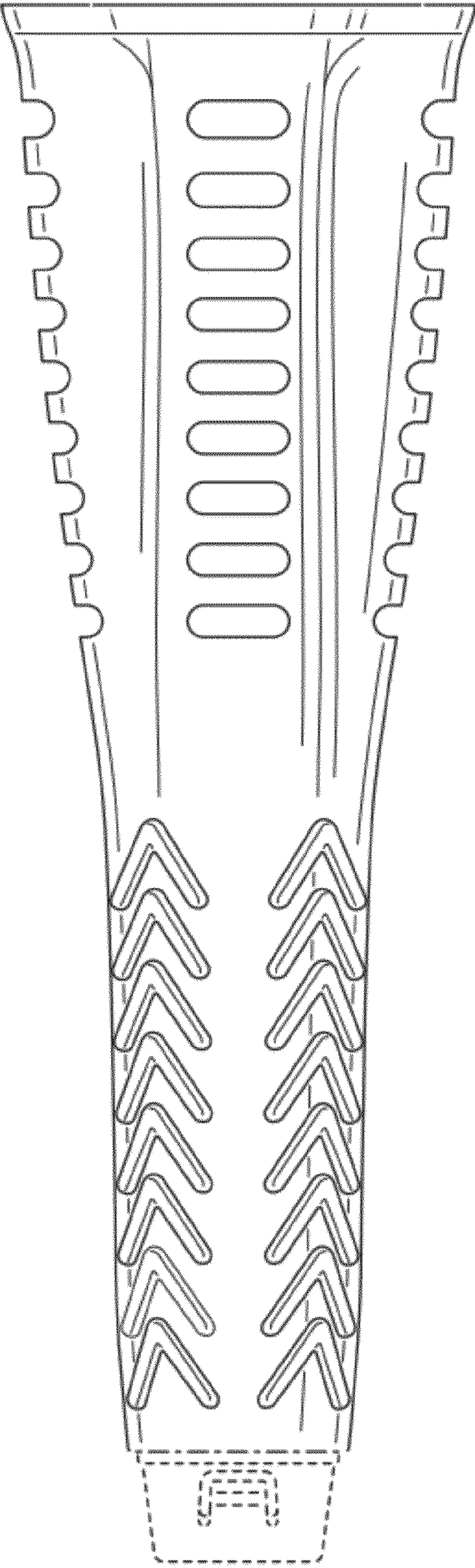

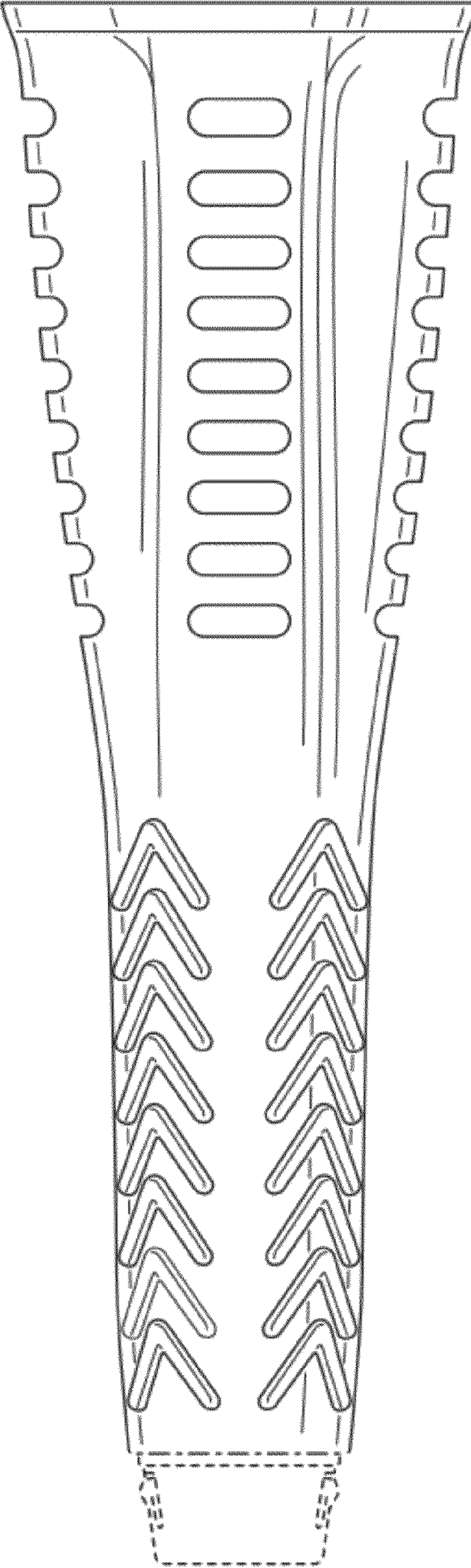

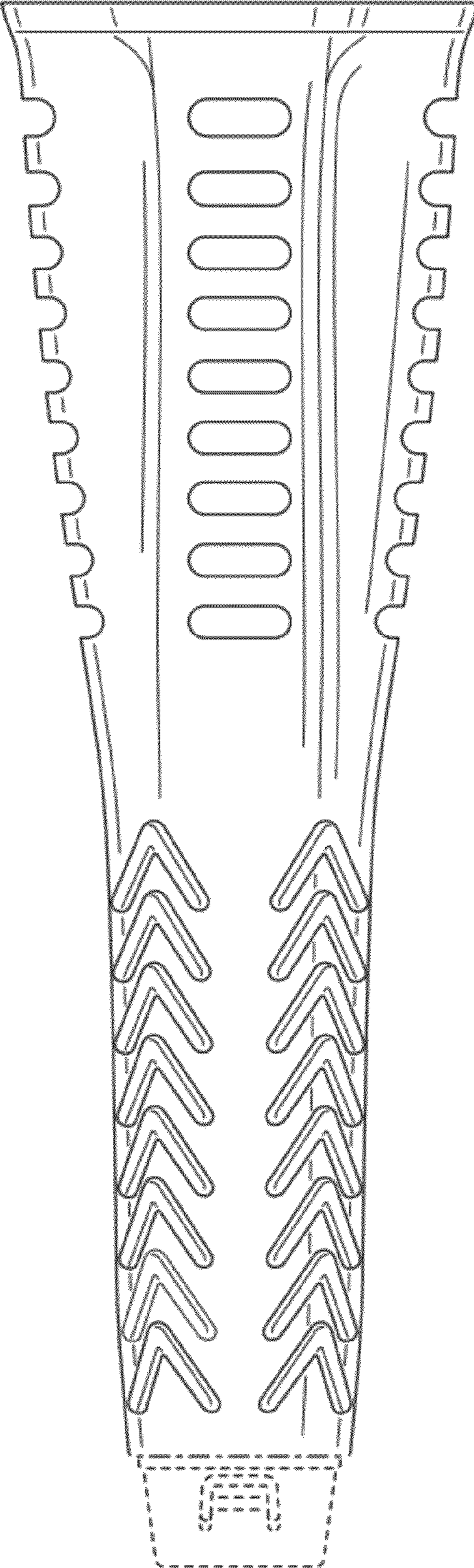

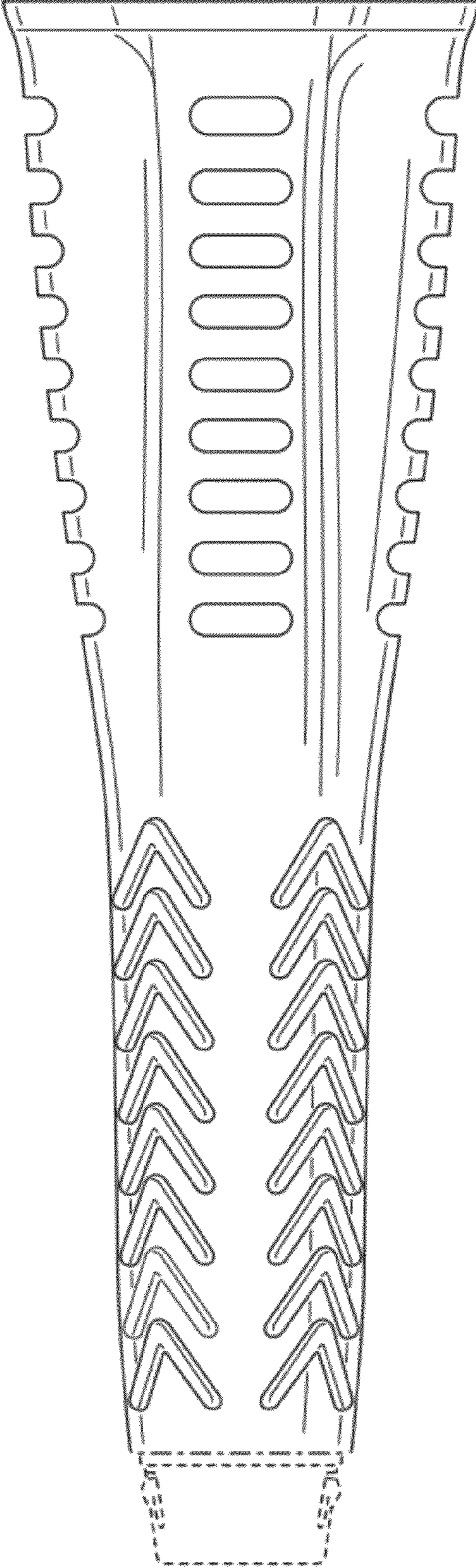

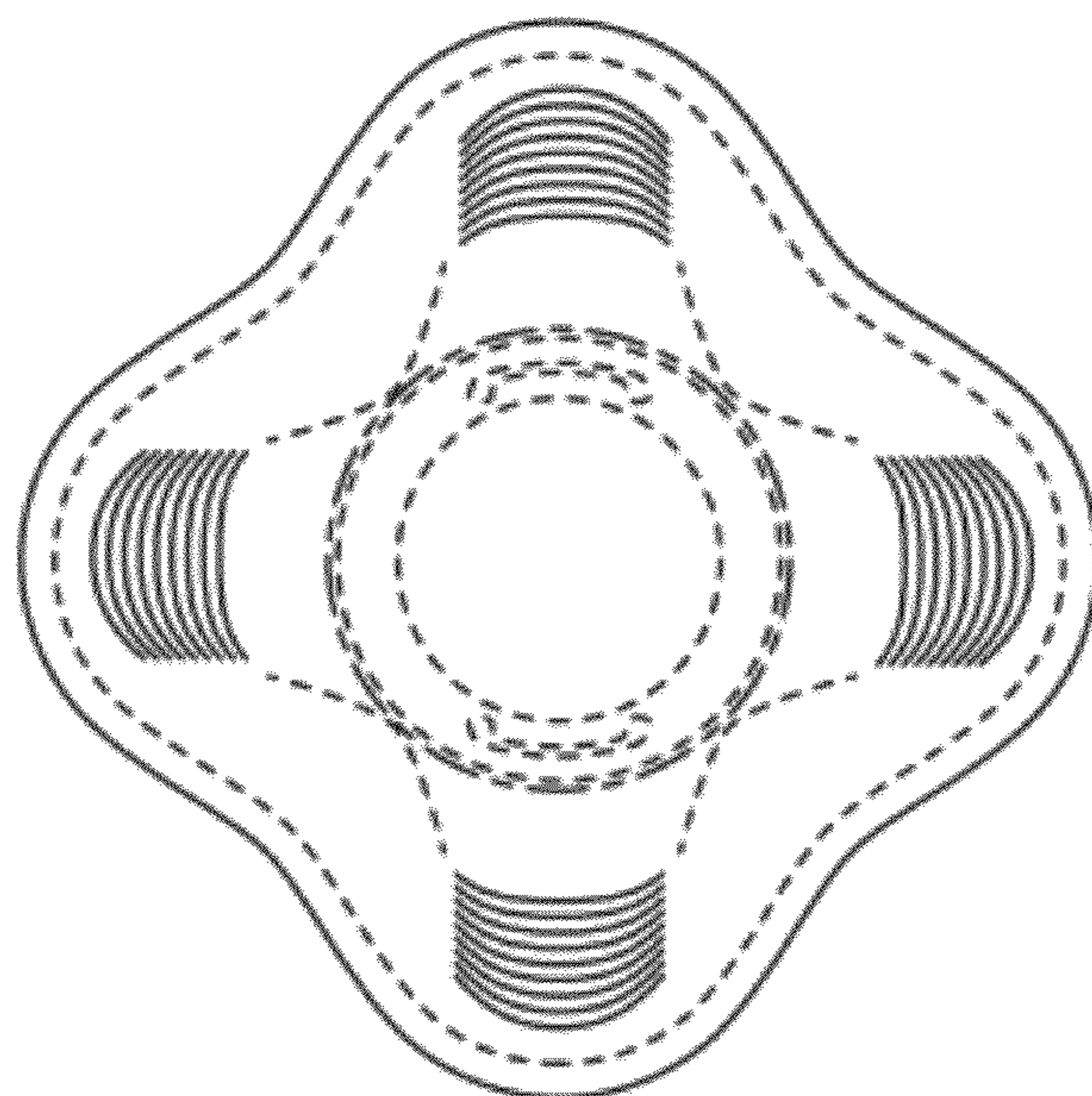

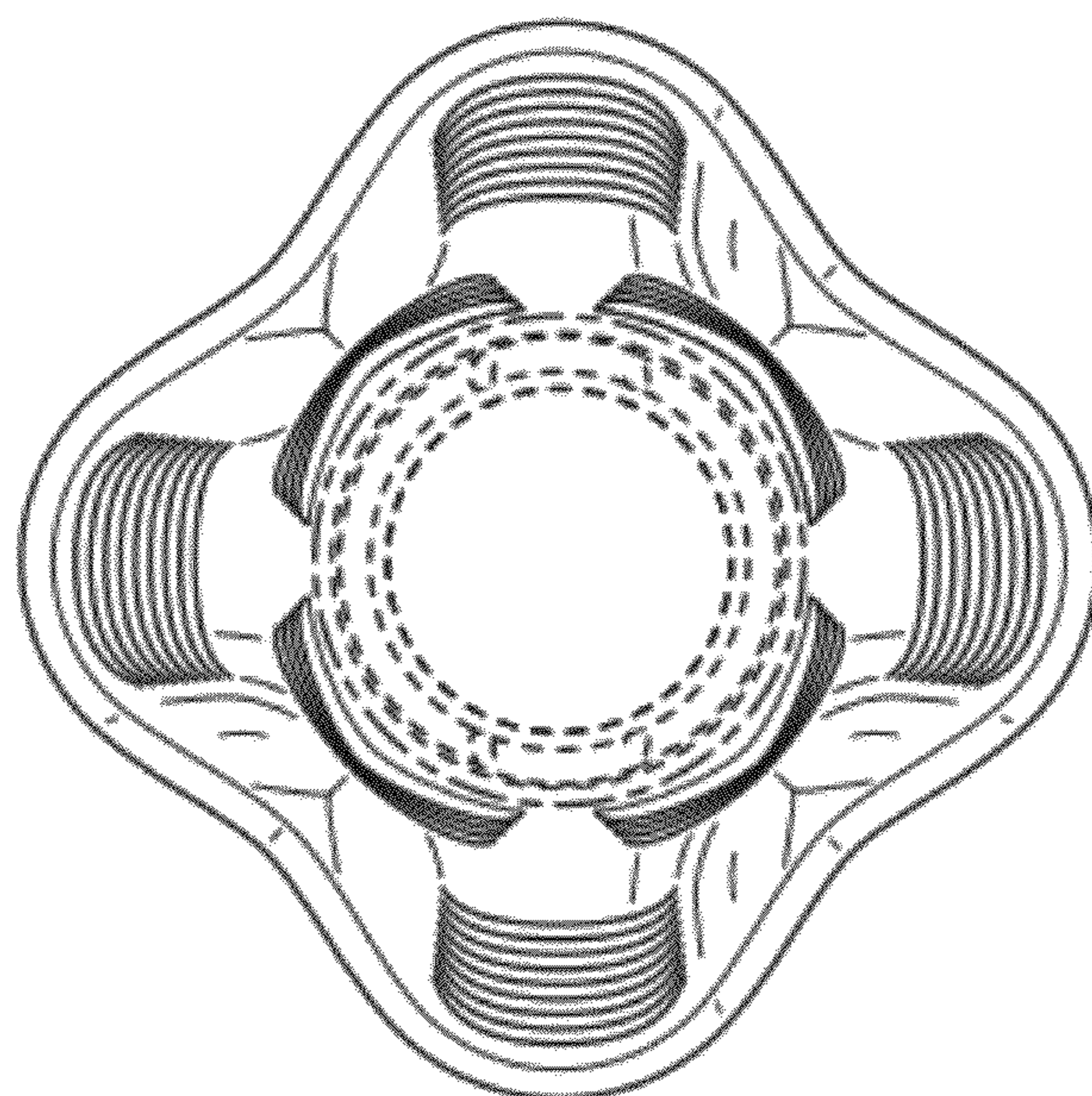
