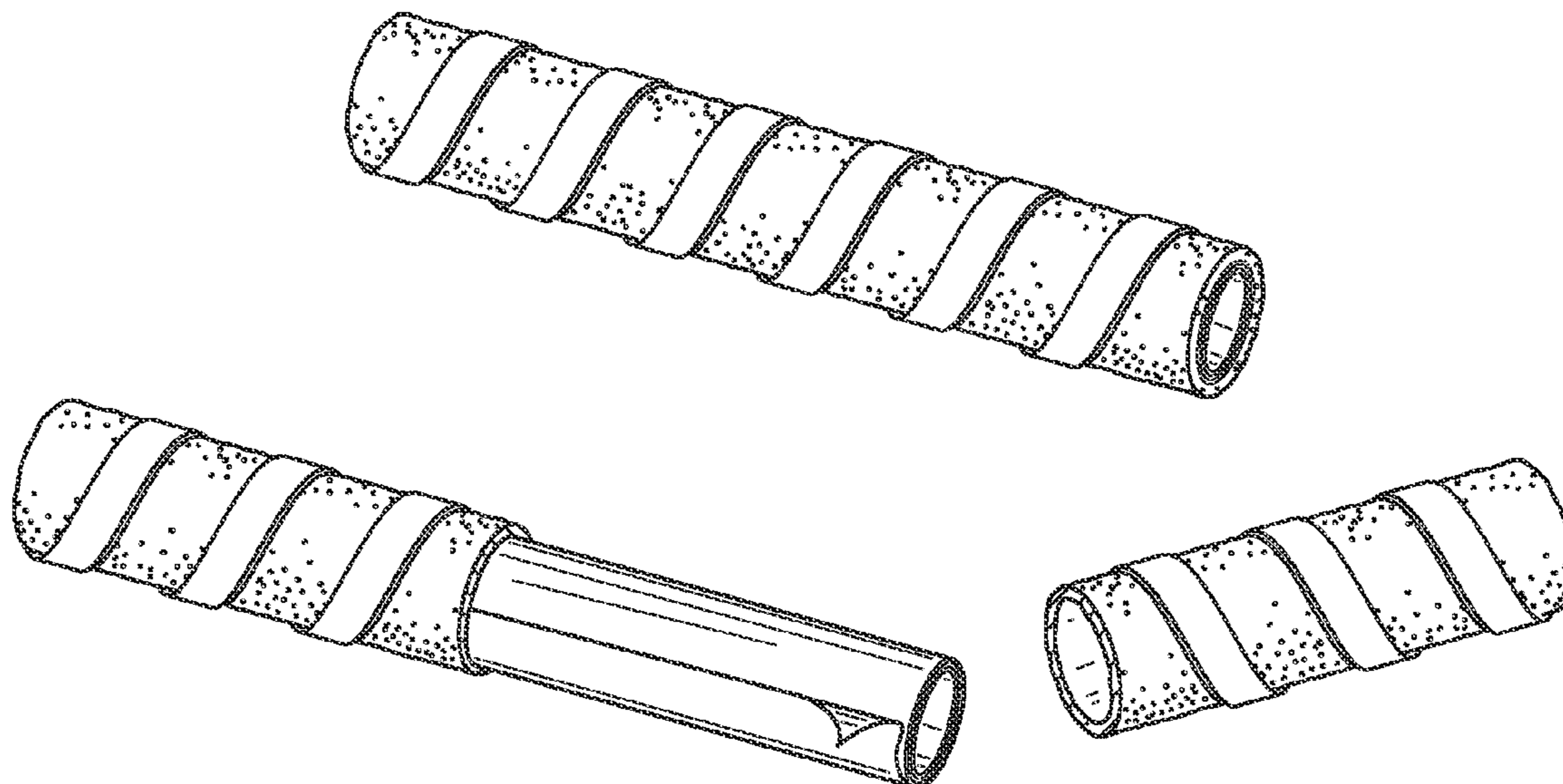
(57) **CLAIM**

The ornamental design for a cookie, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cookie showing the new design;
FIG. 2 is a left elevation view thereof;
FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image thereof;
FIG. 4 is a right elevation view thereof; and,
FIG. 5 is a perspective view of the cookie broken apart to show a message stored therein.
The broken lines shown in the drawings represent portions of the cookie and form no part of the claimed design.
The cookie is shown broken apart for ease of illustration.

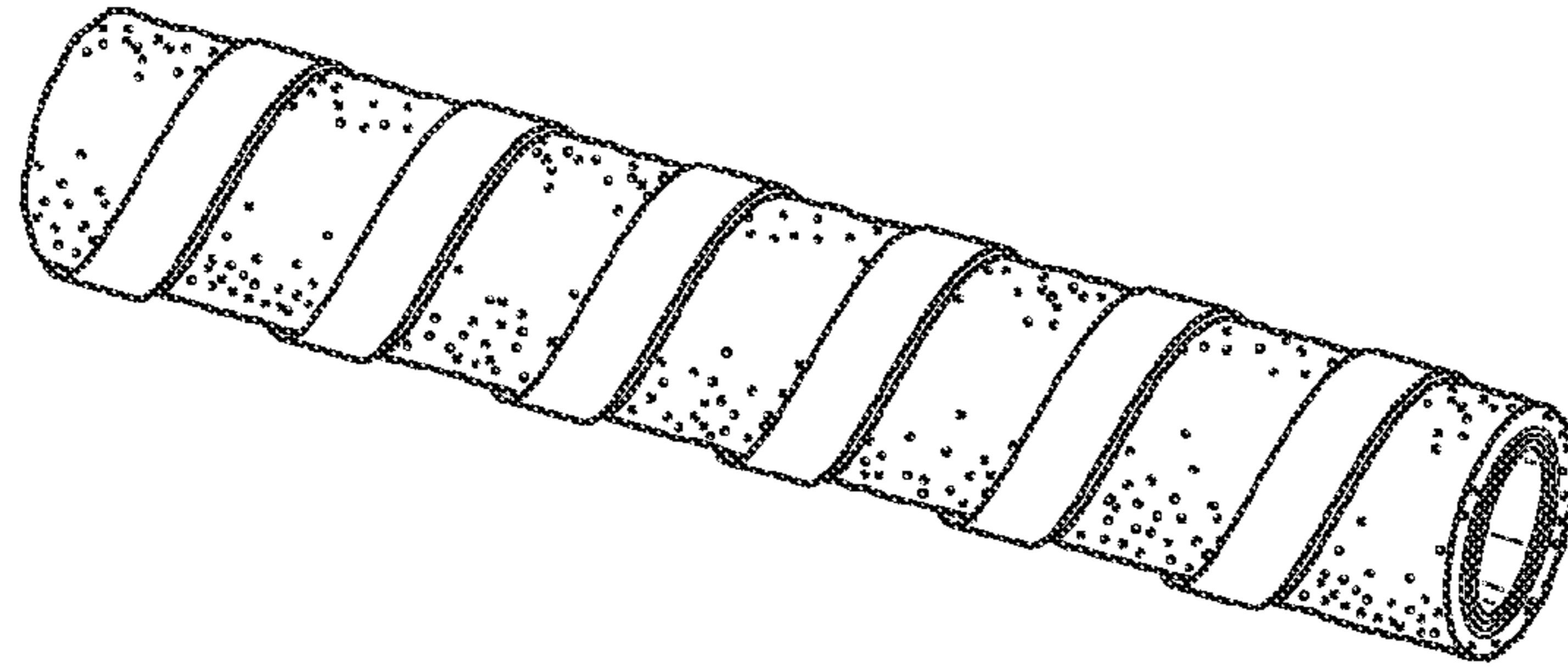

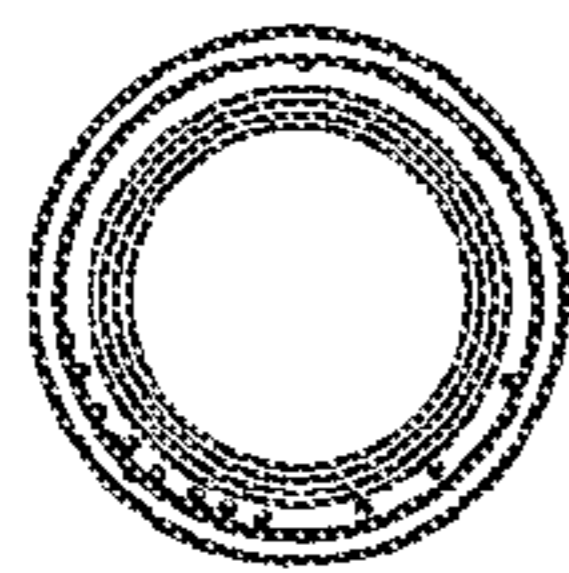

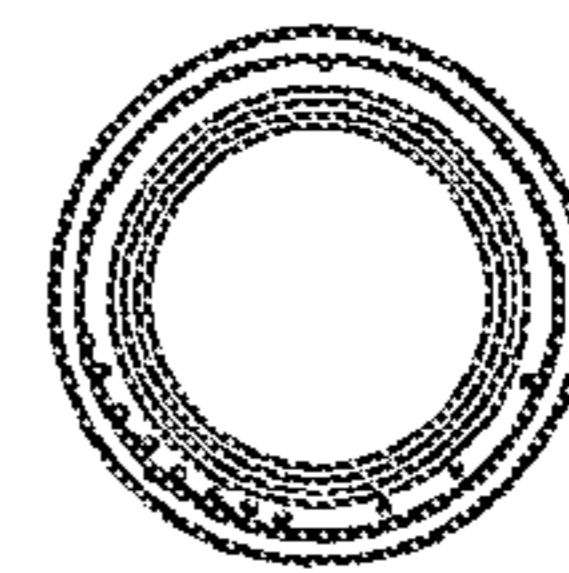

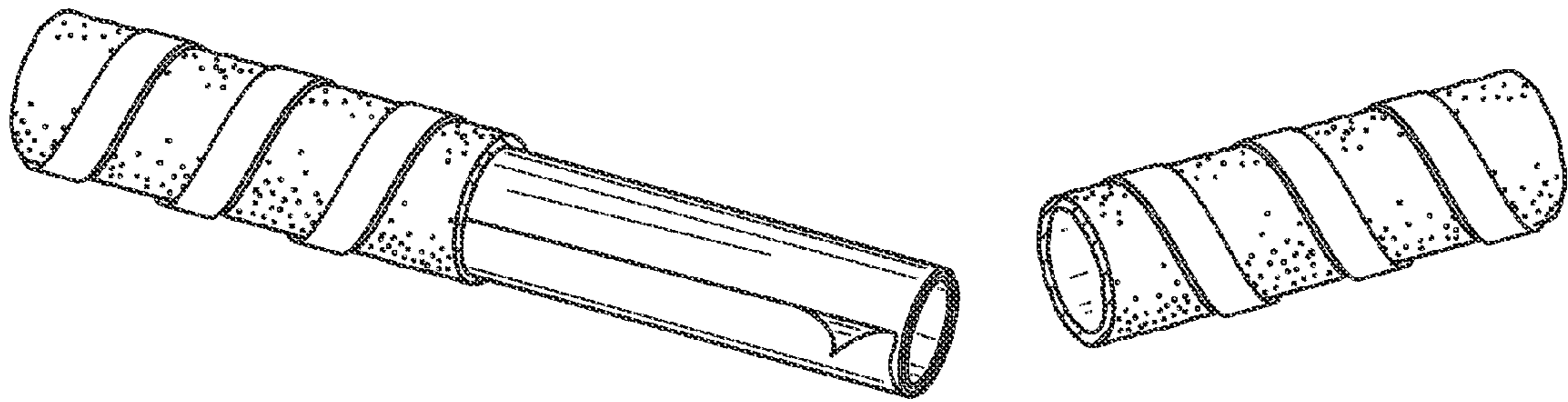
