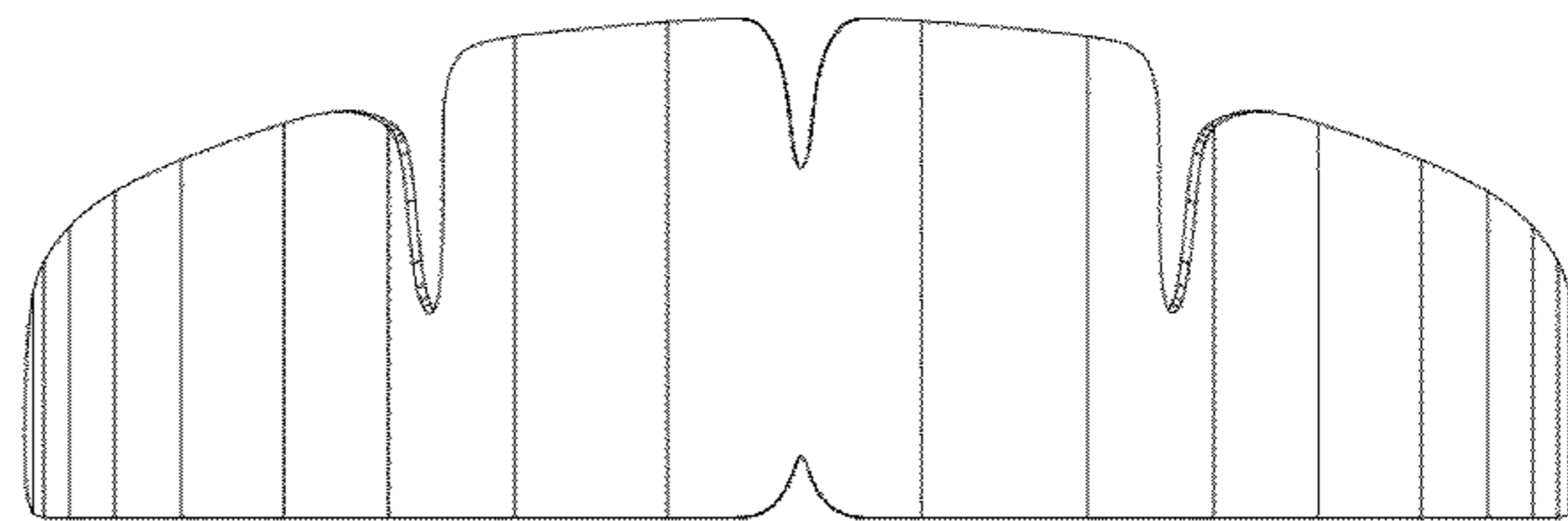
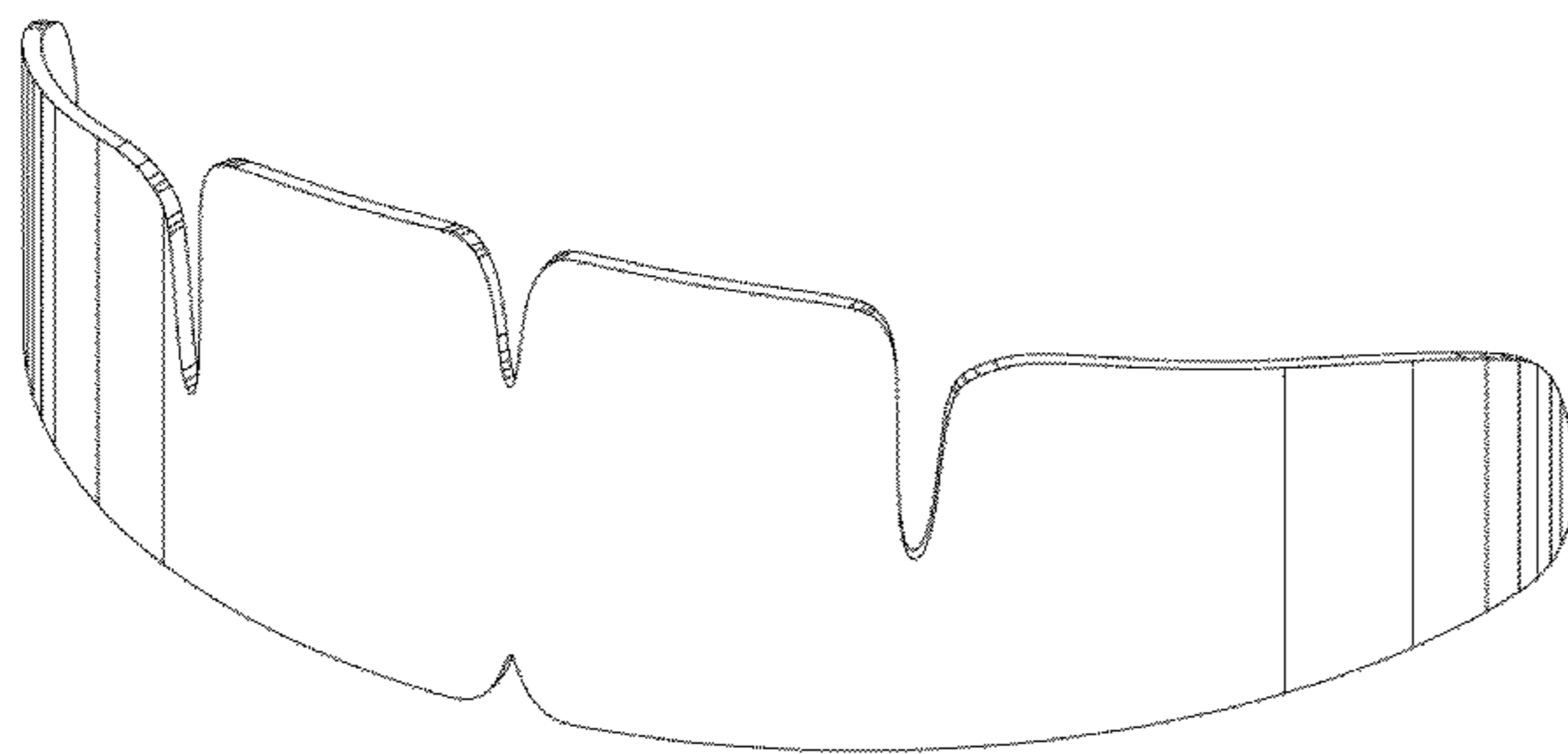
(57) **CLAIM**

The ornamental design for a baseball cap front insert, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a baseball cap front insert, showing my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left-side elevation view thereof with a right-side elevation view being a mirror image thereof;  
FIG. 5 is a top plan view thereof; and,

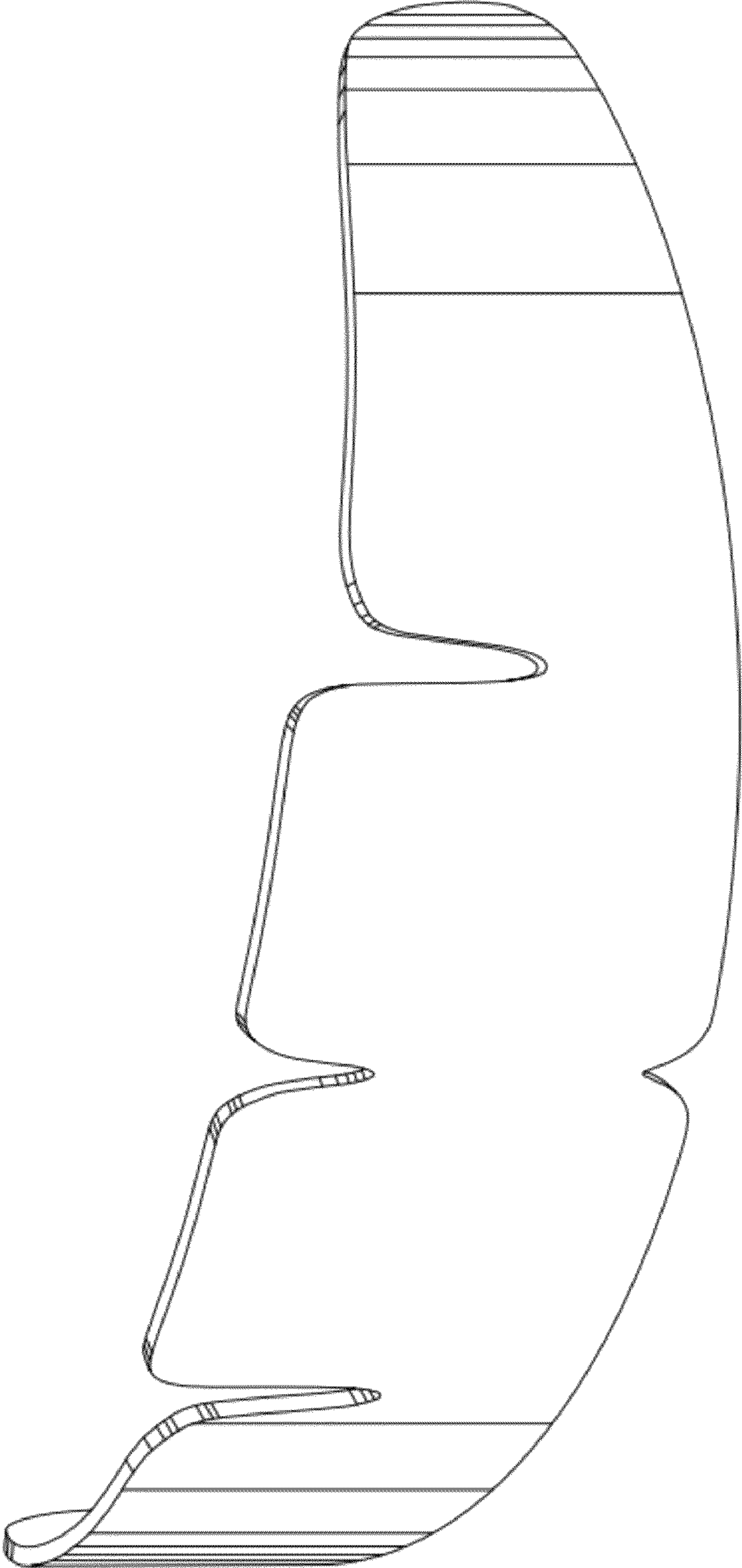

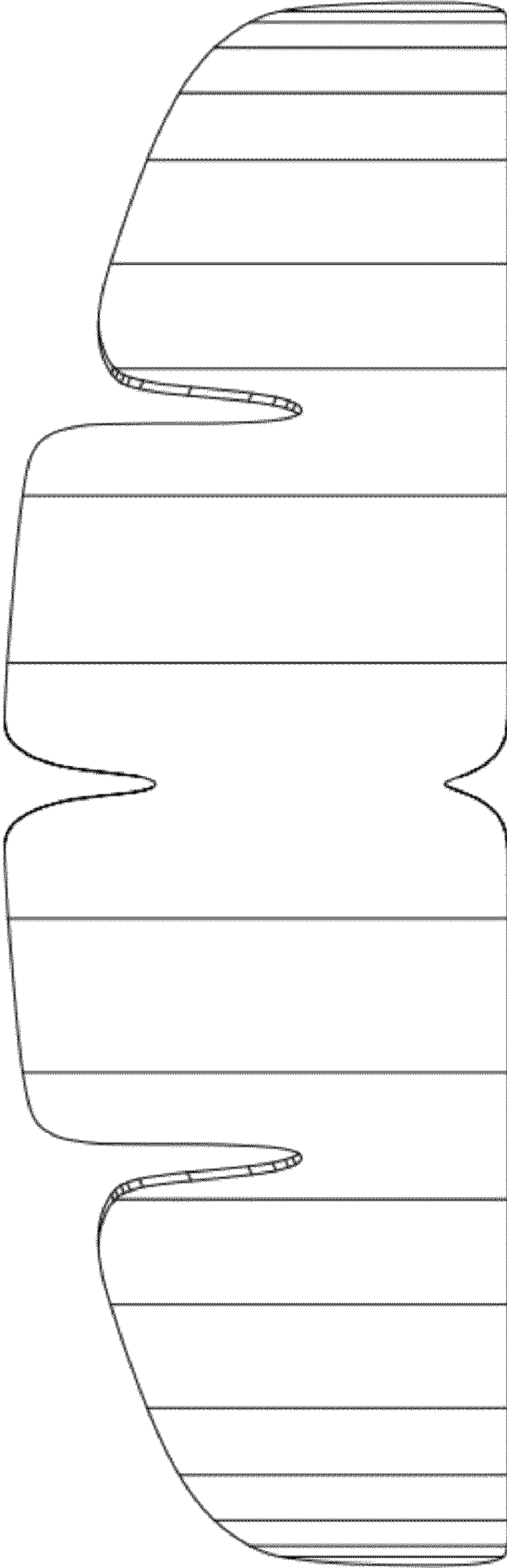

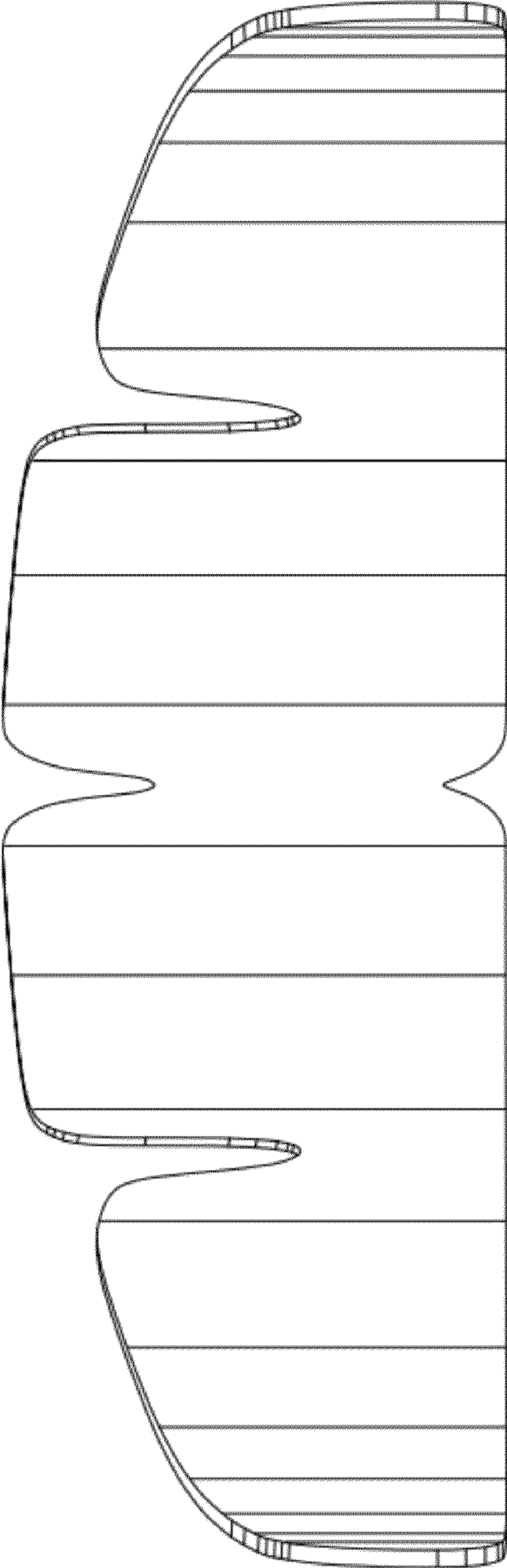

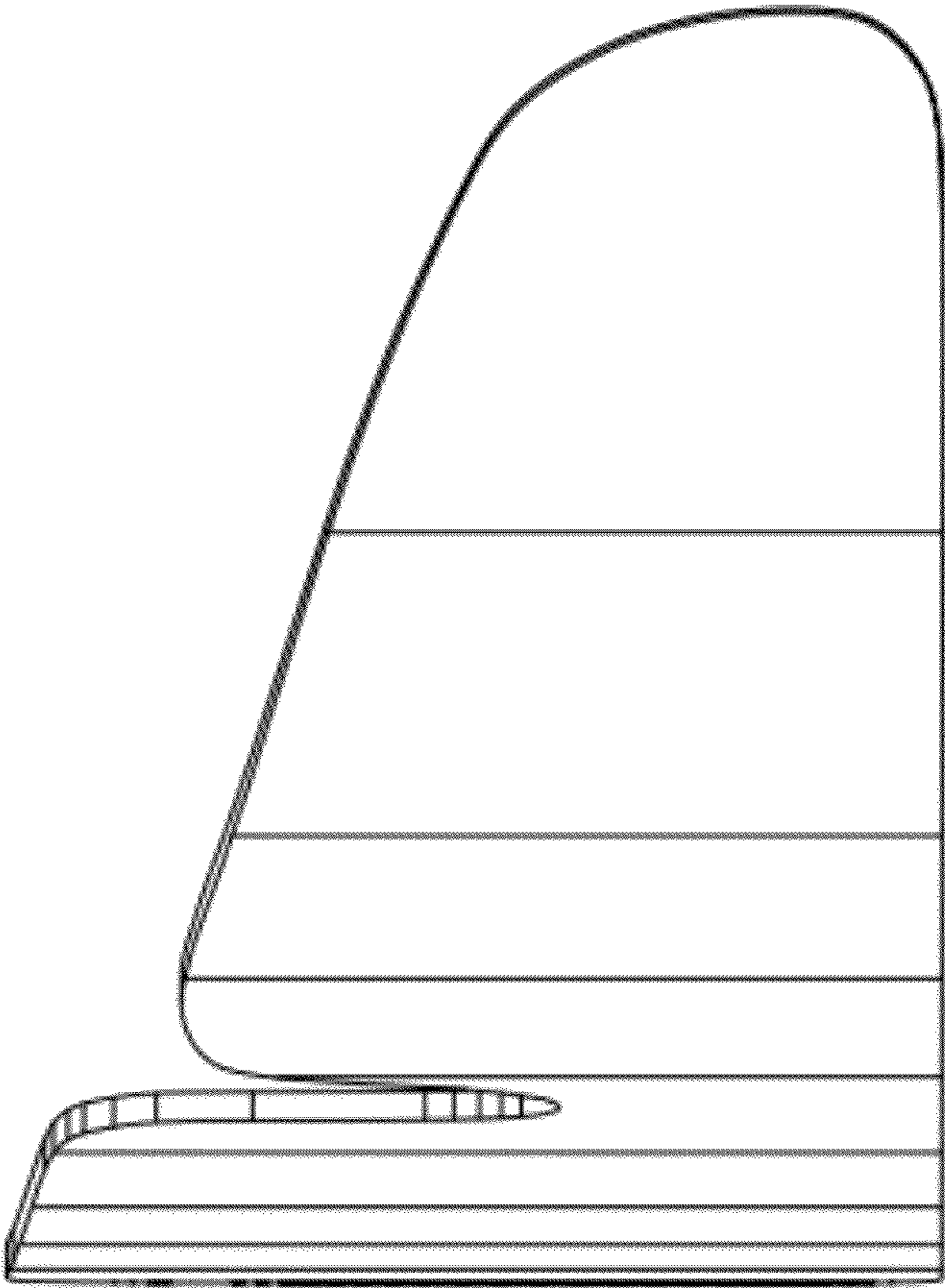

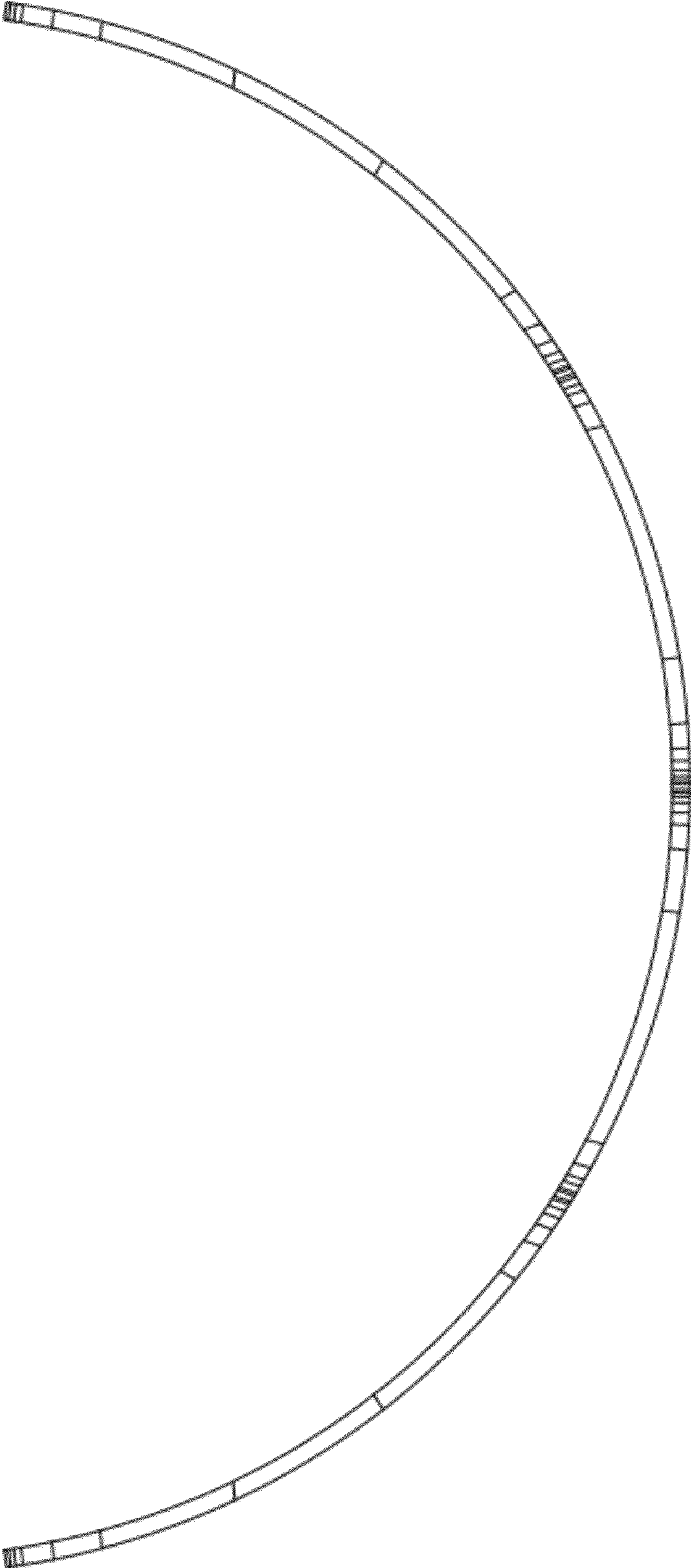

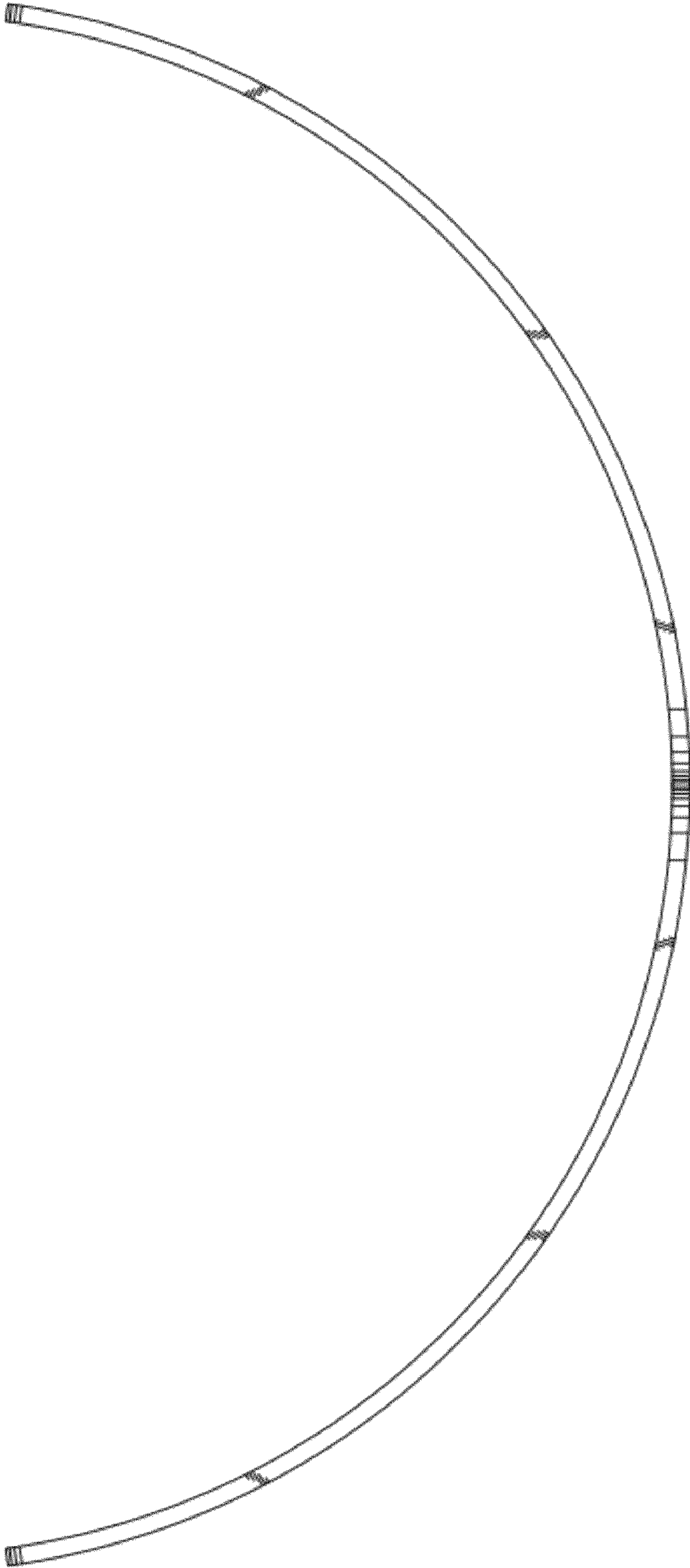
