(57) **CLAIM**

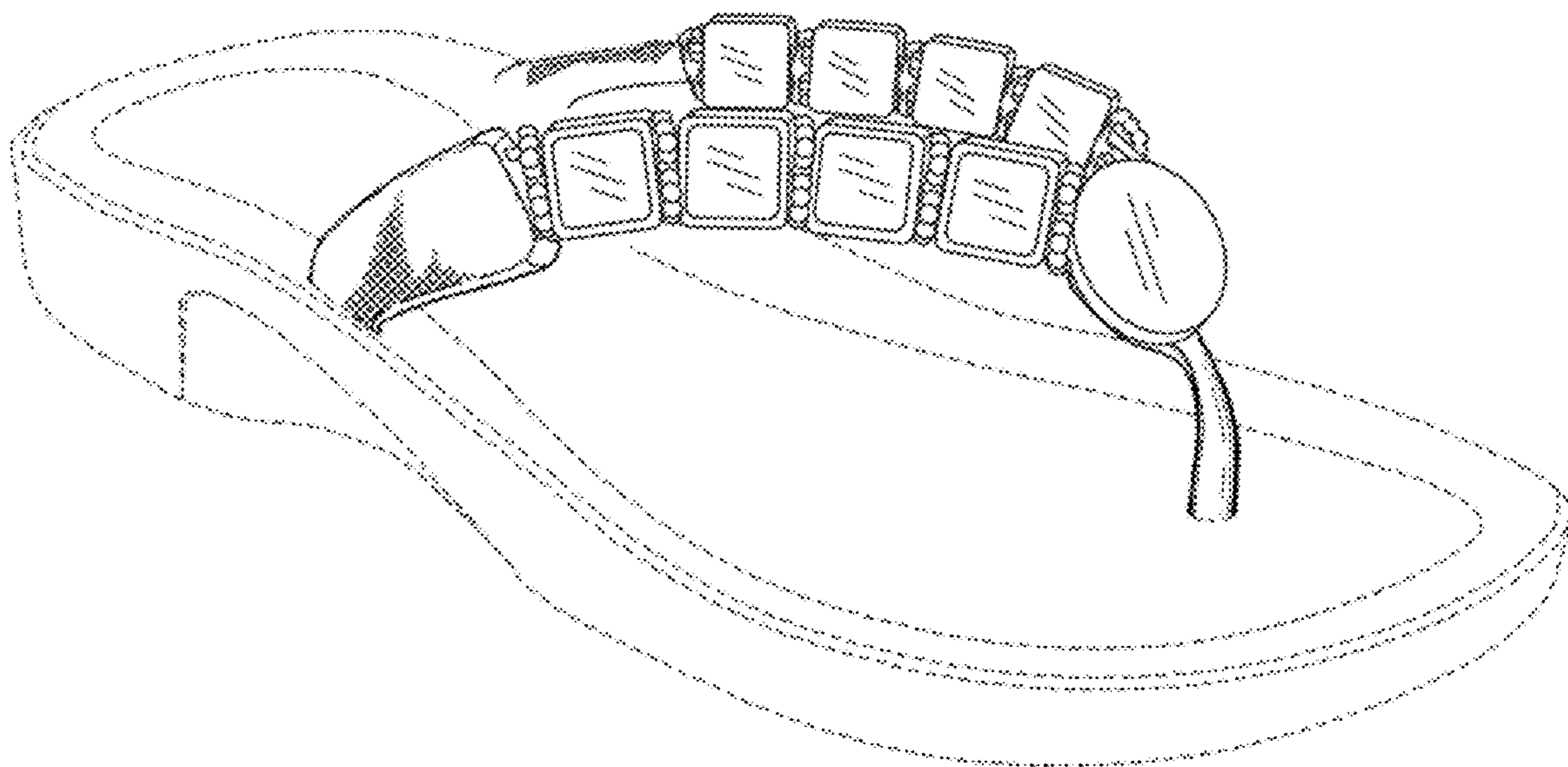
I claim, the ornamental design for a strap for a sandal and the like, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a strap for a sandal and the like for a right foot, showing my new design;  
2 is a front elevation view thereof;  
FIG. 3 is right side elevation view thereof;  
FIG. 4 is left side elevation view thereof;  
FIG. 5 is a rear elevation view thereof; and,  
FIG. 6 is a top plan view thereof.

It is understood that a second embodiment of the claimed design, a strap for a sandal and the like for a left foot, comprises the mirror images of FIGS. 1-6, respectively. The broken lines in the drawings represent environment and form no part of the claimed design.

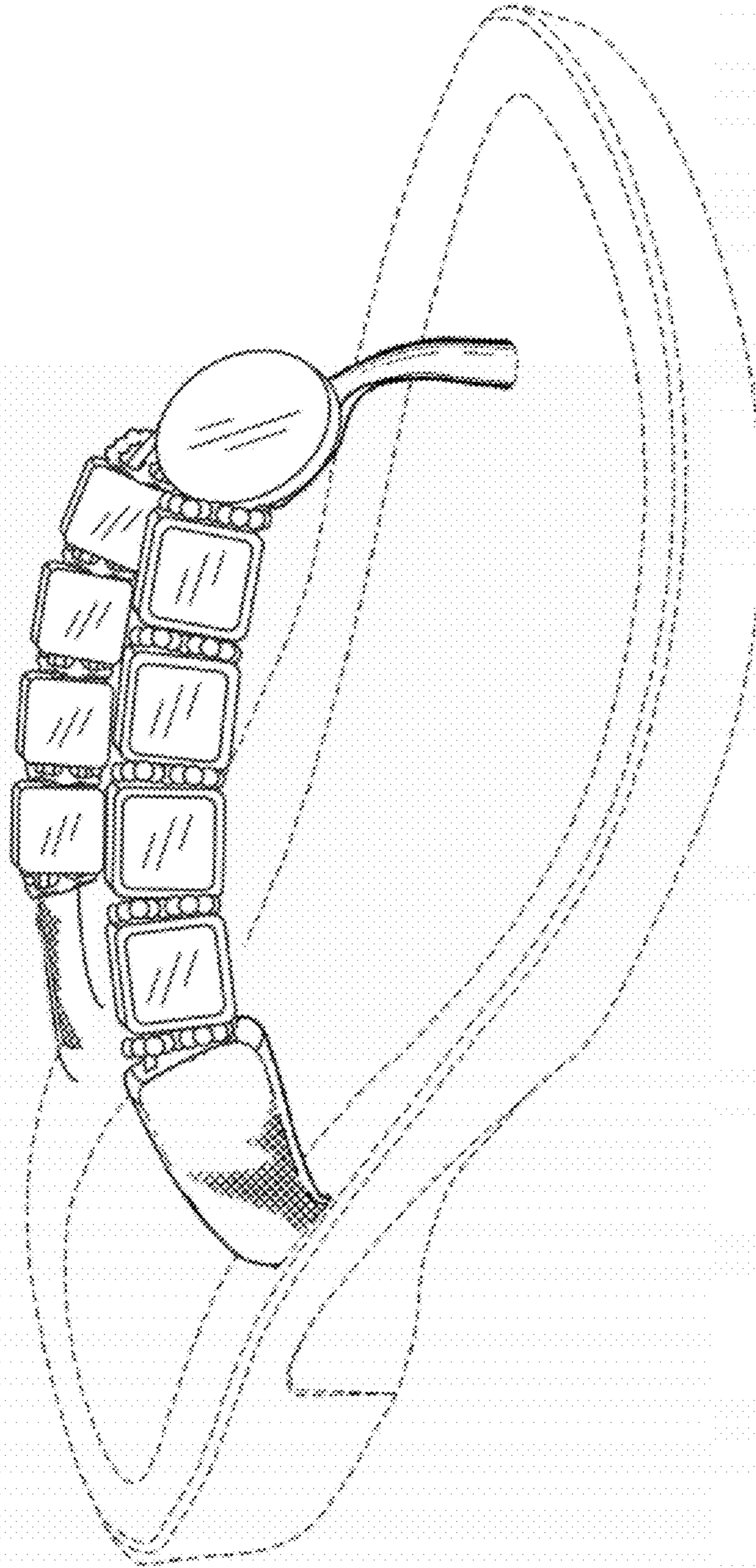

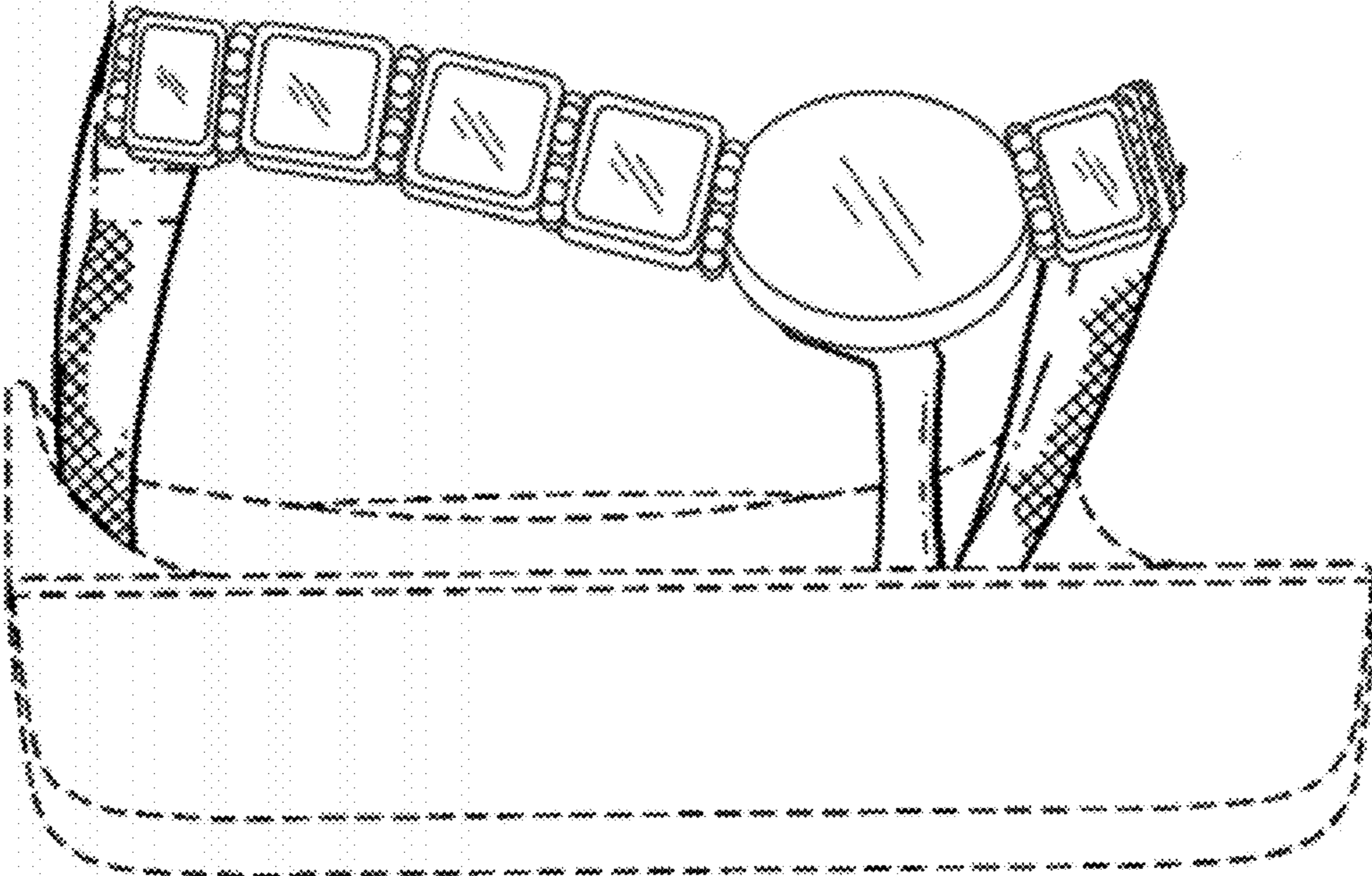

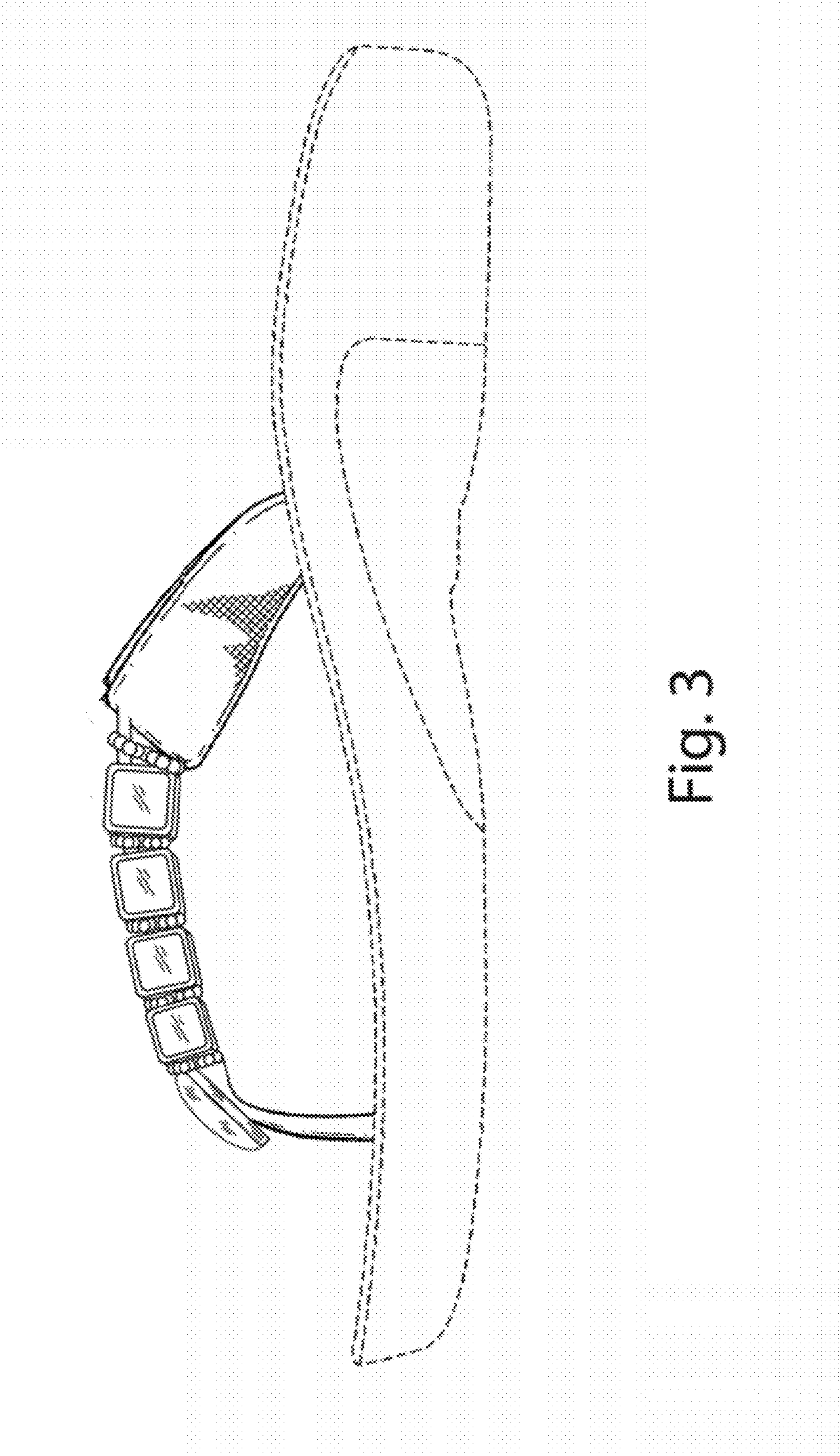

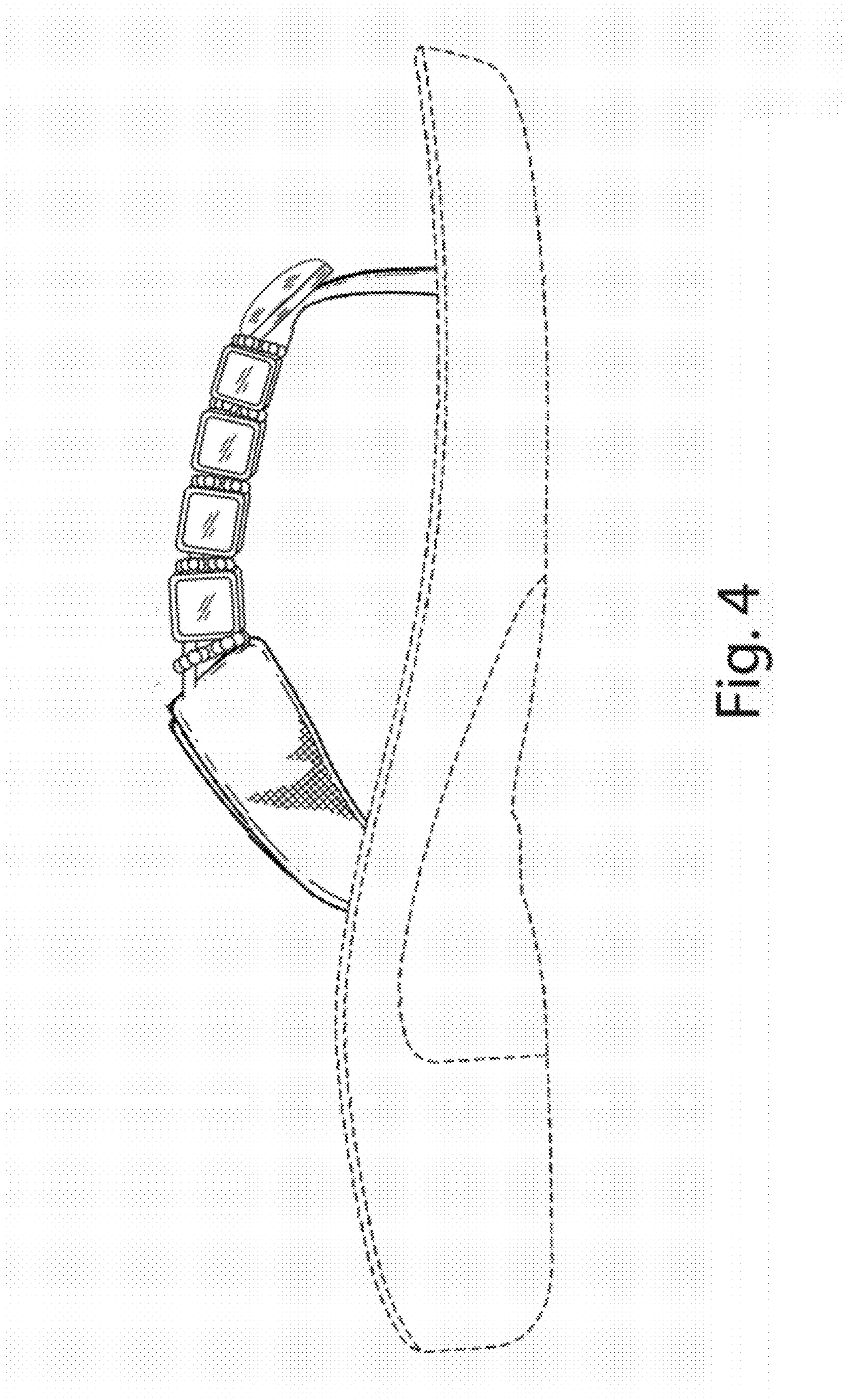

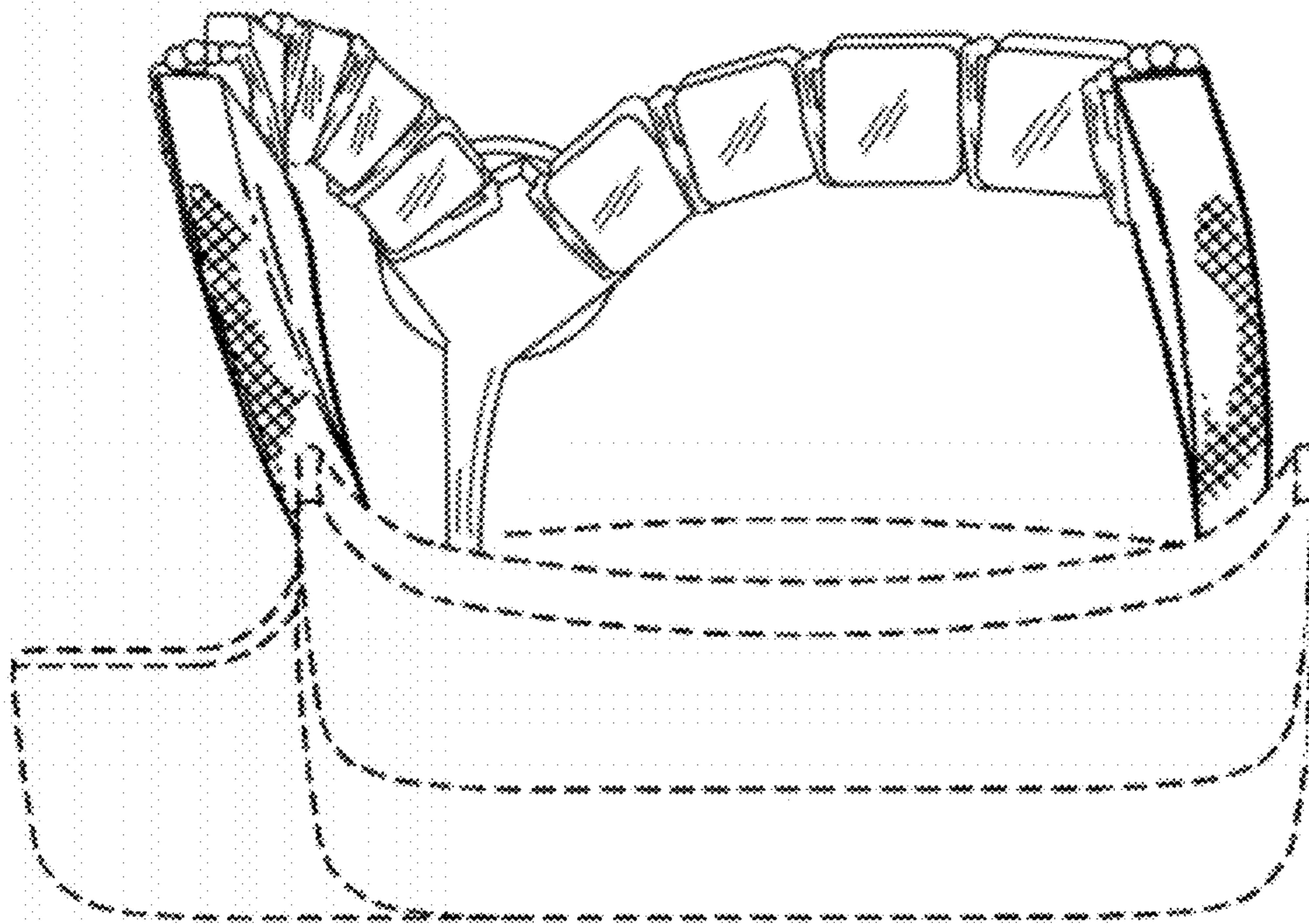

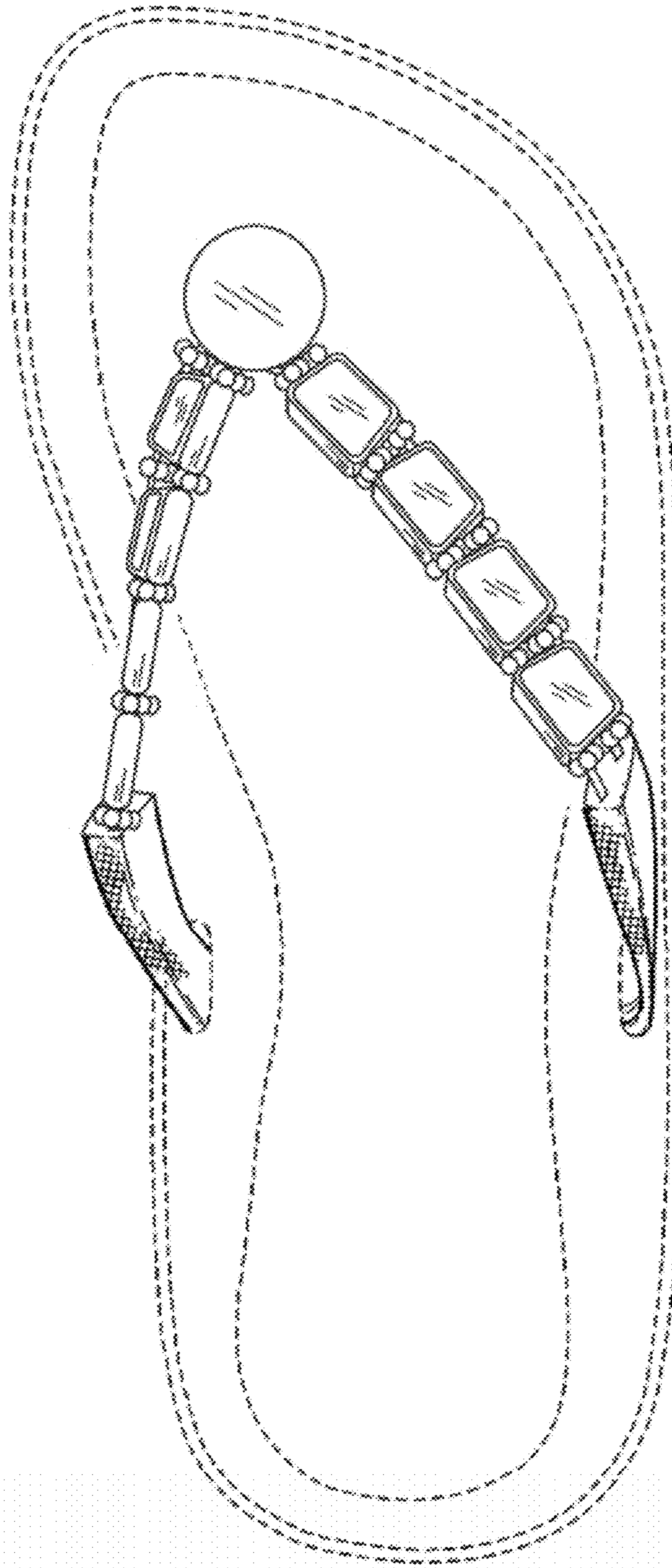
