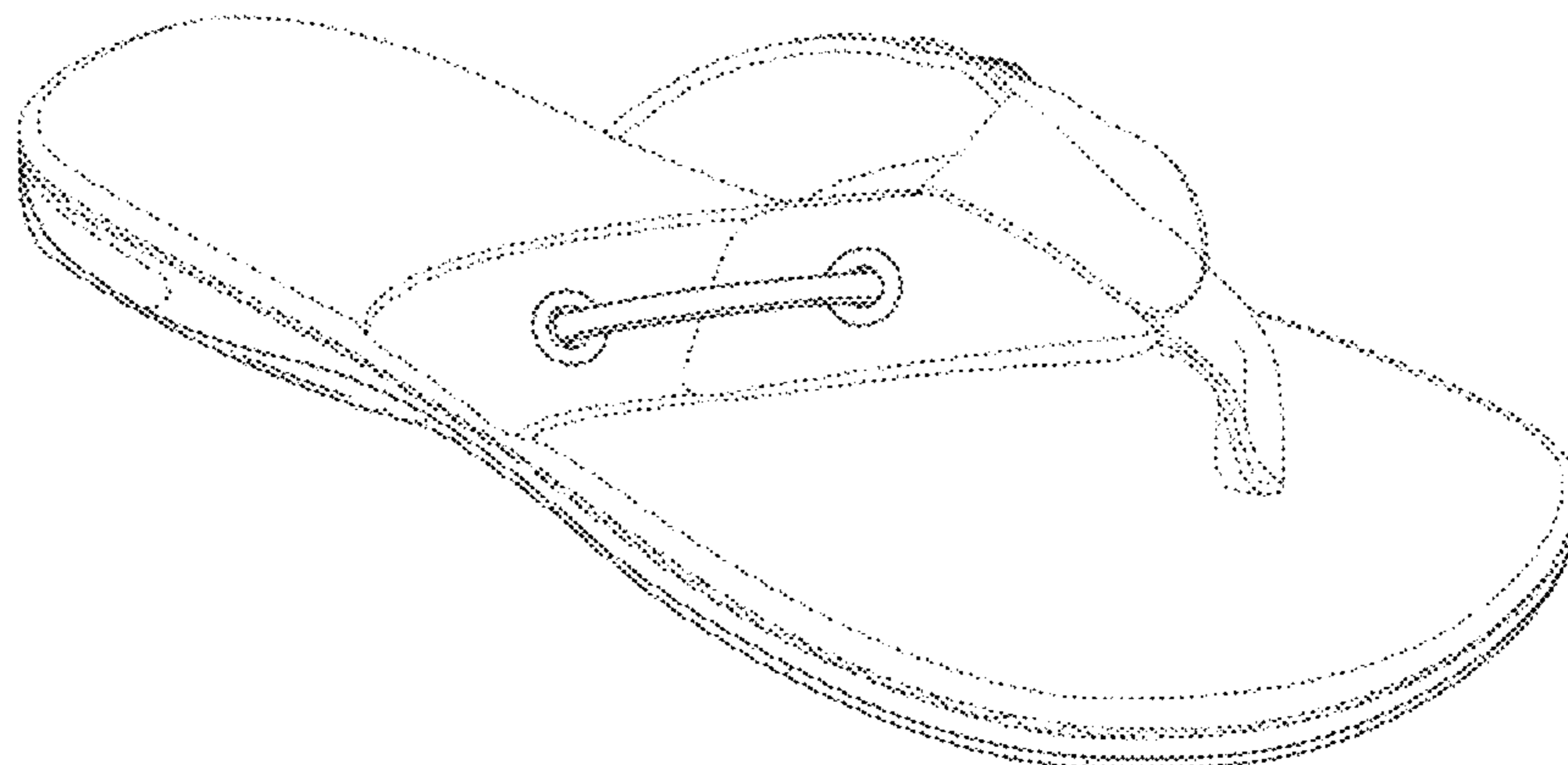

**DESCRIPTION**

FIG. 1 is a front-top perspective view of pair of footwear articles, showing my new design;  
 FIG. 2 is a bottom-rear perspective view thereof;  
 FIG. 3 is a lateral side view thereof;  
 FIG. 4 is a medial side view thereof;  
 FIG. 5 is a front view thereof;  
 FIG. 6 is a rear view thereof;  
 FIG. 7 is a top plan view thereof; and,  
 FIG. 8 is a bottom plan view thereof.  
 The drawings show the design of an article of footwear suitable for being worn on a right foot. The ornamental design also includes the mirror images of drawings, i.e., the design of an article of footwear suitable for being worn on the left foot. The broken lines in the drawing views form no part of the claimed design.

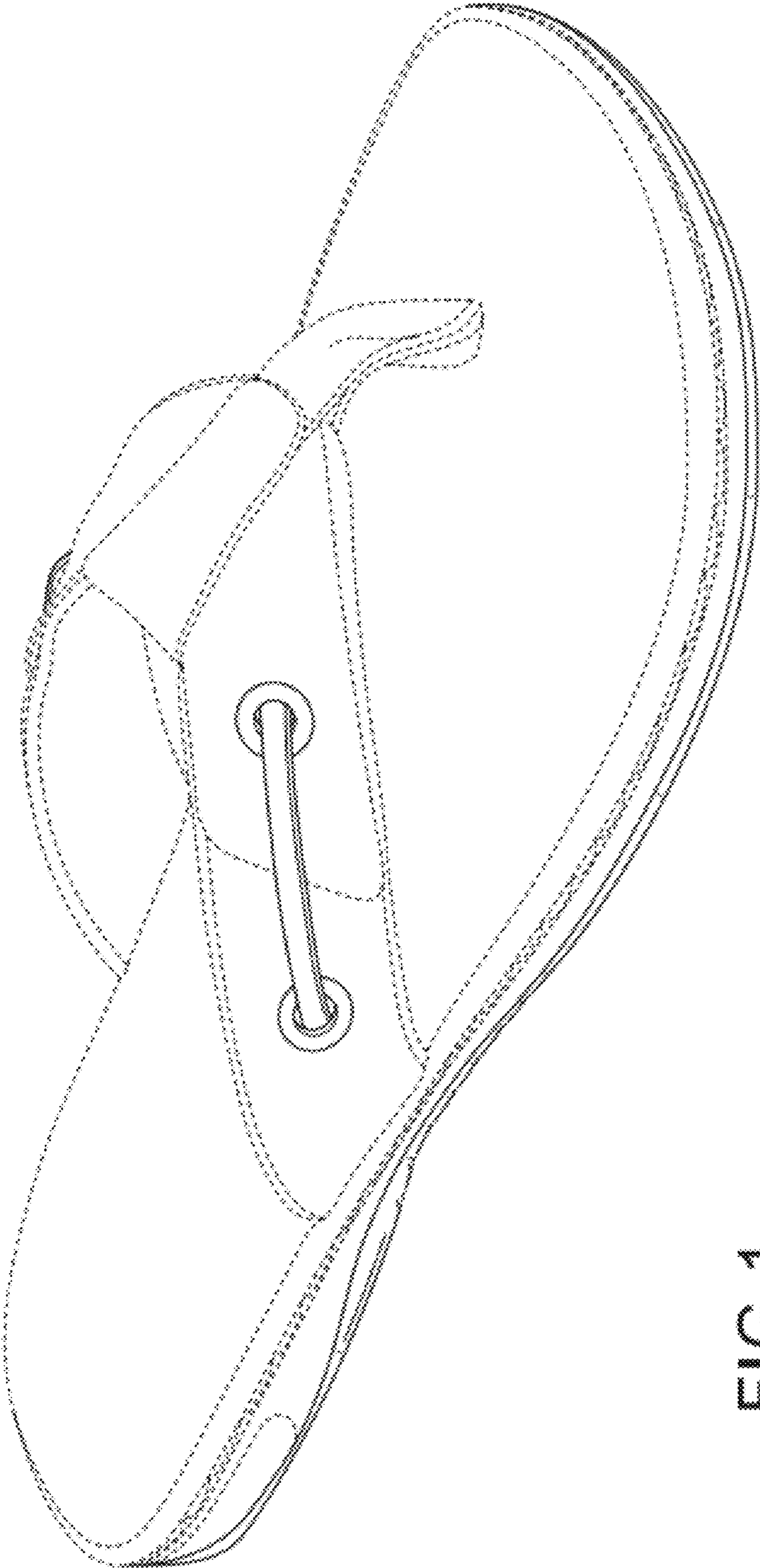

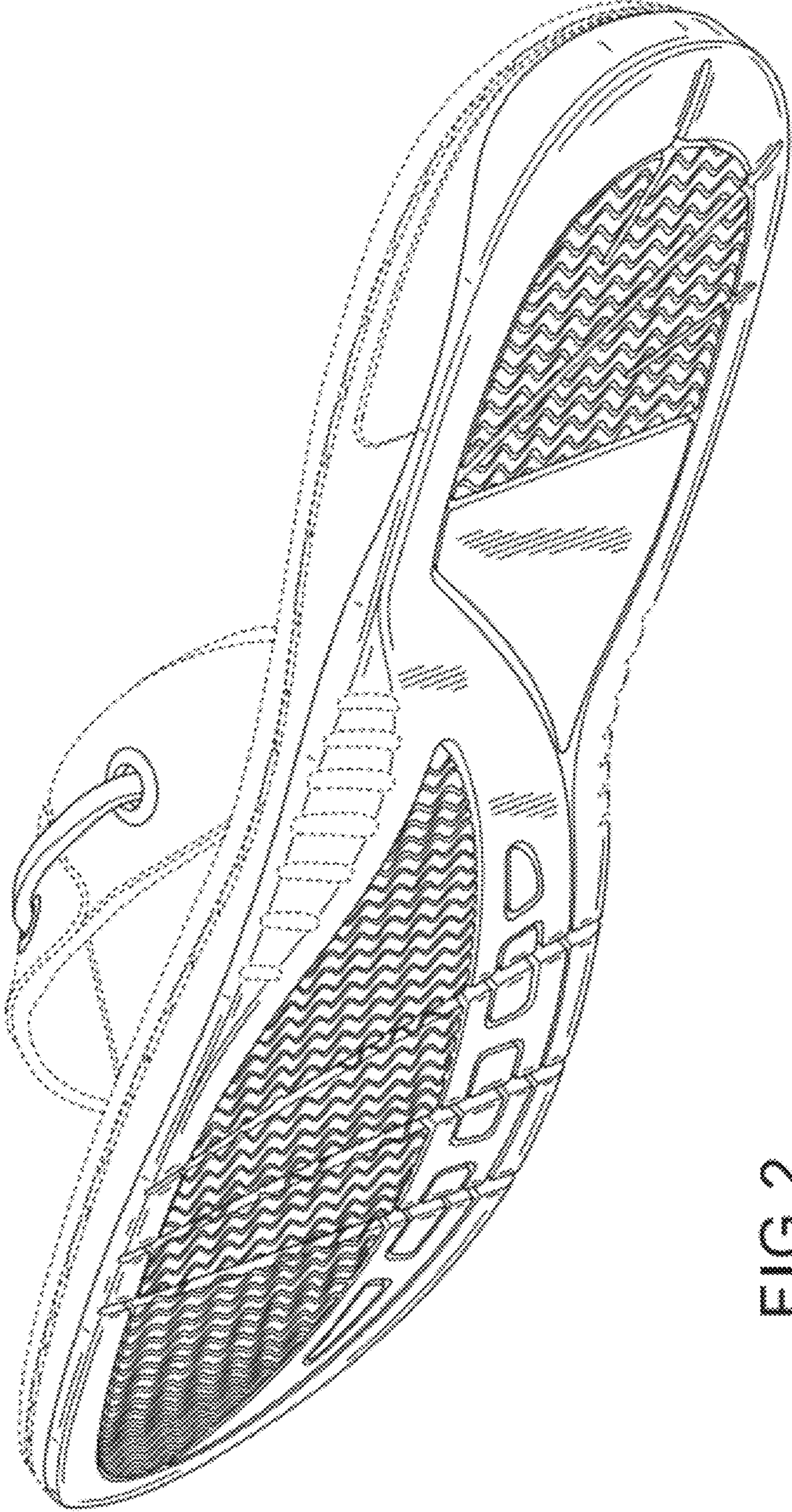

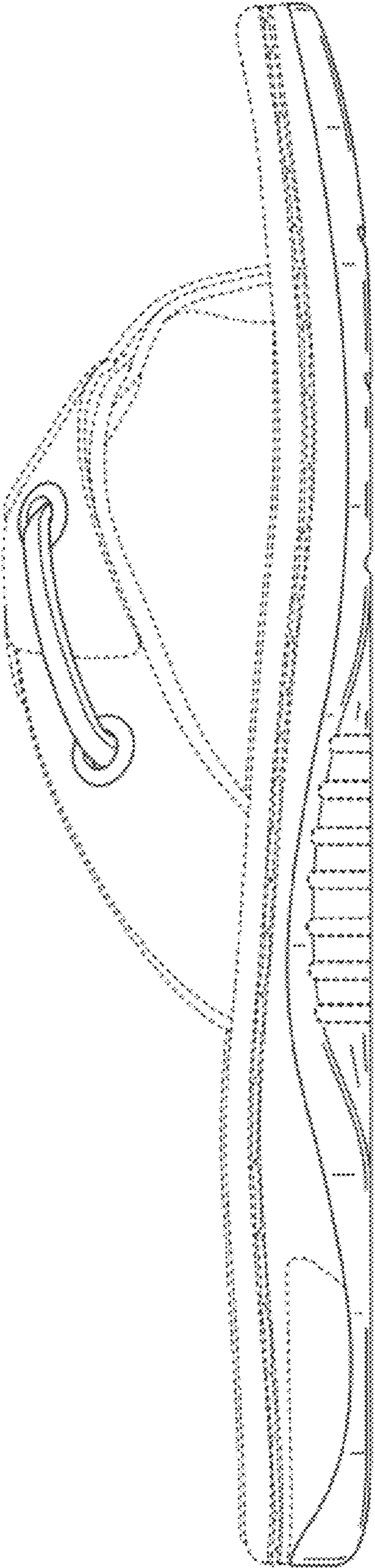

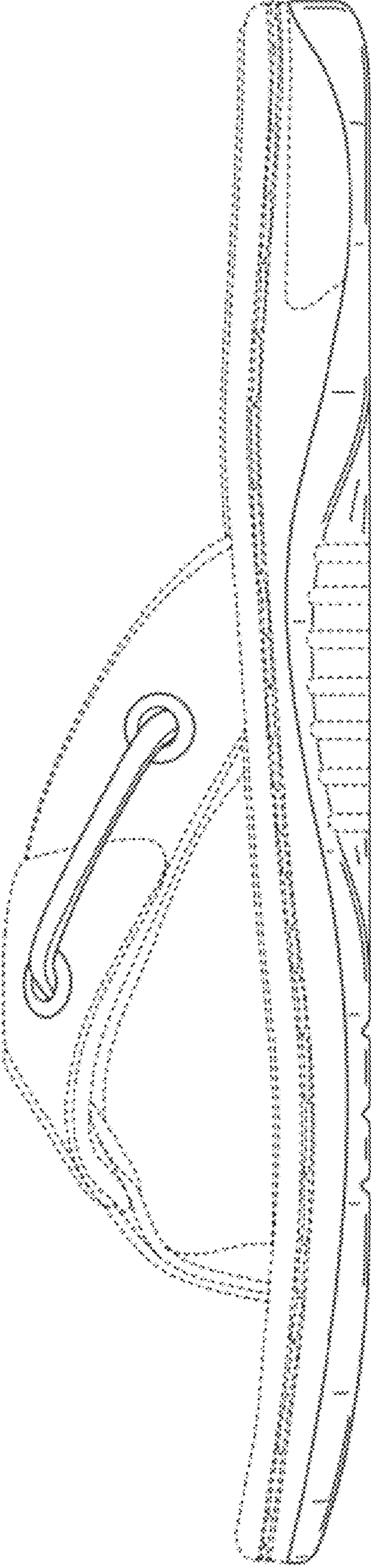

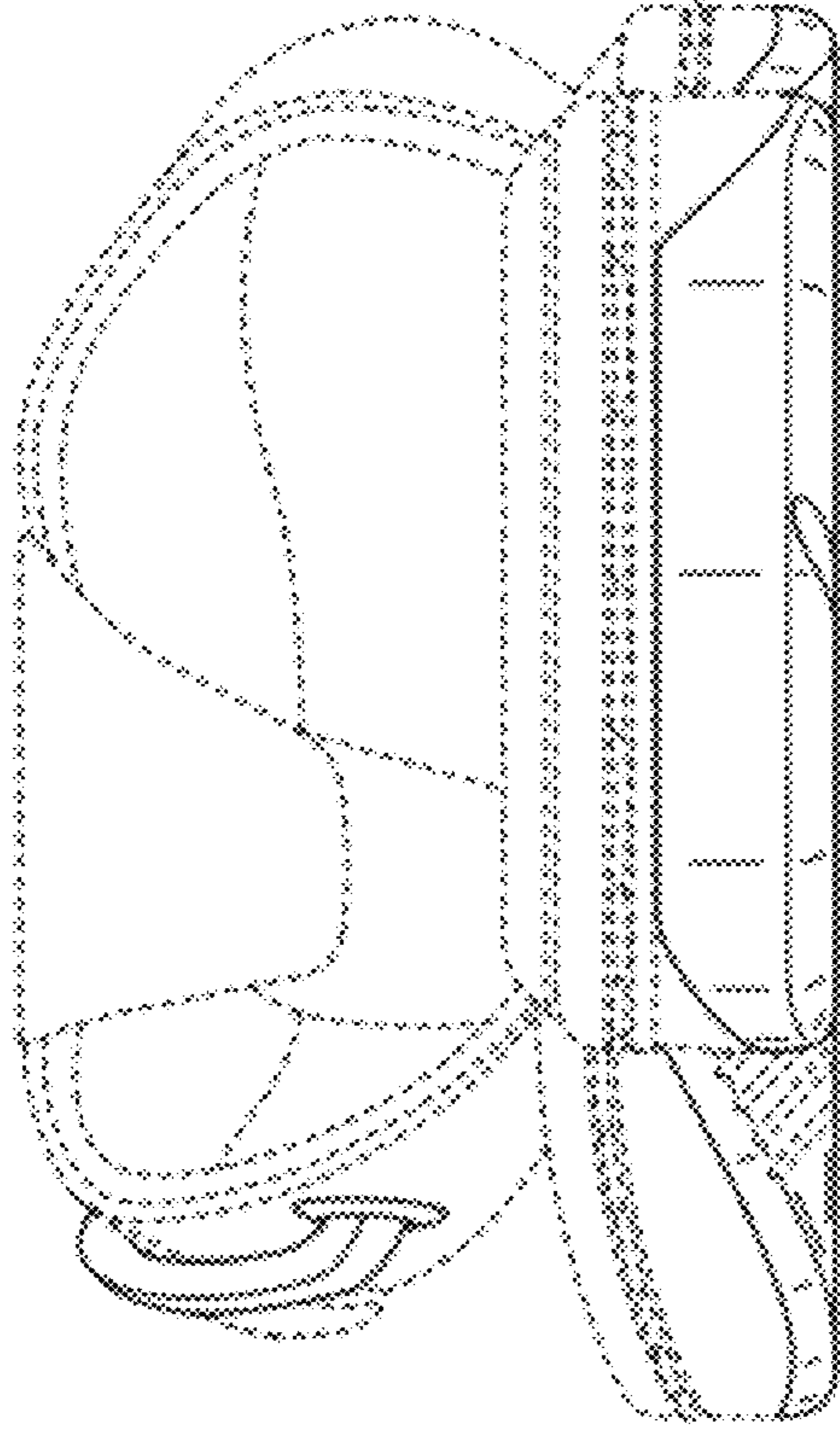

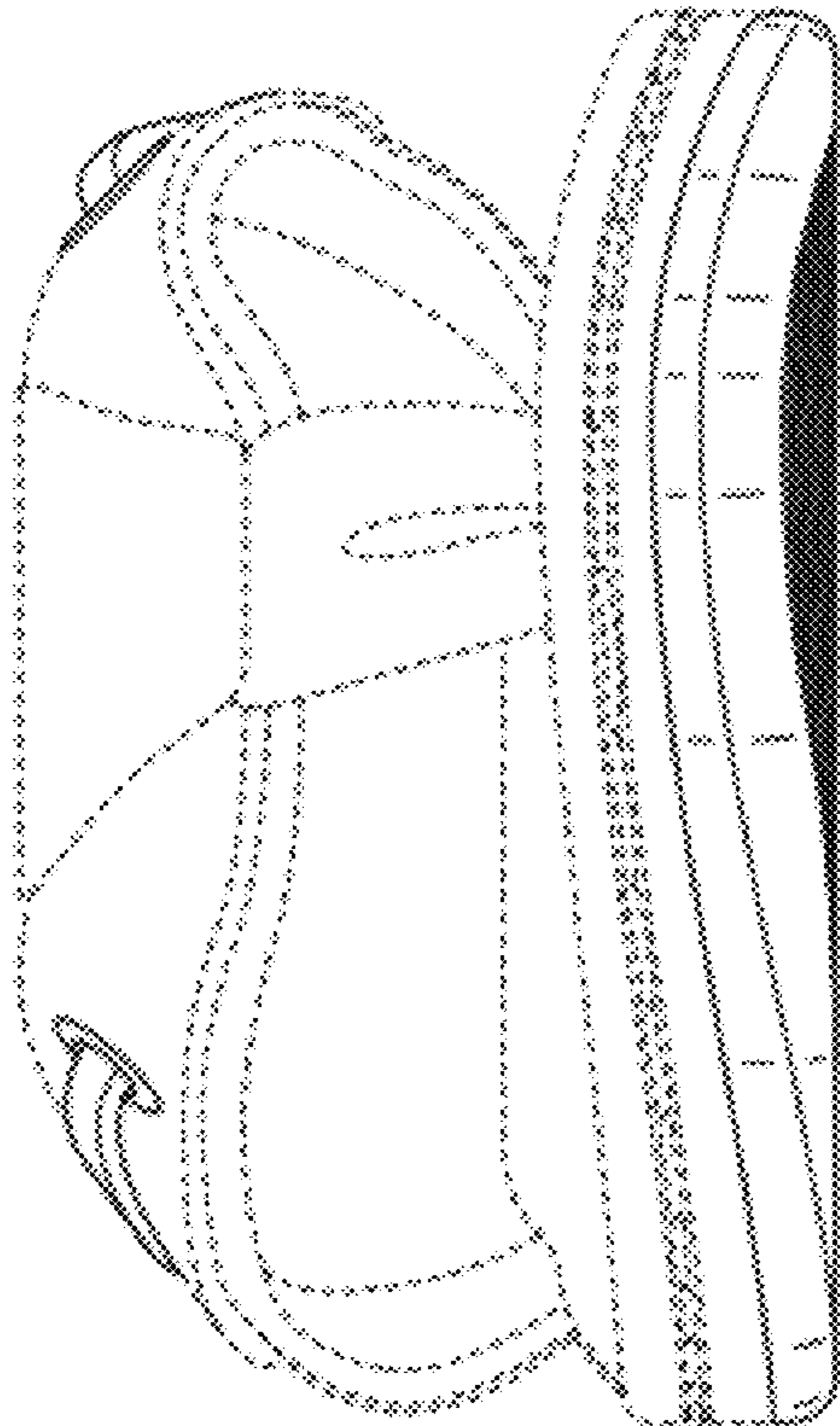

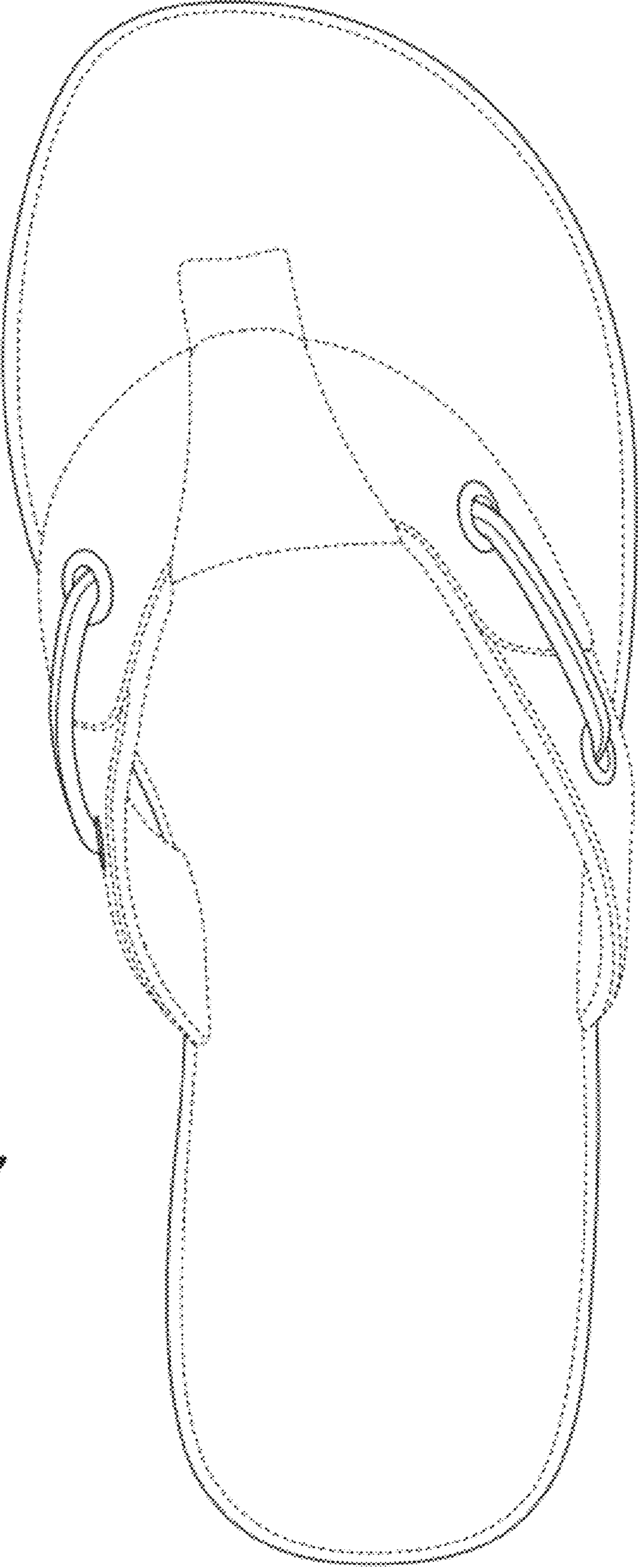

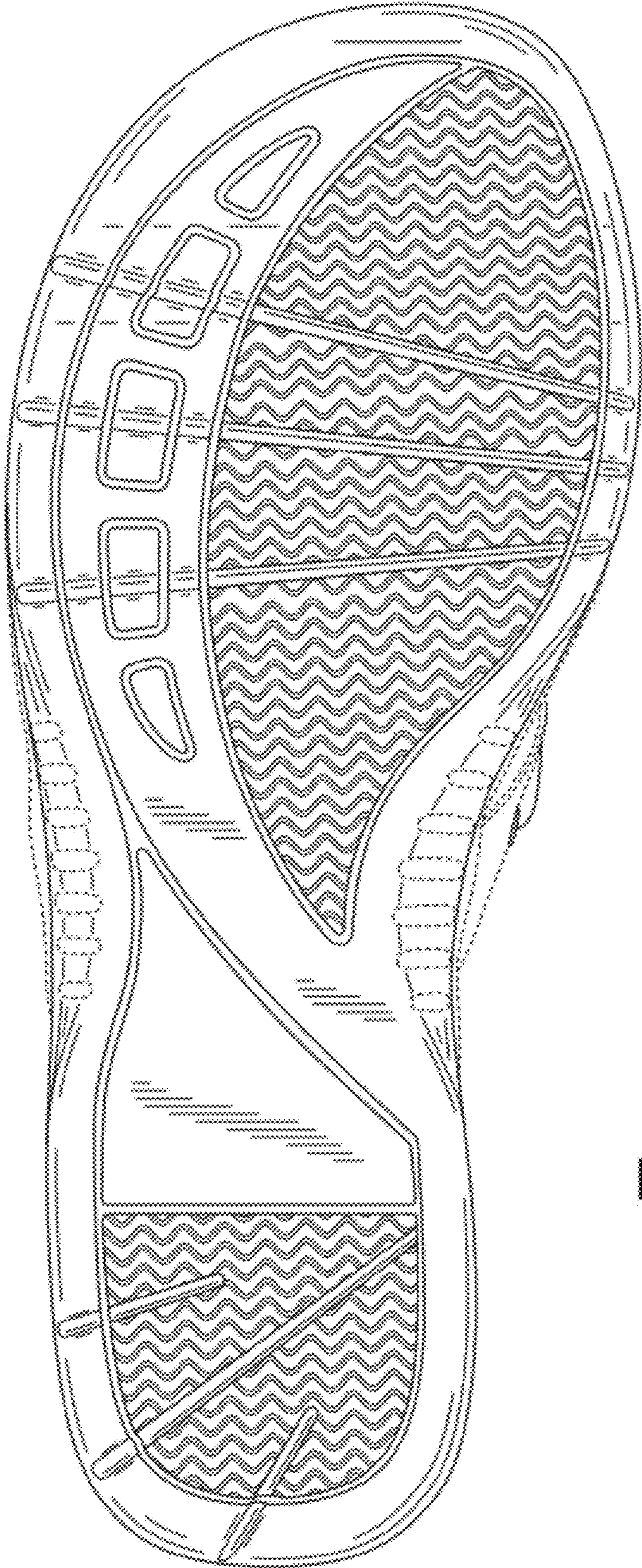
