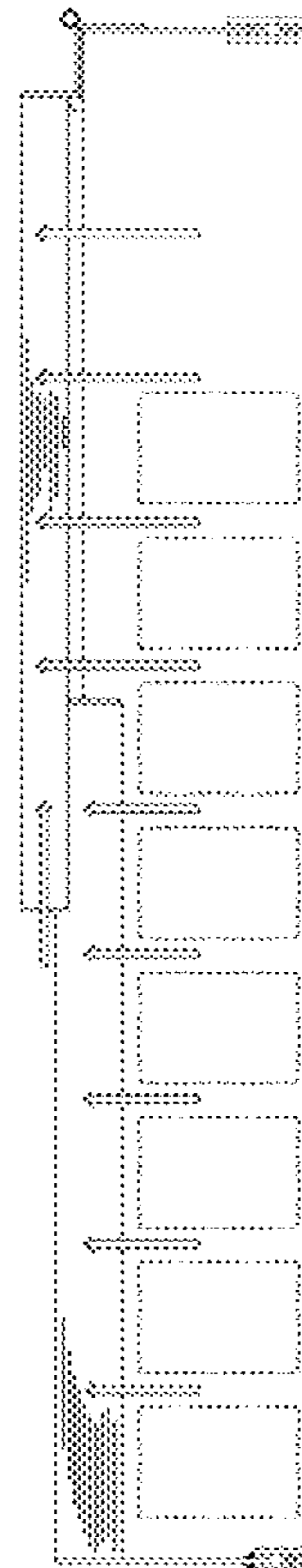
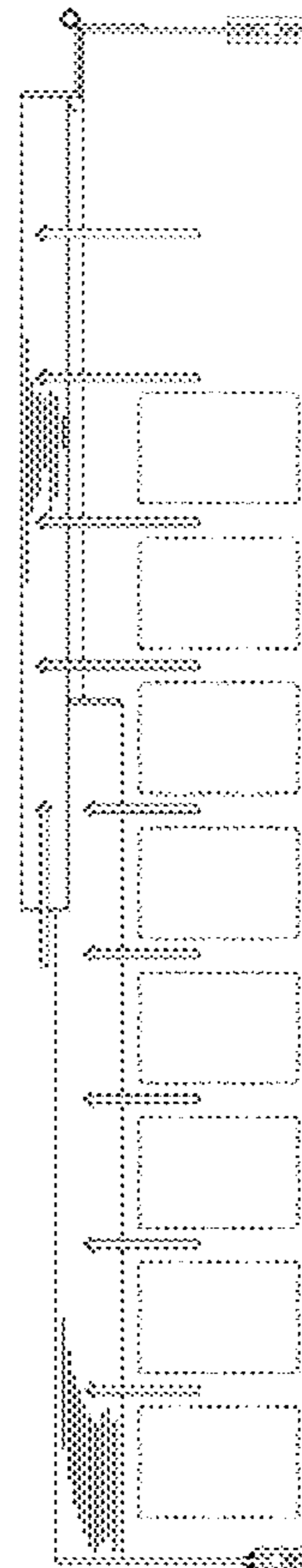
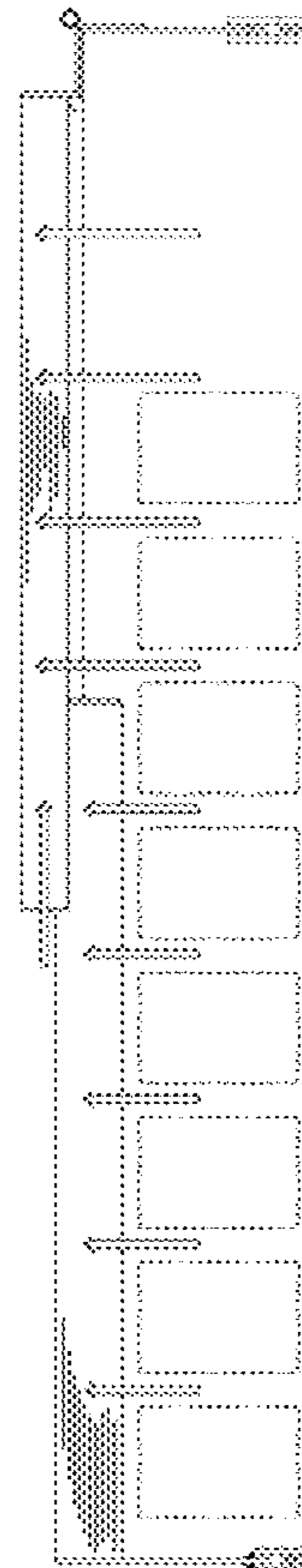
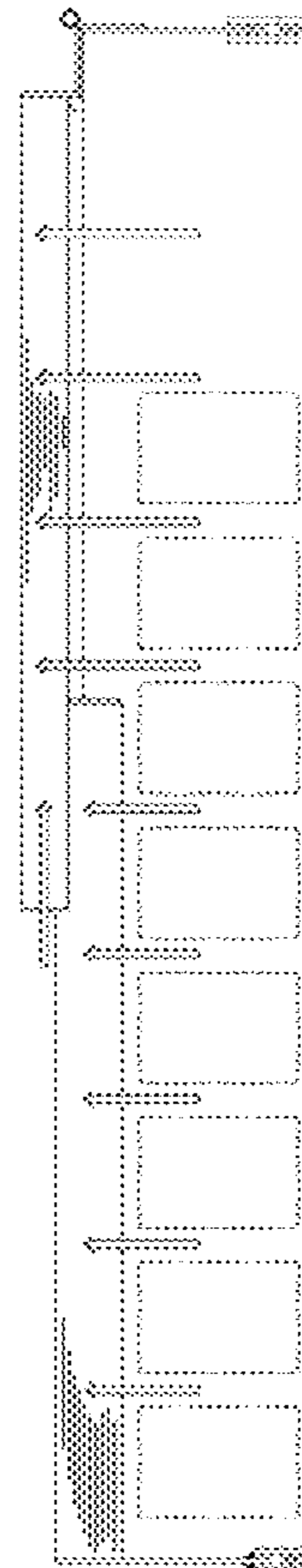
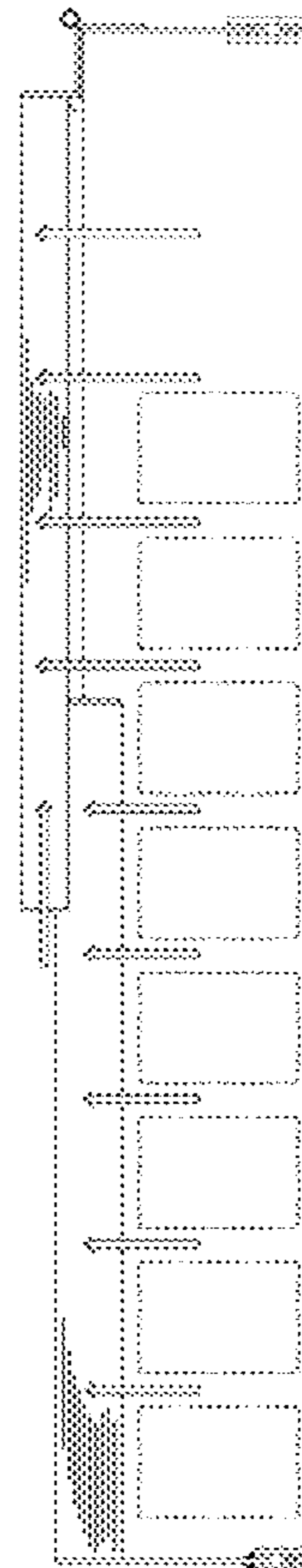
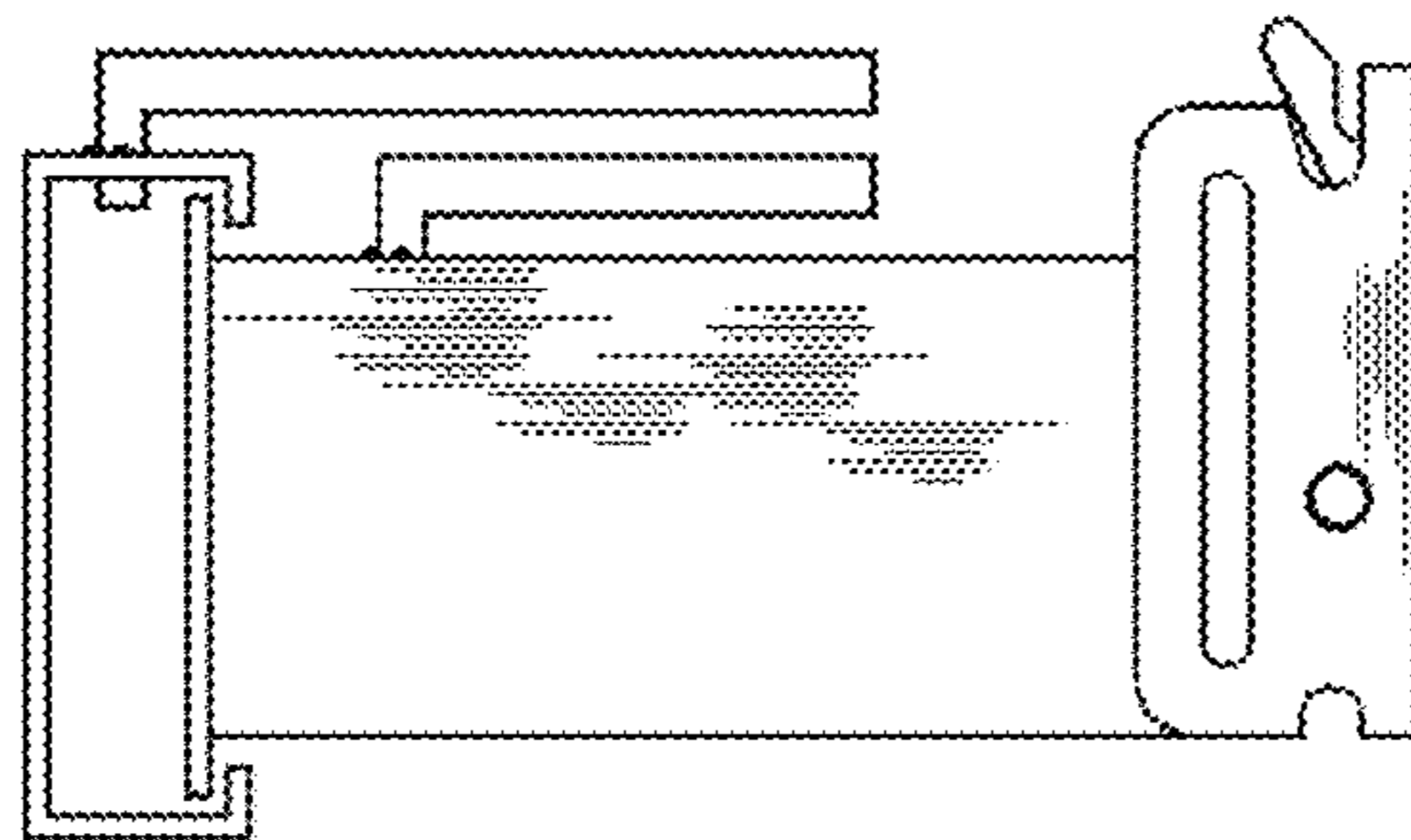
(57) **CLAIM**

The ornamental design for a load bar securing mechanism, as shown and described.

DESCRIPTION

FIG. 1 is a left side view for a load bar securing mechanism showing my new design; FIG. 2 is a right side view thereof; FIG. 3 is a top side view thereof; pos FIG. 4 is a bottom side view thereof; FIG. 5 is a back side view thereof; and, FIG. 6 is a front side view thereof. The broken lines in FIG. 3 and FIG. 6 depict environmental subject matter of load bar(s) for the invention only and form no part of the claimed design.

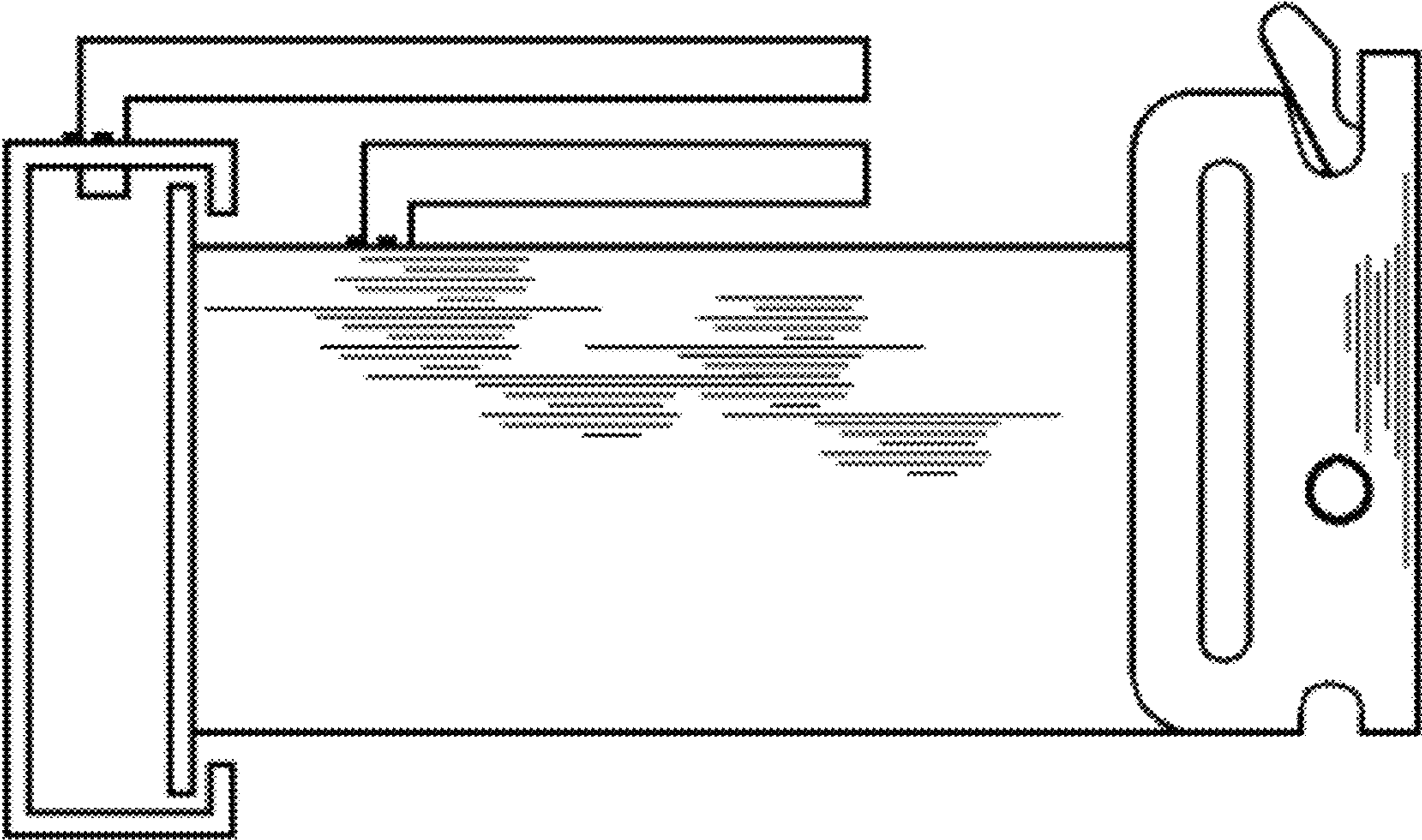

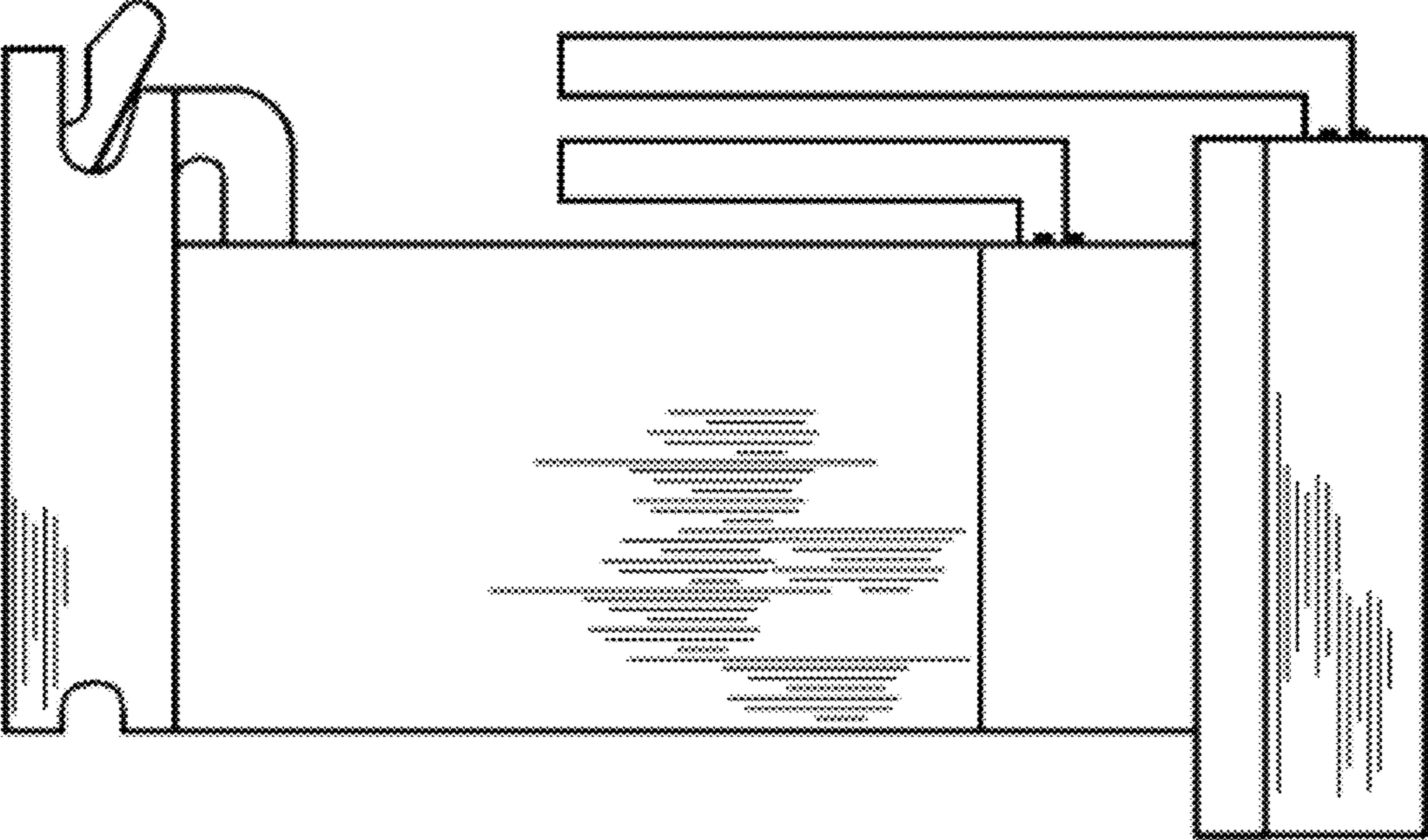

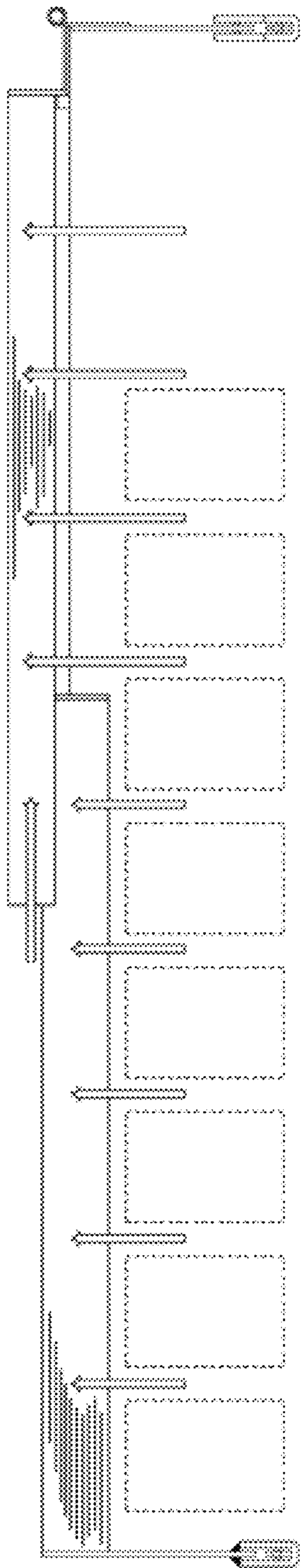

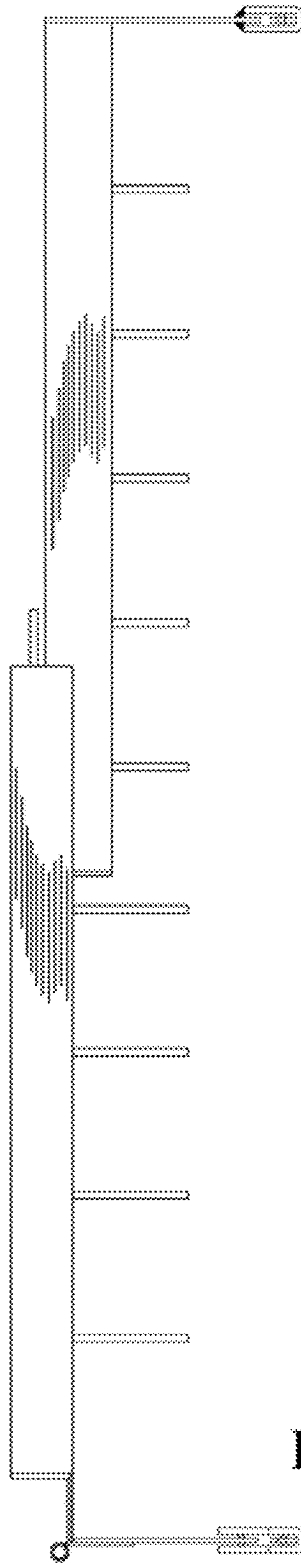

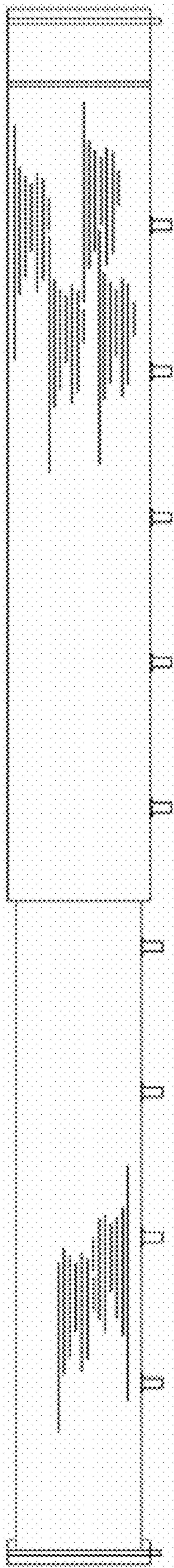

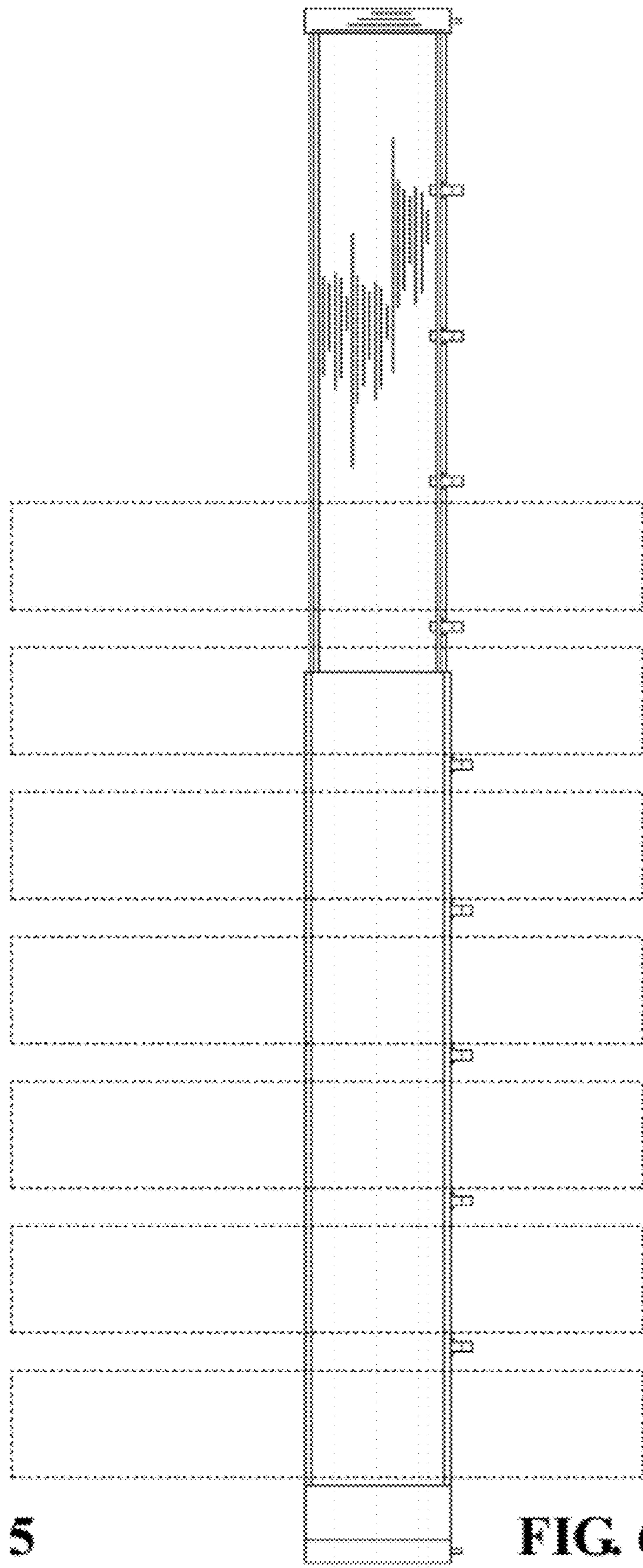
