**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view of a tissue holder thereof showing my new design;

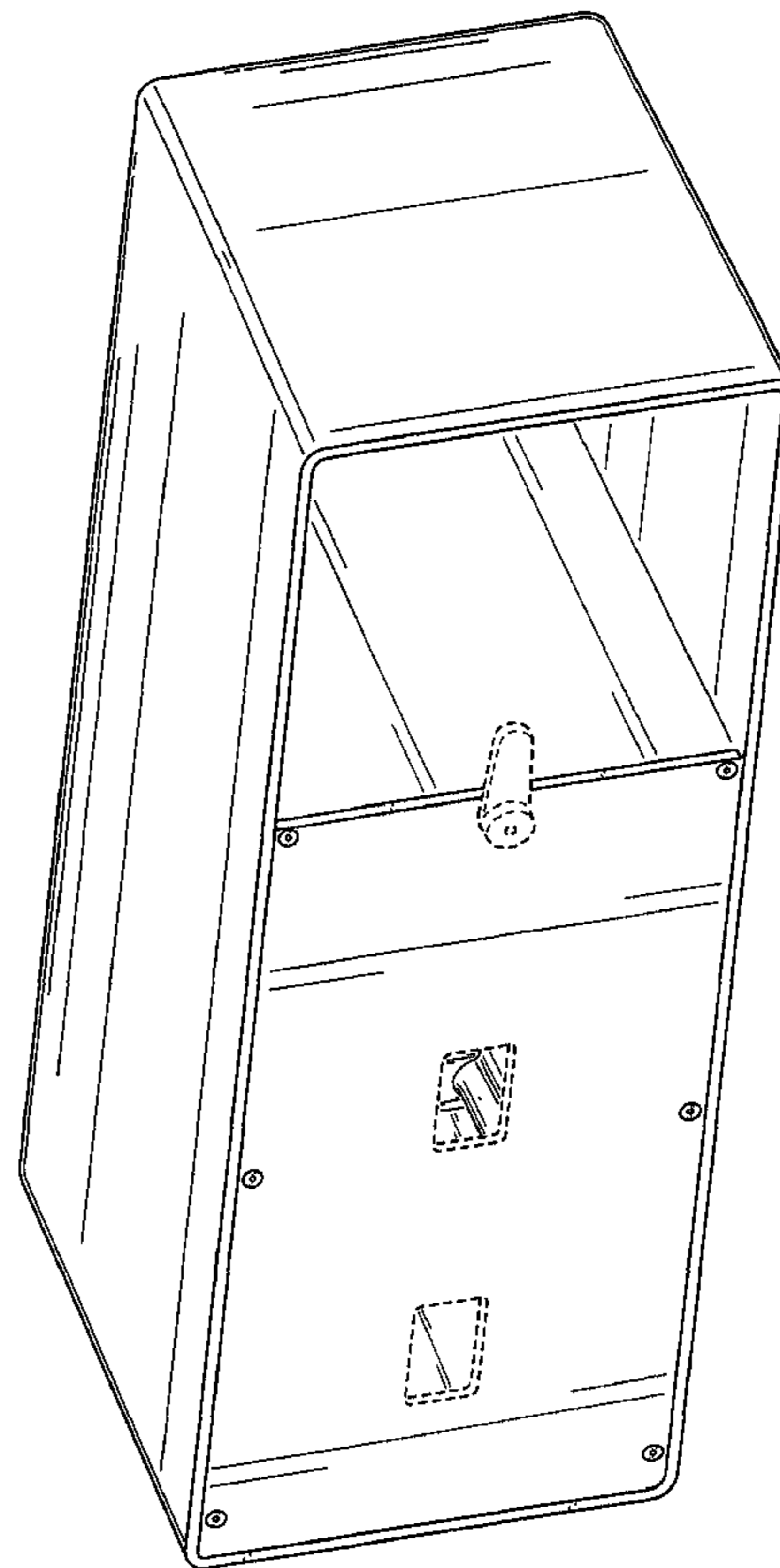
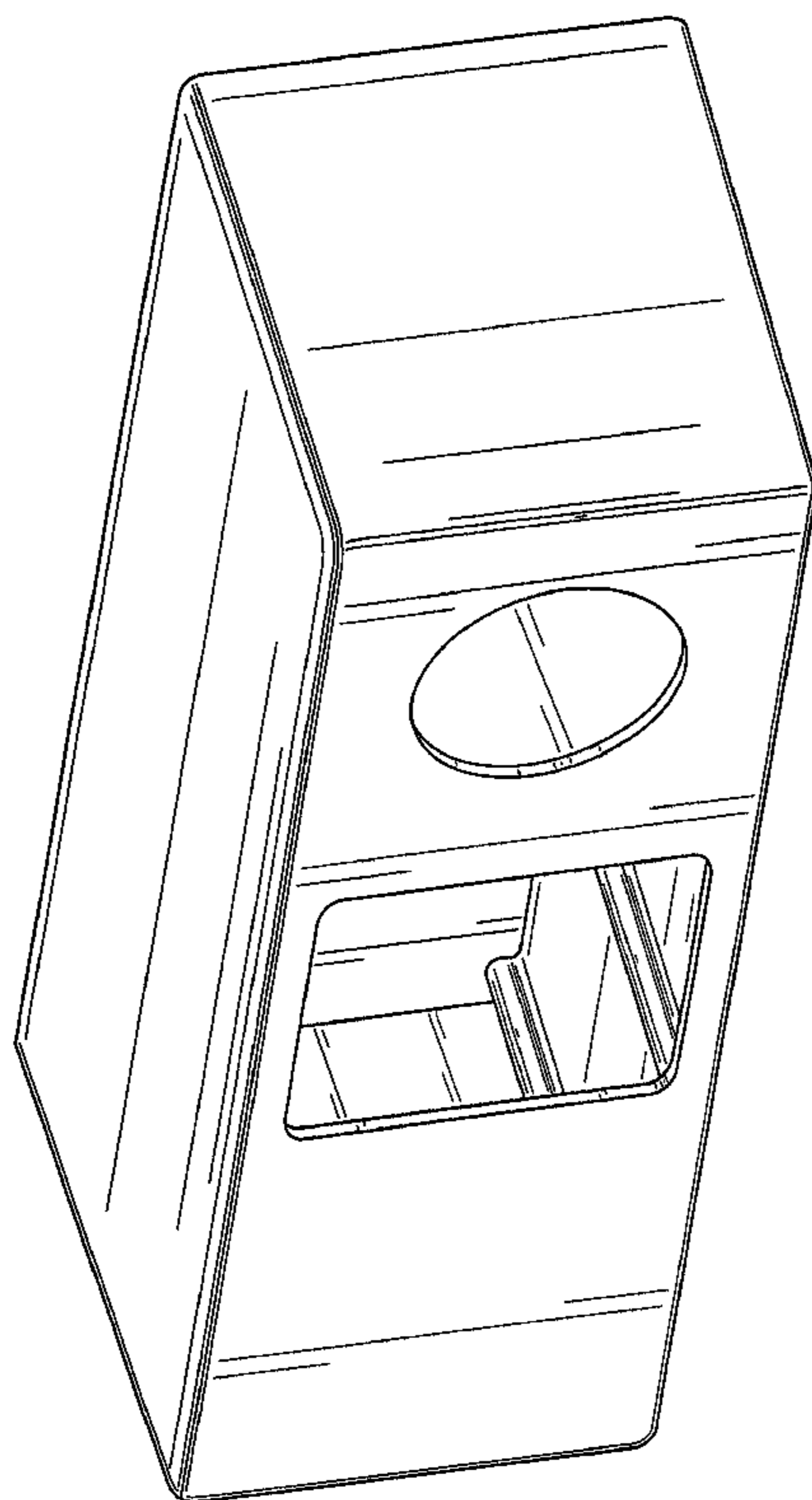

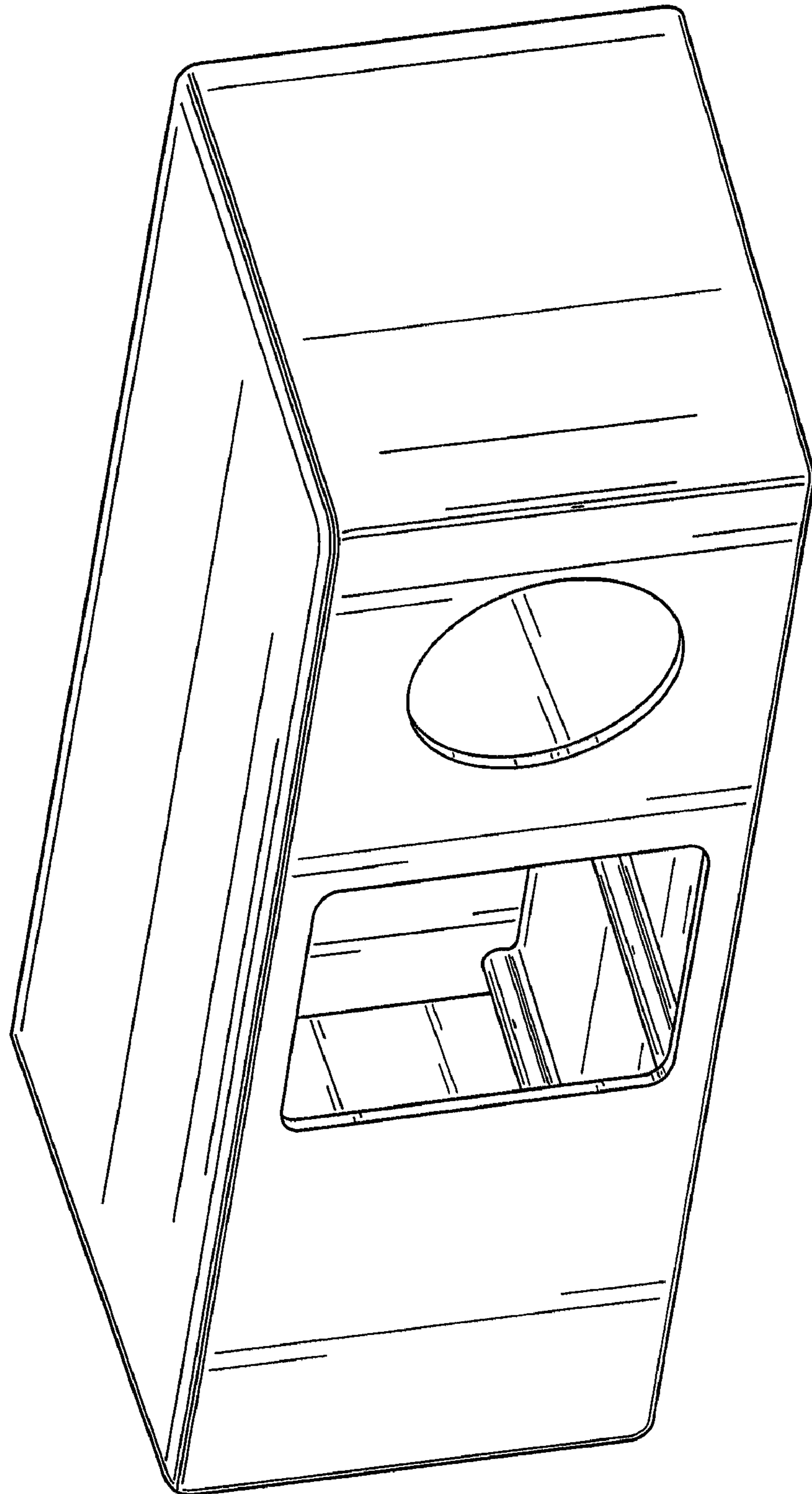

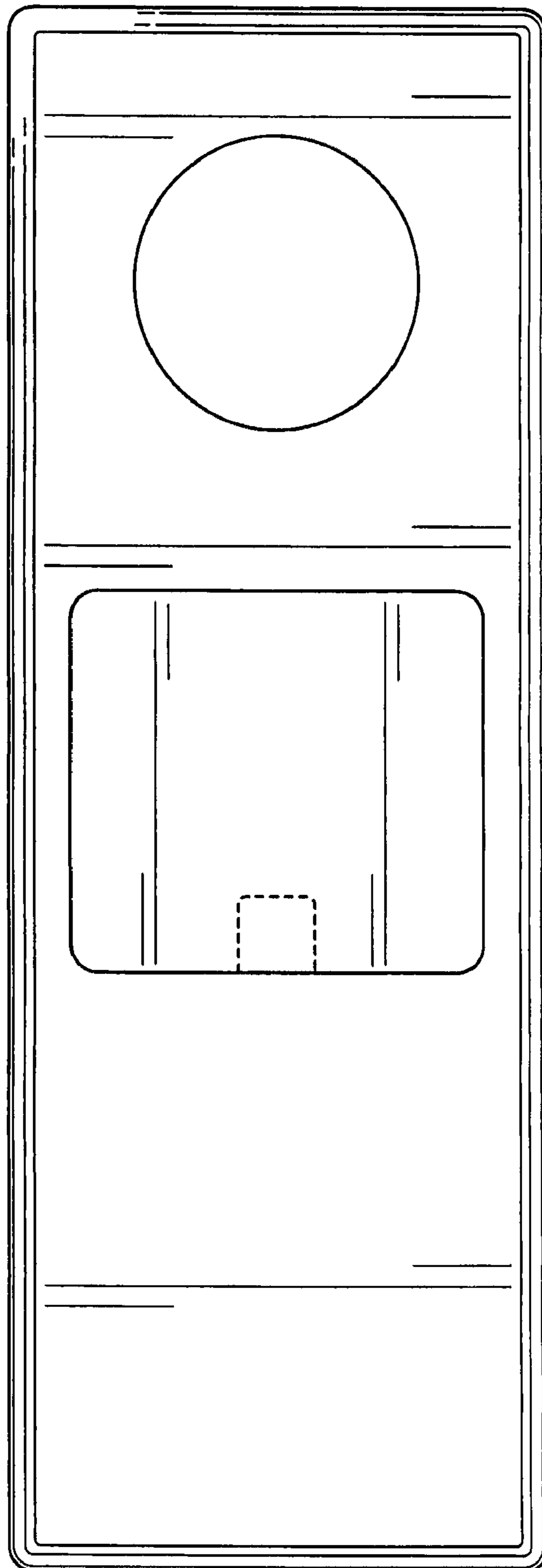

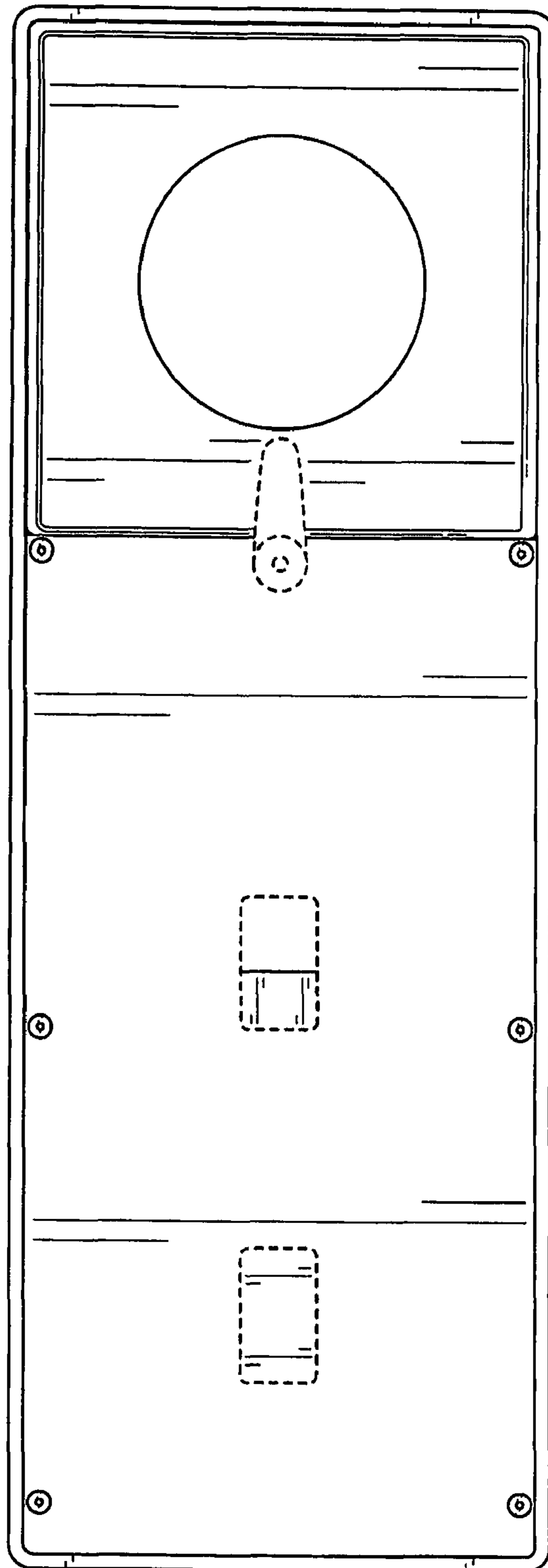

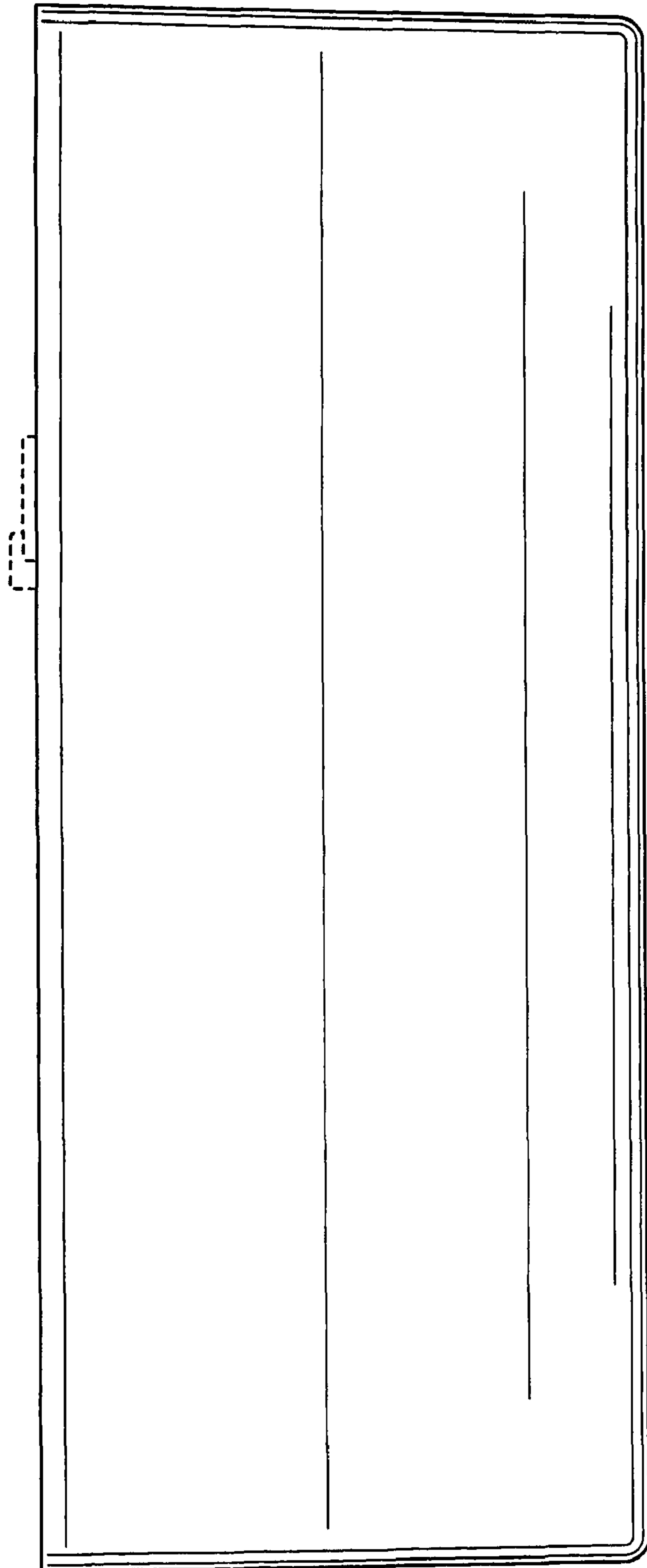

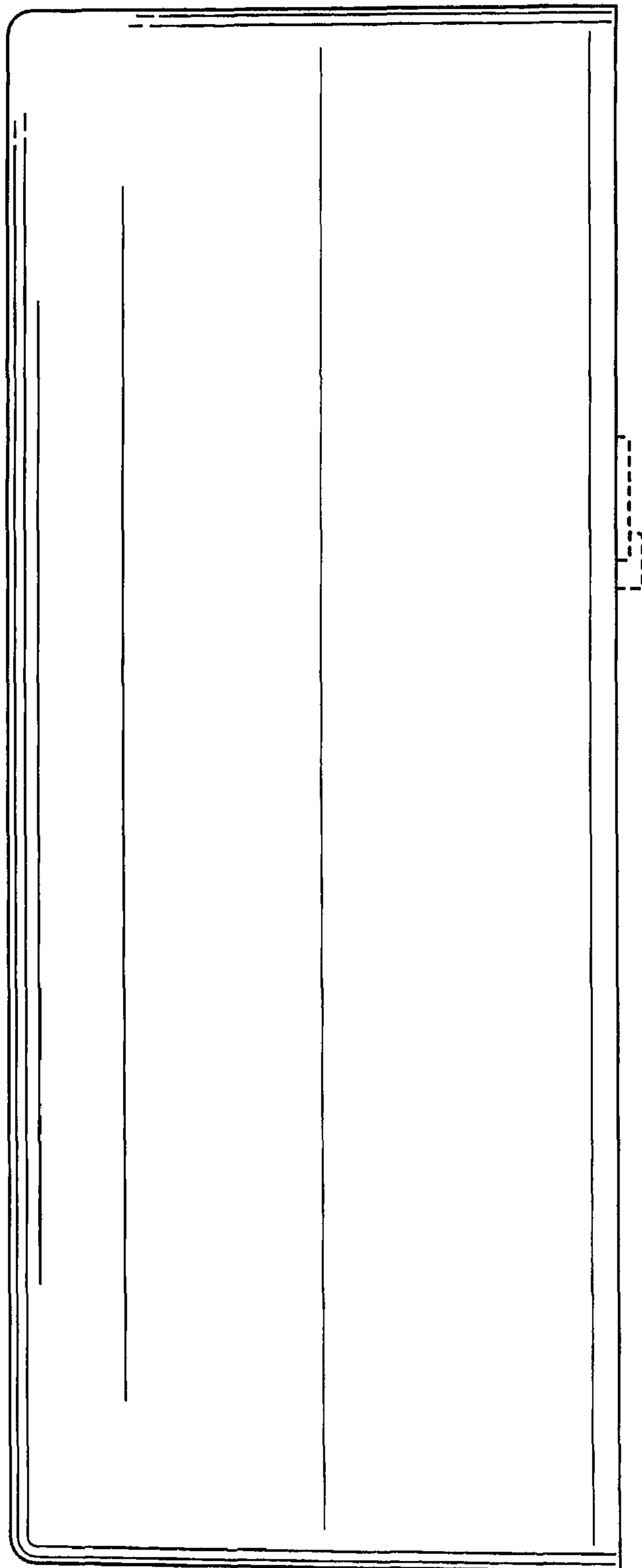

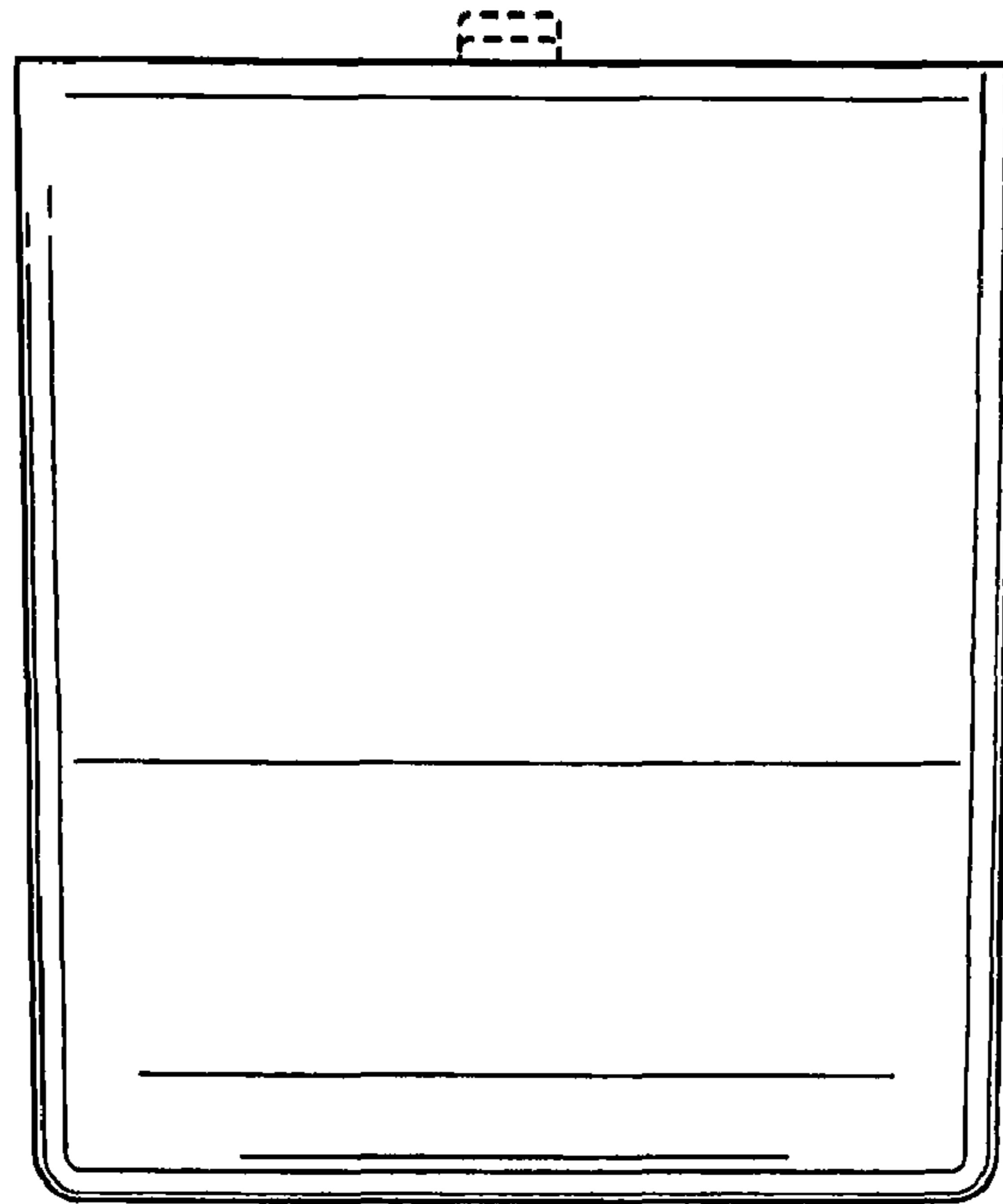

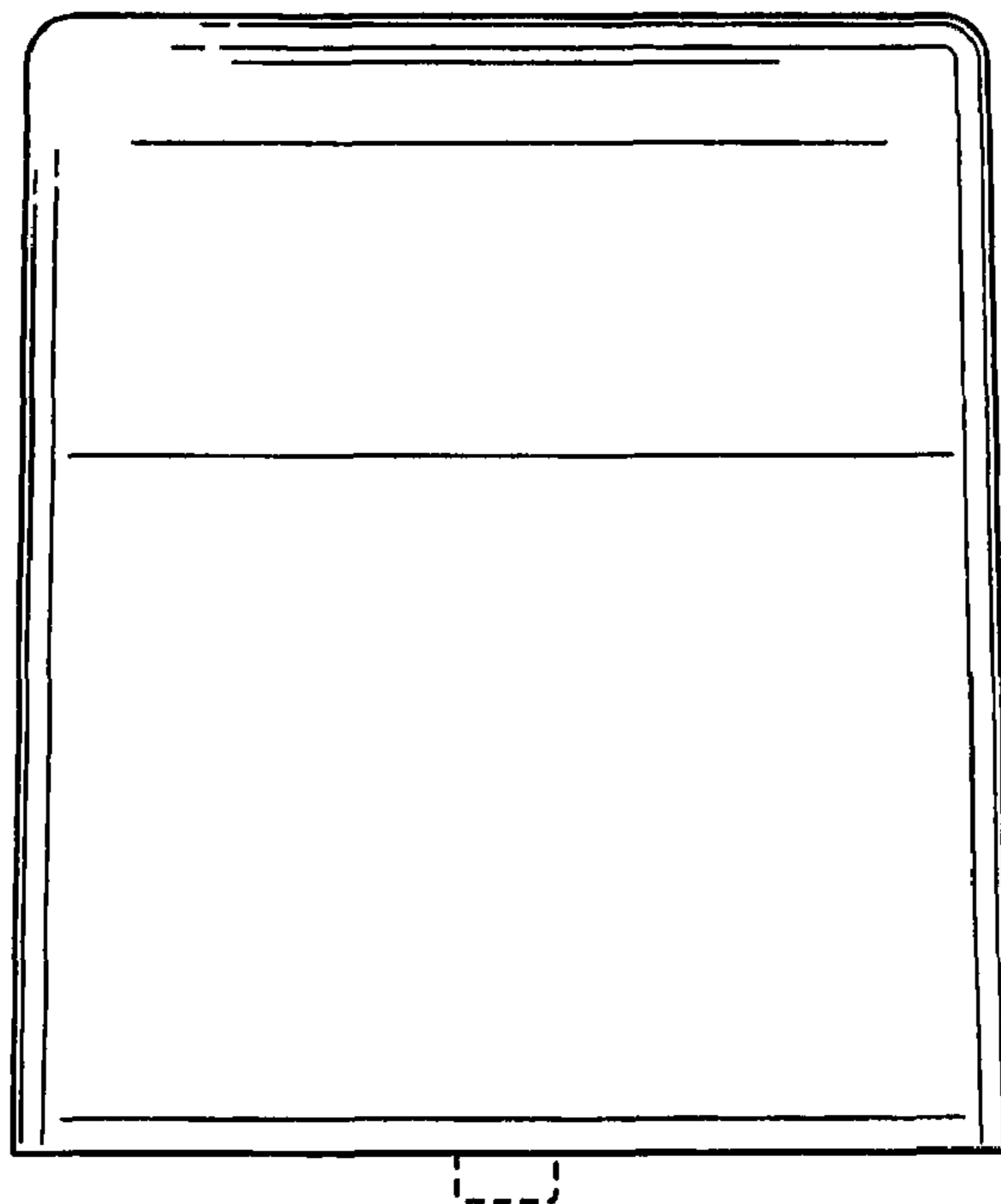
