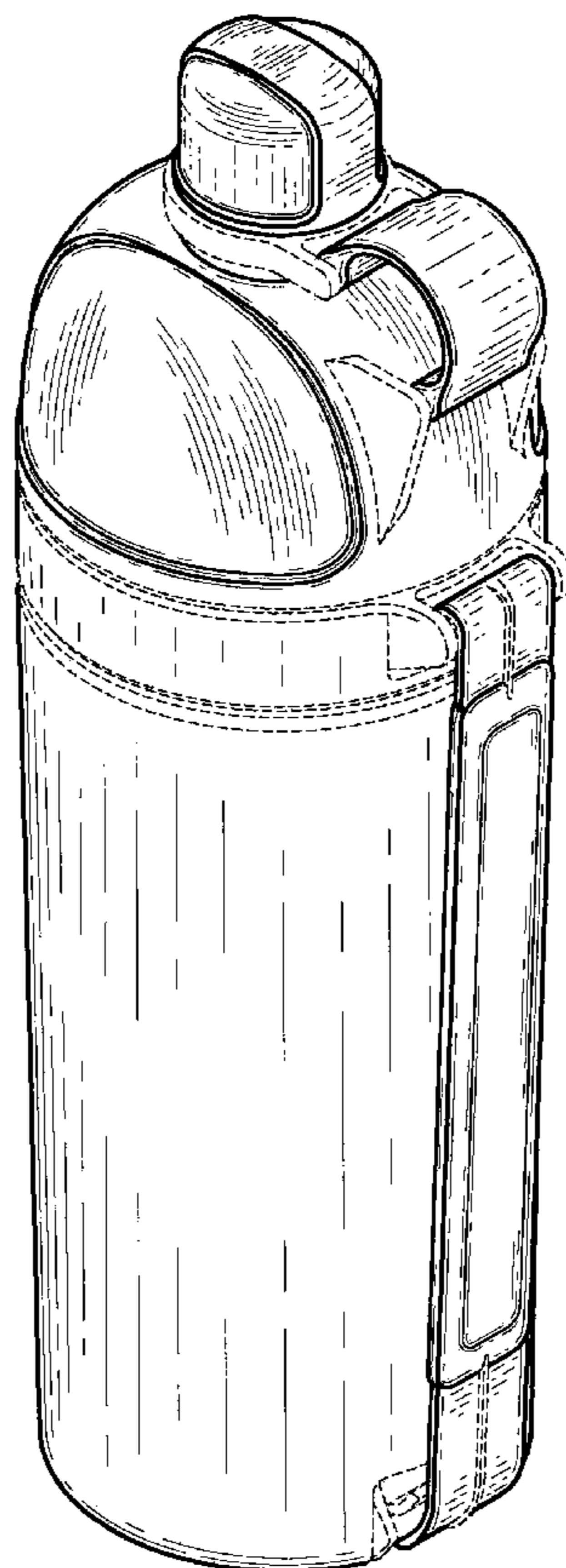

The ornamental design for a beverage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left side perspective view of a beverage container showing my new design.  
FIG. 2 is a rear elevational view thereof.  
FIG. 3 is a front elevational view thereof.  
FIG. 4 is a right side elevational view thereof  
FIG. 5 is a left side elevational view thereof.  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

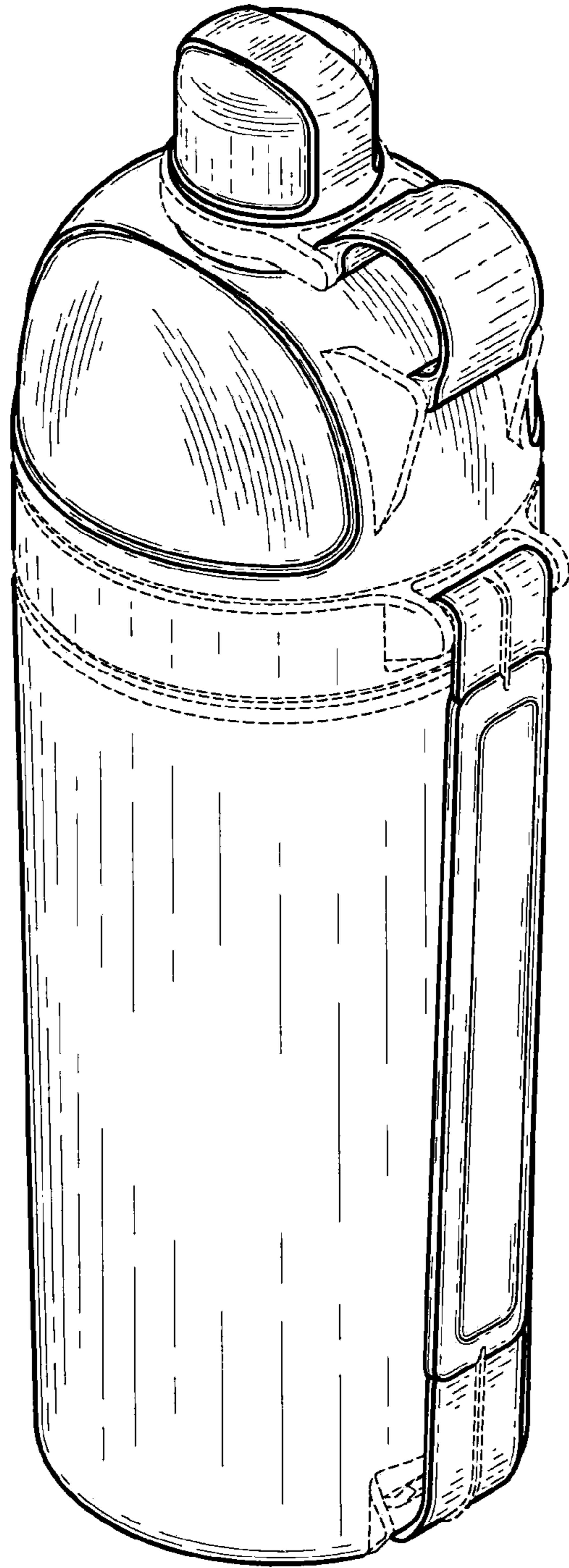

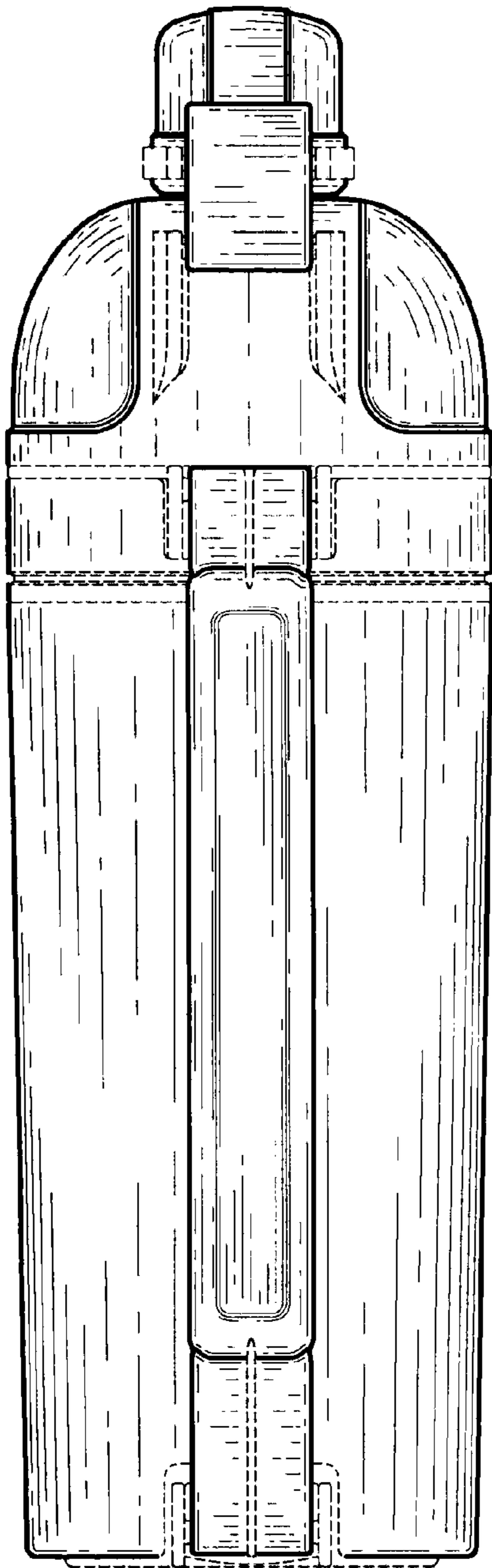

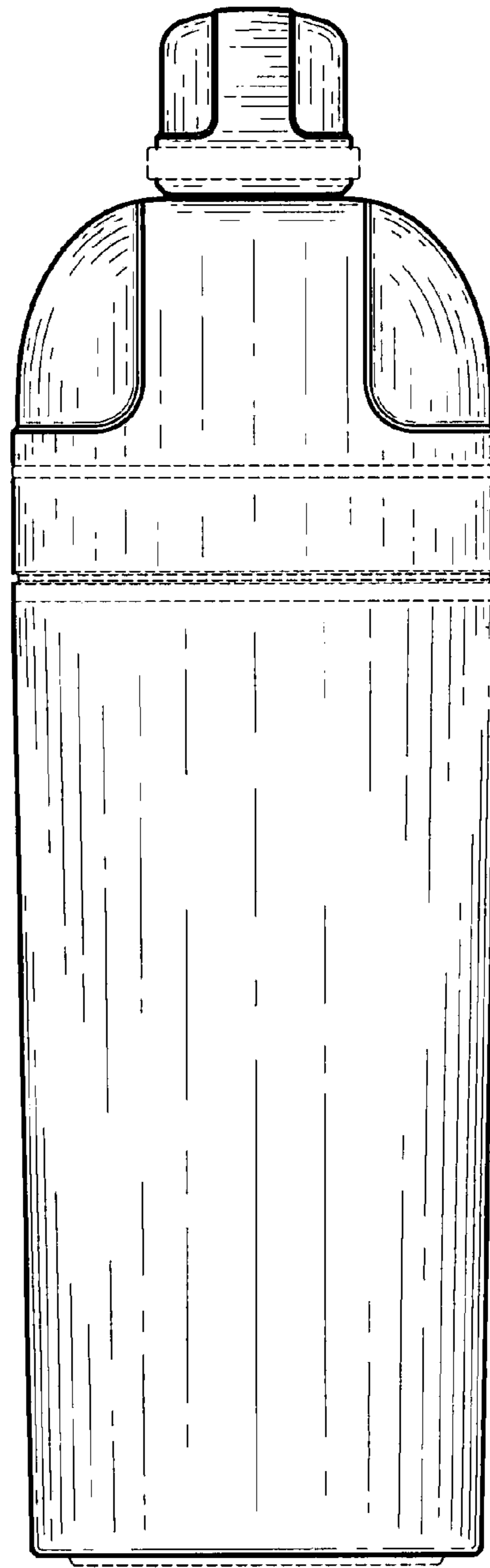

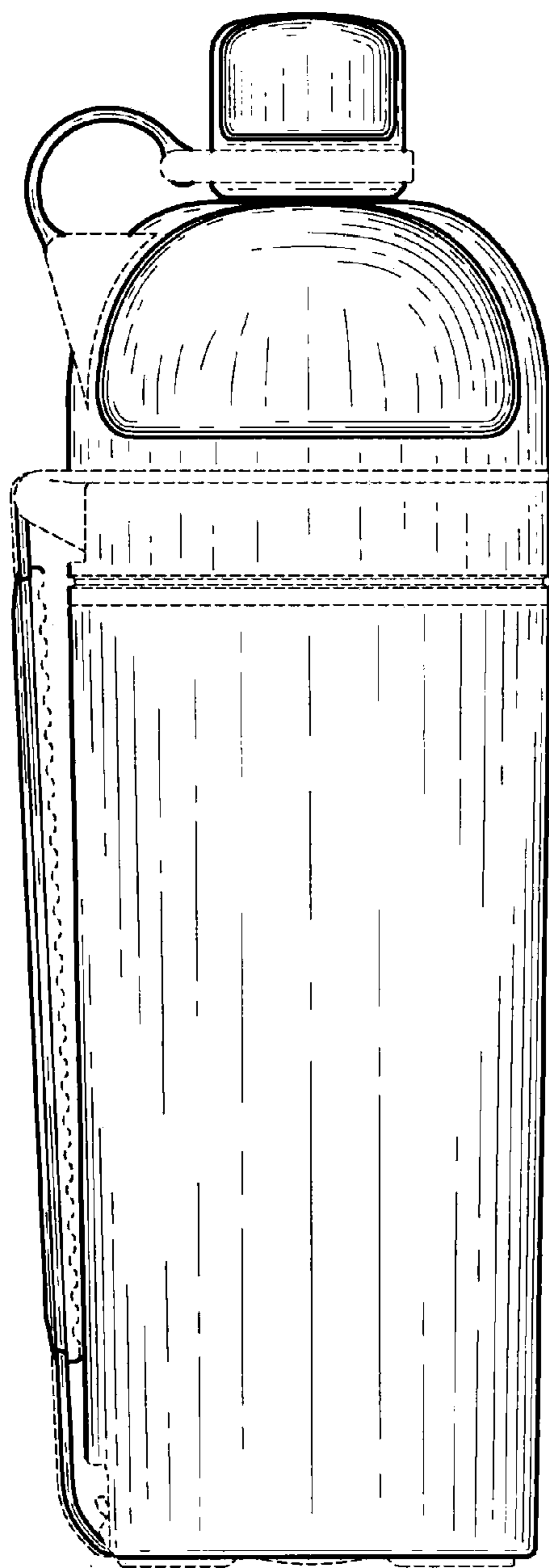

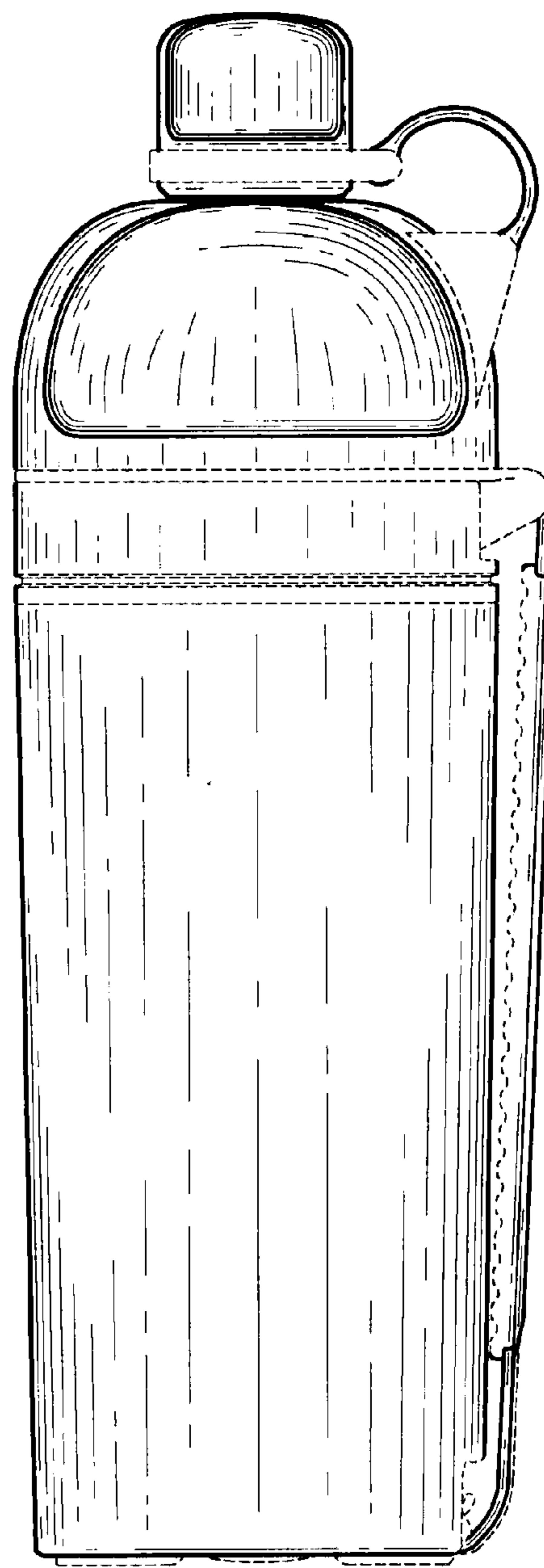

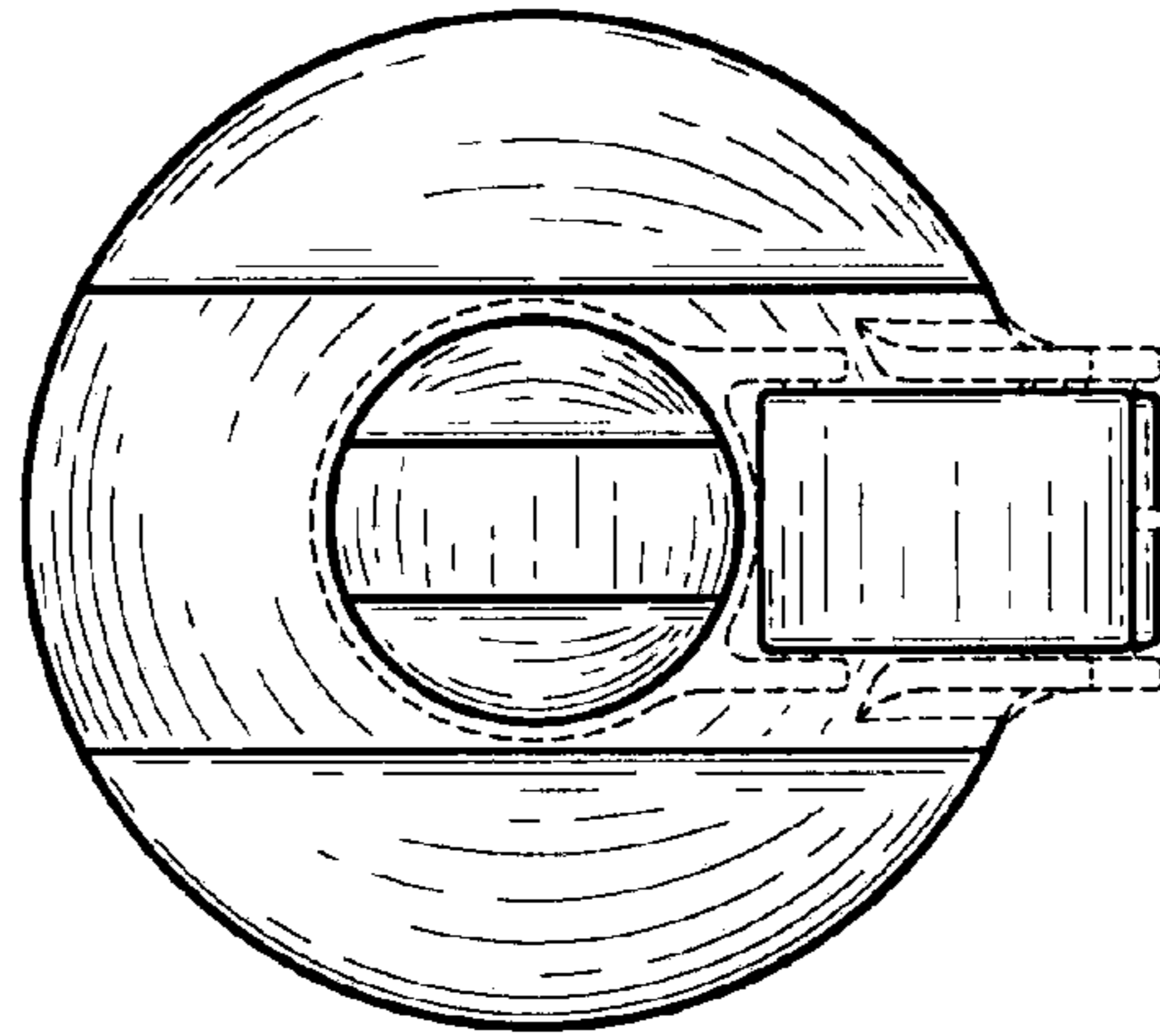

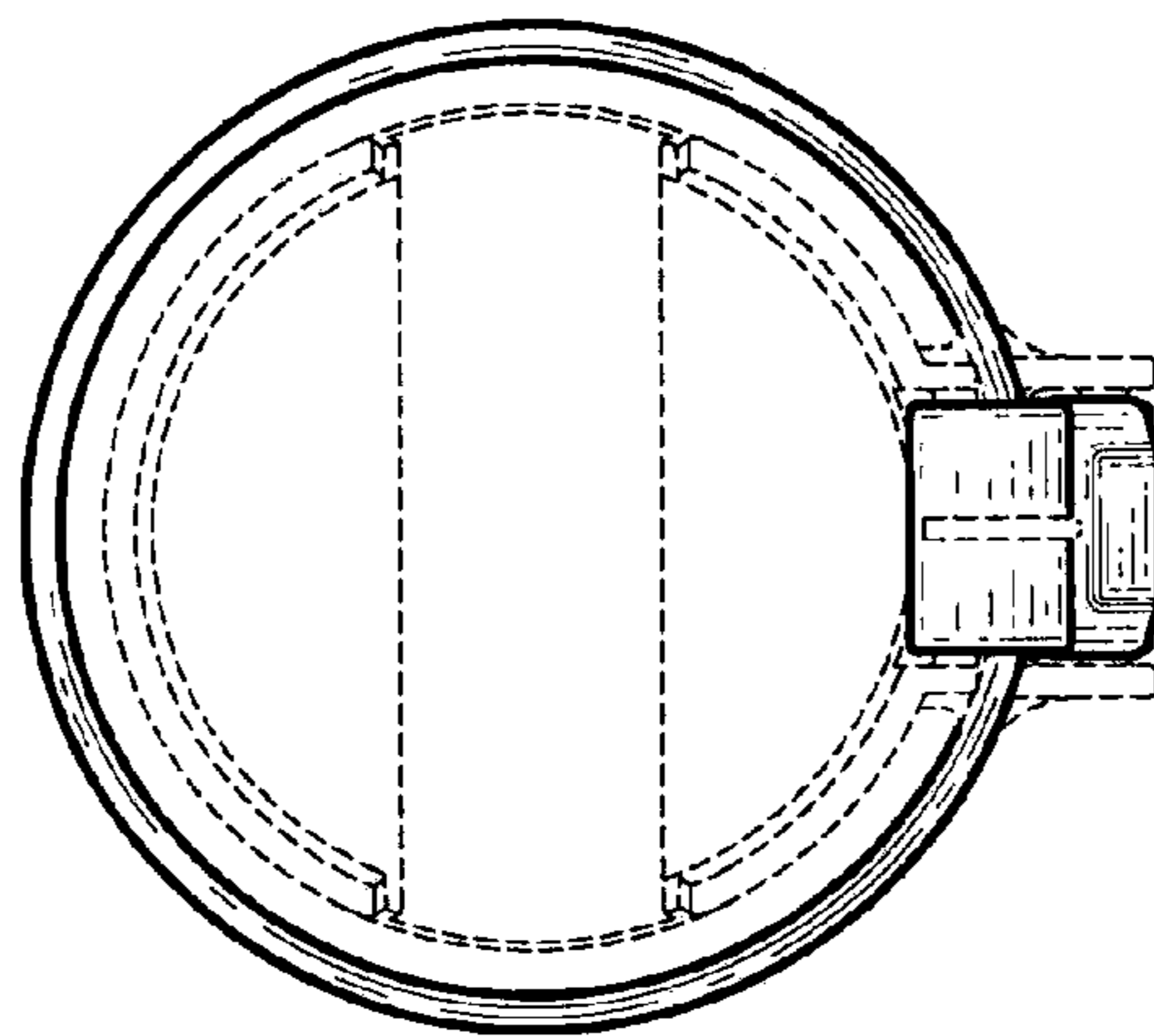
