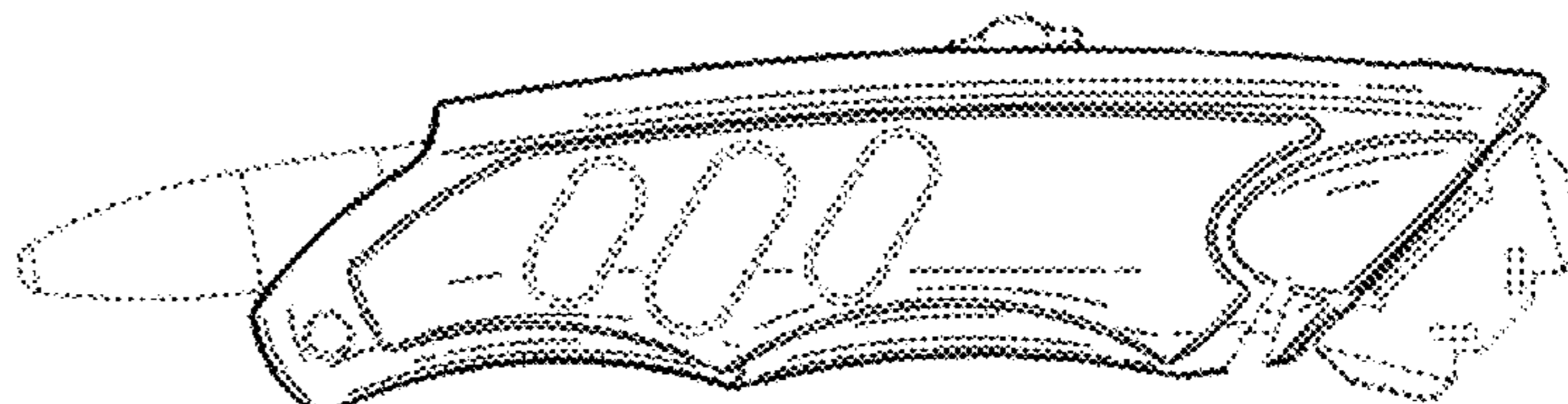
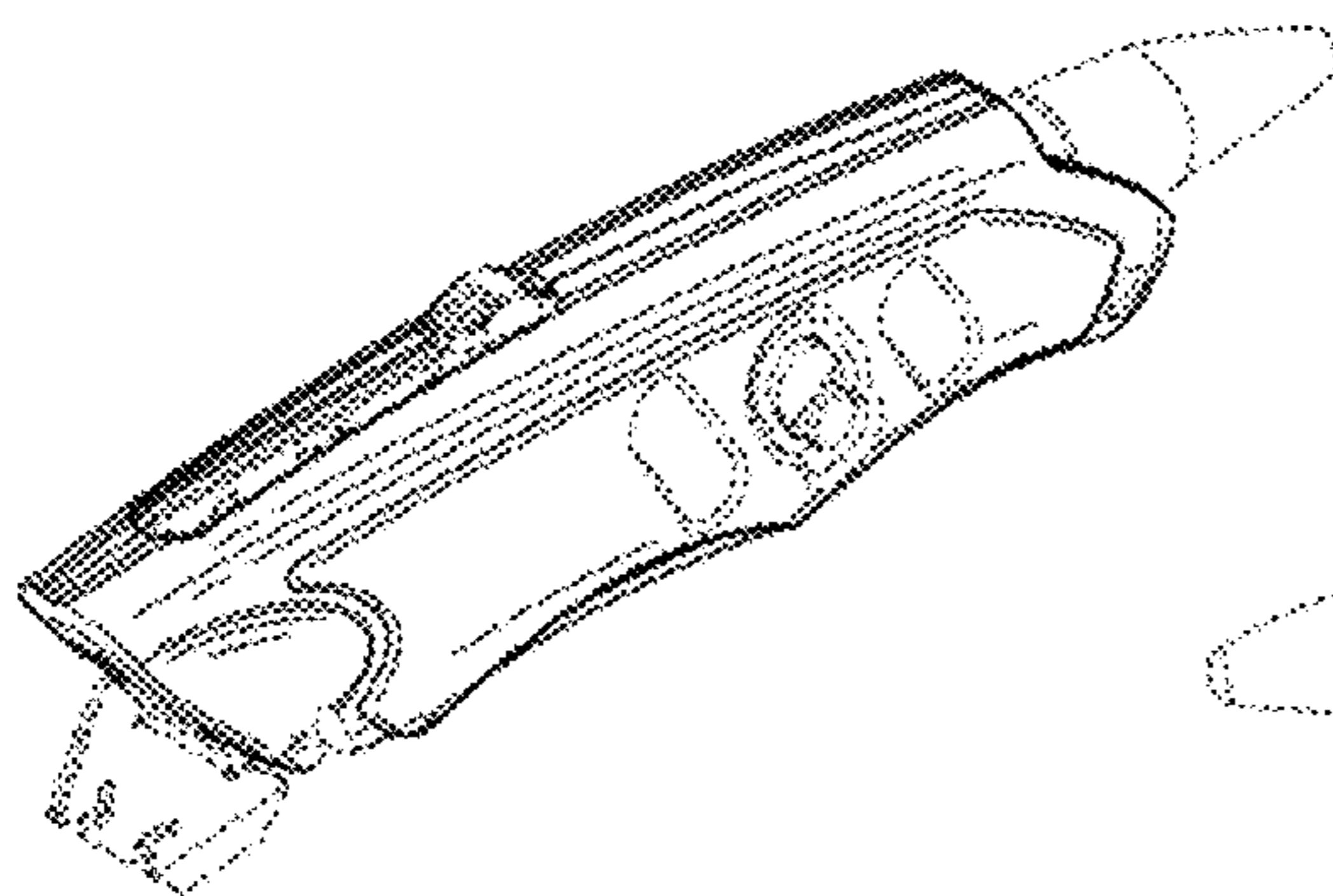
We claim the ornamental design for a multi-function tool, as shown and described.

DESCRIPTION

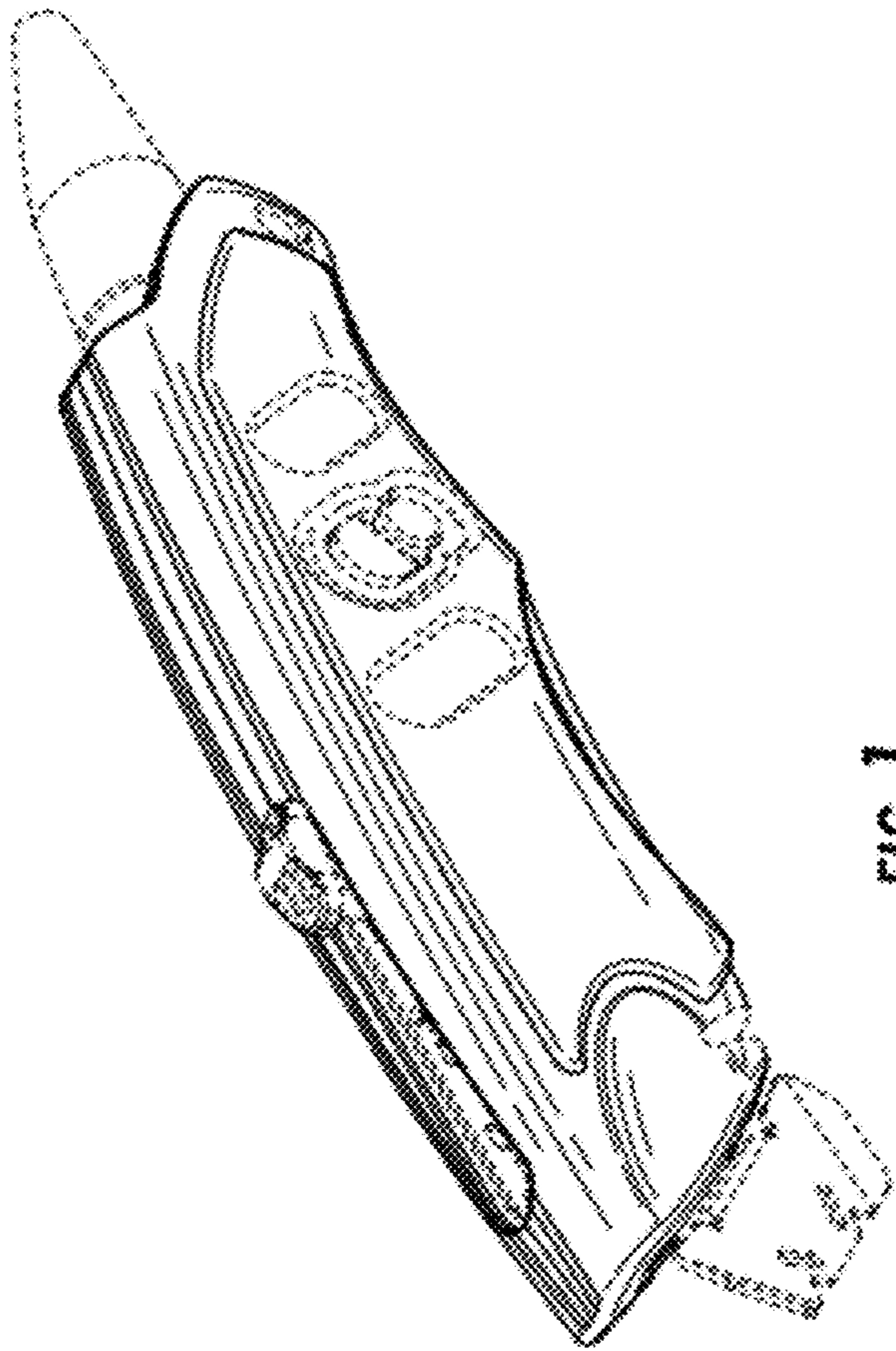

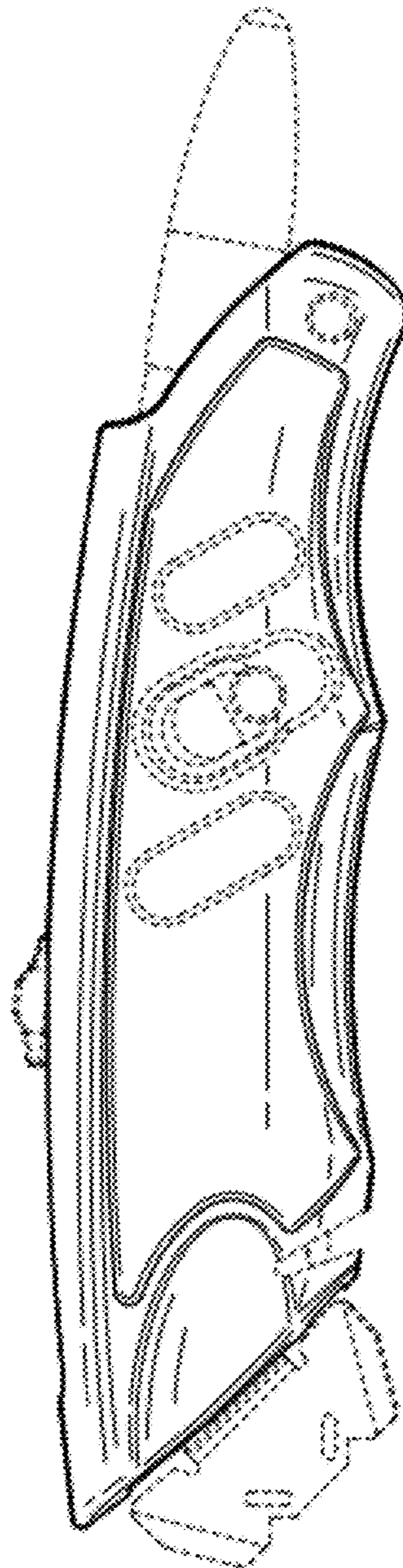

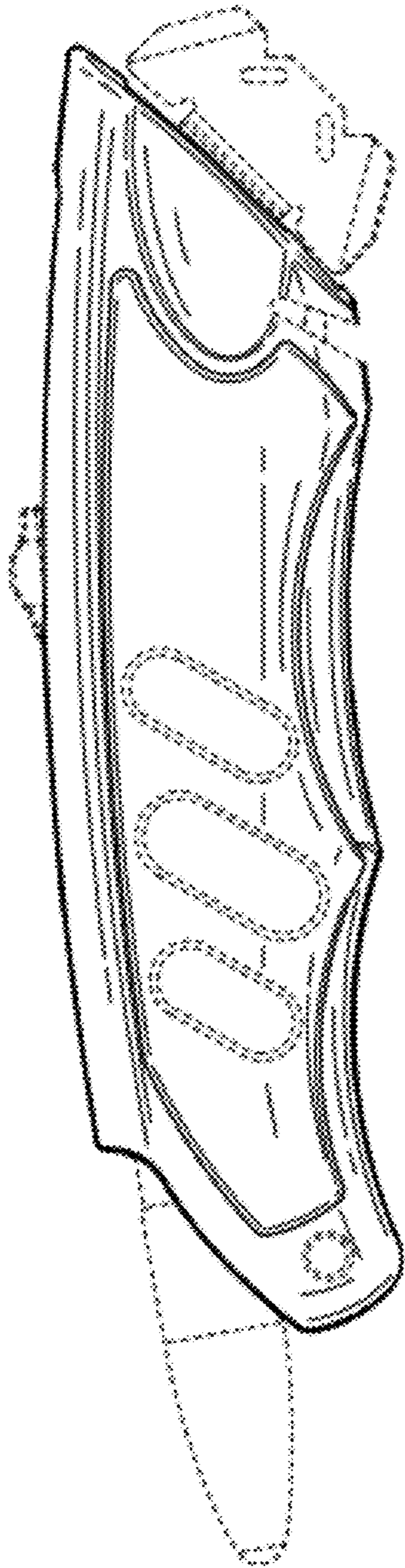

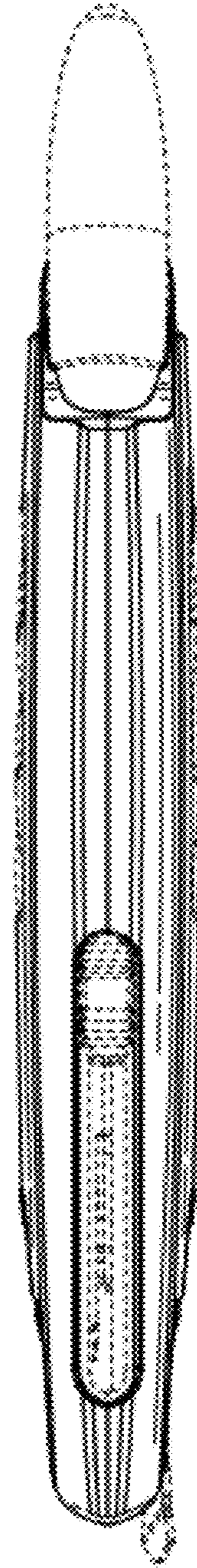

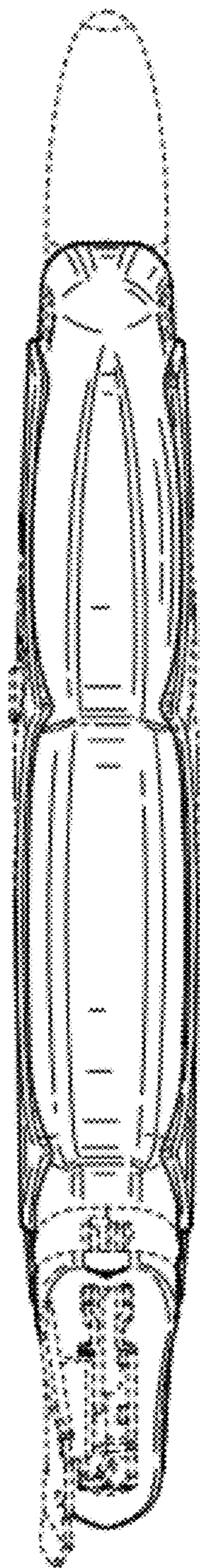

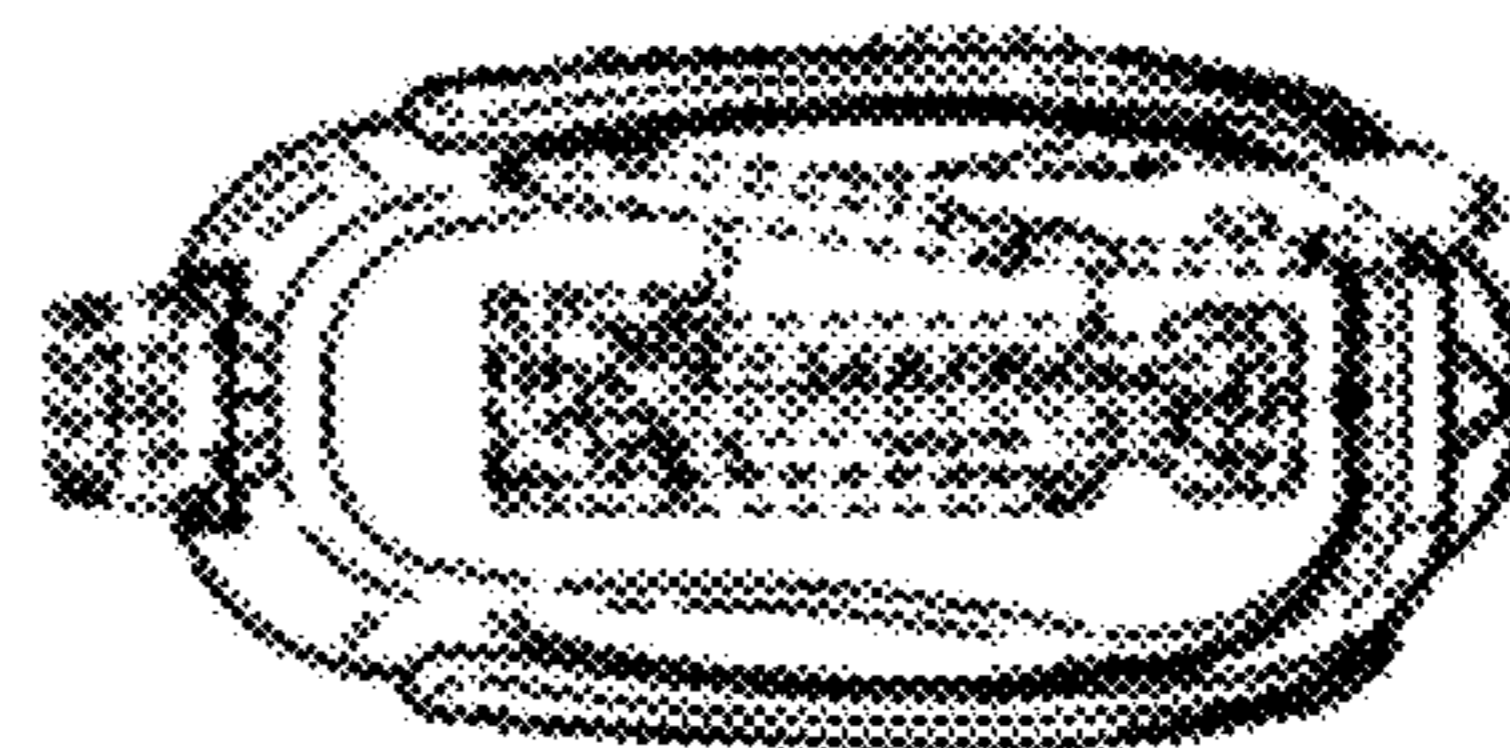

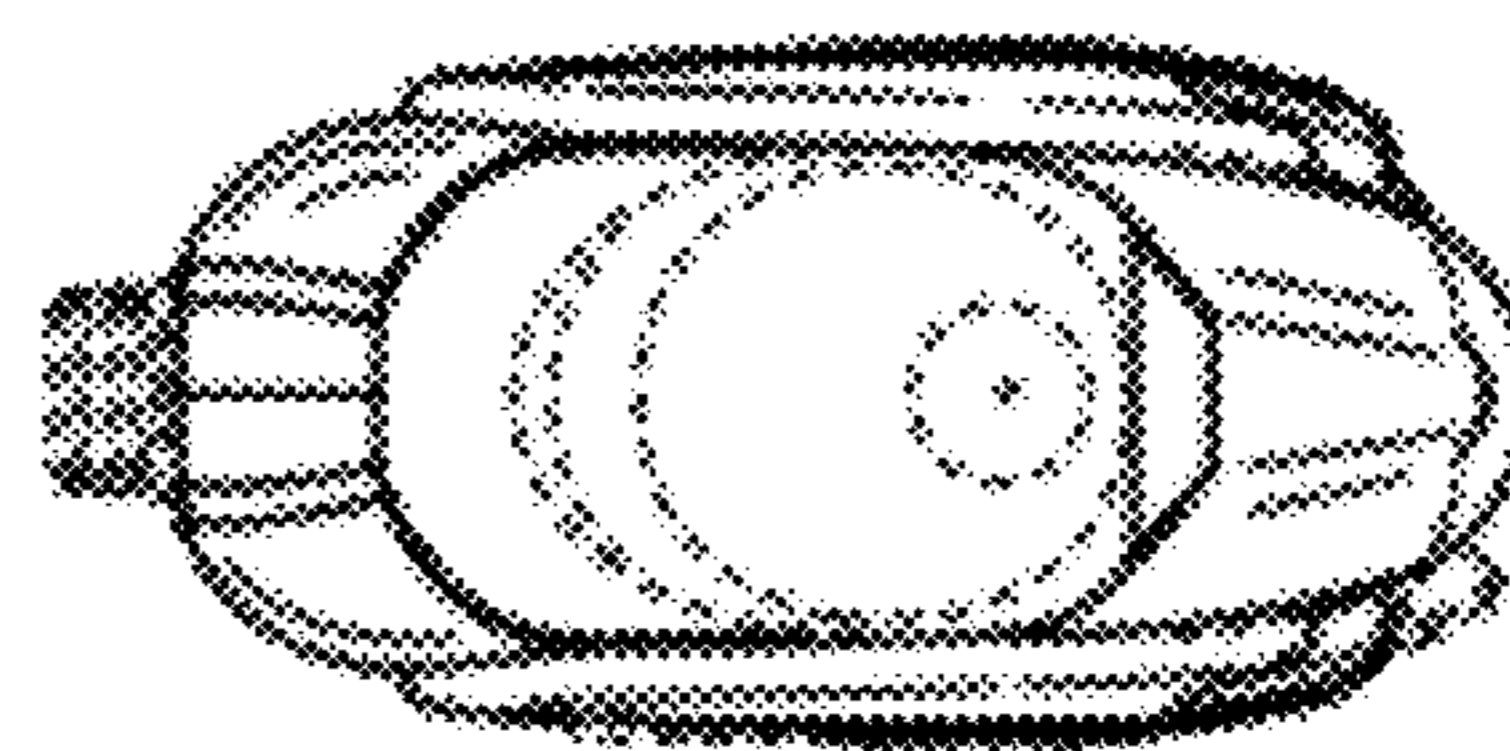
