(57) **CLAIM**

The ornamental design for a container with surface indicia, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container with surface indicia, embodying our new design;

FIG. 2 is a front view of the container with surface indicia of FIG. 1.

FIG. 3 is a back elevational view of the container with surface indicia of FIG. 1;

FIG. 4 is a first side elevational view of the container with surface indicia of FIG. 1;

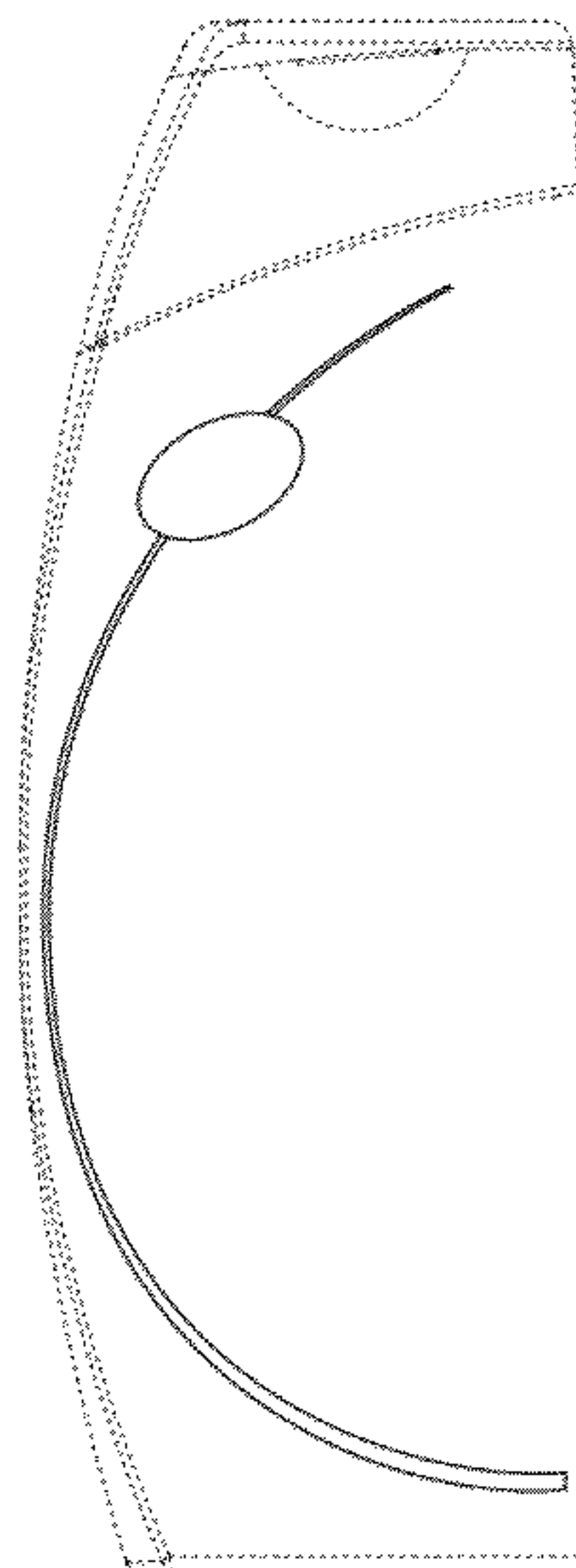
FIG. 5 is a second side elevational view of the container with surface indicia of FIG. 1;

FIG. 6 is a top view of the container with surface indicia of FIG. 1; and,

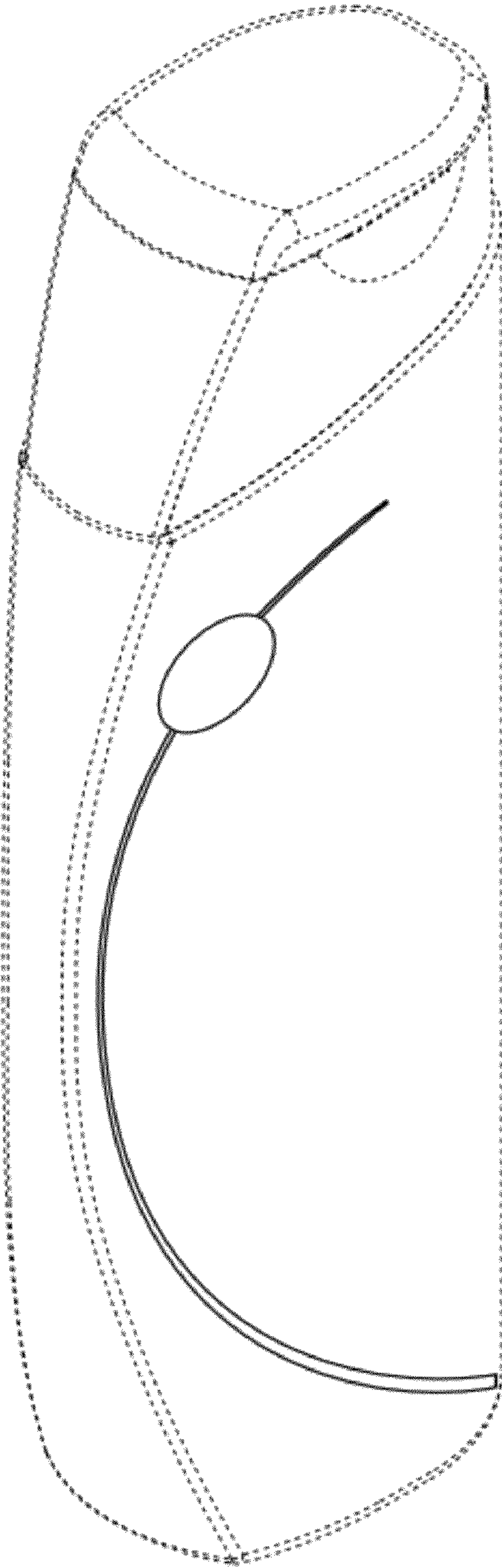

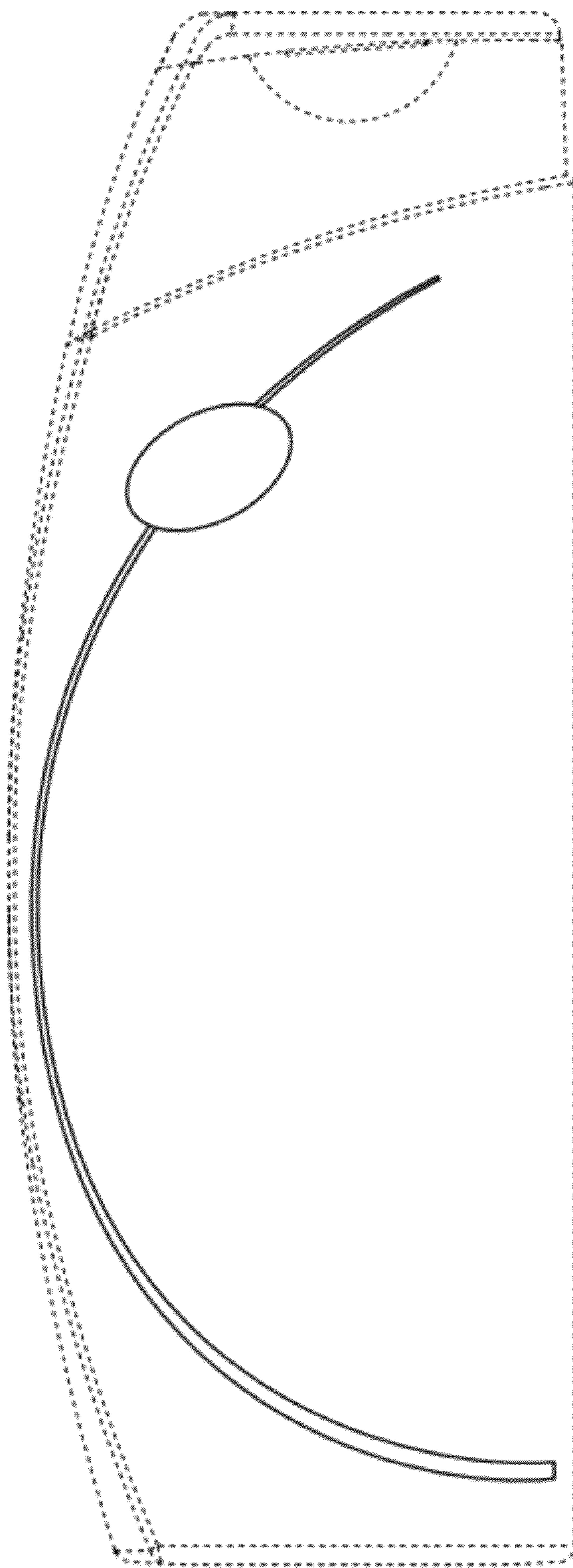

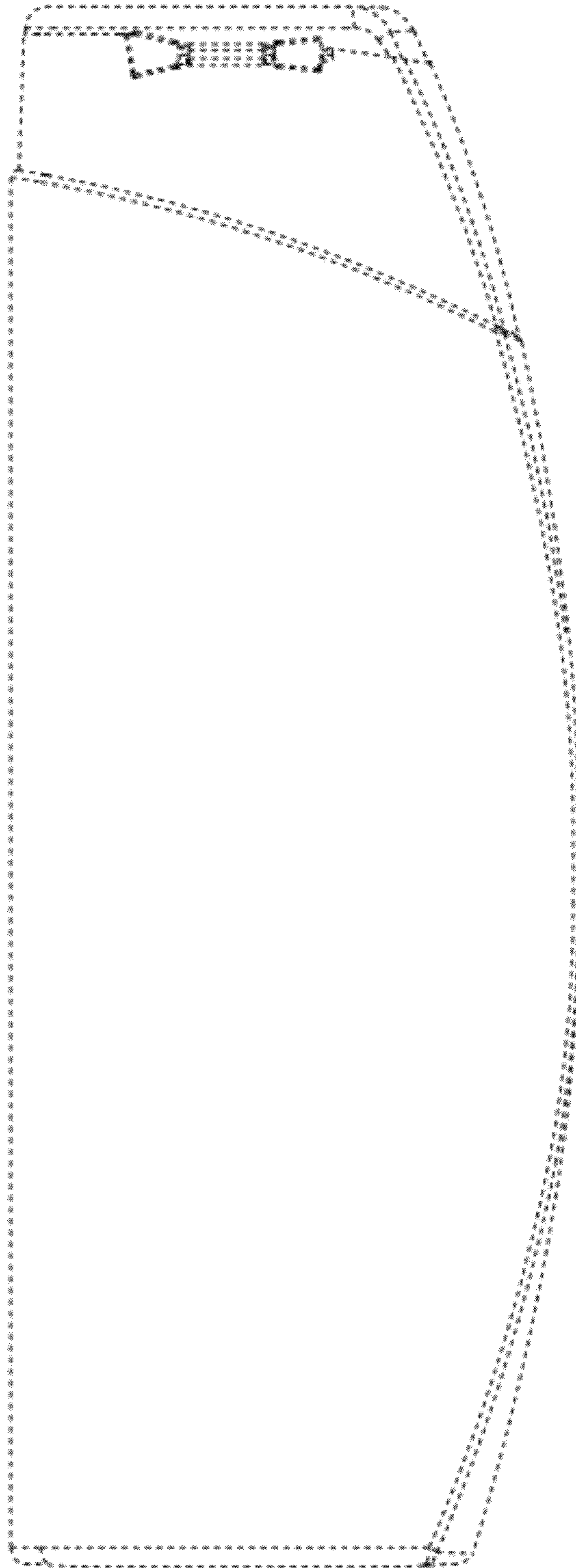

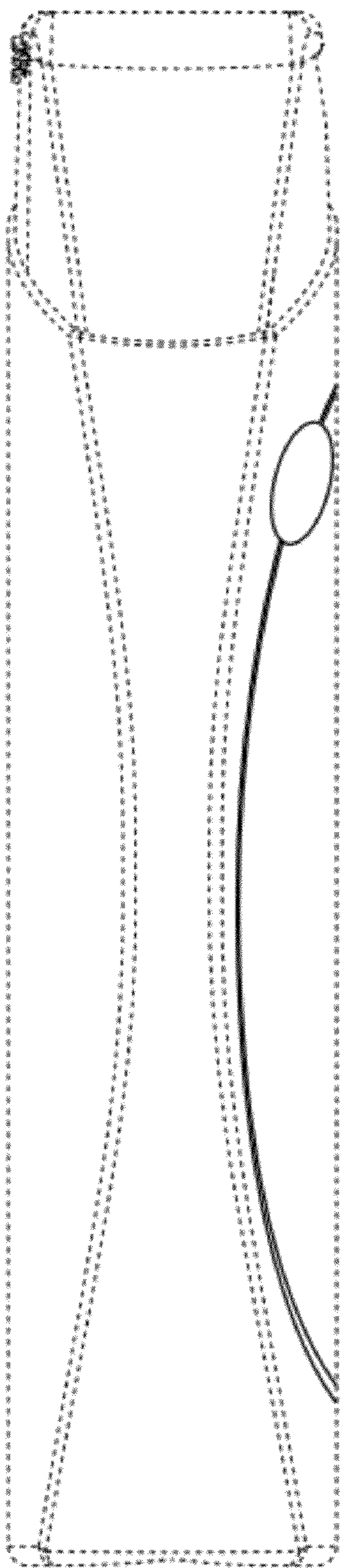

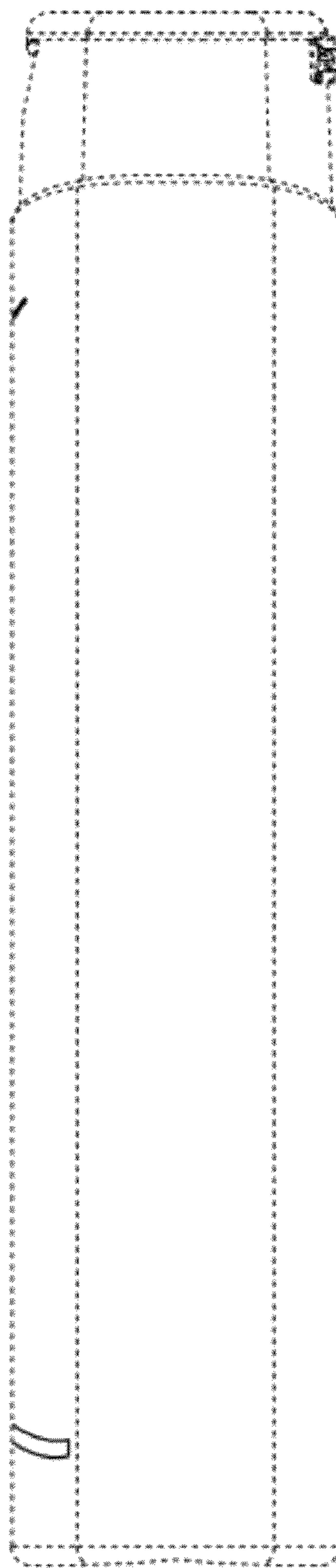

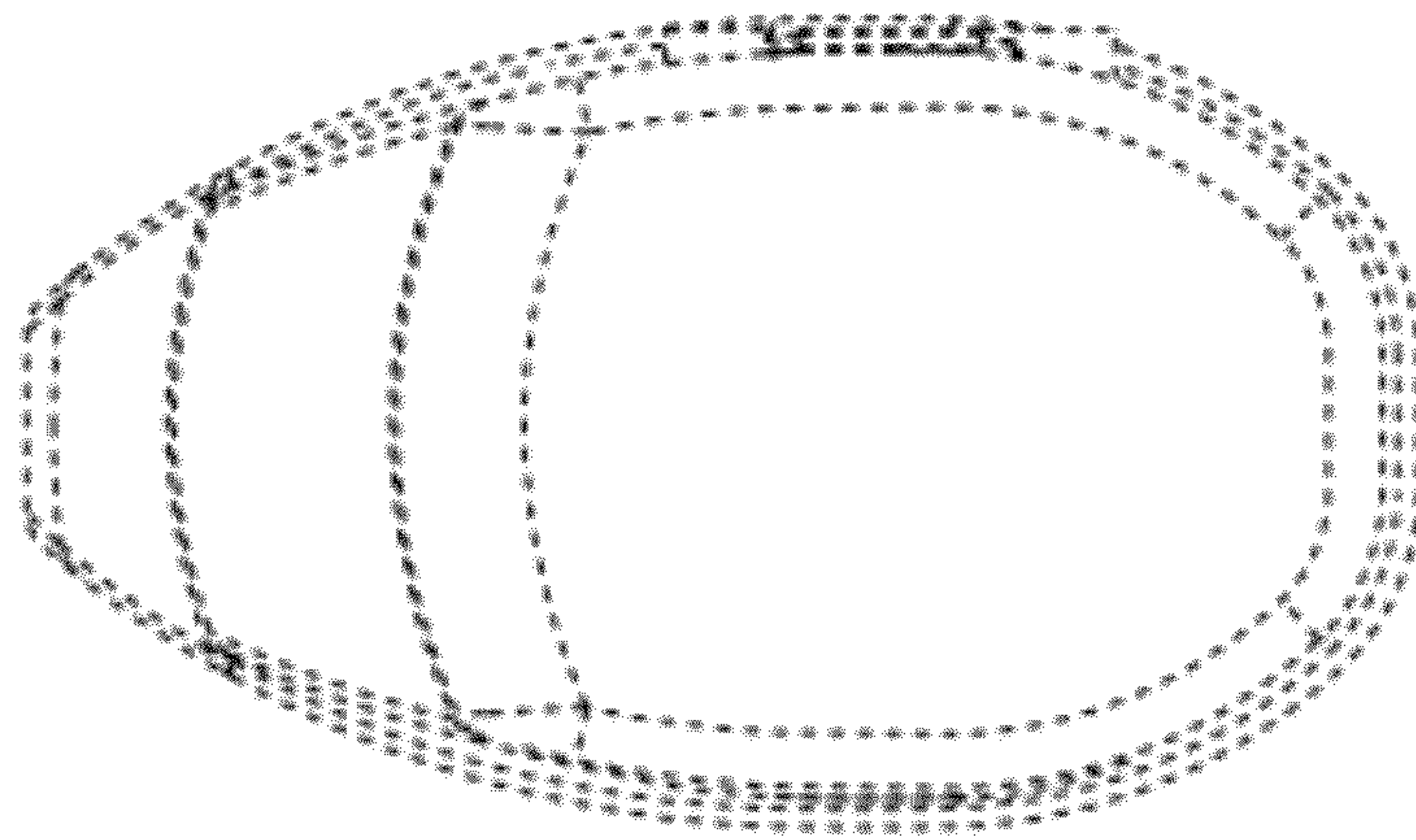

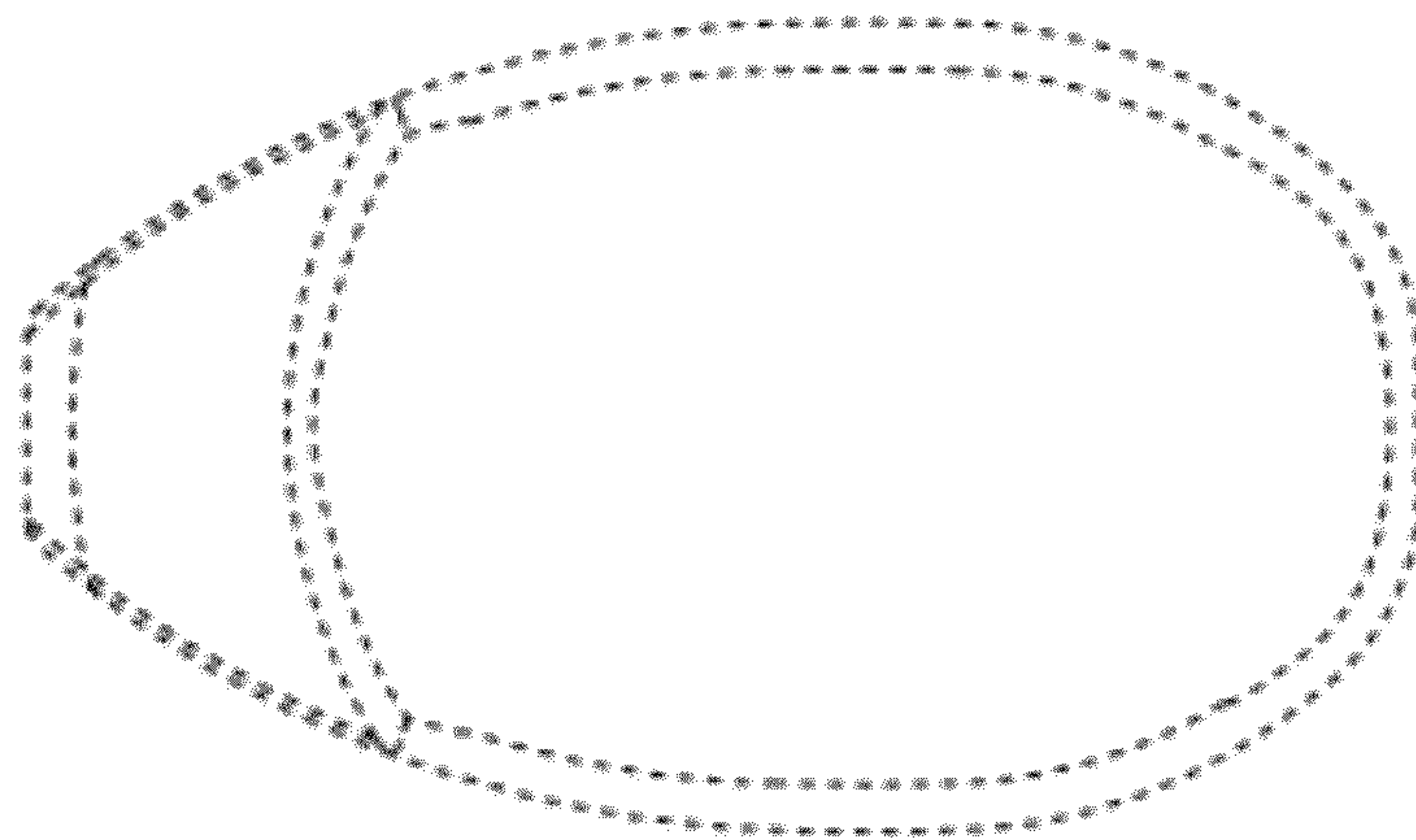
