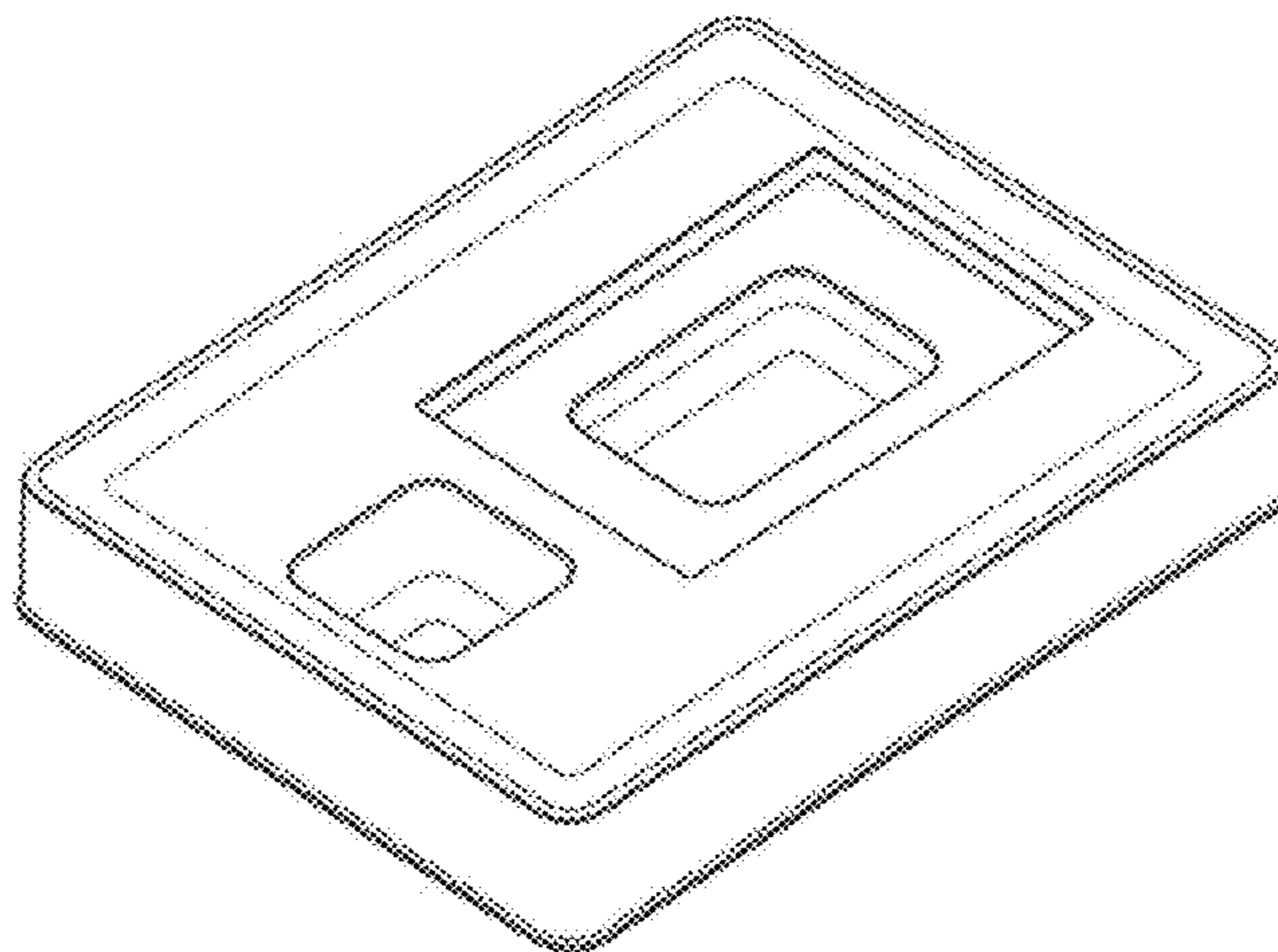
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom front perspective view of packaging showing our new design;
FIG. 2 is another bottom front perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is side view, the opposite side being a mirror image thereof;
FIG. 5 is a top view, the bottom view being a mirror image thereof;
FIG. 6 is a longitudinal cross-sectional view thereof taken along line 6-6 of FIG. 3;
FIG. 7 cross-sectional view thereof taken along line 7-7 of FIG. 3; and,
FIG. 8 cross-sectional view thereof taken along line 8-8 of FIG. 3.

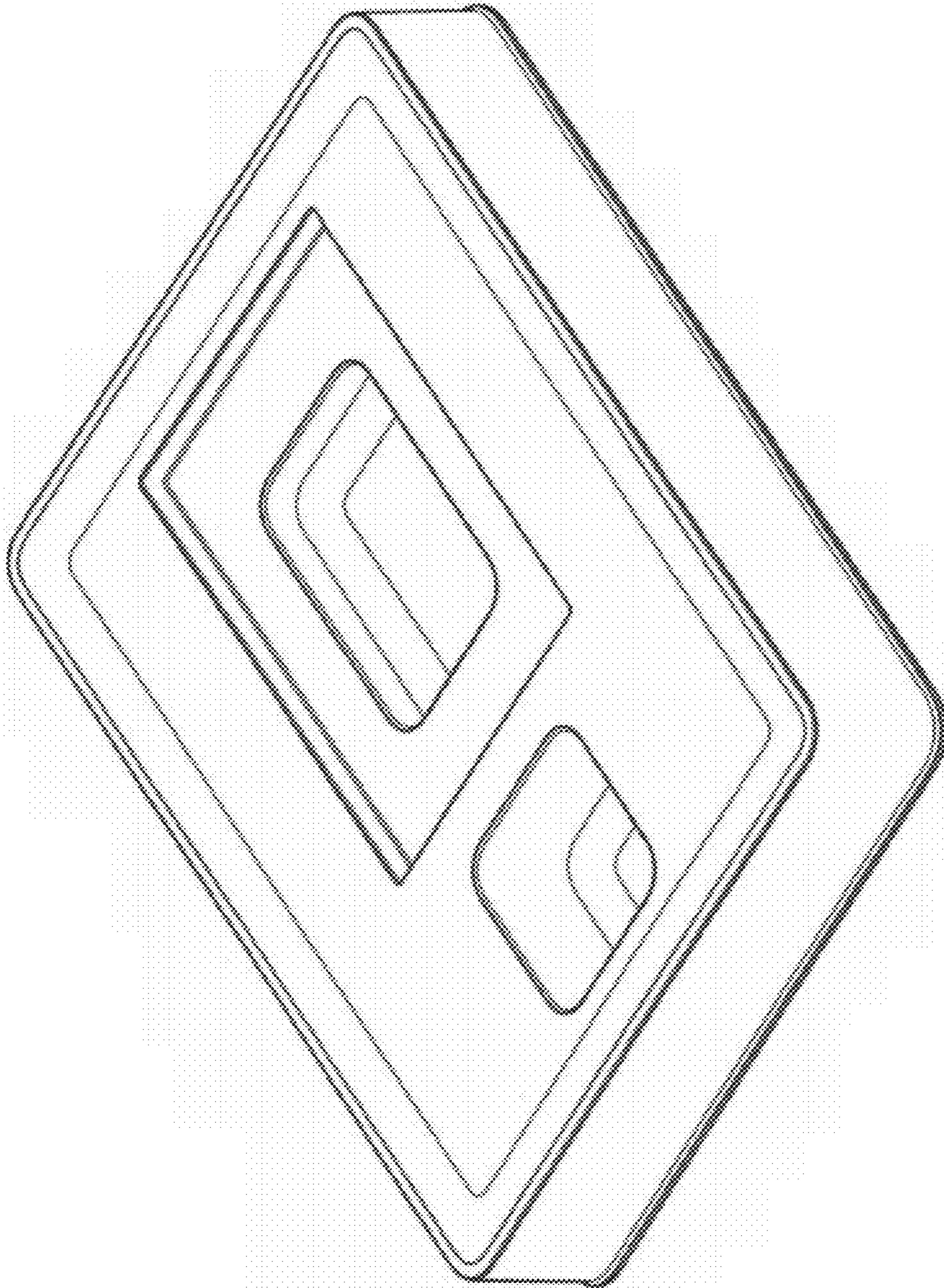

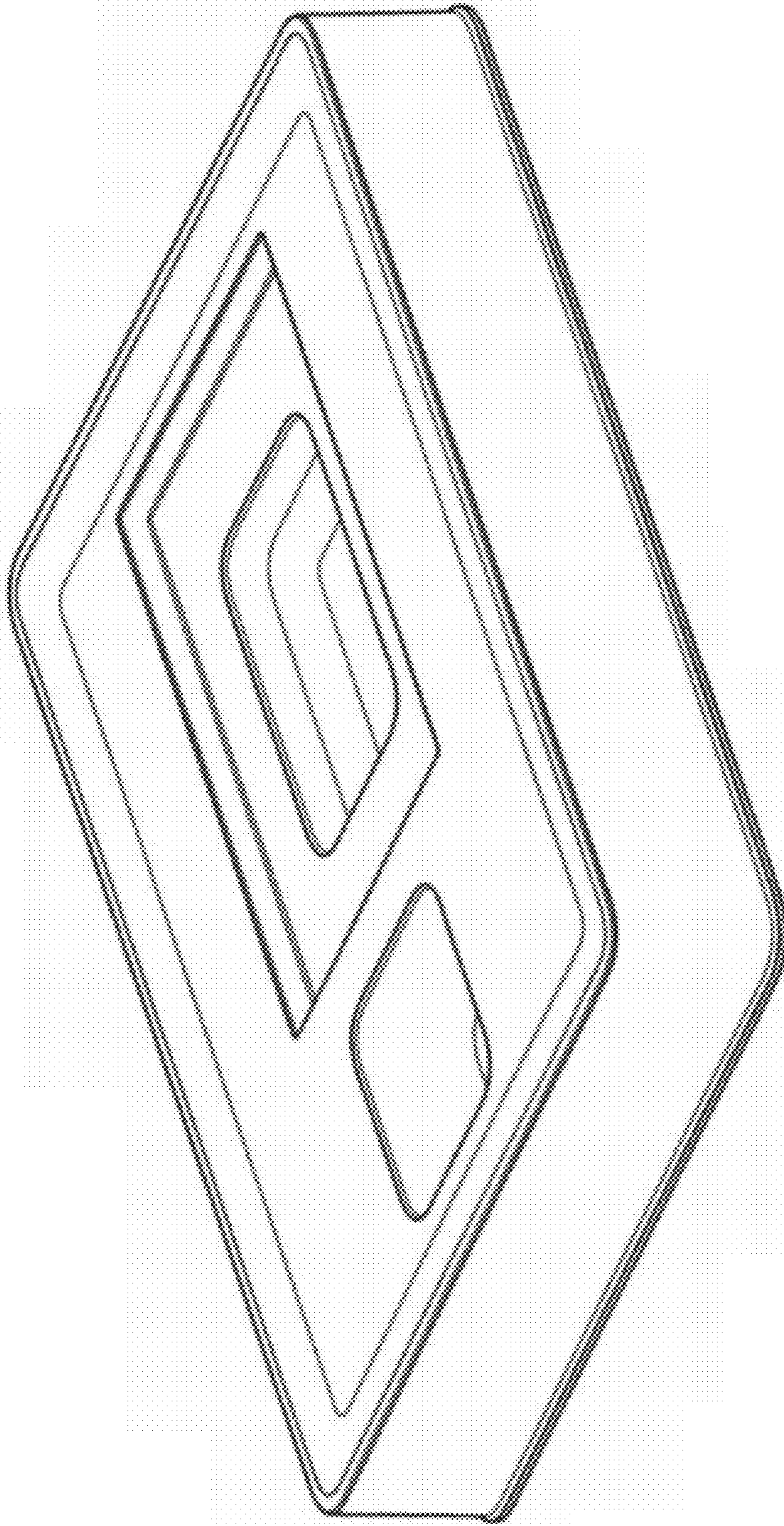

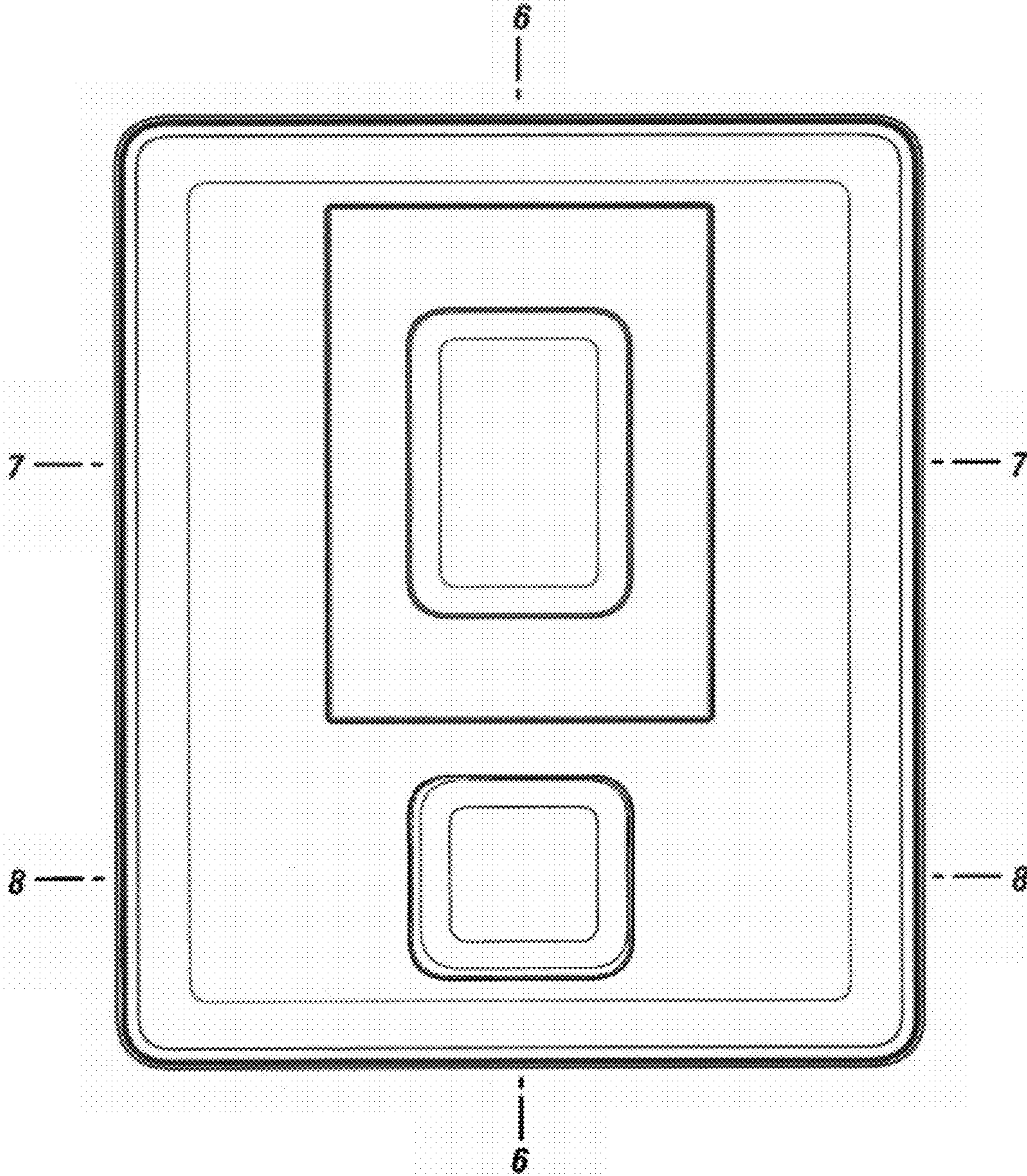

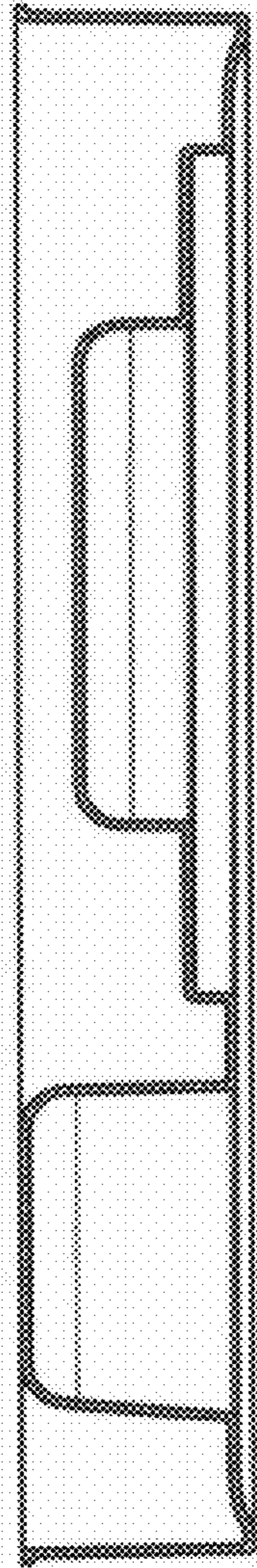

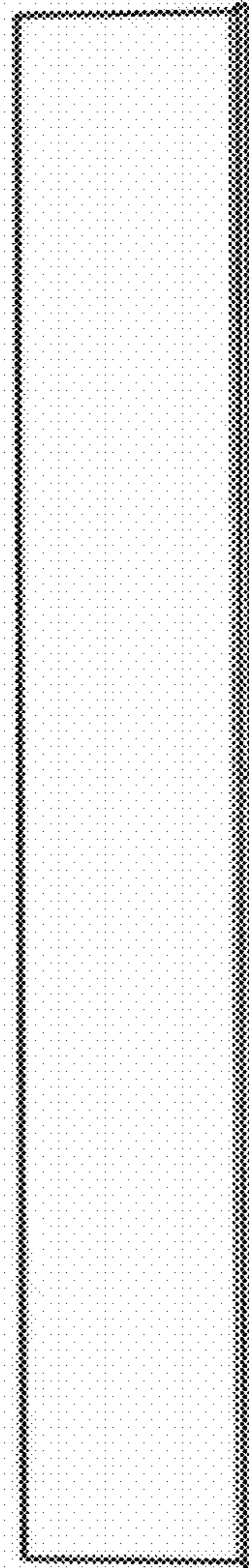

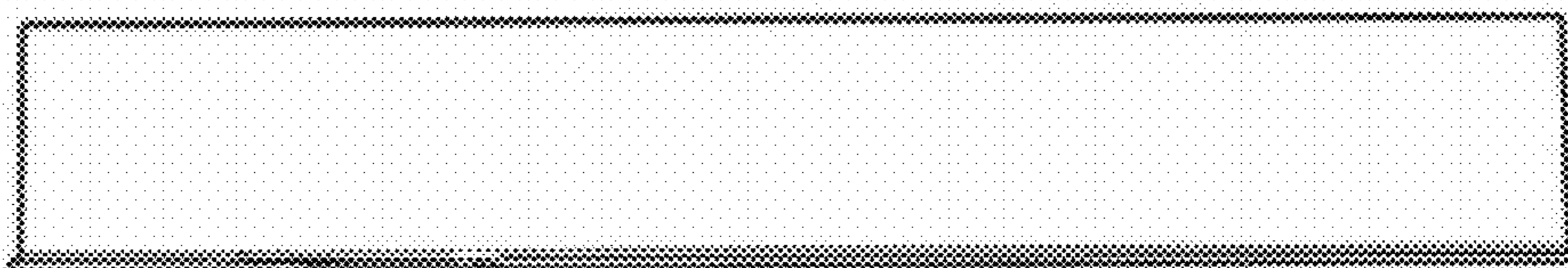

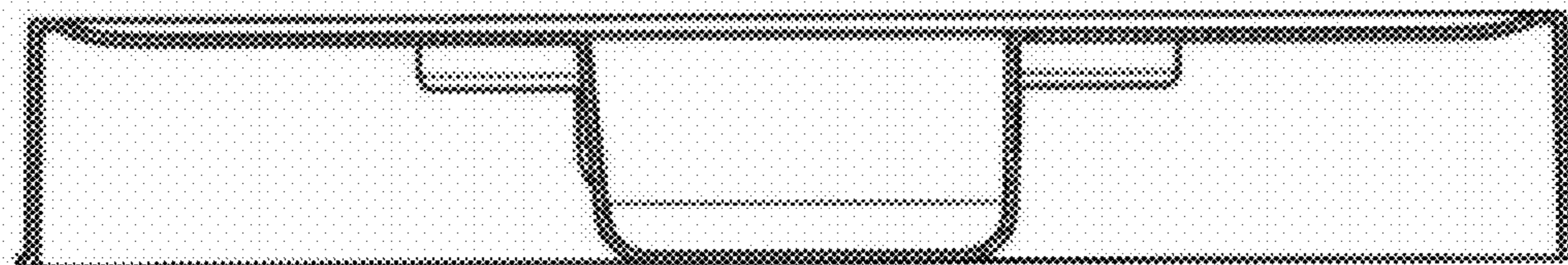
