(57) **CLAIM**

What is claimed is the ornamental design for a turkey gobble call, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view showing the turkey gobble call of Applicant’s invention.

FIG. 2 is a right side perspective view of the turkey gobble call of Applicant’s invention.

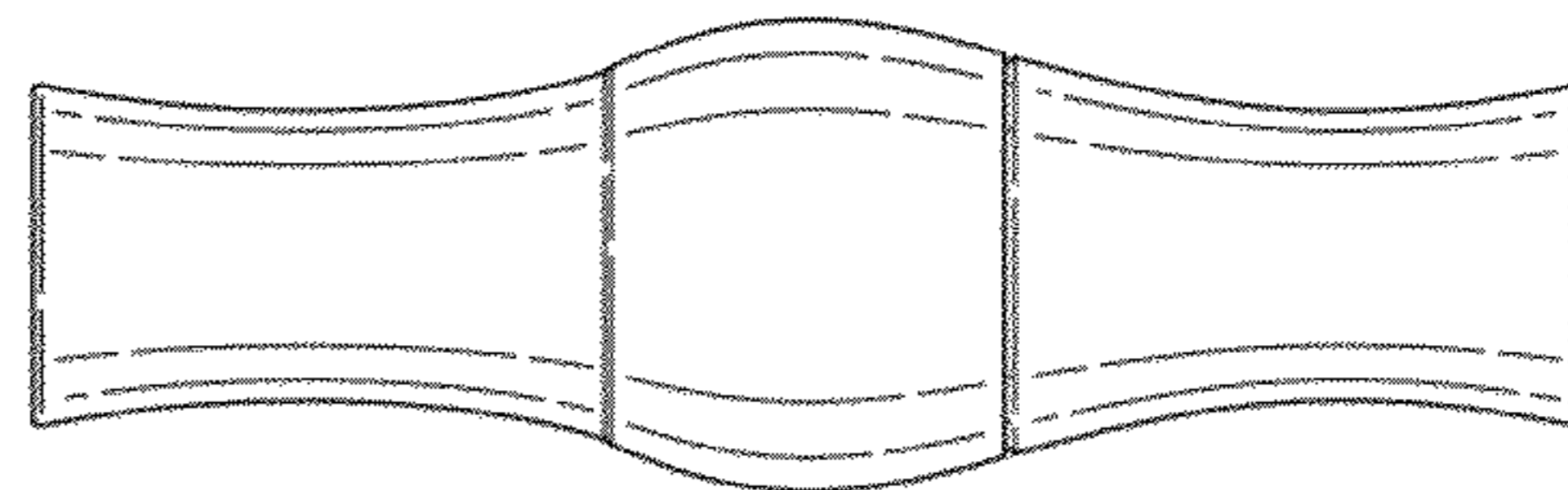
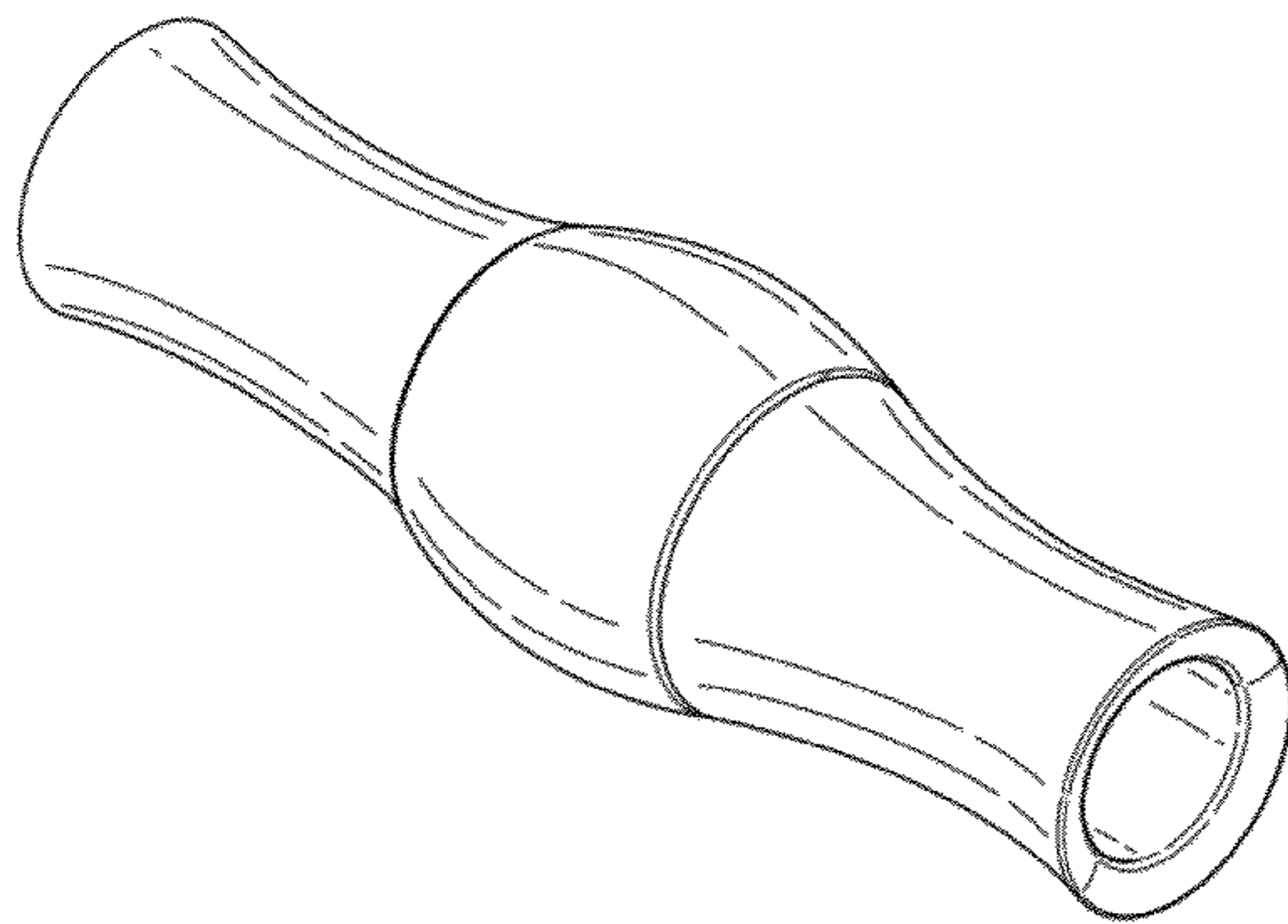
FIG. 3 is a right side elevation view of the turkey gobble call of Applicant’s invention, both sides being identical.

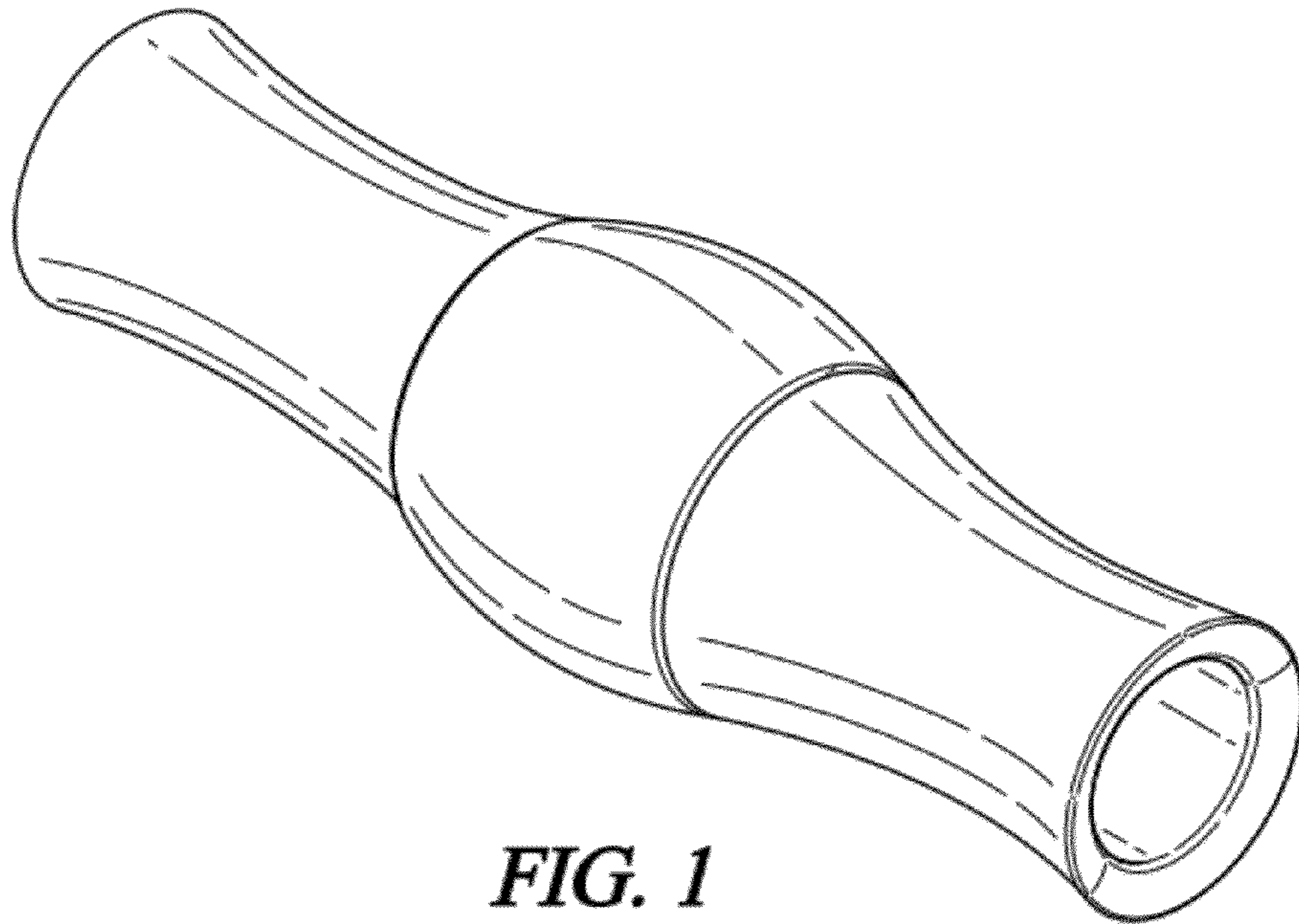

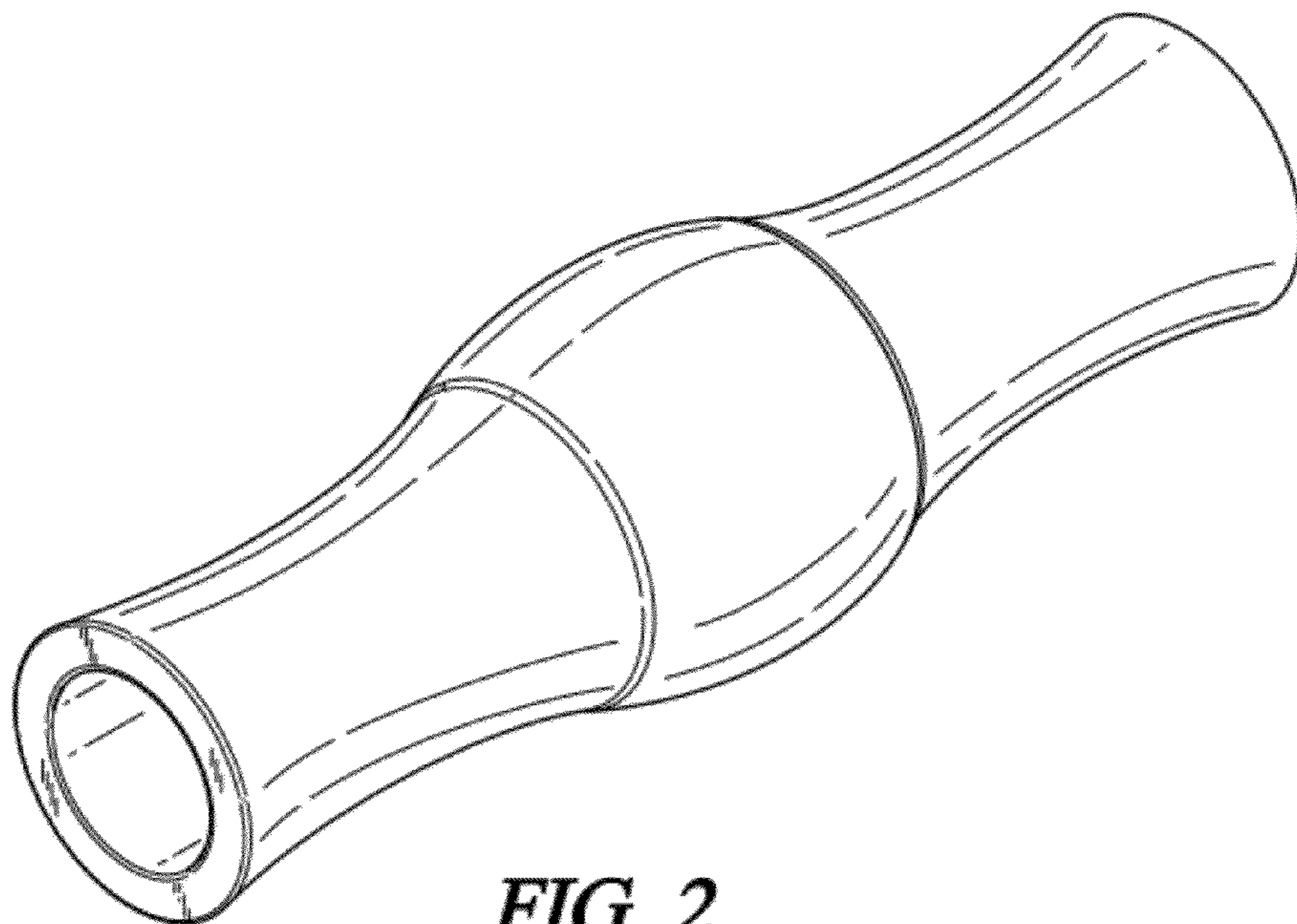

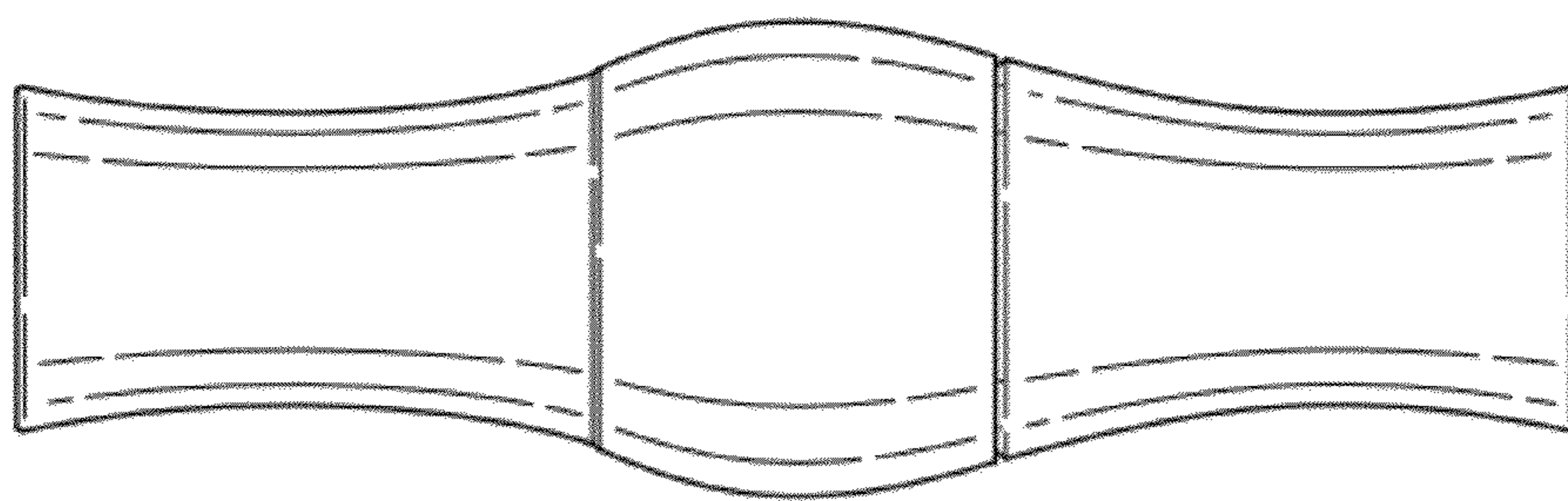

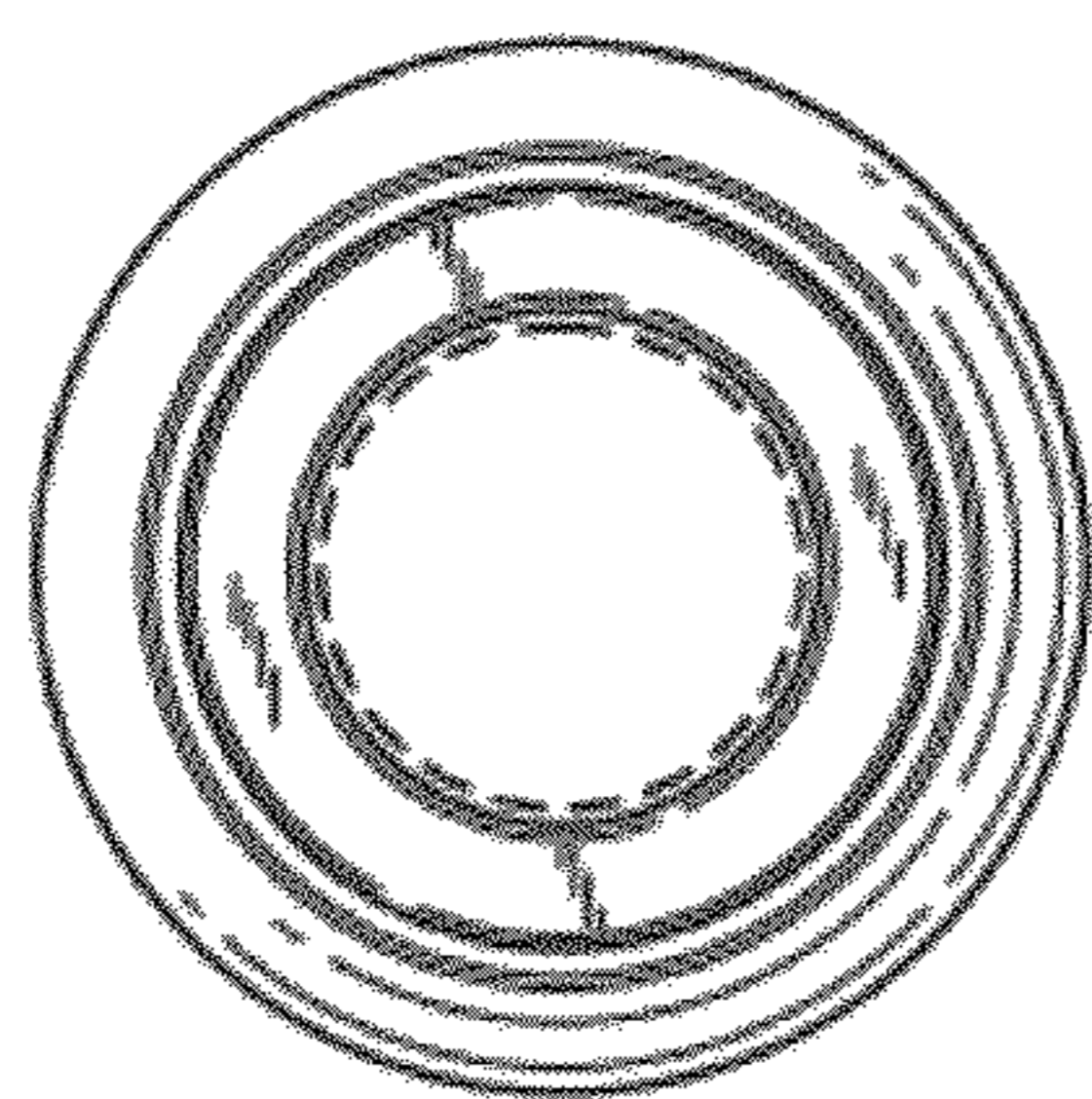

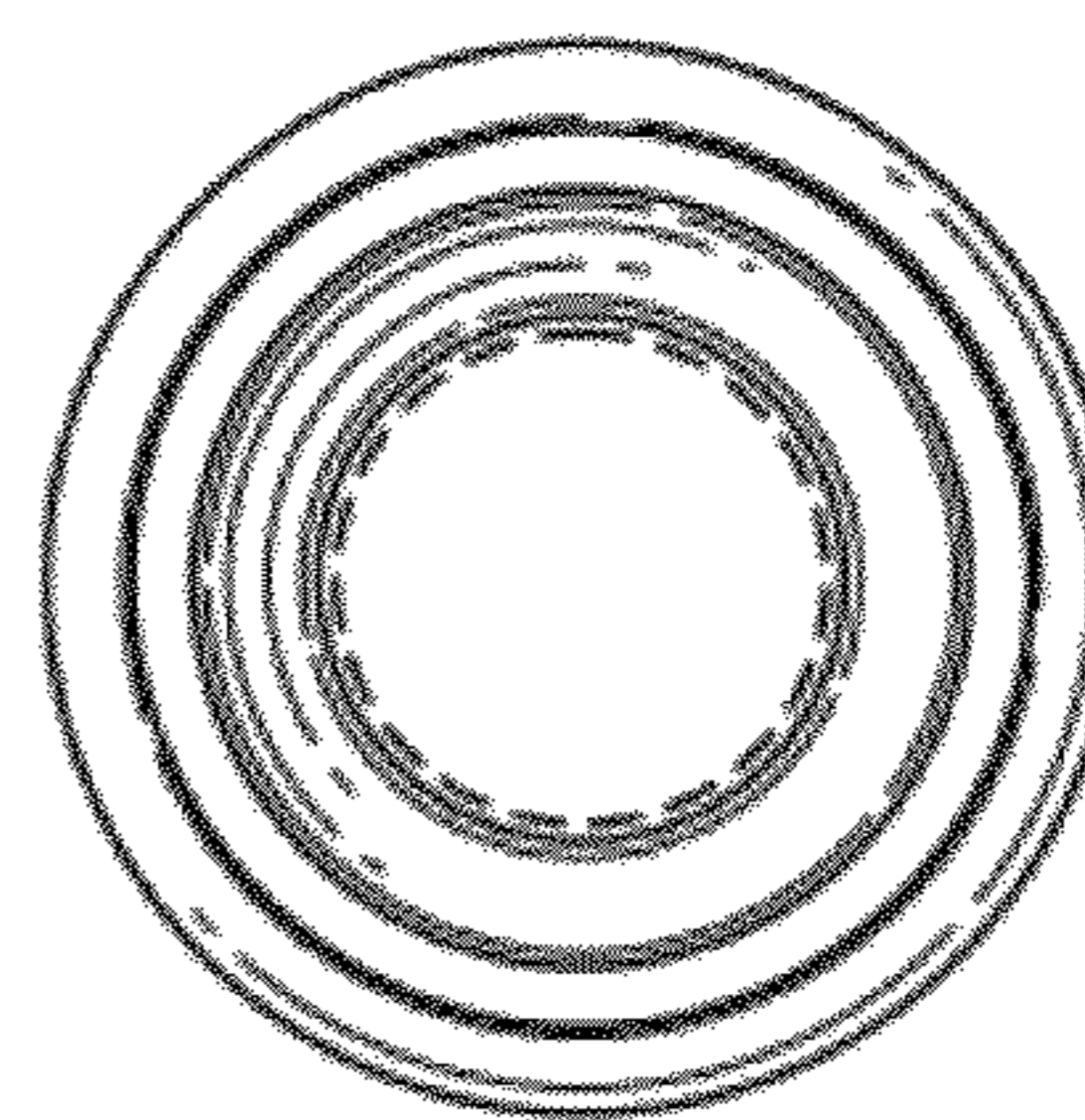
