**DESCRIPTION**

FIG. 1 is a right, front perspective view of an all terrain vehicle showing my new design;

FIG. 2 is a right, rear perspective view thereof;

FIG. 3 is a right side elevation view thereof;

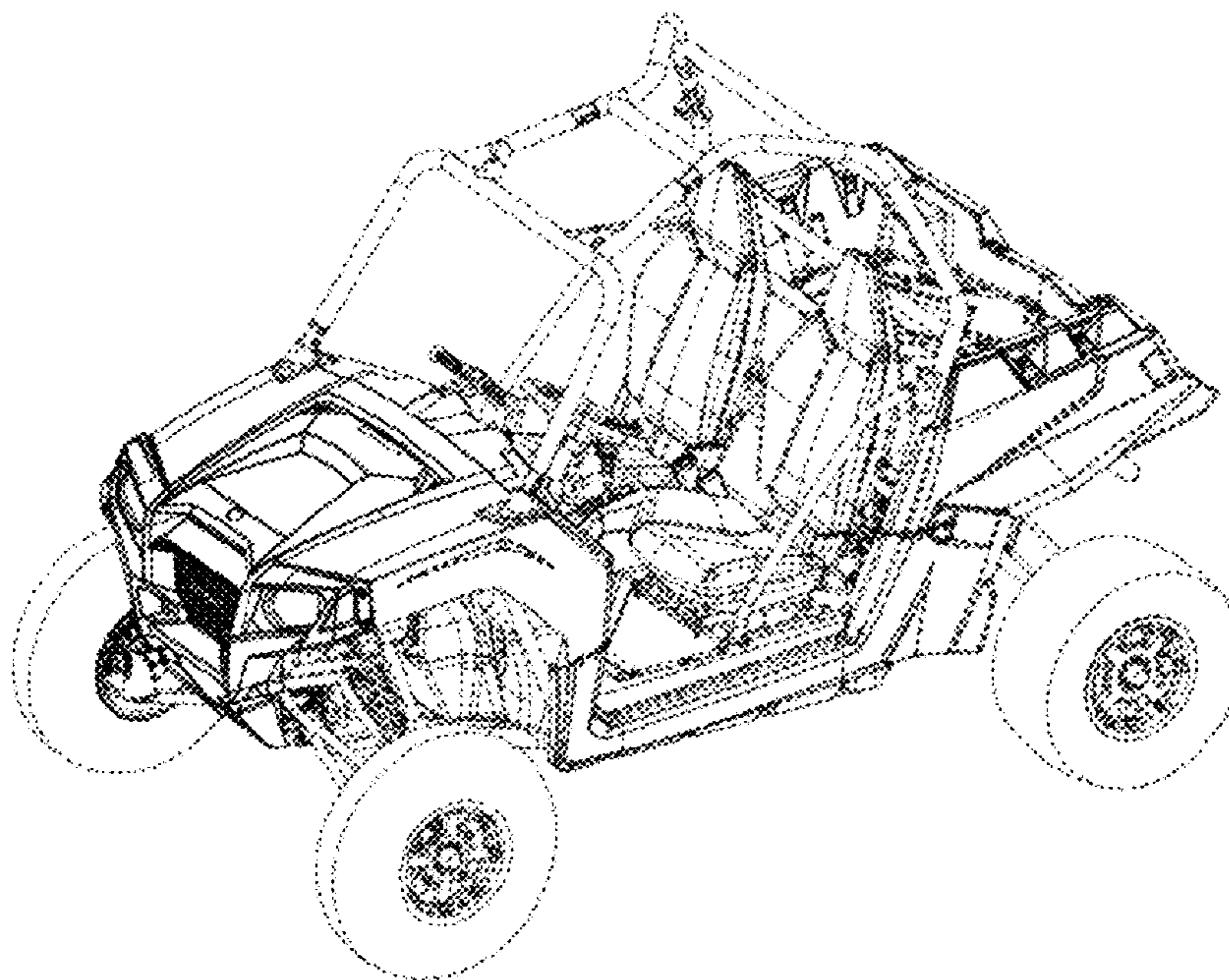
FIG. 4 is a left-hand side elevation view thereof;

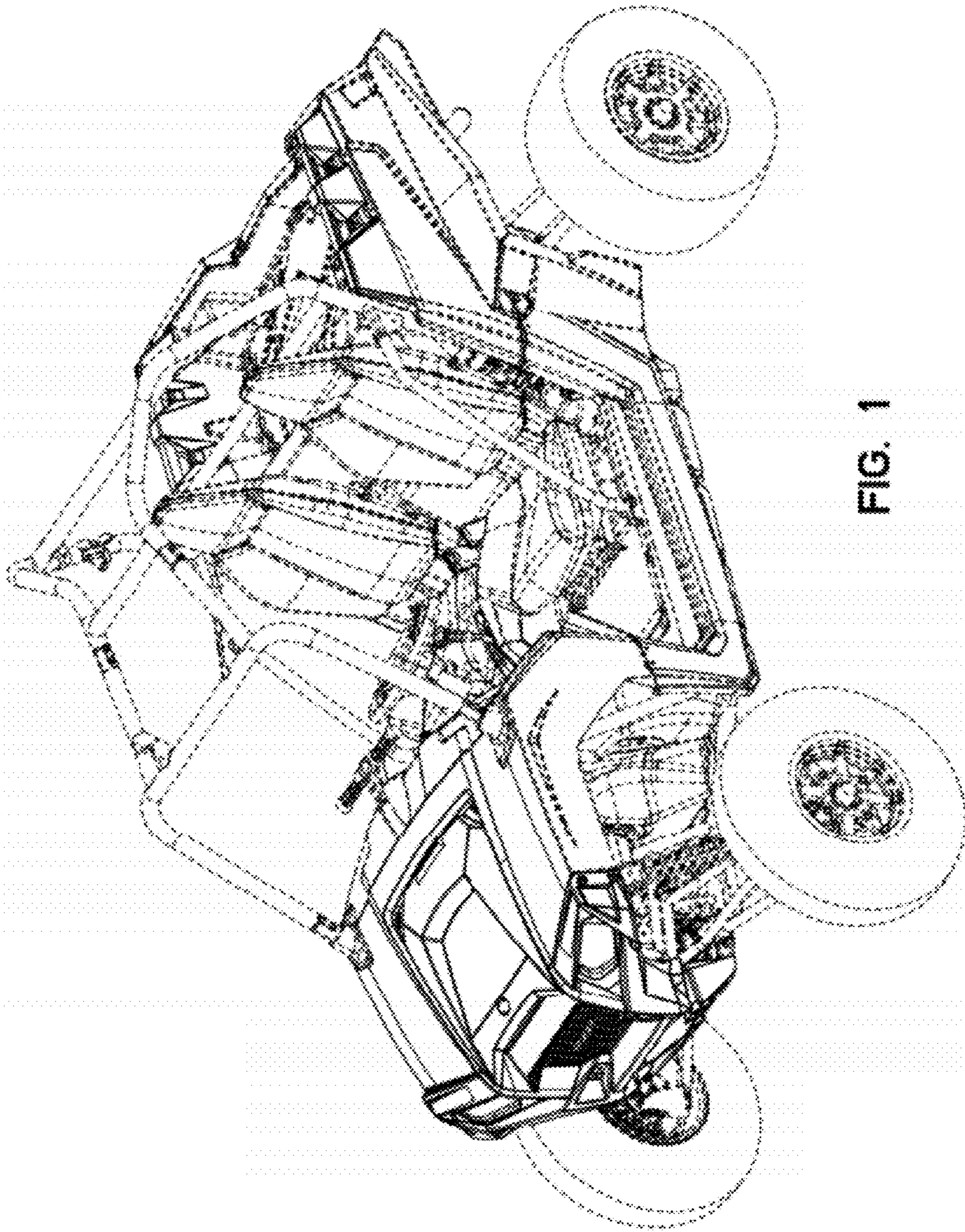

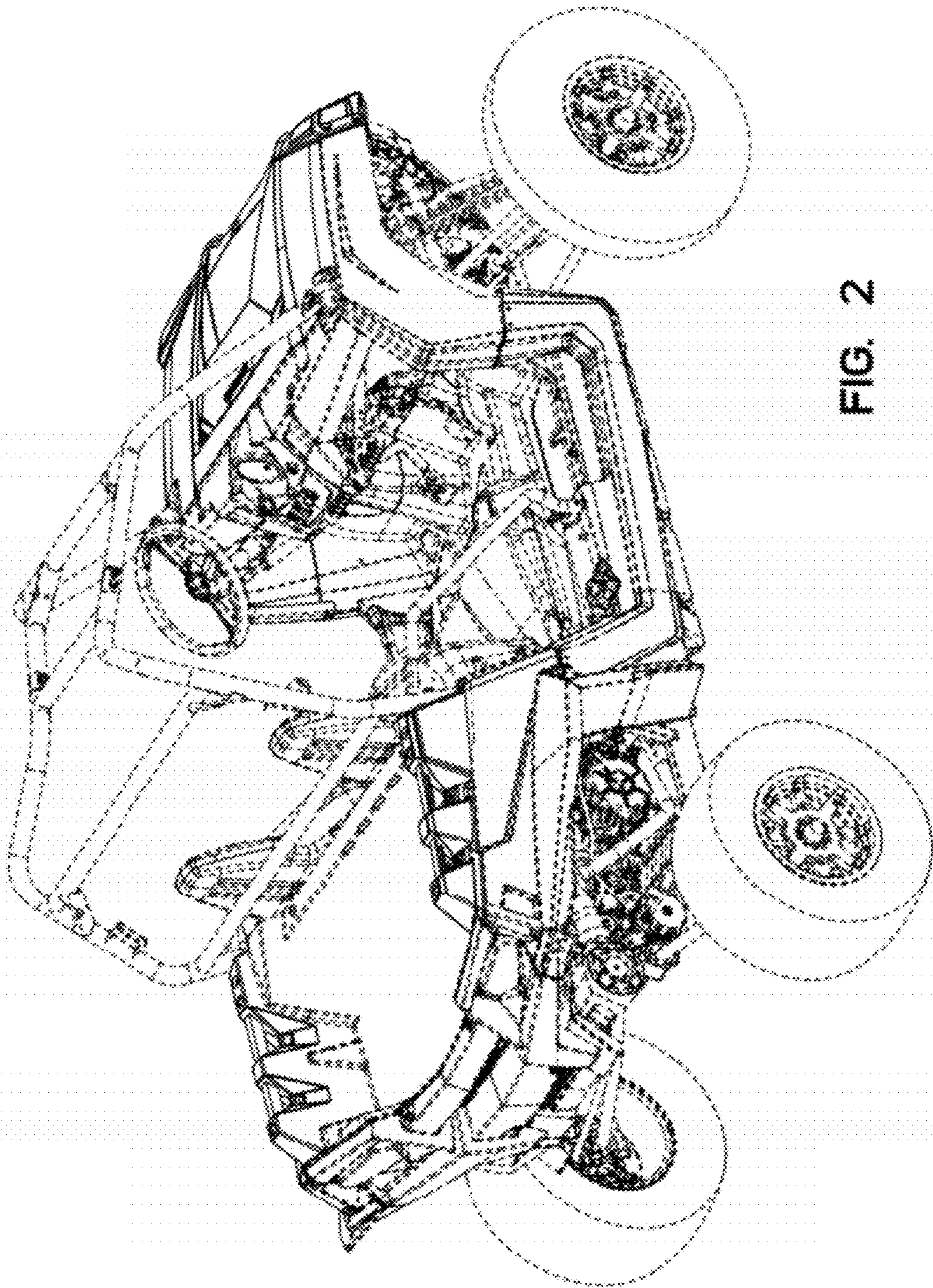

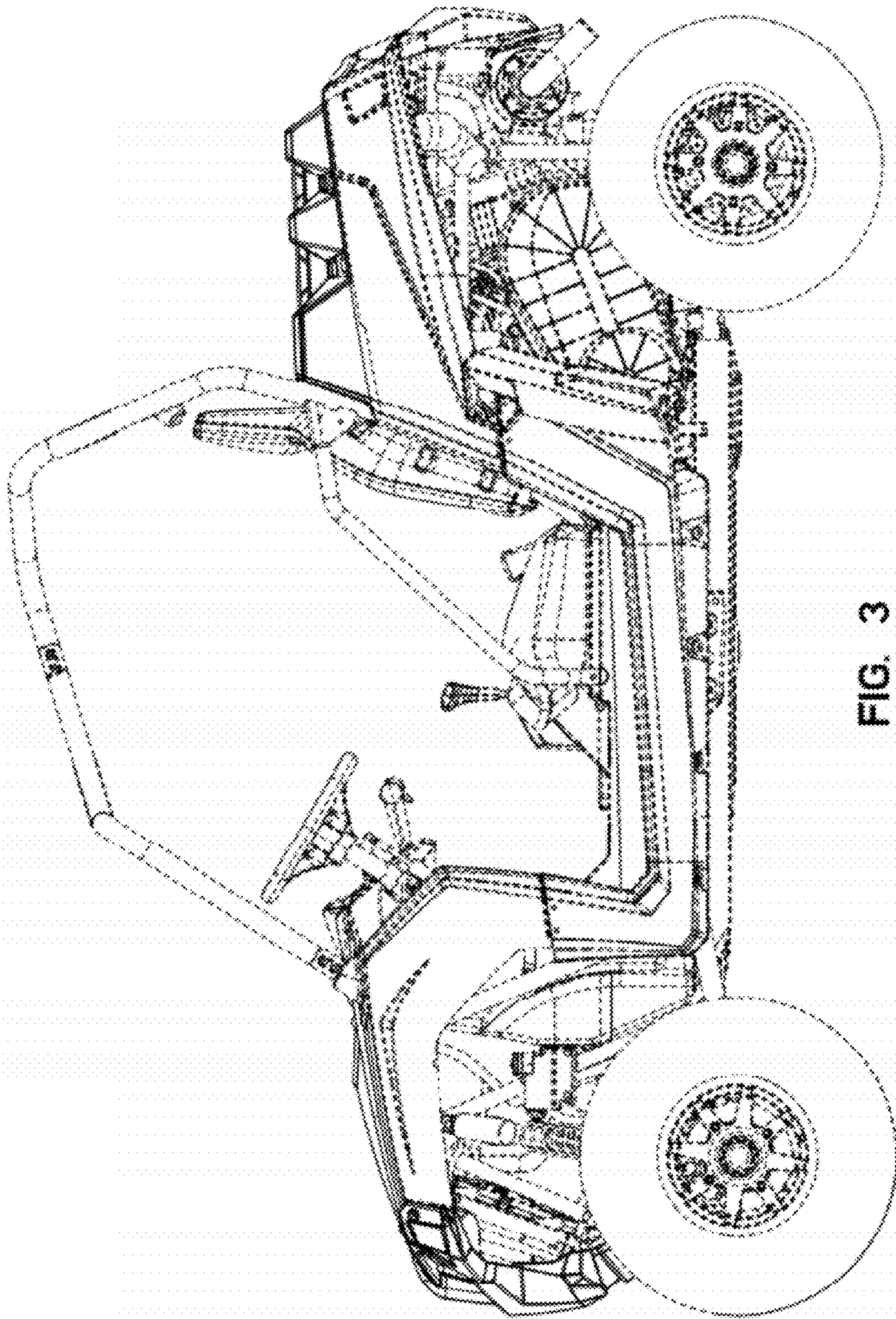

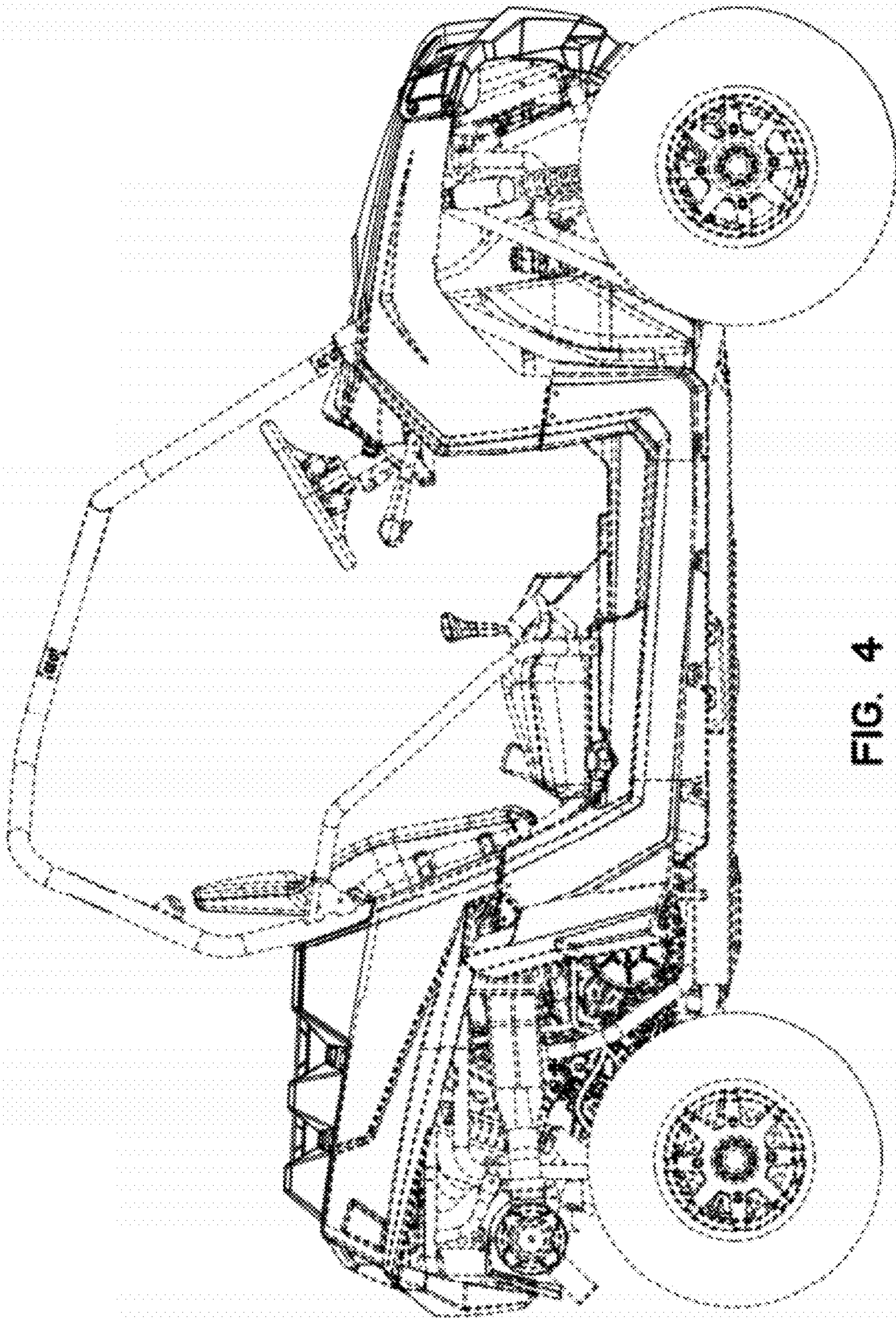

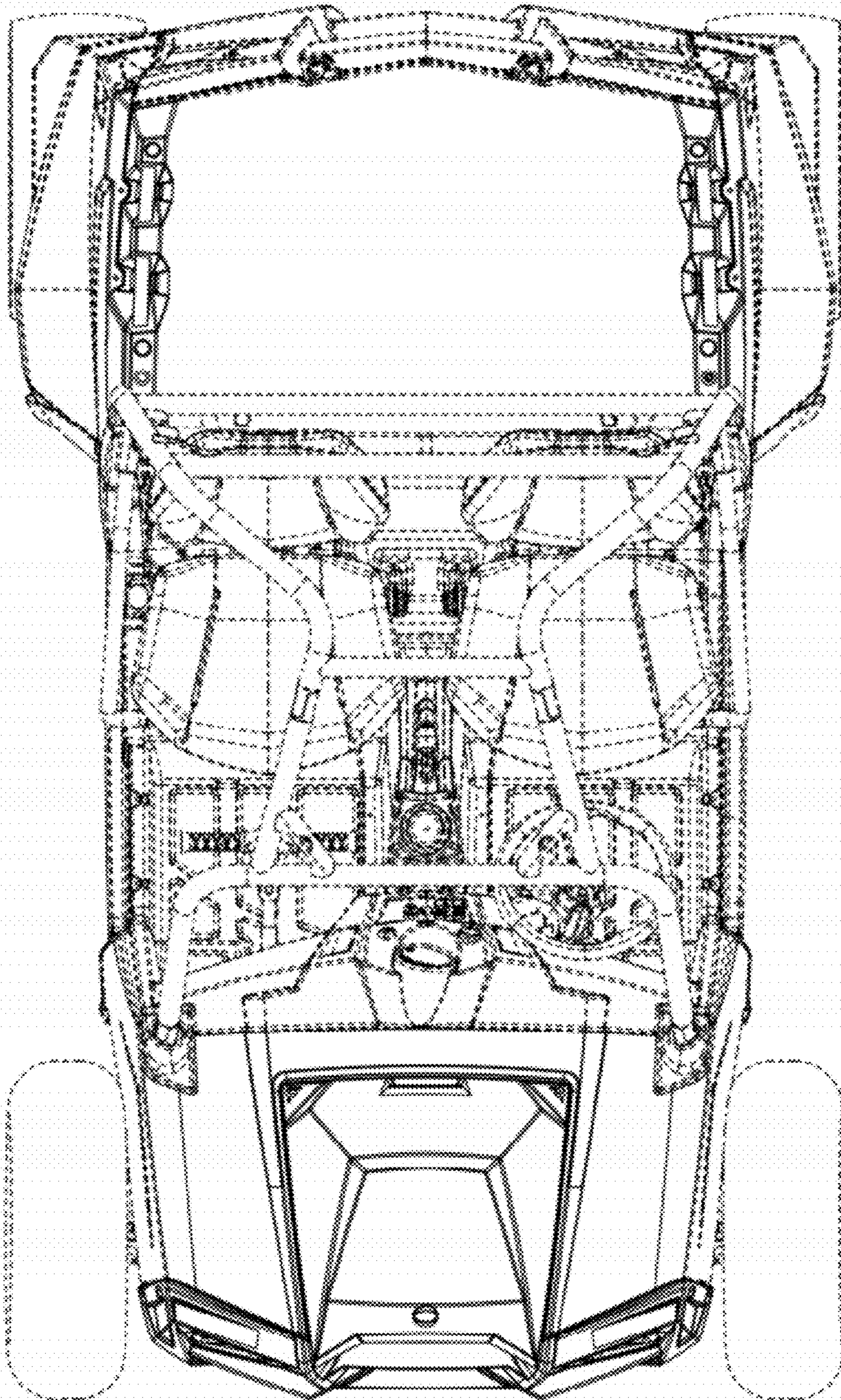

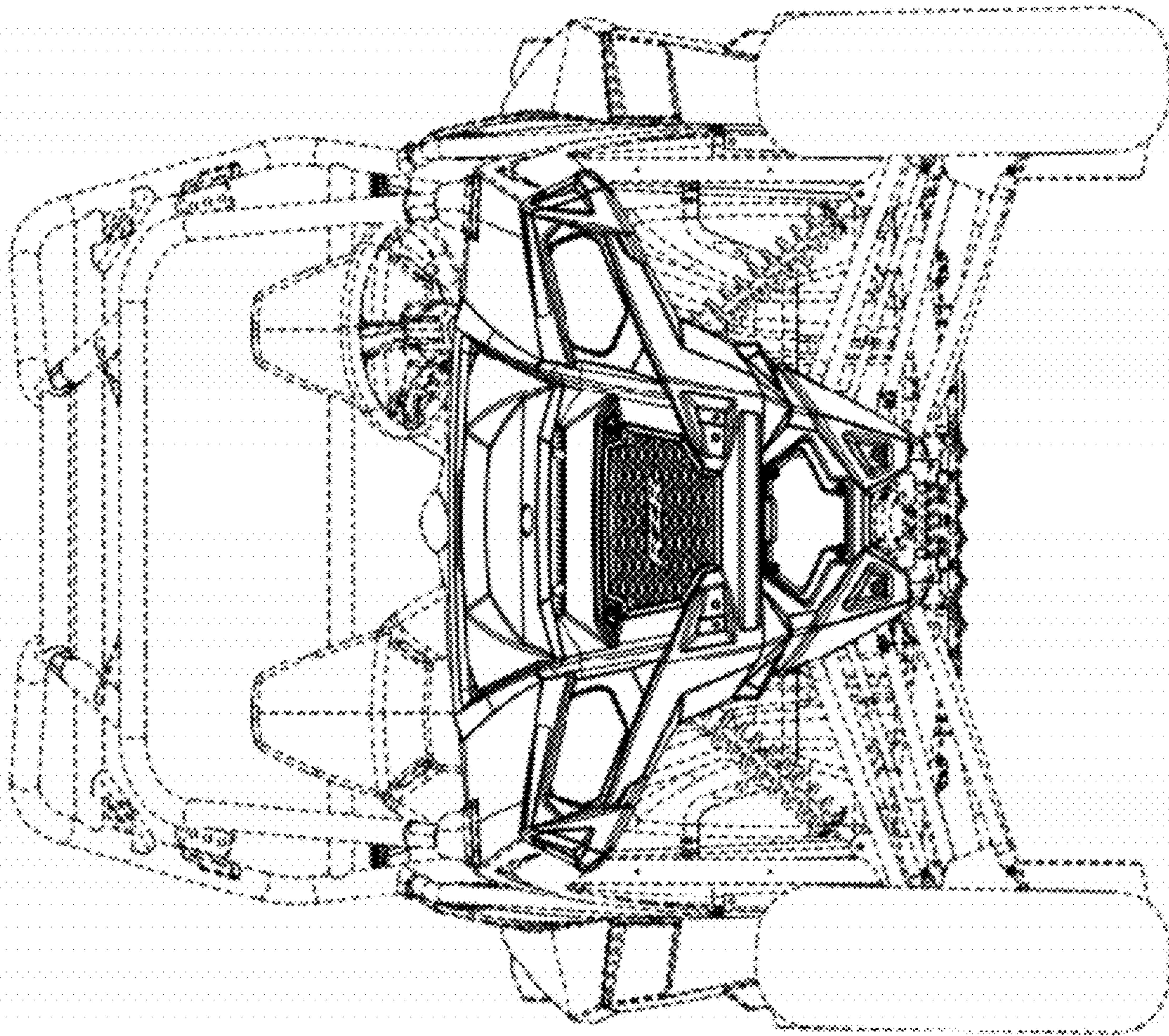
