DESCRIPTION

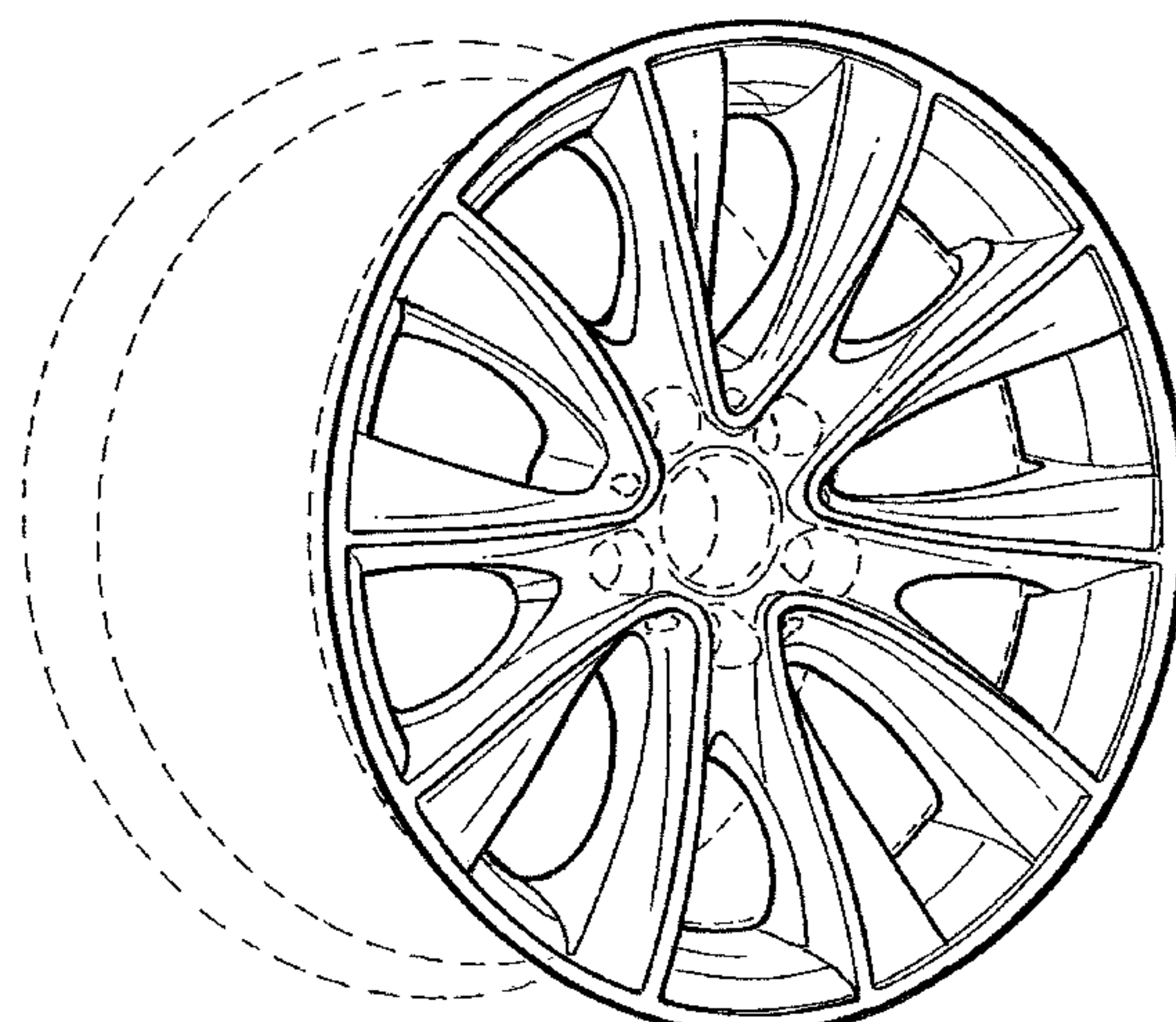
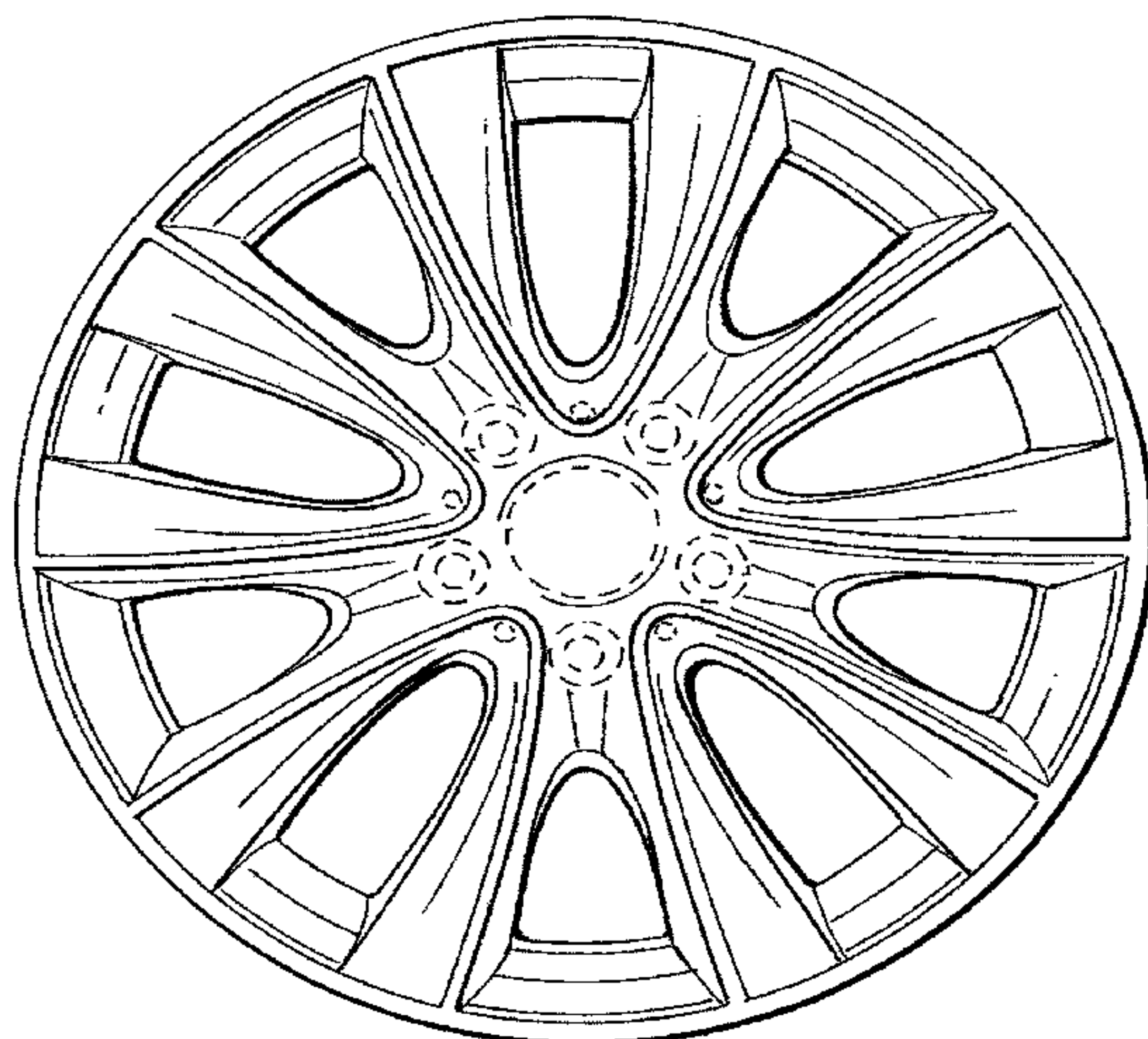

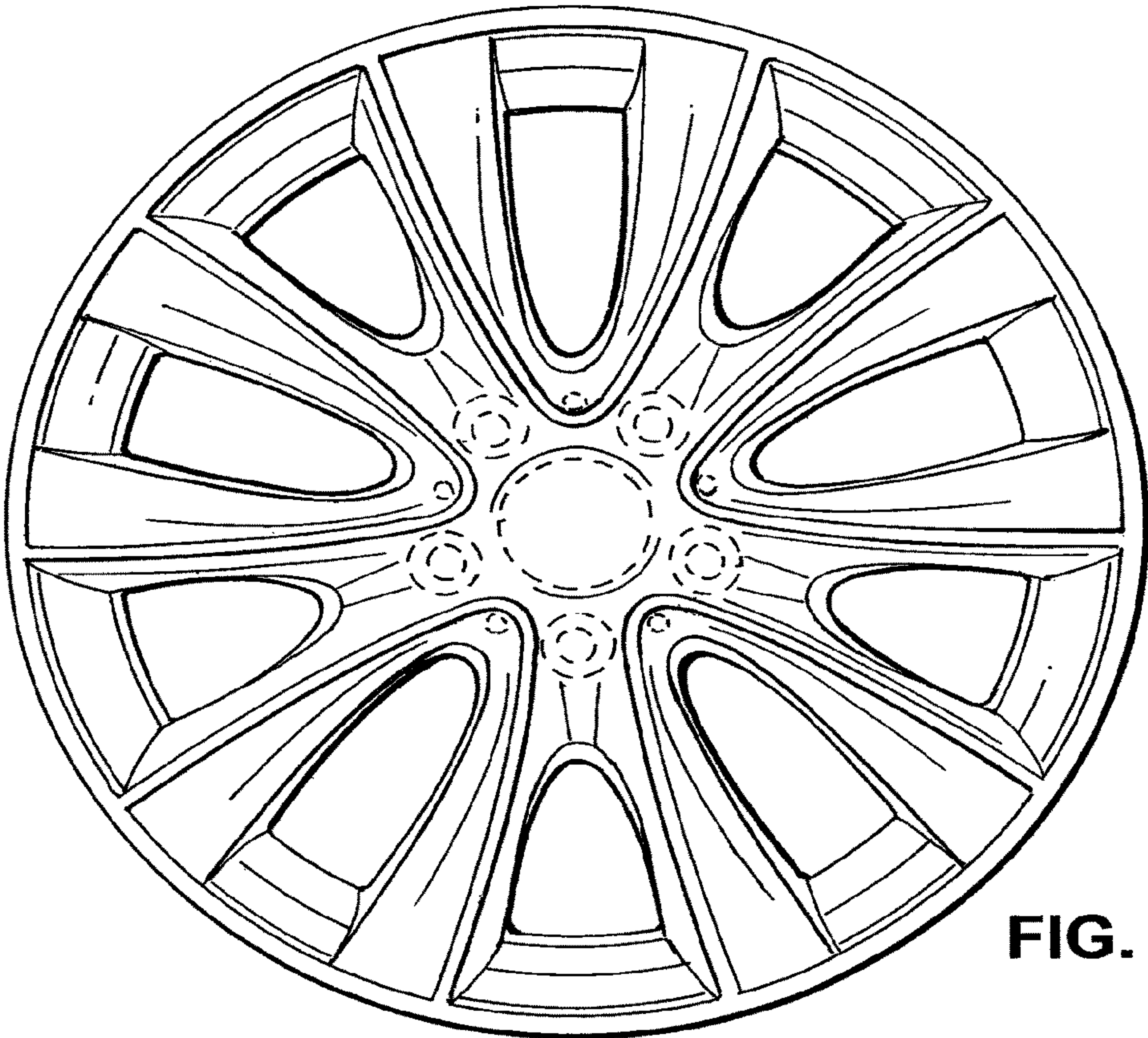

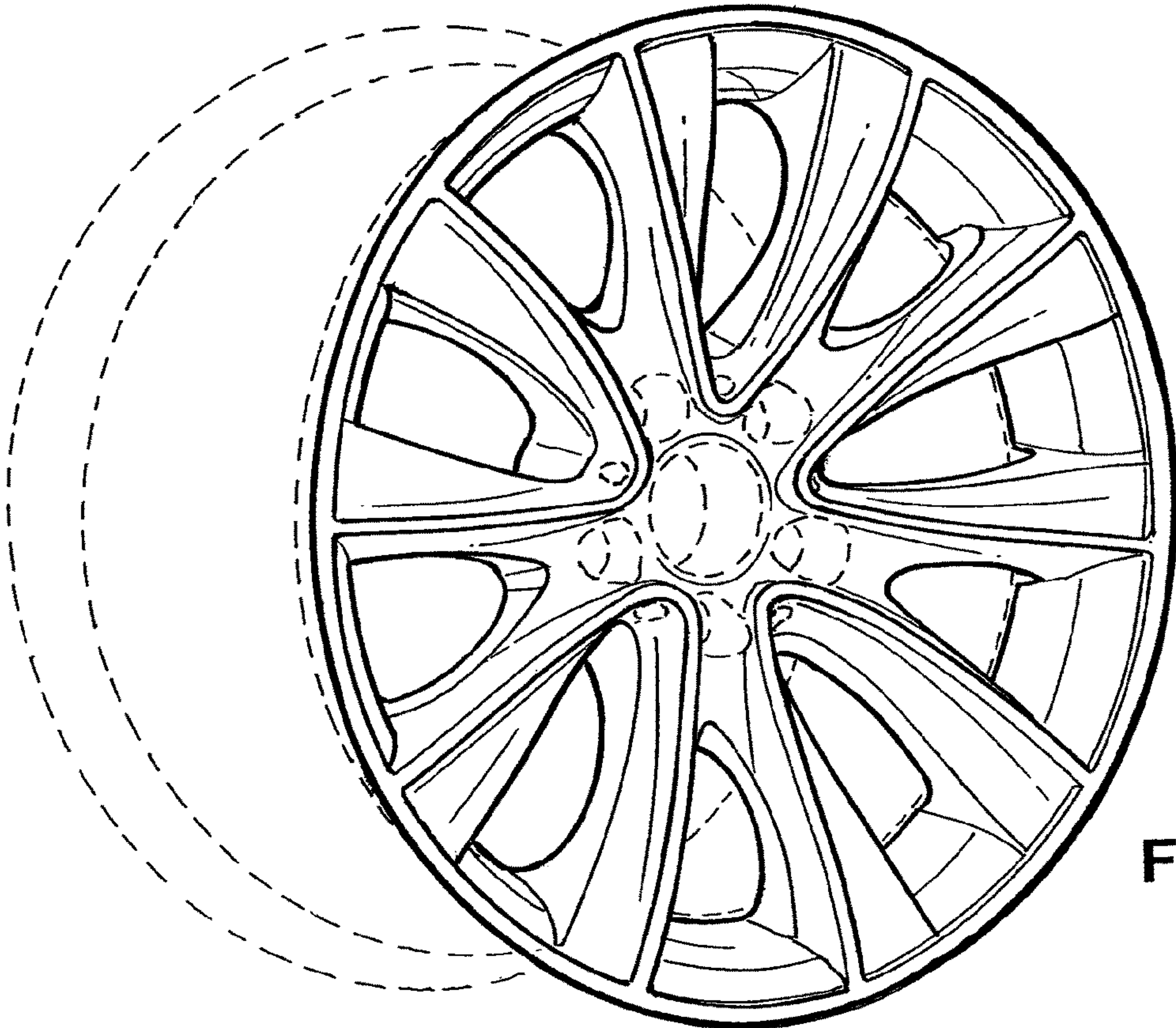
