(57) **CLAIM**

The ornamental design for a charger stand for electric vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left, and top perspective view of a charger stand for electric vehicle;  
 FIG. 2 is a rear, right, and bottom perspective view thereof;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is a rear view thereof;  
 FIG. 5 is a top view thereof;  
 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a right view thereof;  
 FIG. 8 is a left view thereof;  
 FIG. 9 is a cross-sectional view along line 9-9 from FIG. 3 that omits internal mechanisms; and,  
 FIG. 10 is a cross-sectional view along line 10-10 from FIG. 7 that omits the power cord and internal mechanisms.  
 The broken lines shown in FIGS. 9 and 10 are included for the purpose of illustrating environmental structure and form no part of the claimed design.

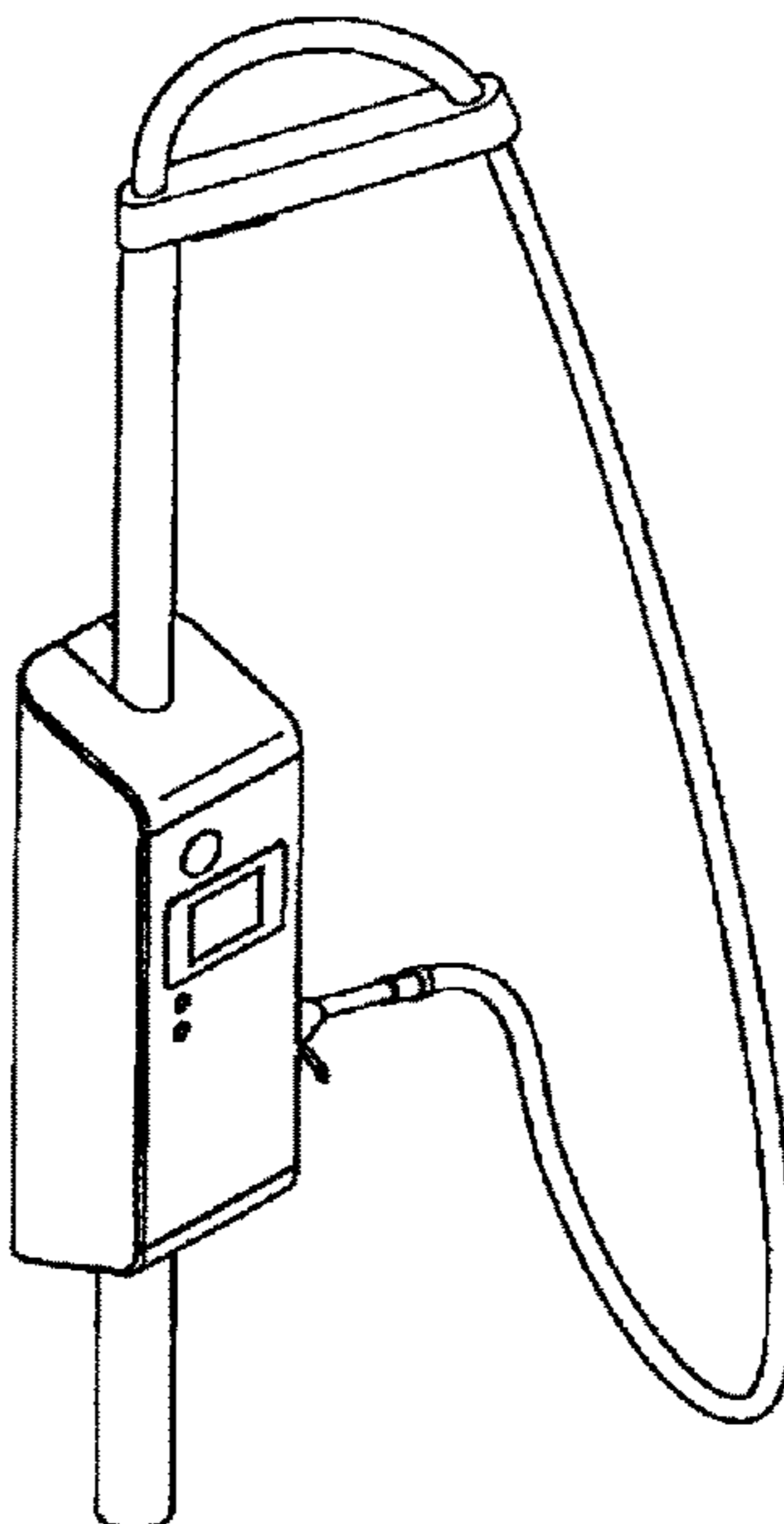

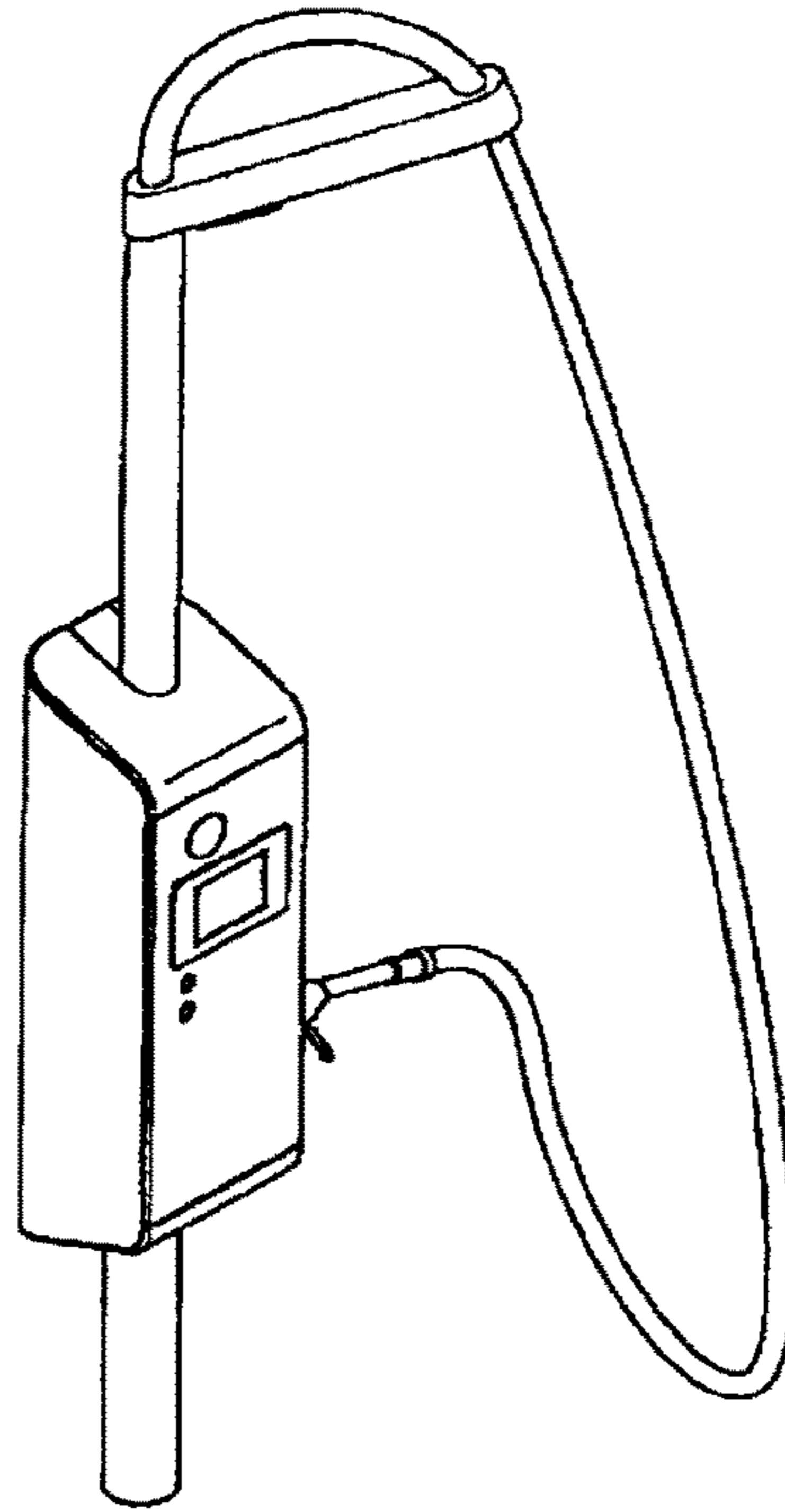

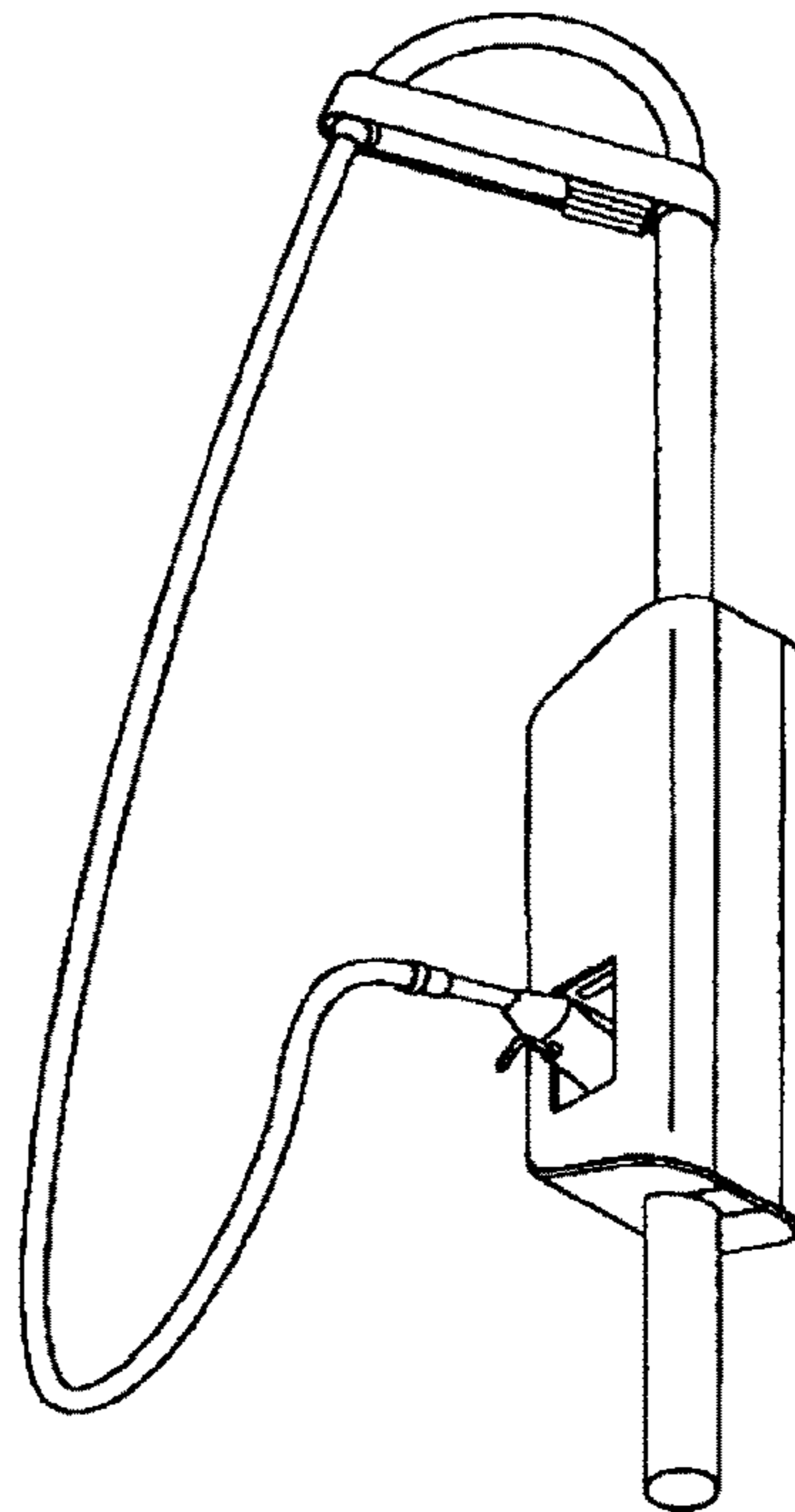

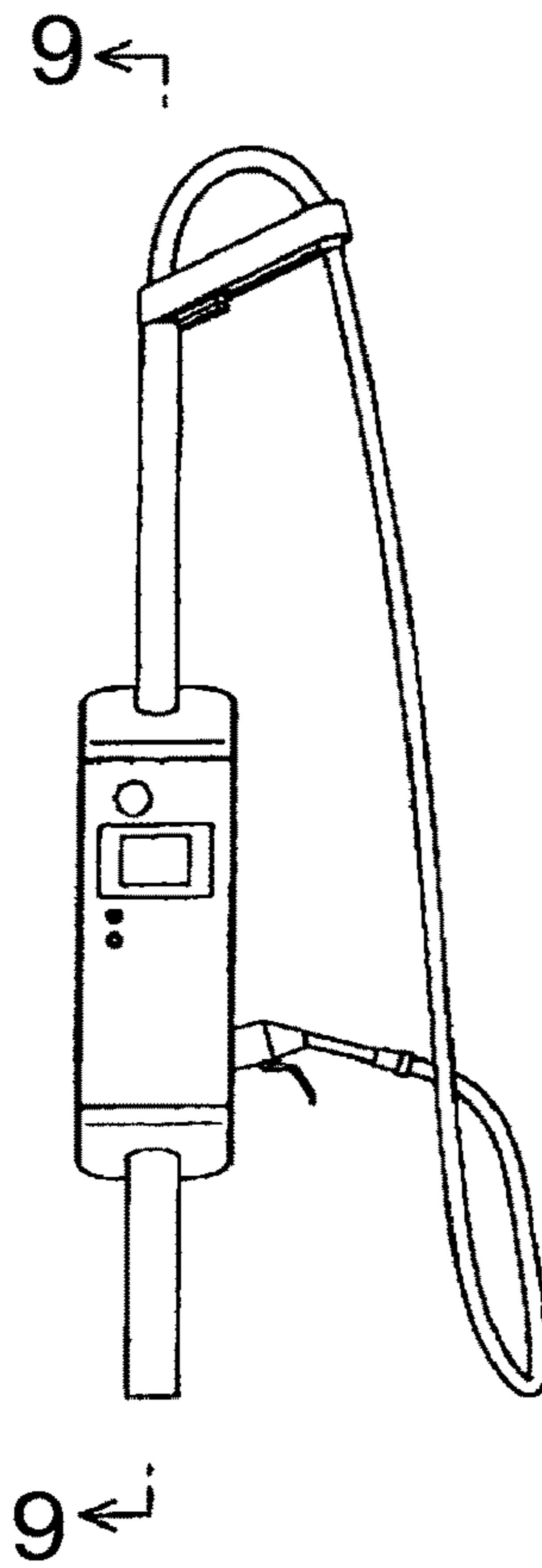

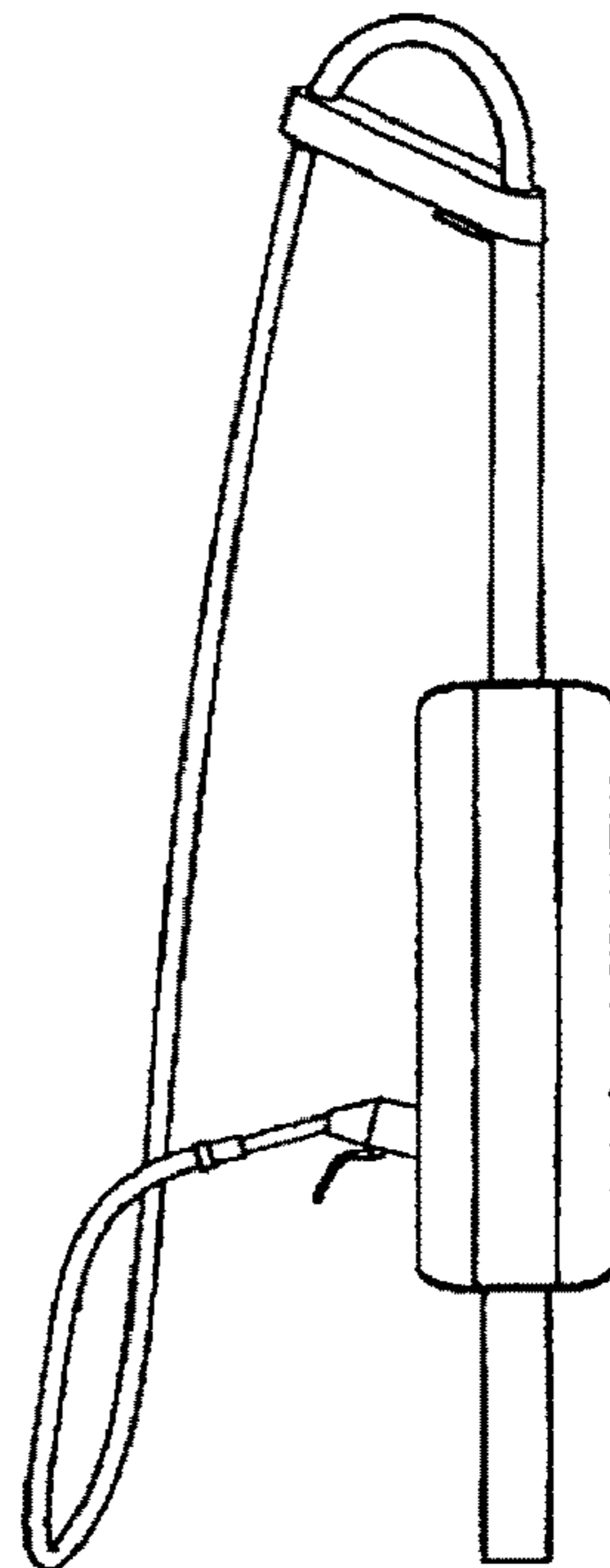

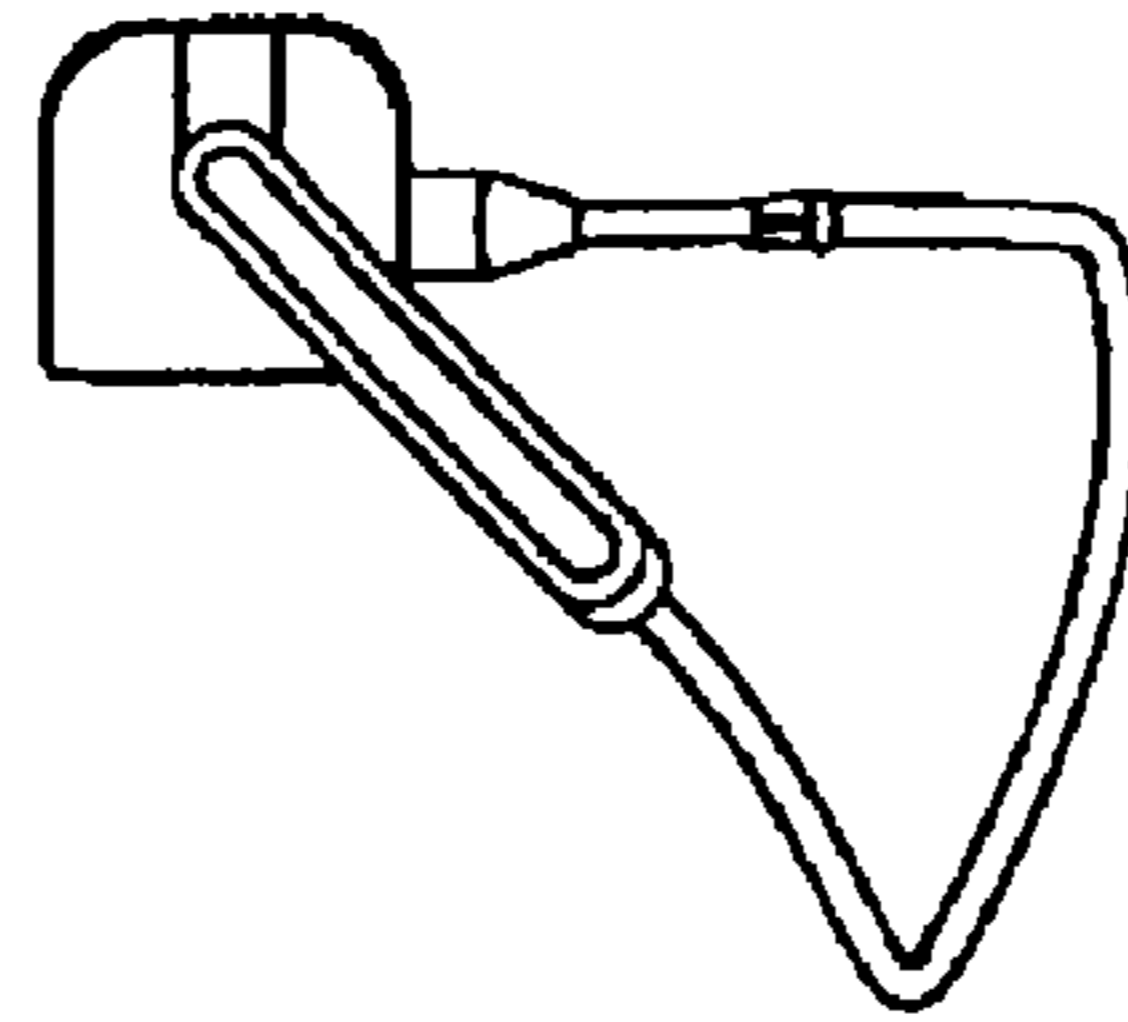

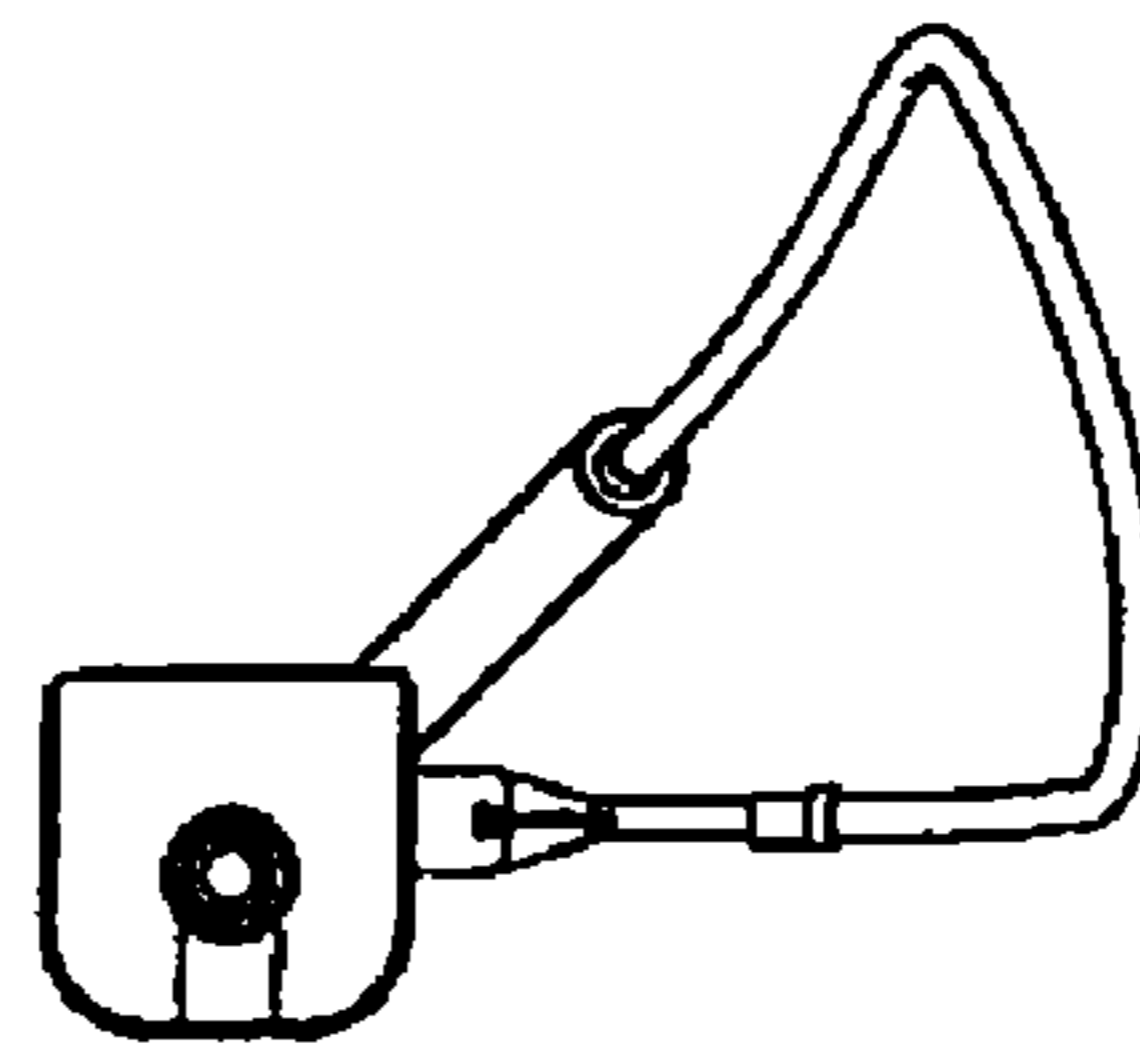
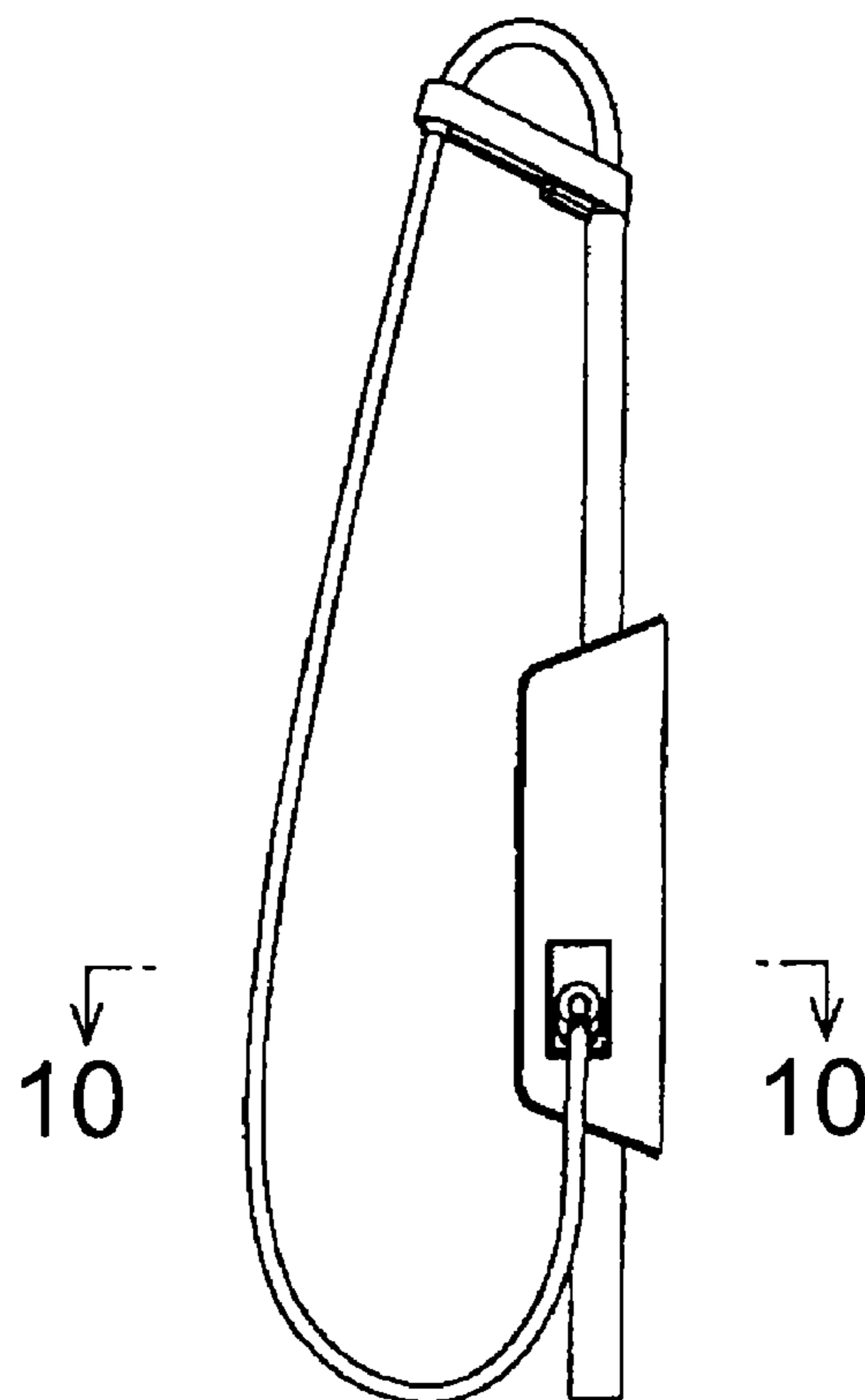
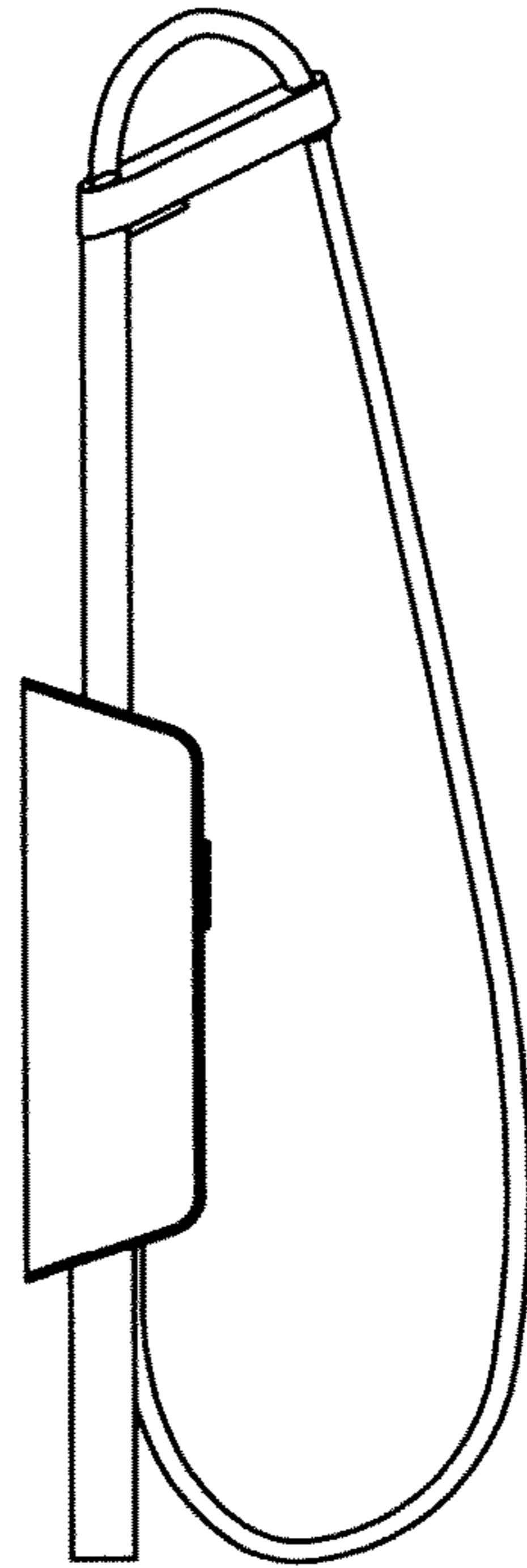


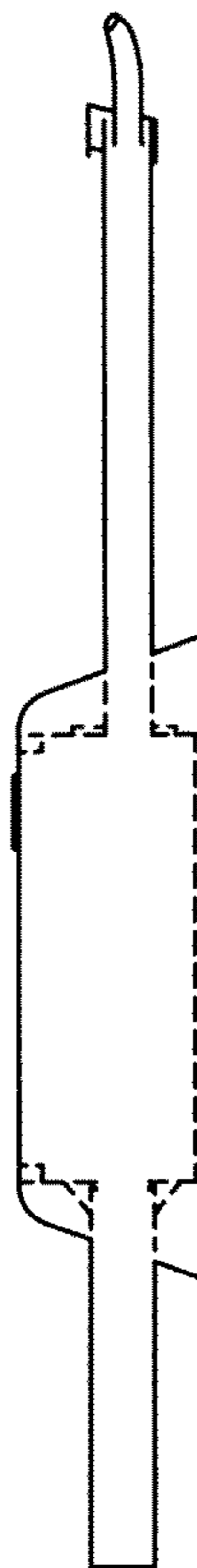
