The ornamental design for a neckloop, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the neckloop showing my new design;

FIG. 2 is a first side view thereof, the second side (opposite the first side) view being a mirror image thereof;

FIG. 3 is a third side (perpendicular to the first side) view thereof;

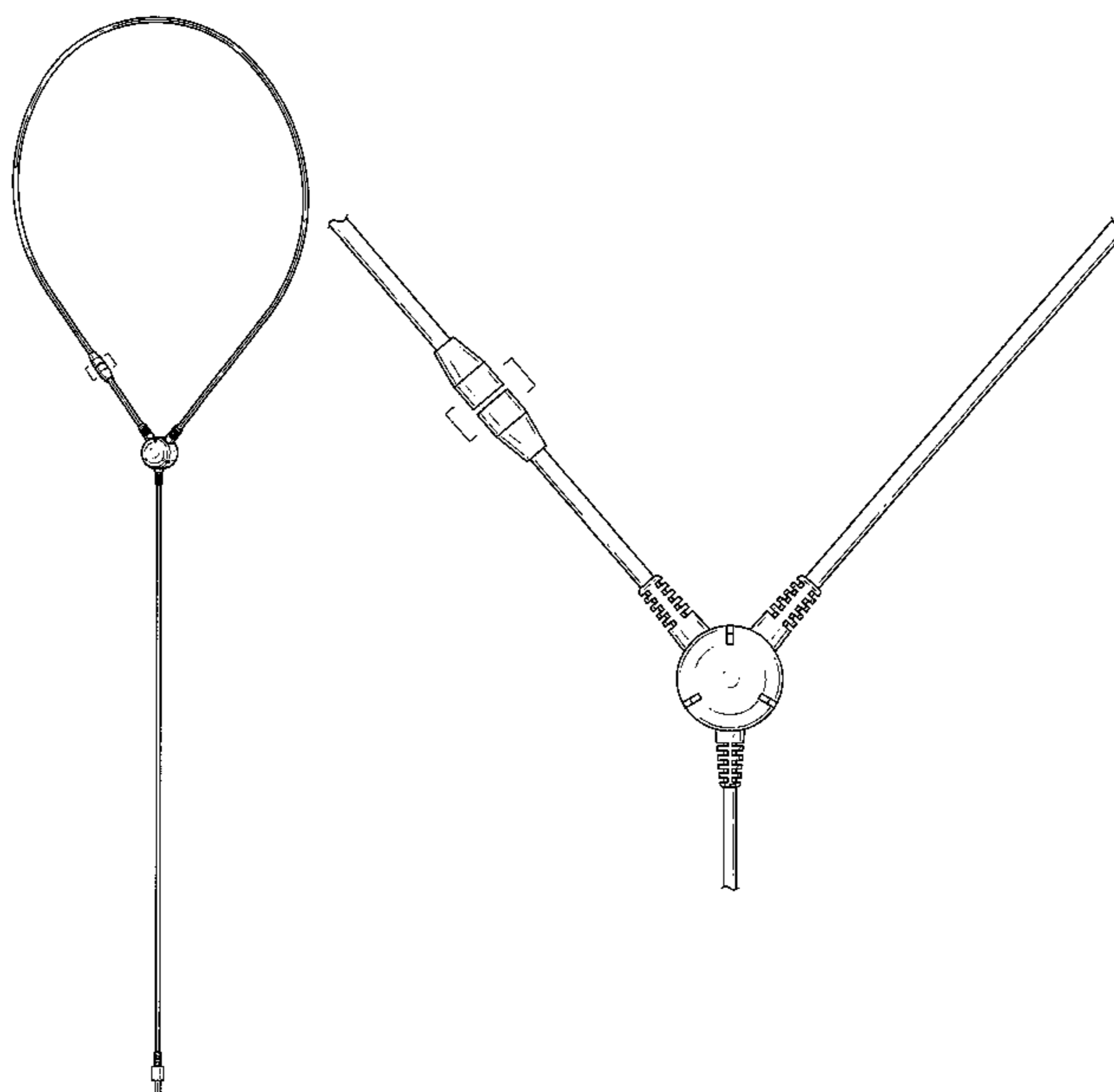
FIG. 4 is a fourth side (opposite to the third side) view thereof;

FIG. 5 is an enlarged view of a portion of the first side view;

FIG. 6 is a third side view of the enlarged portion shown in FIG. 5; and,

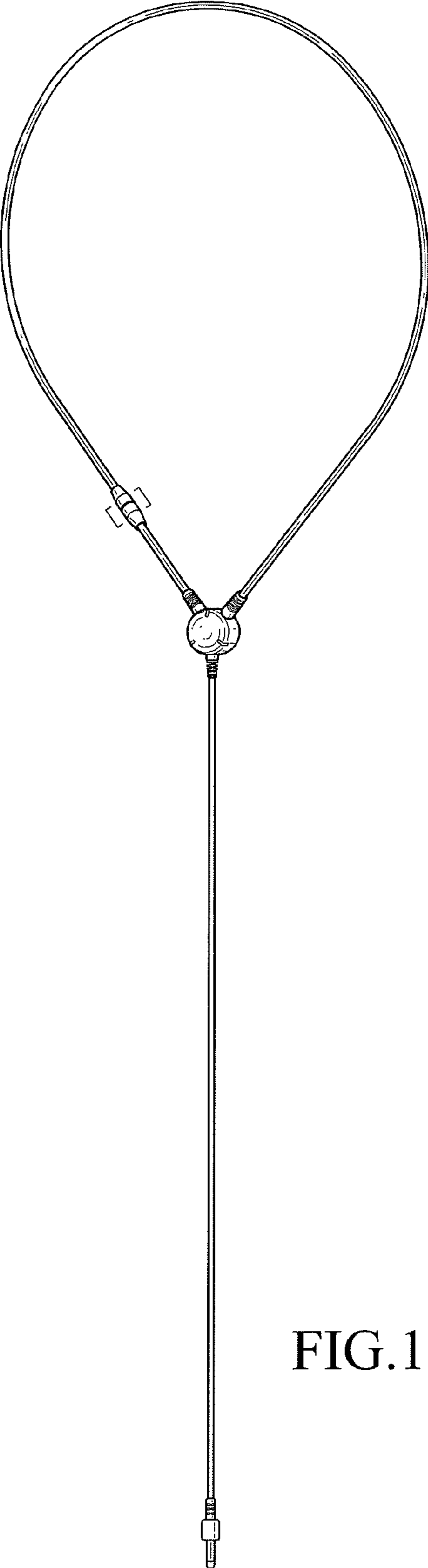

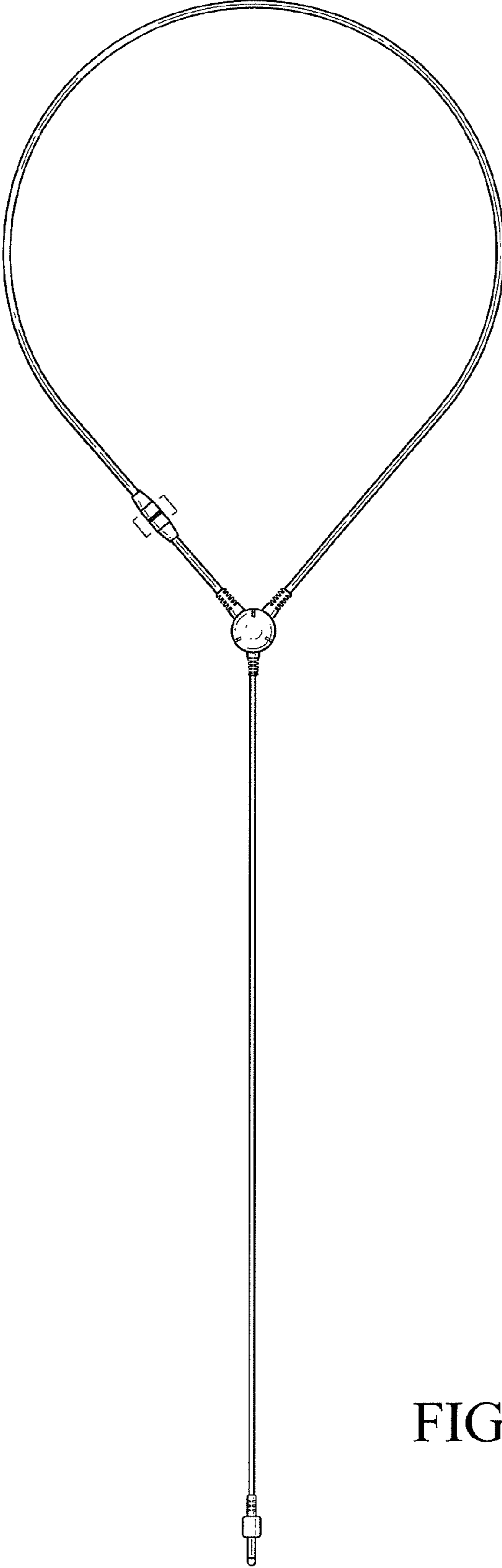

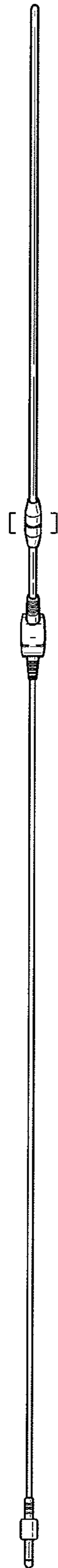

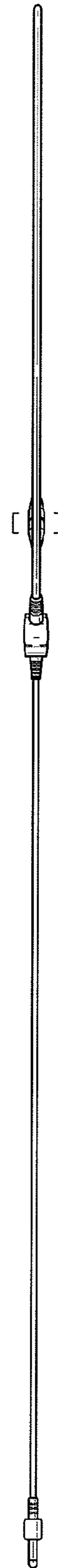

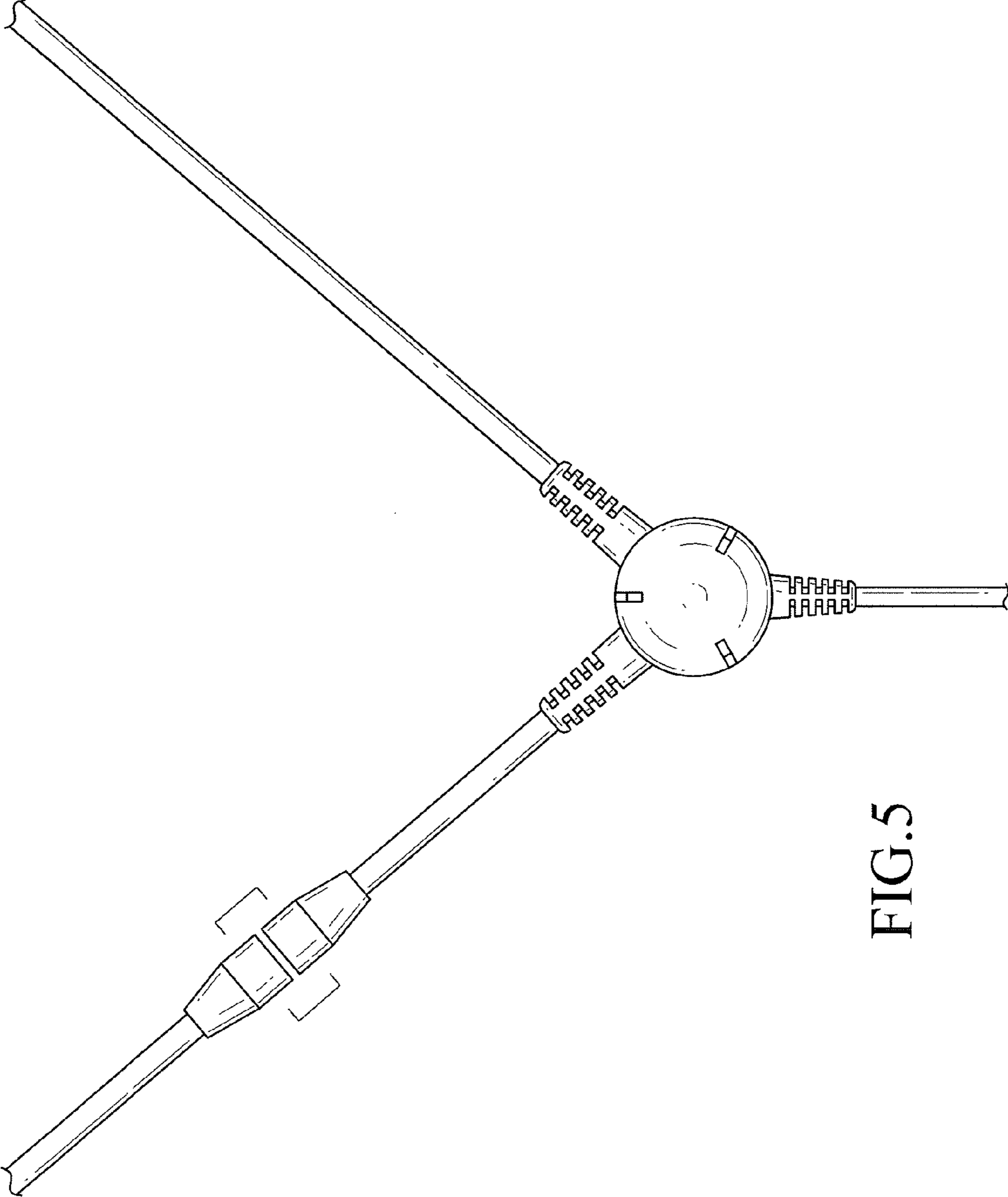

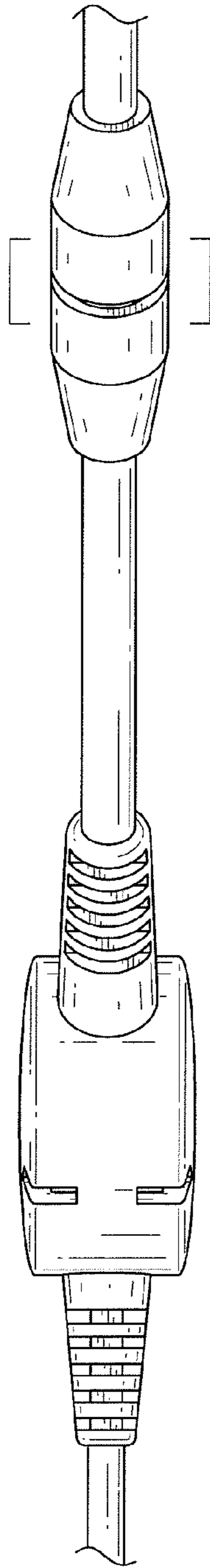

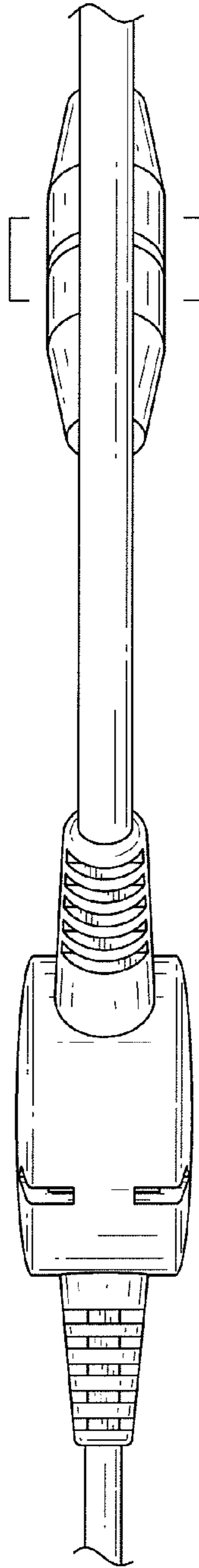
