(57) **CLAIM**

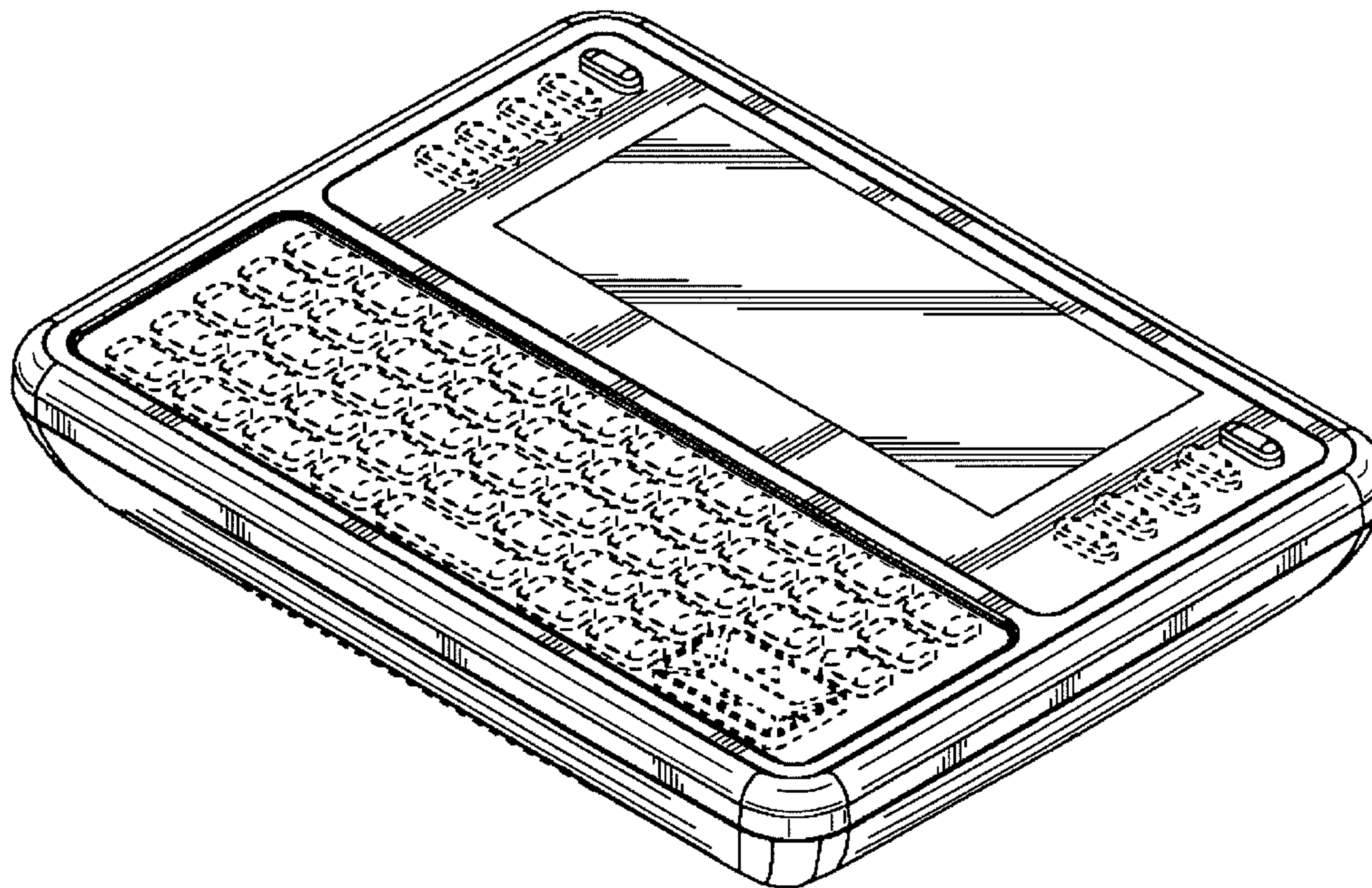
The ornamental design for a handheld electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear elevational view of a handheld electronic device in accordance with our new design;  
FIG. 2 is a front elevational view of the handheld electronic device of FIG. 1;  
FIG. 3 is a perspective view of the handheld electronic device of FIG. 1;  
FIG. 4 is a right side elevational view of the handheld electronic device of FIG. 1;  
FIG. 5 is a left side elevational view of the handheld electronic device of FIG. 1;  
FIG. 6 is a bottom plan view of the handheld electronic device of FIG. 1; and,  
FIG. 7 is top plan view of the handheld electronic device of FIG. 1.

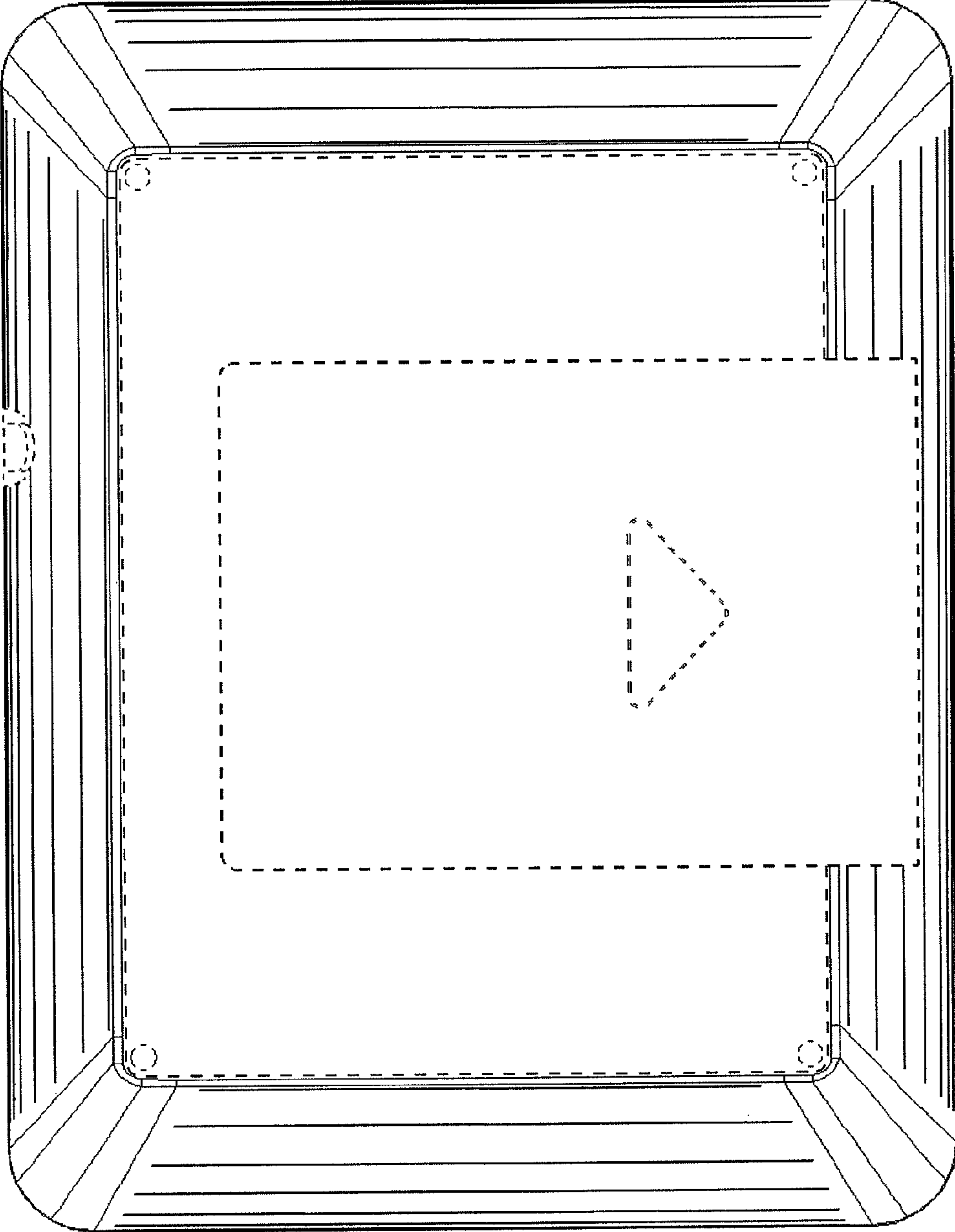

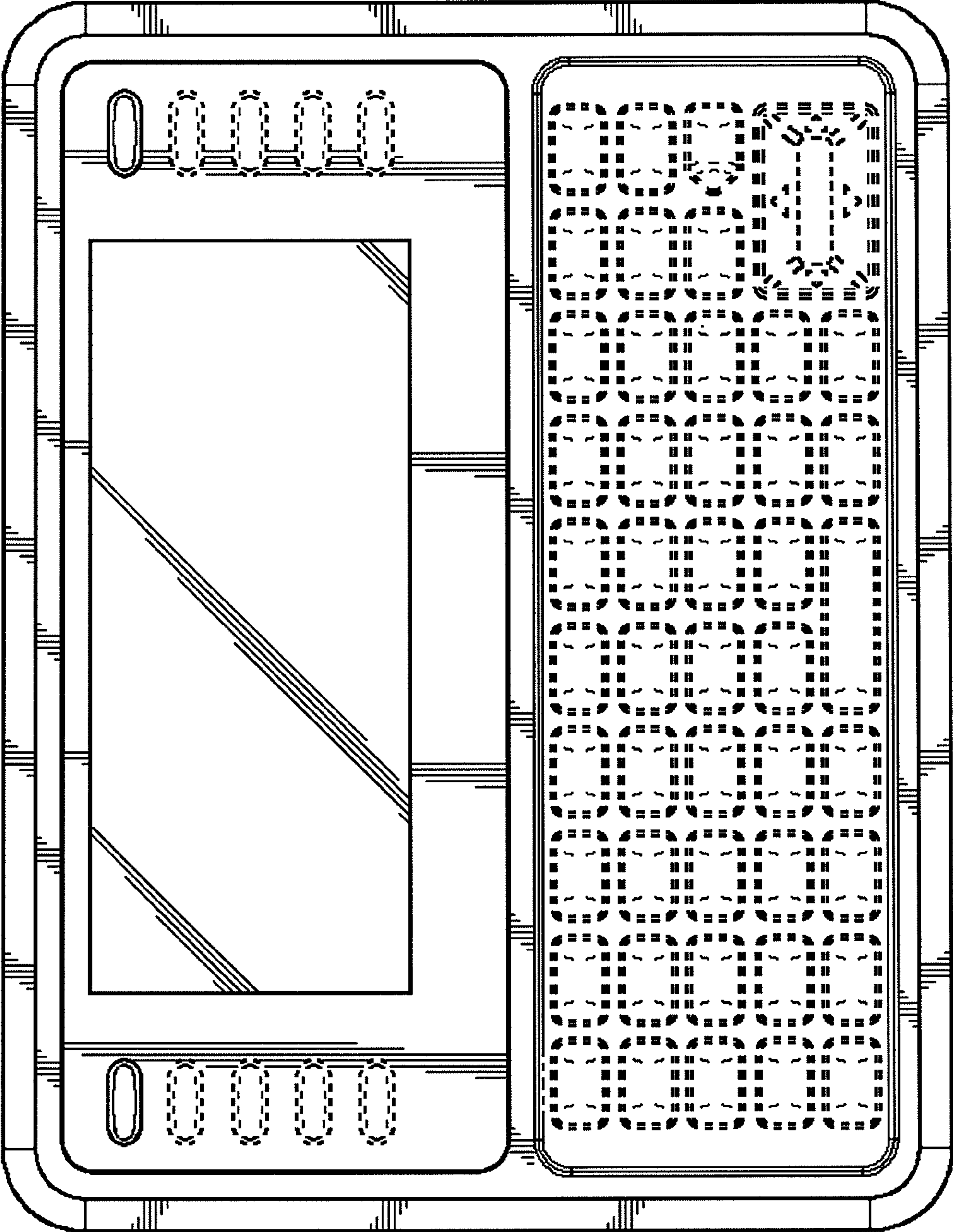

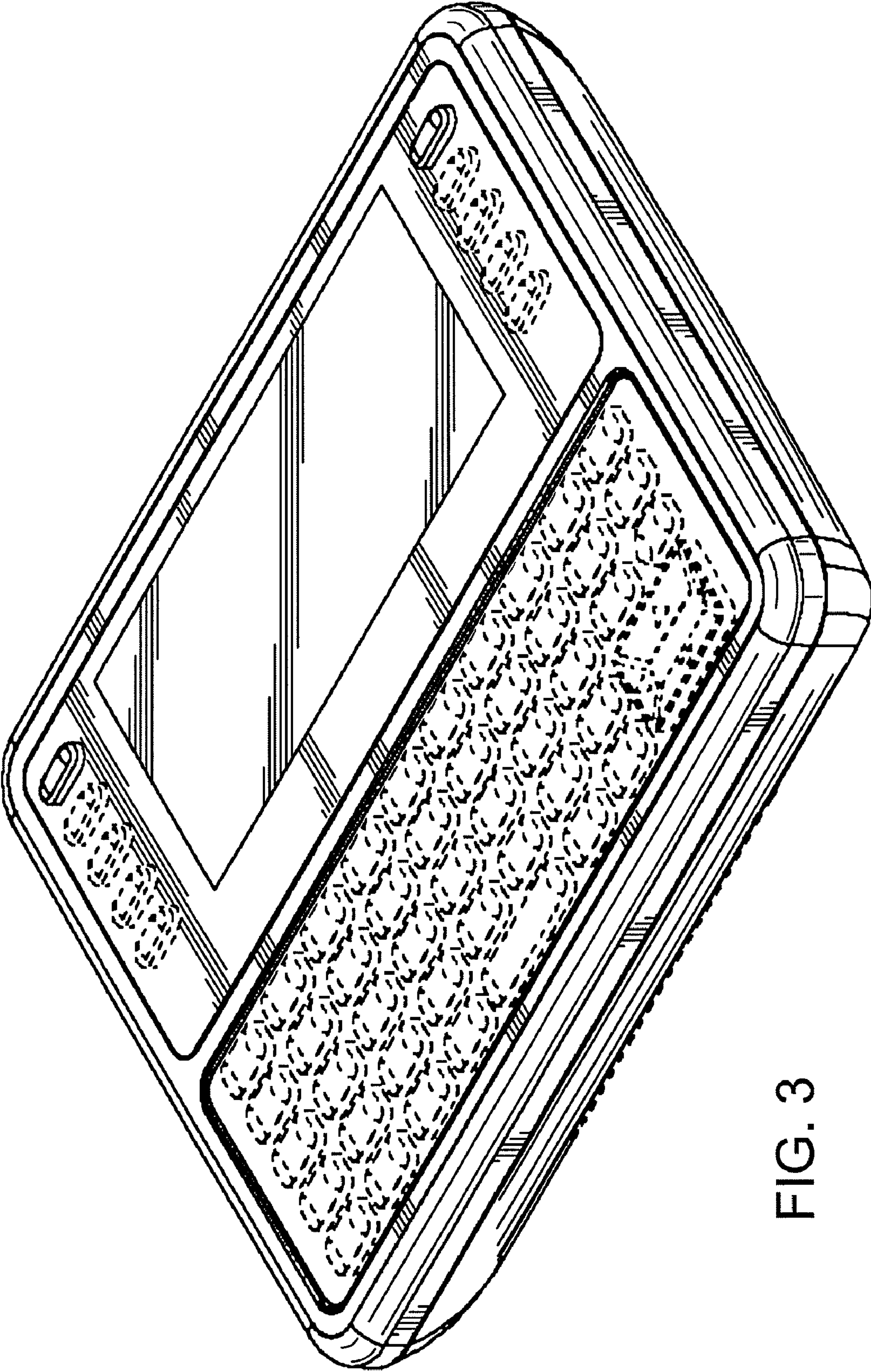

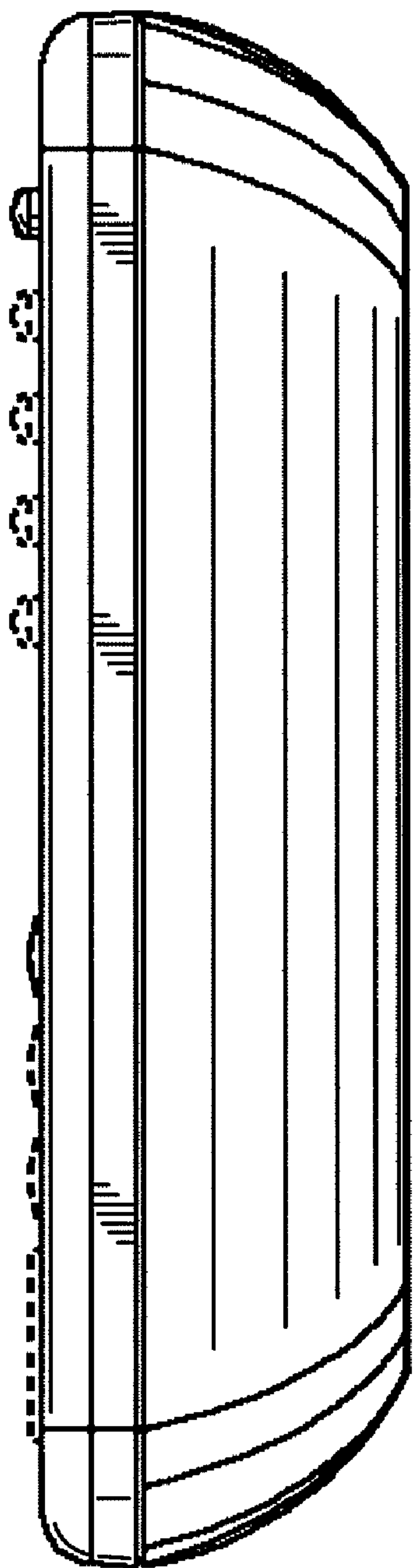

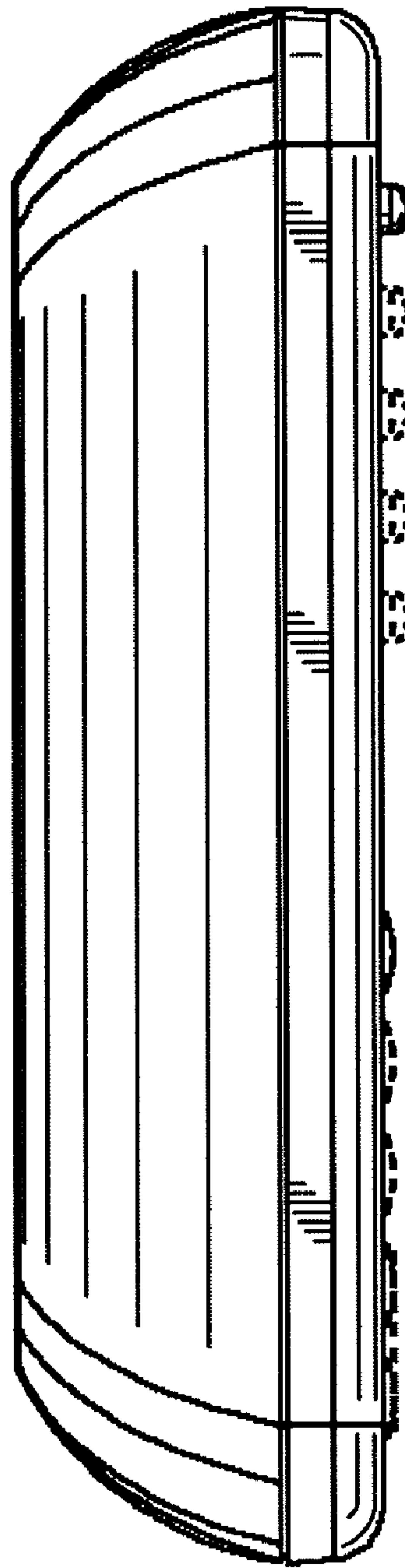

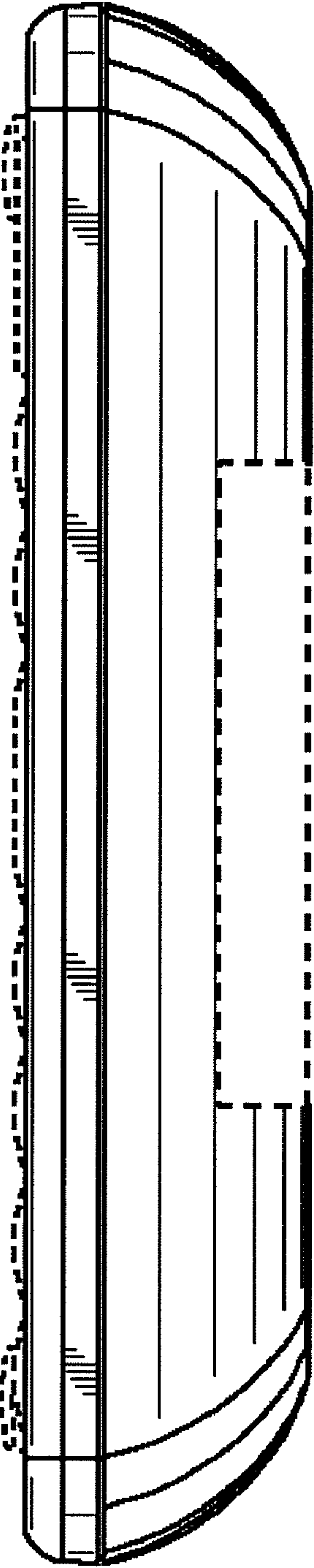

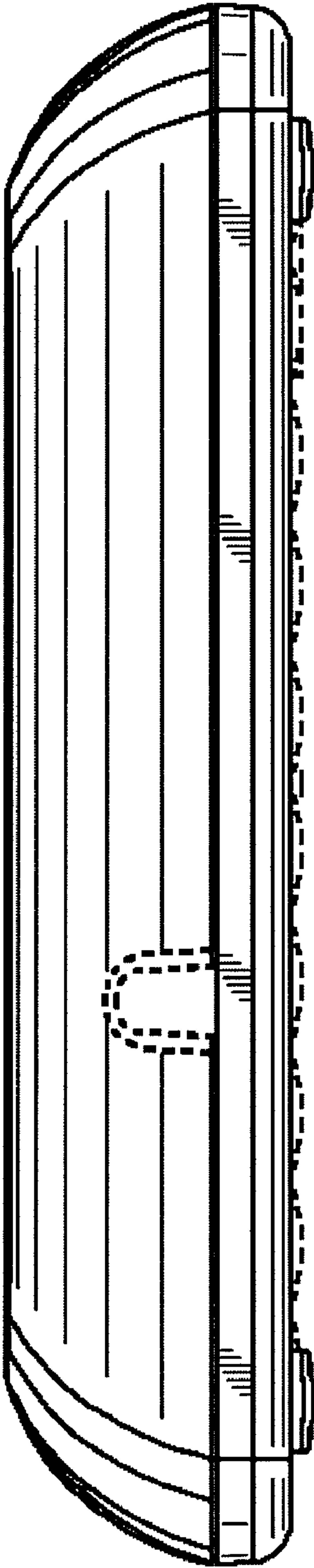
