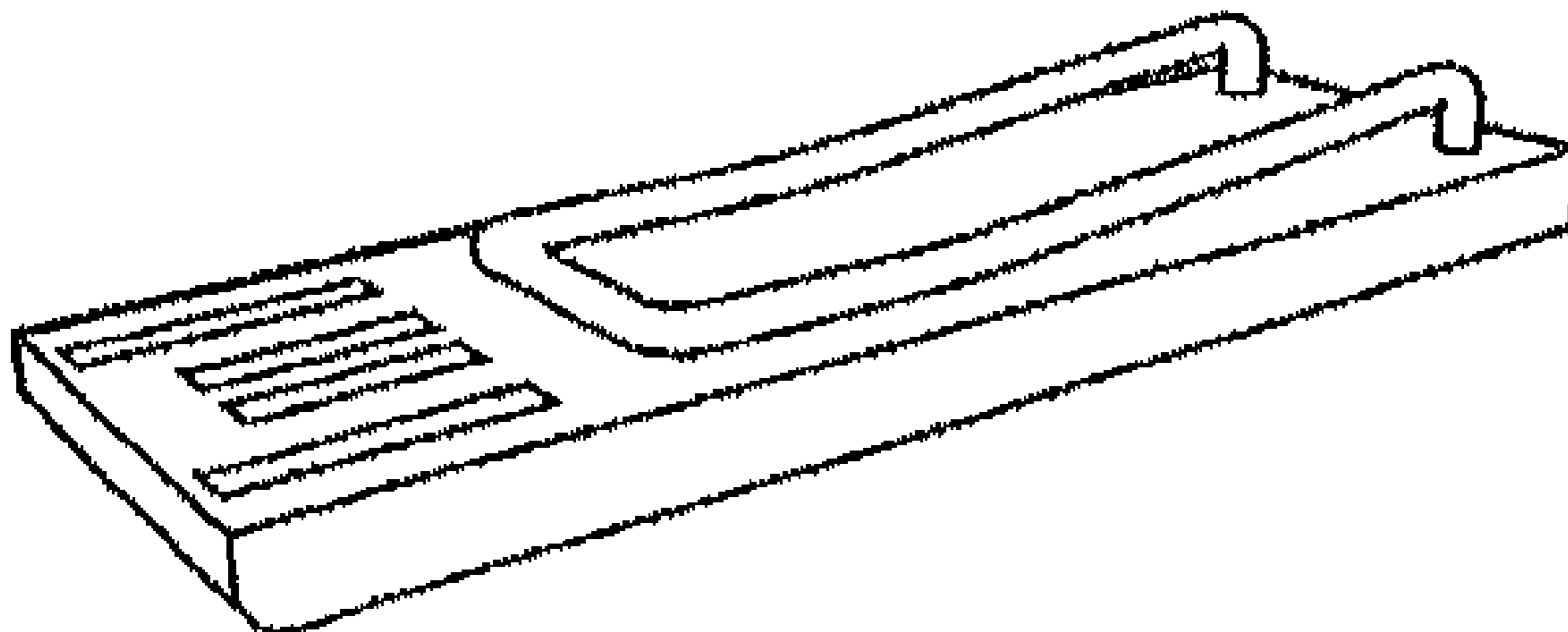
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a memory stick showing my new design;

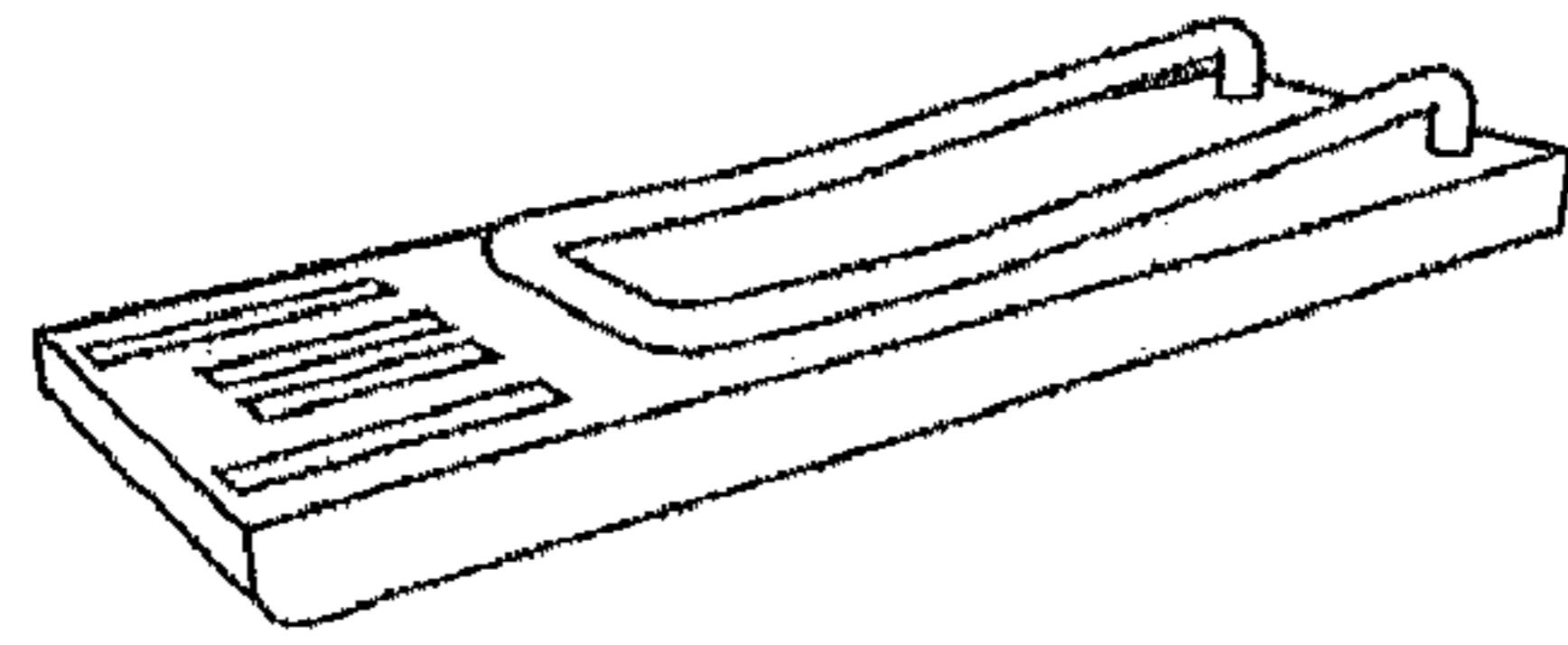

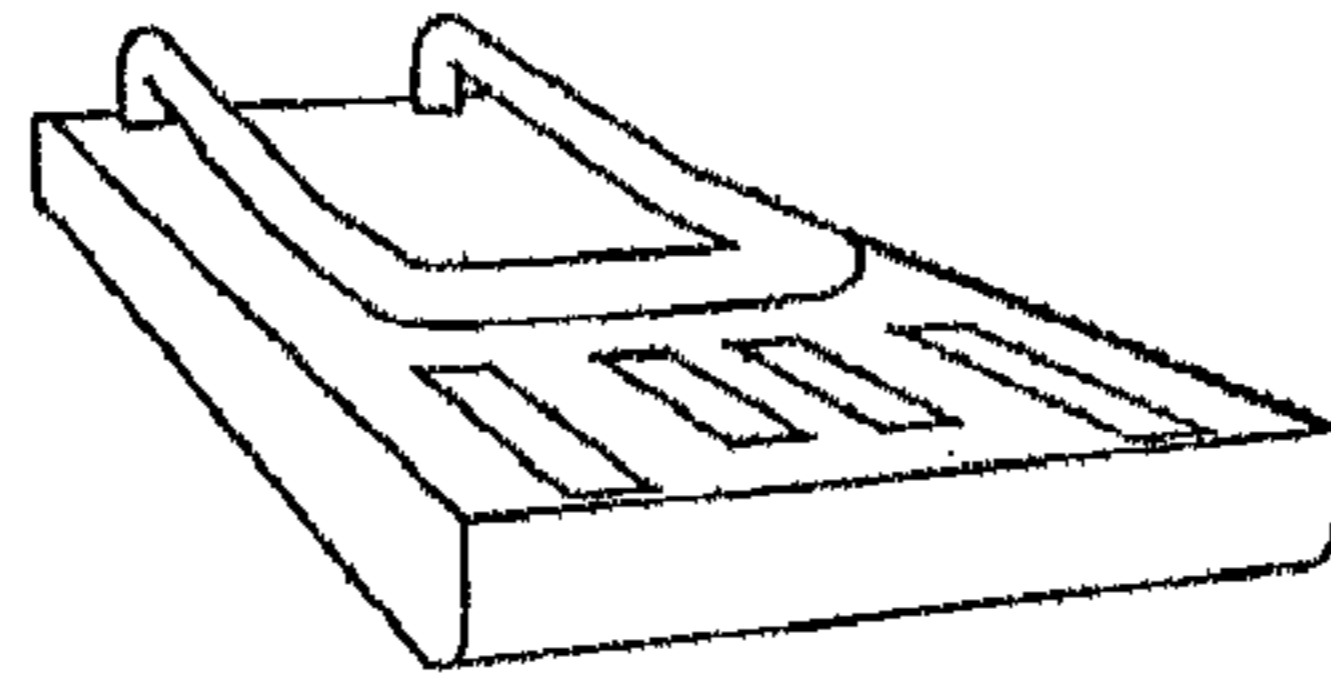

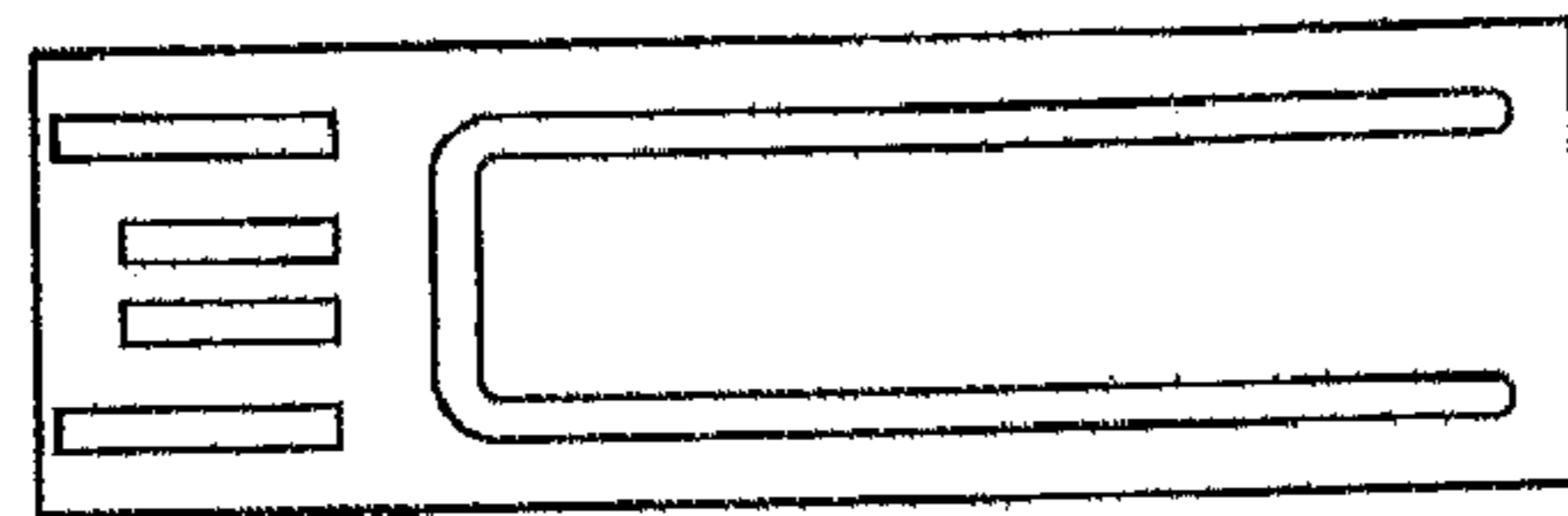

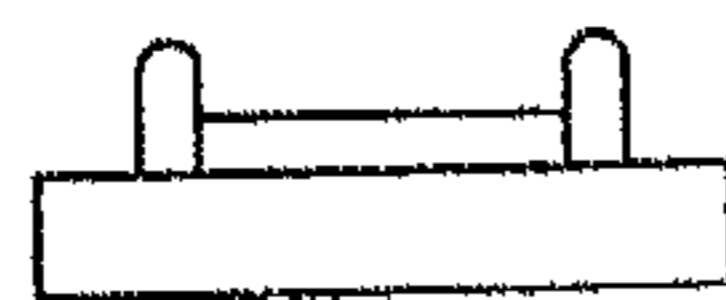

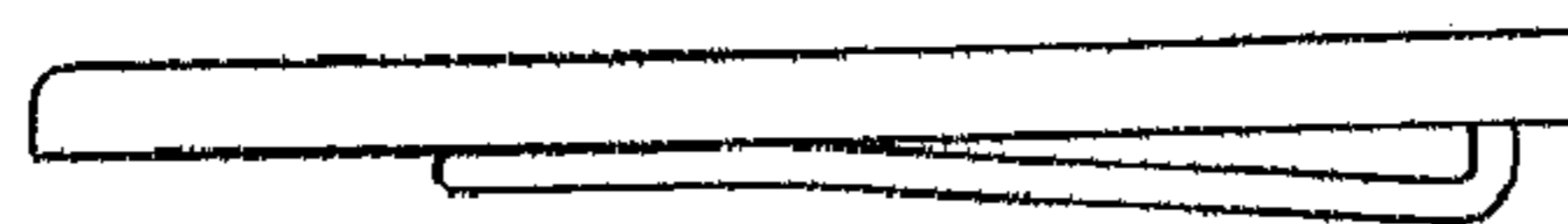

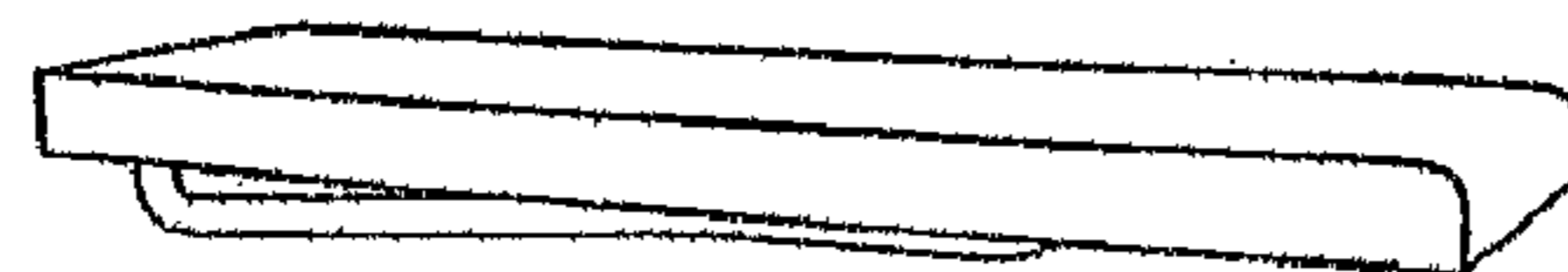

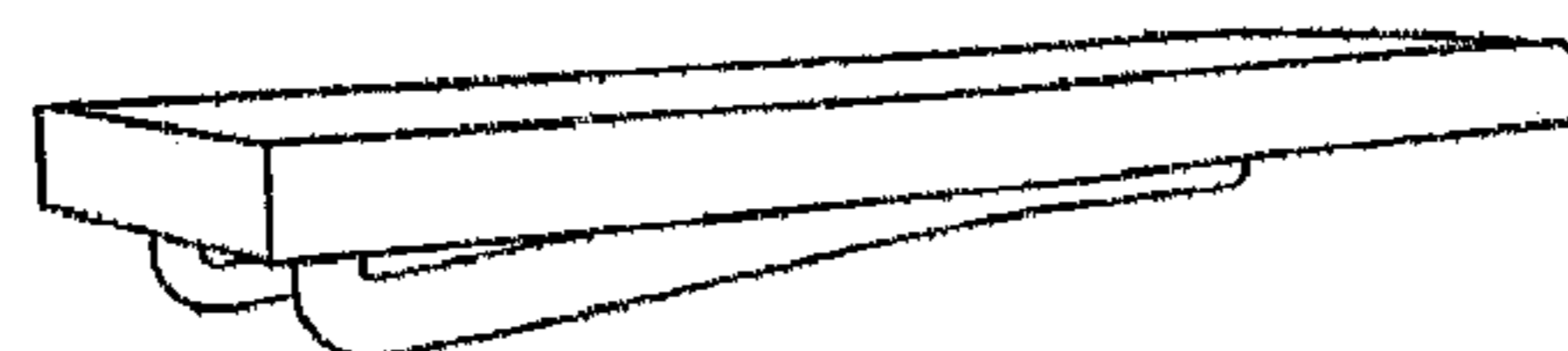
