(57) **CLAIM**

I claim, the ornamental design for a crane cab, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a crane cab, showing my new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a side elevation view thereof taken from the left of FIG. 1;

FIG. 4 is a front perspective view thereof;

FIG. 5 is a side elevation view thereof taken from the right of FIG. 1;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

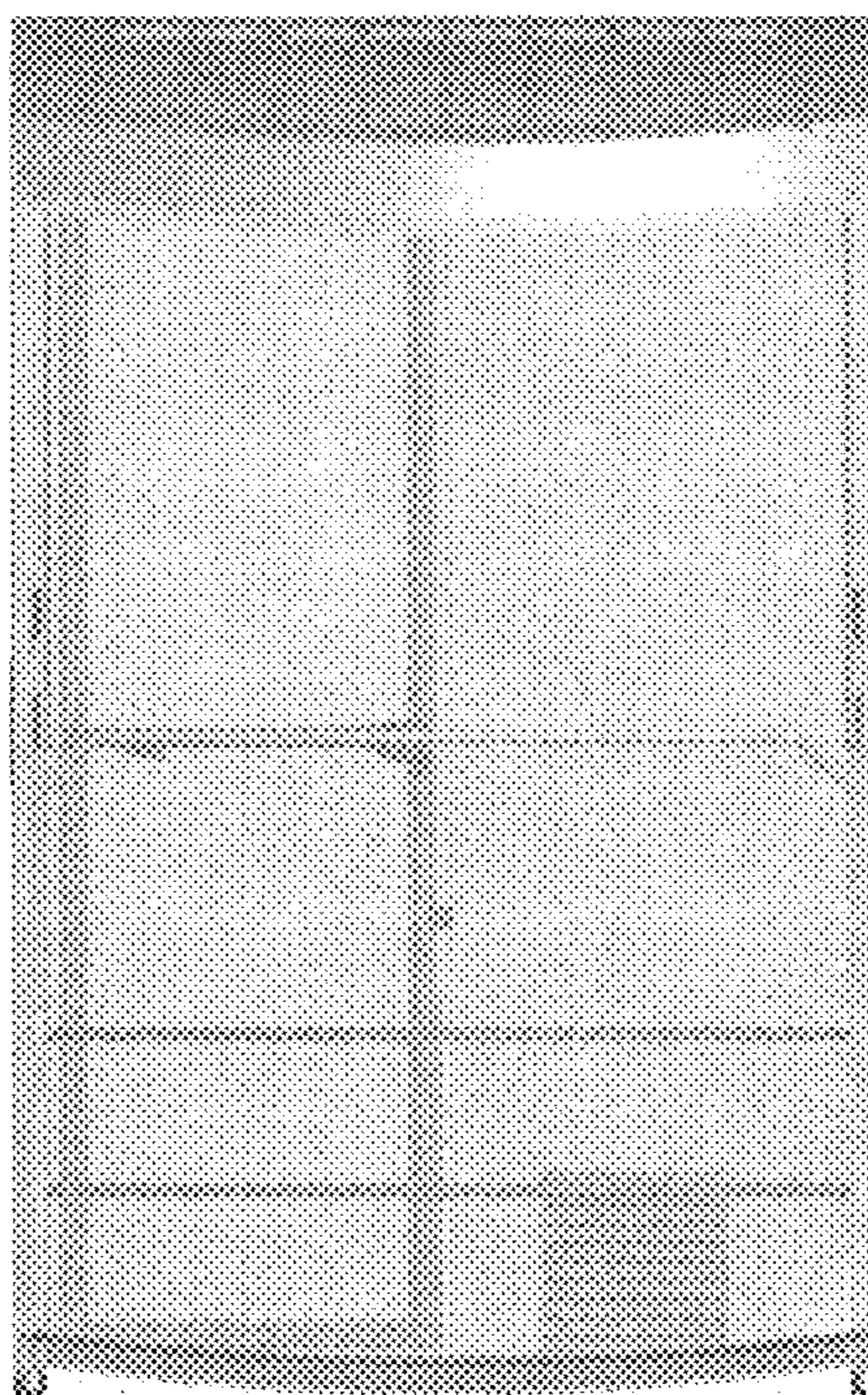

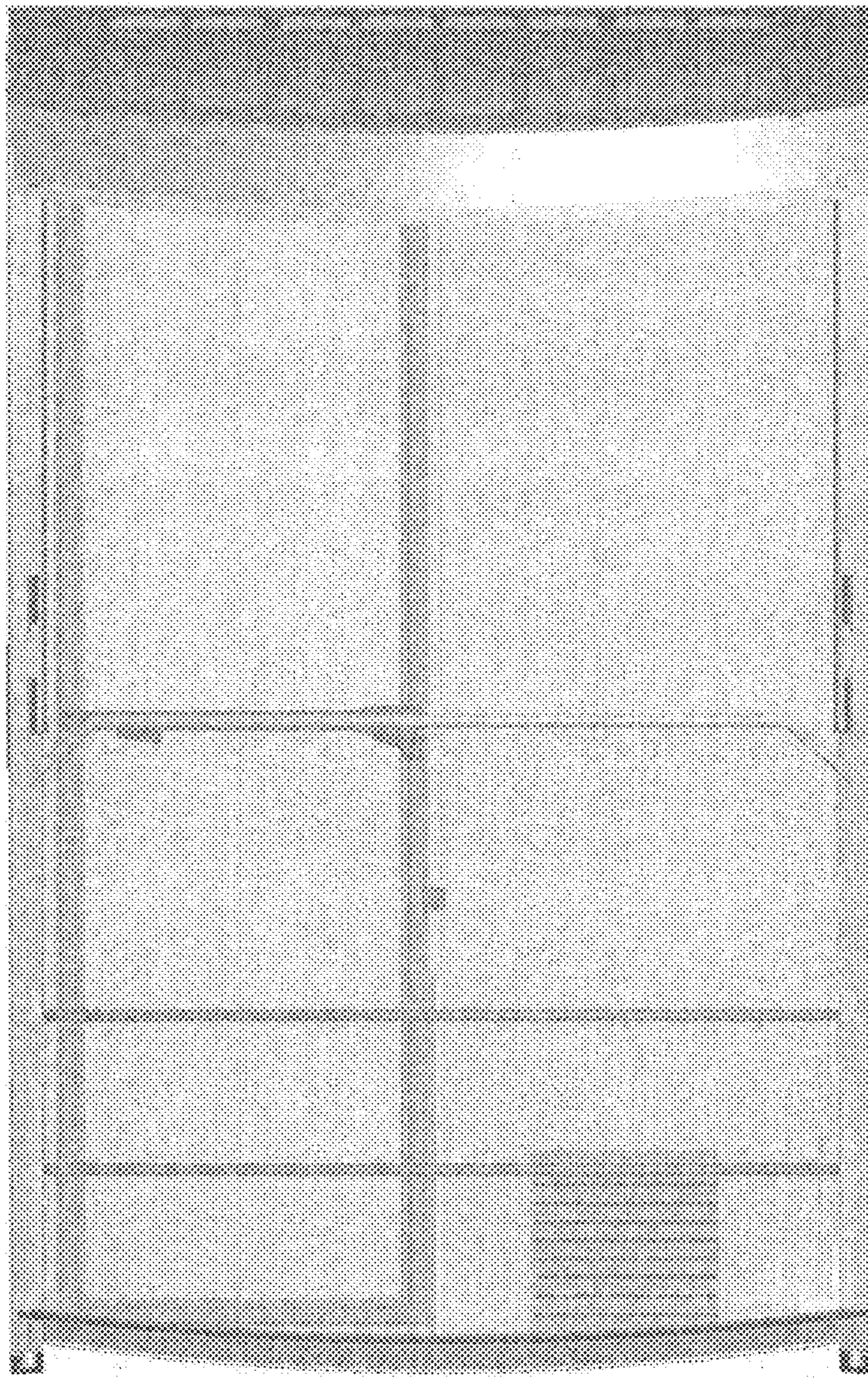

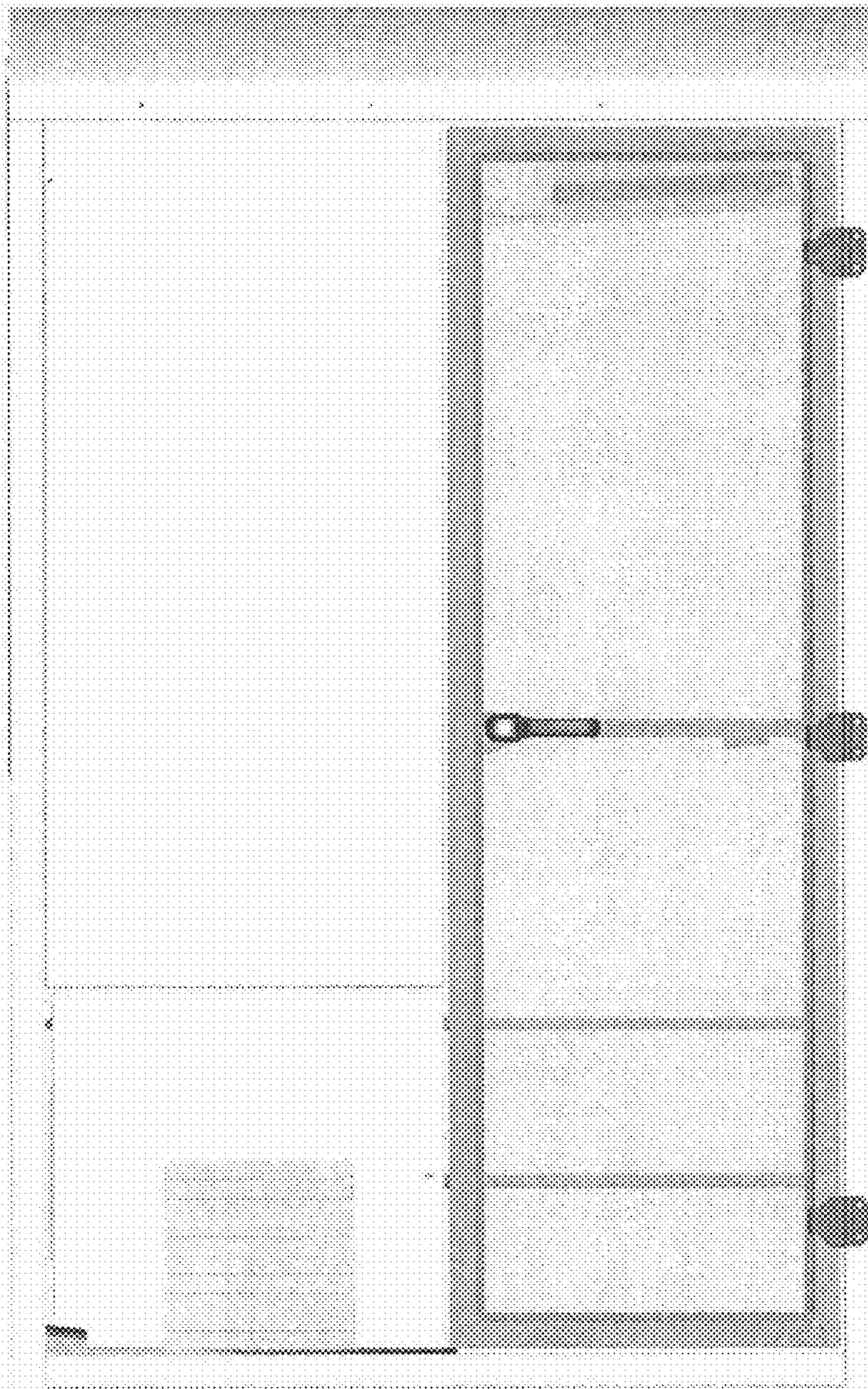

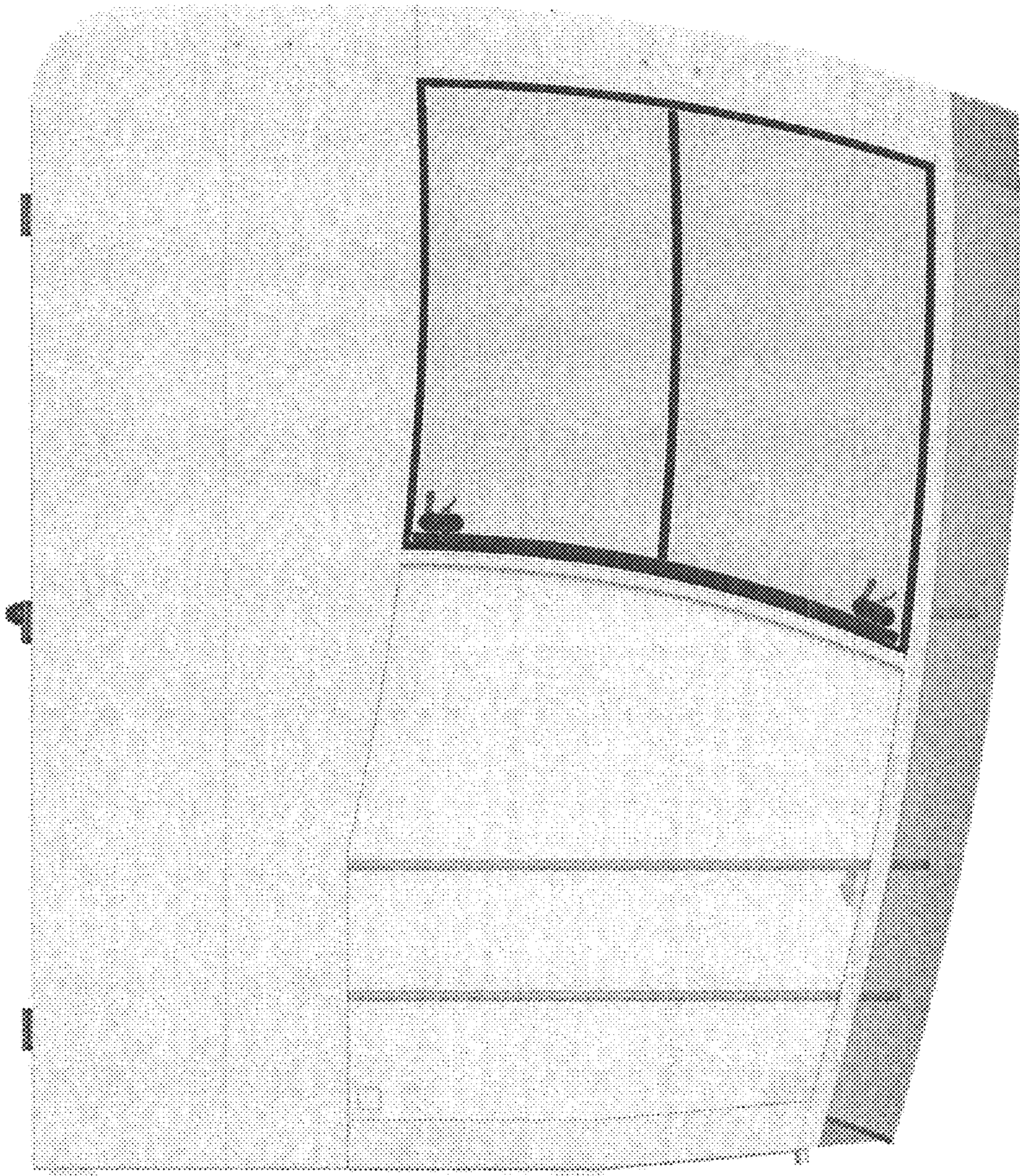

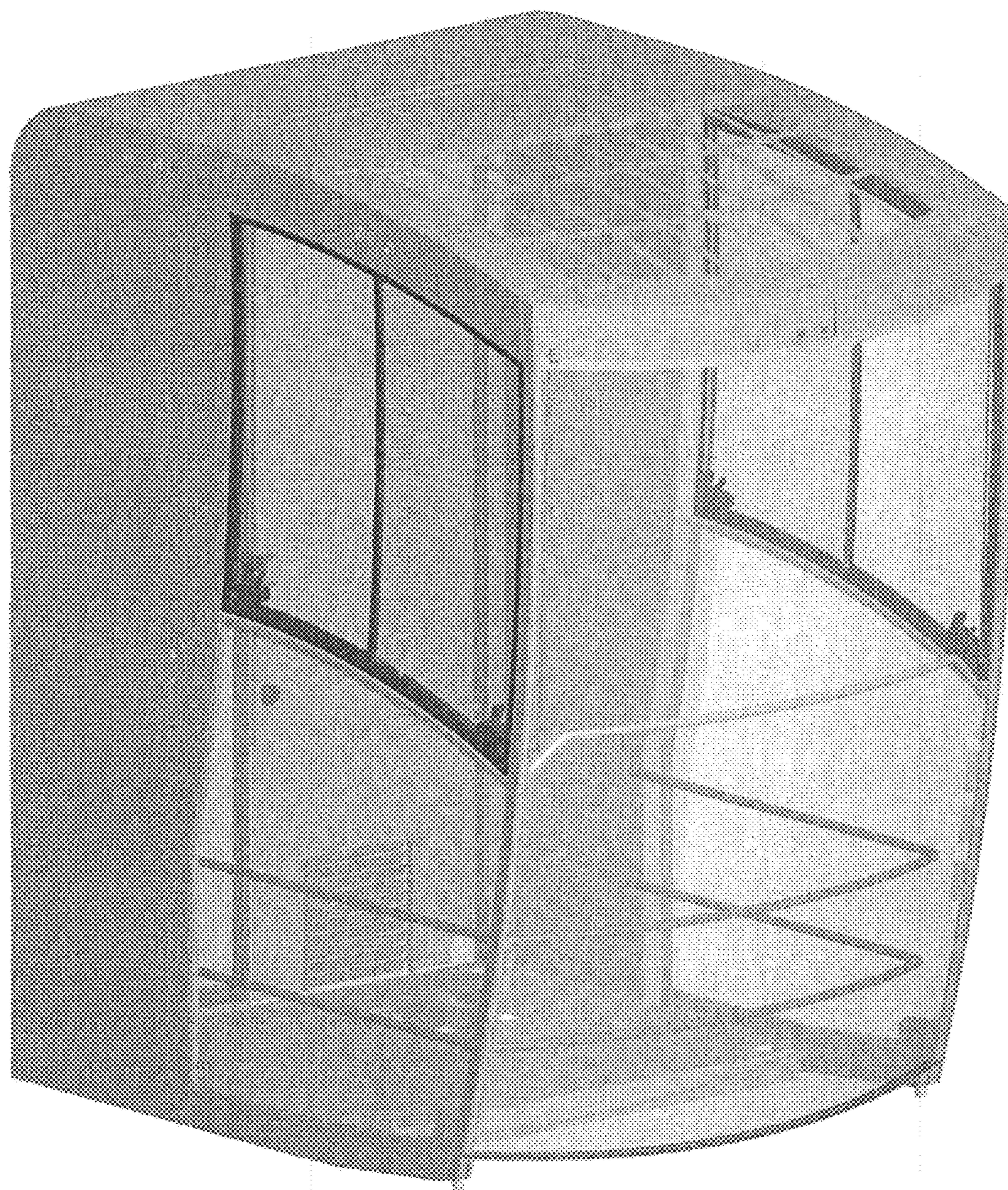

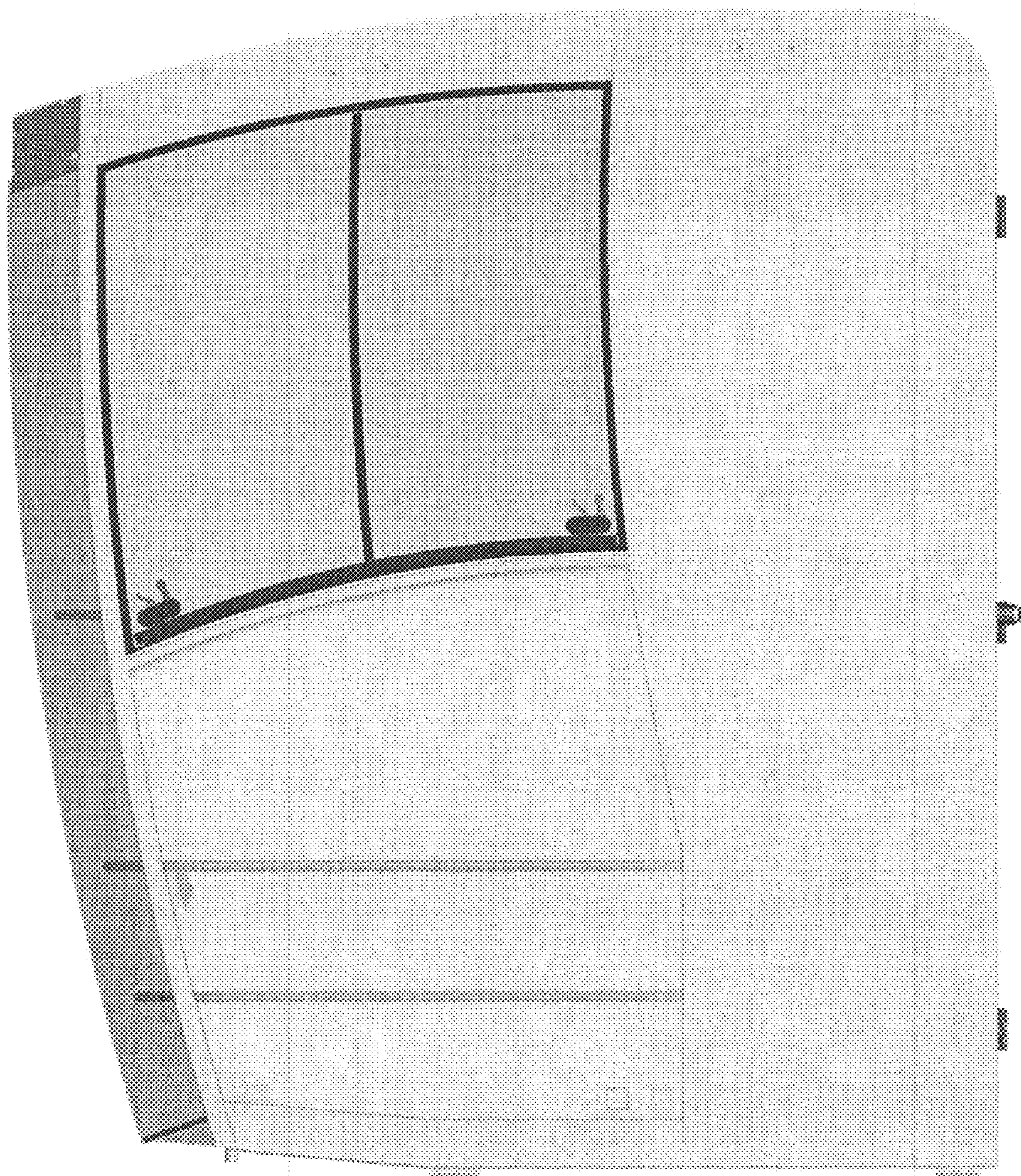

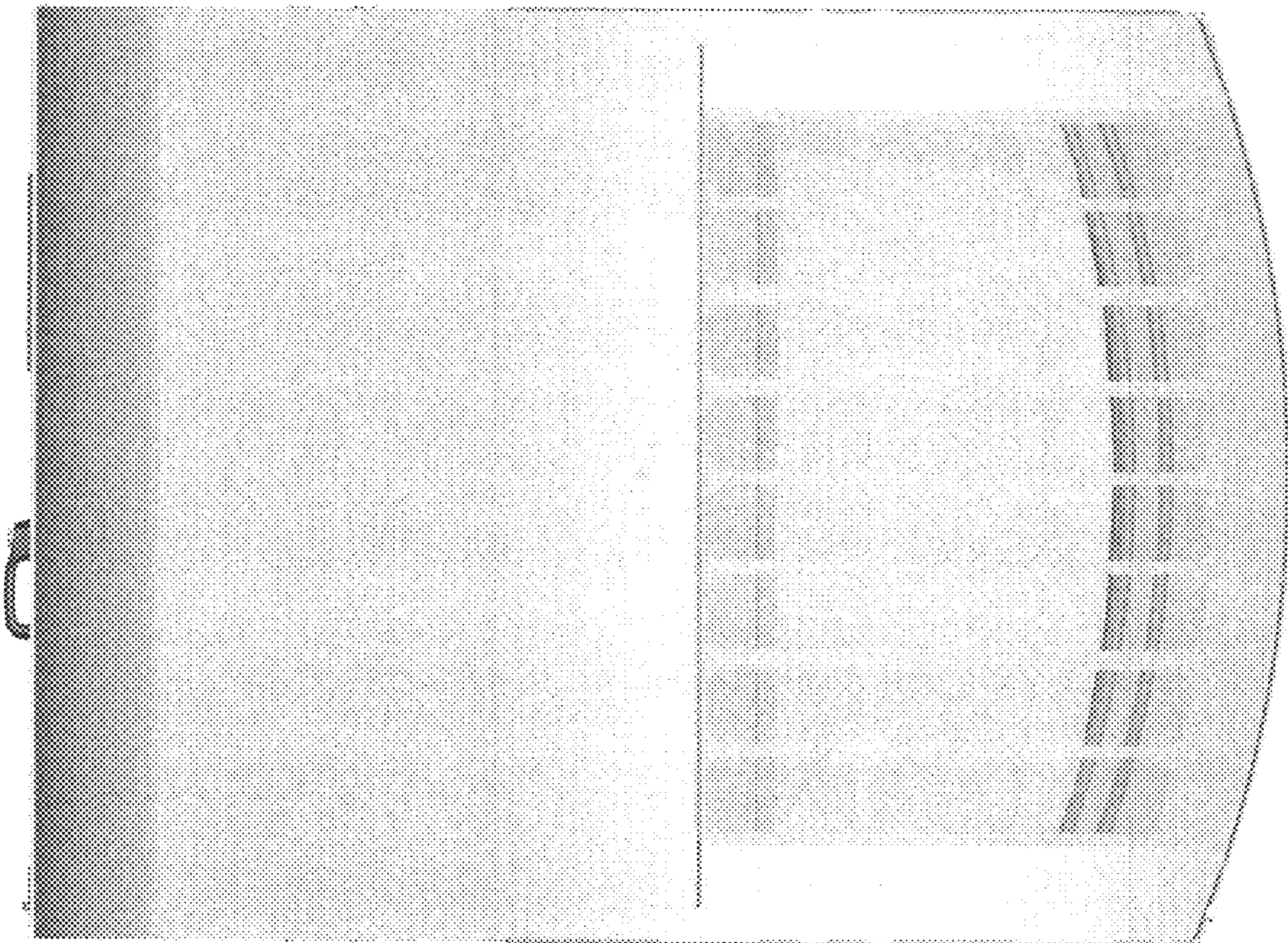
