The ornamental design for a printer device, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, front perspective view of a printer device embodying our new design;

FIG. 5 is a bottom plan view thereof;

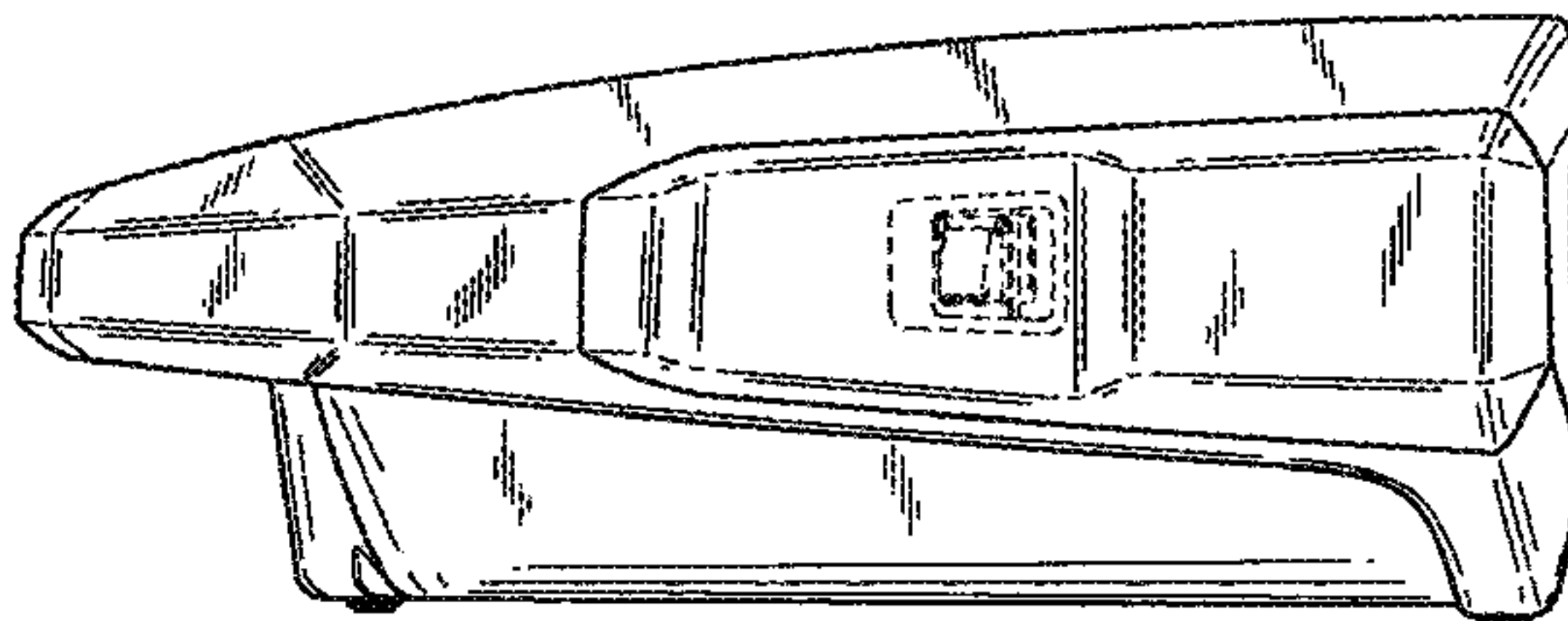
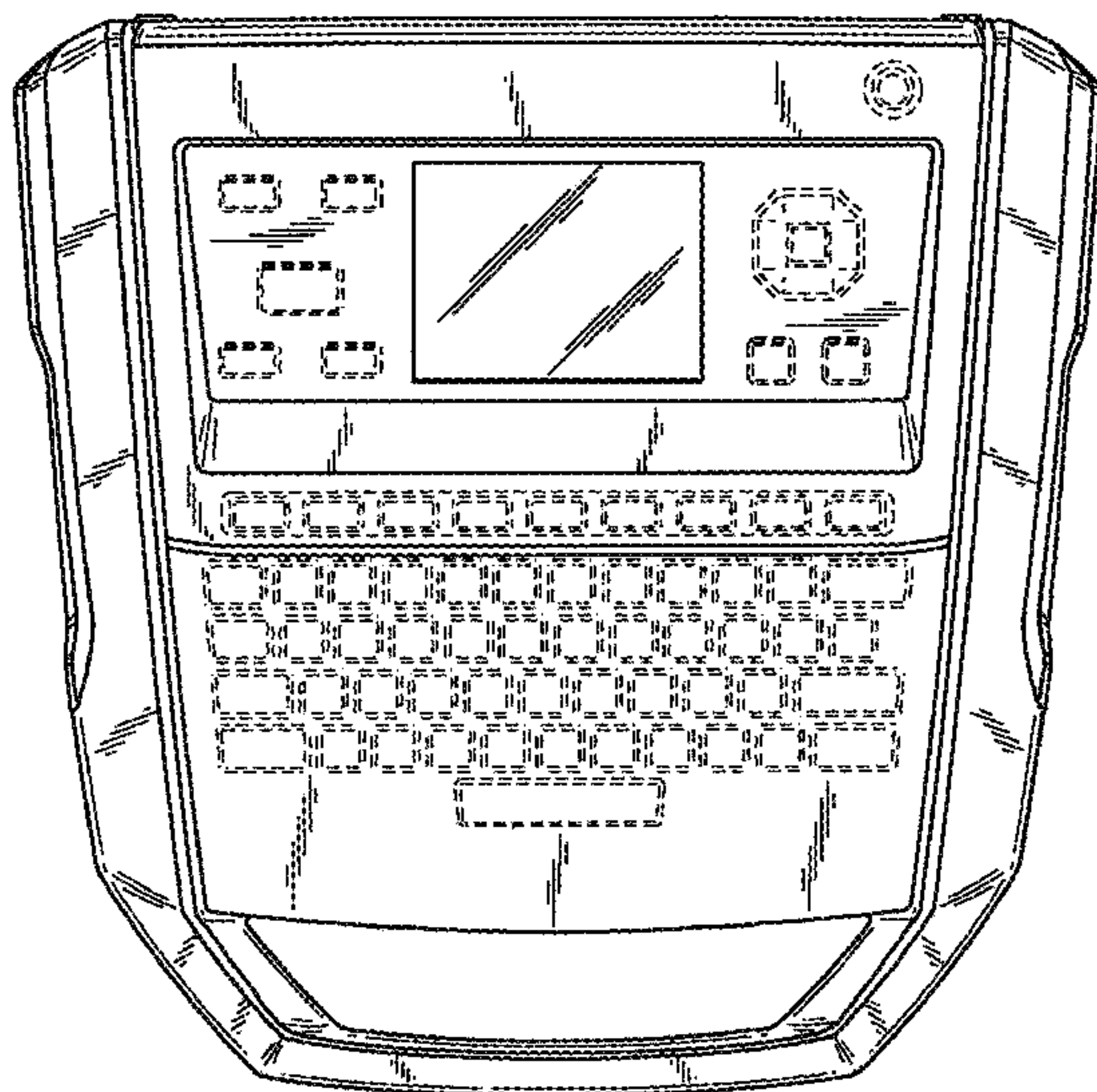
FIG. 6 is a back elevational view thereof;

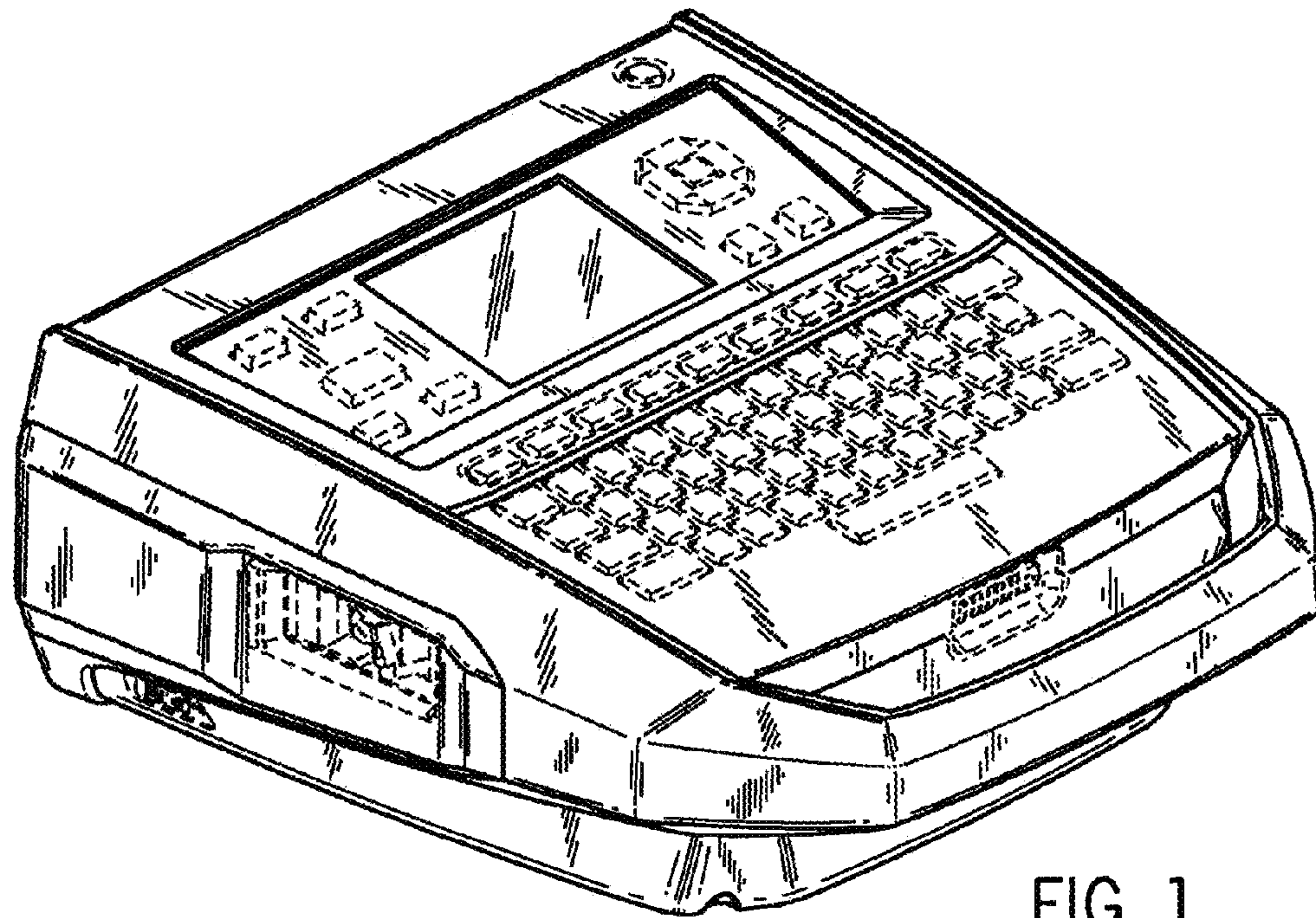

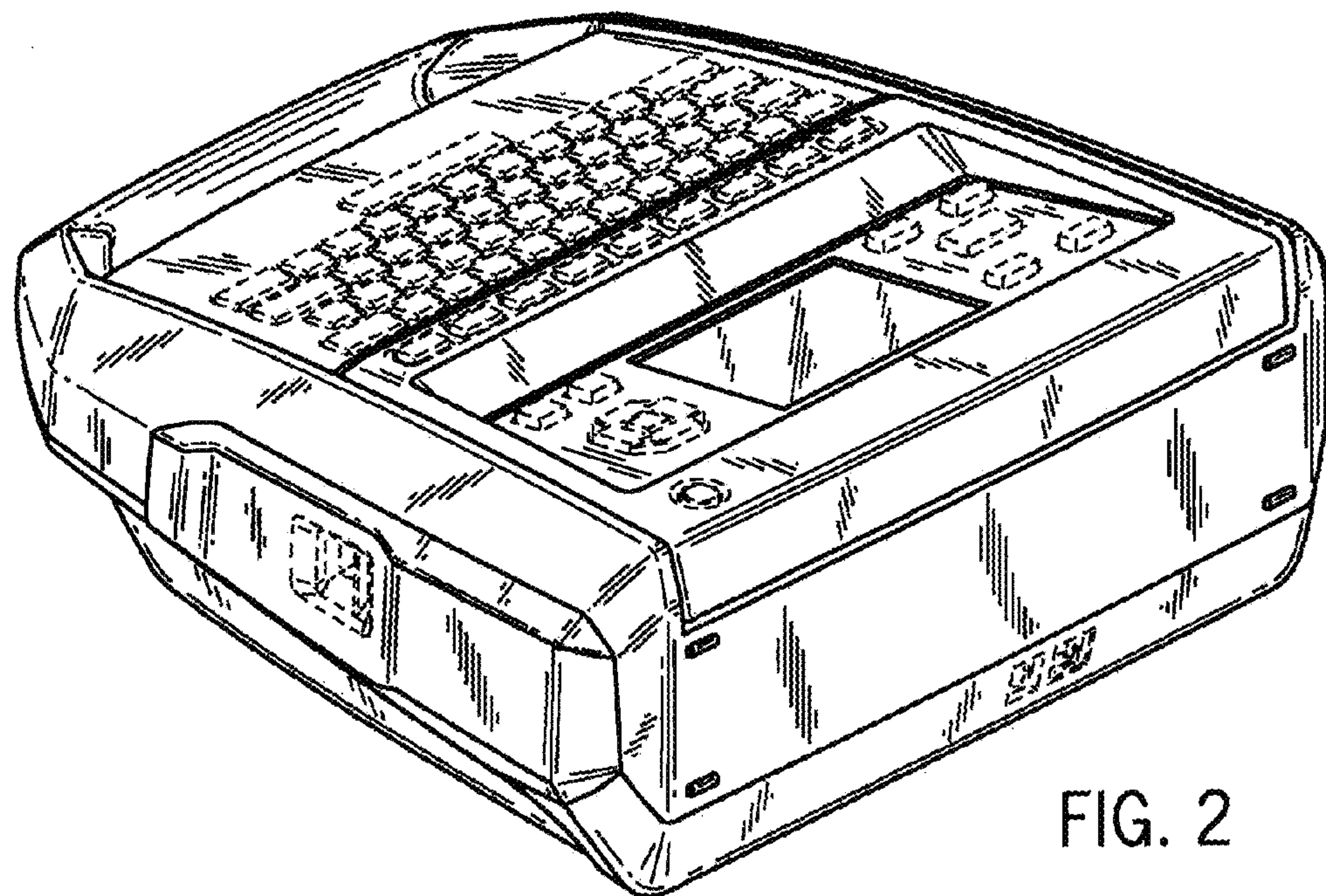

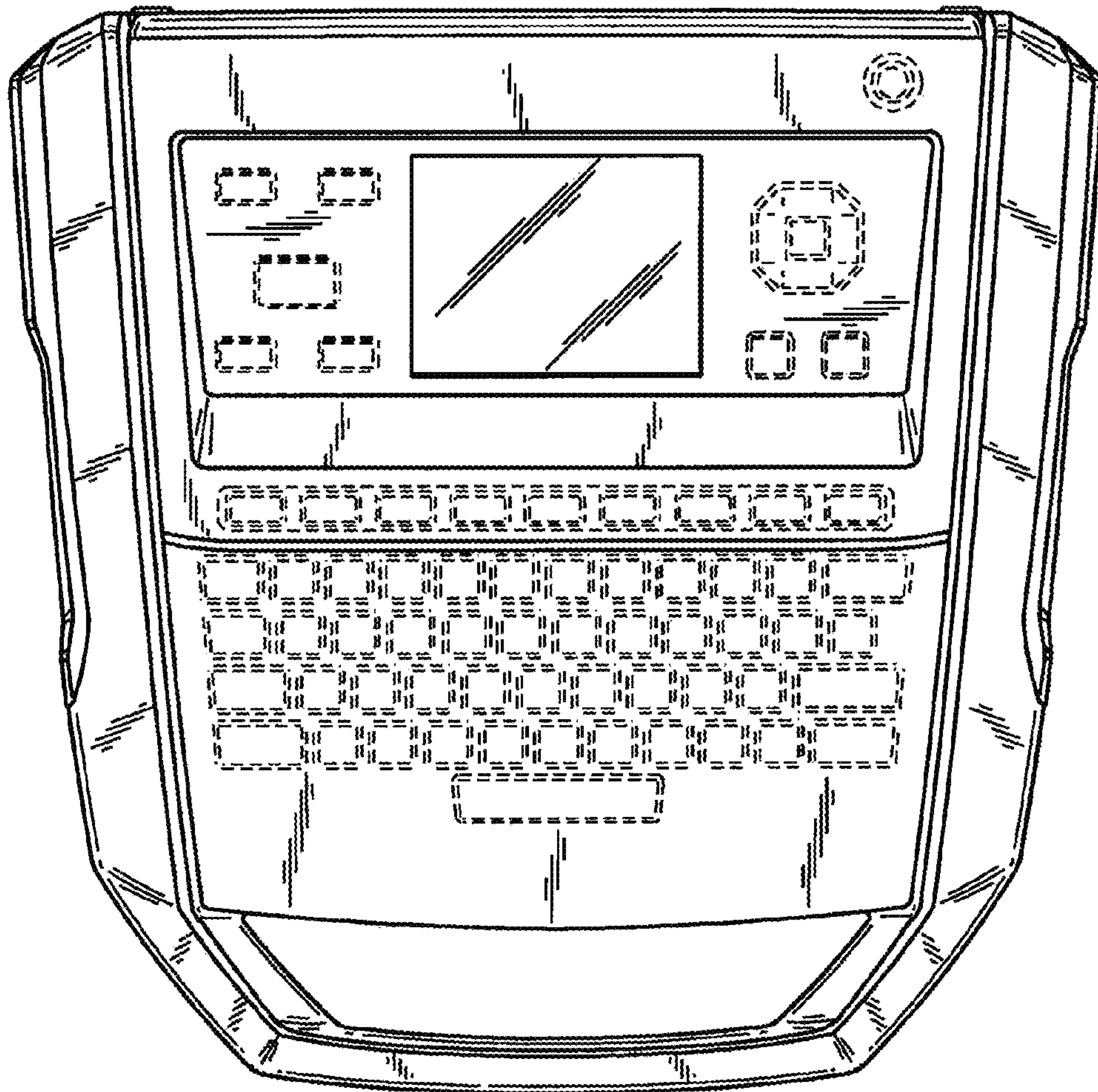

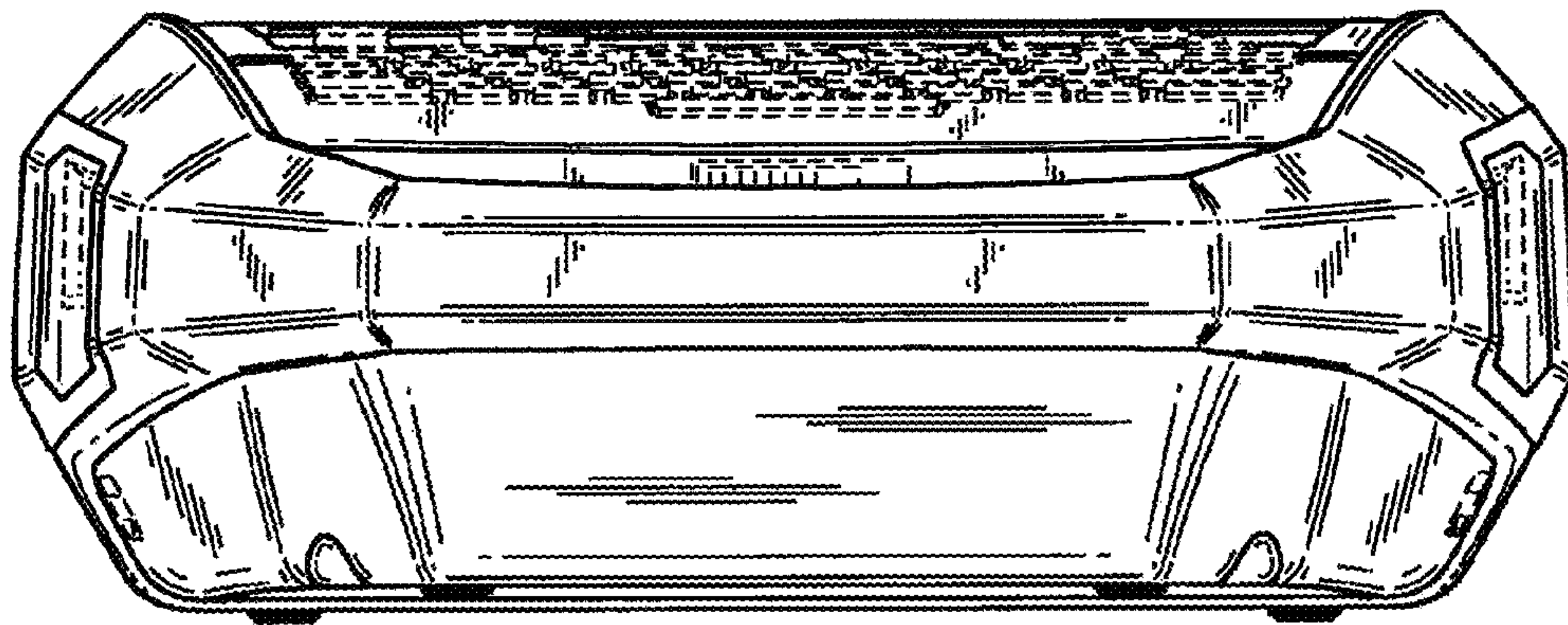

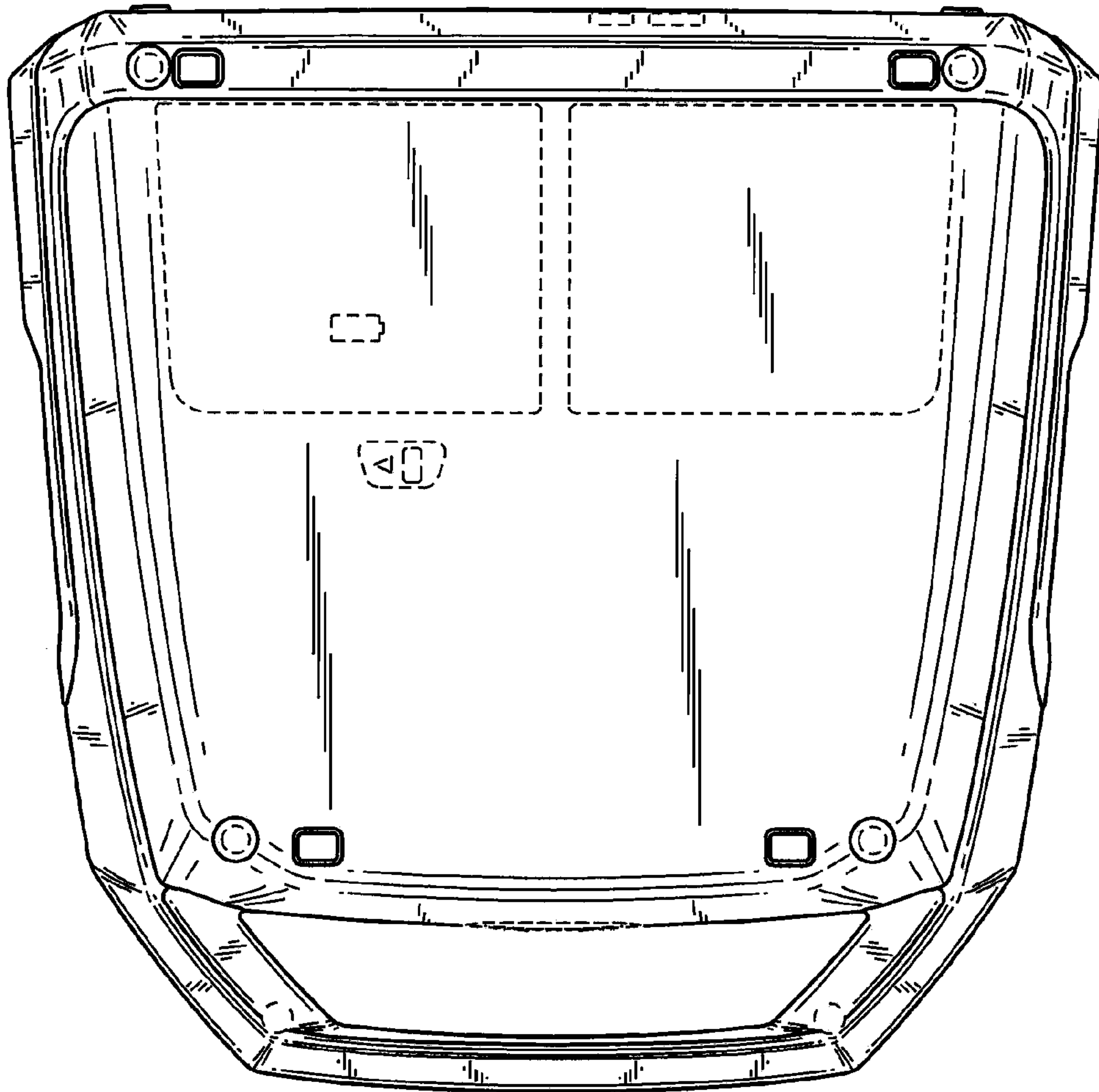

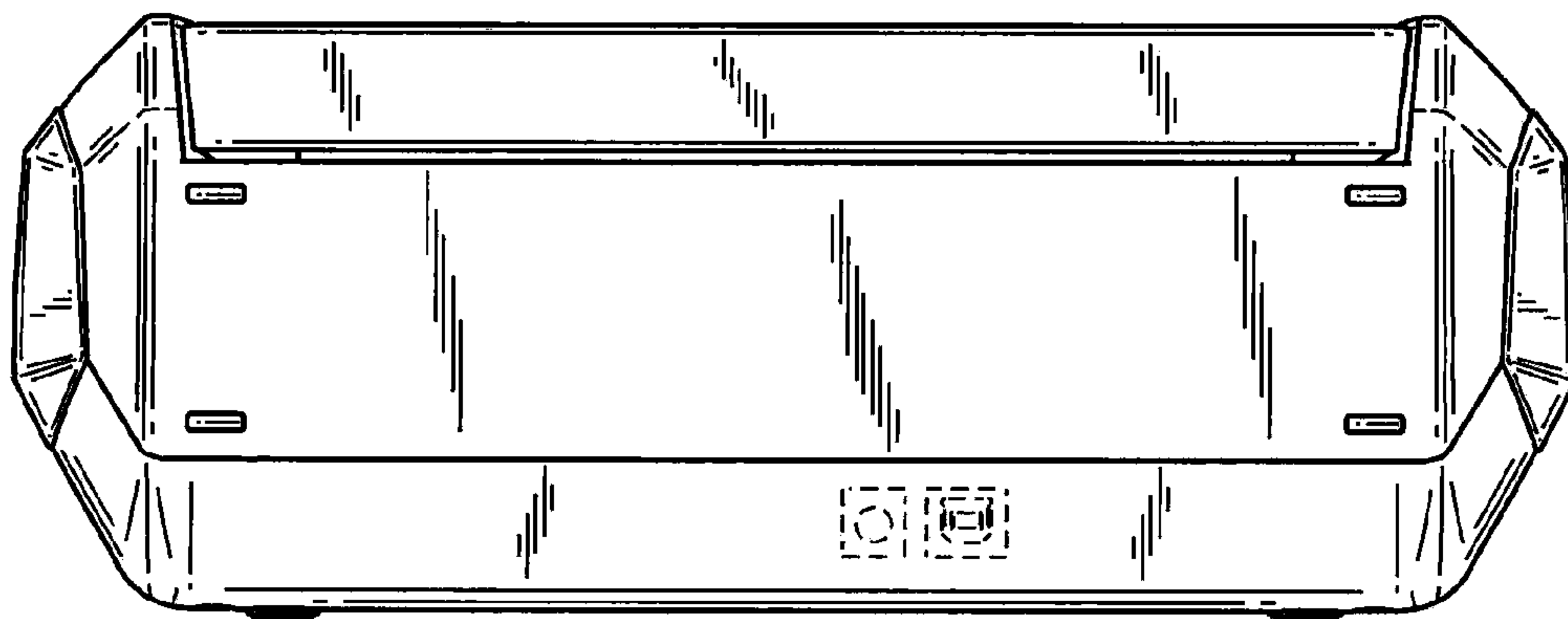

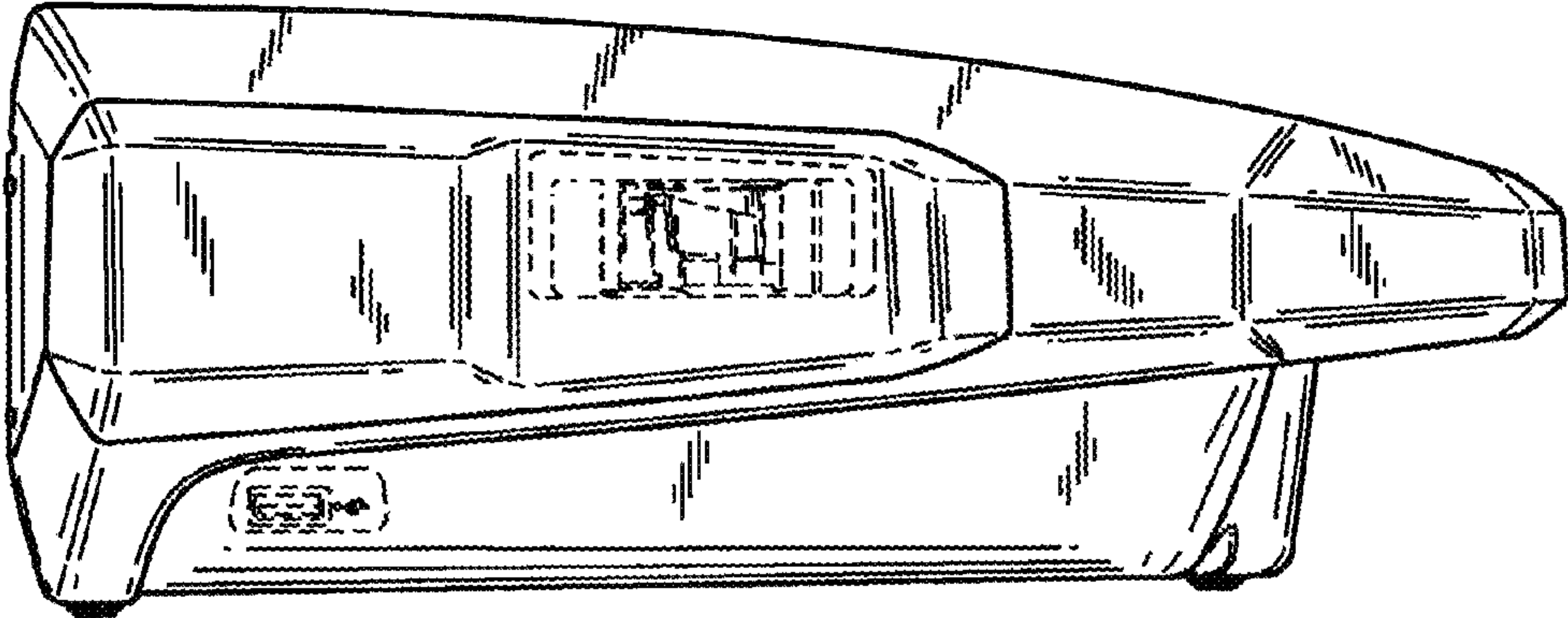

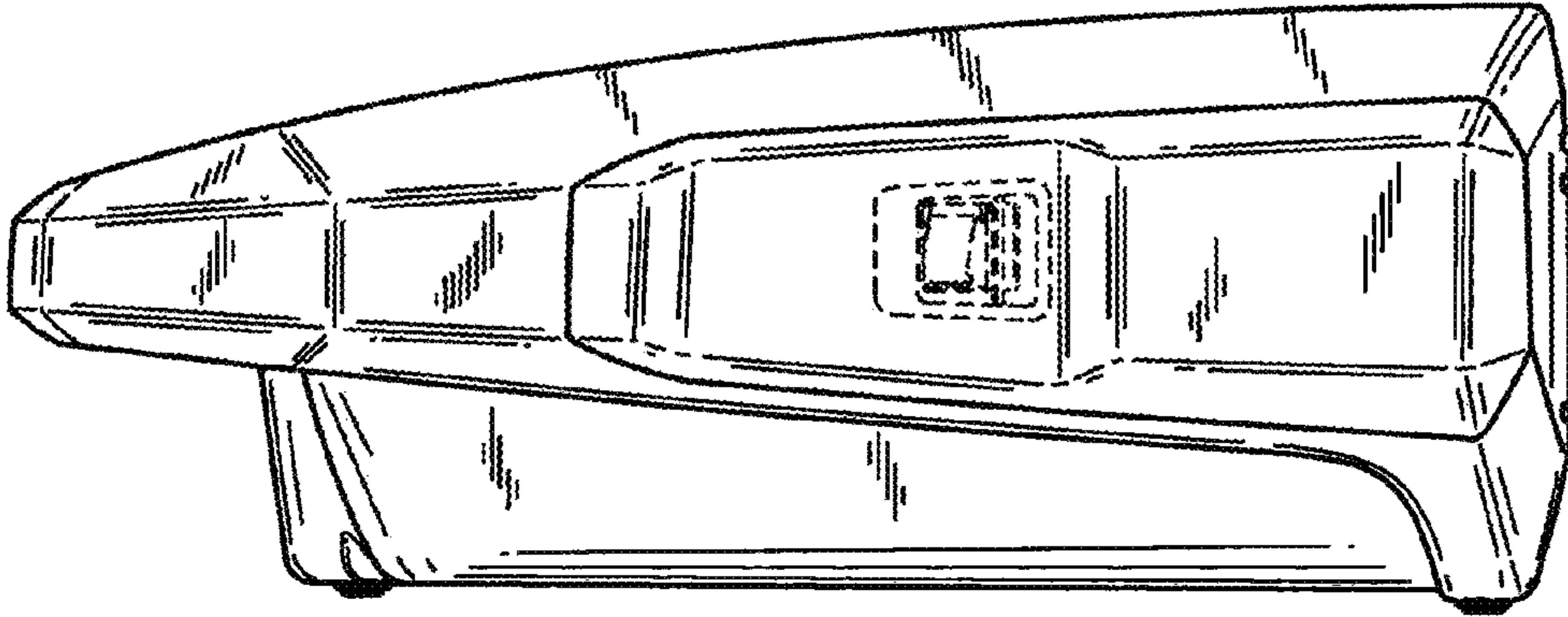
