FIG. 5 is a top end view thereof;

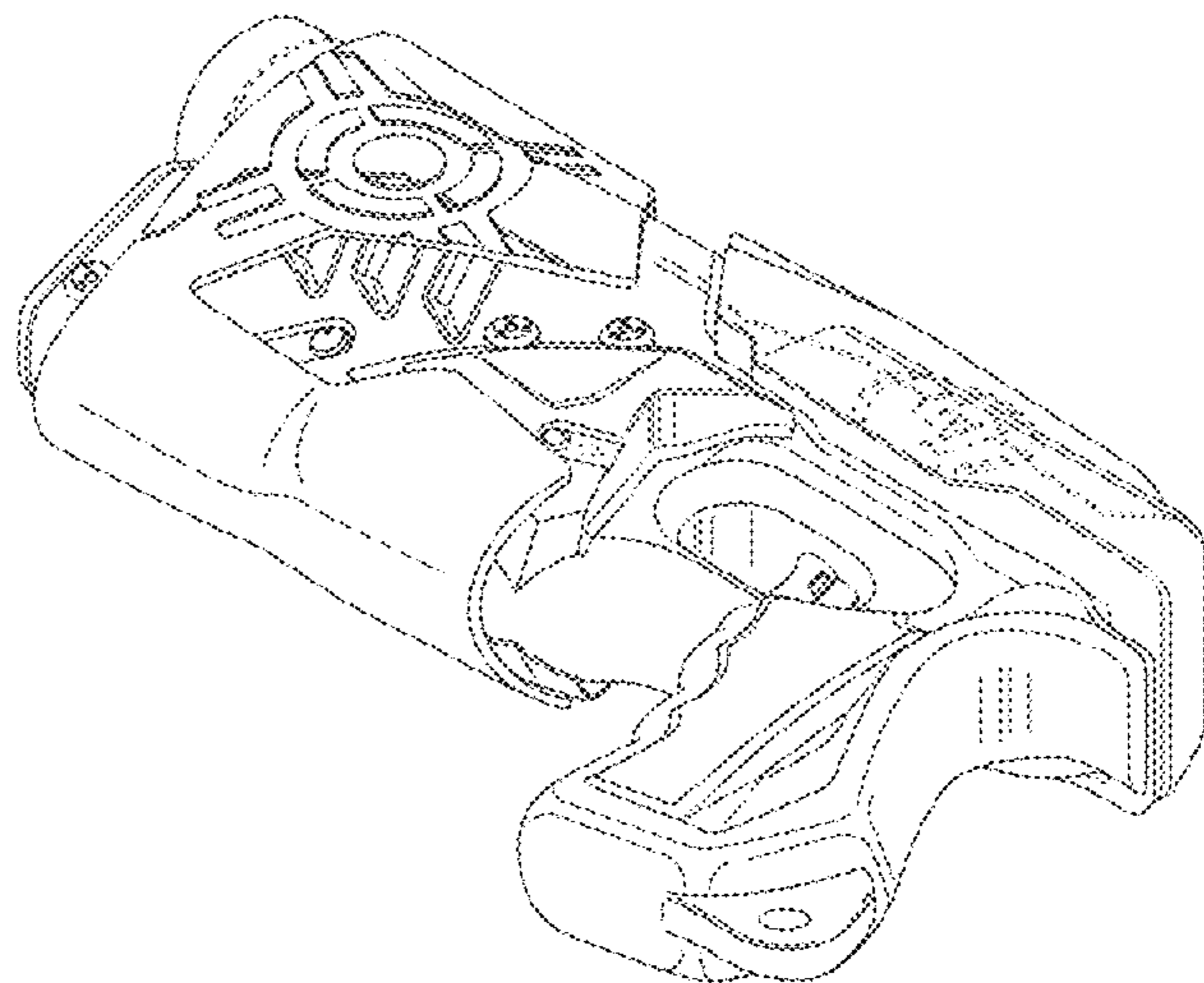
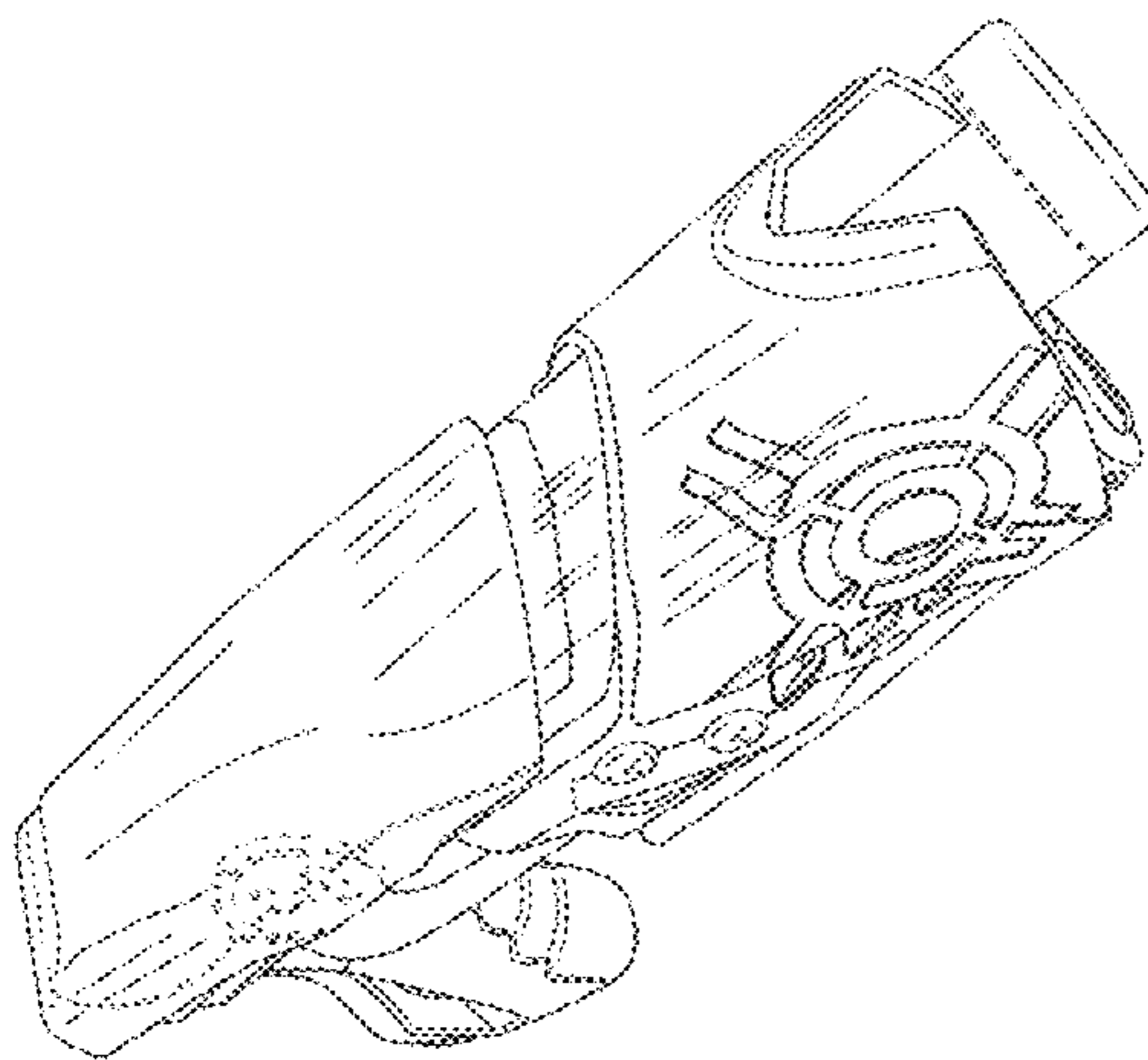
FIG. 6 is a bottom end view thereof;

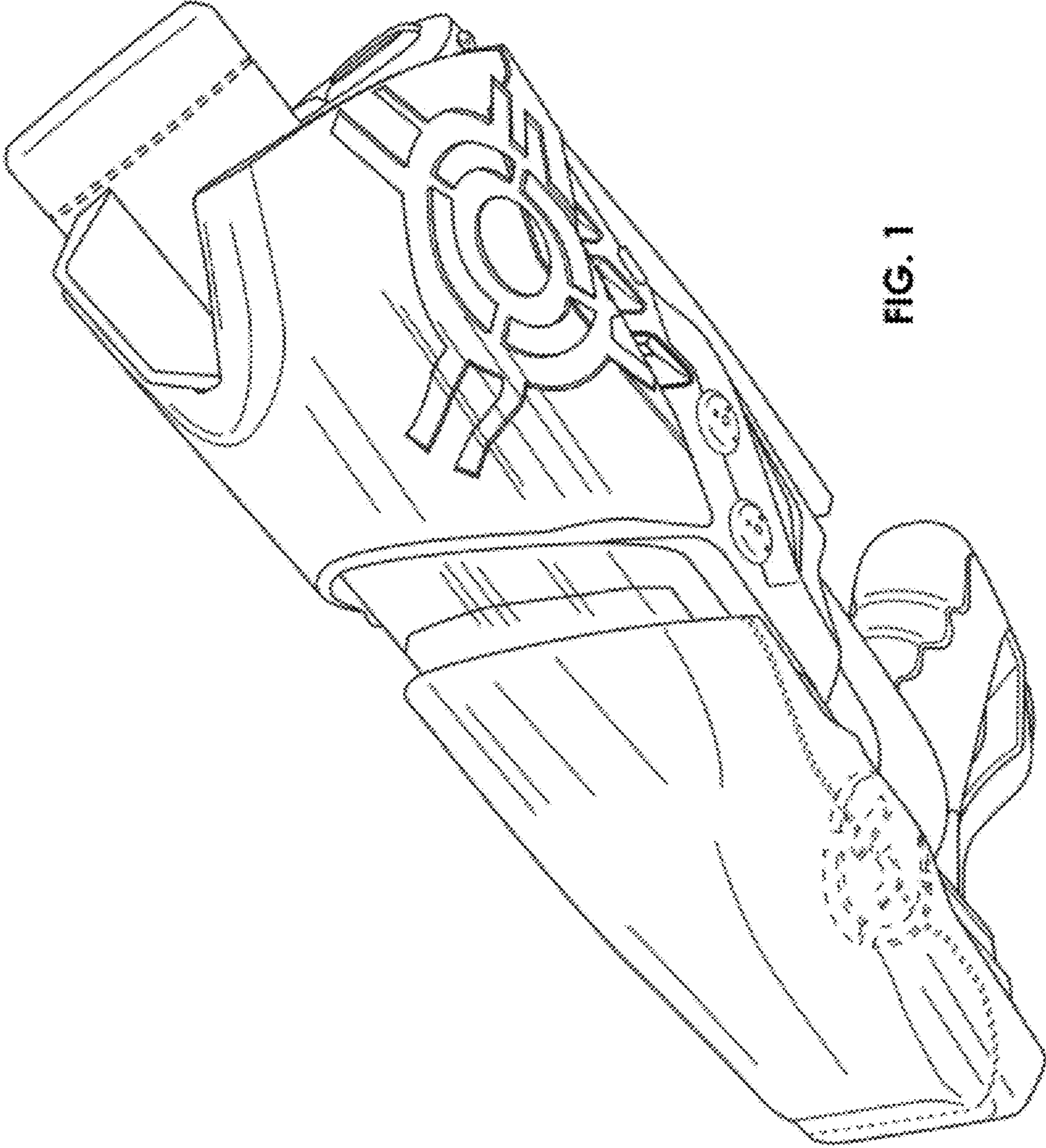

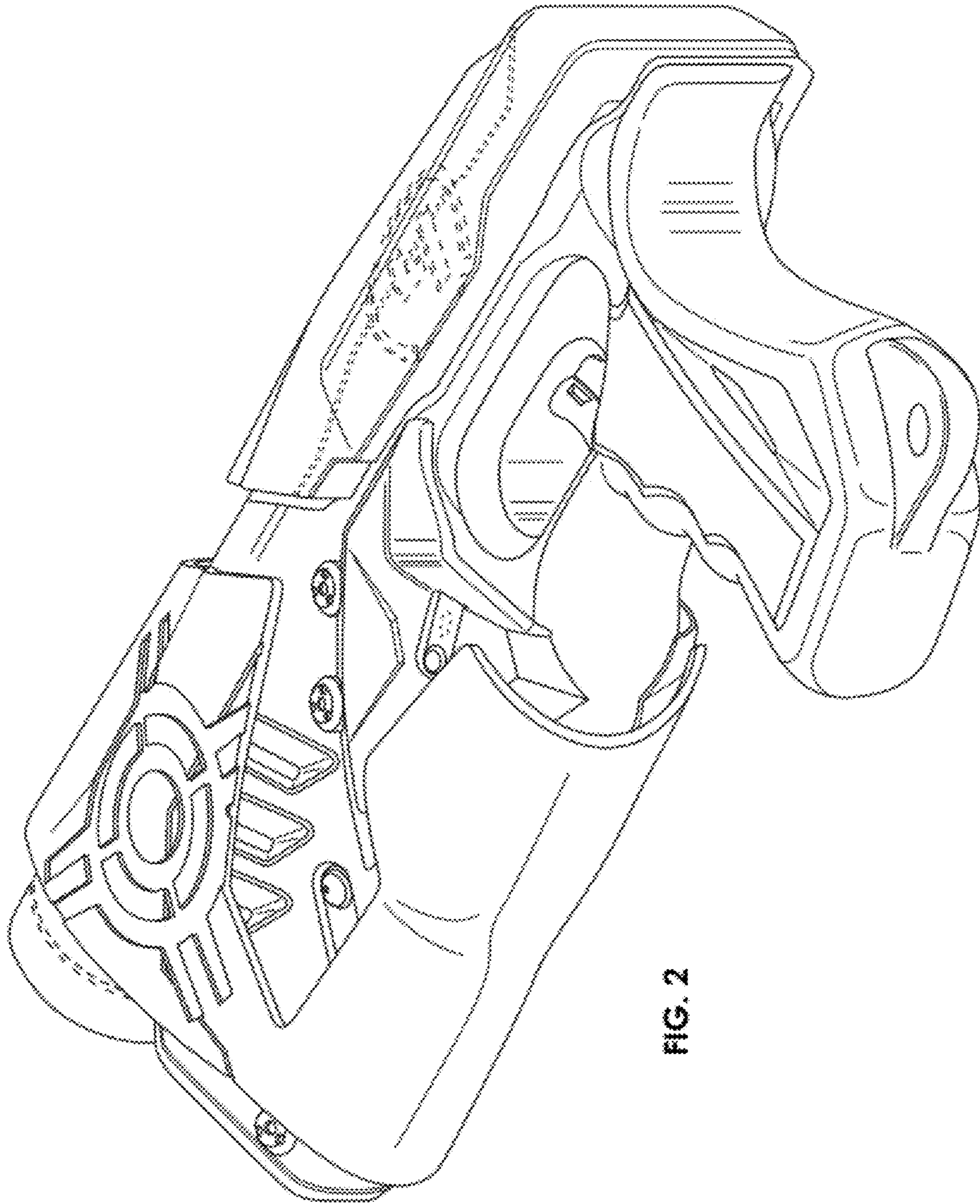

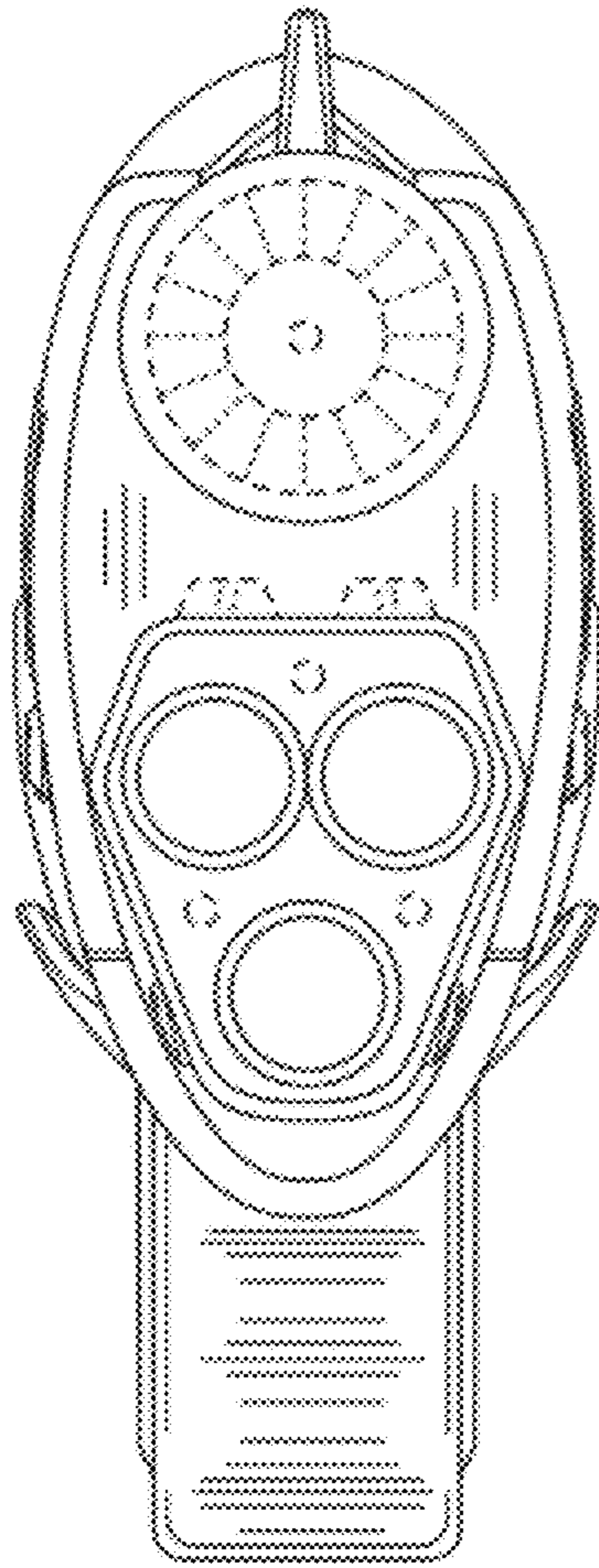

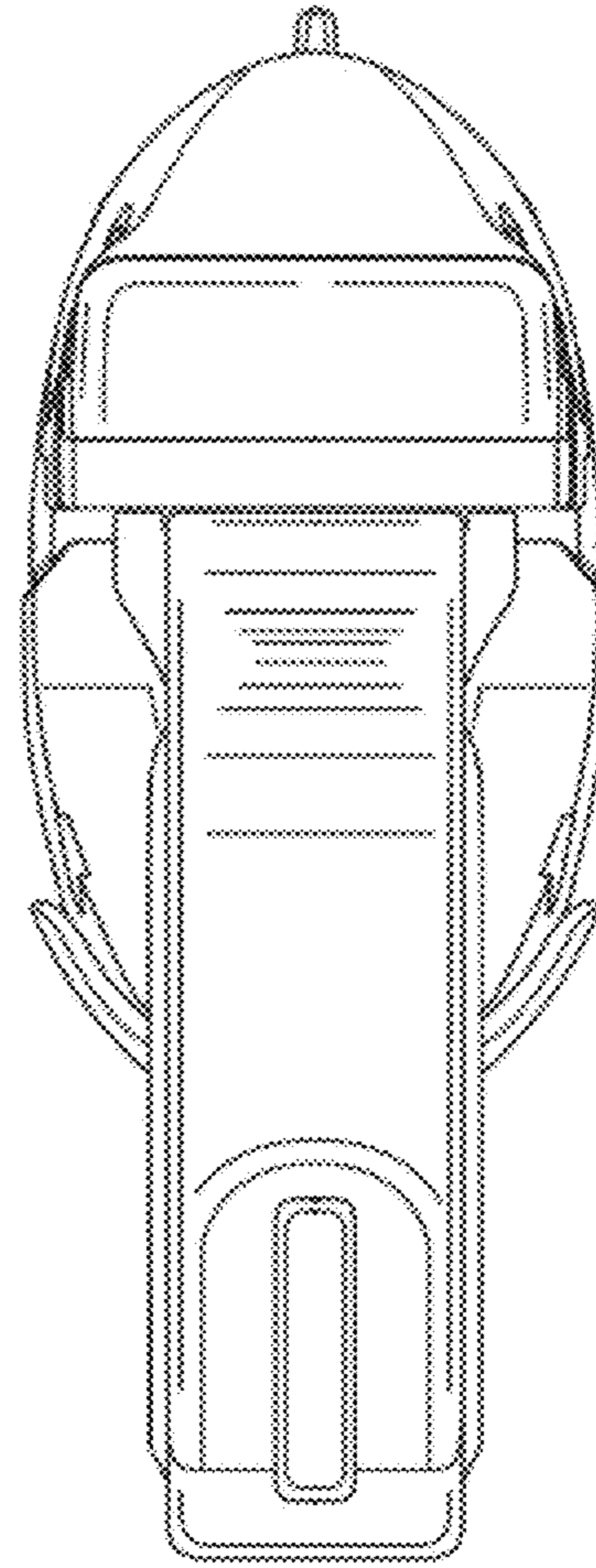

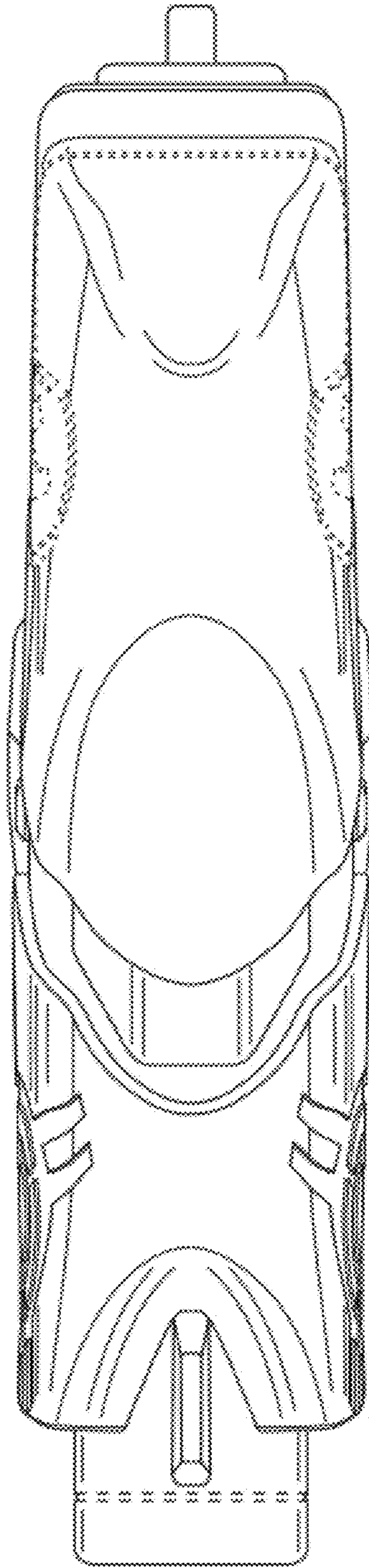

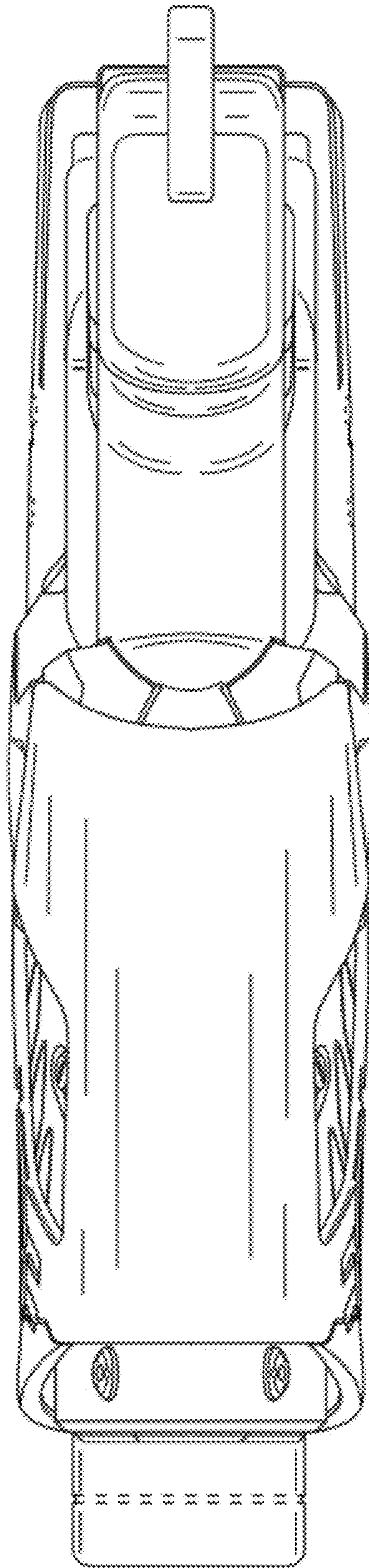

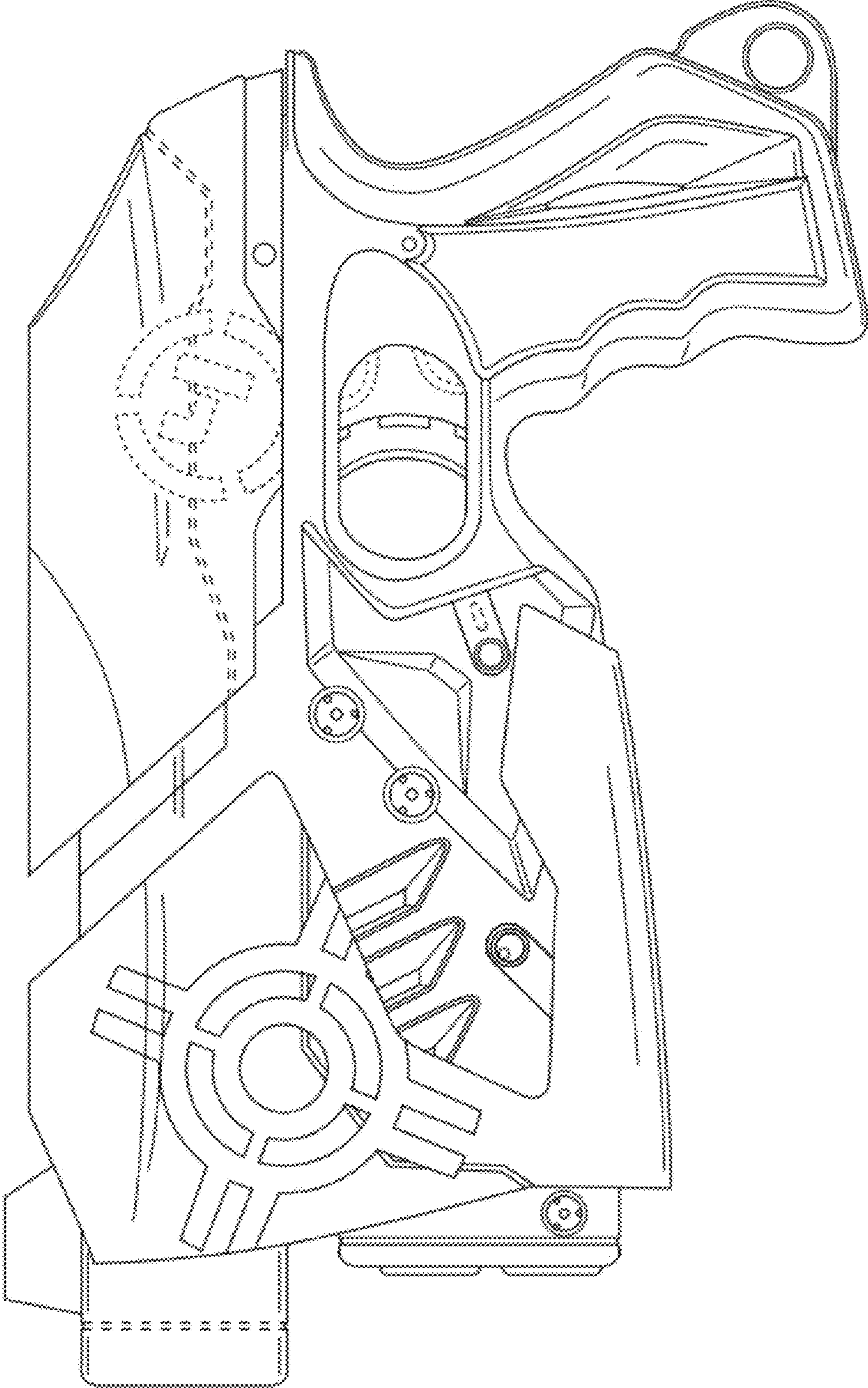

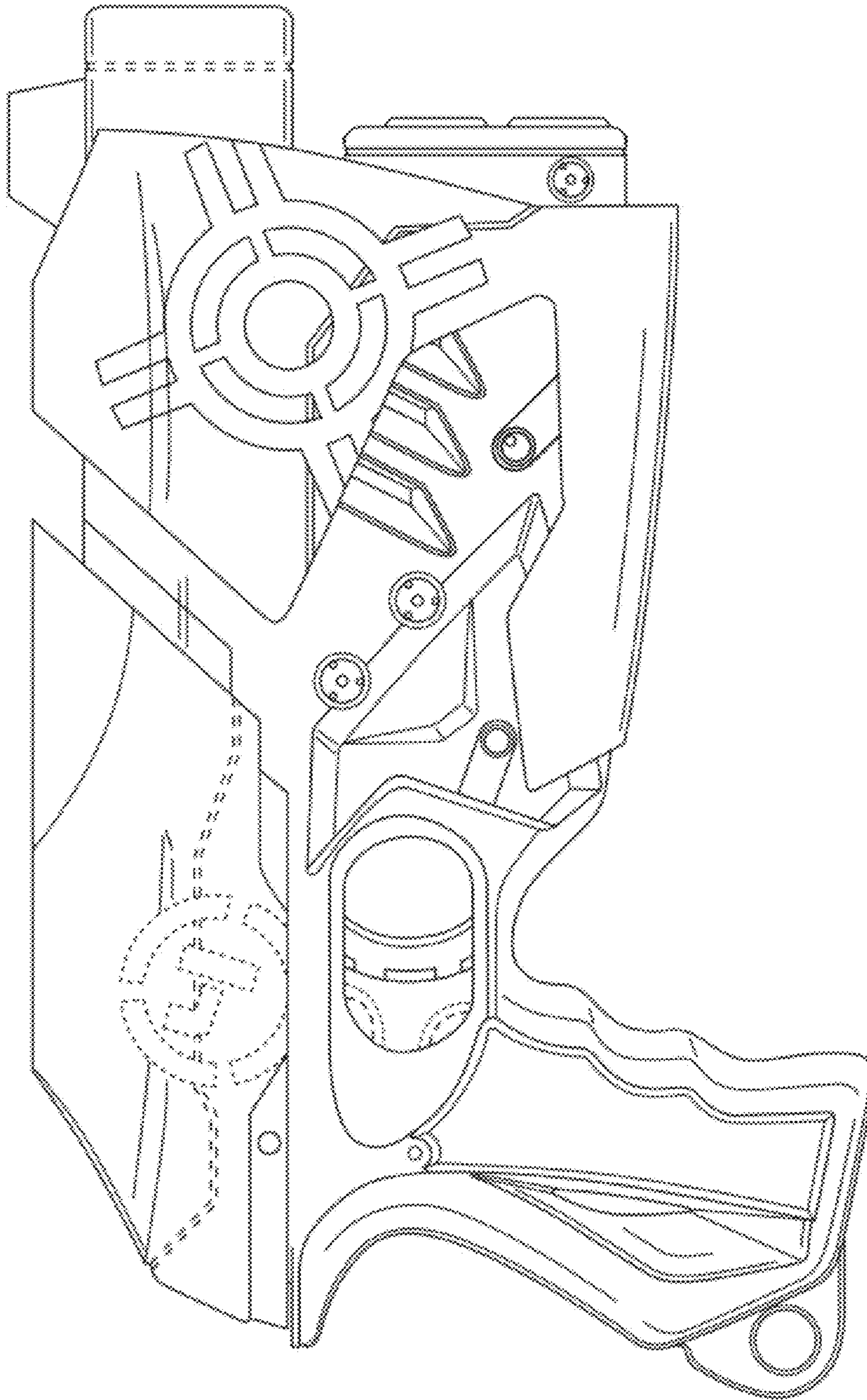
