(57) **CLAIM**

The ornamental design for an outdoor playground fitness equipment, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of an outdoor playground fitness equipment, showing my design;

FIG. 2 is a rear elevation view of the outdoor playground fitness equipment of FIG. 1;

FIG. 3 is a left side elevation view of the outdoor playground fitness equipment of FIG. 1;

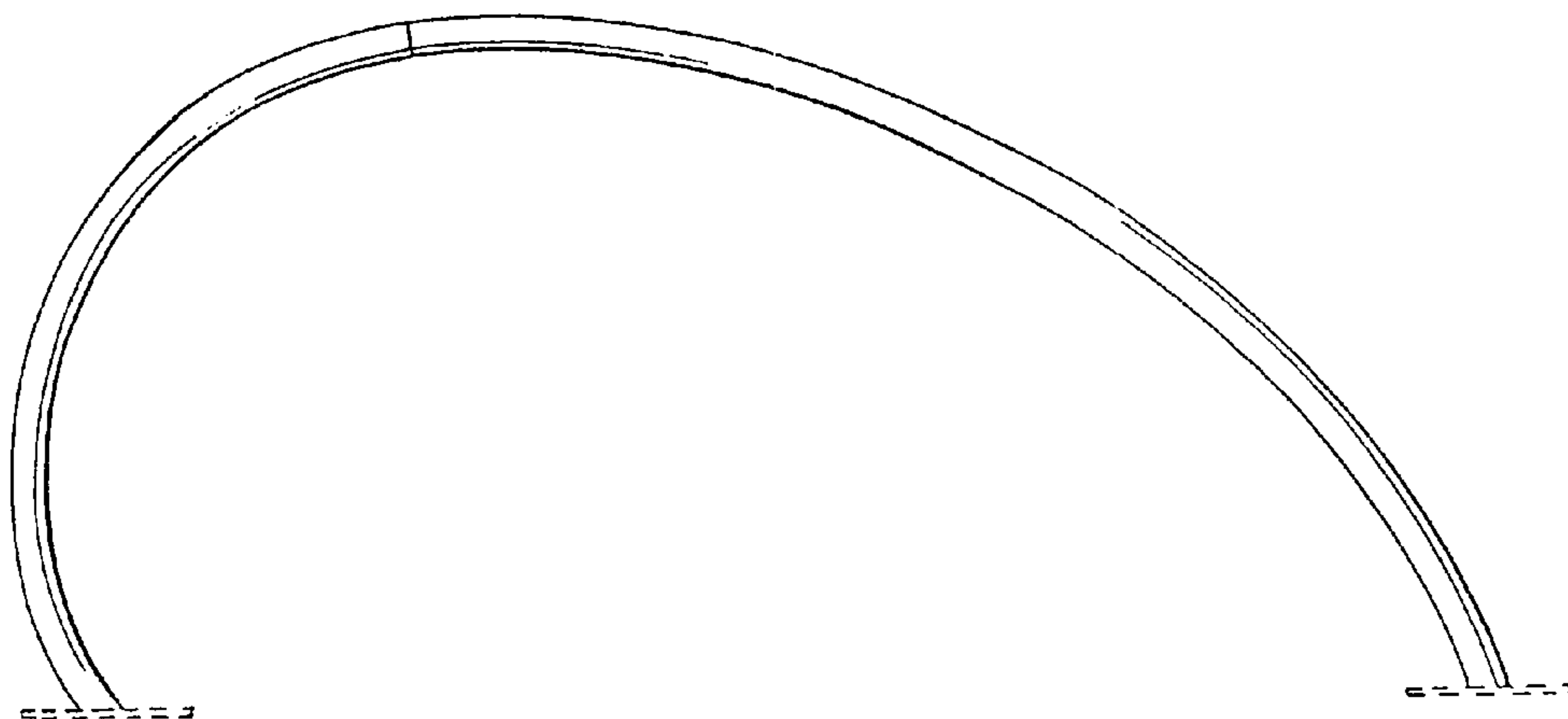

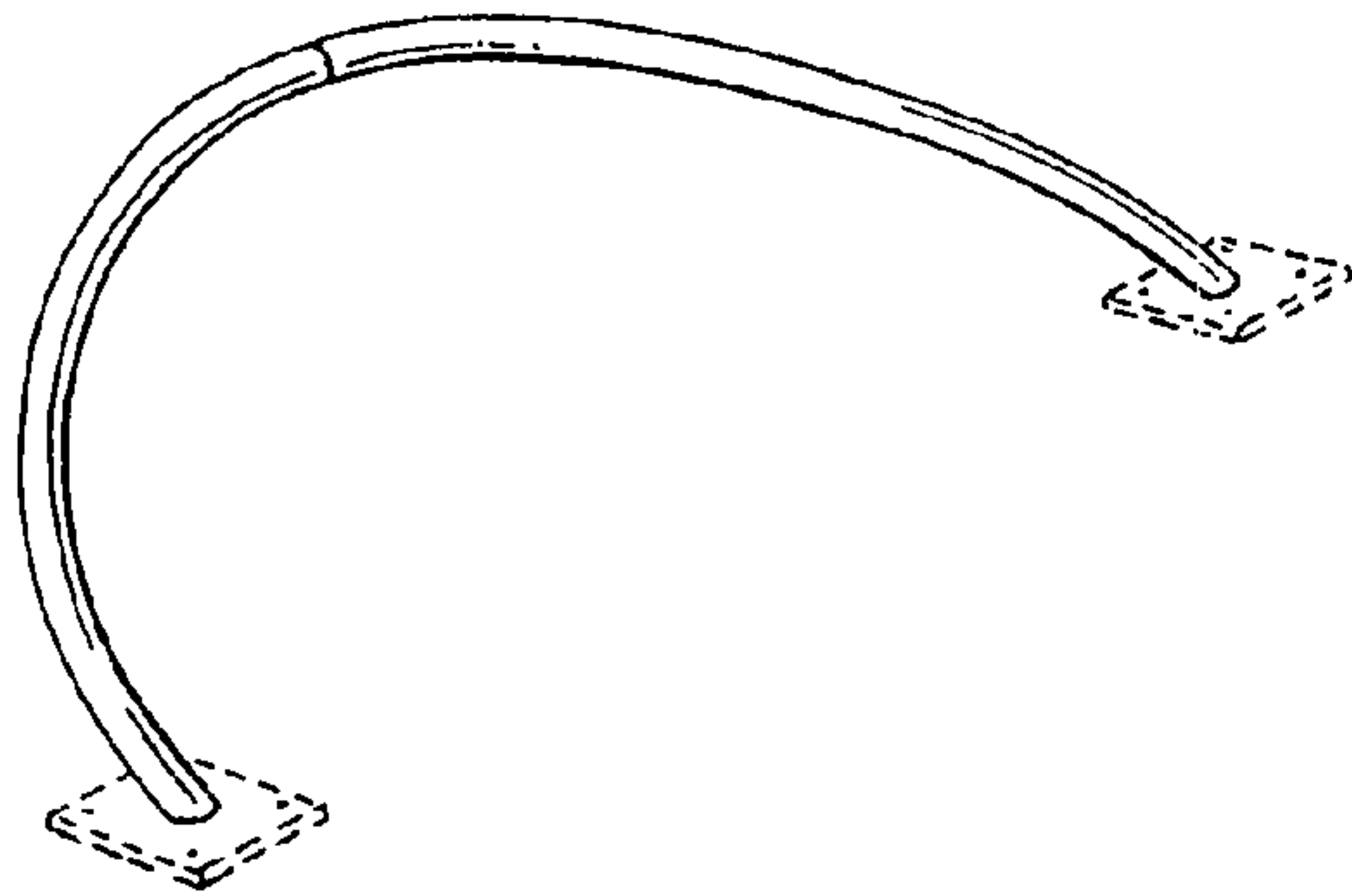

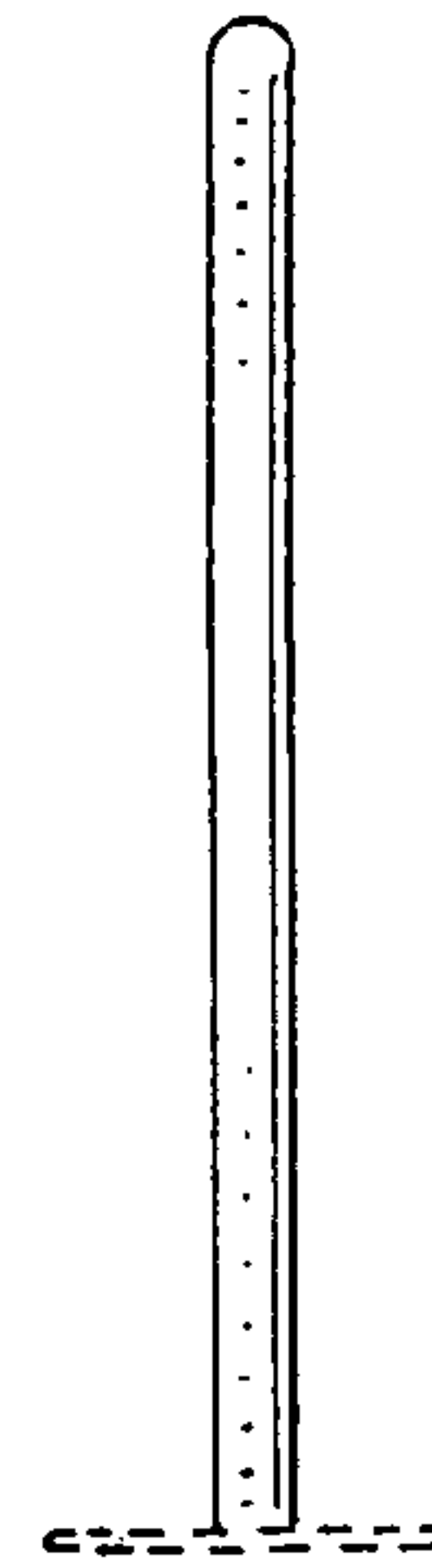

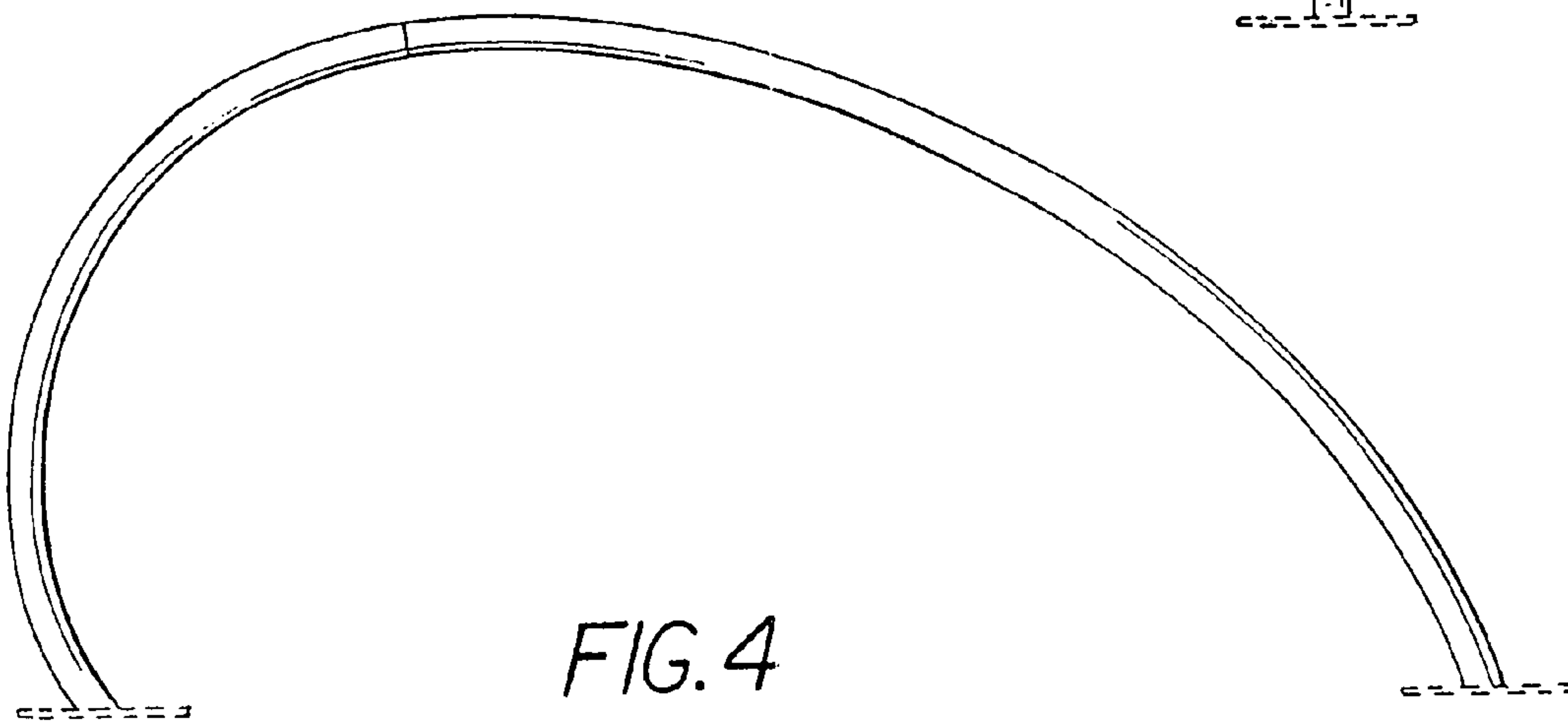

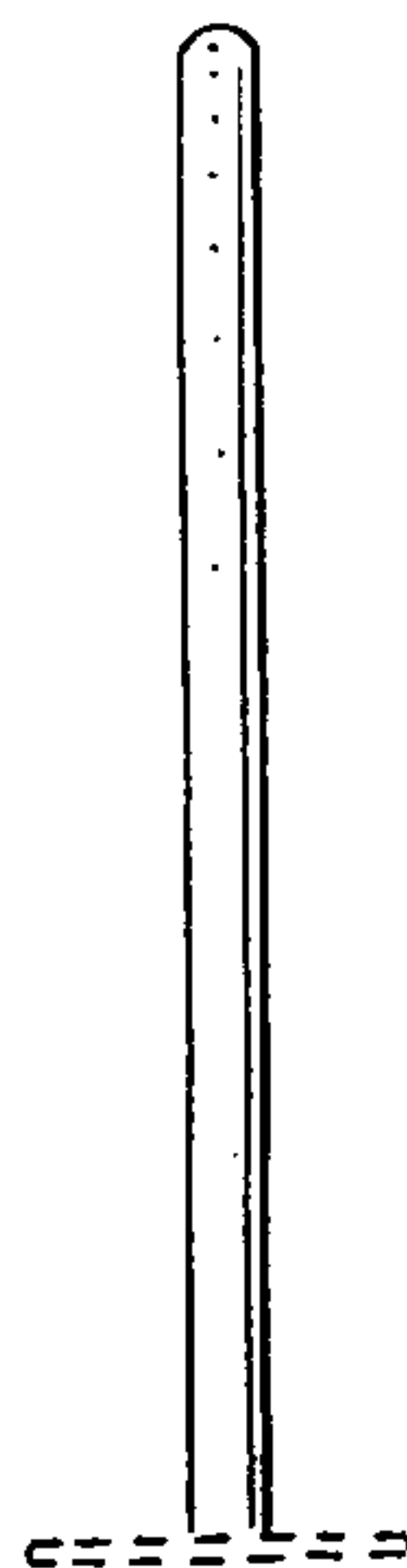

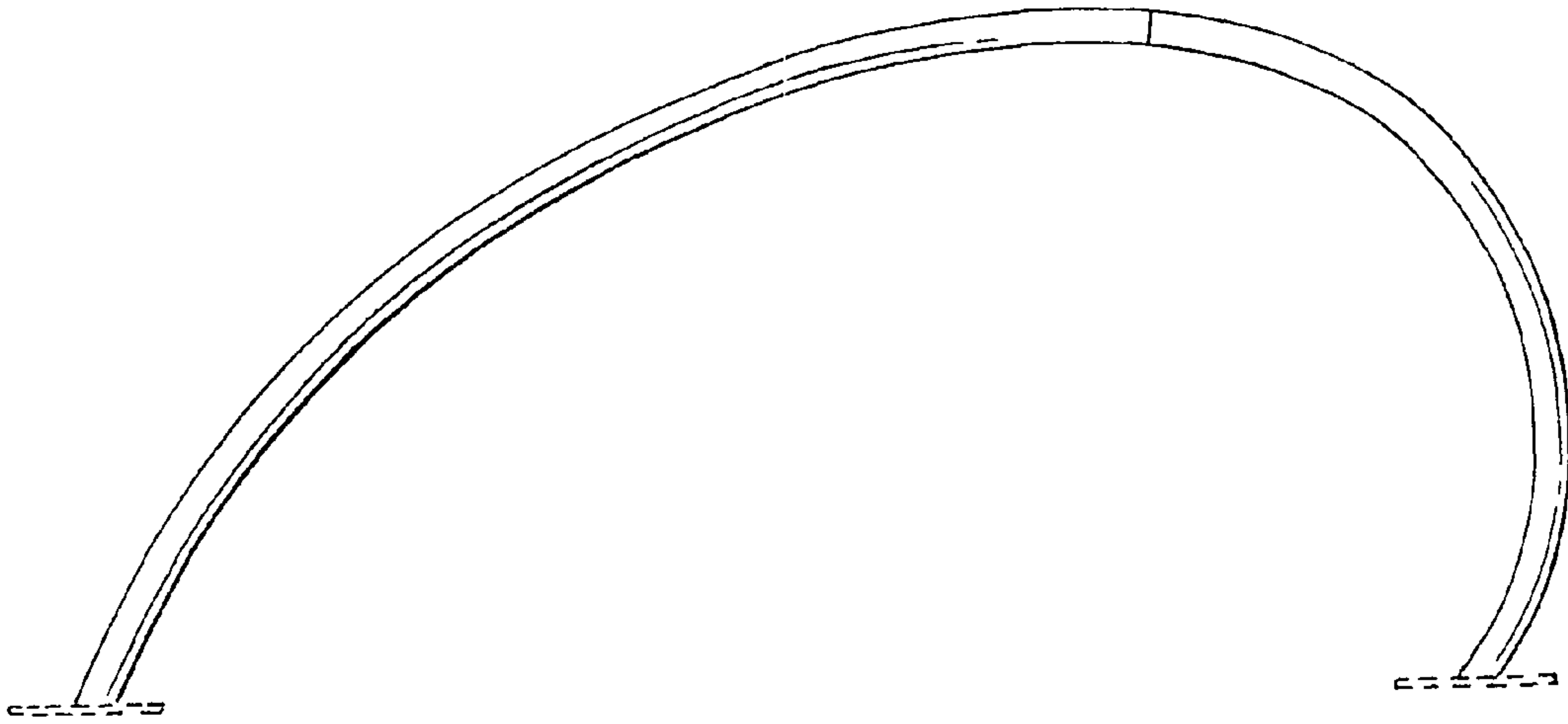

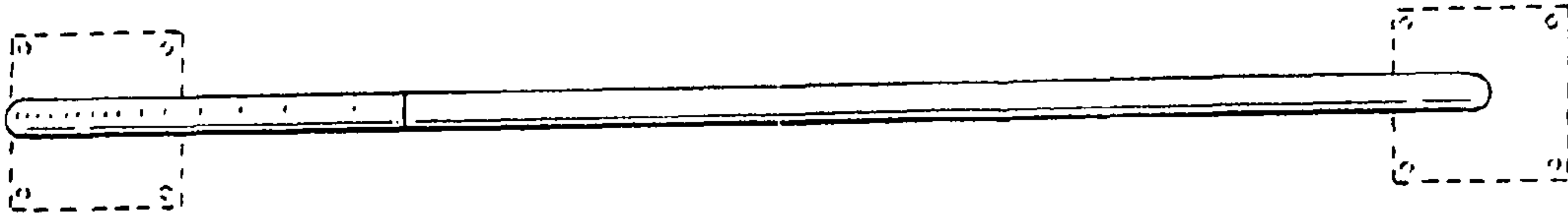
