FIG. 11 is a front perspective view of a third embodiment of the star-shaped light

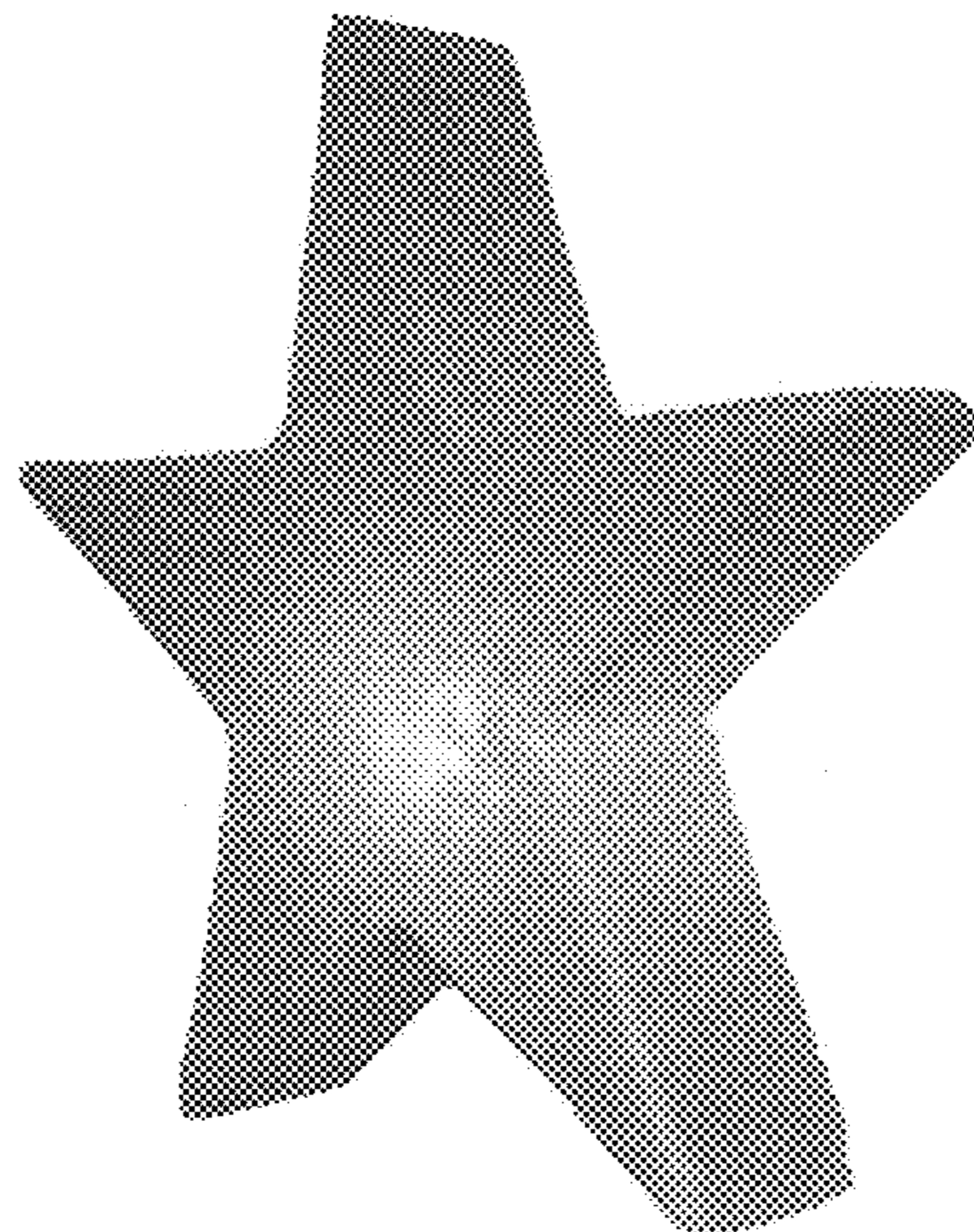
FIG. 12 is a top view thereof;

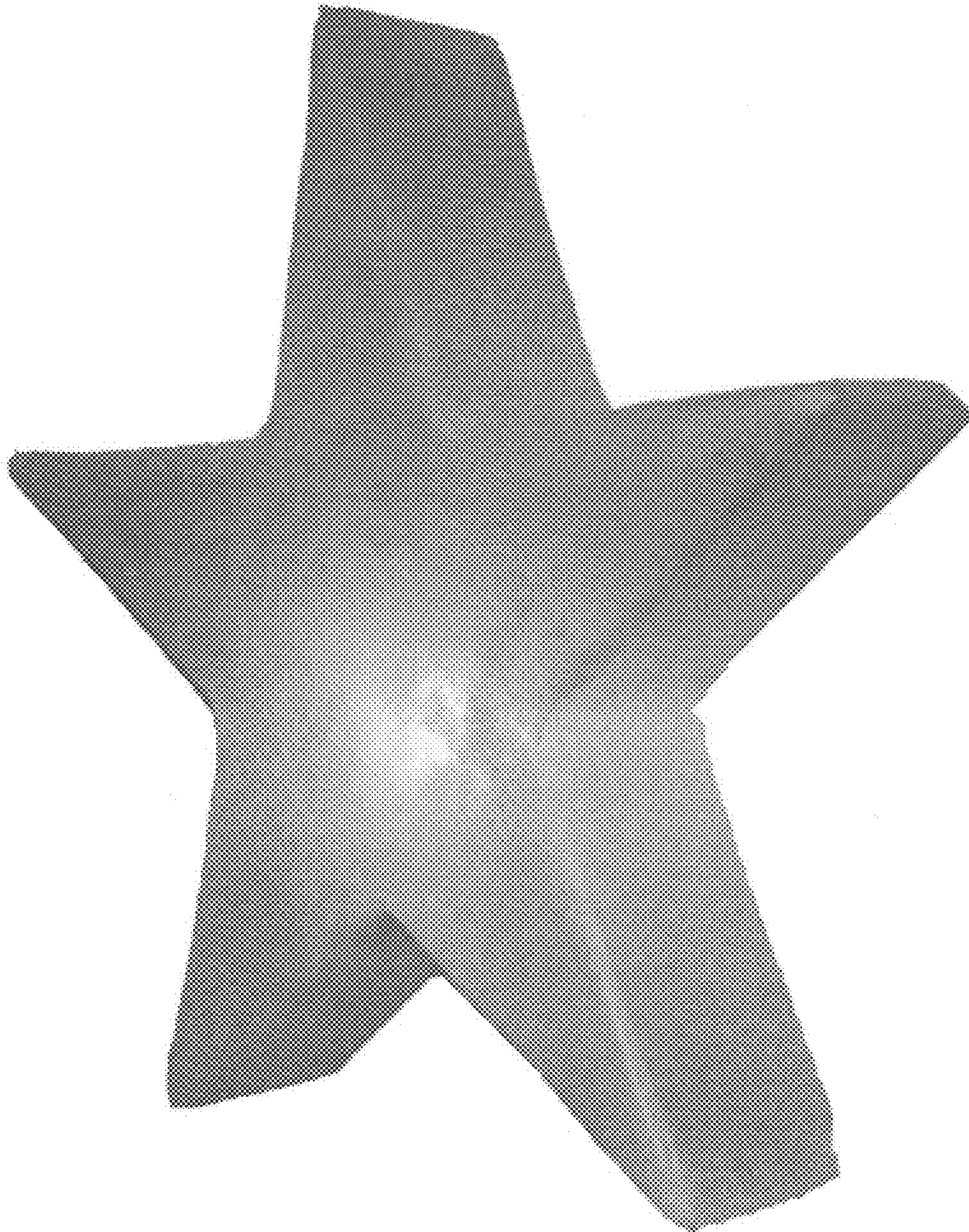

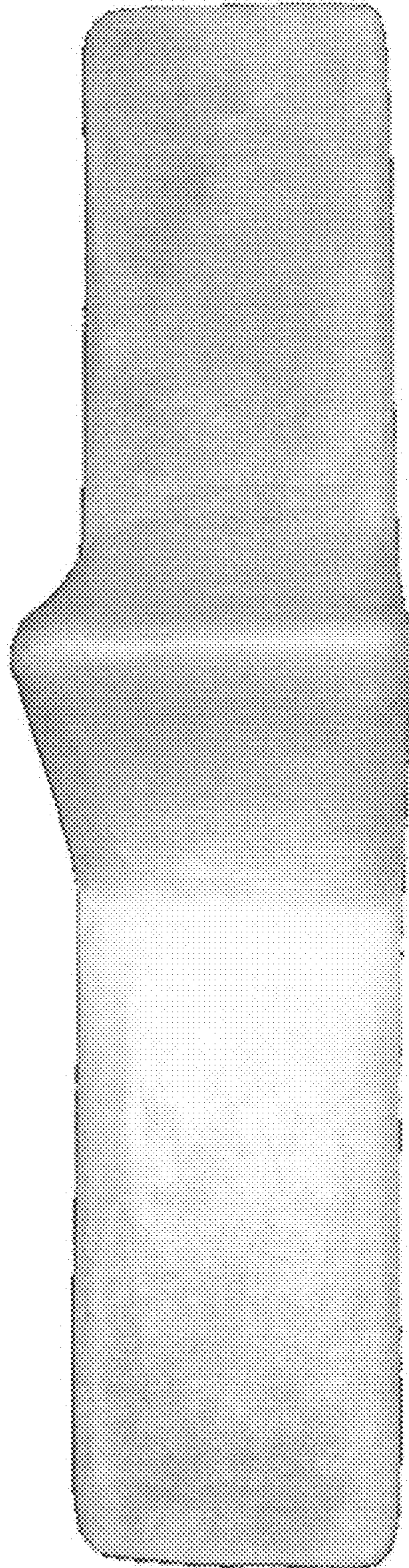

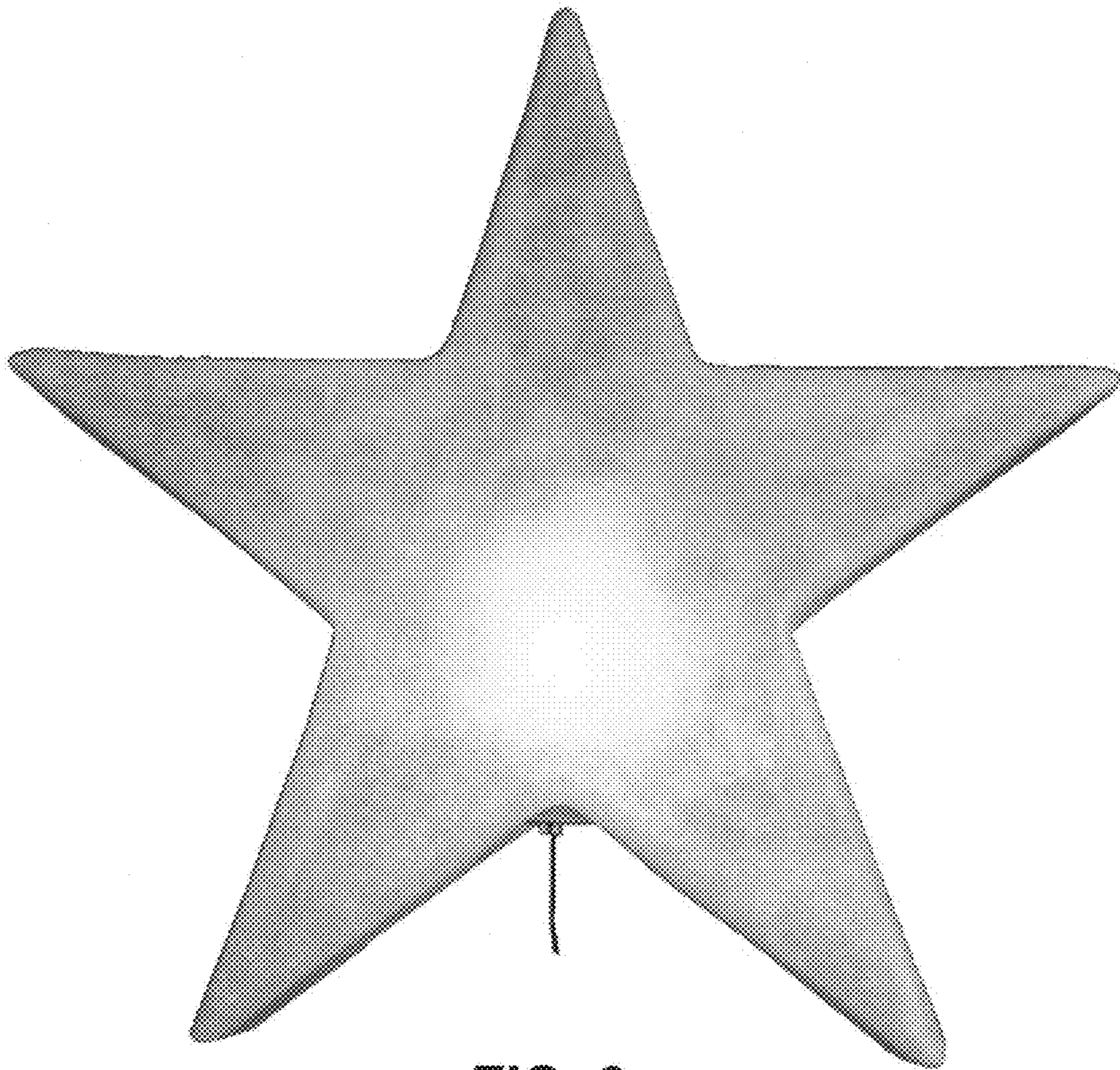

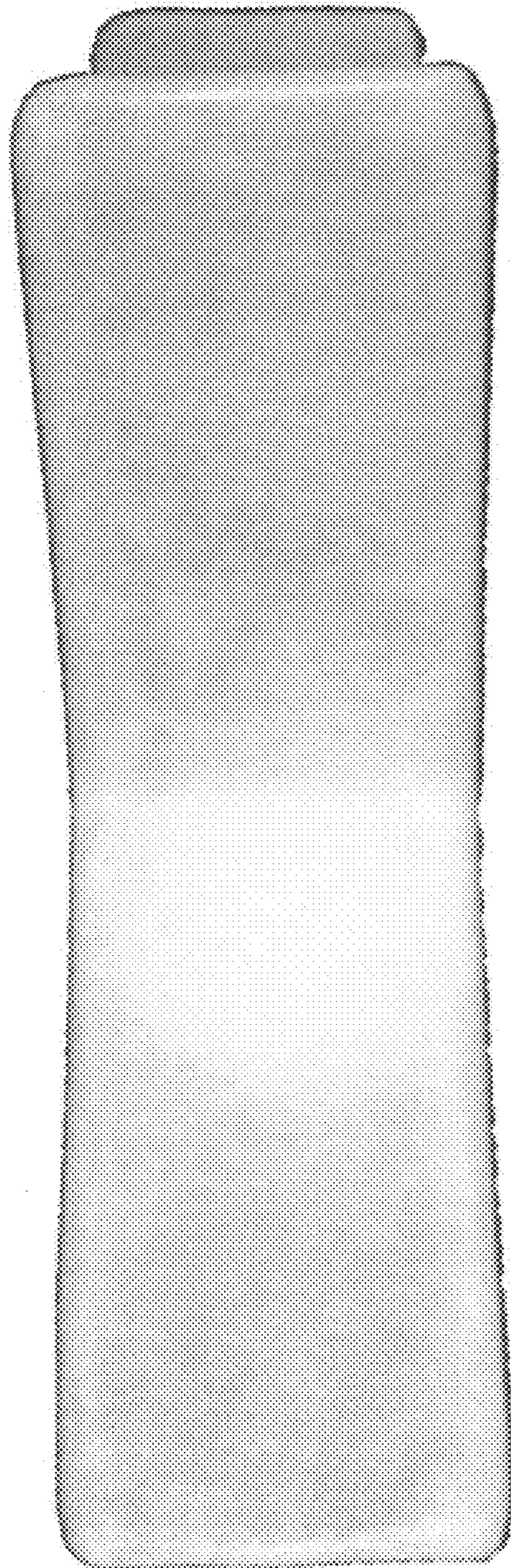

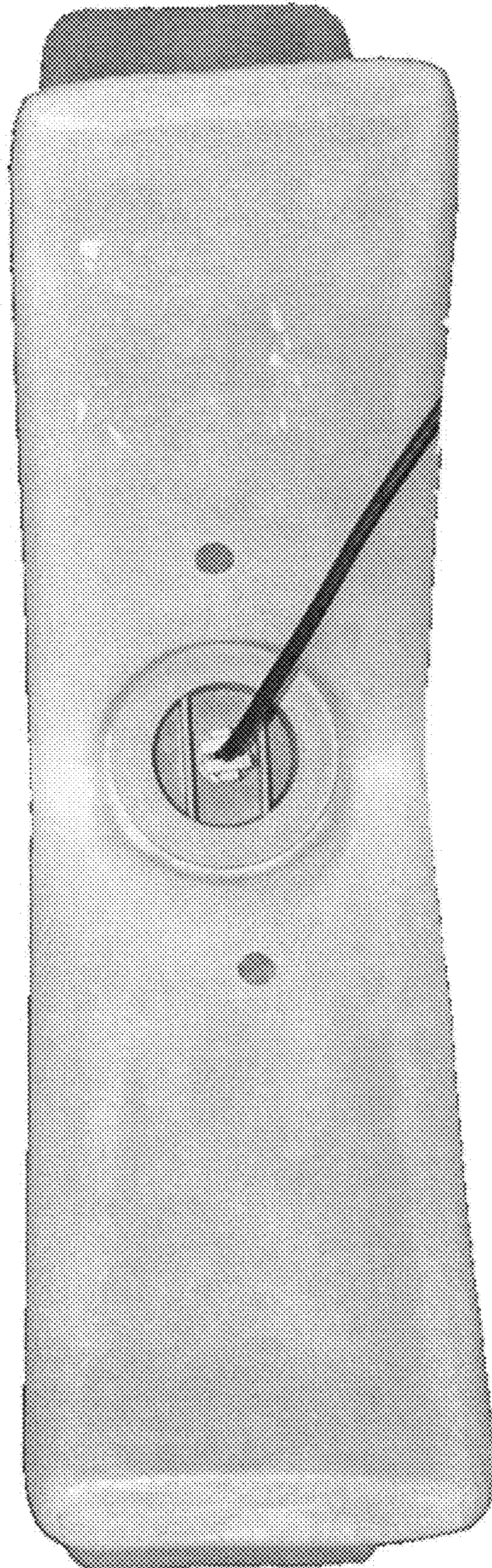

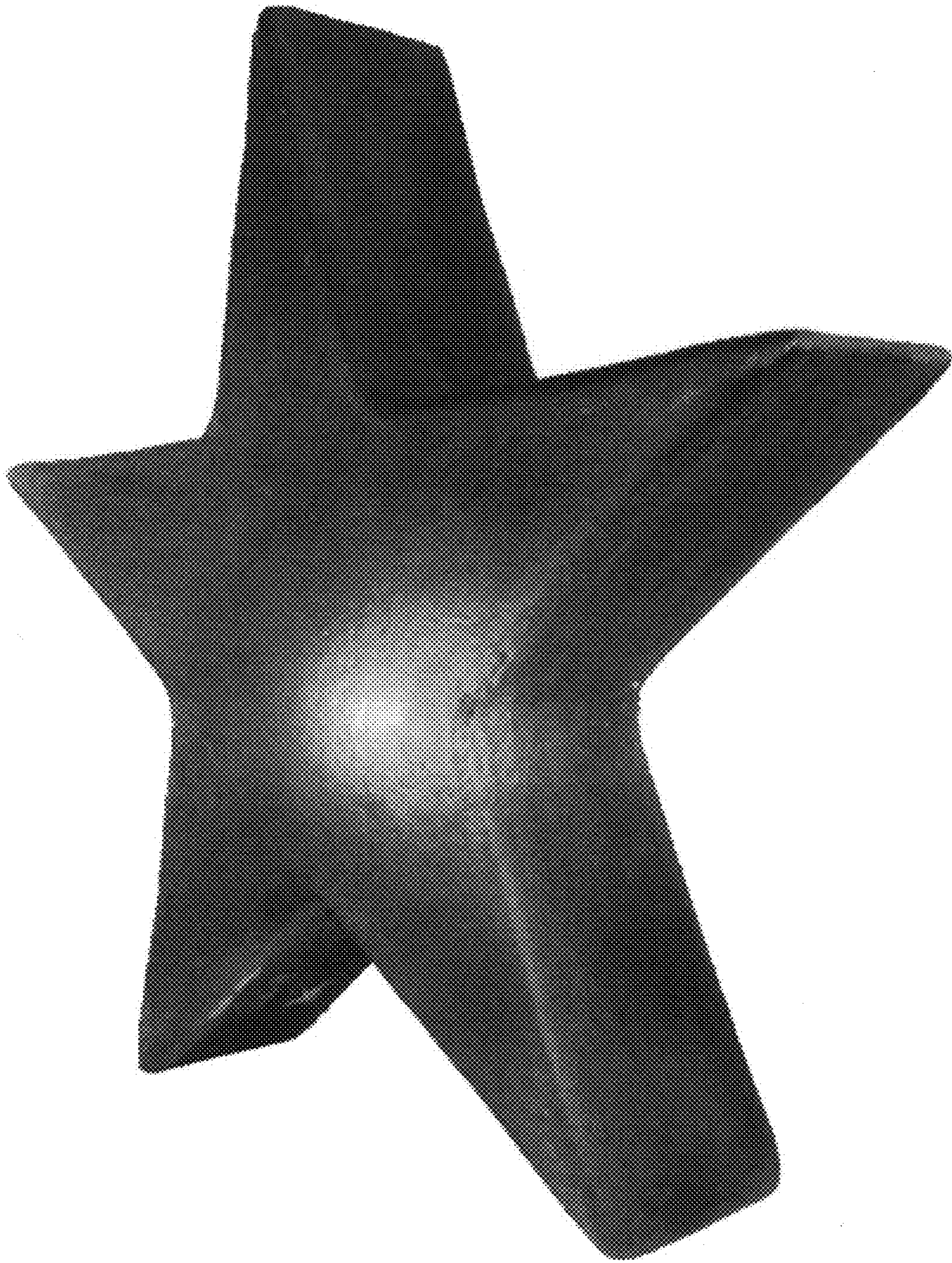

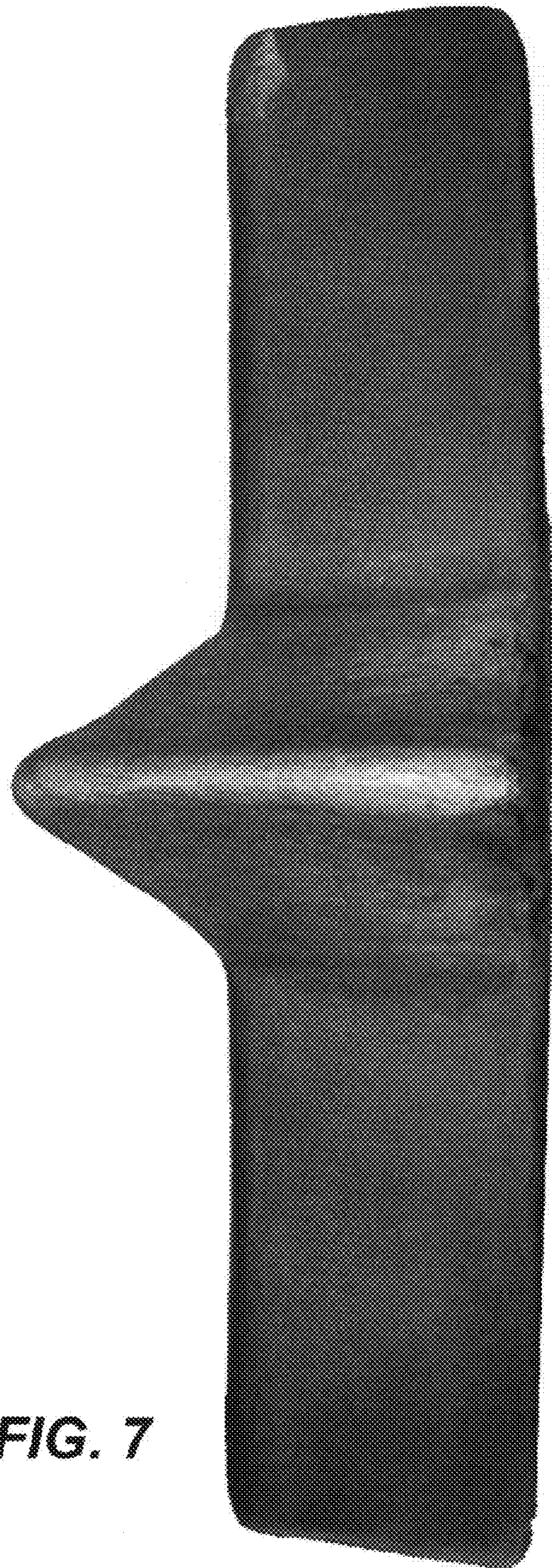

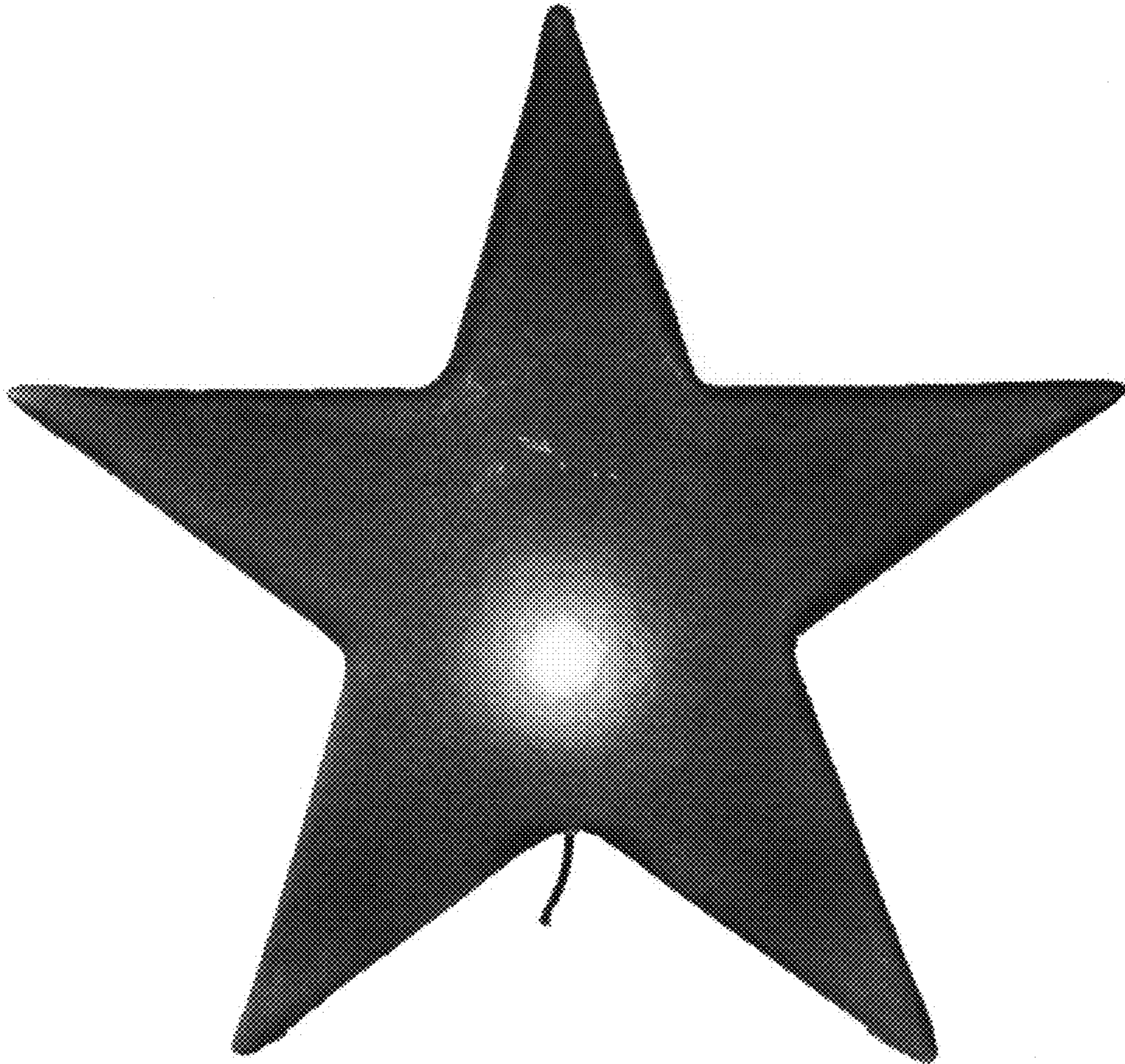

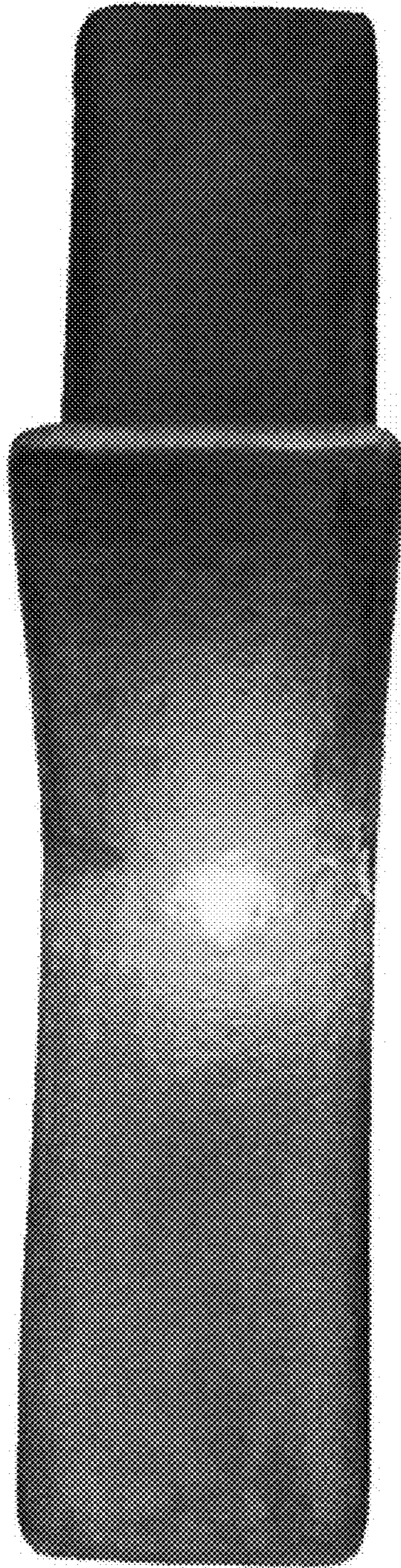

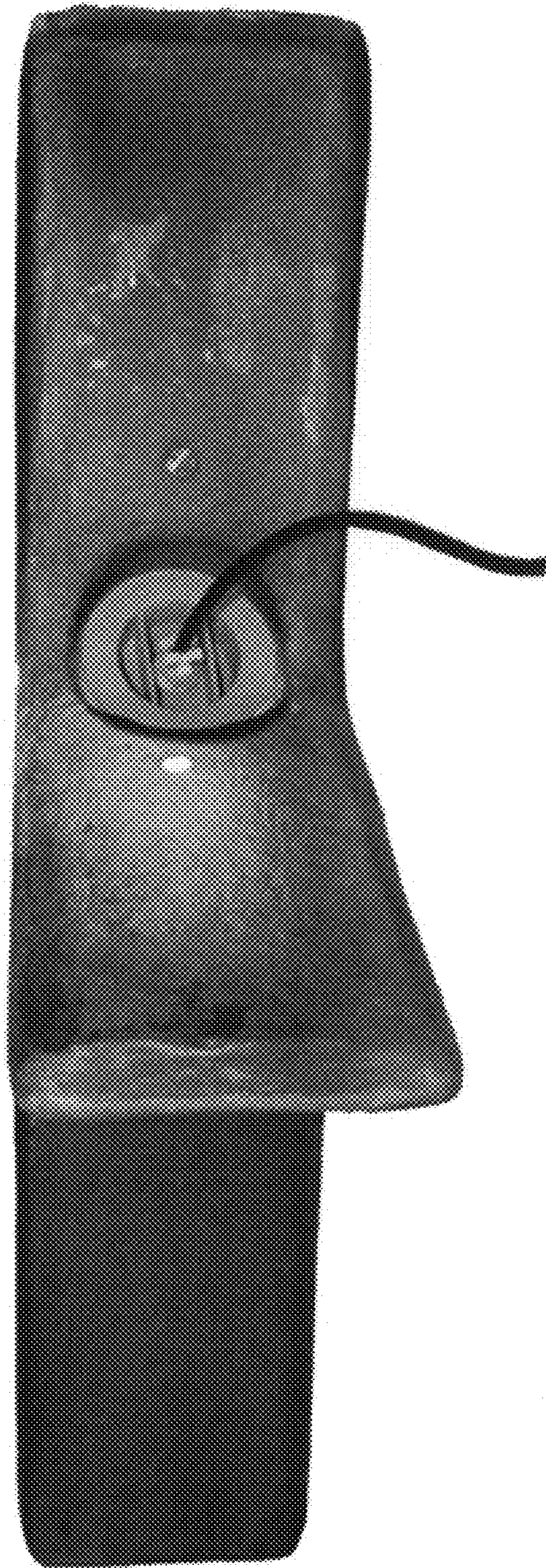

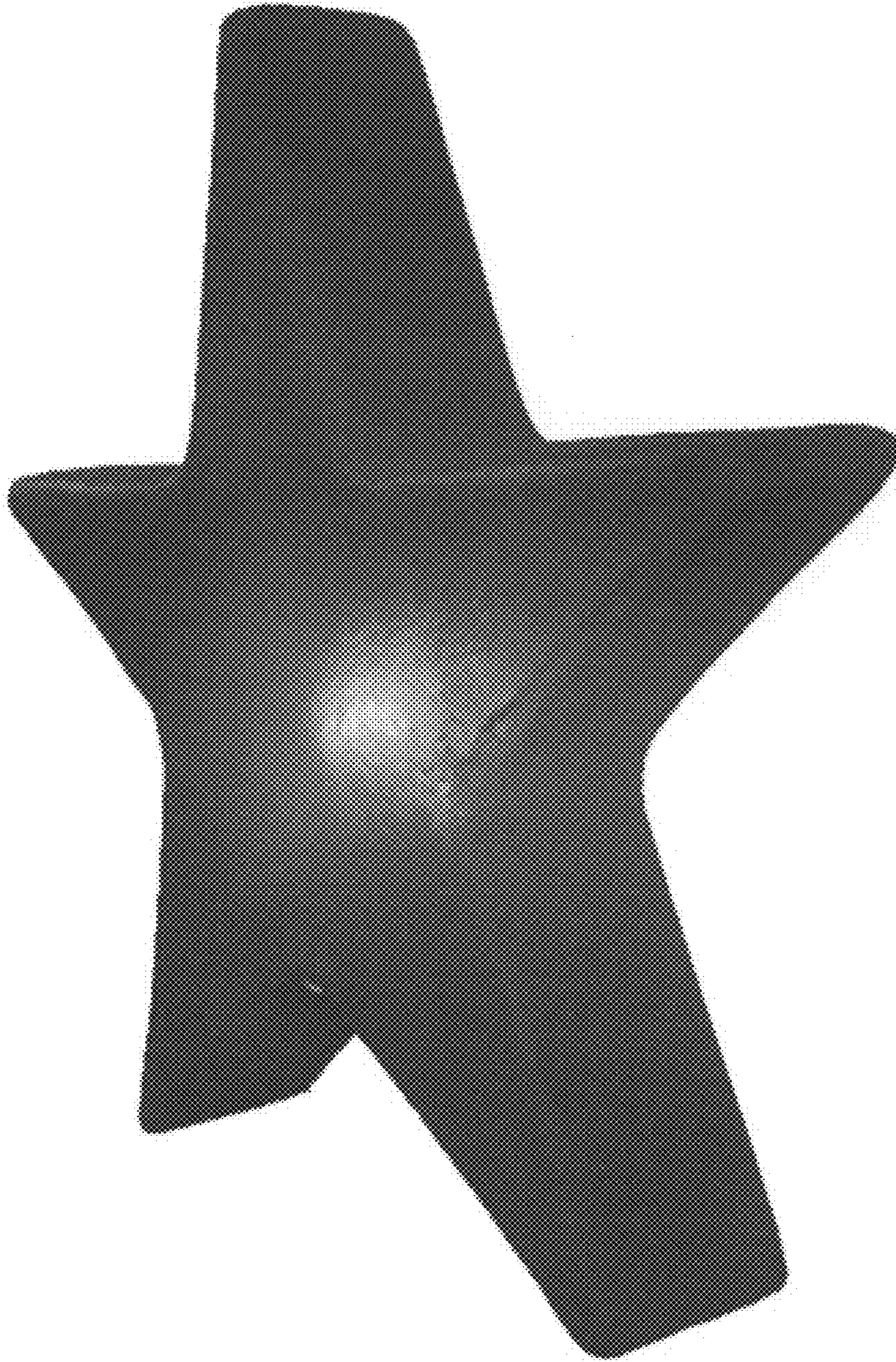

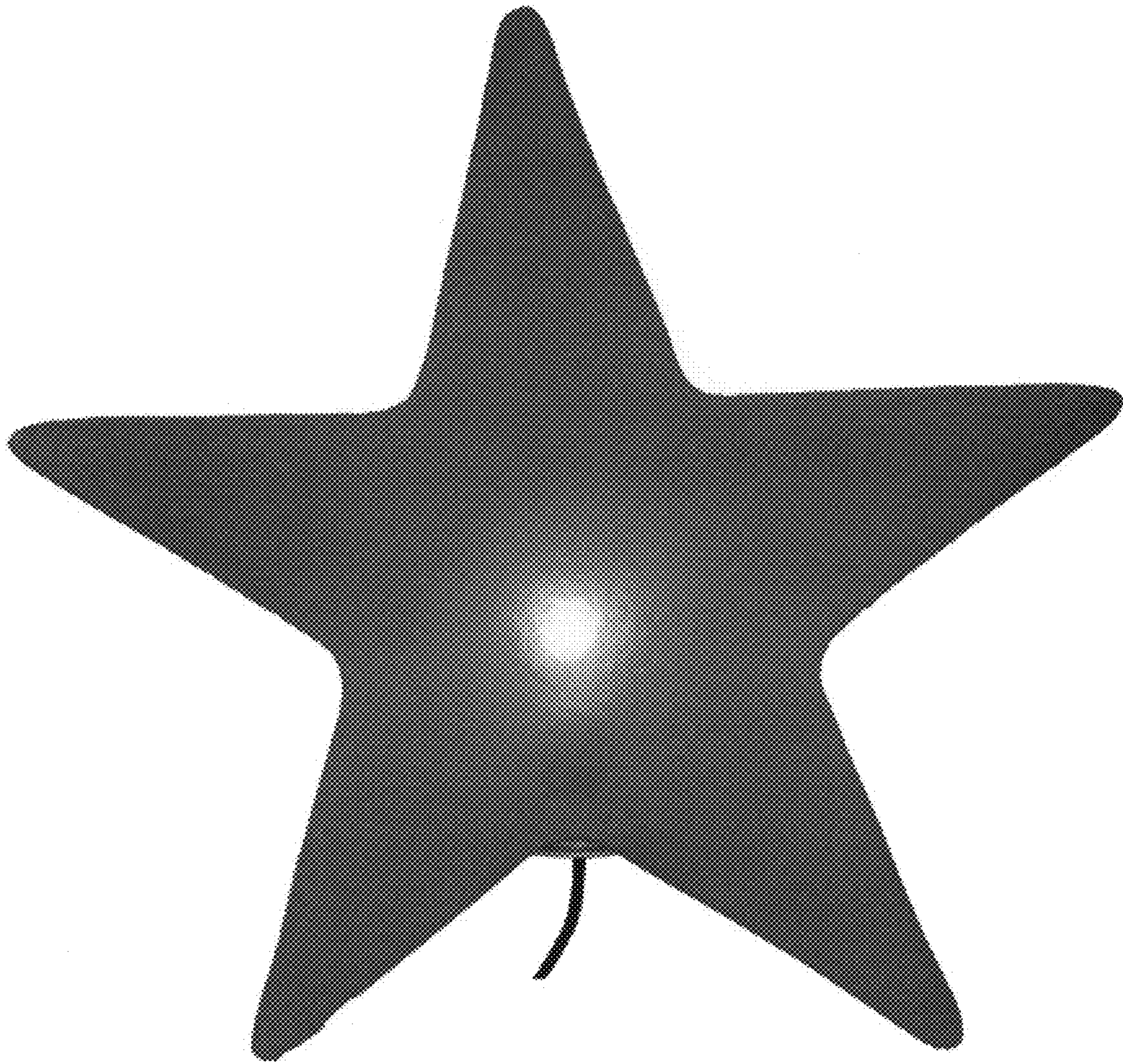

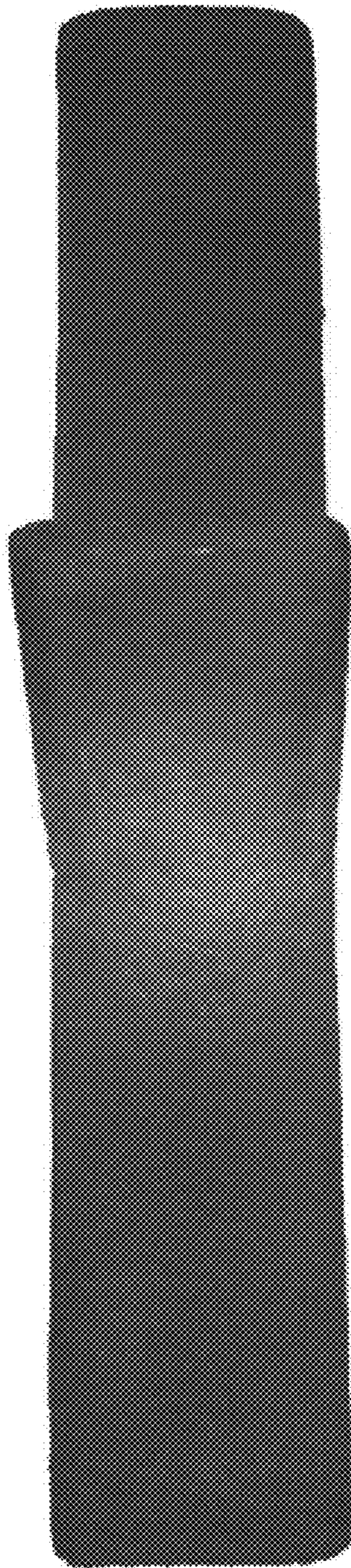

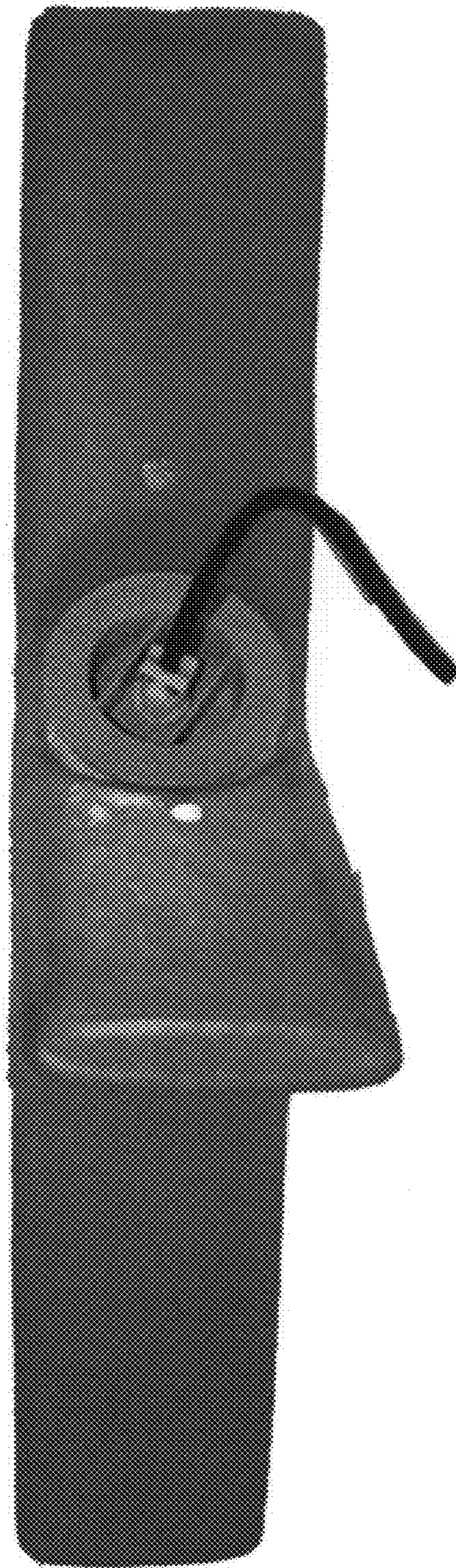
