FIG. 1 is a front elevational view of the lamp, showing my new design;

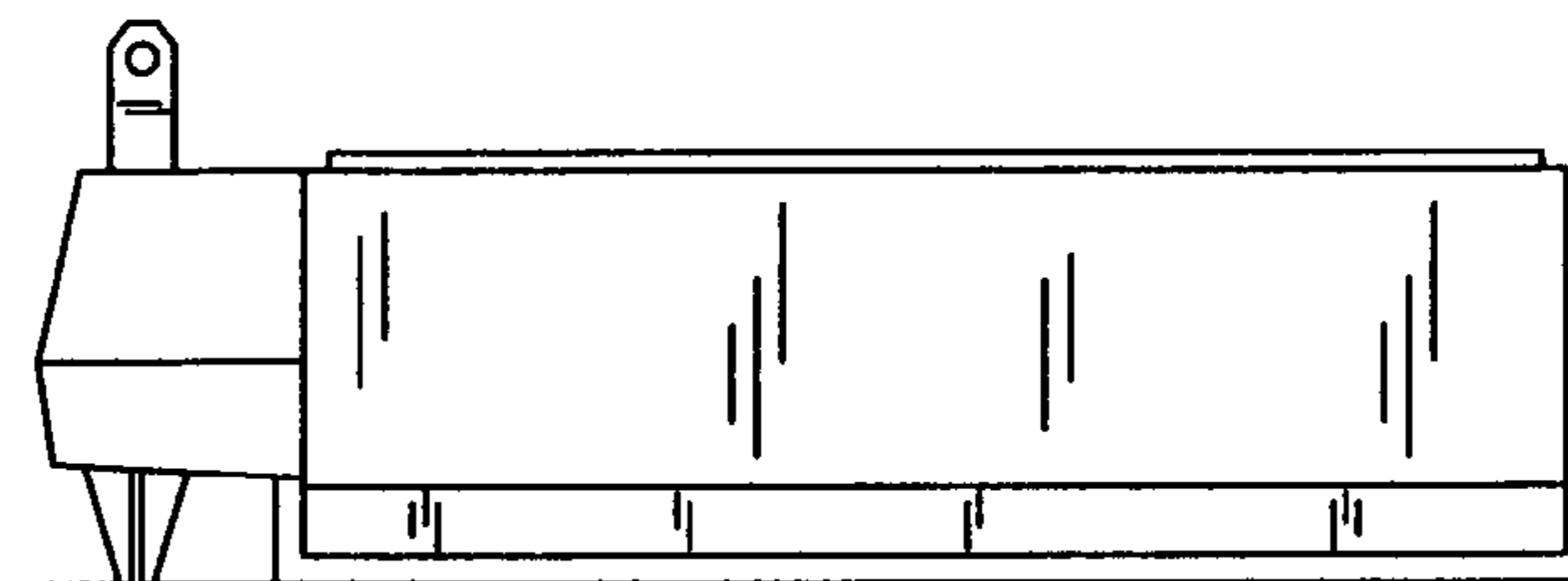
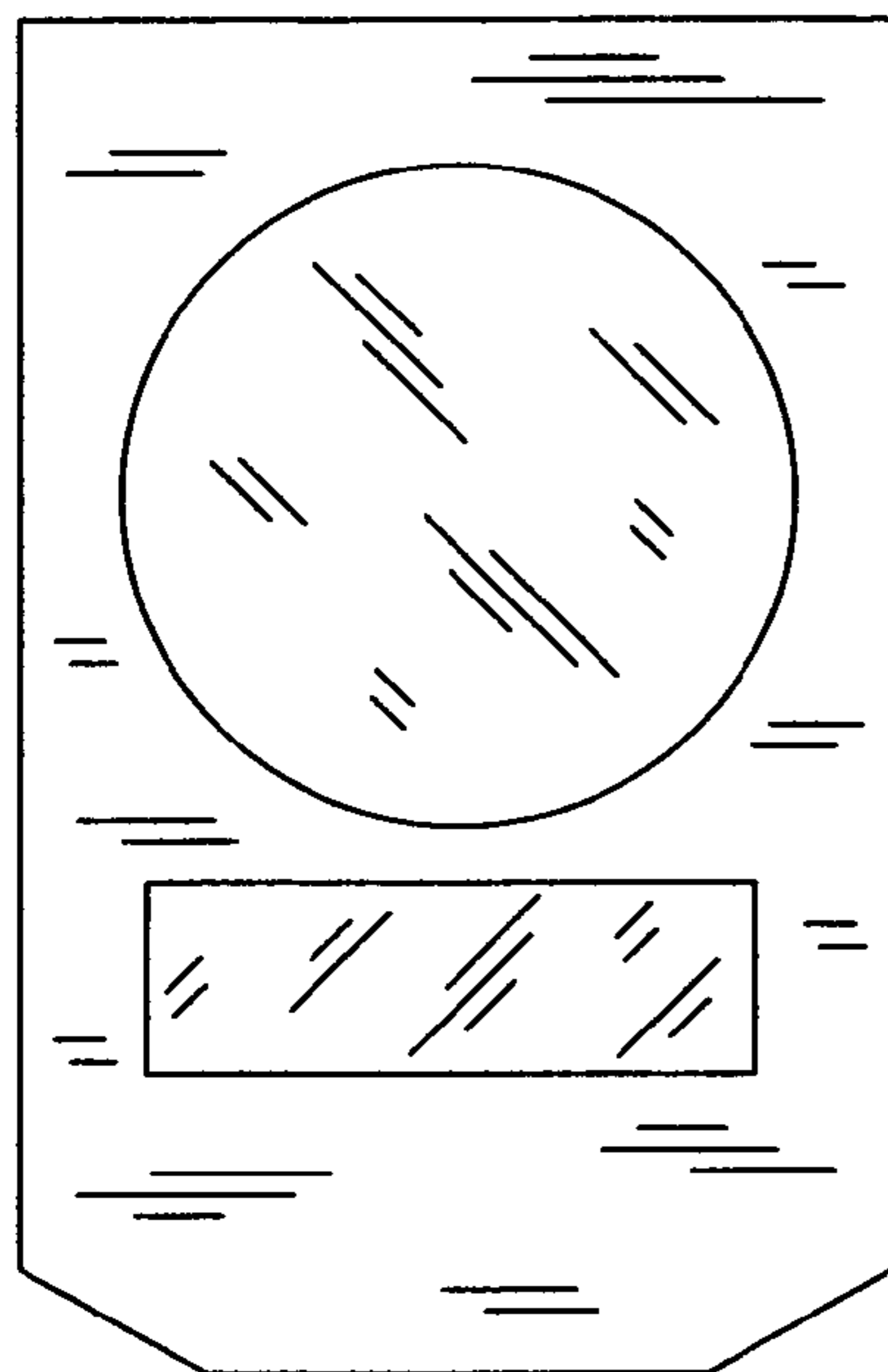
FIG. 2 is a left side view of the invention wherein the right side is a mirror image thereof;

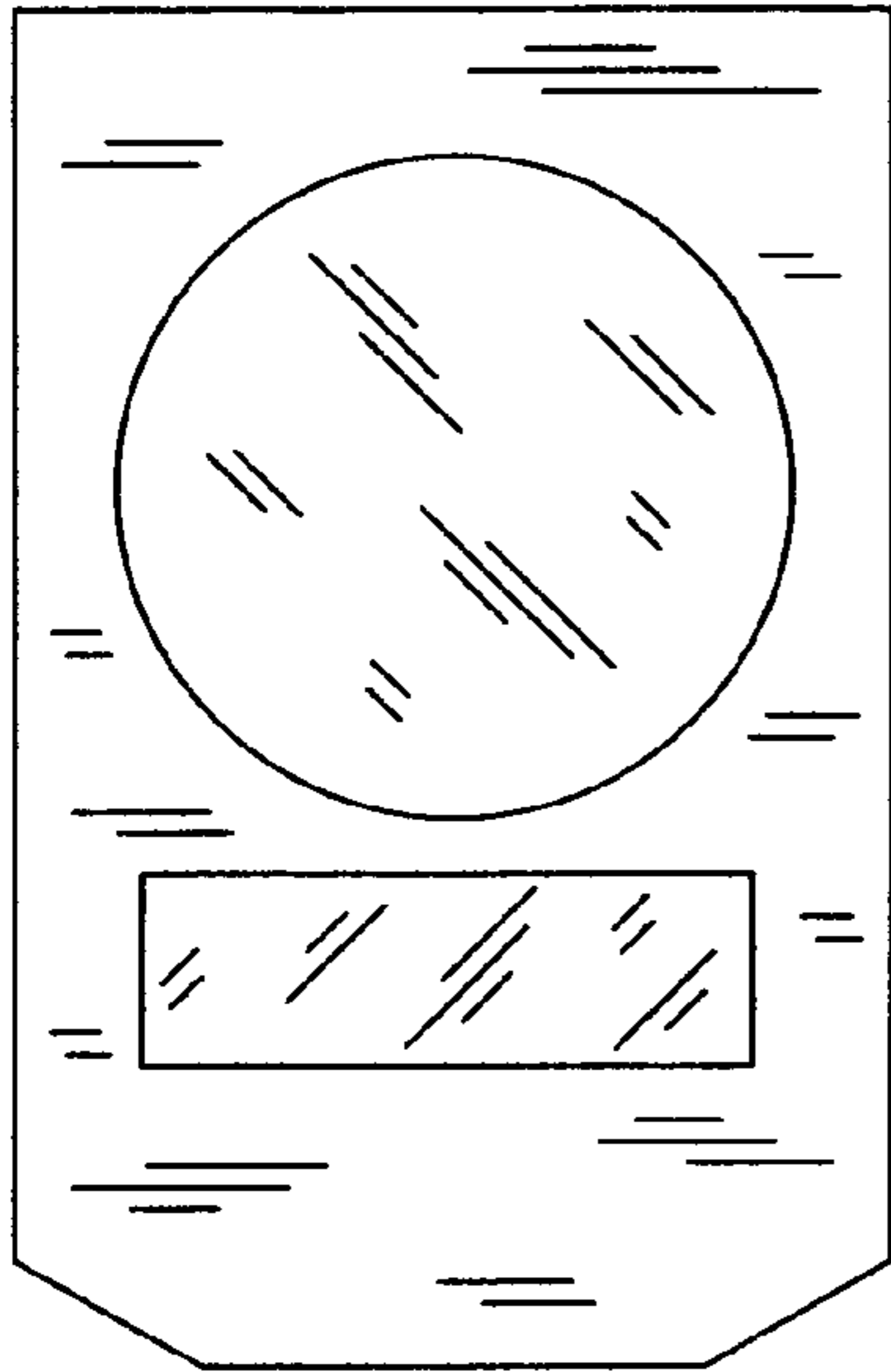

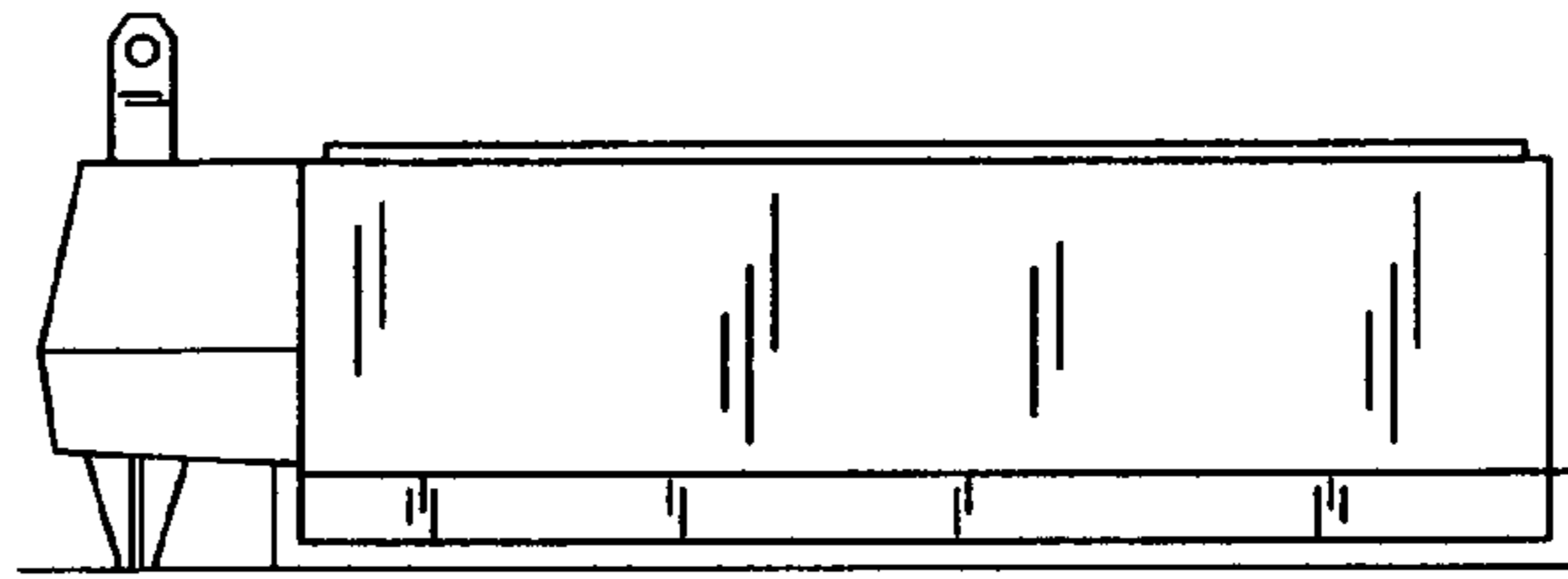

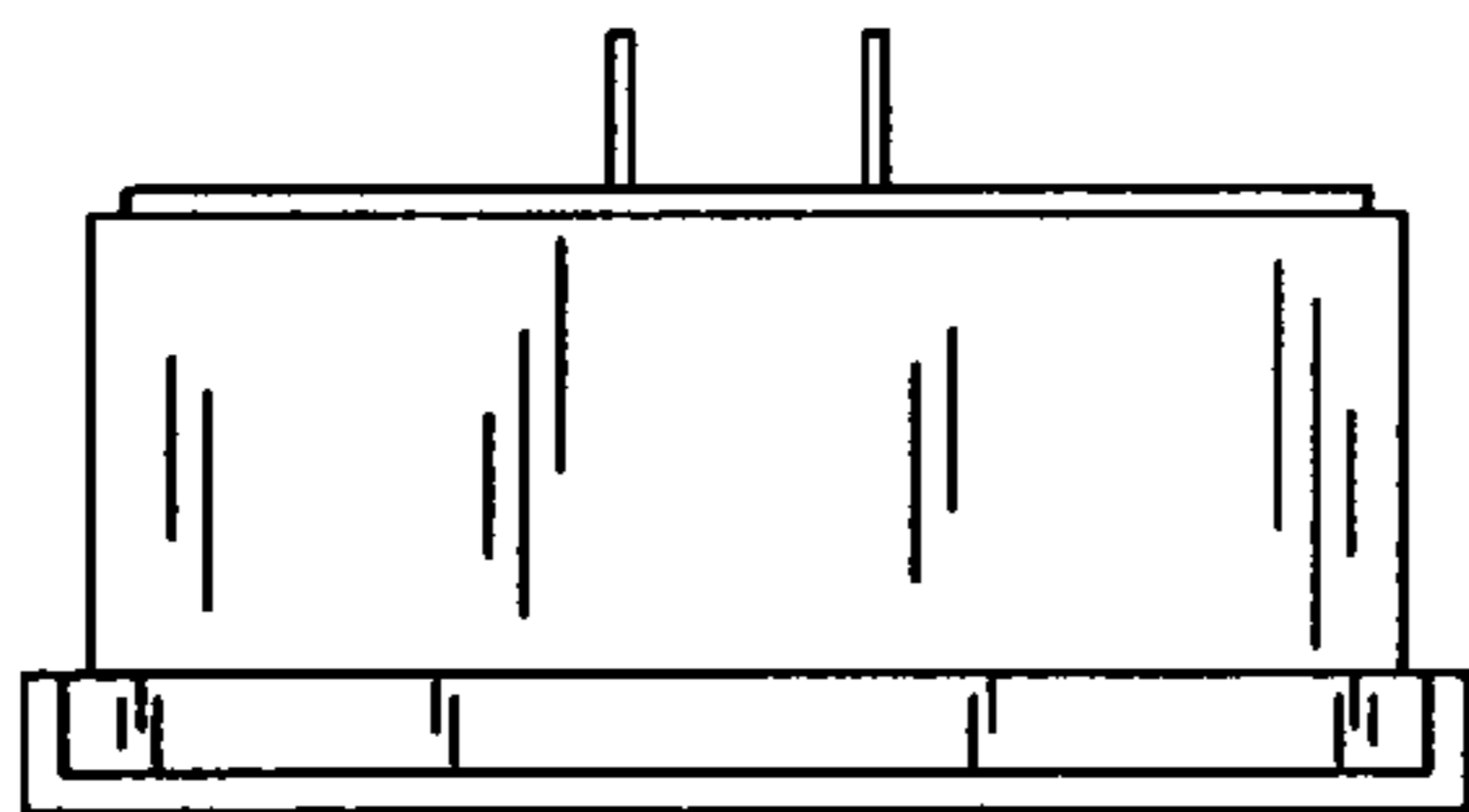

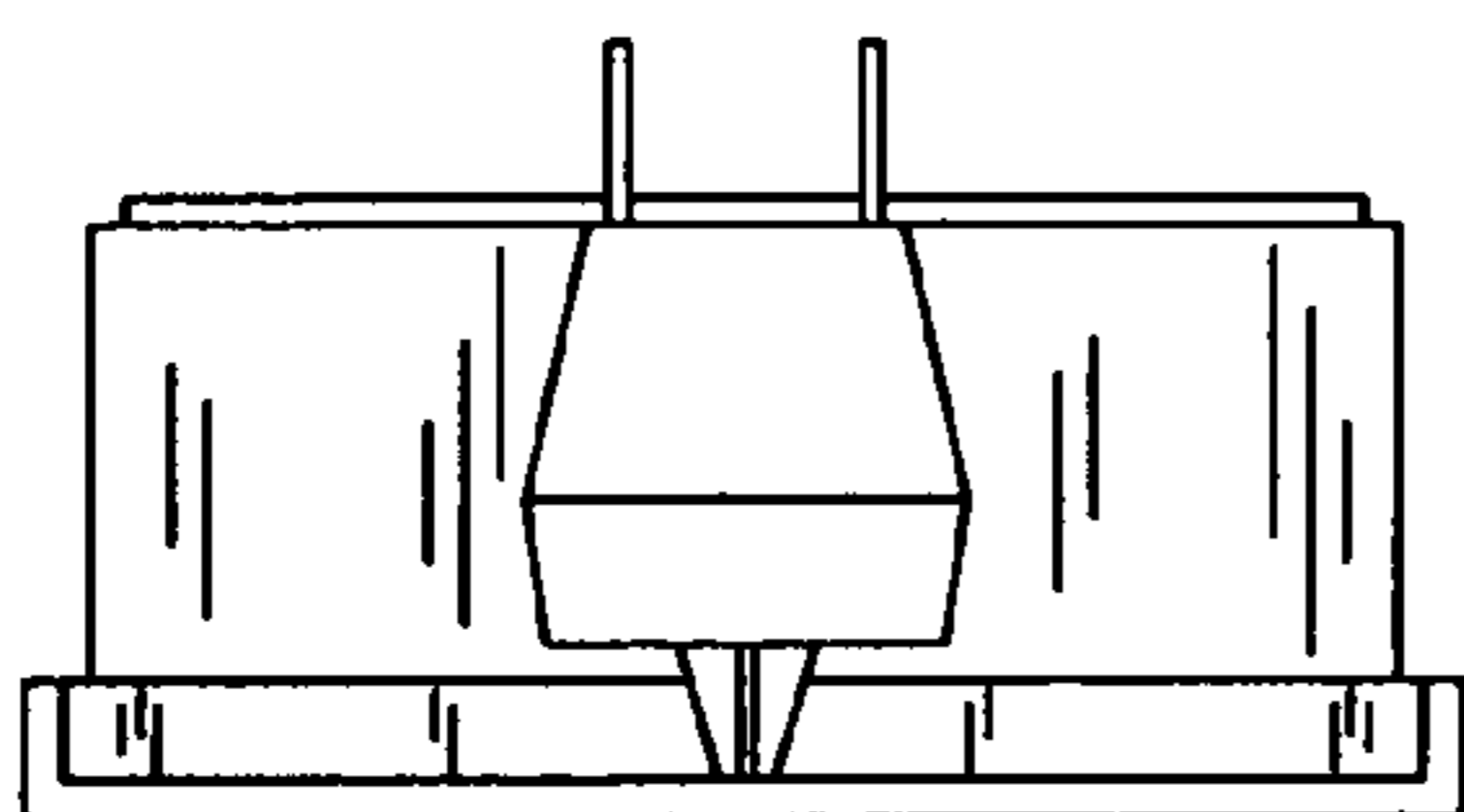

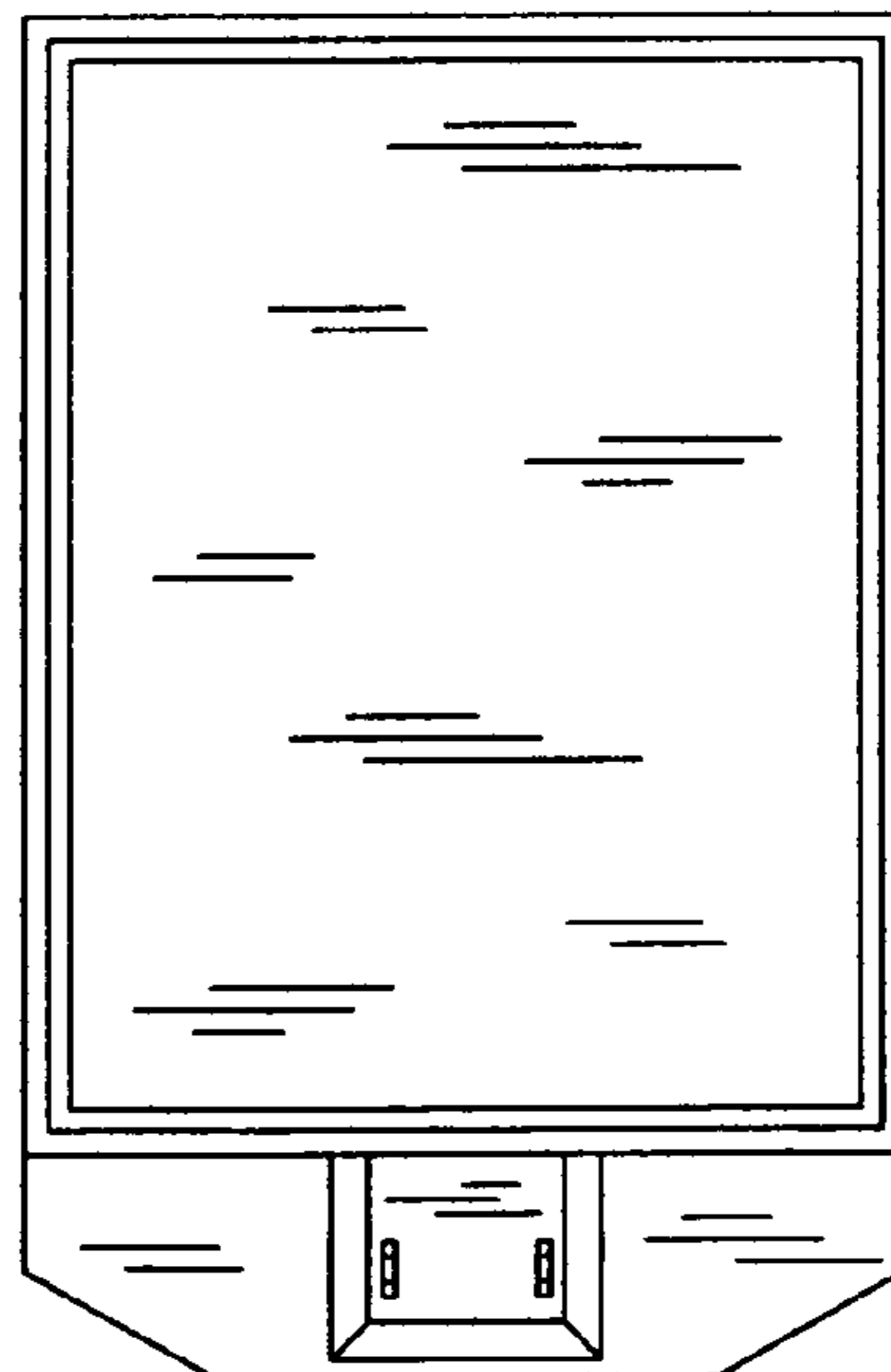
