The ornamental design for UV sun bib, as shown and described.

**DESCRIPTION**

FIG. 1 is top plan view of the UV sun bib of the invention in its open position.

FIG. 2 is a bottom plan view of the UV sun bib of FIG. 1.

FIG. 3 is top plan view of the UV sun bib of the invention, but in its closed position.

FIG. 4 a front view of the UV sun bib of FIG. 3.

FIG. 6 a left side view of the UV sun bib of FIG. 3.

FIG. 7 a right side view of the UV sun bib of FIG. 3.

FIG. 8 a front perspective view of the UV sun bib of FIG. 3; and,

FIG. 9 a rear perspective view of the UV sun bib of FIG. 3.

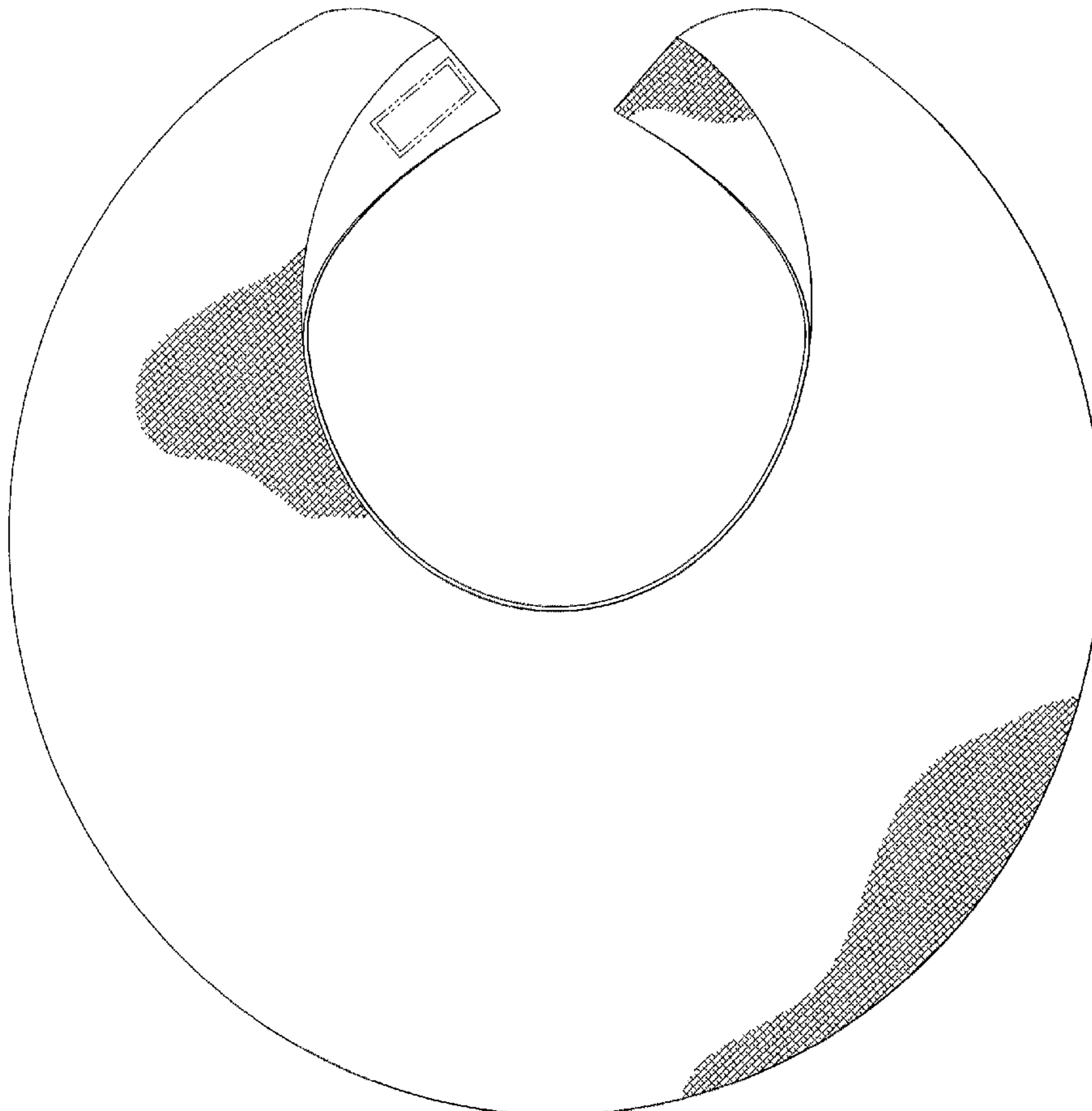

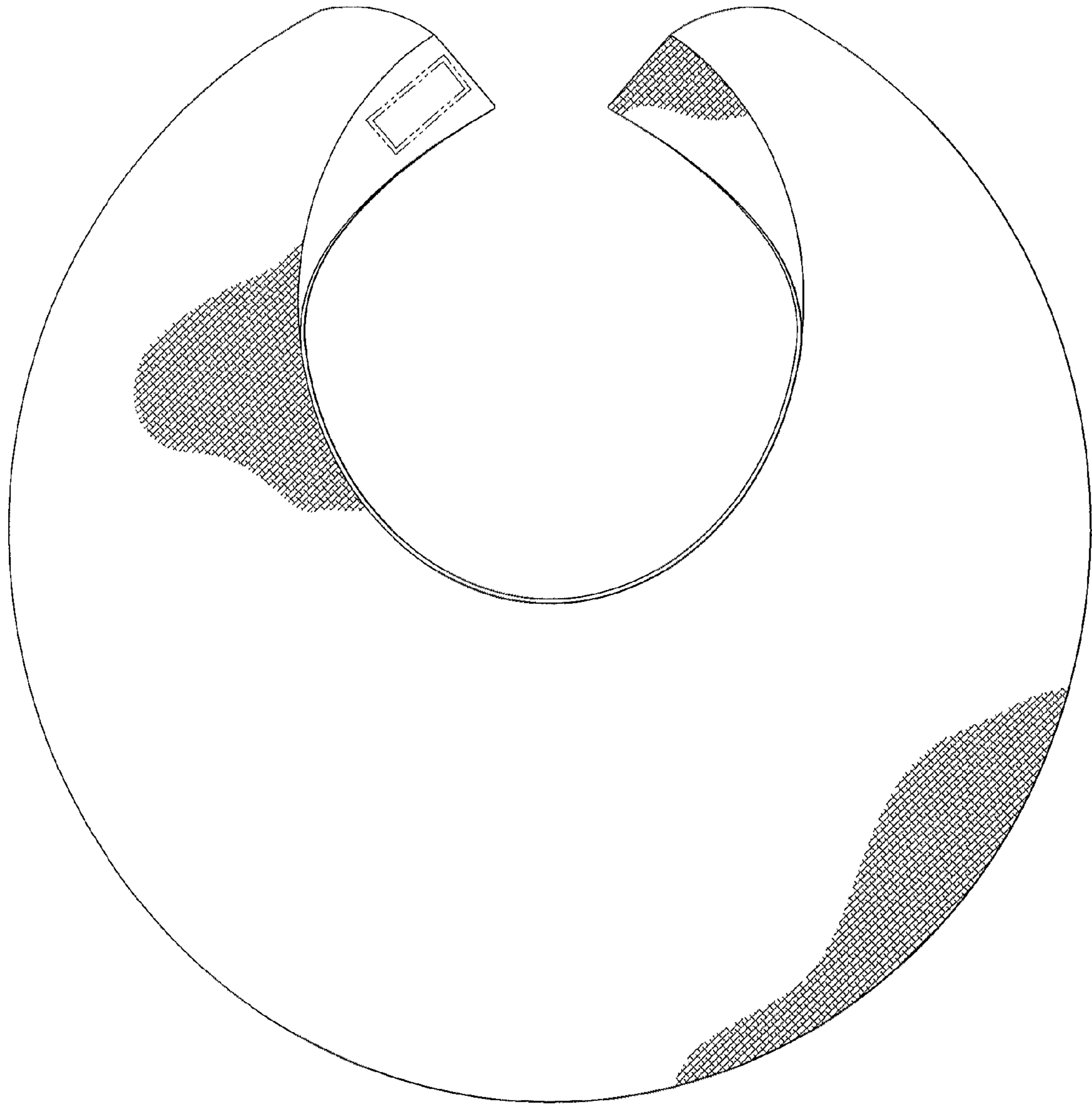
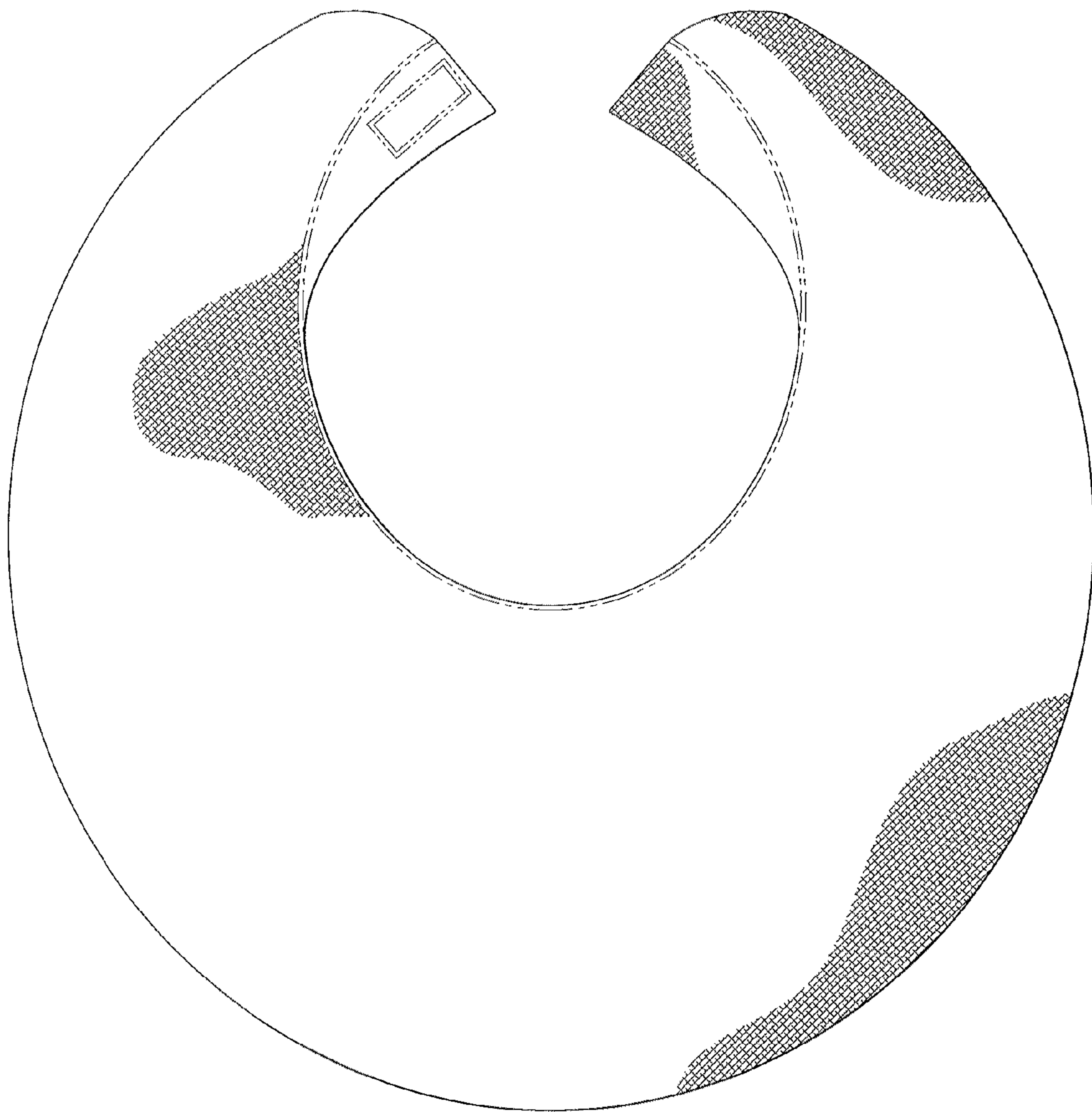
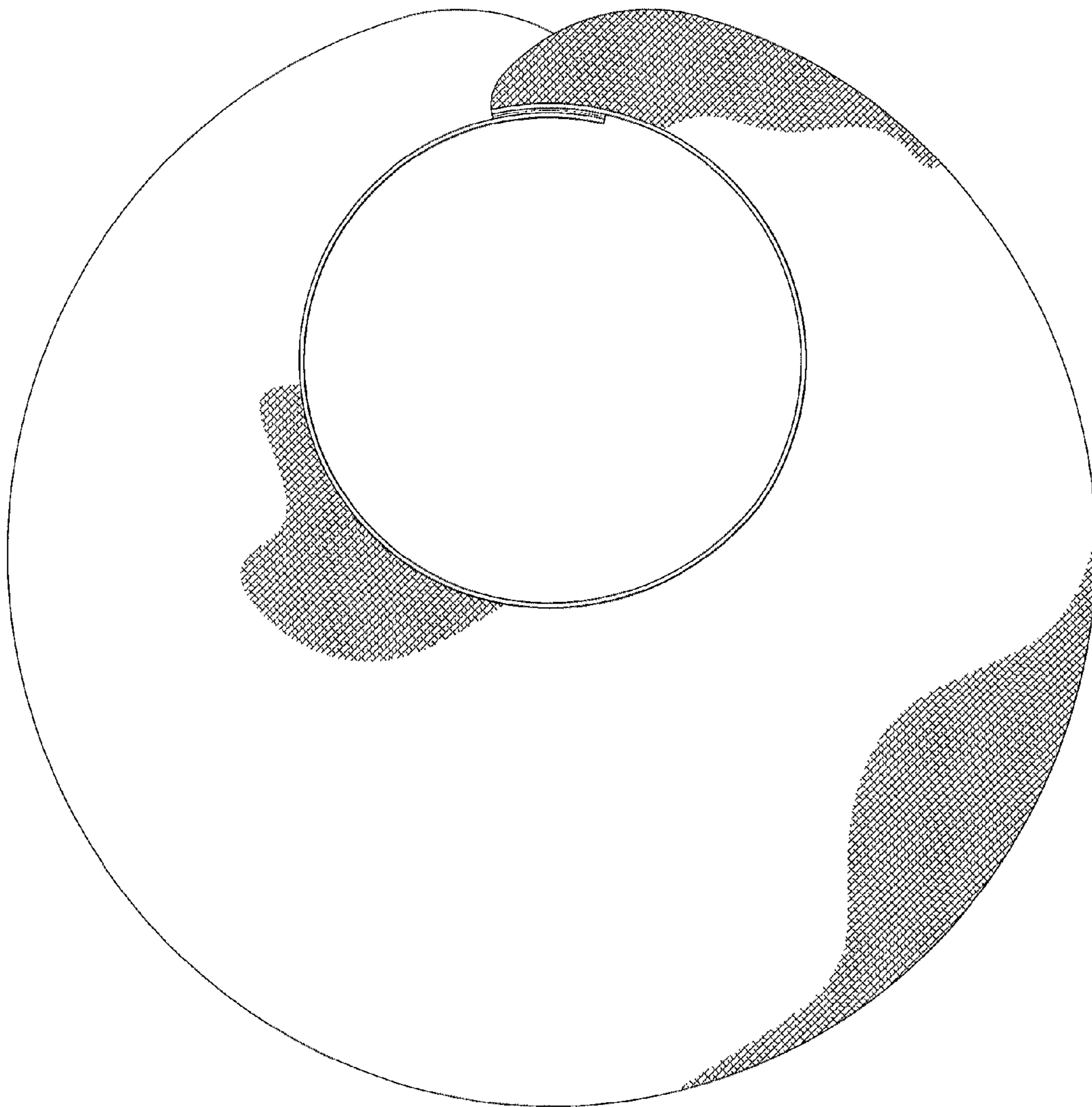


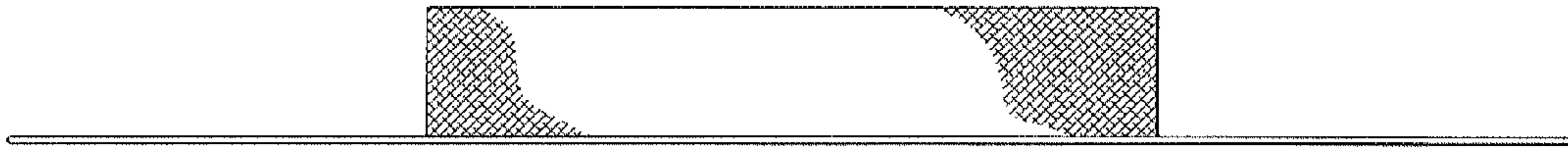

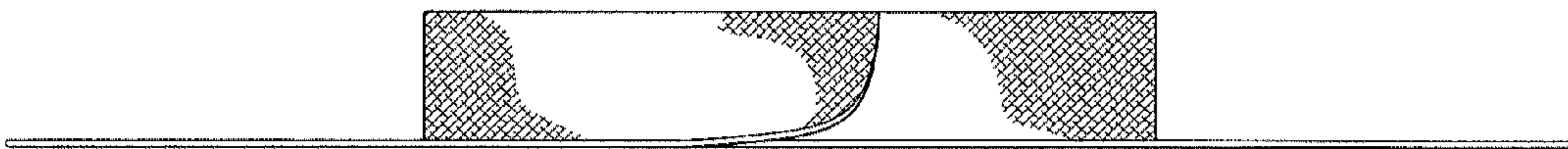

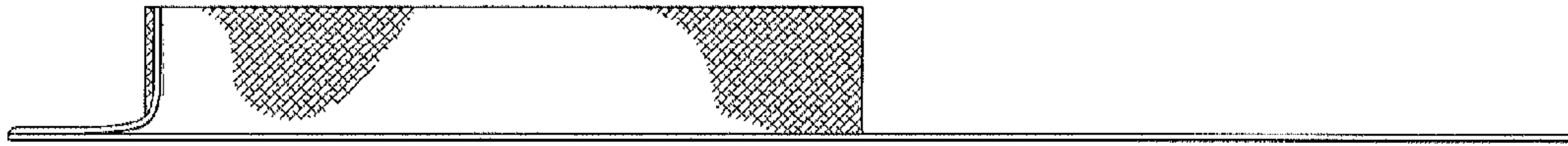

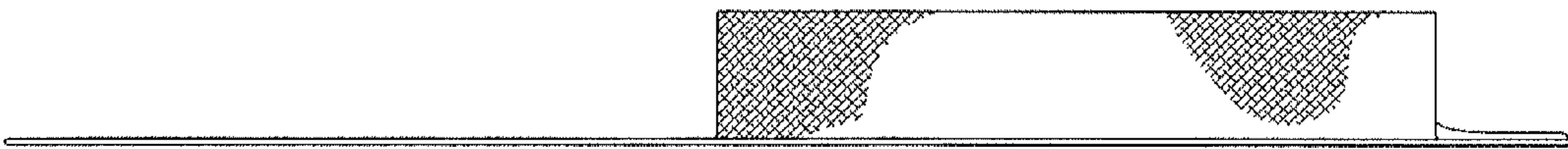

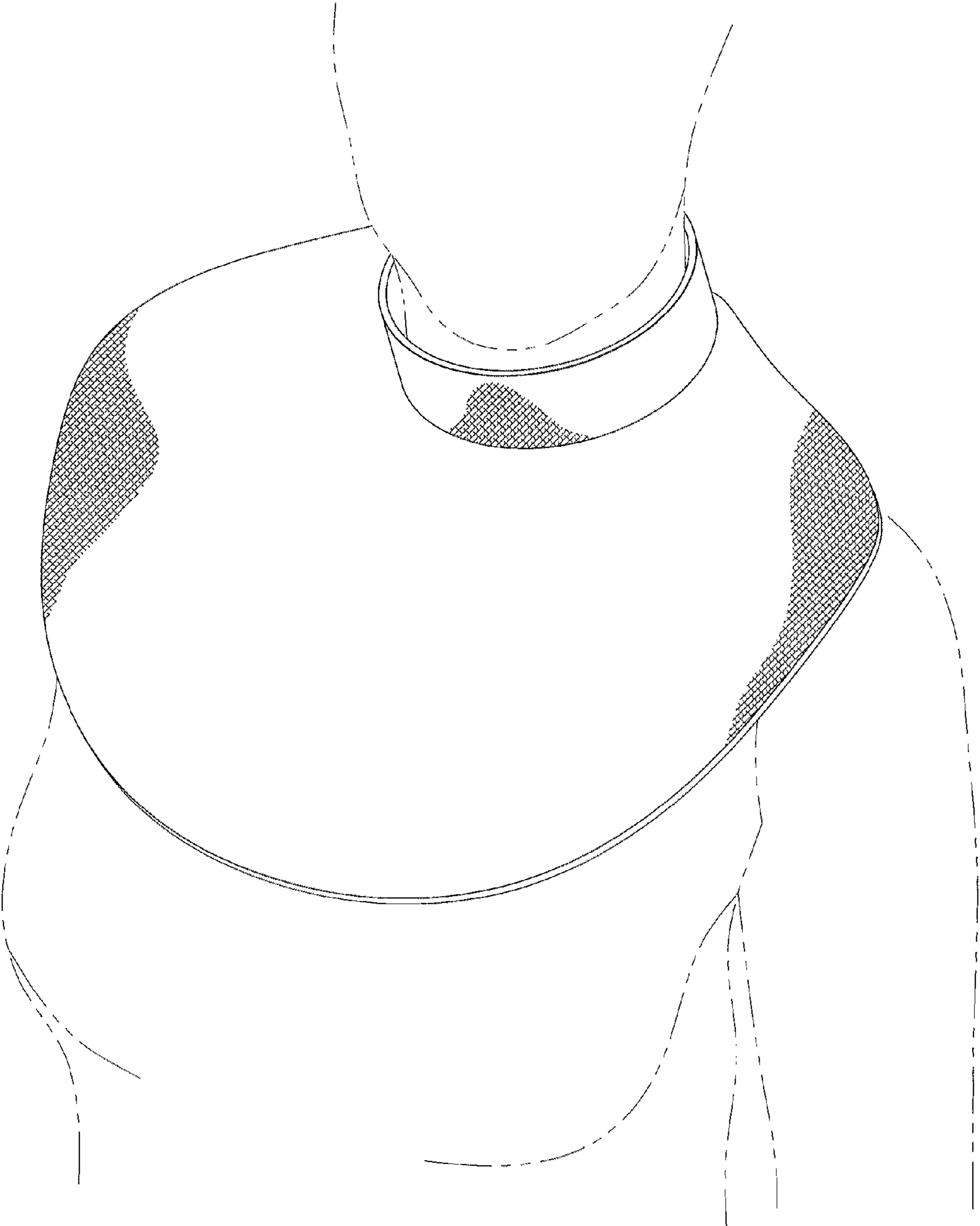
