(57) **CLAIM**

I claim the ornamental design for a food product, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a food product showing my new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a rear elevation view thereof, the front elevation view being identical;

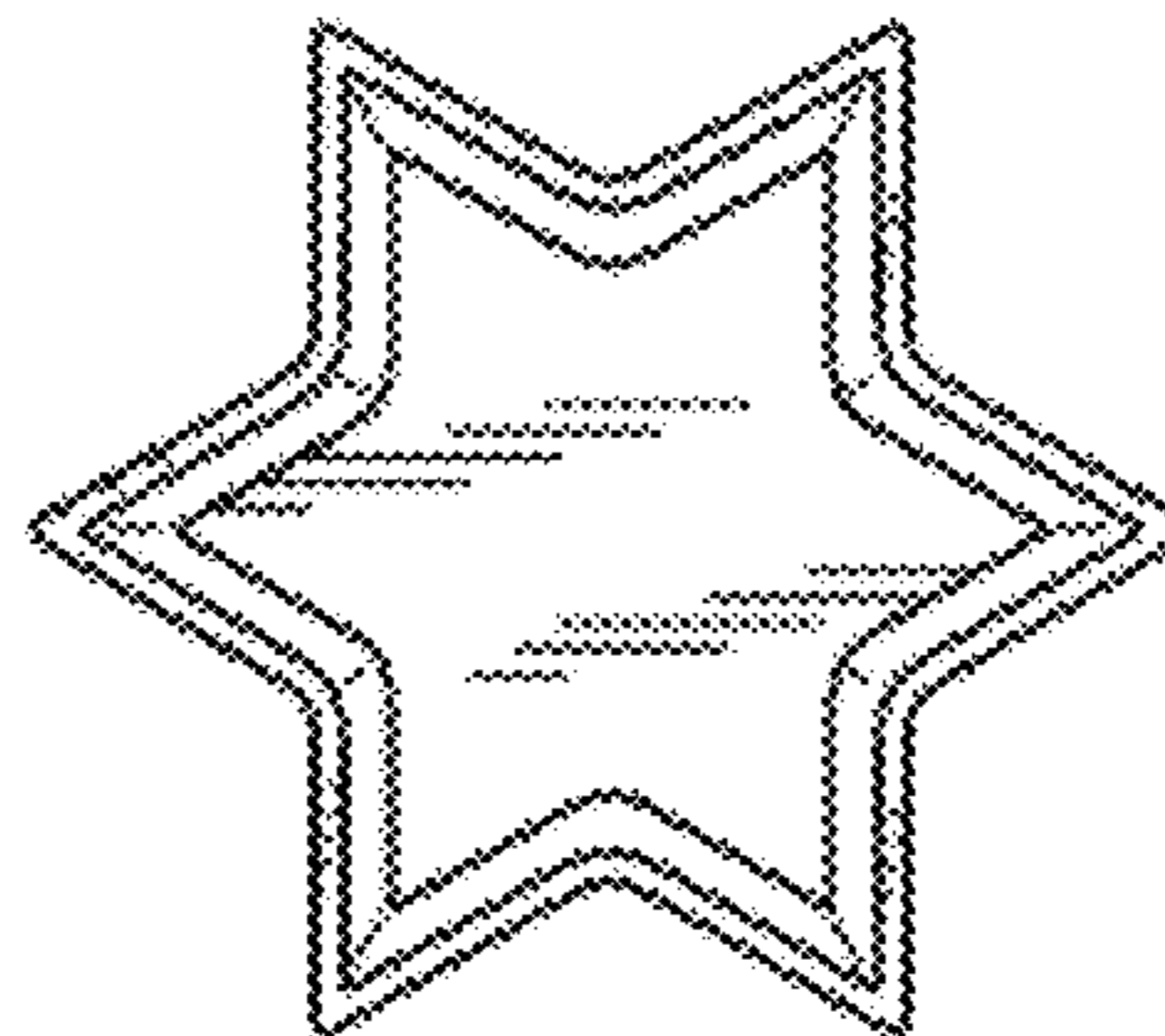
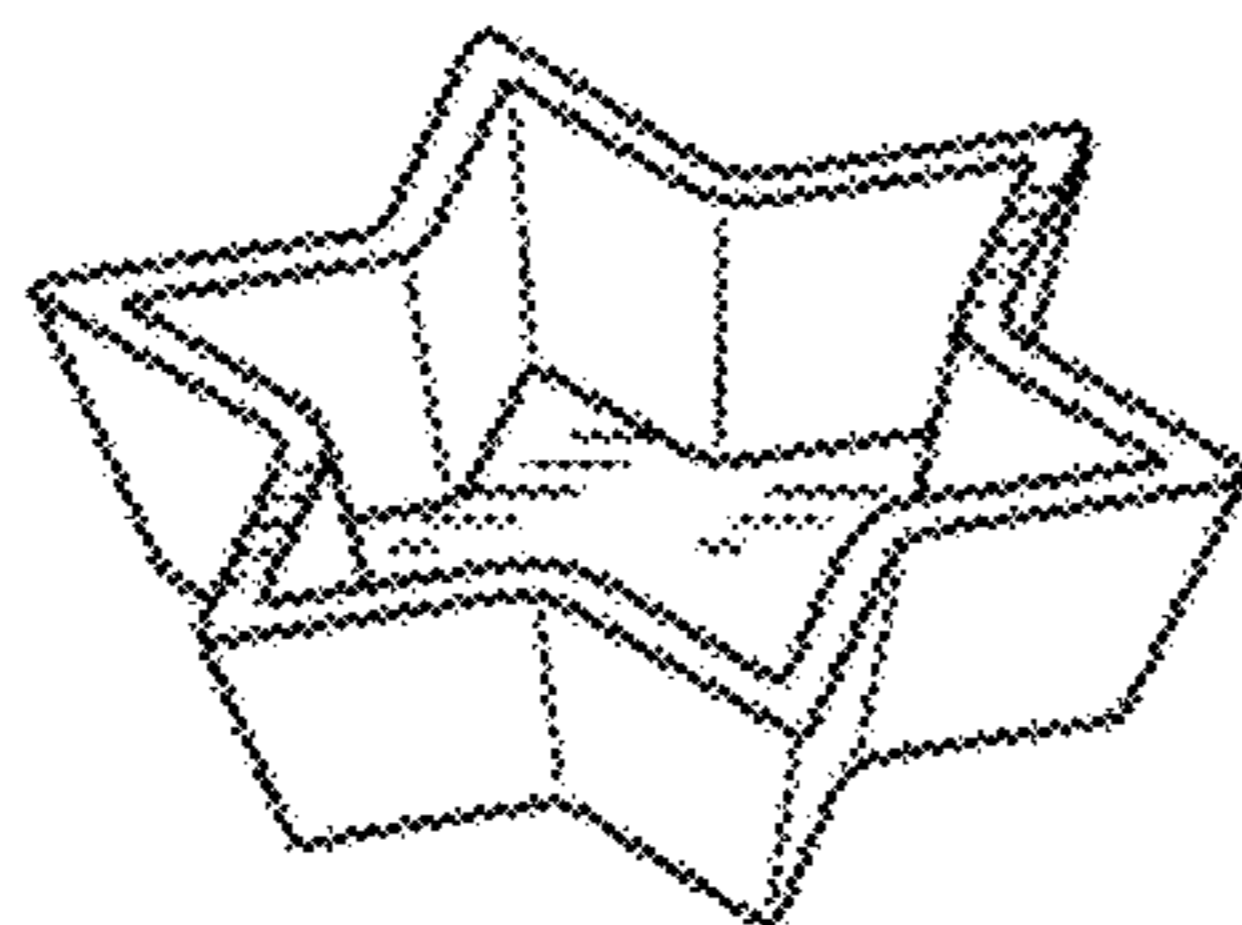
FIG. 4 is a top view thereof;

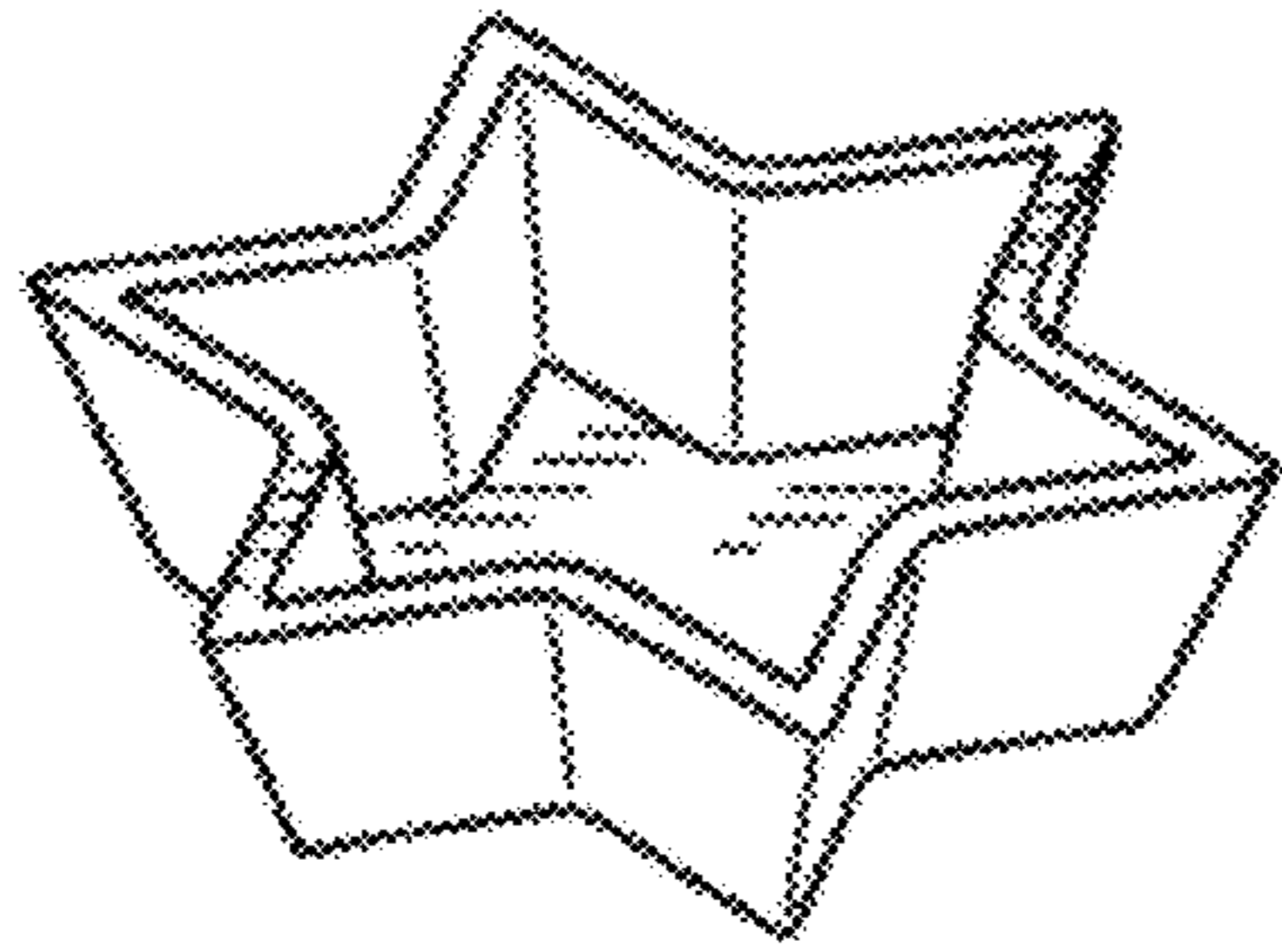

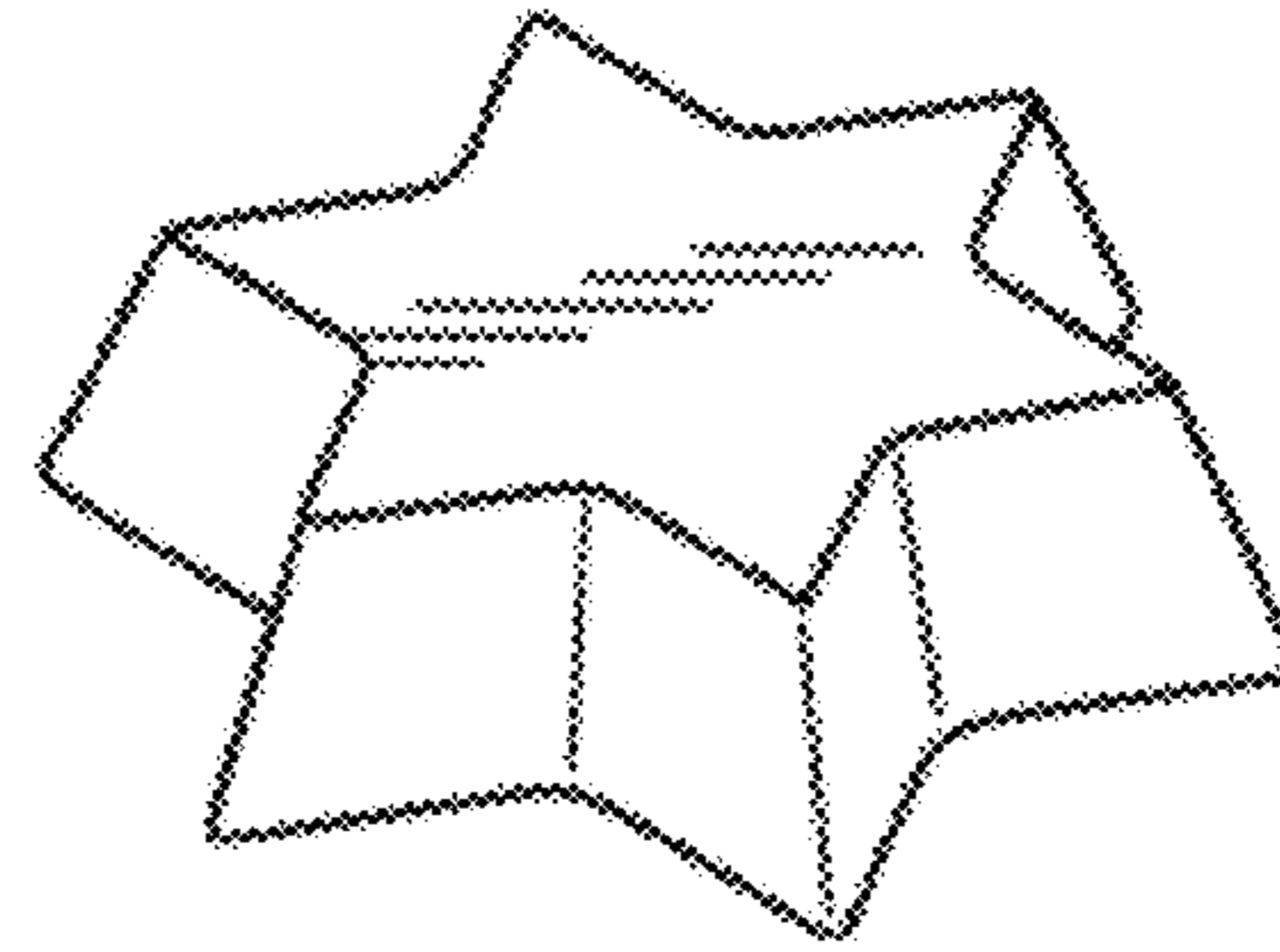

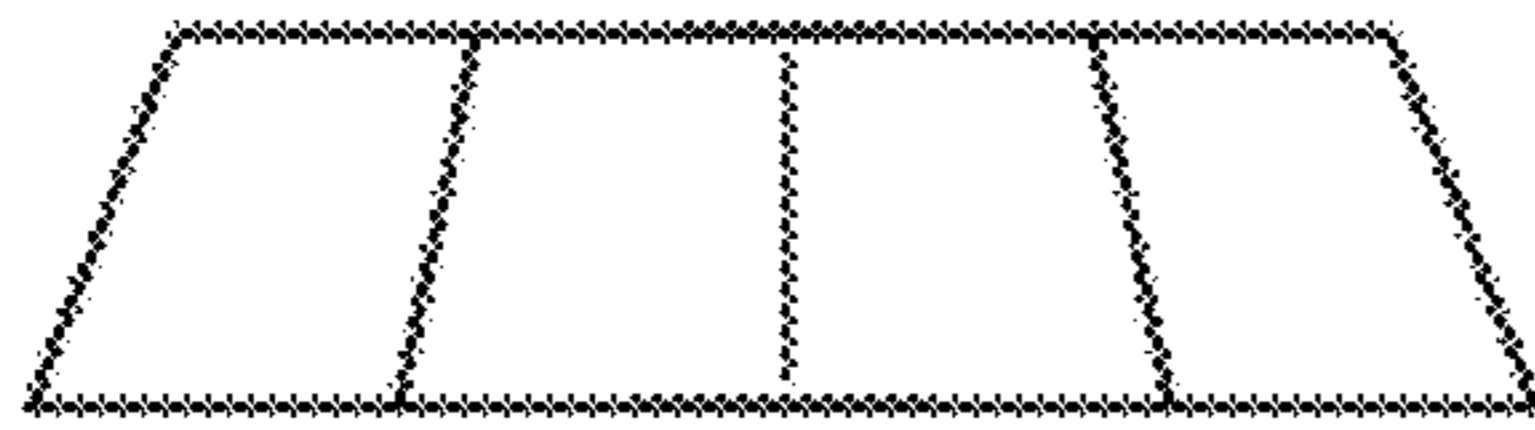

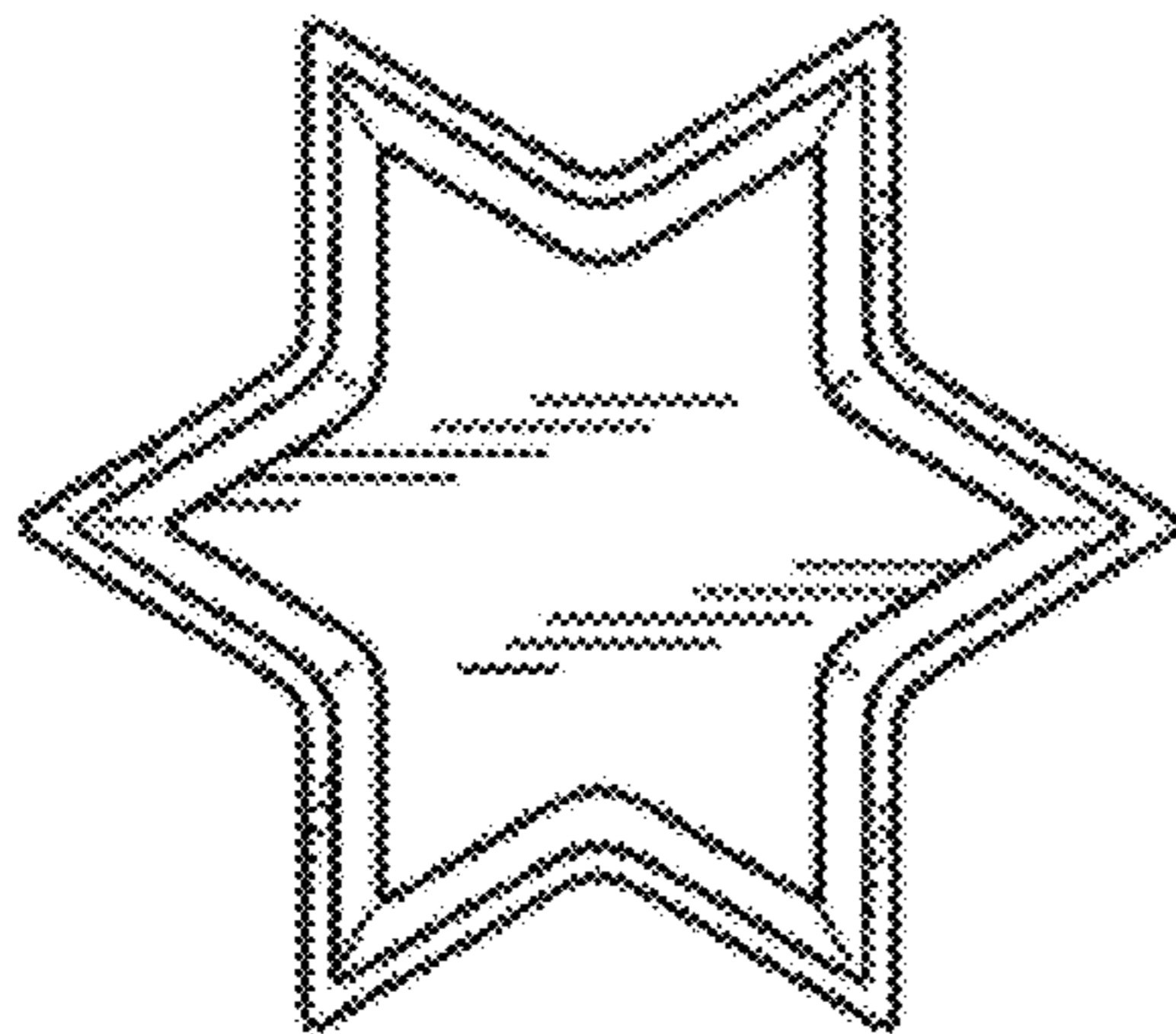

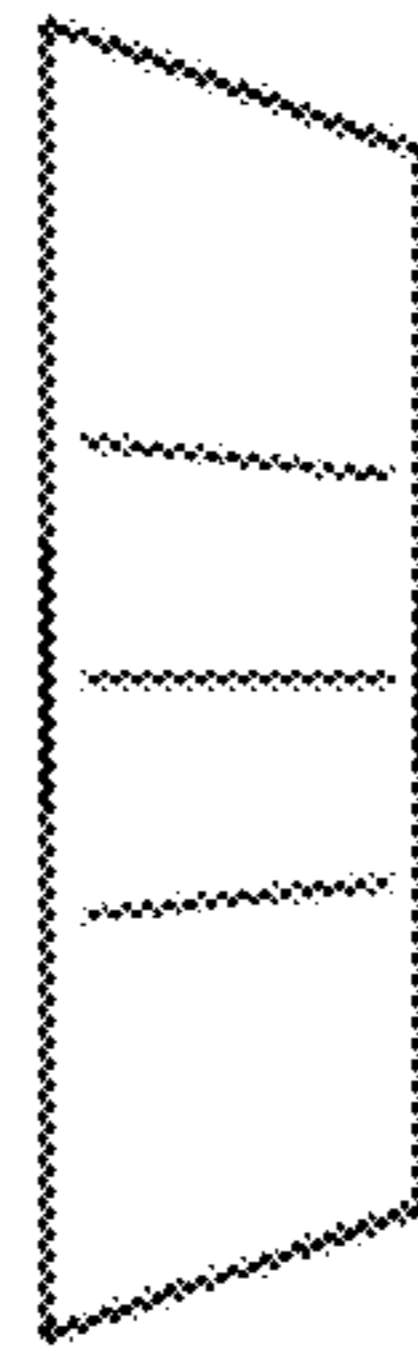

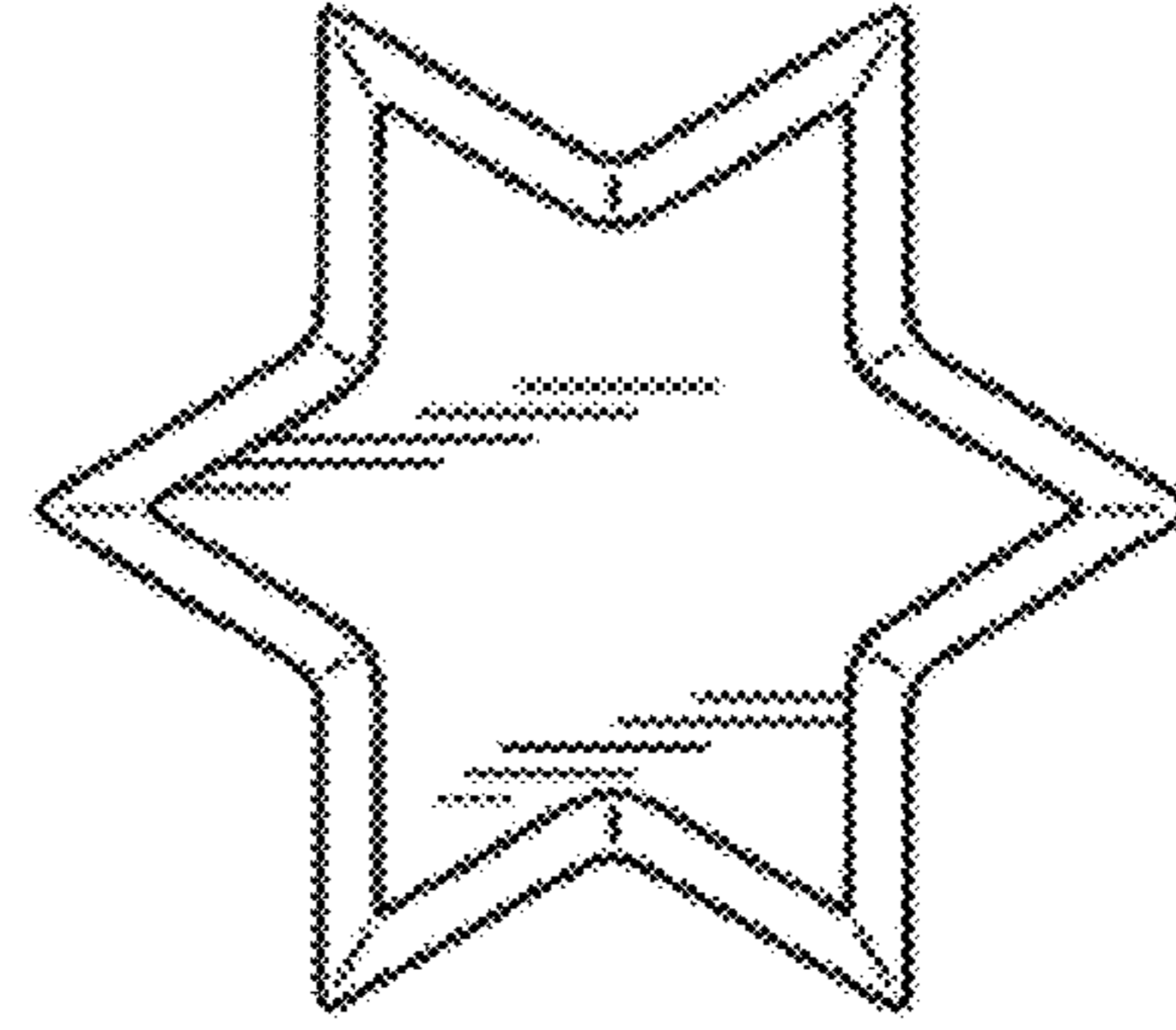

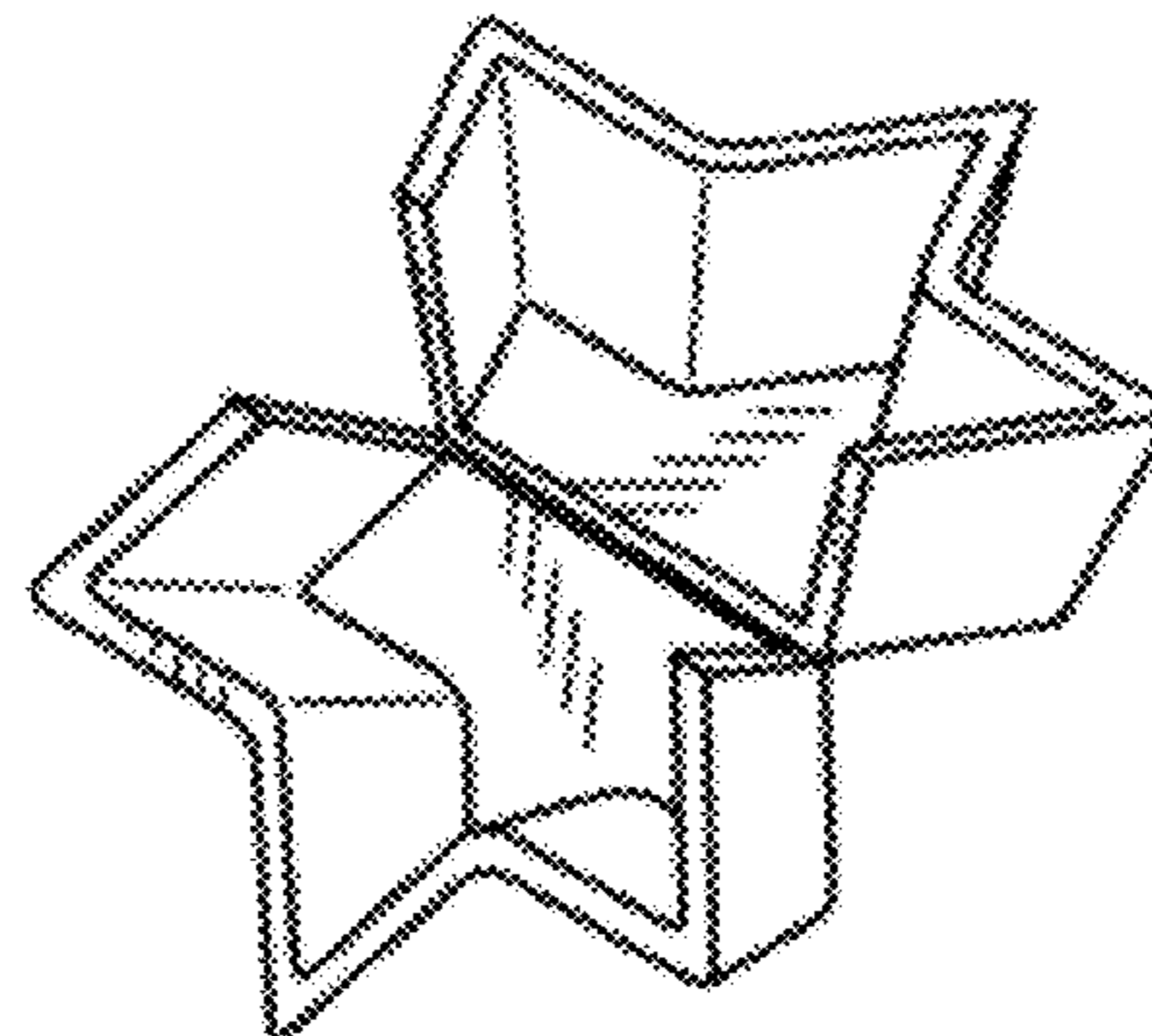
