(57) **CLAIM**

What is claimed is the ornamental design for a neck warmer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a neck warmer, showing the new design in a worn position;

FIG. 2 is a front elevational view thereof in a flat position;

FIG. 3 is a top plan view of FIG. 2;

FIG. 4 is a bottom plan view of FIG. 2;

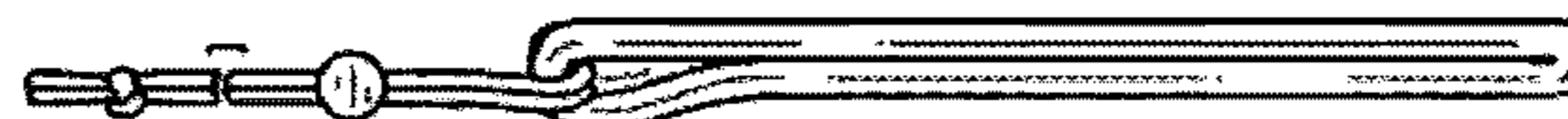
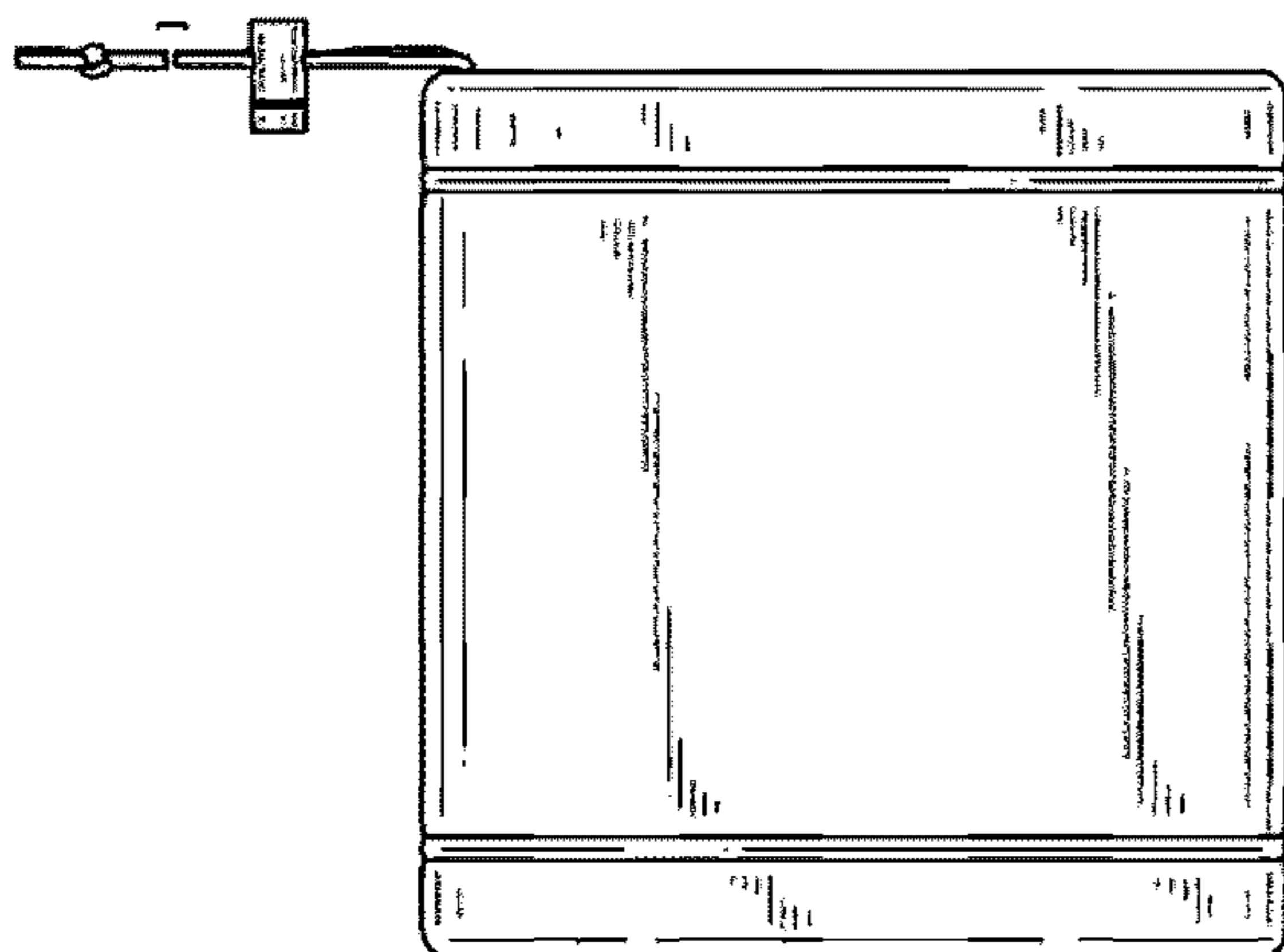
FIG. 5 is a rear elevational view of FIG. 2;

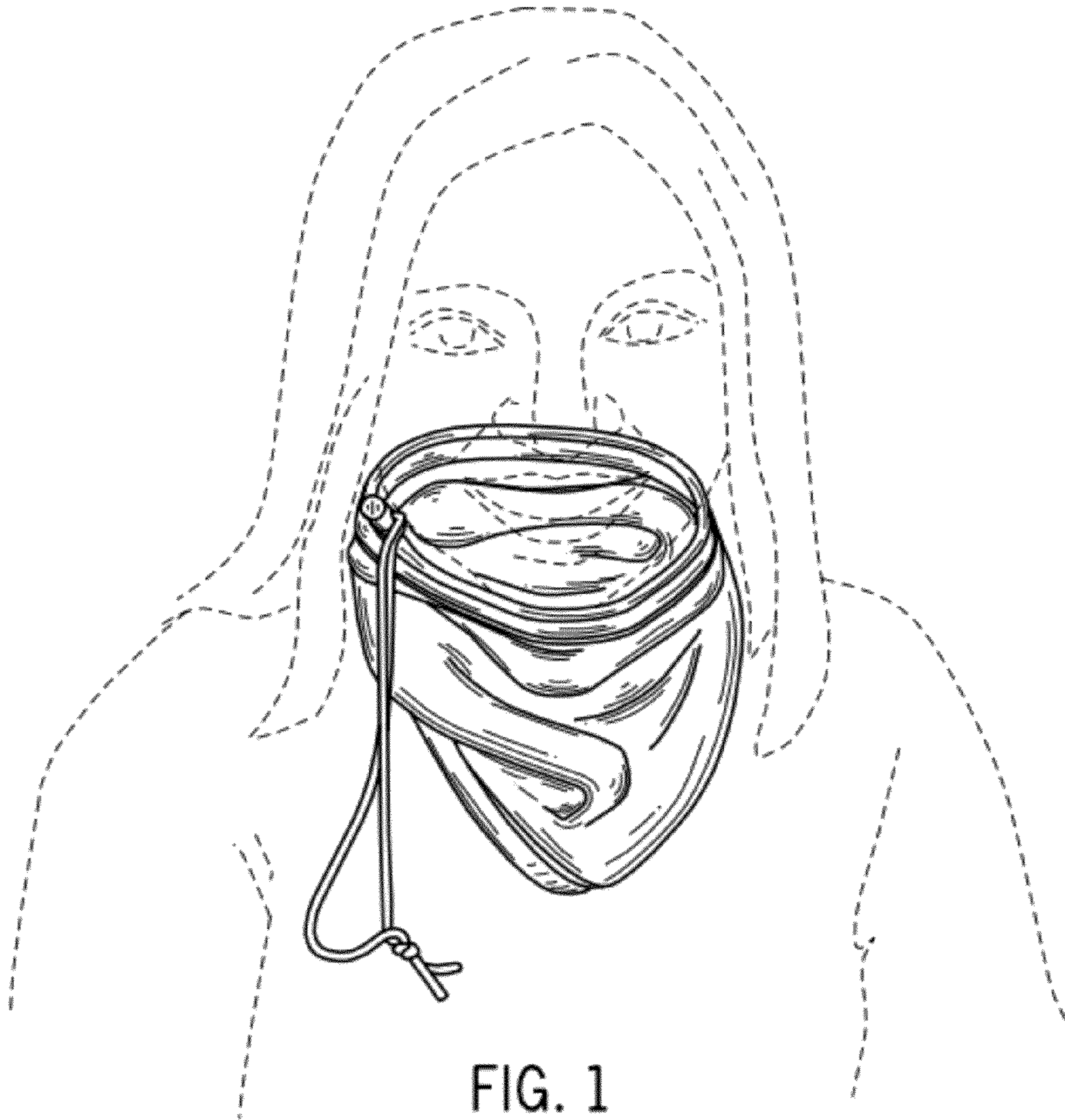
FIG. 6 is a right-side elevational view of FIG. 2; and,

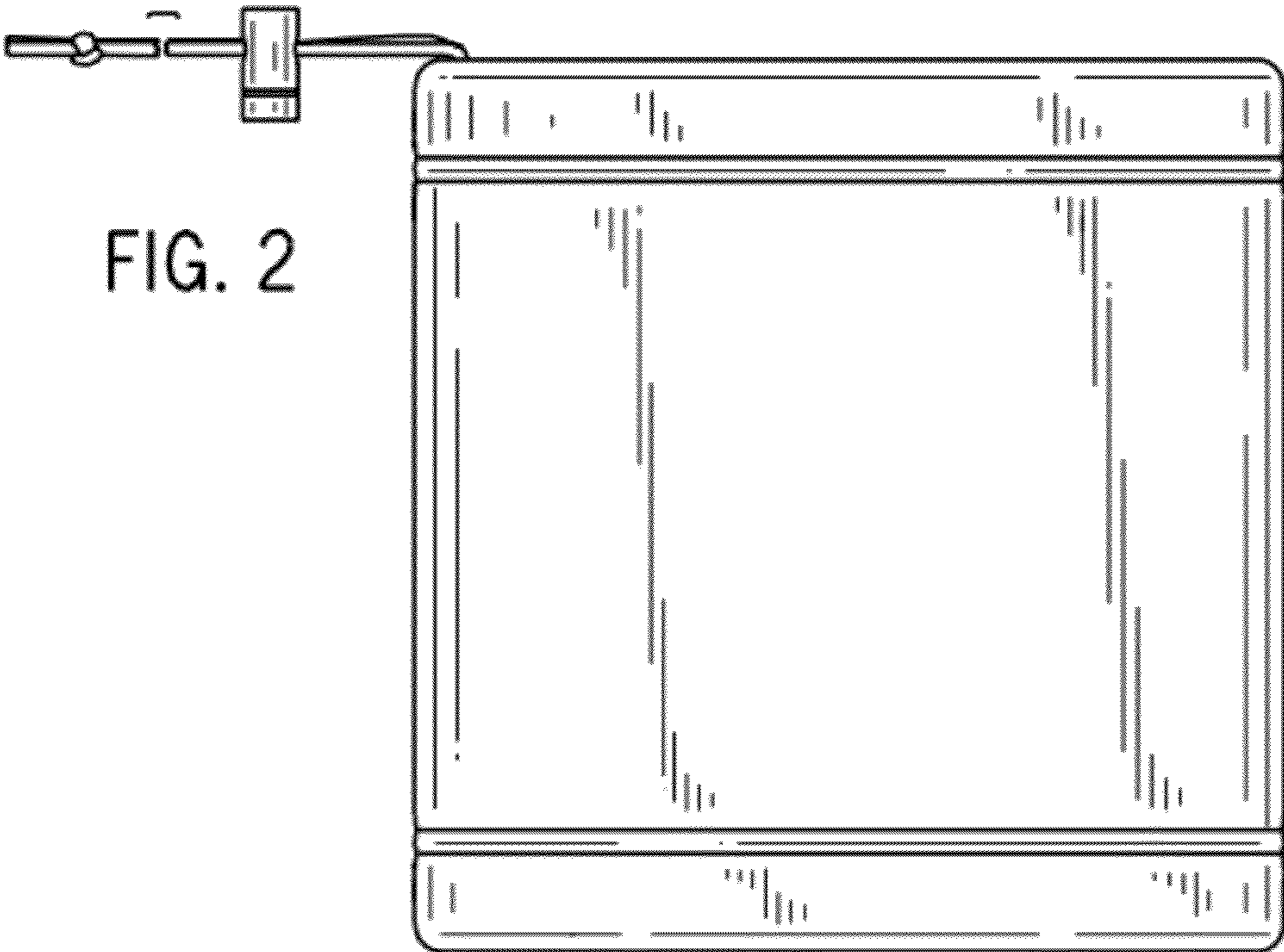

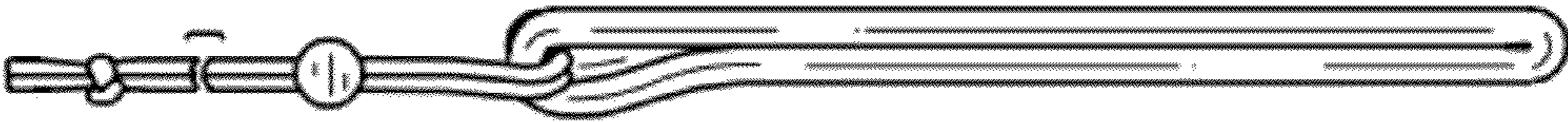
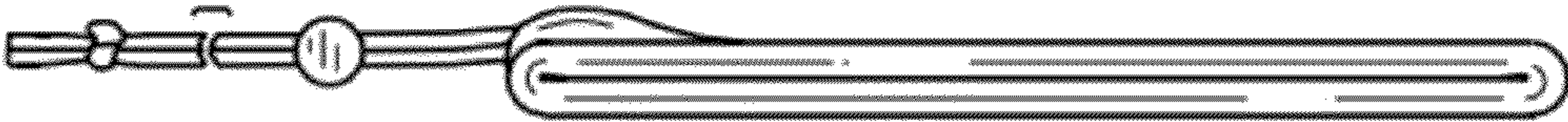

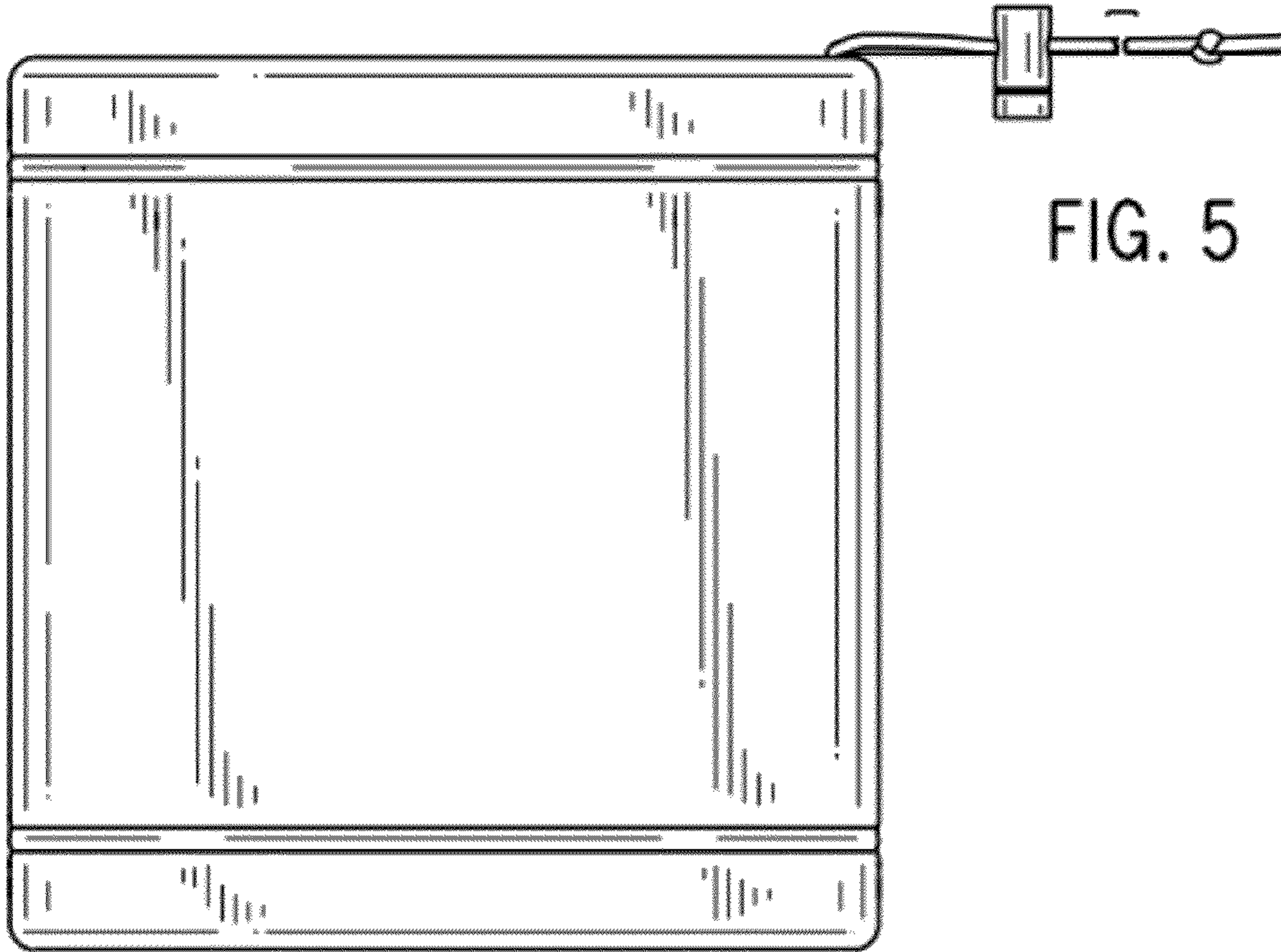

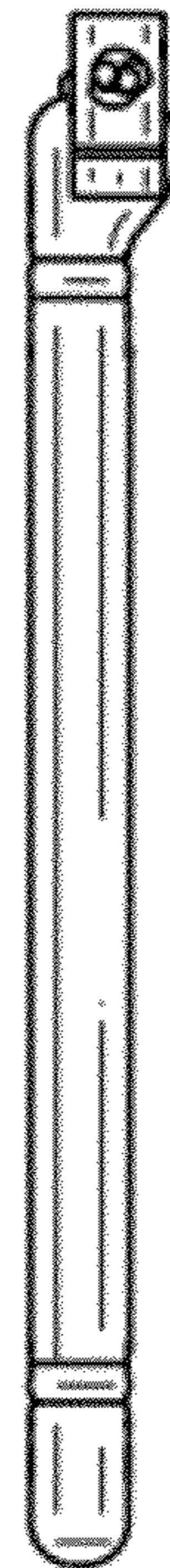
