(57) **CLAIM**

I claim the ornamental design for a shirt, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shirt of the design described herein.

FIG. 2 is a left side view thereof.

FIG. 3 is a right side view thereof.

FIG. 4 is a front side view thereof.

FIG. 5 is a top side view thereof.

FIG. 6 is a enlarged bottom side view thereof.

FIG. 7 is a back side view thereof.

FIG. 8 is a perspective view of a shirt of the design described herein.

FIG. 9 is a left side view thereof.

FIG. 10 is a right side view thereof.

FIG. 11 is a front side view thereof.

FIG. 12 is a top side view thereof.

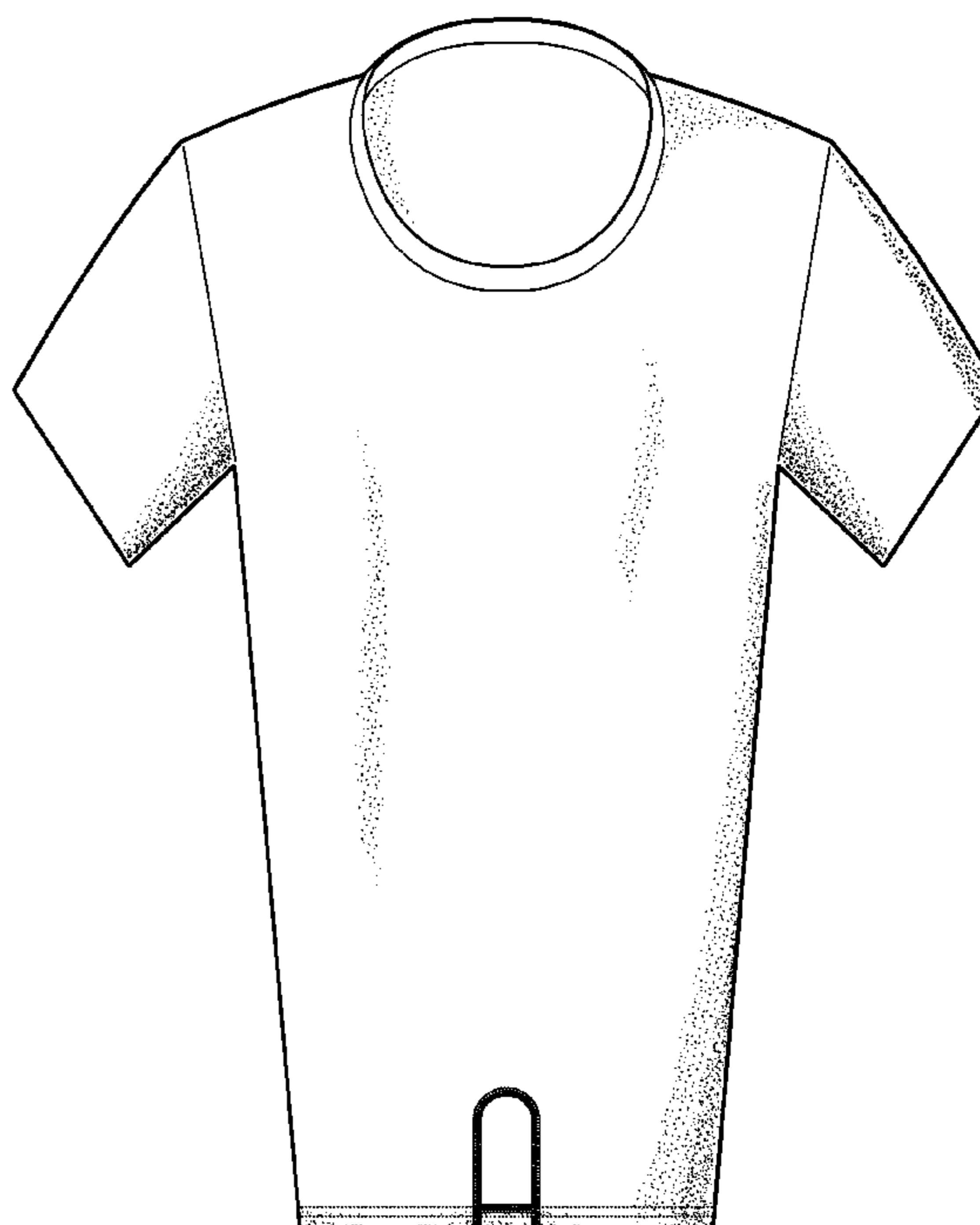
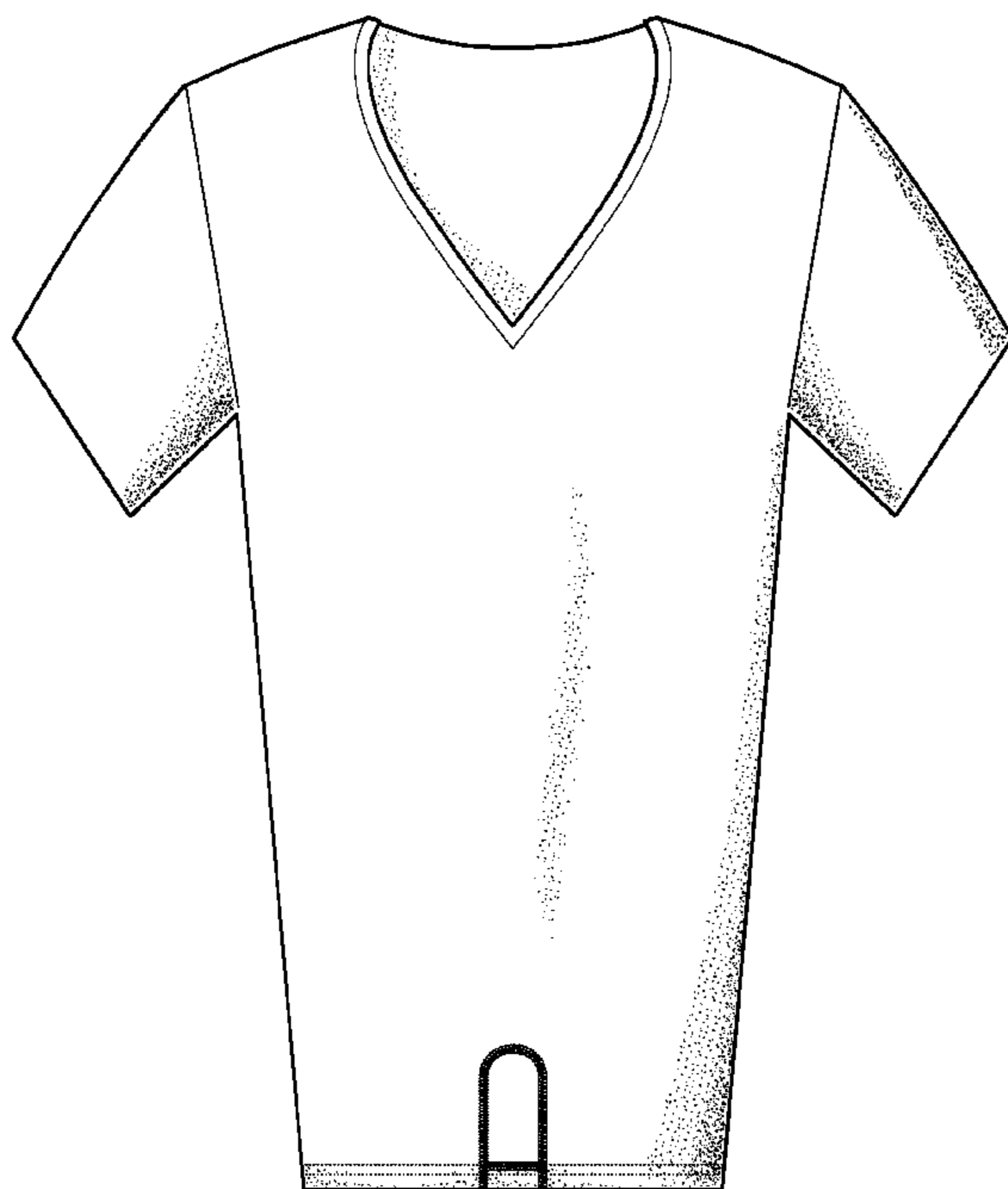
FIG. 13 is a enlarged bottom side view thereof.

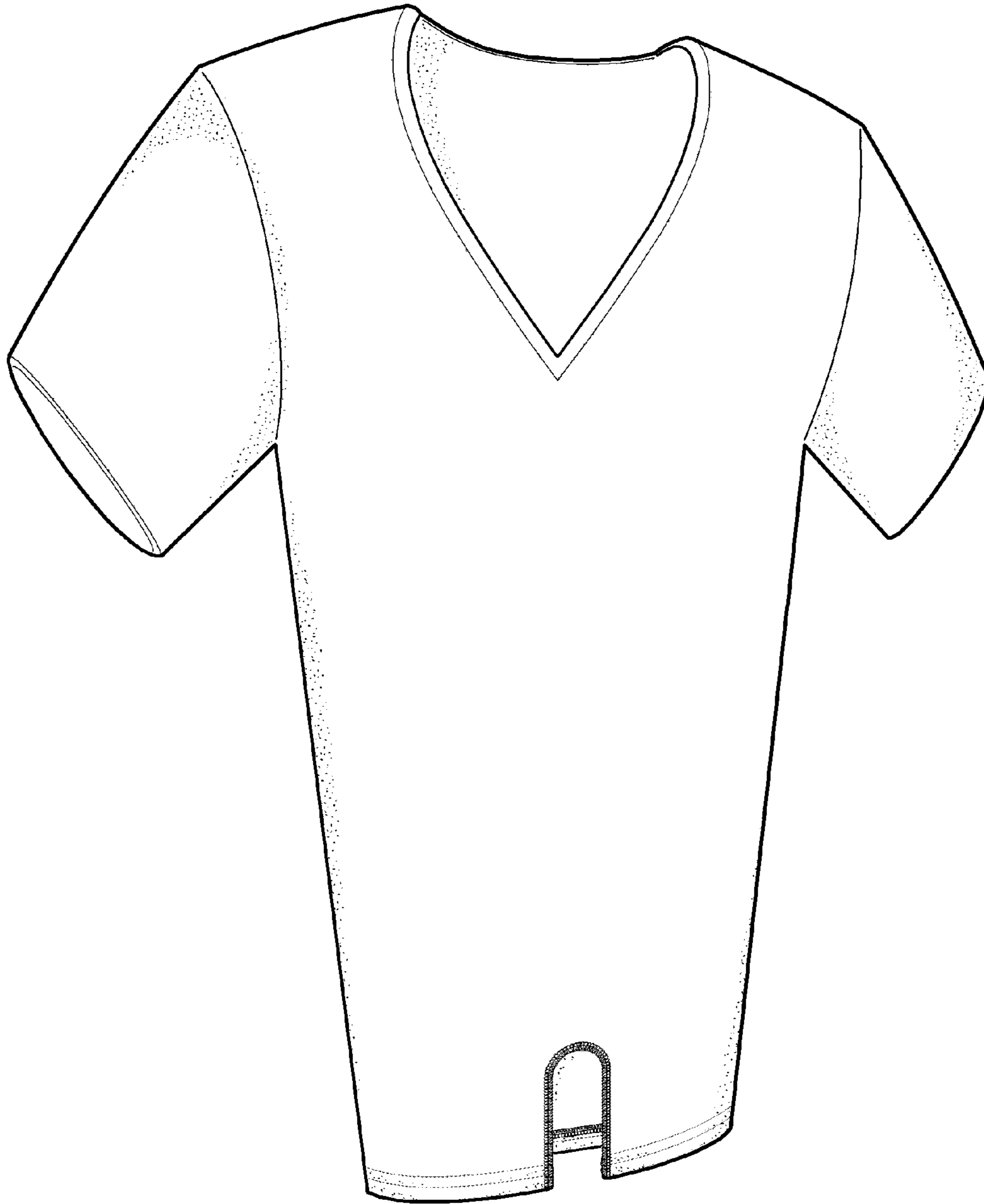

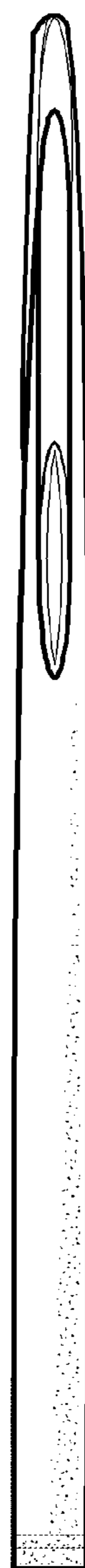

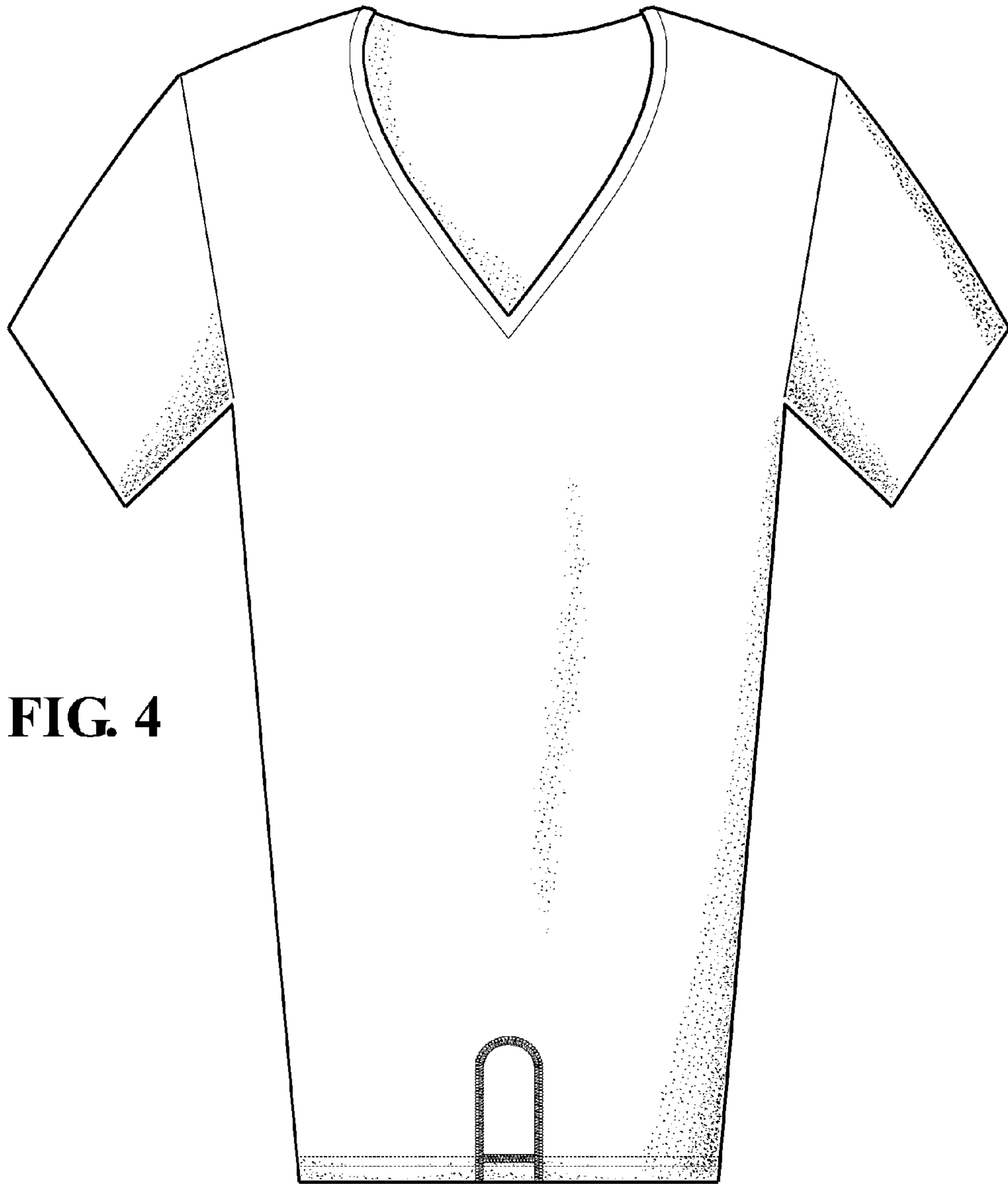
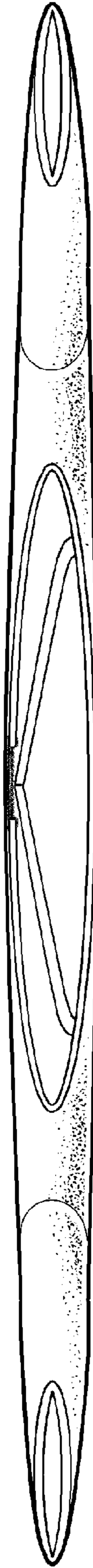

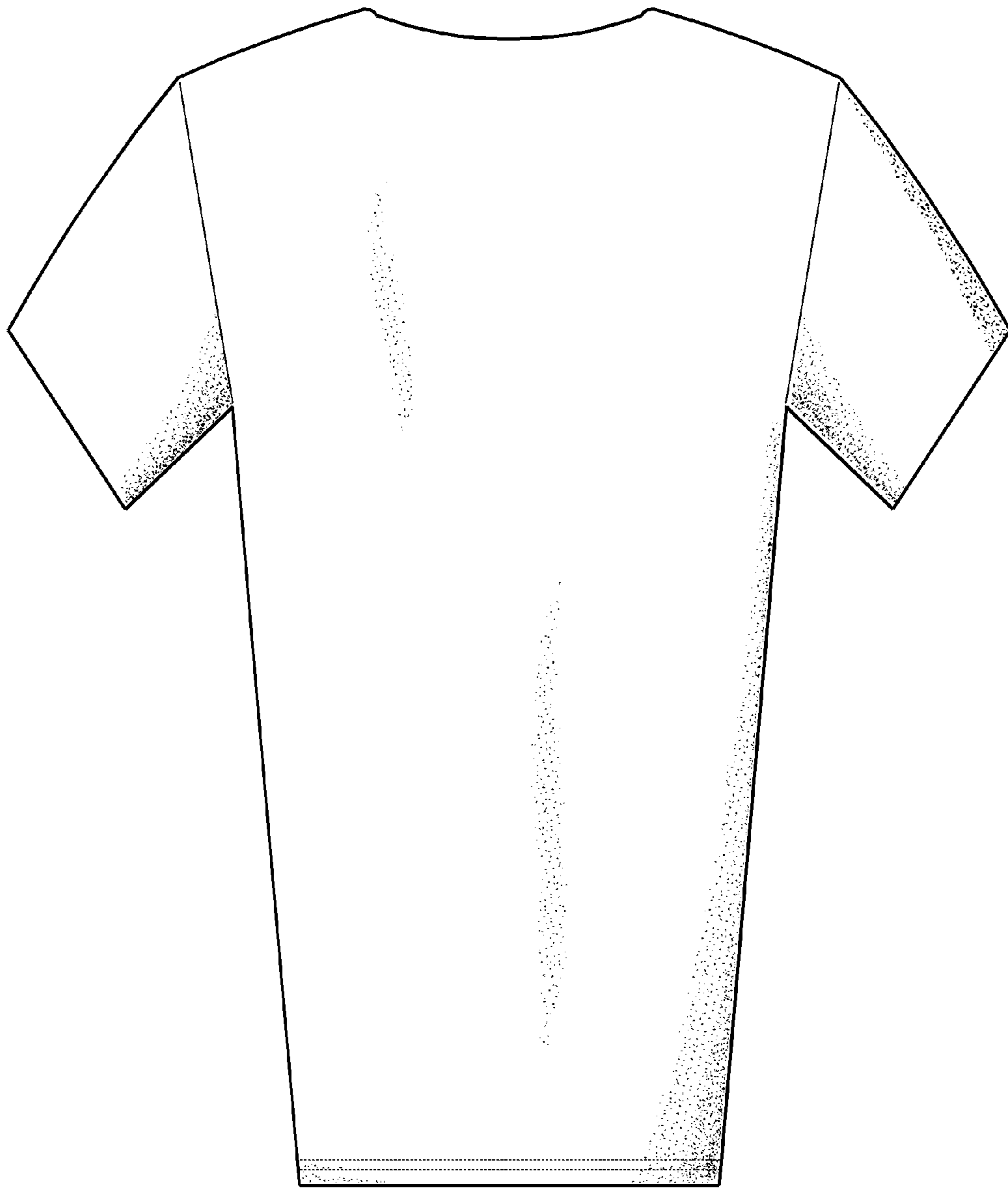

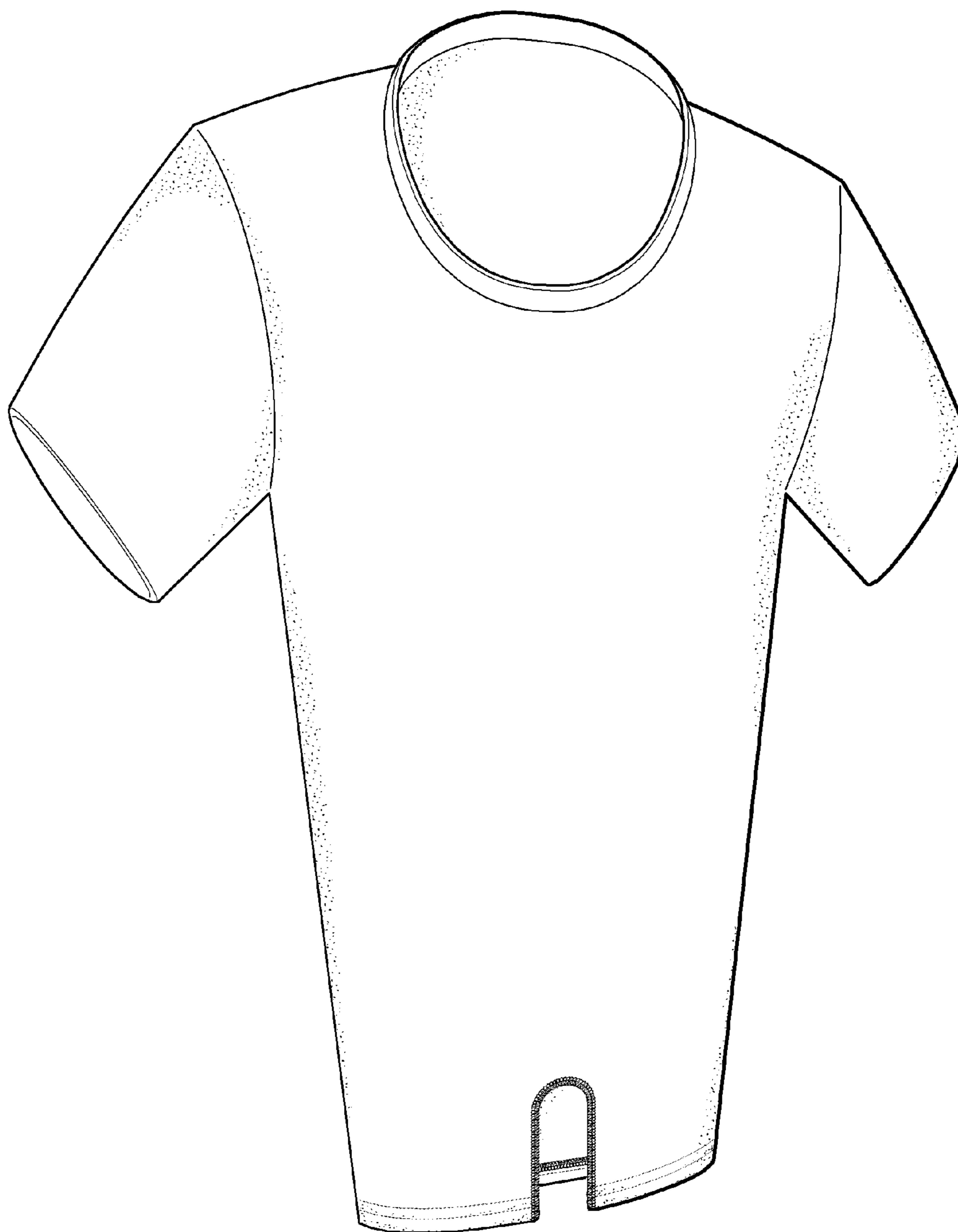

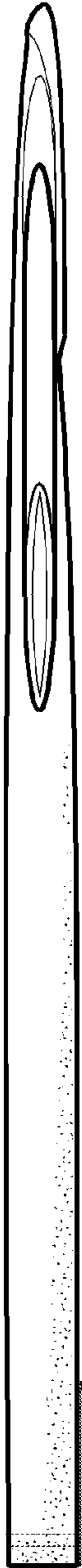

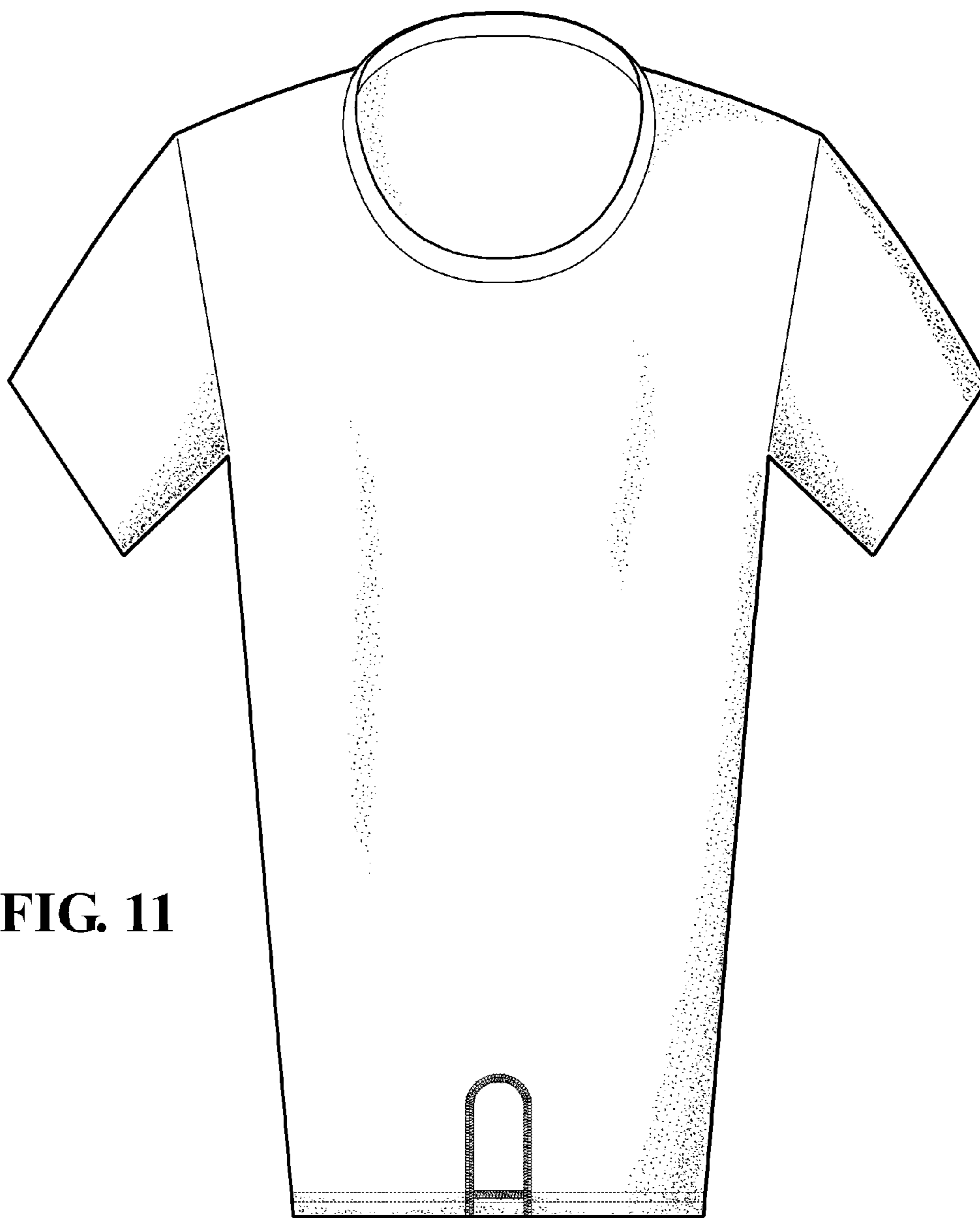

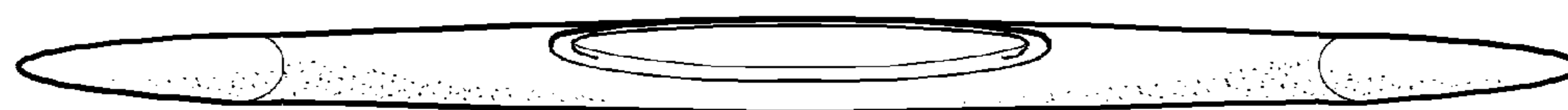

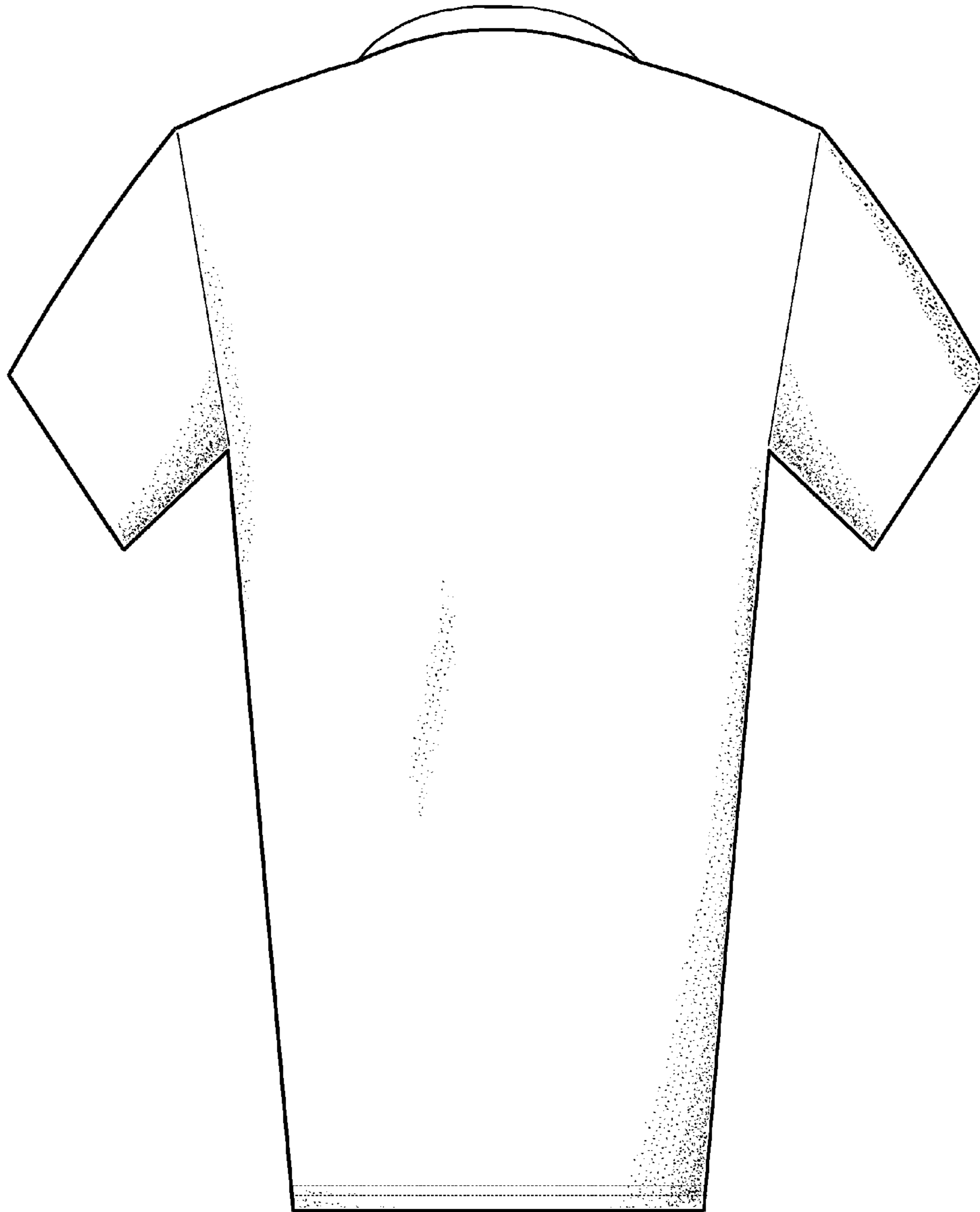

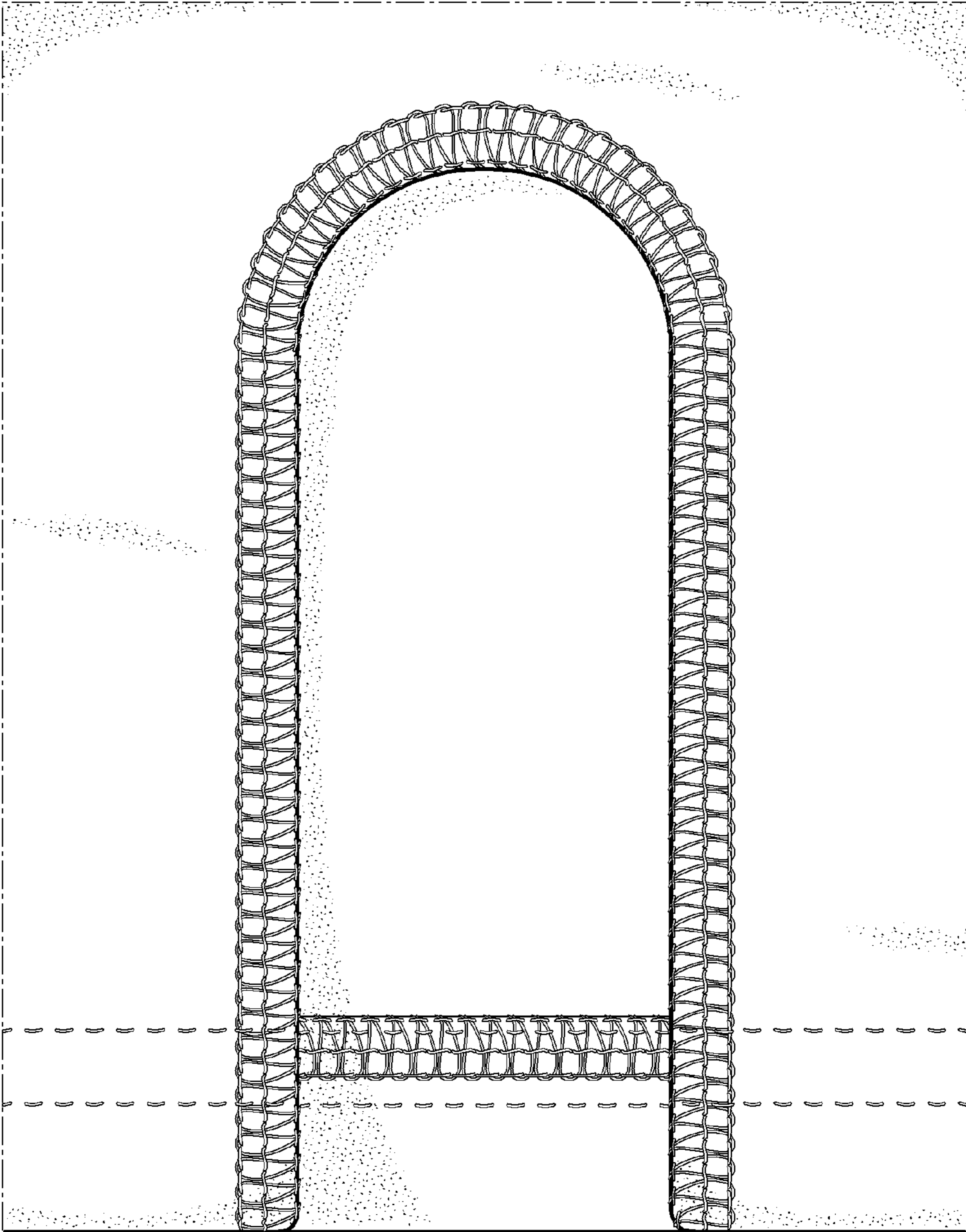
