(57) **CLAIM**

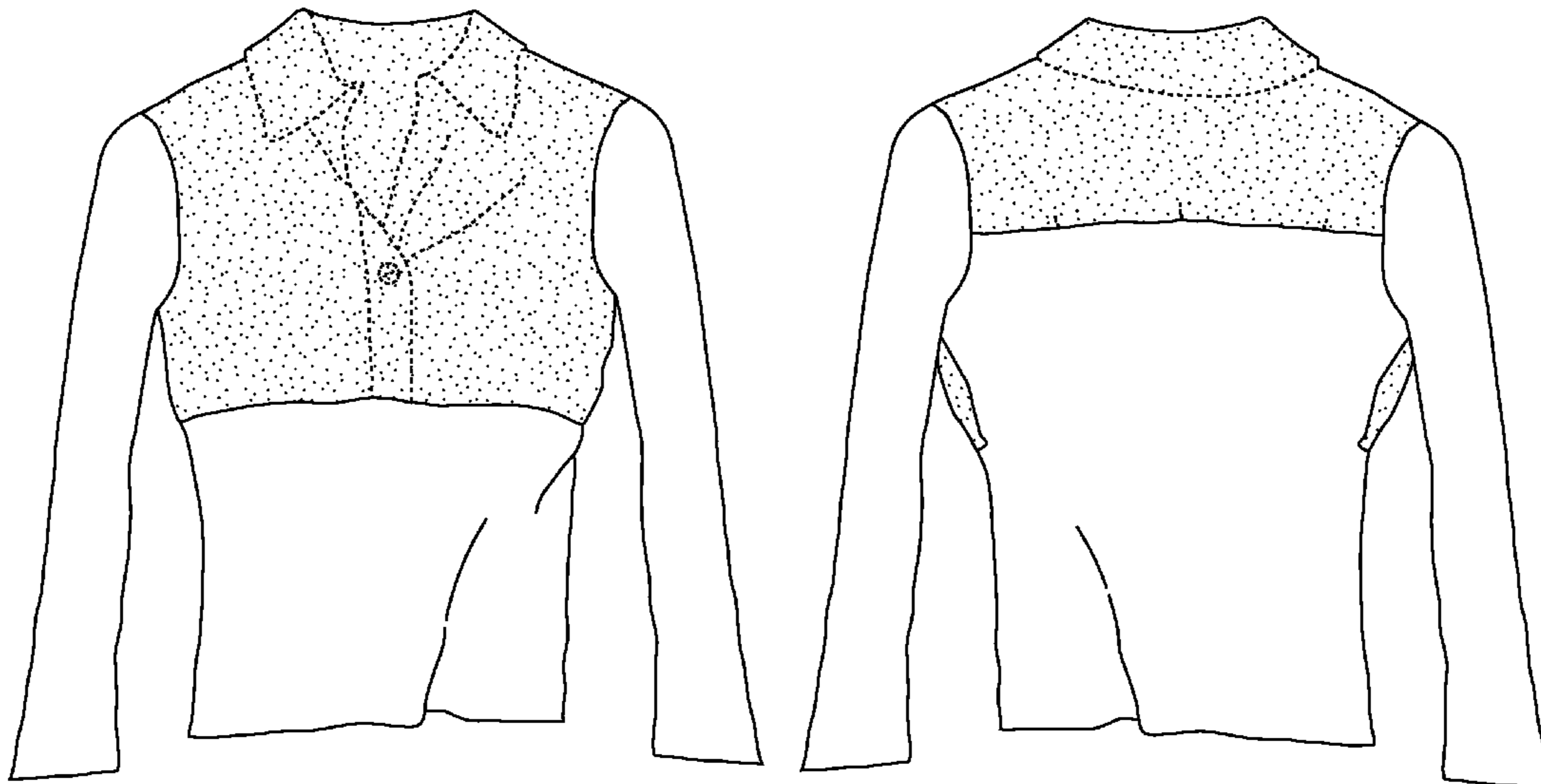
The ornamental design for a multi-texture garment, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front view of a multi-texture garment, the portions shown in broken lines illustrate unclaimed portions of the article and form no part of the claimed design, the stipple shading is to illustrate contrasting material only; and,

FIG. 2 is a rear view of a multi-texture garment, the portions shown in broken lines illustrate unclaimed portions of the article and form no part of the claimed design, the stipple shading is to illustrate contrasting material only.

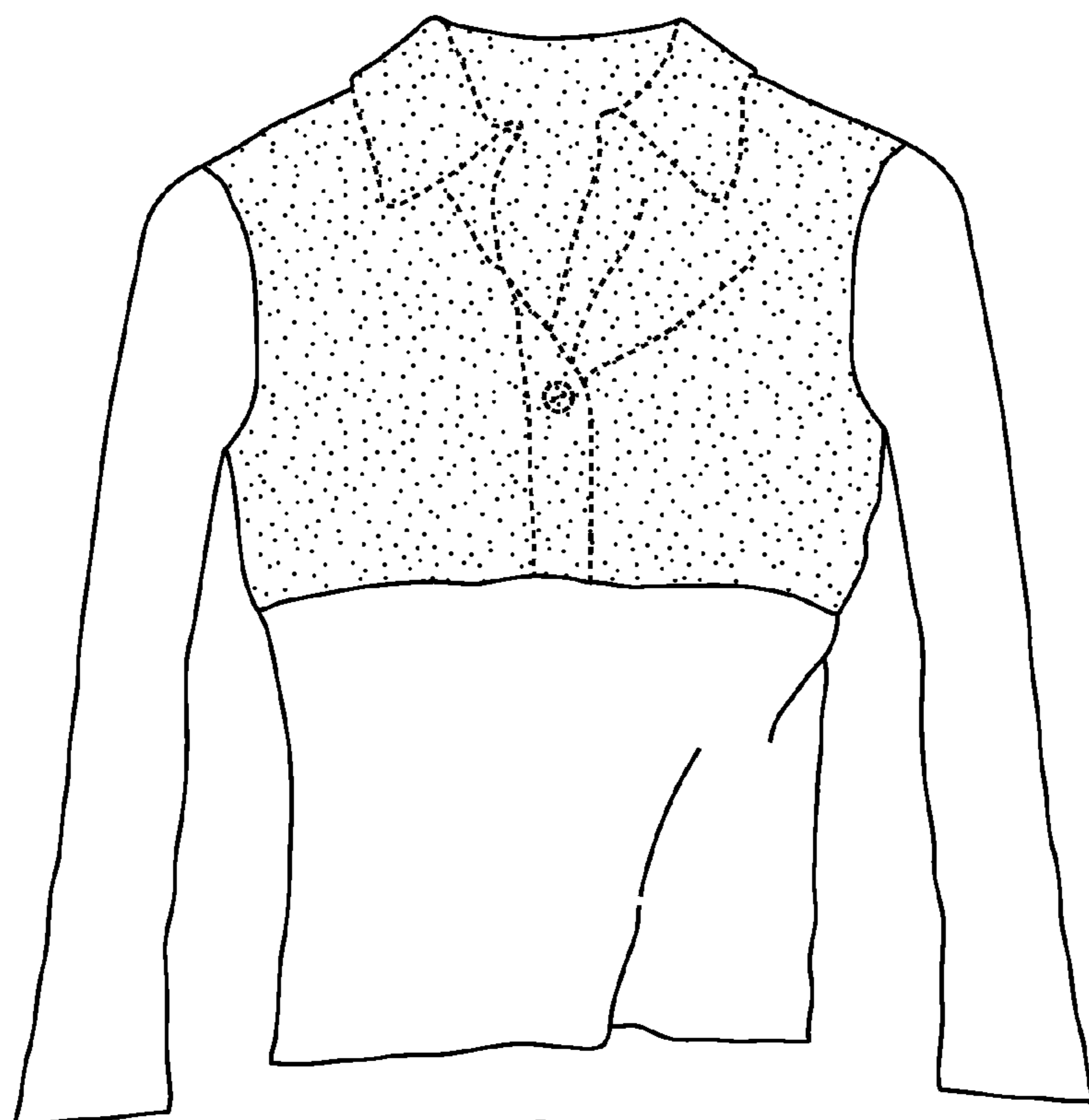

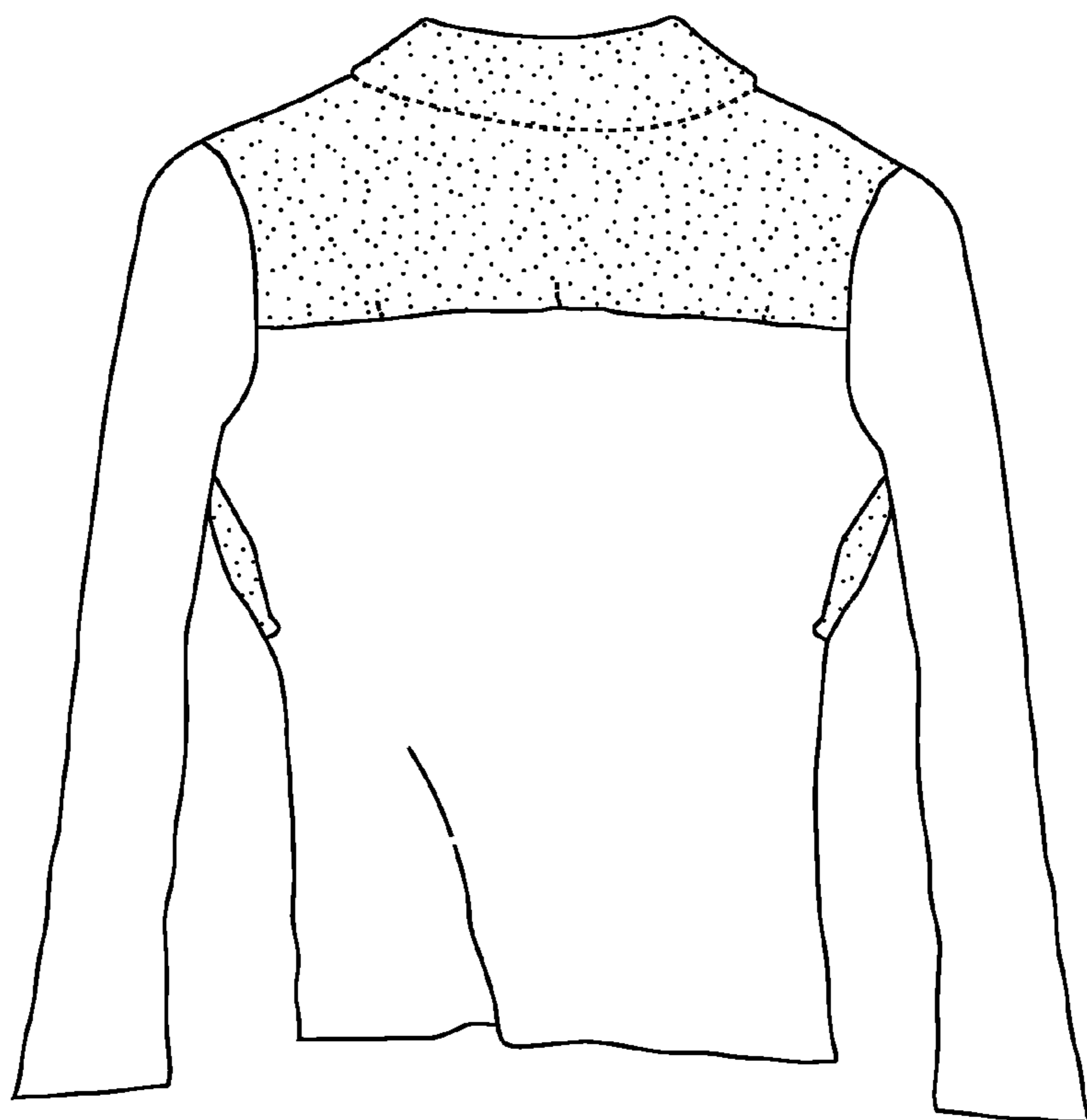
