FIG. 3 is a top plan view of the portfolio shown in FIG. 1.

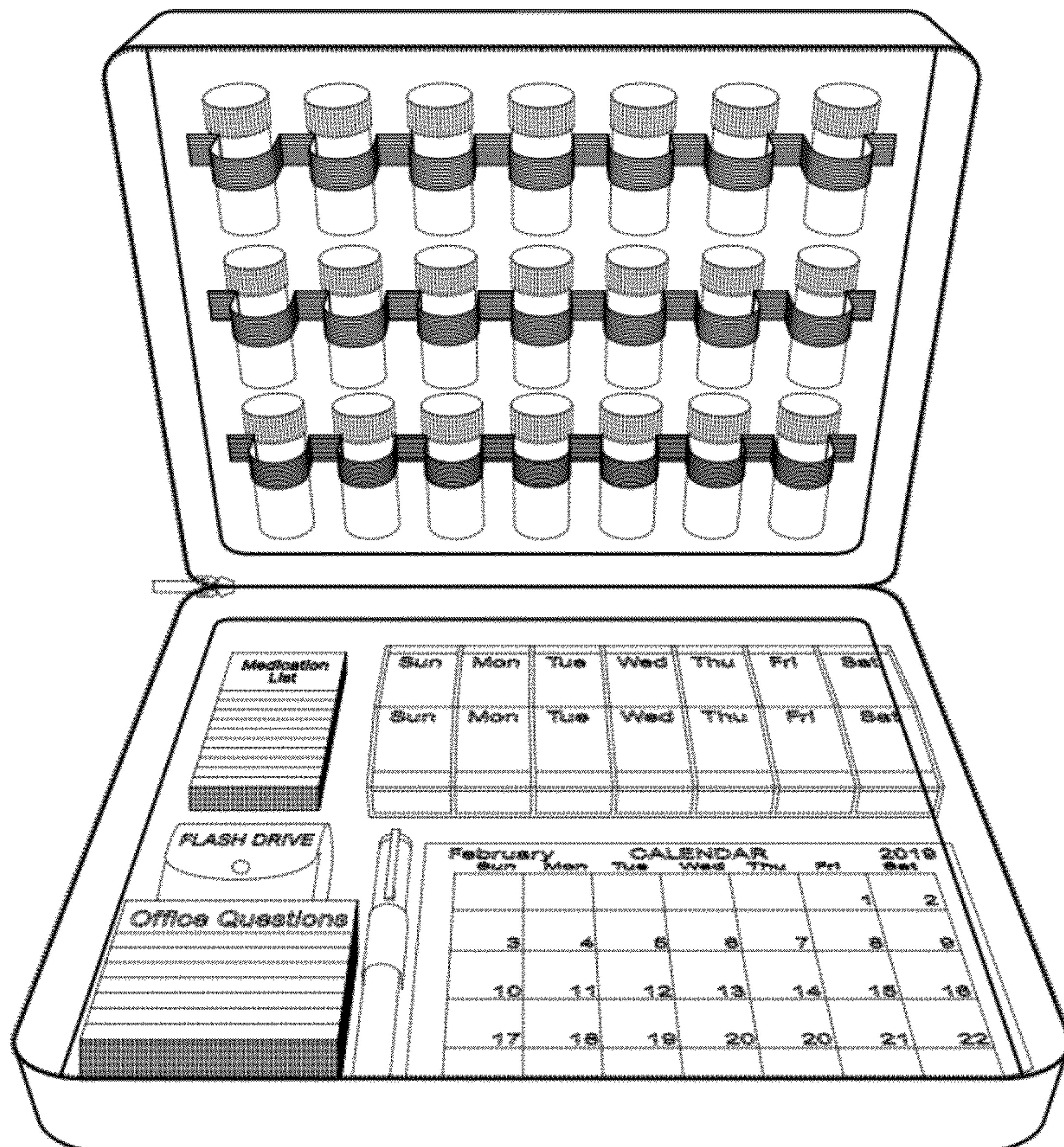
FIG. 4 is a side elevation view of the portfolio shown in FIG. 1; and,

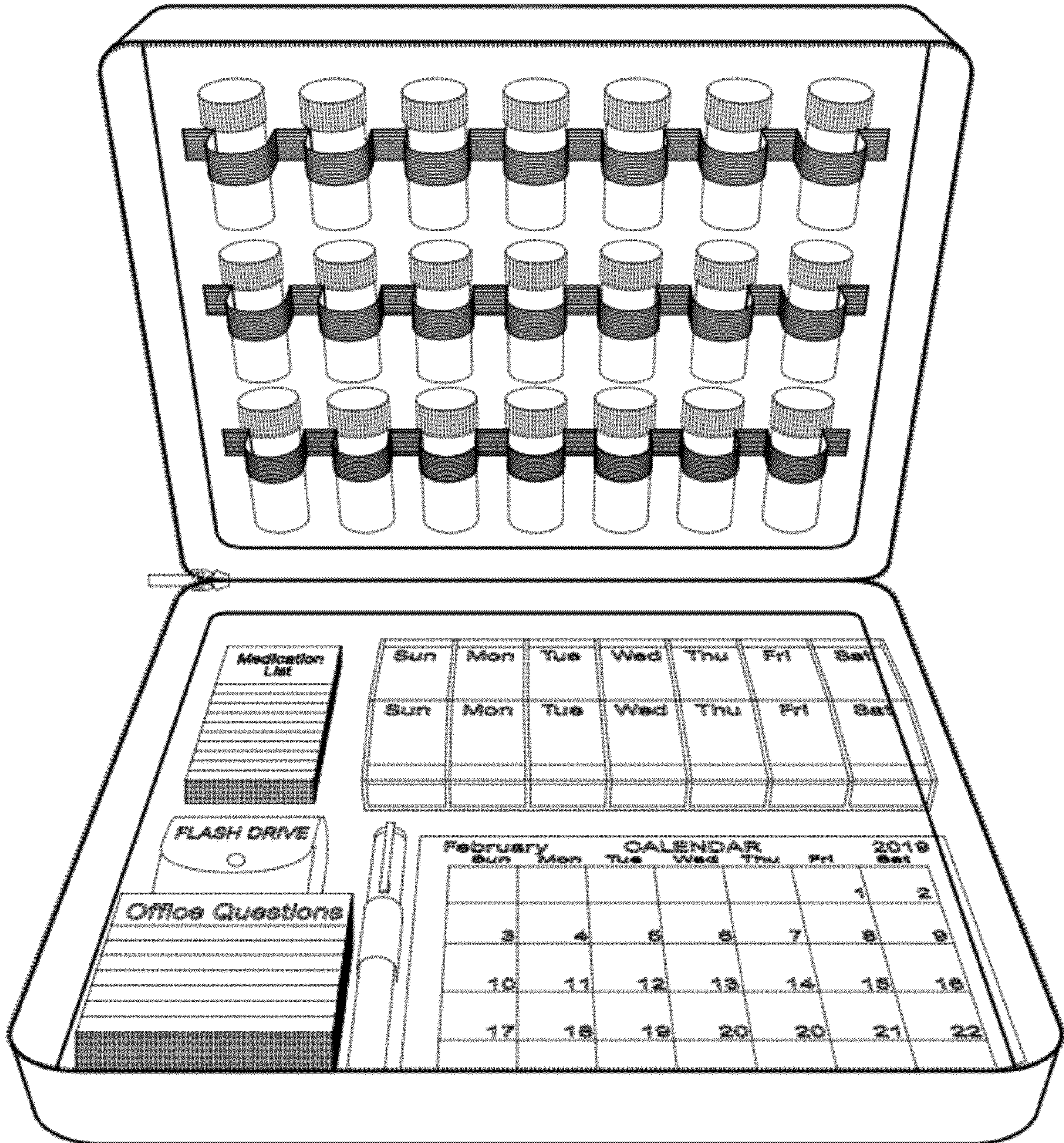

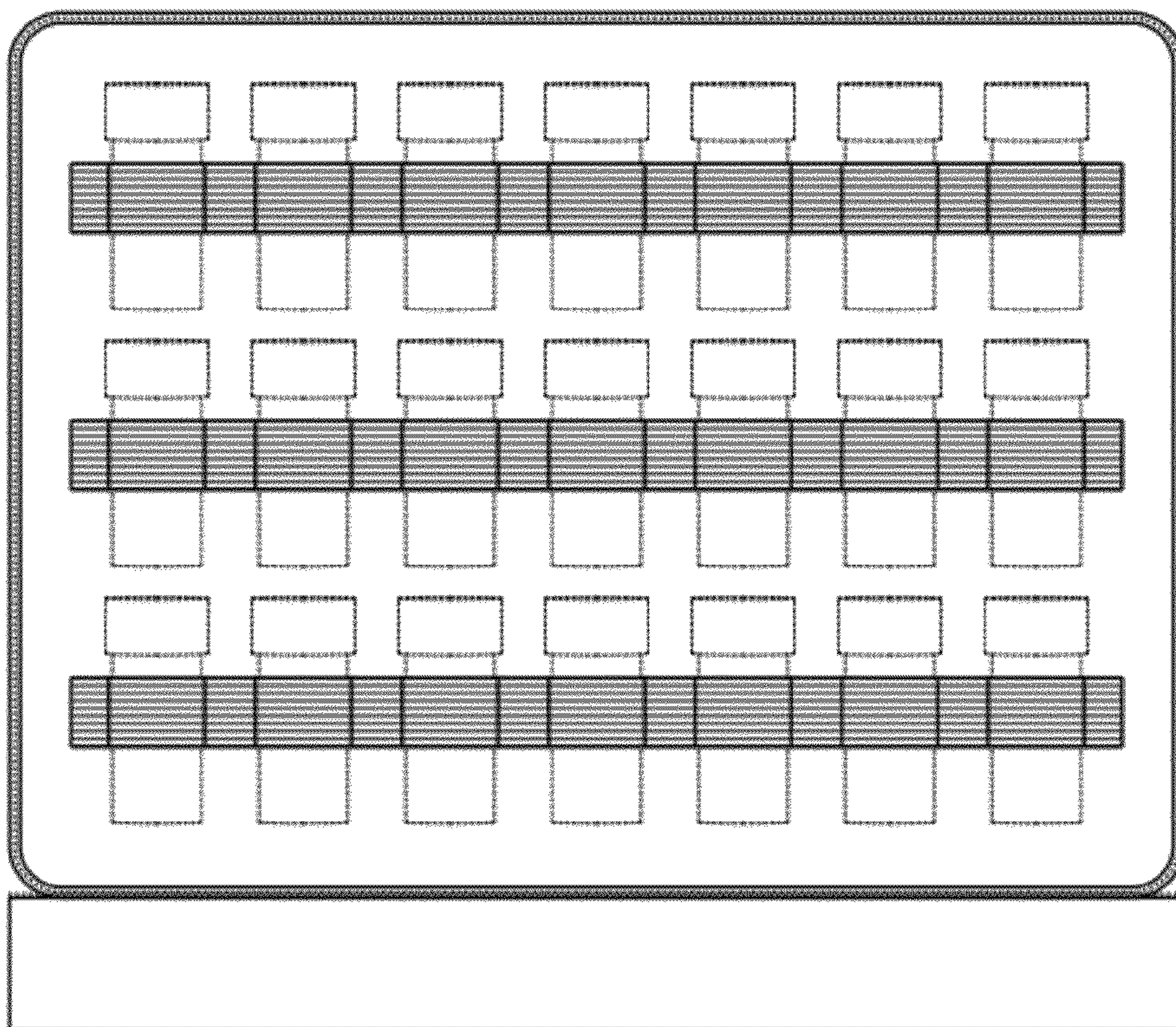

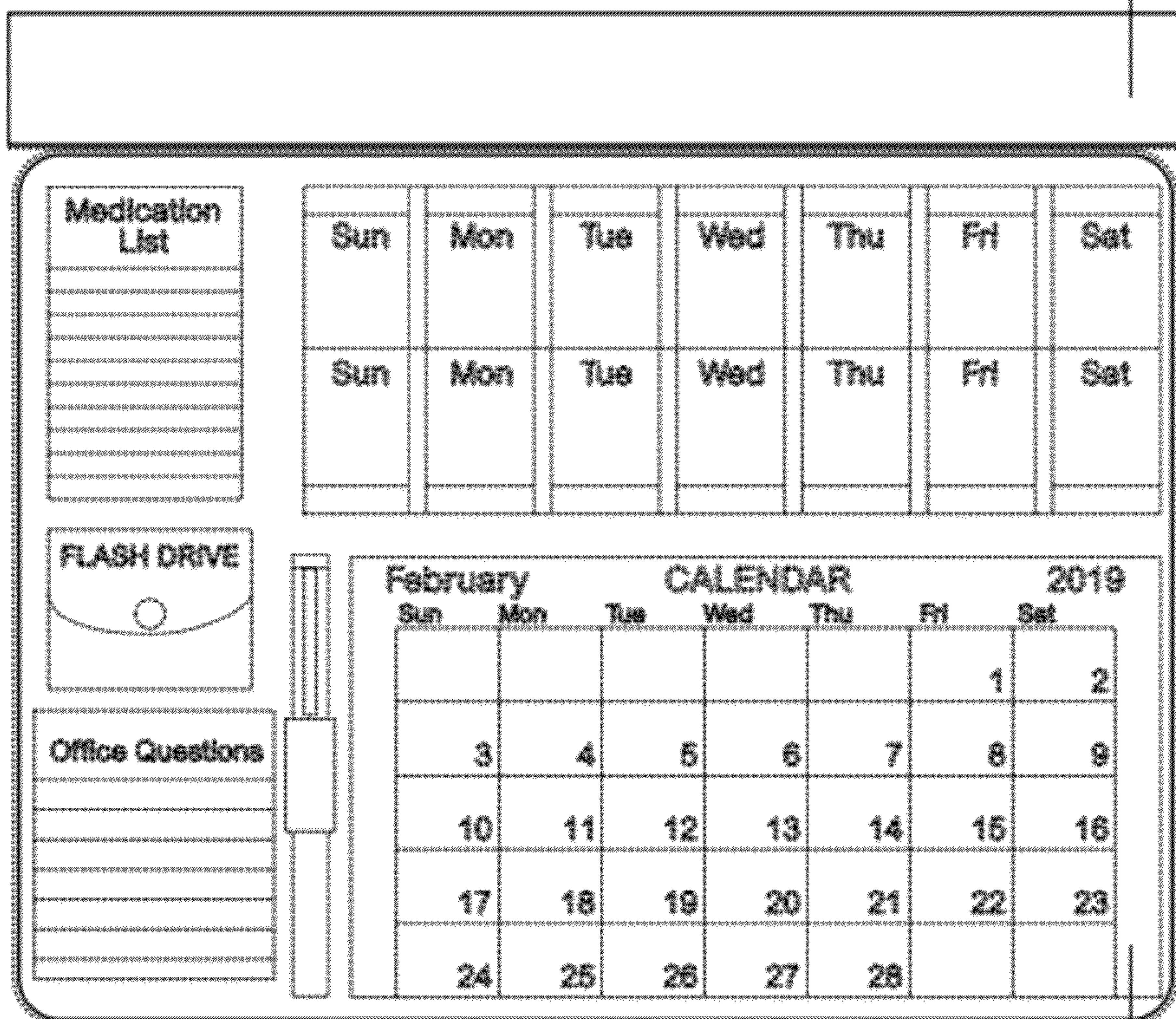
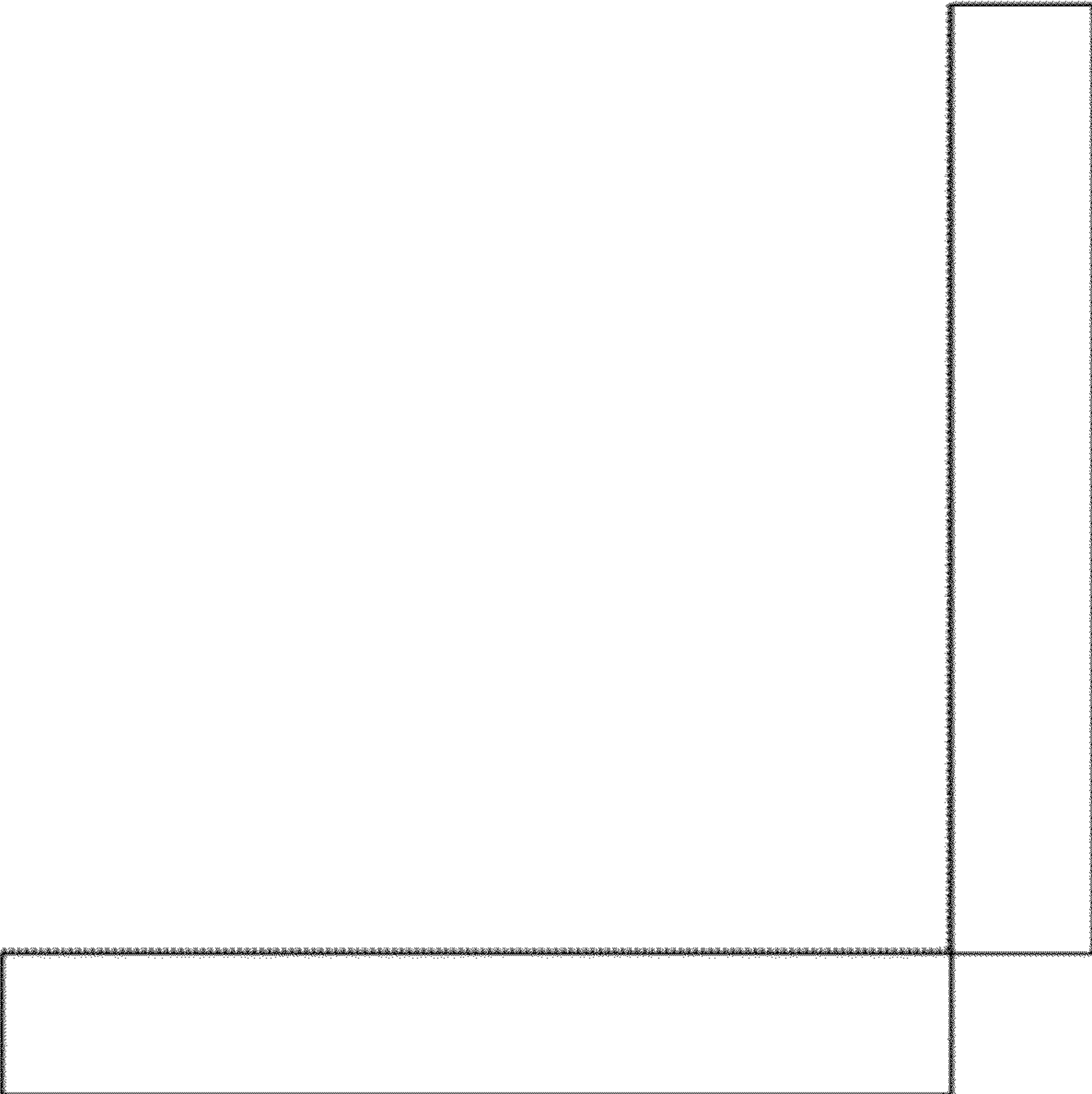


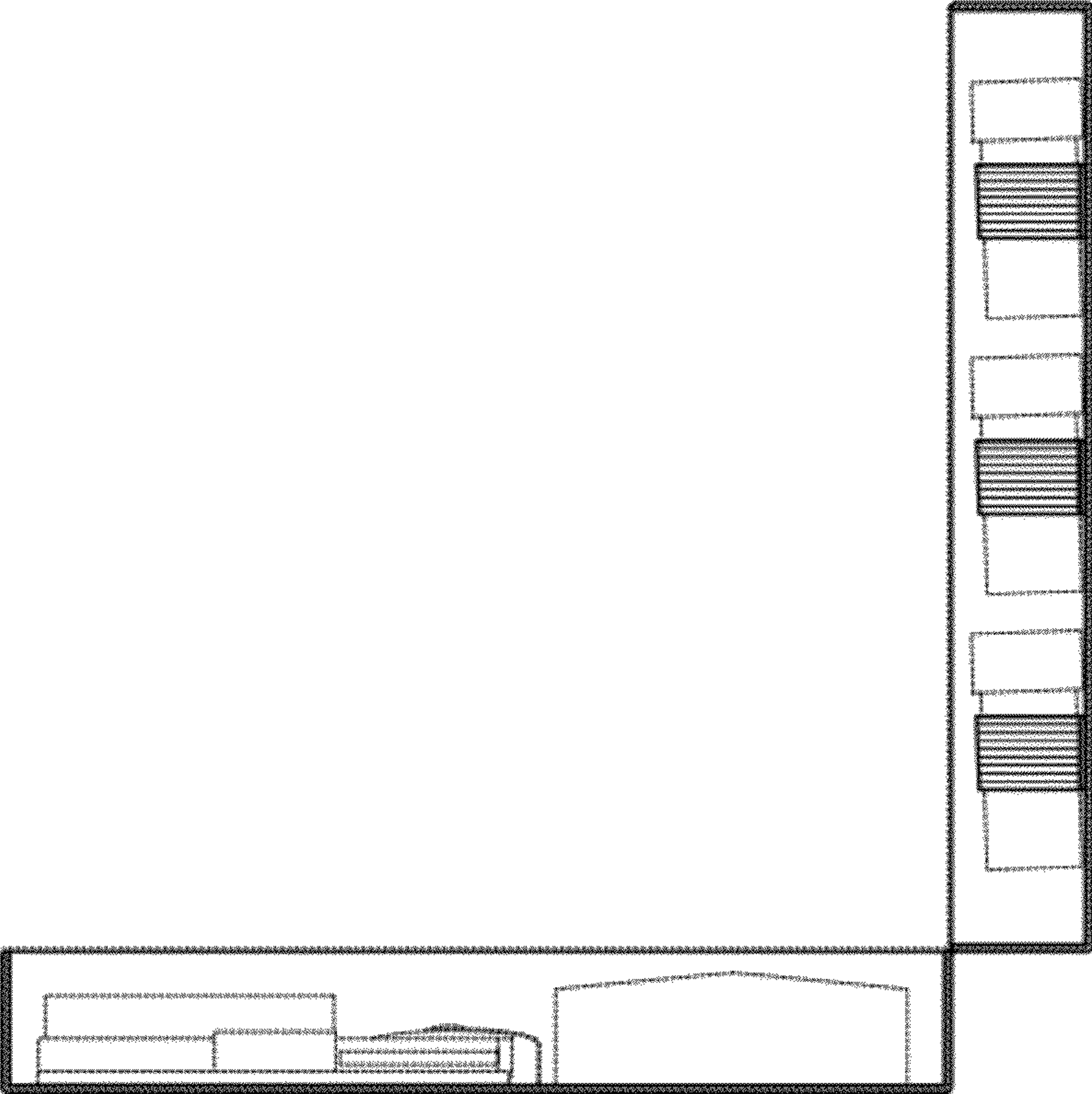
