(57) **CLAIM**

The ornamental design for a laptop case, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a laptop case showing the new design according to an embodiment of the invention; FIG. 2 is a top plan view of the laptop case shown in FIG. 1; FIG. 3 is a rear elevational view of the laptop case shown in FIG. 1;

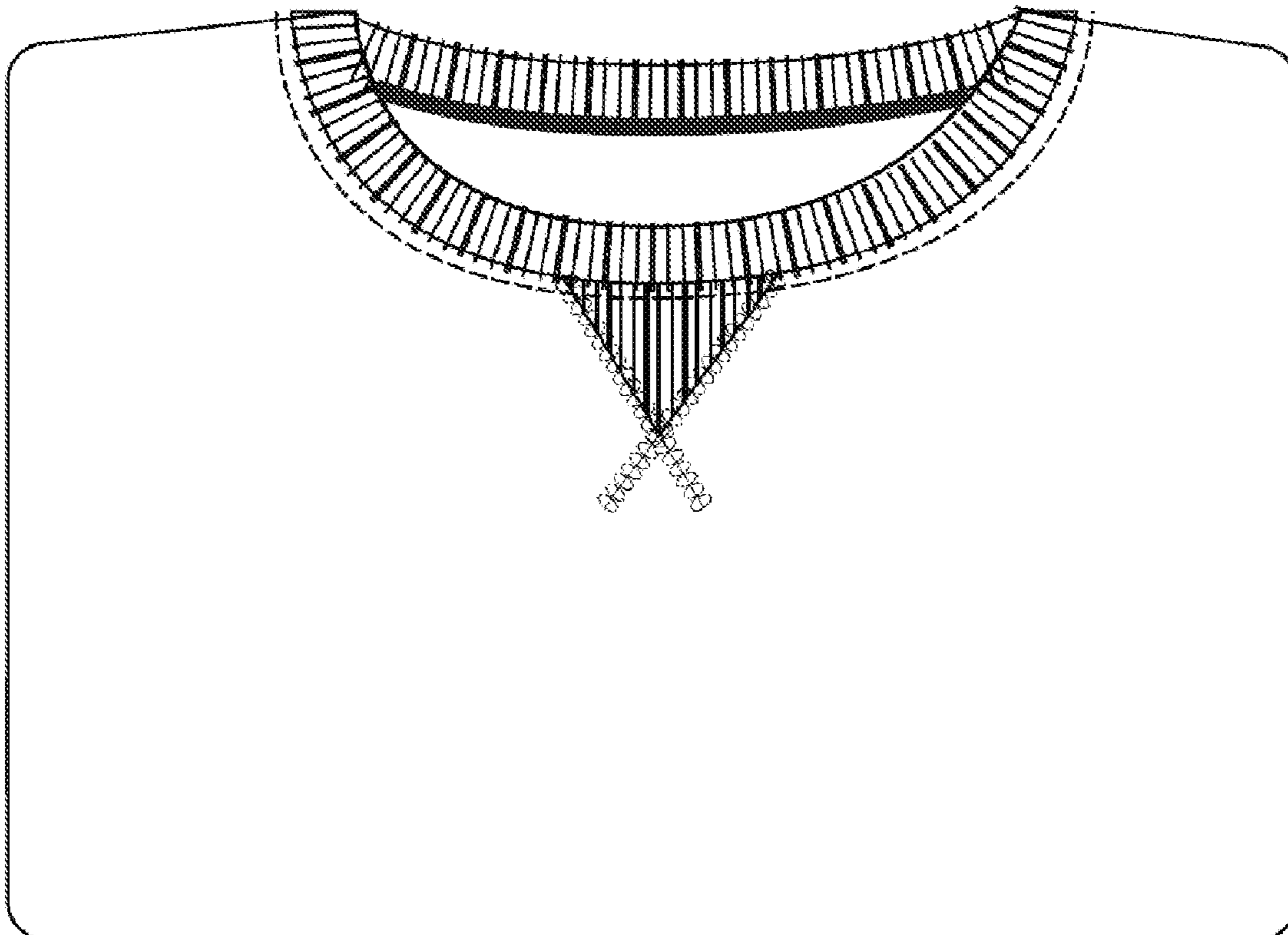
FIG. 4 is a bottom plan view of the laptop case shown in FIG. 1;

FIG. 5 is a left side elevational view of the laptop case shown in FIG. 1, the right side elevational view being a mirror image thereof; and,

FIG. 6 is an alternative left side elevational view of the laptop case shown in FIG. 1, the alternative right side elevational view being a mirror image thereof.

The dashed lines represent stitching and are part of the claimed design.

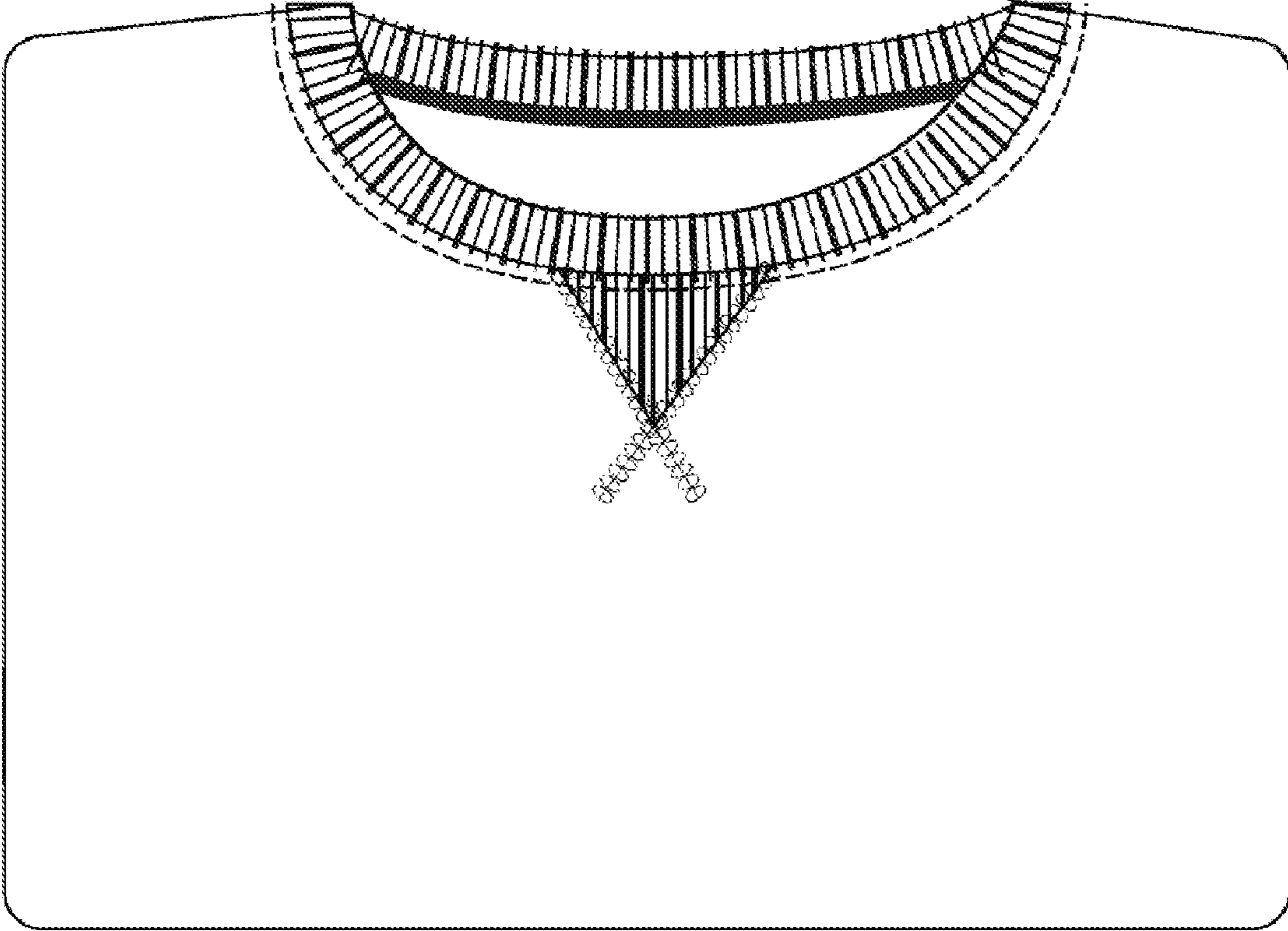

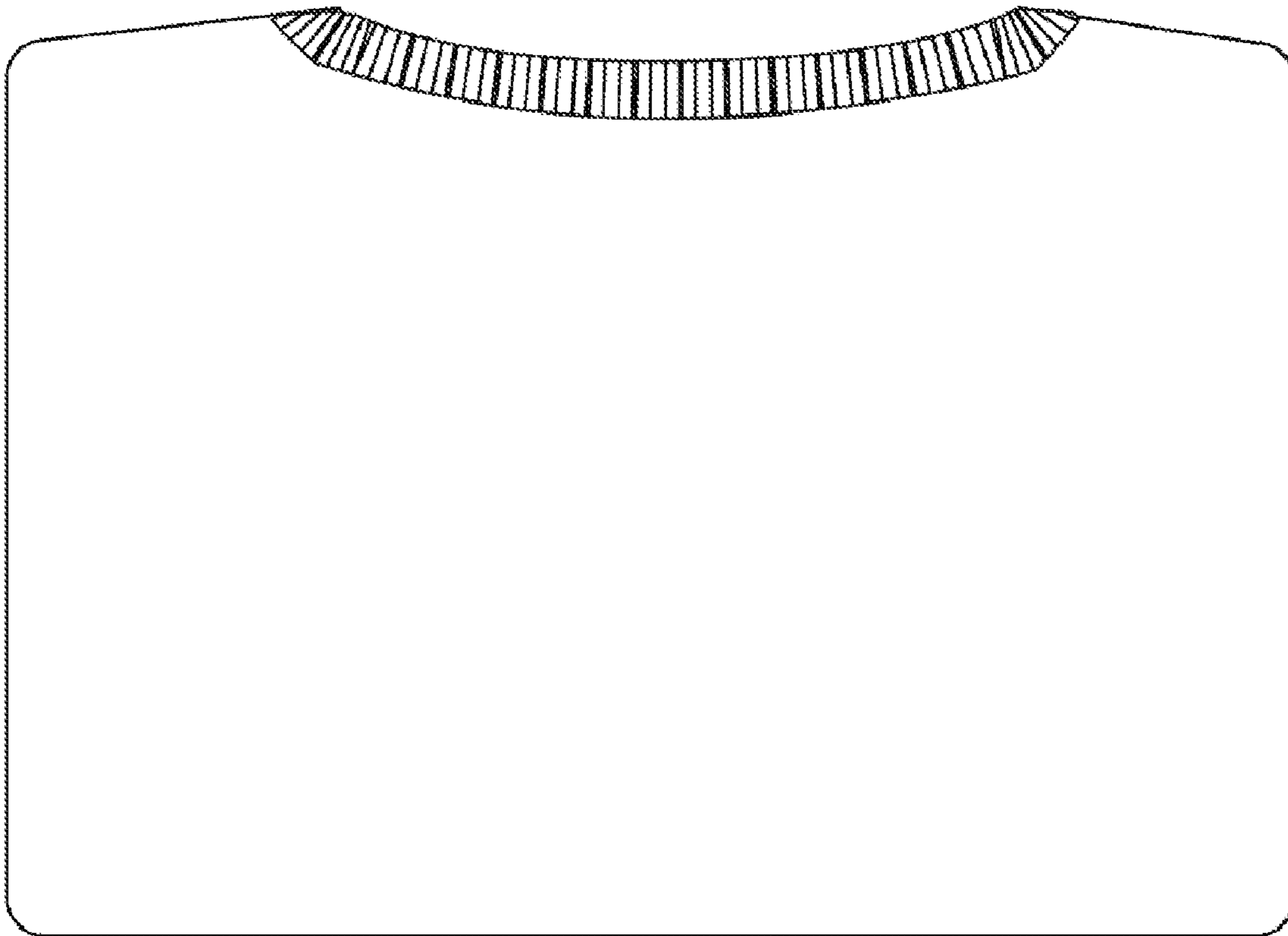

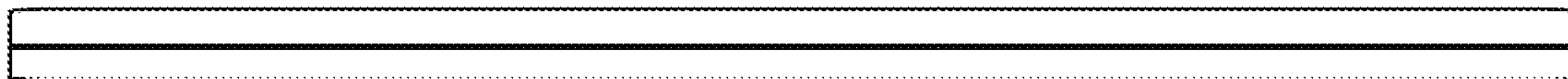

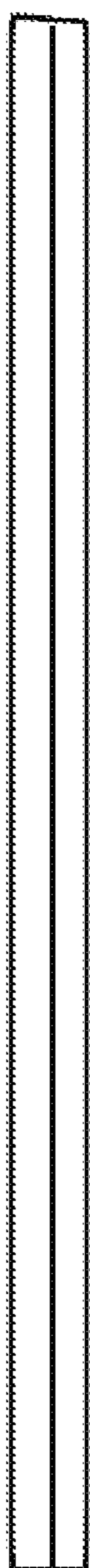

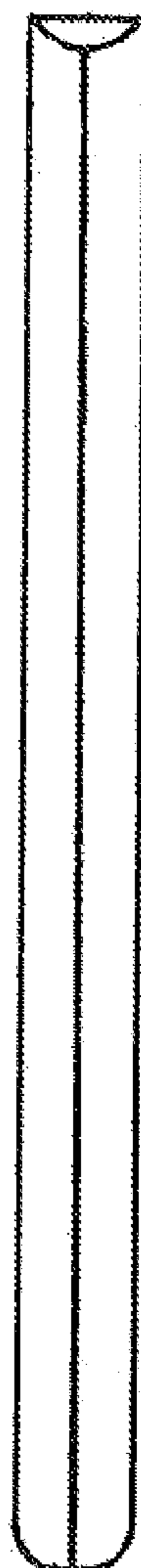
