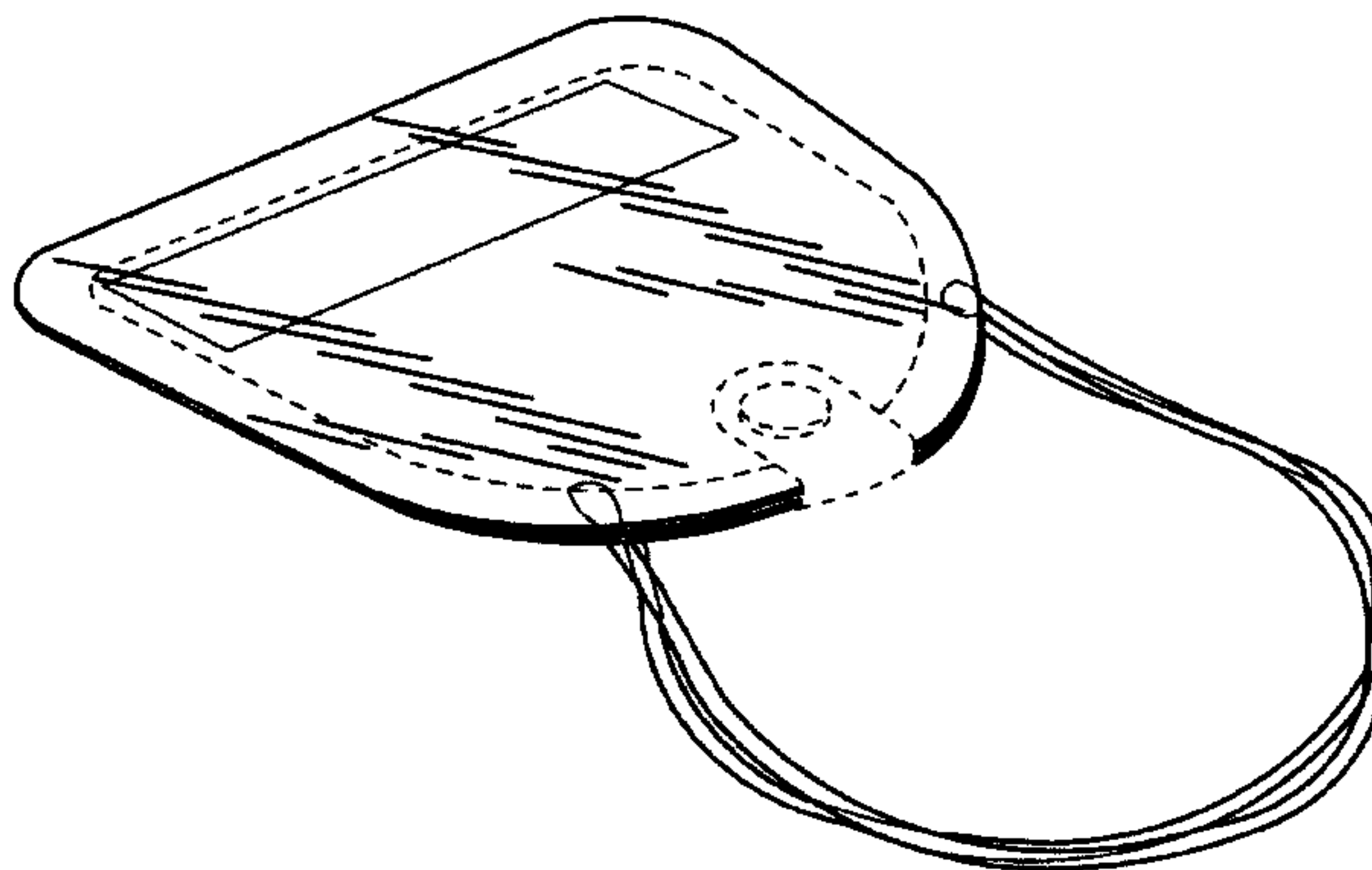
(57) **CLAIM**

The ornamental design for a financial transaction card with storage chamber, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, perspective view of a financial transaction card with storage chamber showing our new design; FIG. 2 is a rear, perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a right side view thereof, the left side view being a mirror image thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The broken lines showing stitching and a fastening tab are for the purposes of illustrating environment and form no part of the claimed design.

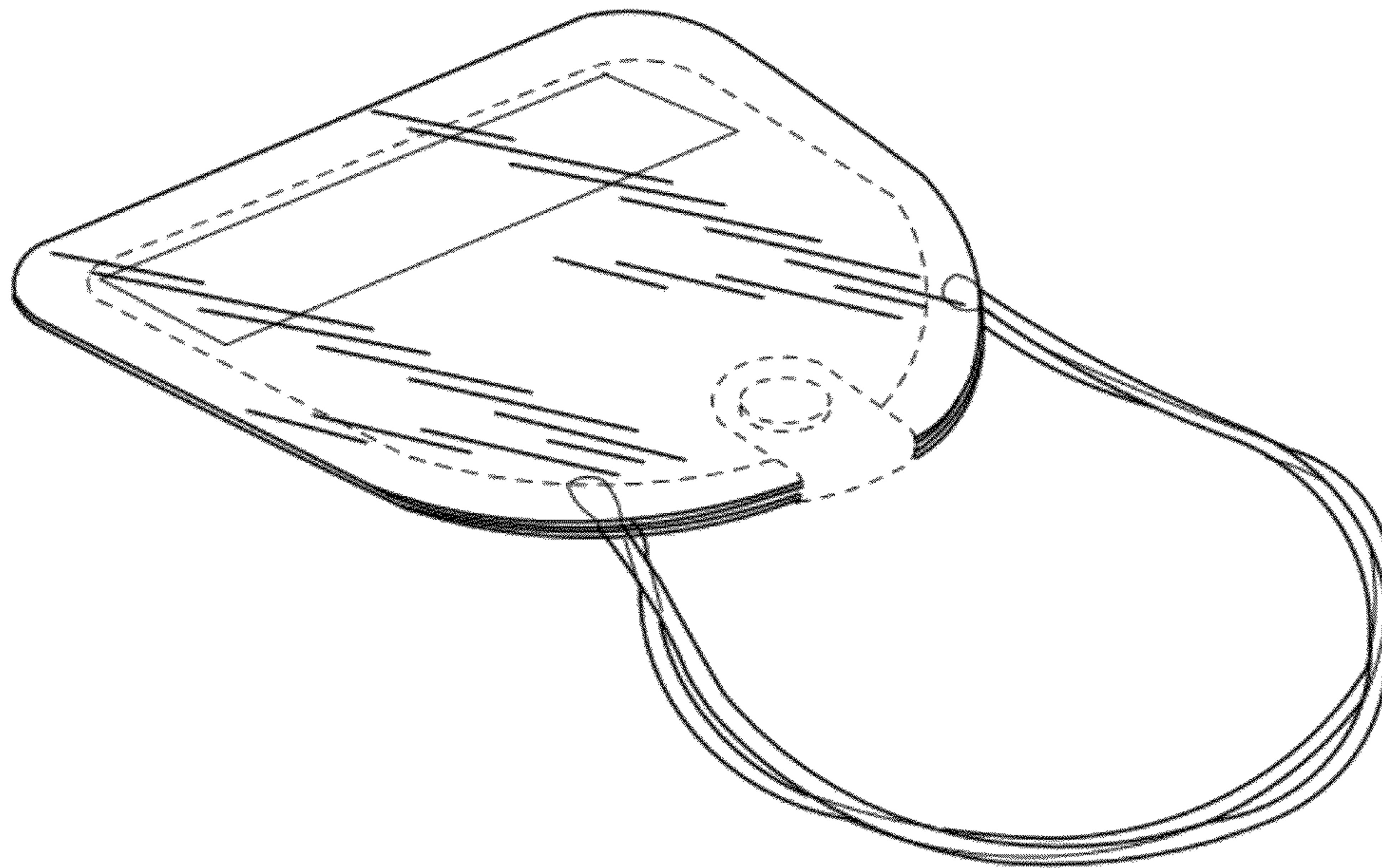

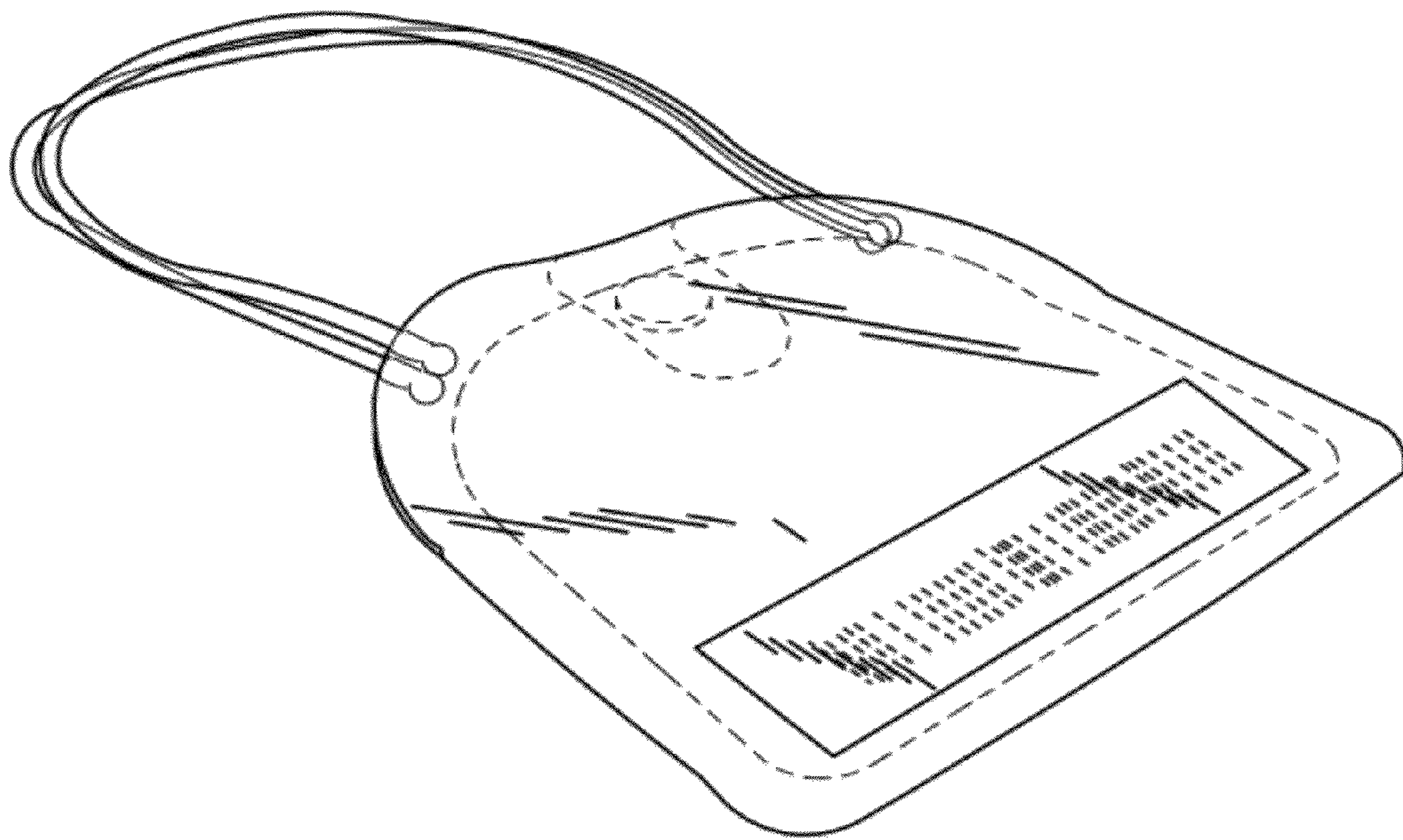

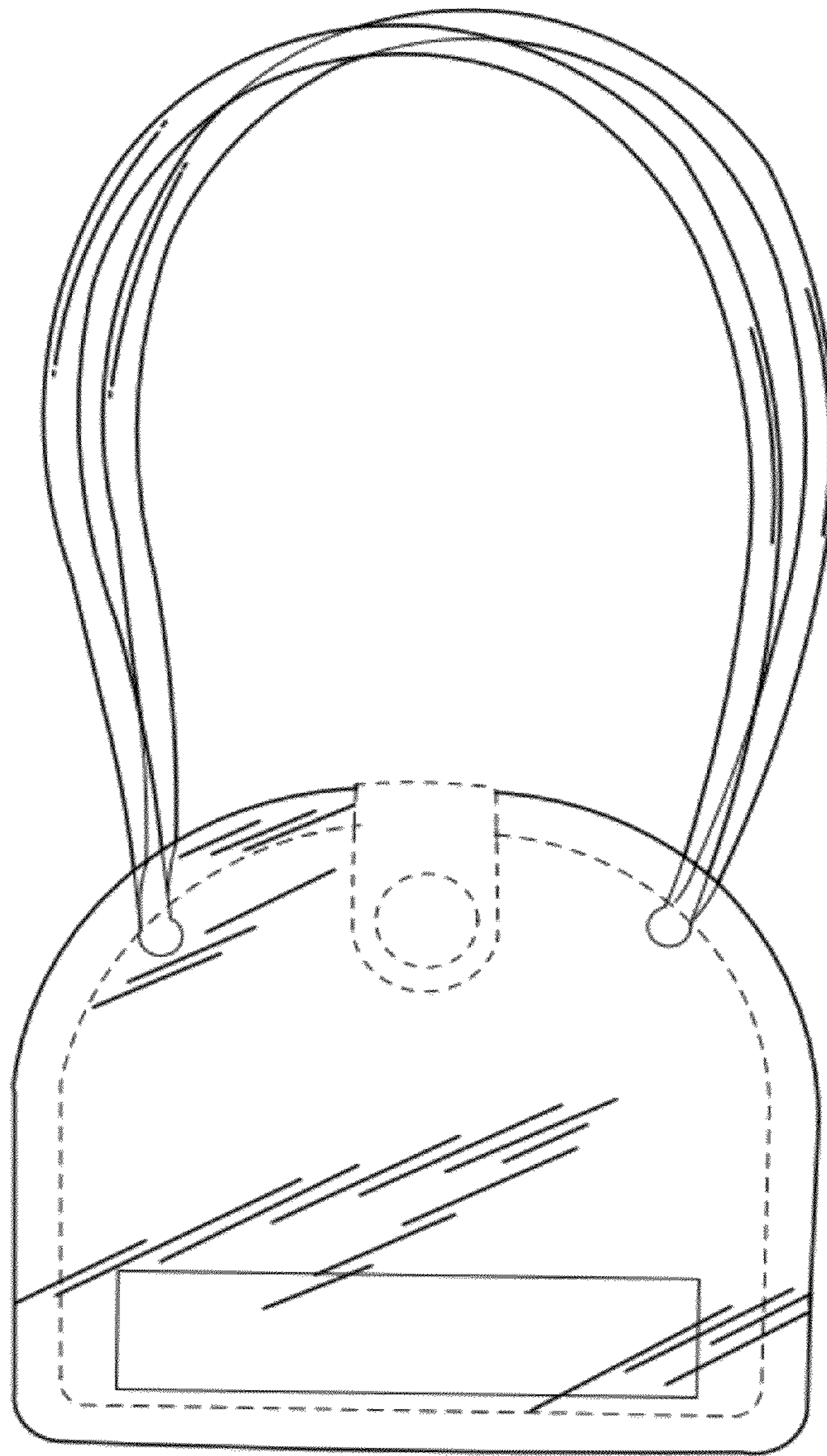

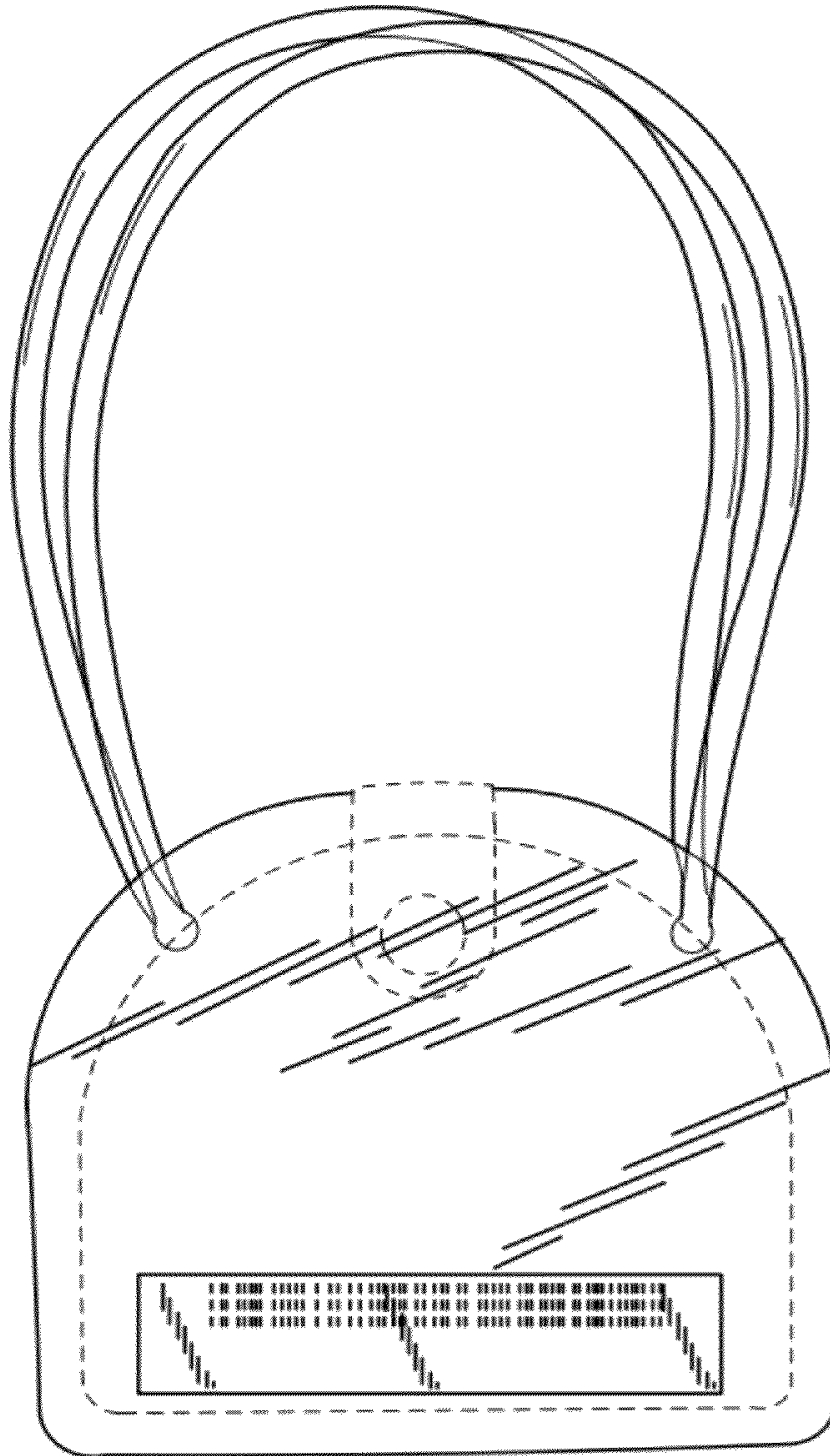

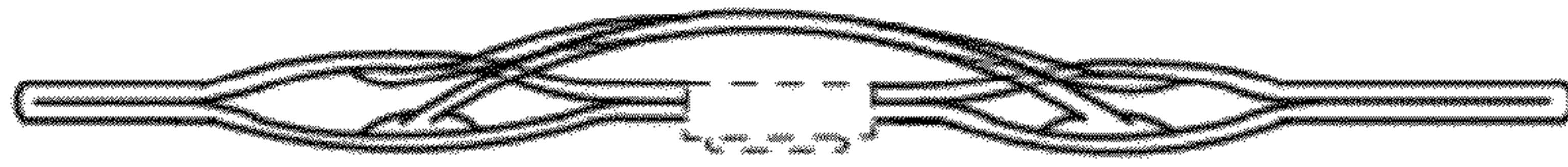
