(57) **CLAIM**

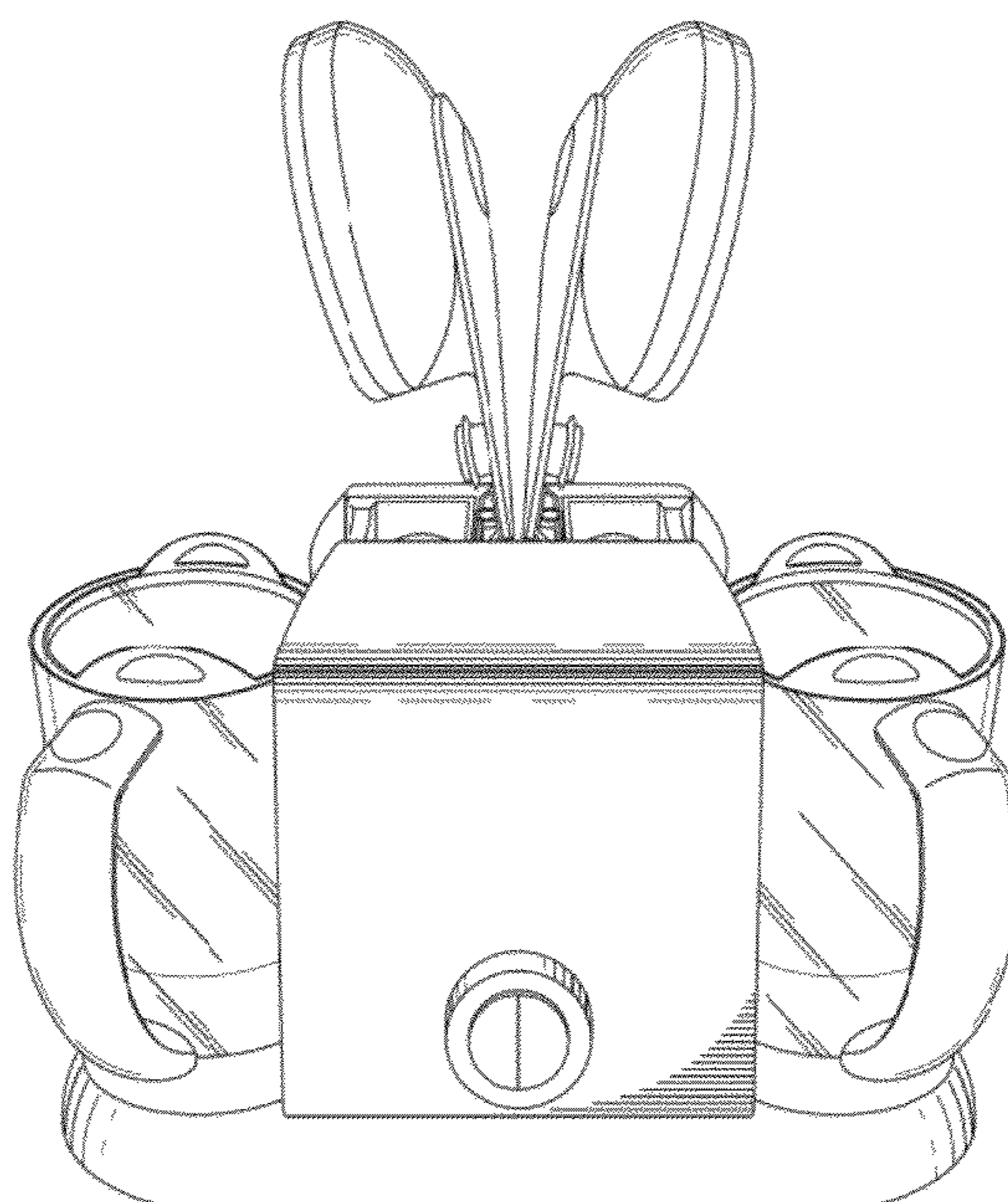
The ornamental design for an electric mixer, as shown and described.

DESCRIPTION

FIG. 1 is front perspective view of an electric mixer illustrating my new design;

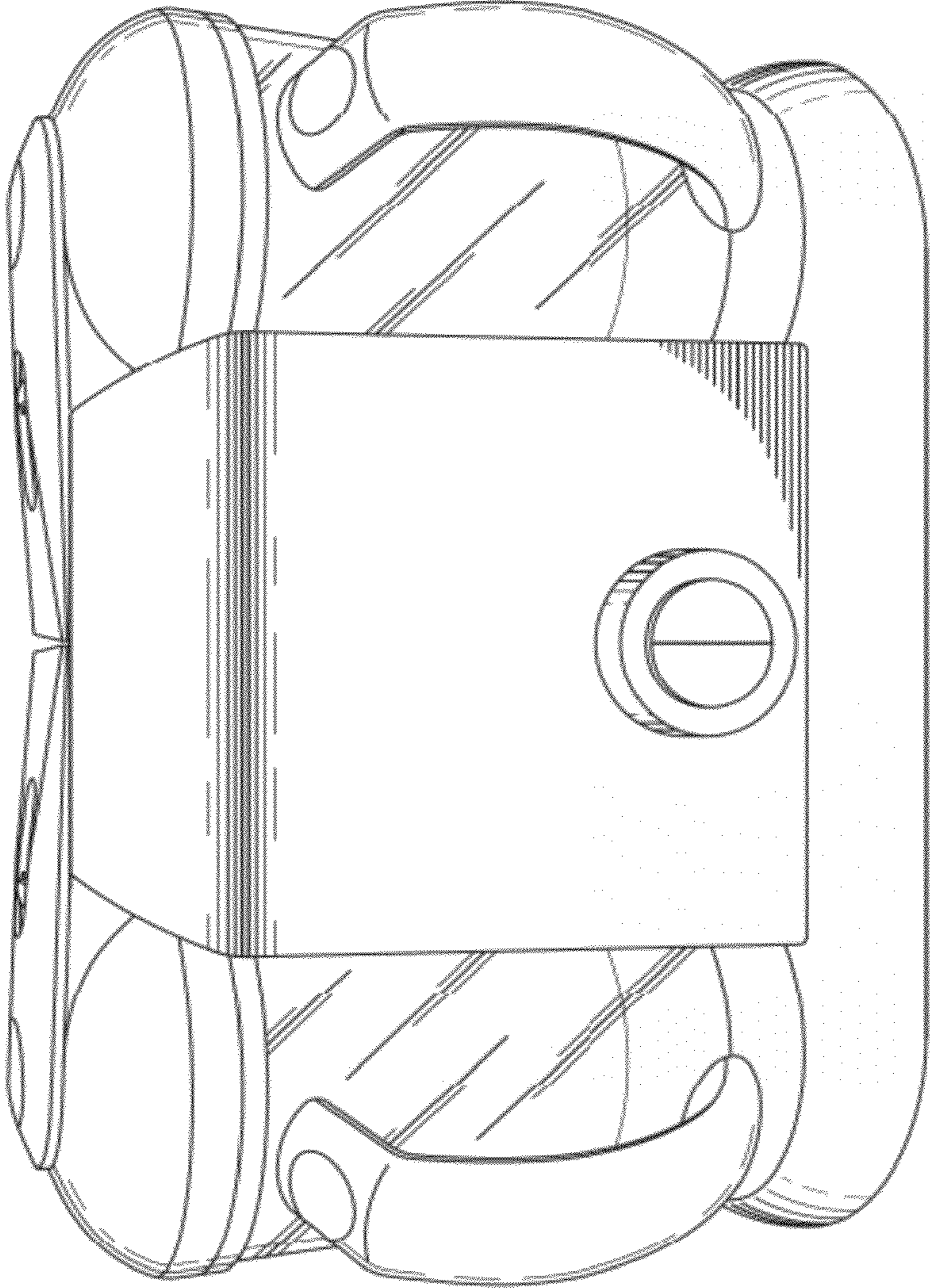

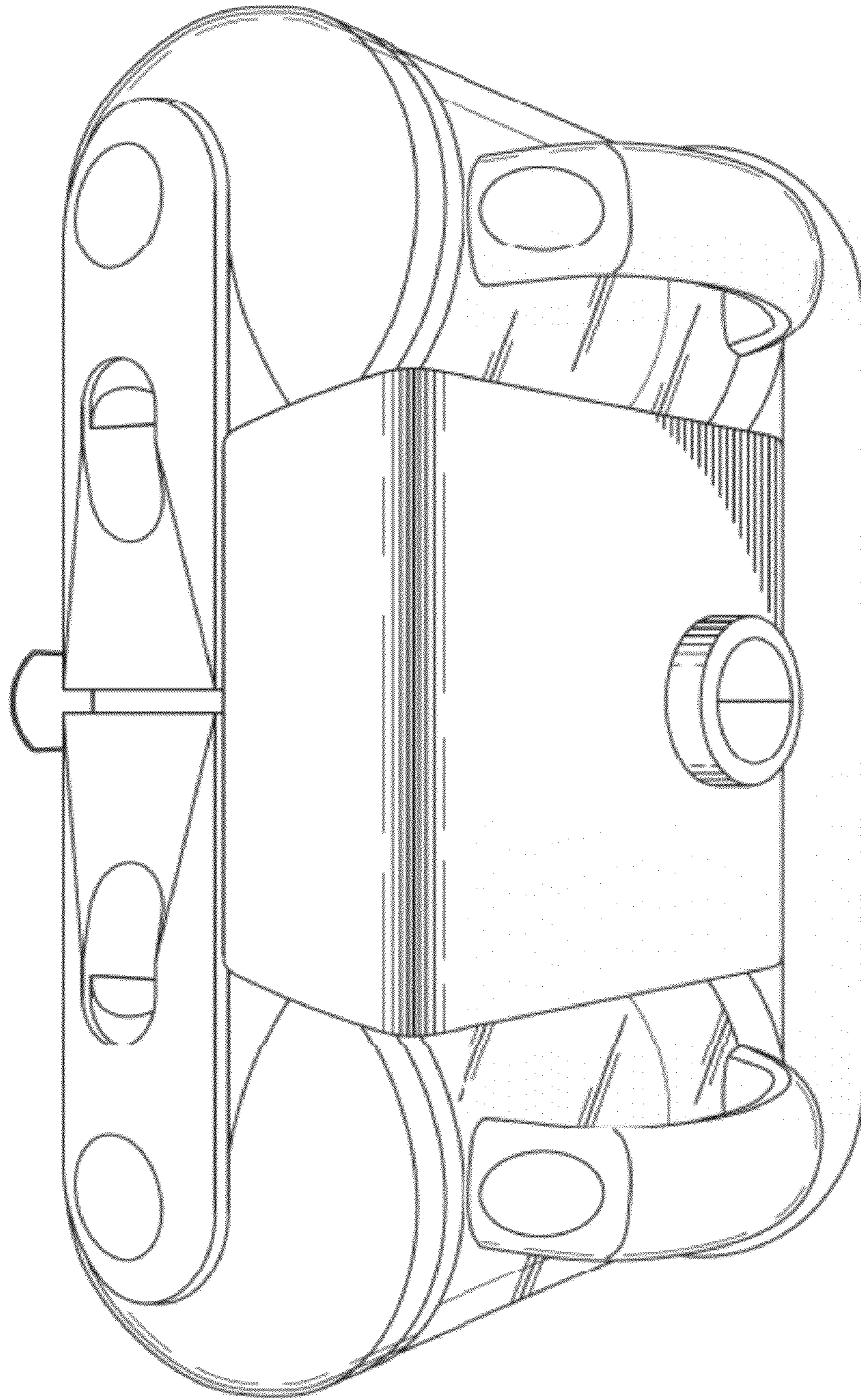
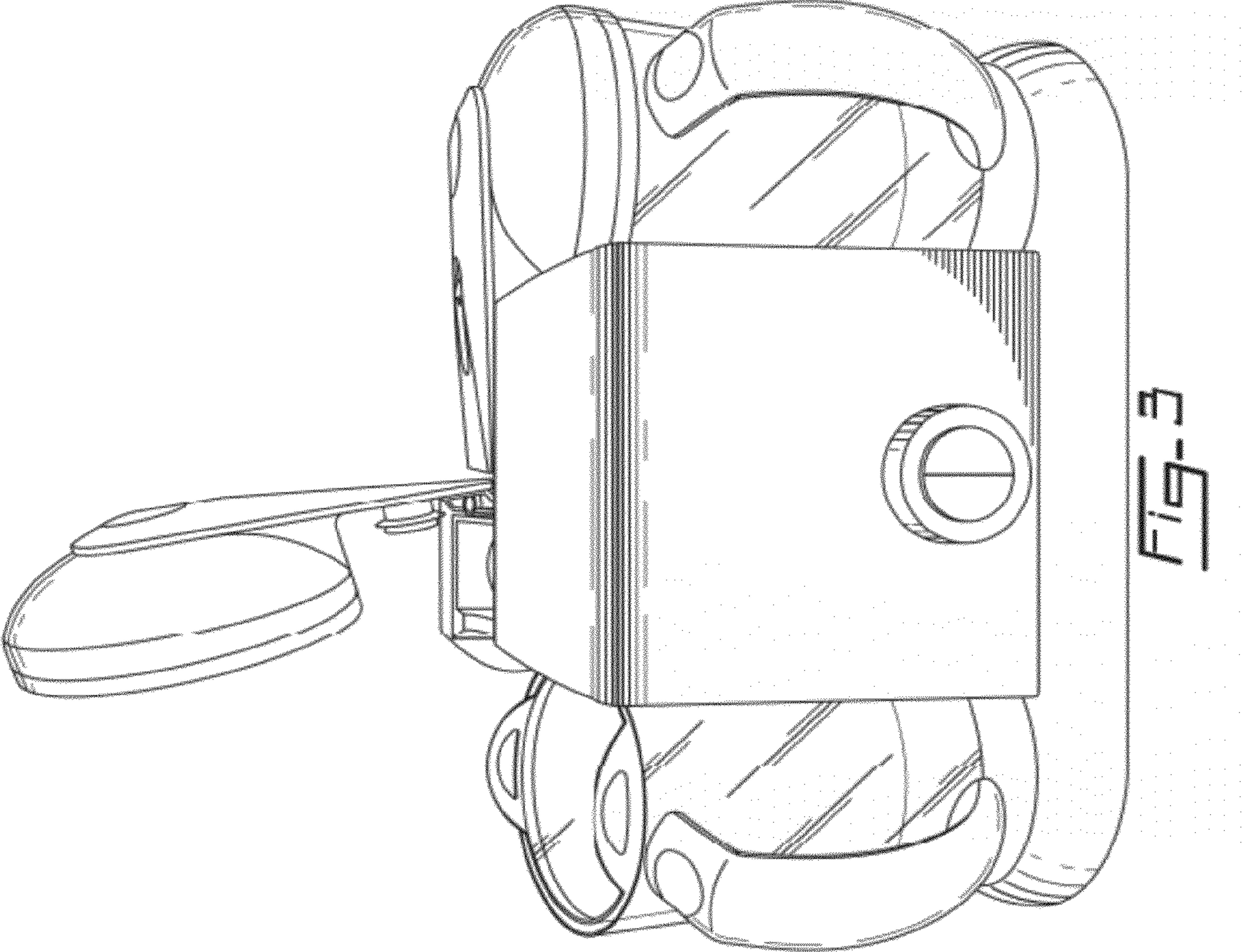
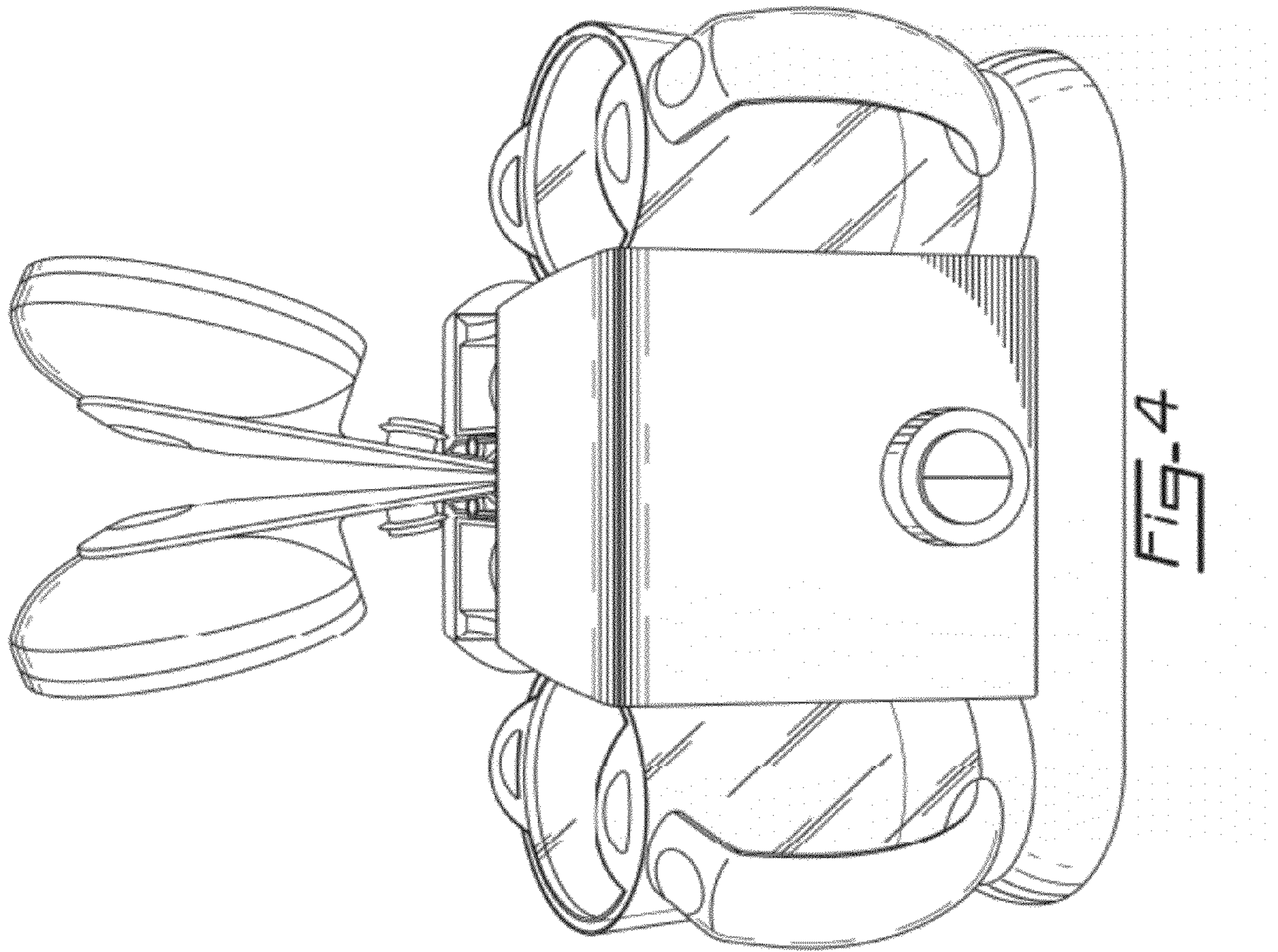

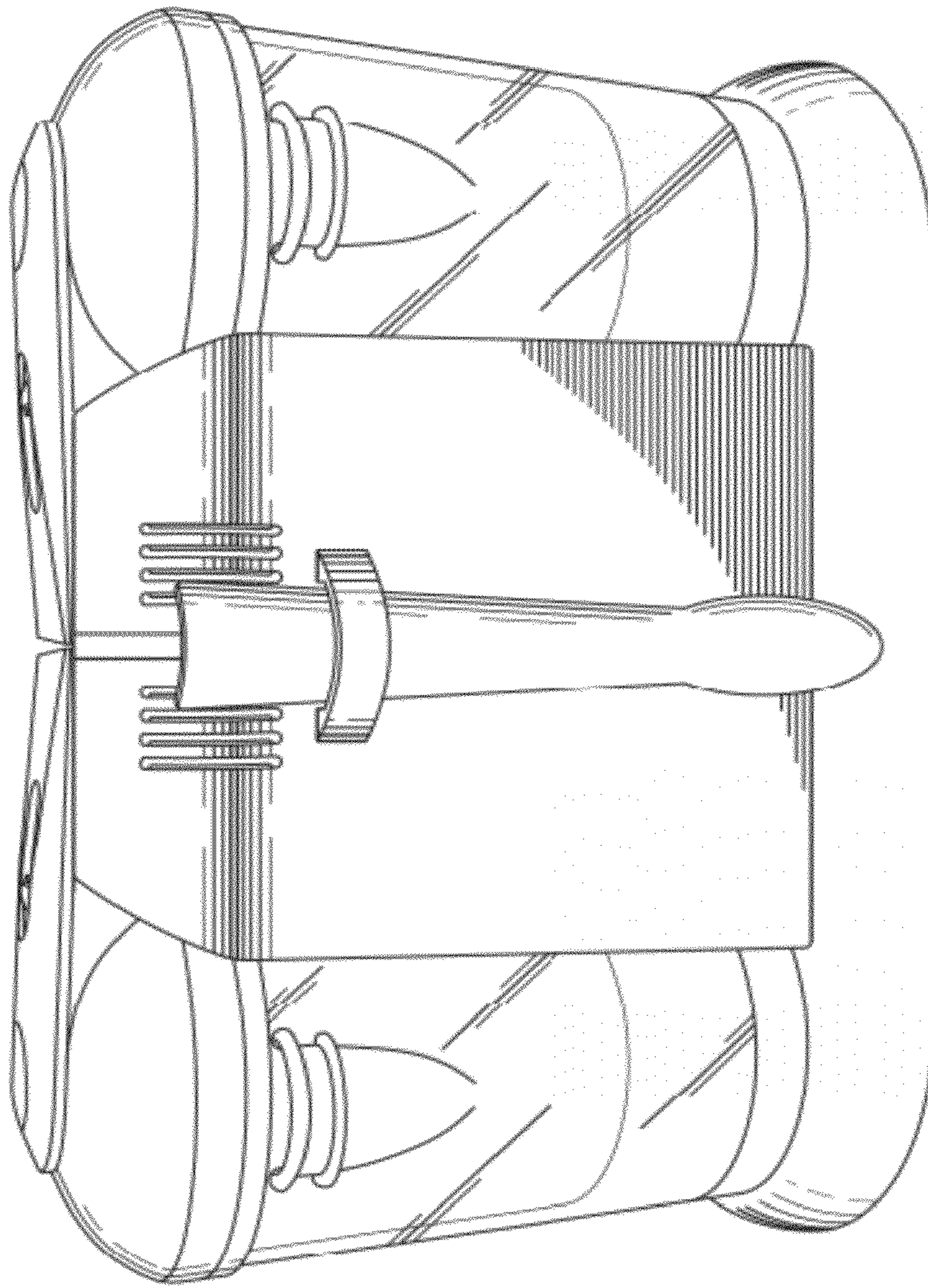

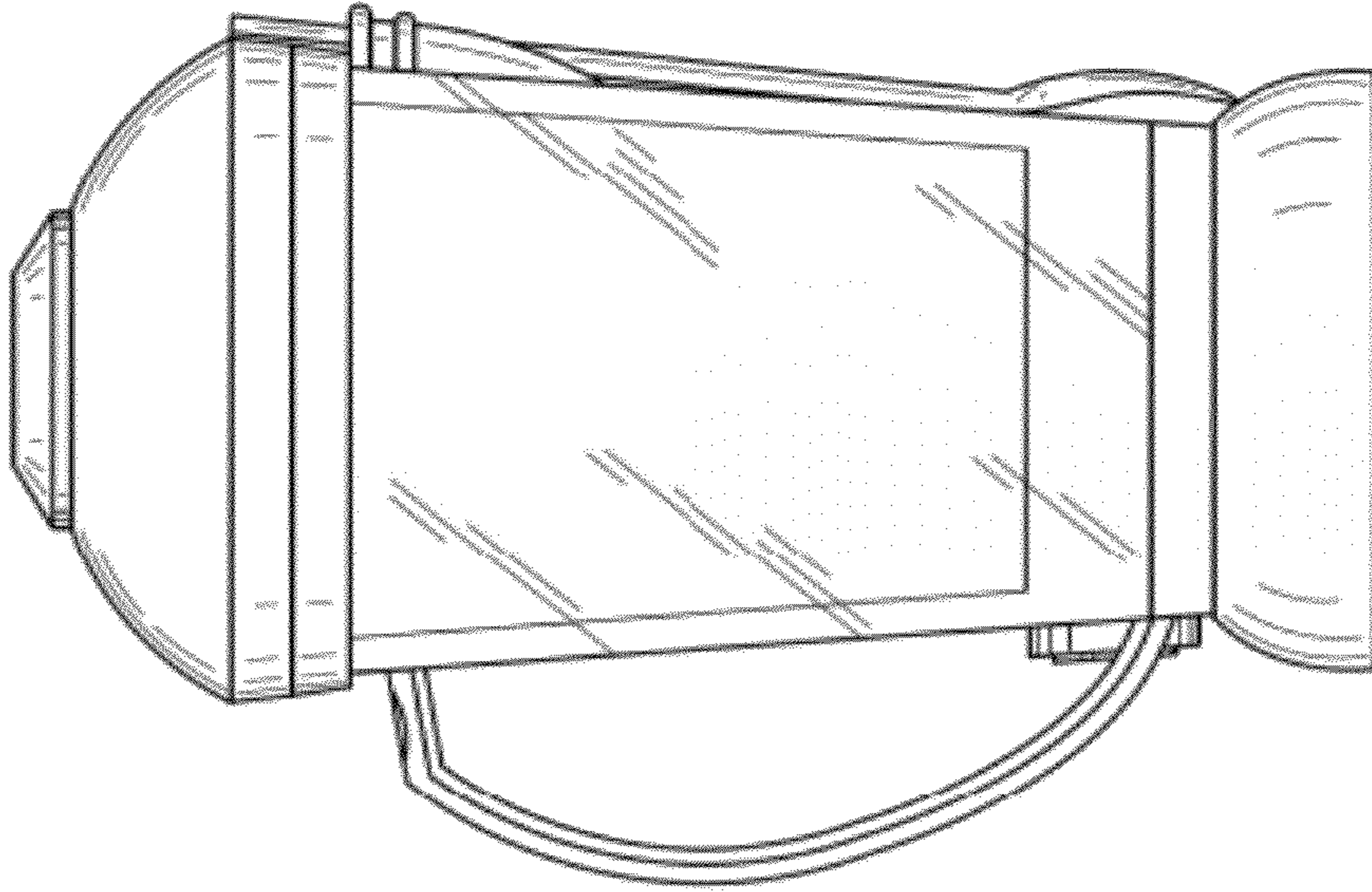

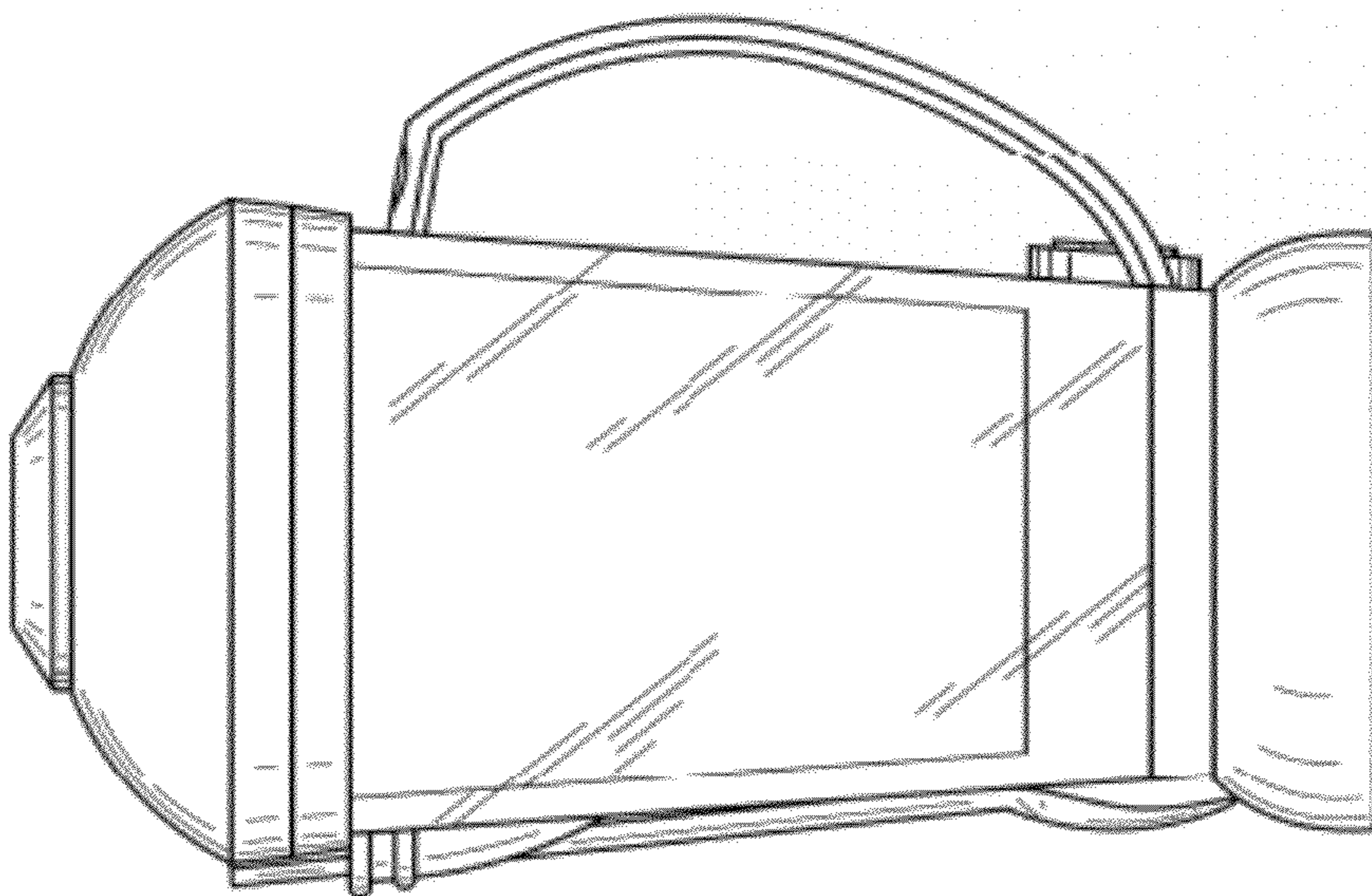

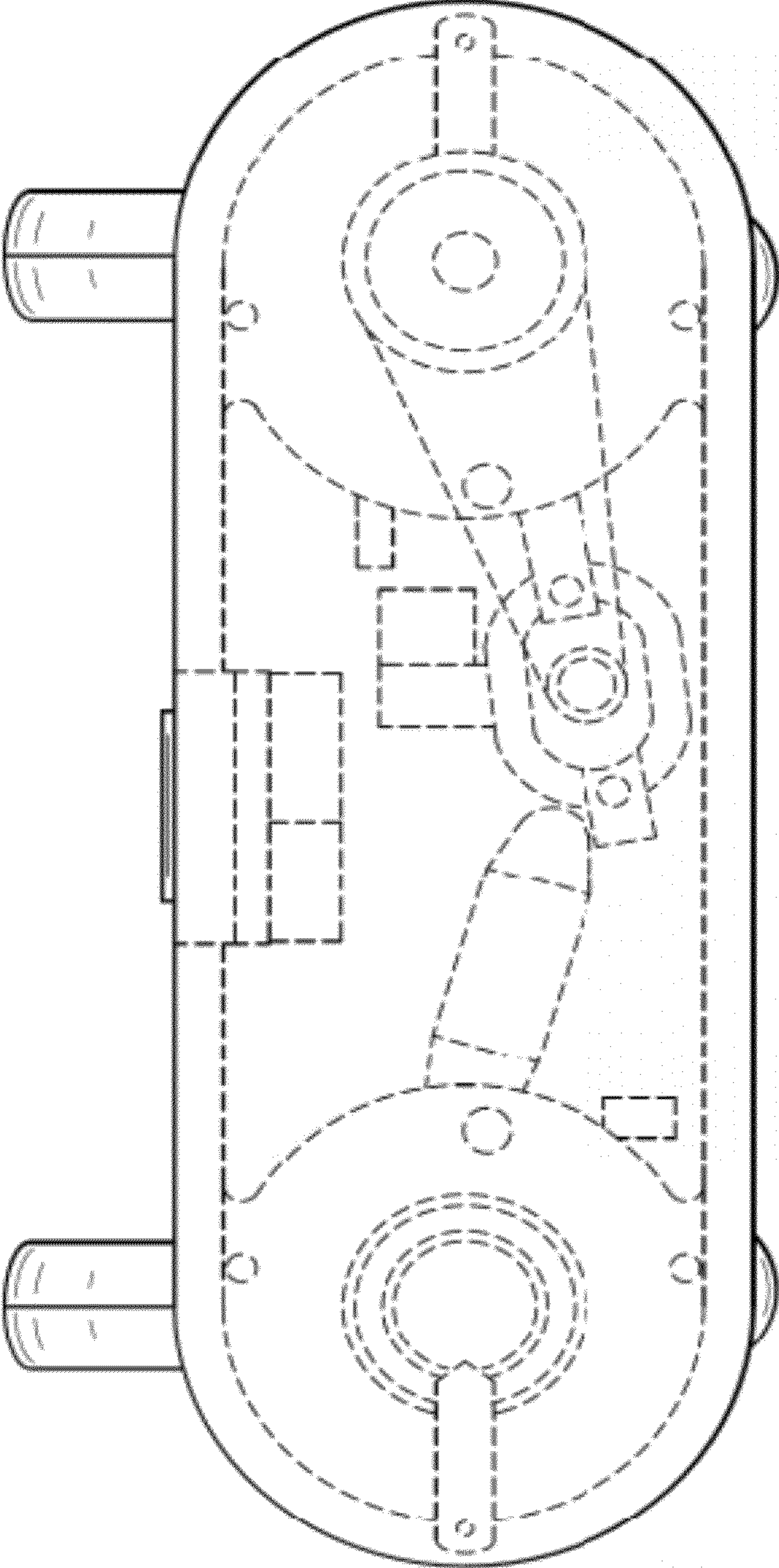
