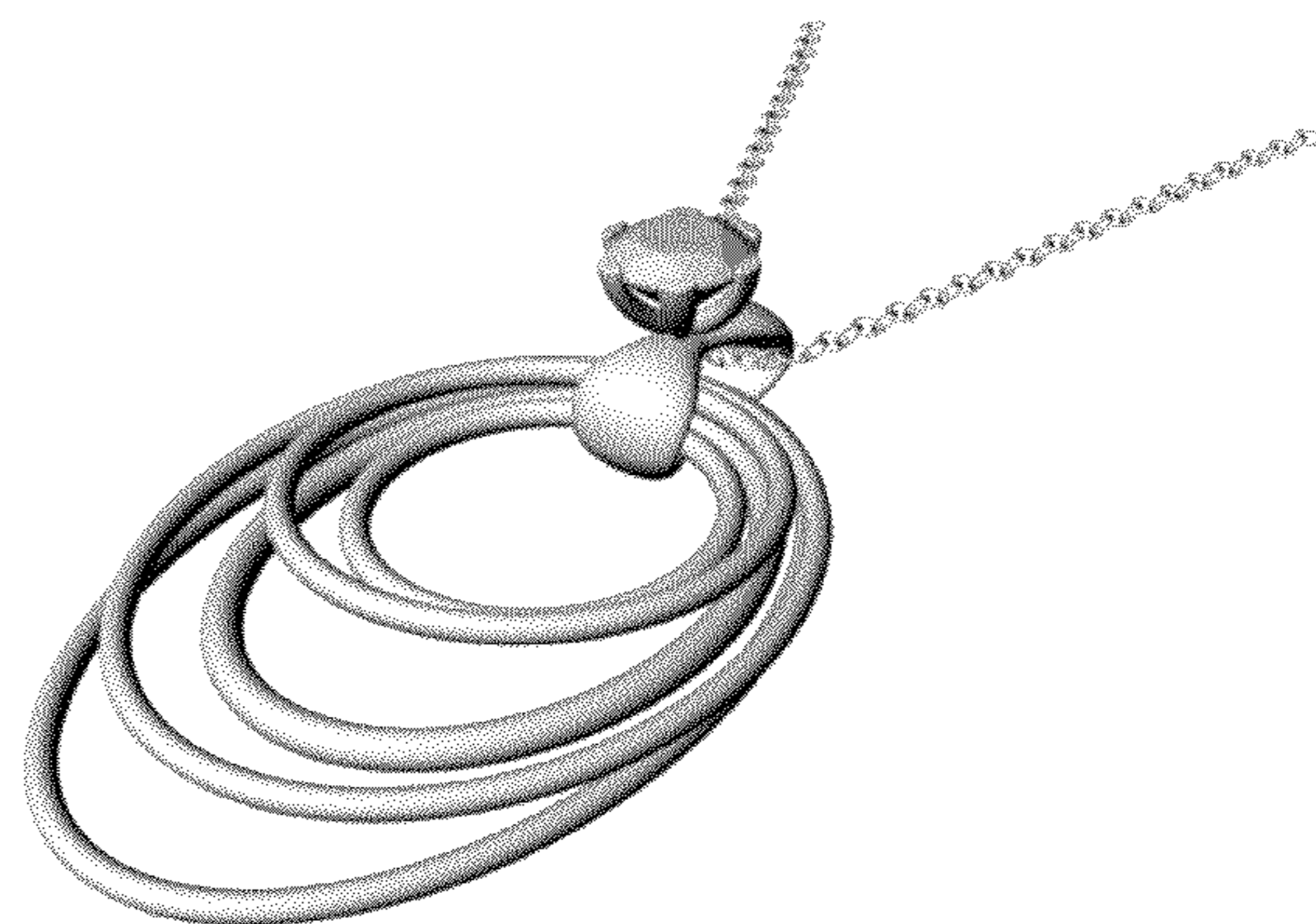
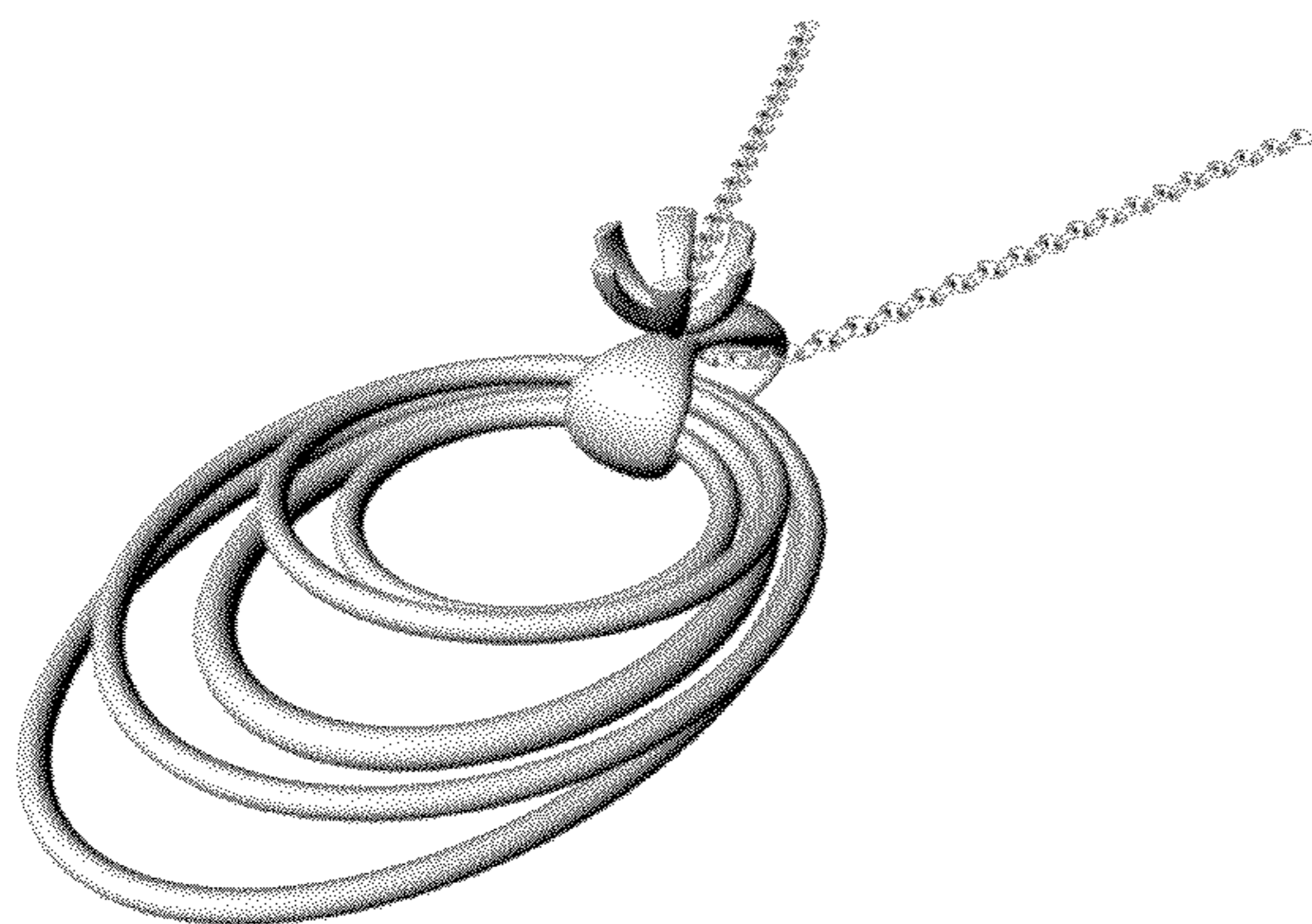
The ornamental design for a pendant, as shown and described.

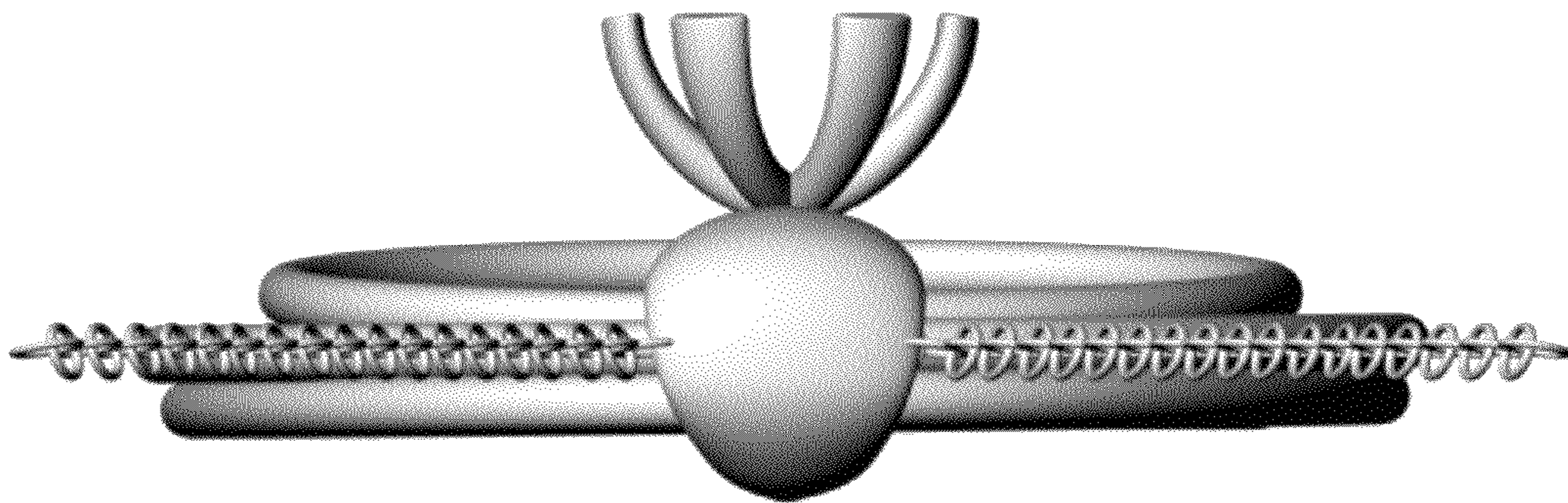

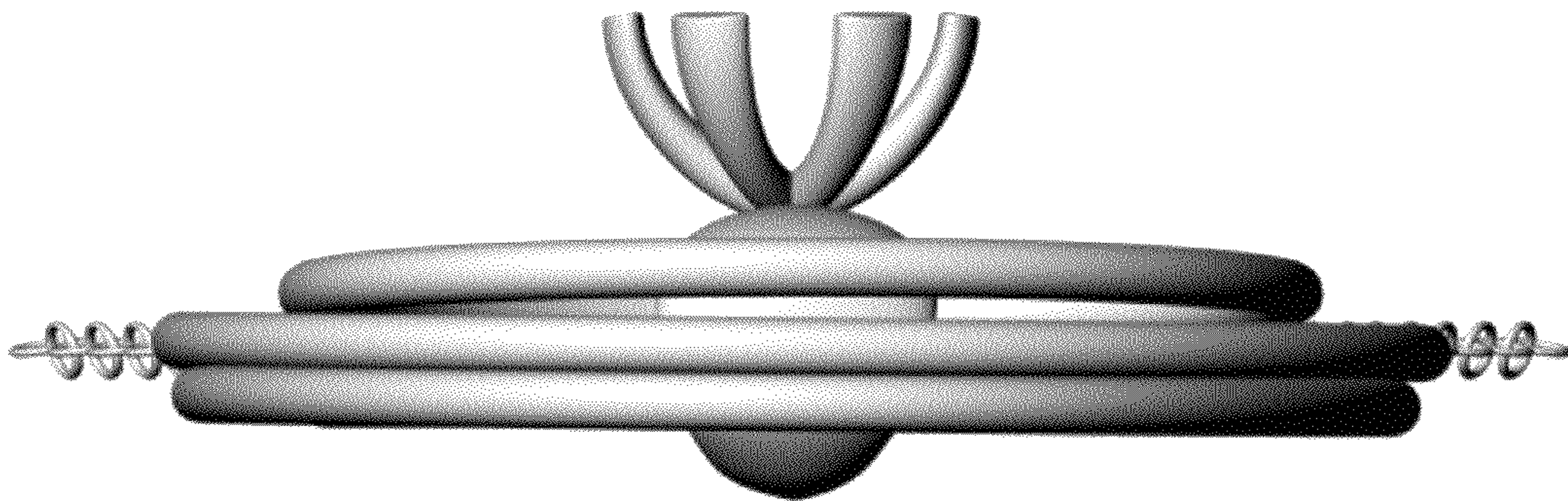

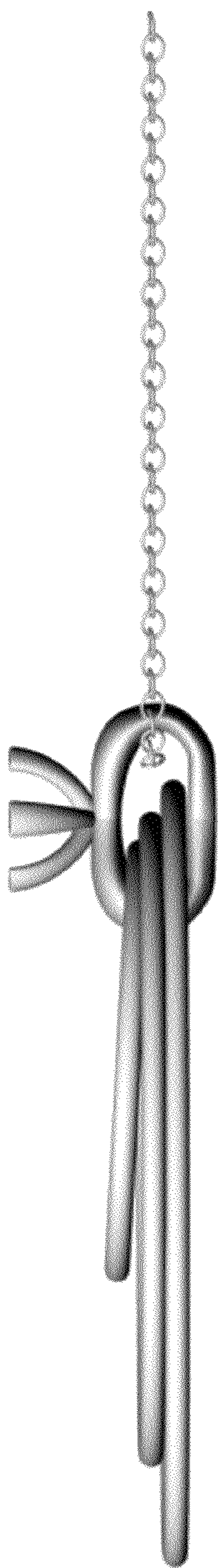

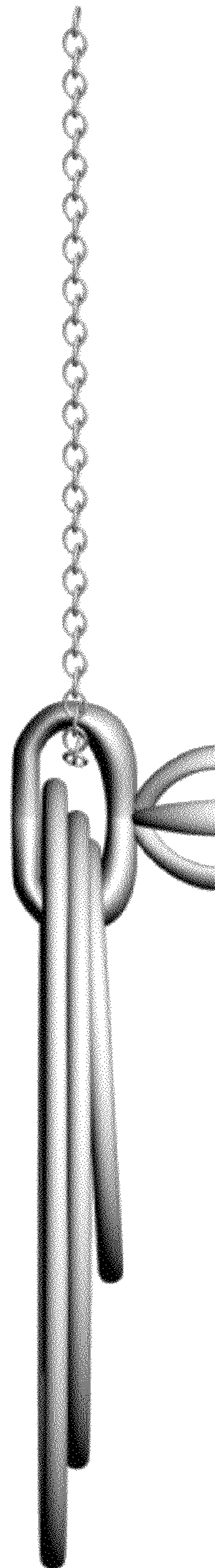

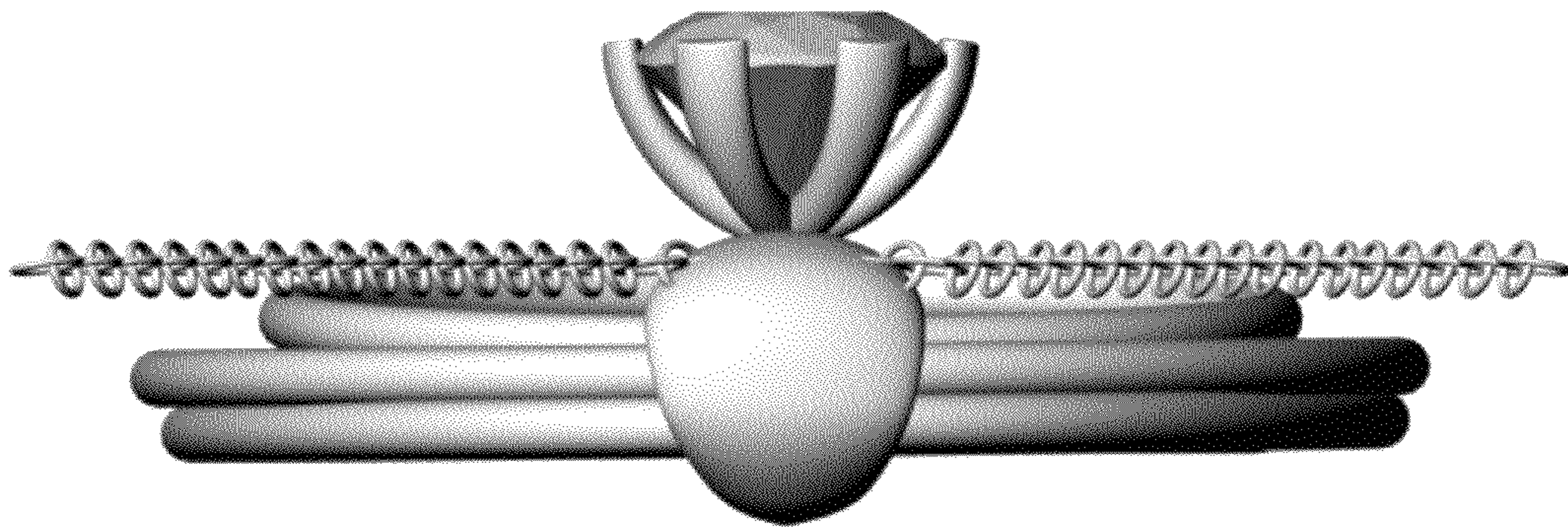

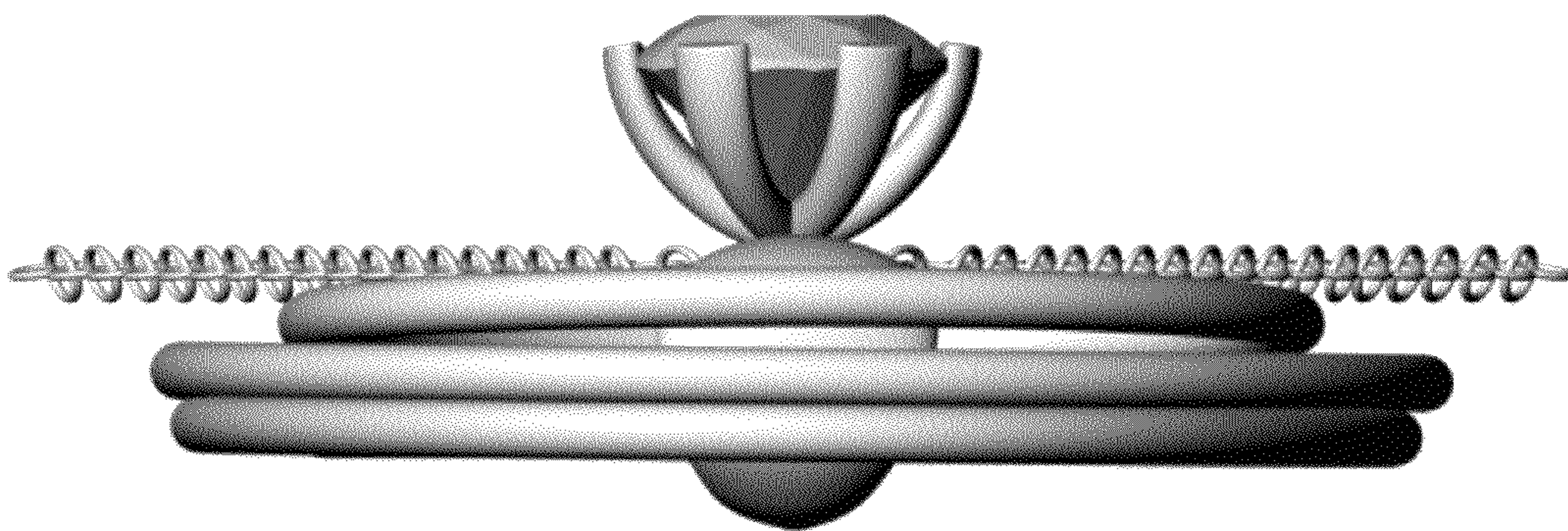

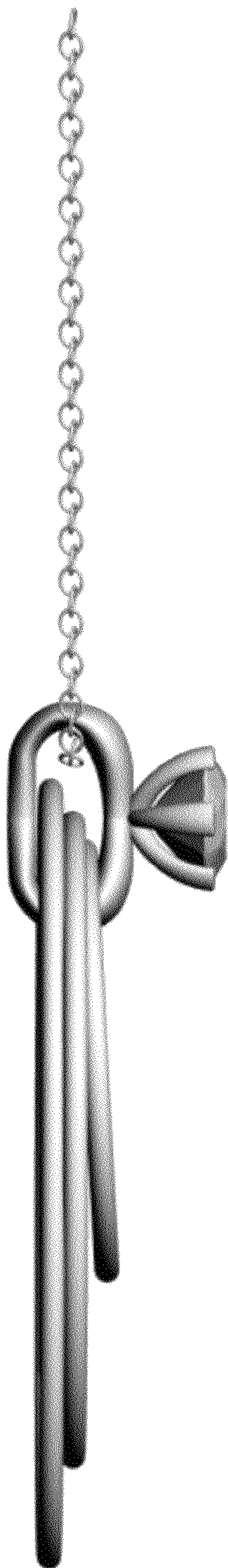

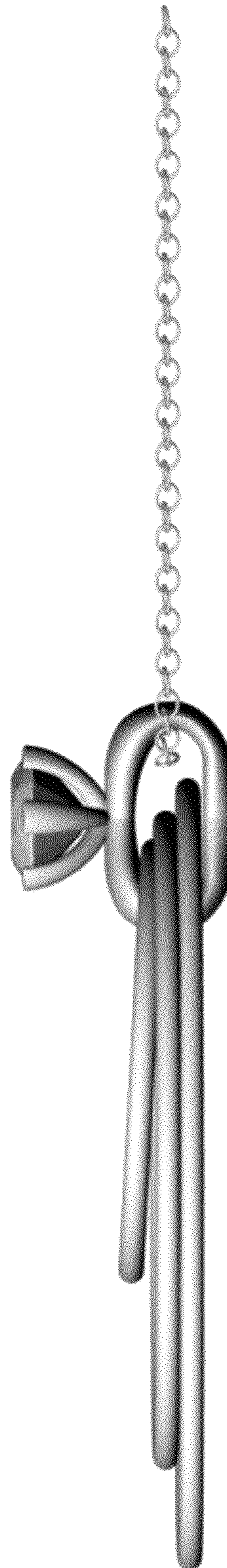
