(57) **CLAIM**

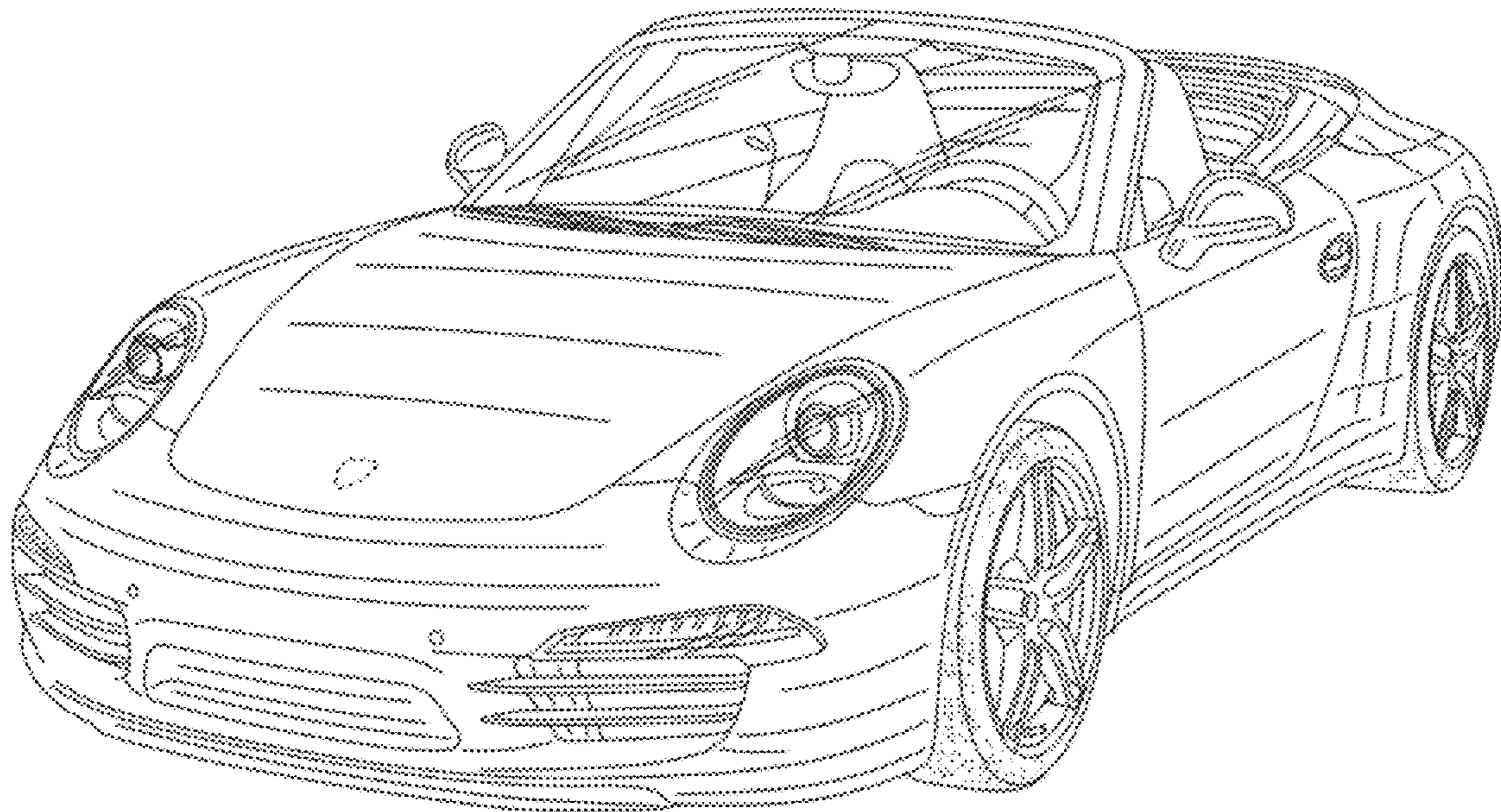
The ornamental design for an automobile, as shown and described.

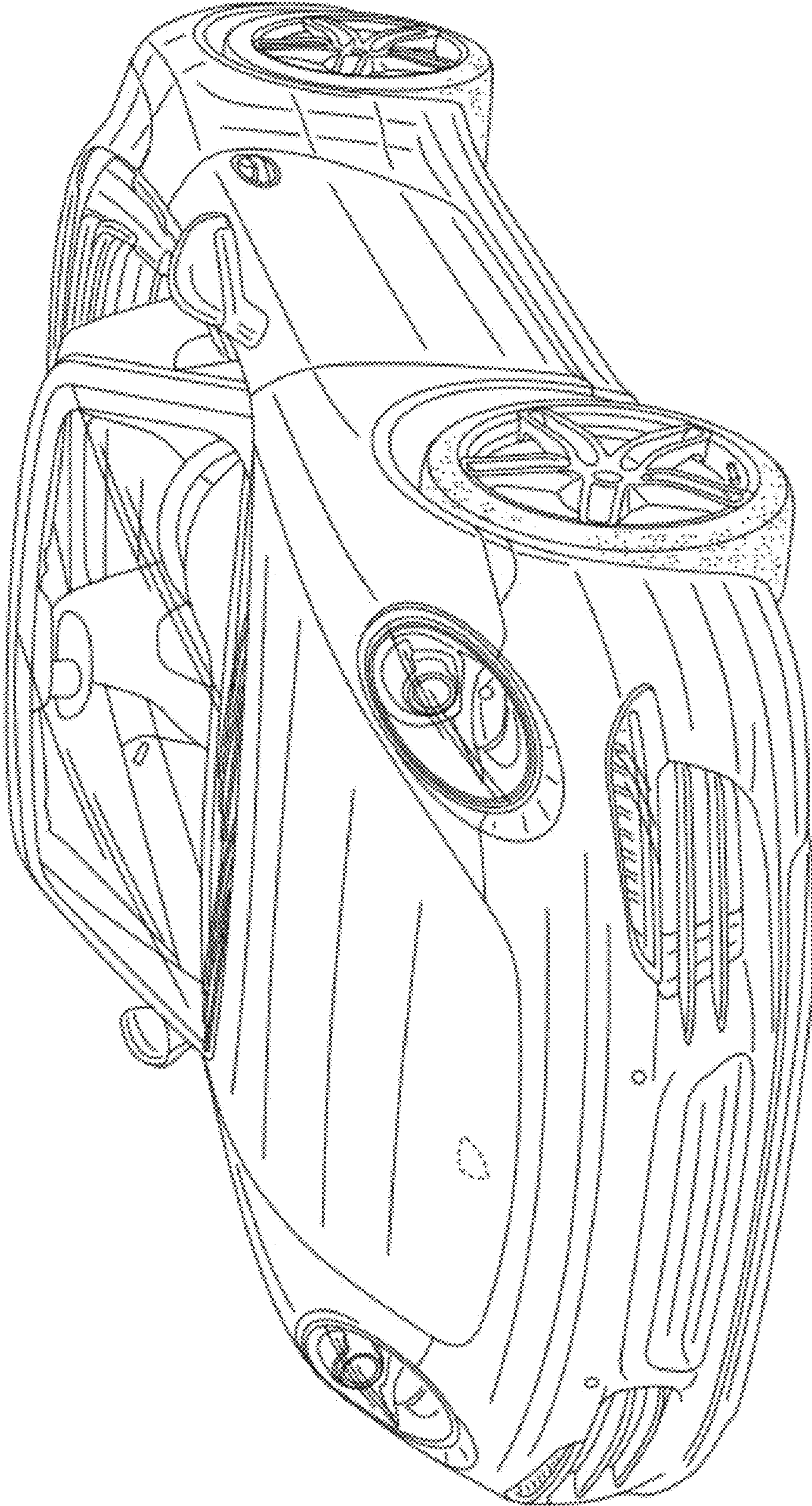

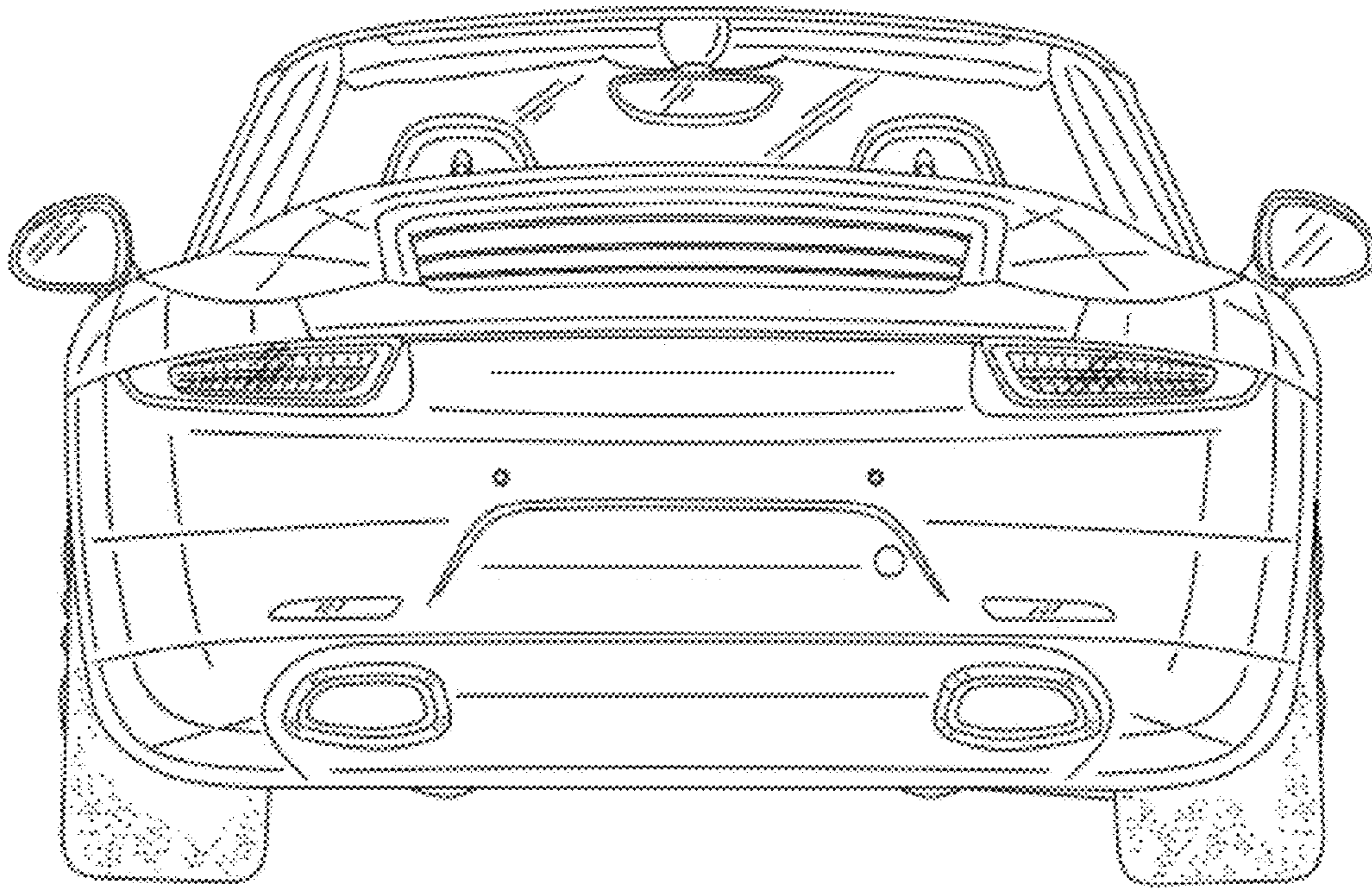

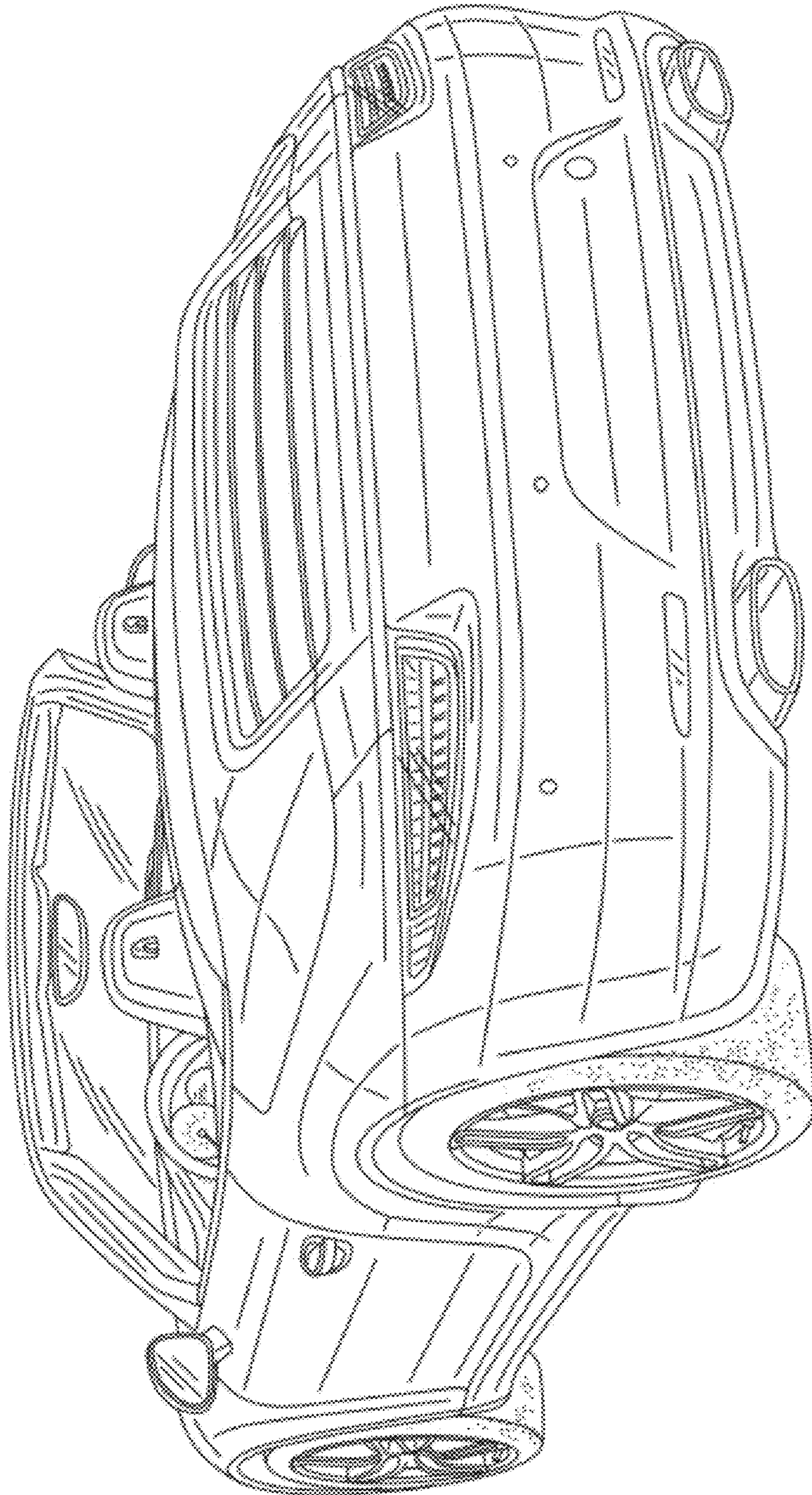

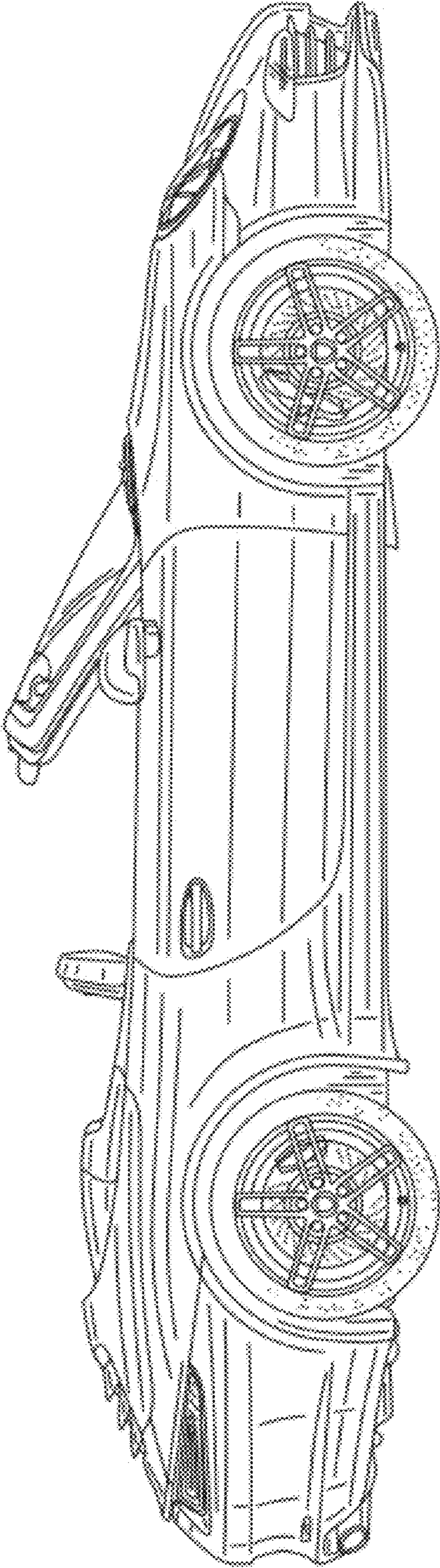

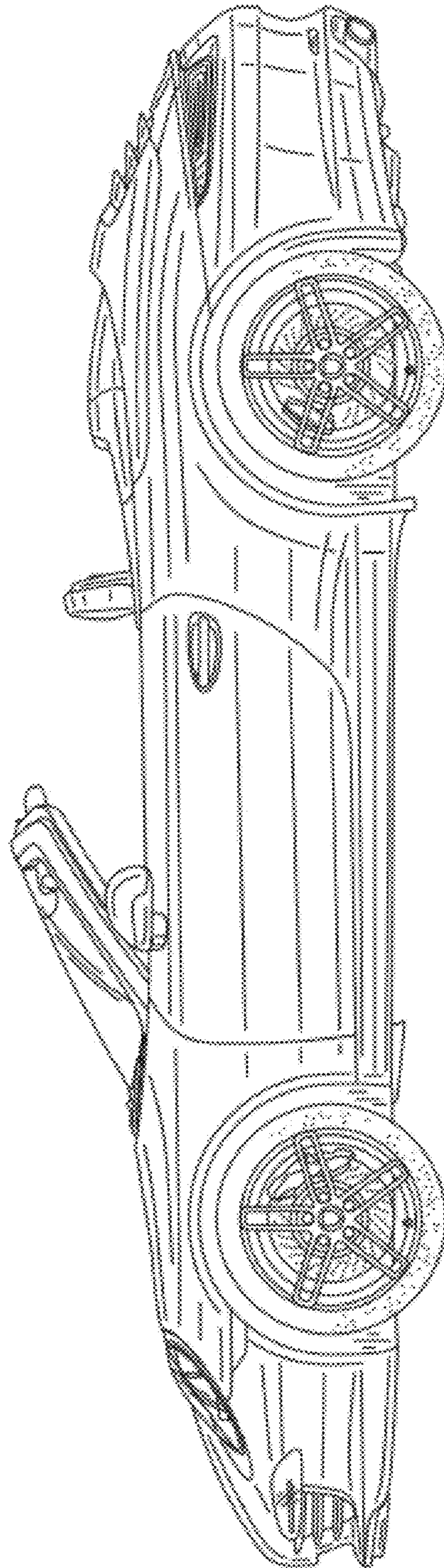

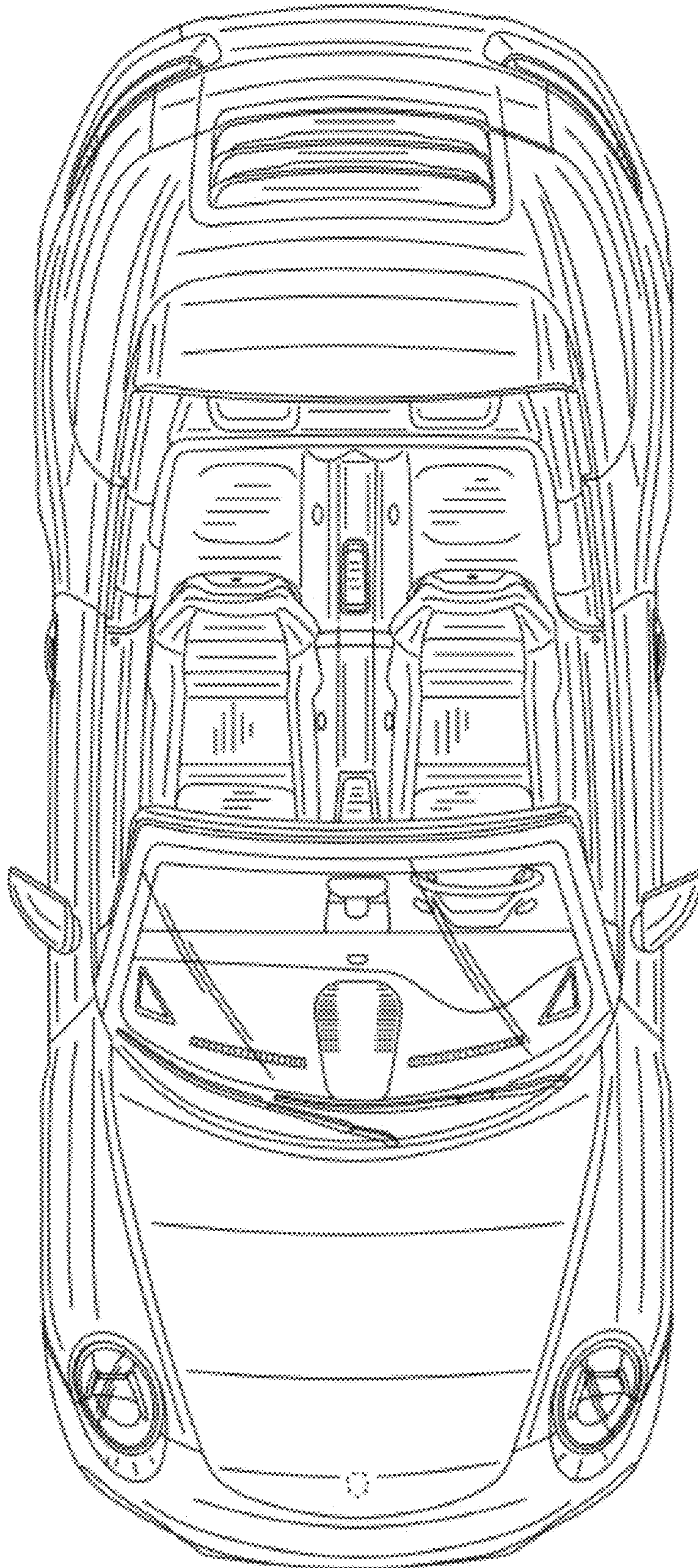

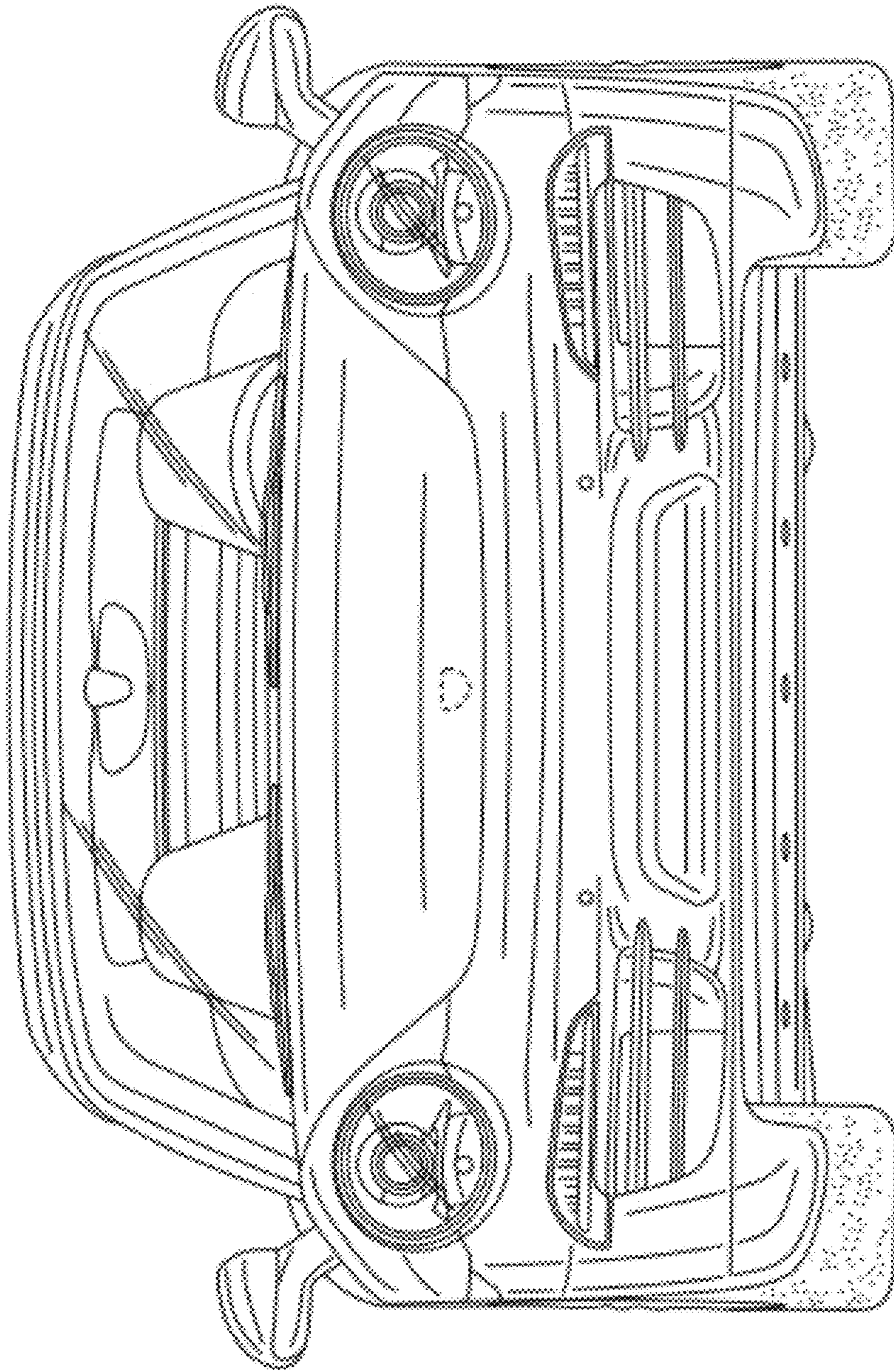

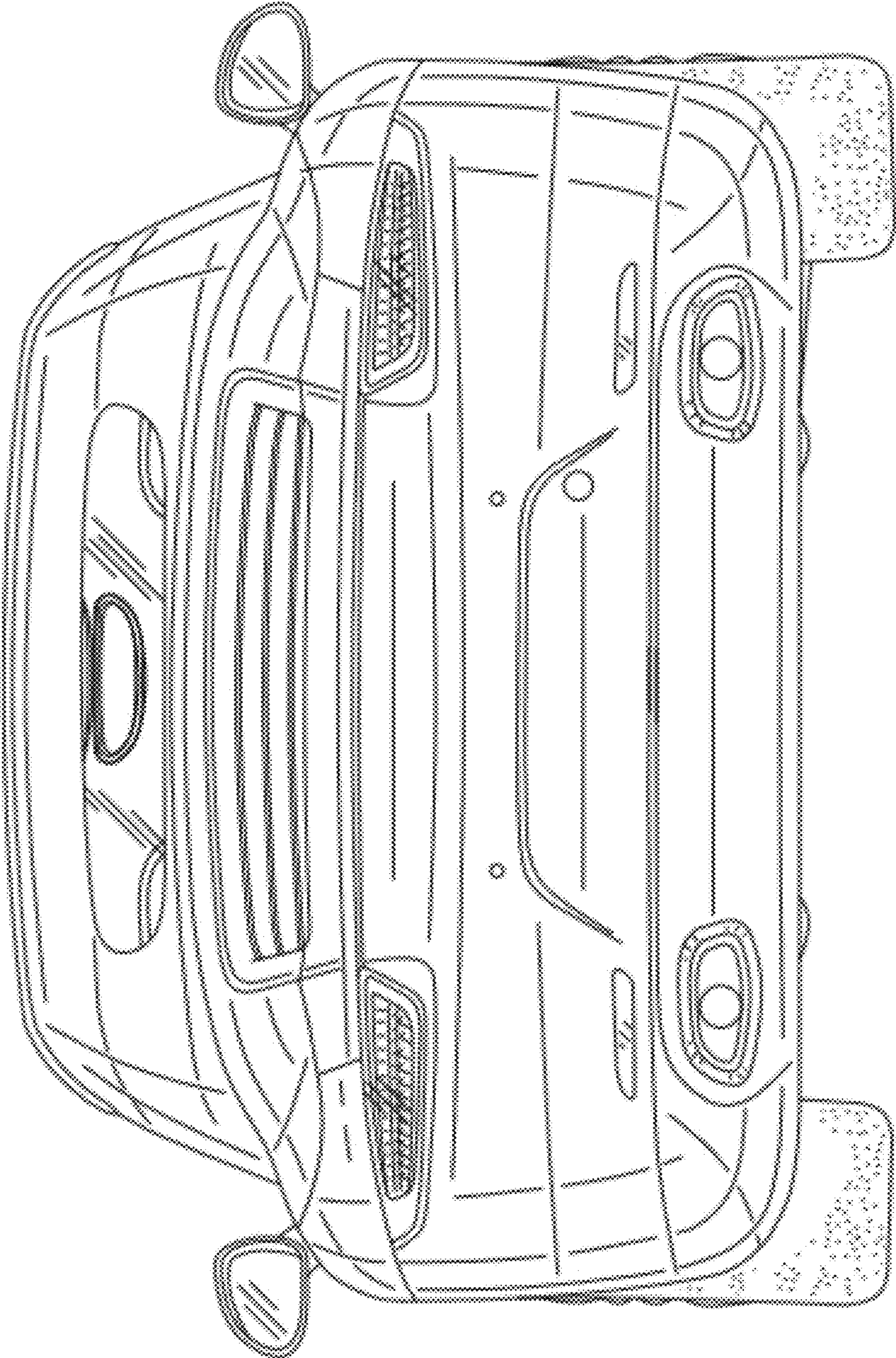

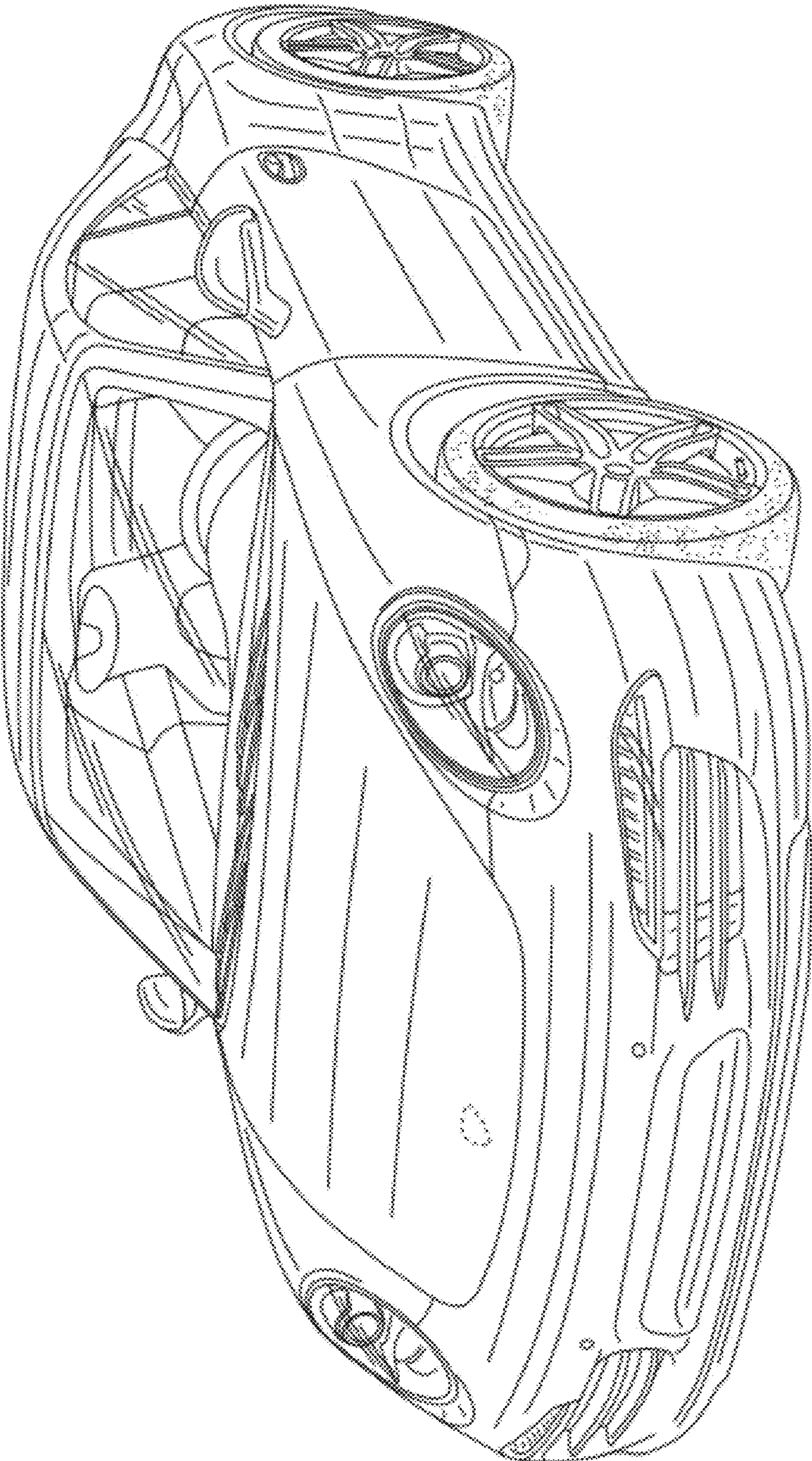

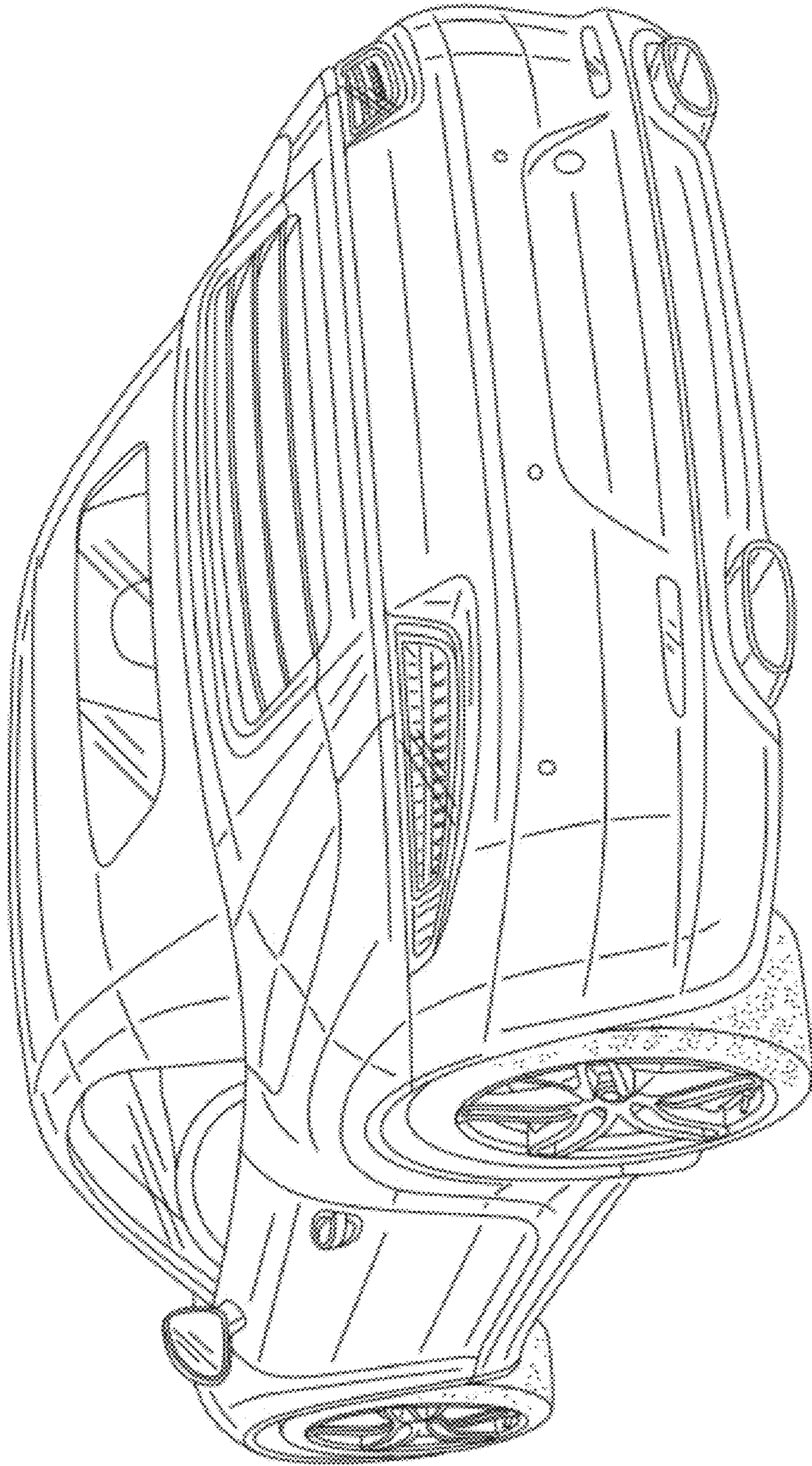

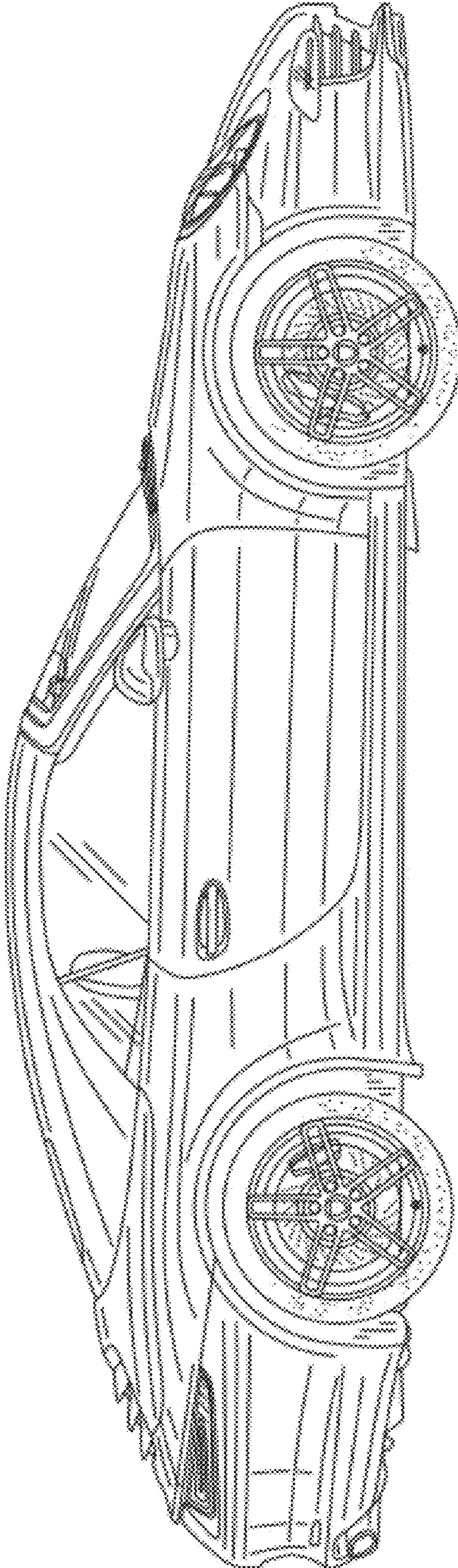

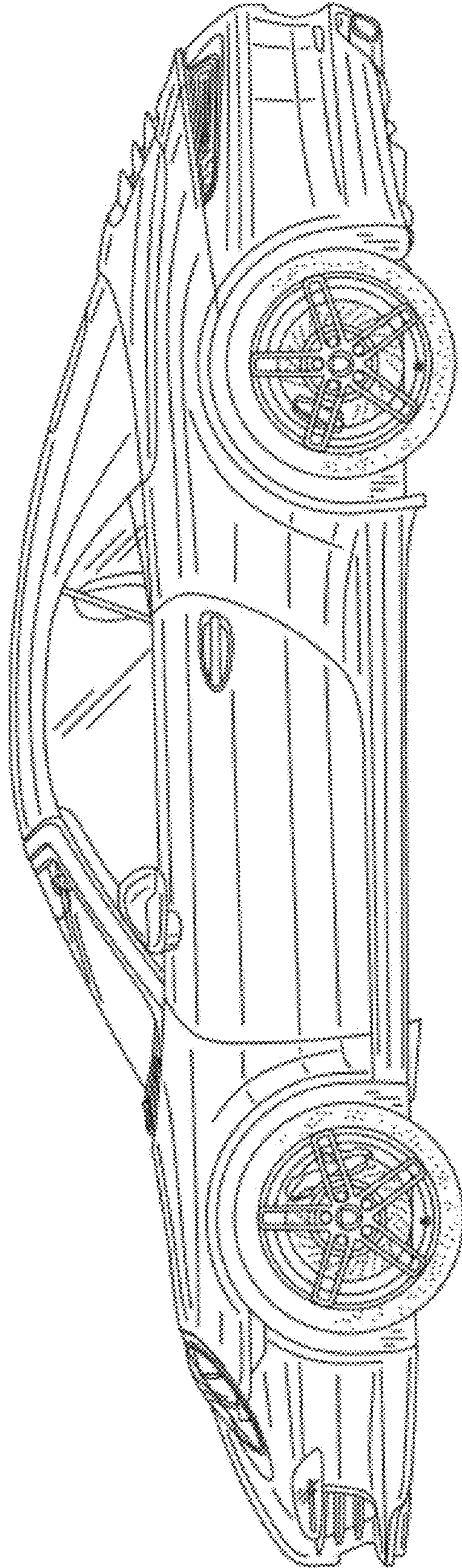

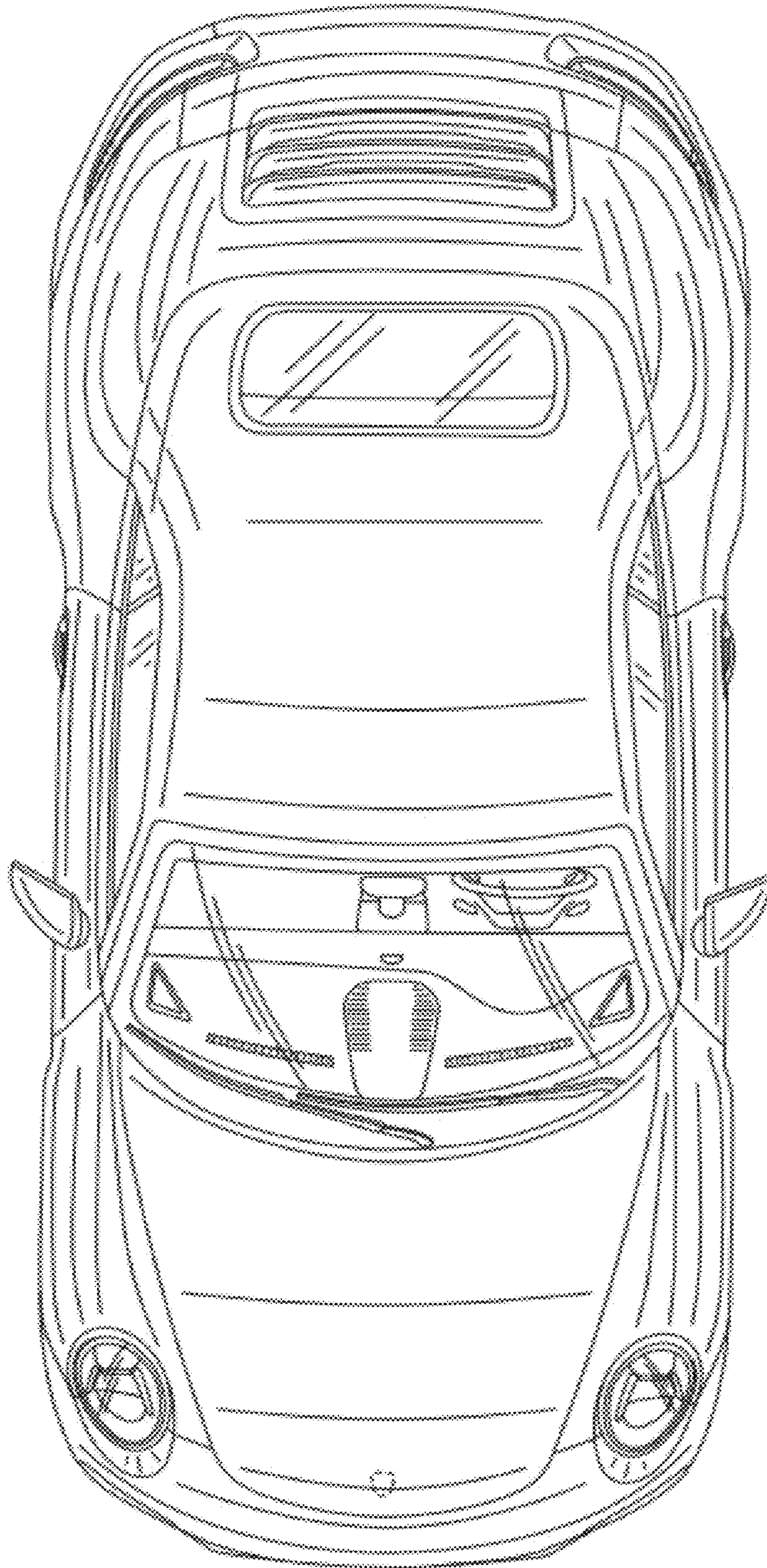
