(57) **CLAIM**

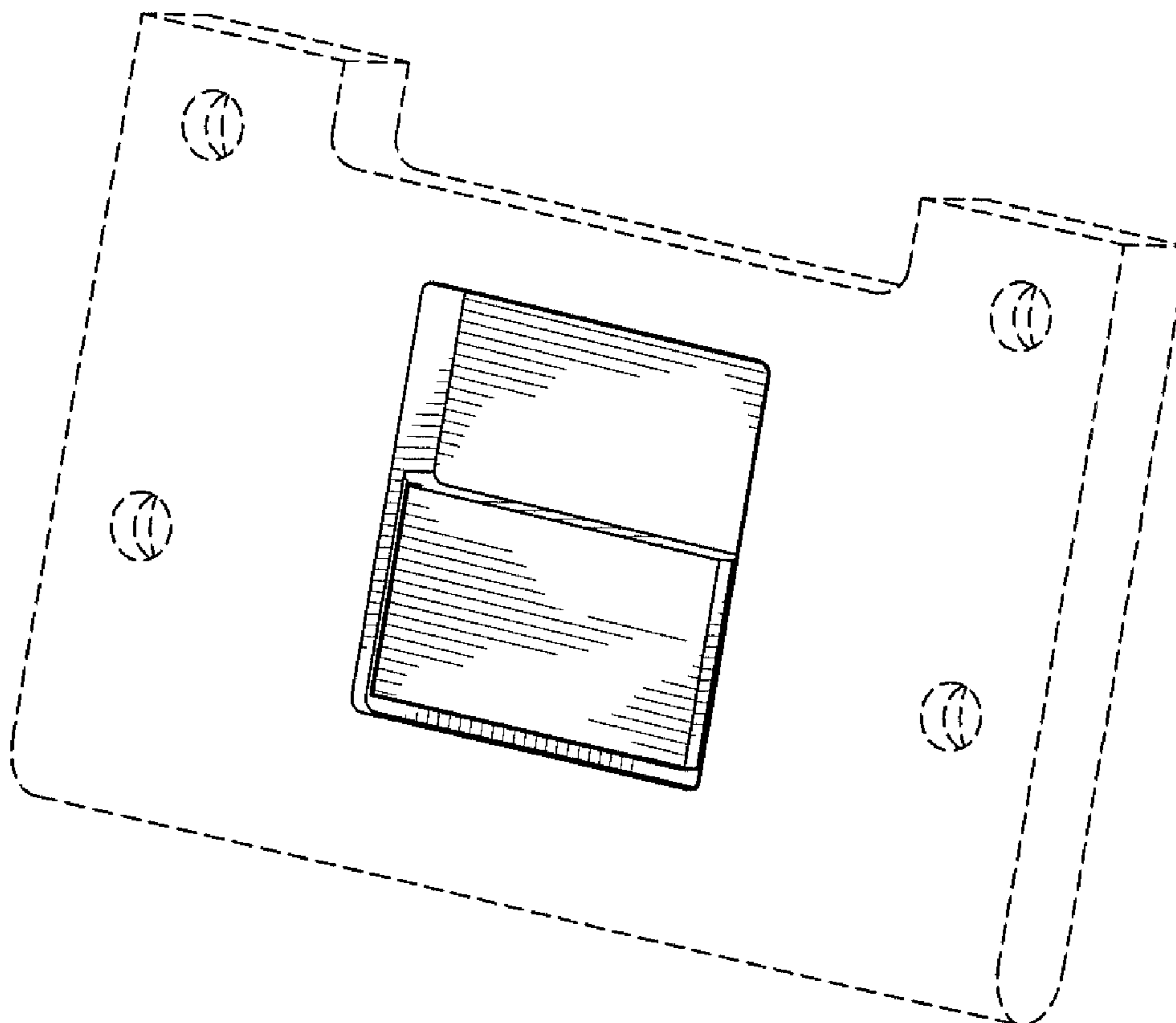
The ornamental design for a heat spreader for a VCSEL array and mounting support, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the heat spreader for a VCSEL array and mounting support;  
FIG. 2 is a top elevation view thereof;  
FIG. 3 is a bottom elevation view thereof;  
FIG. 4 is a right side elevation view thereof;

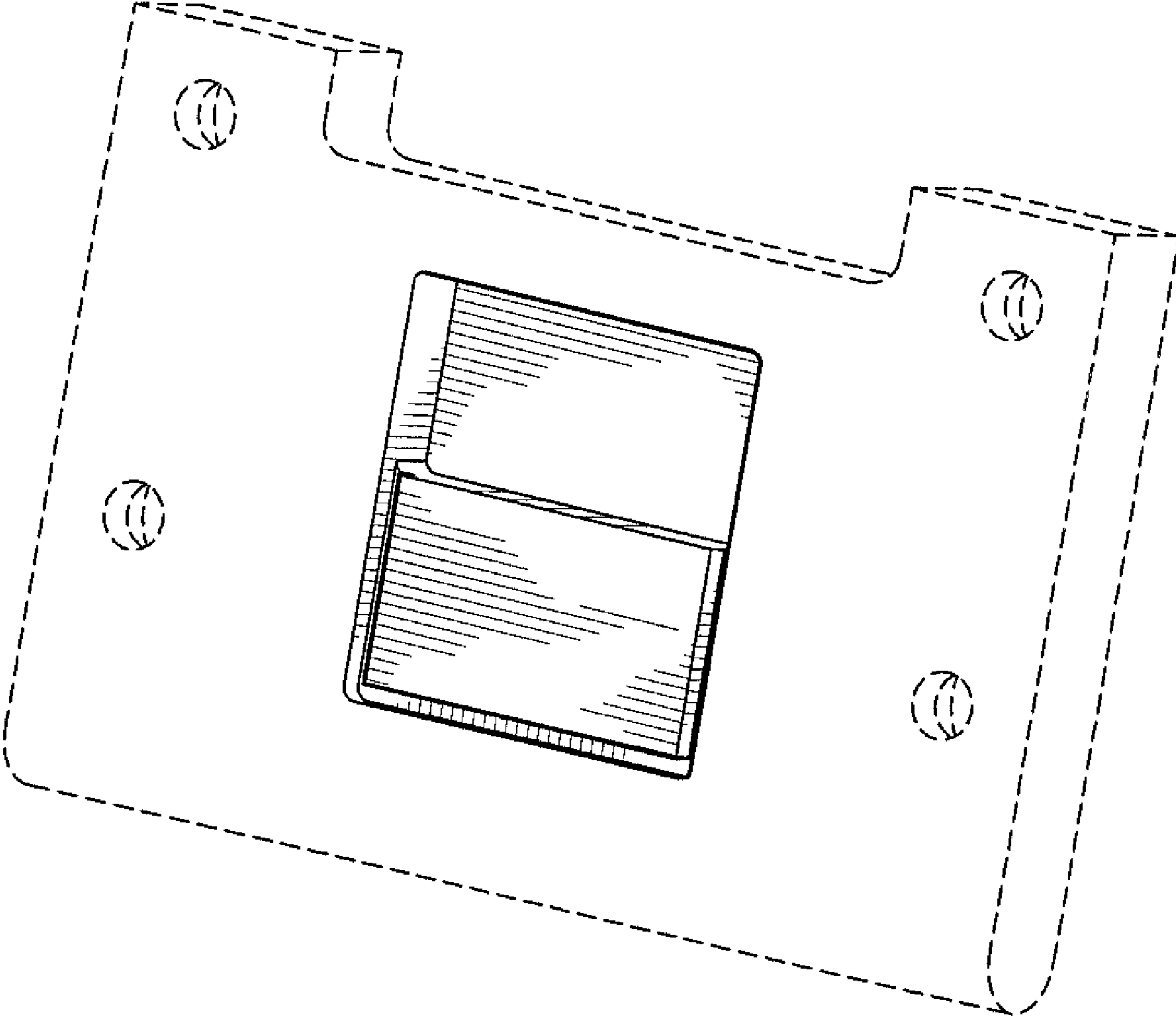

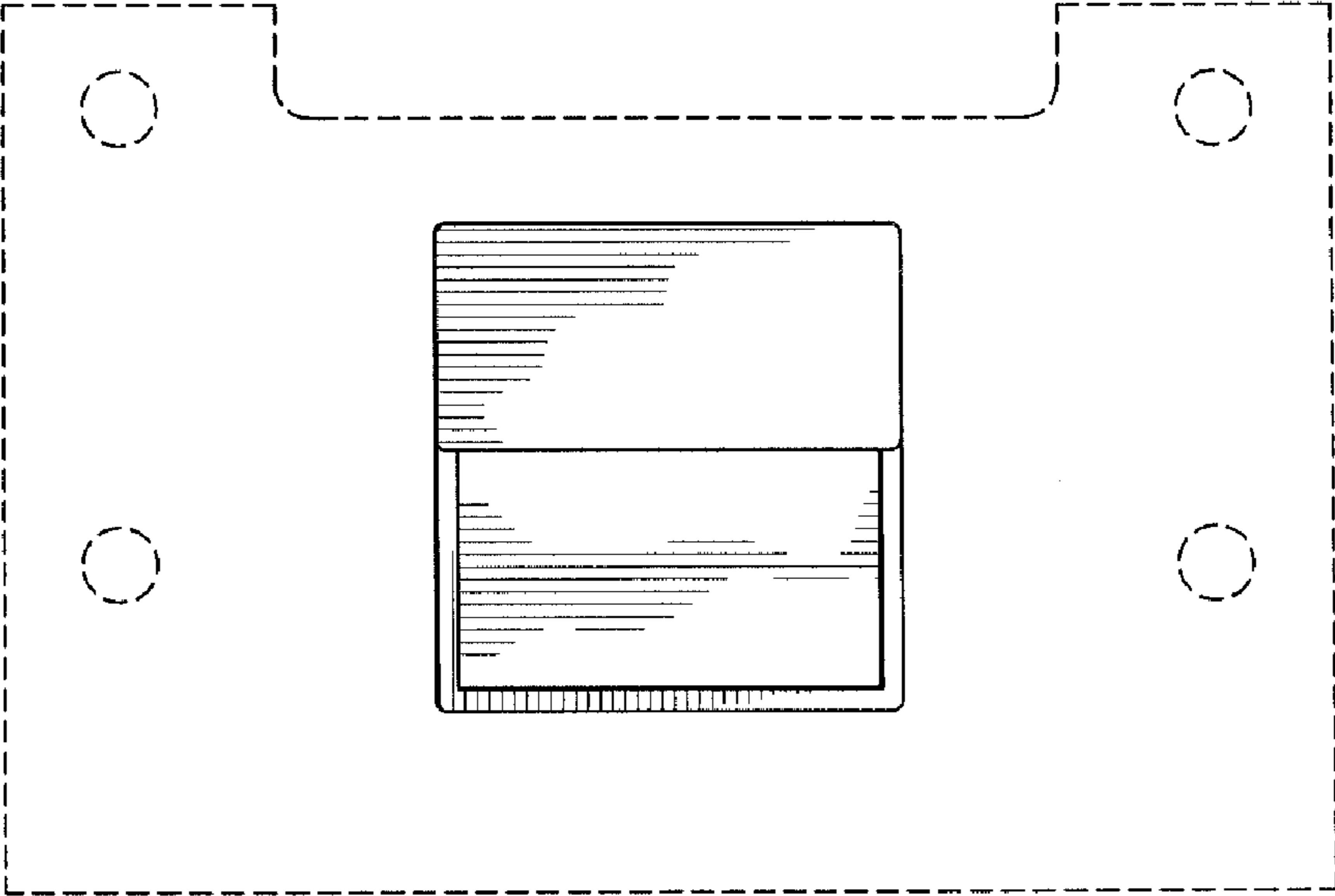

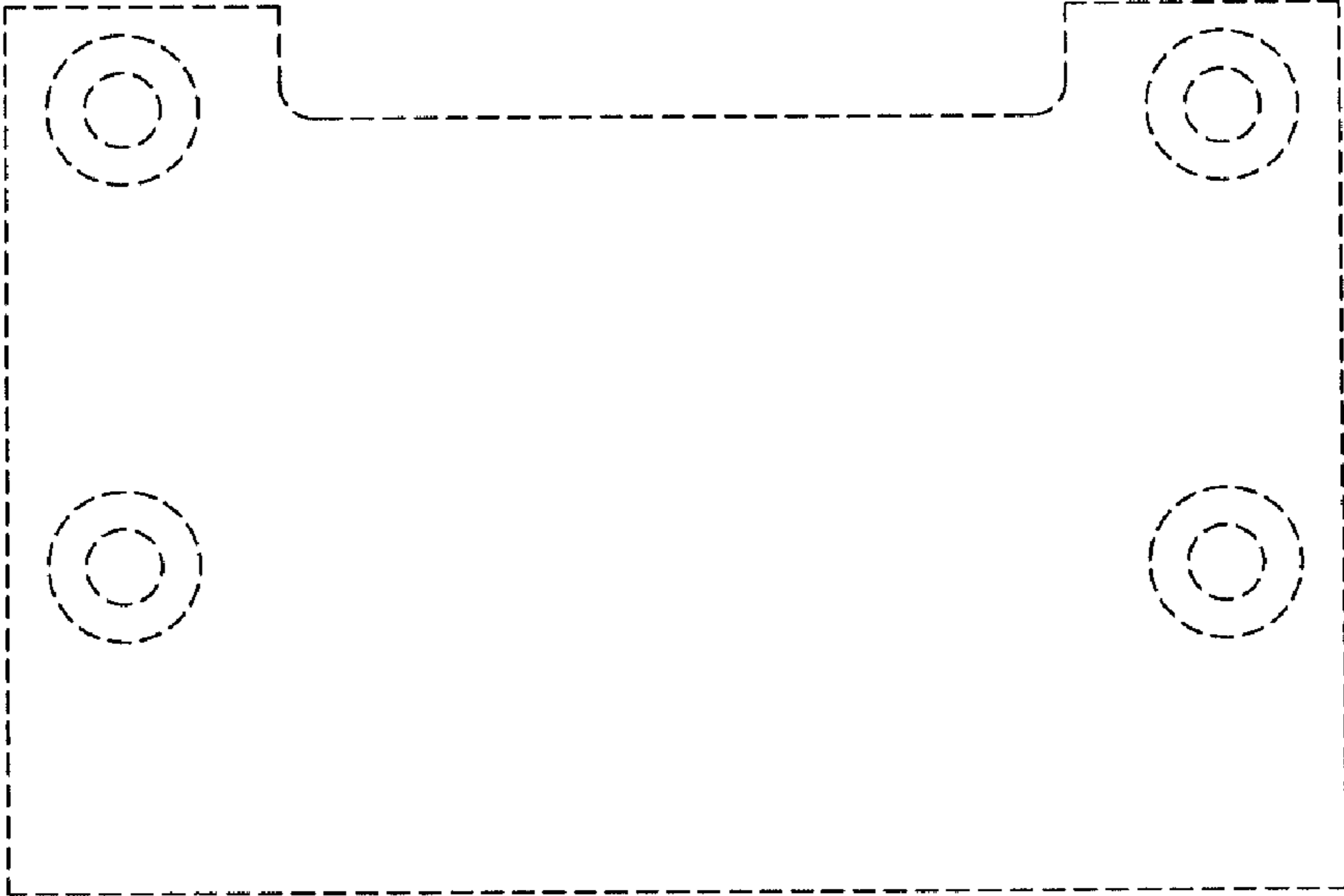
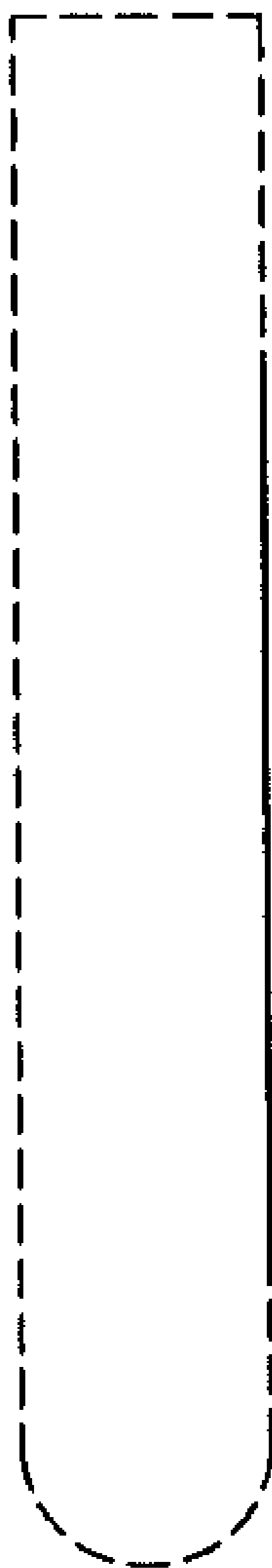
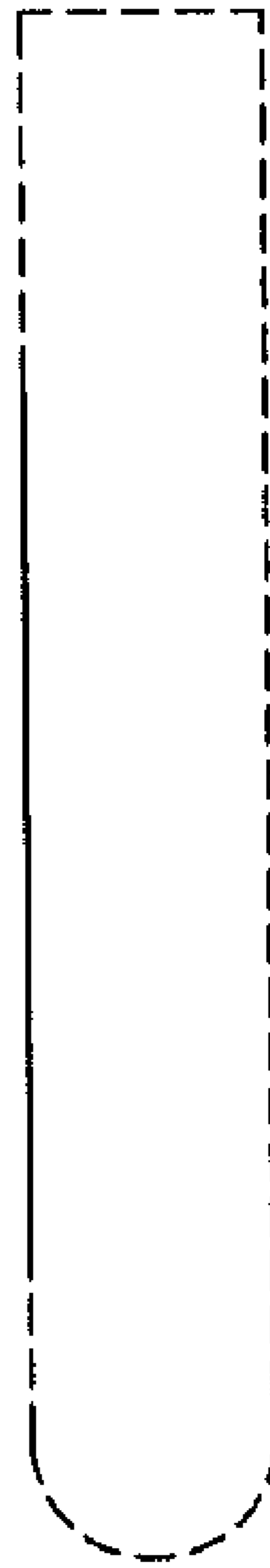

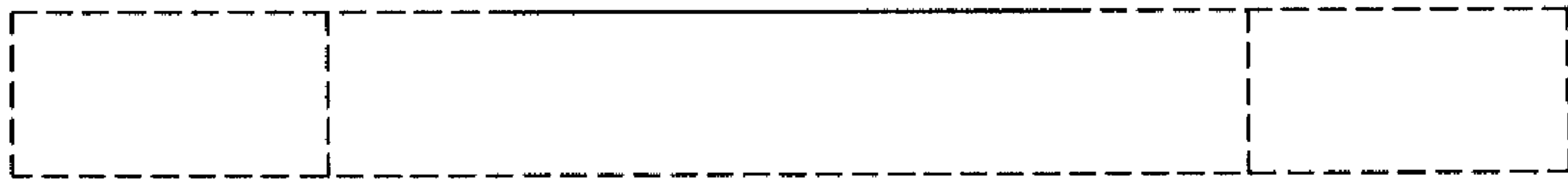

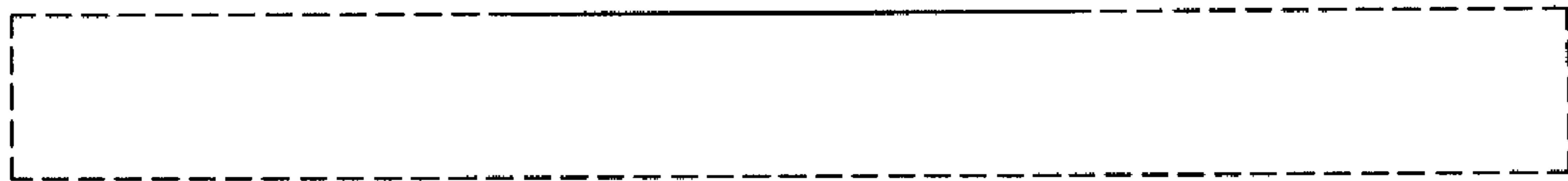
