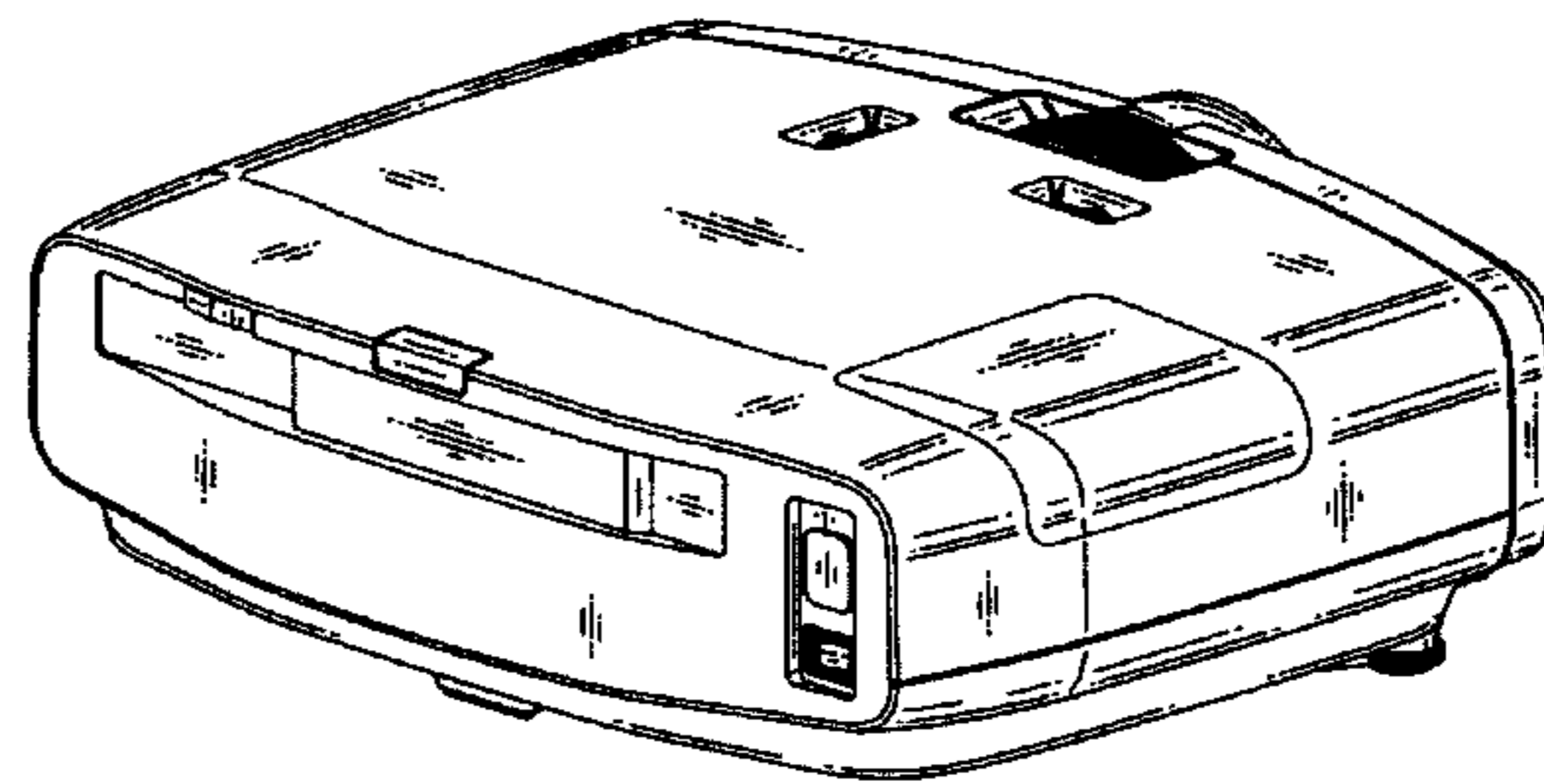
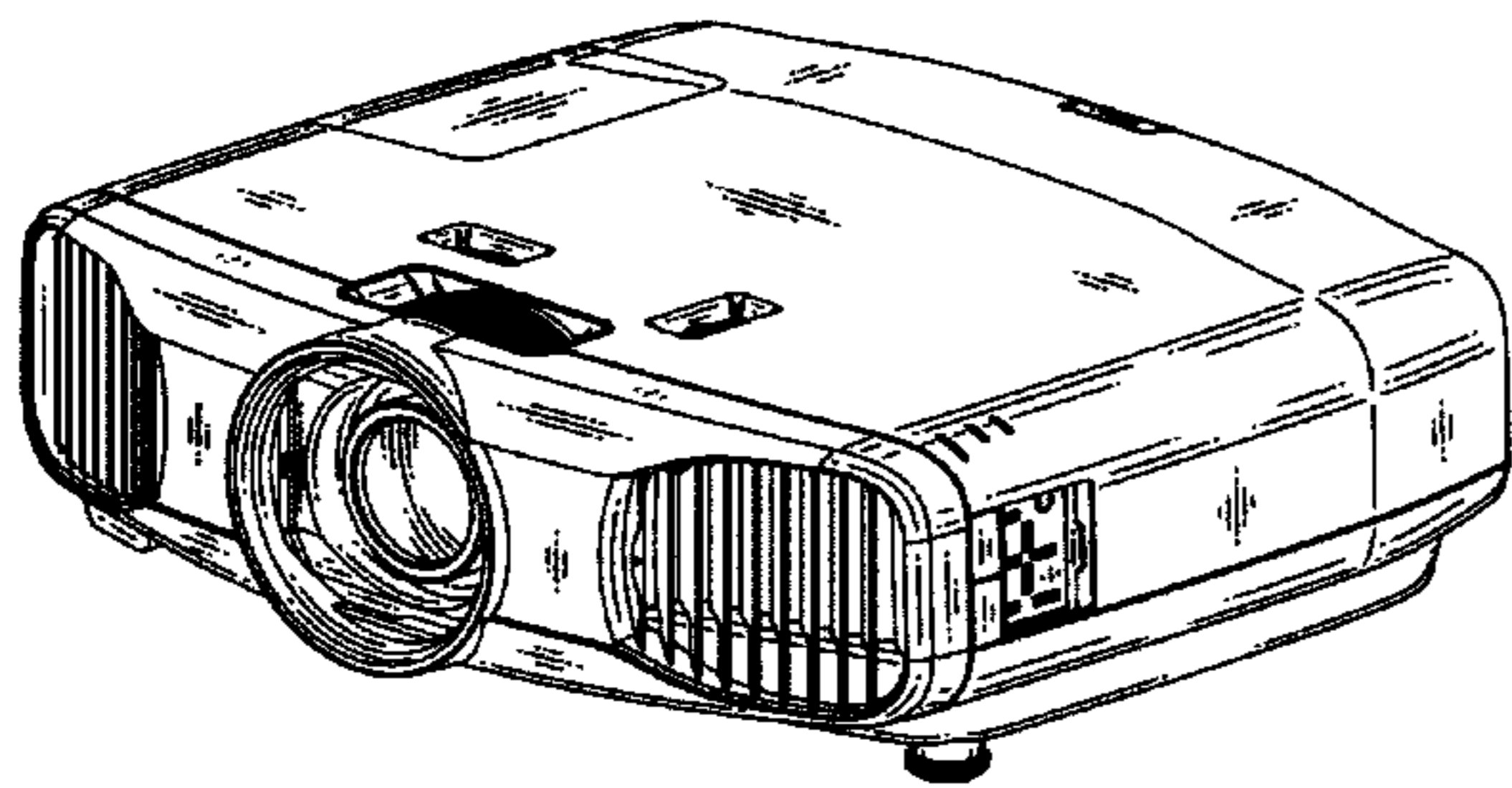
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, right-side perspective view of a projector;

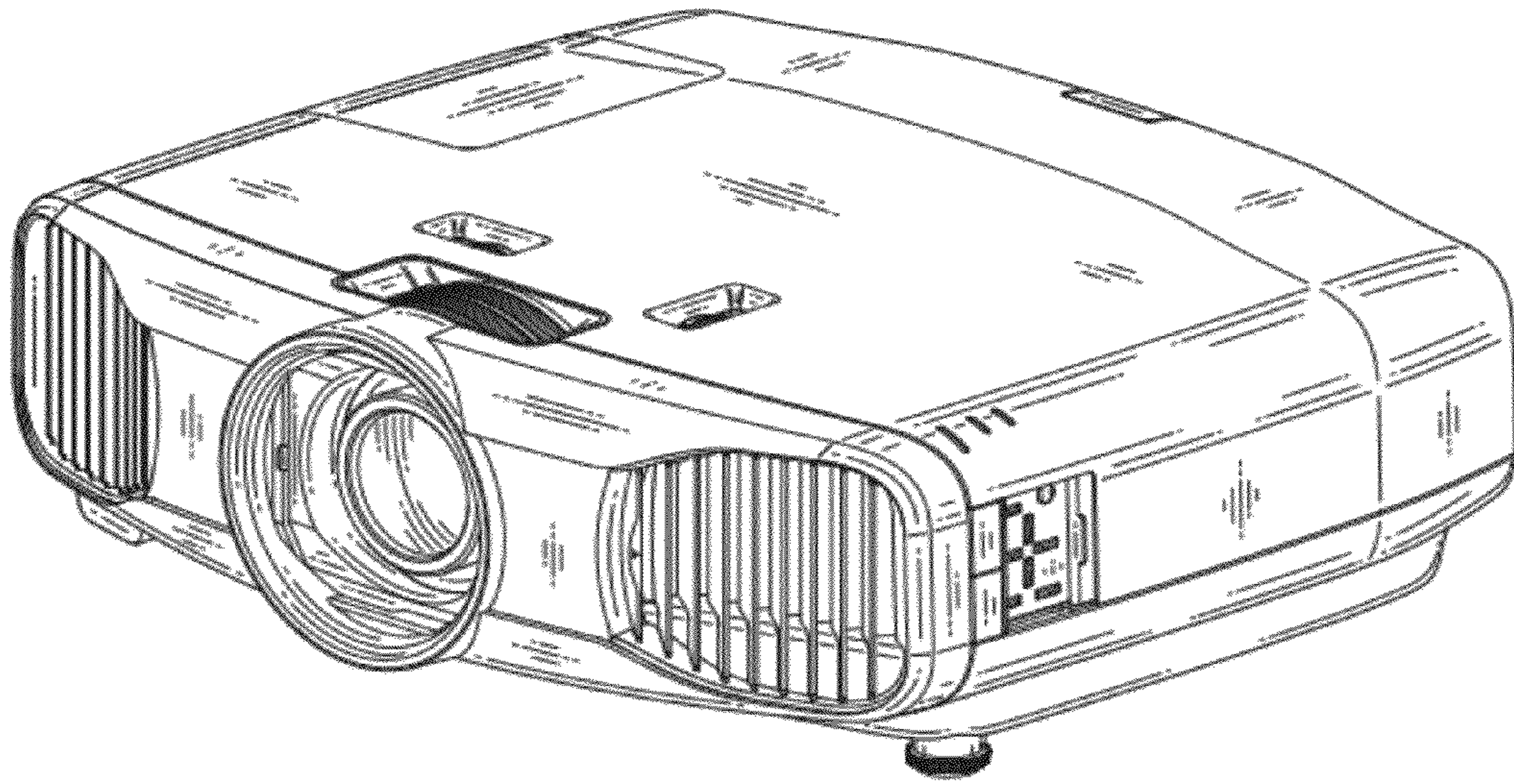

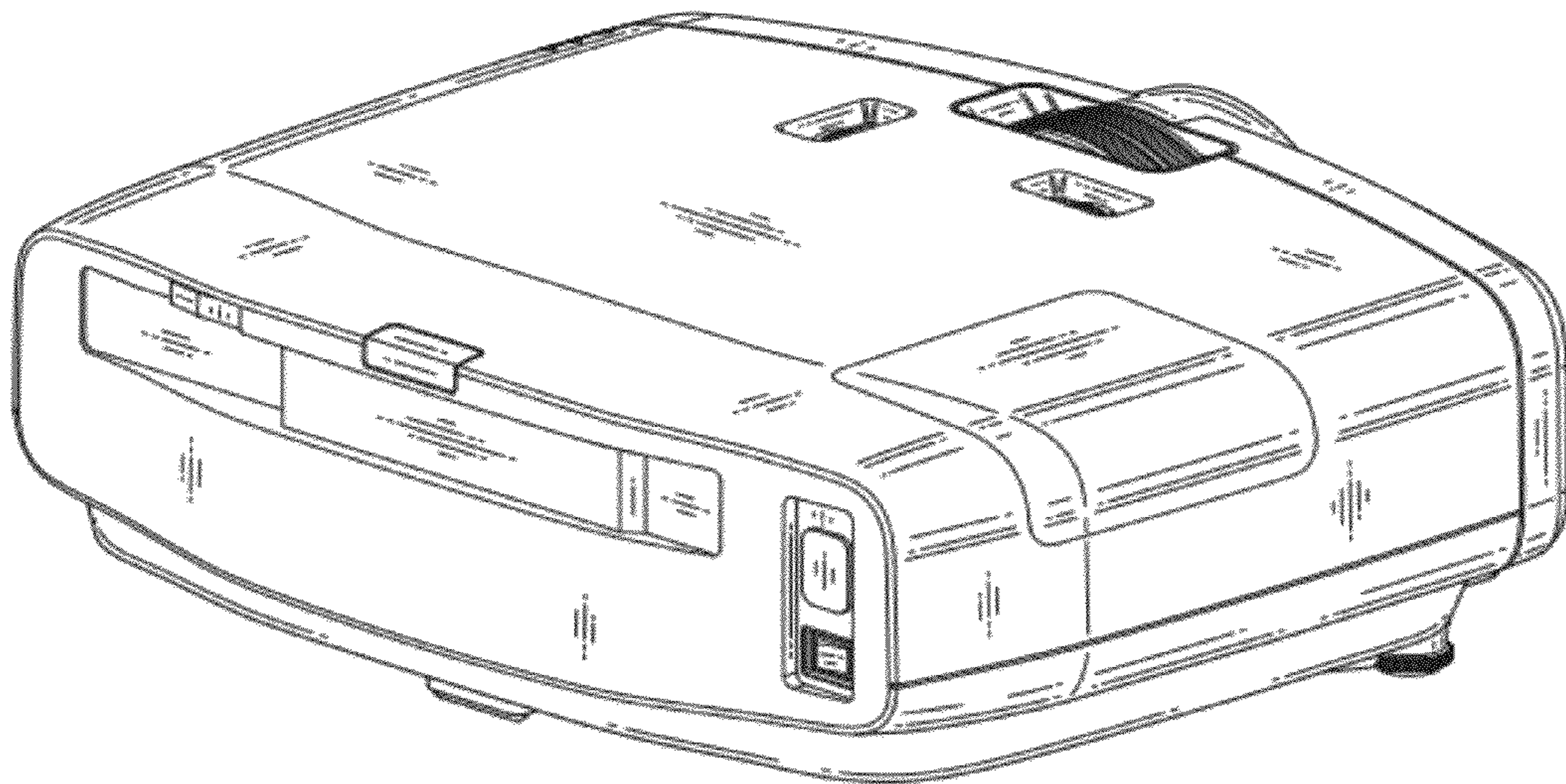

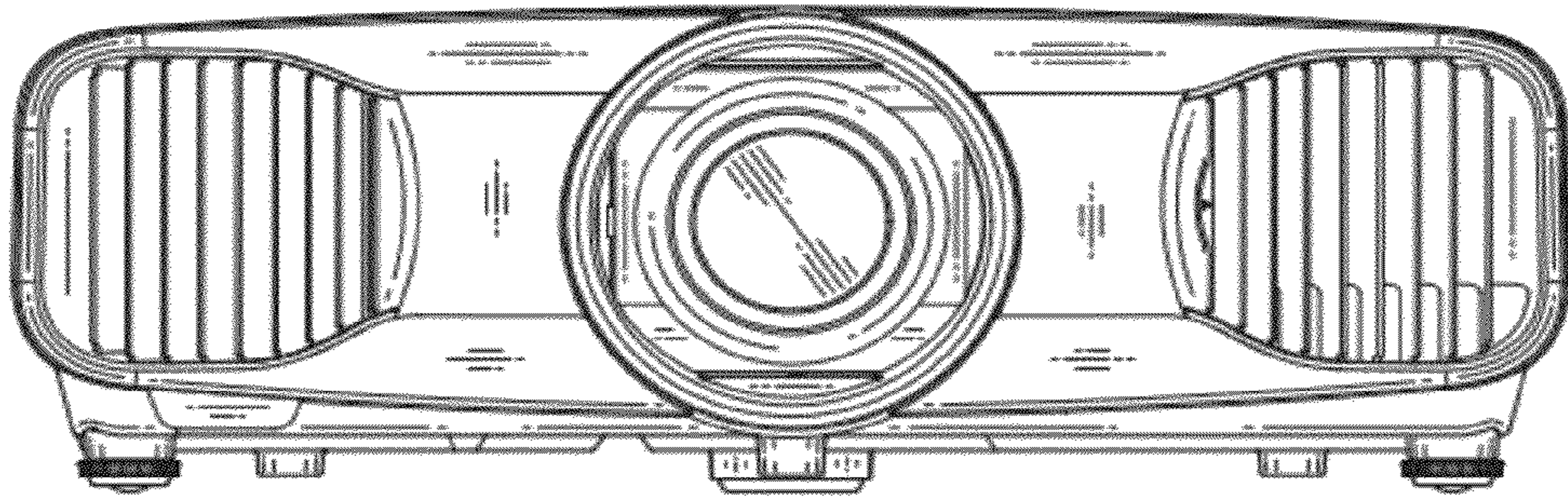

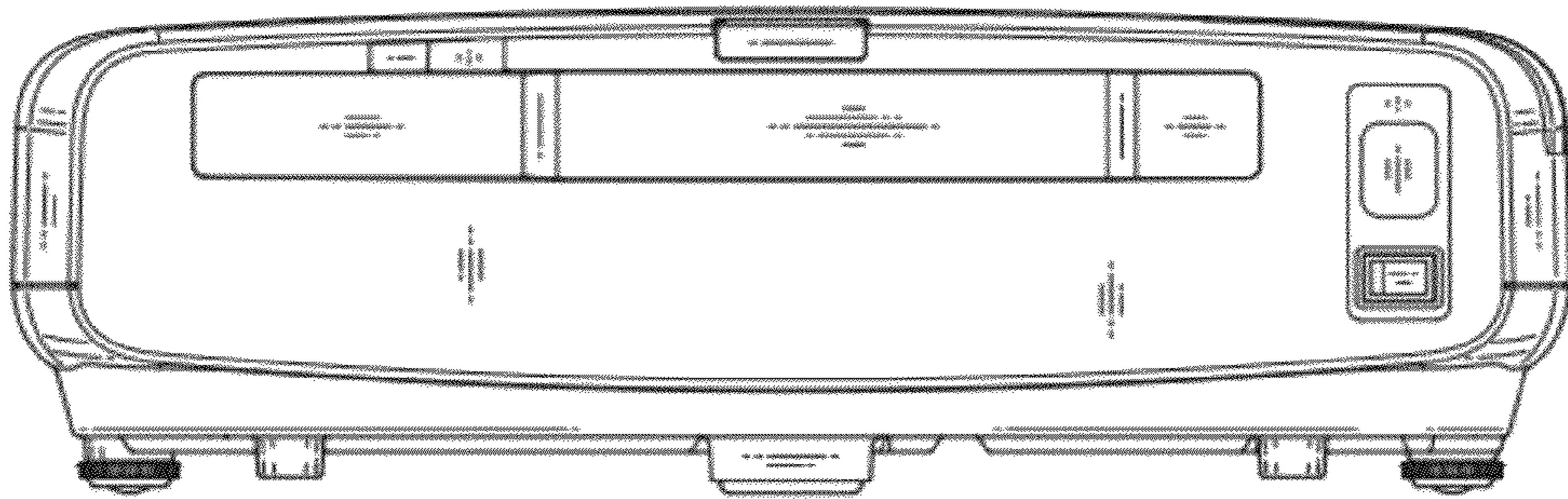

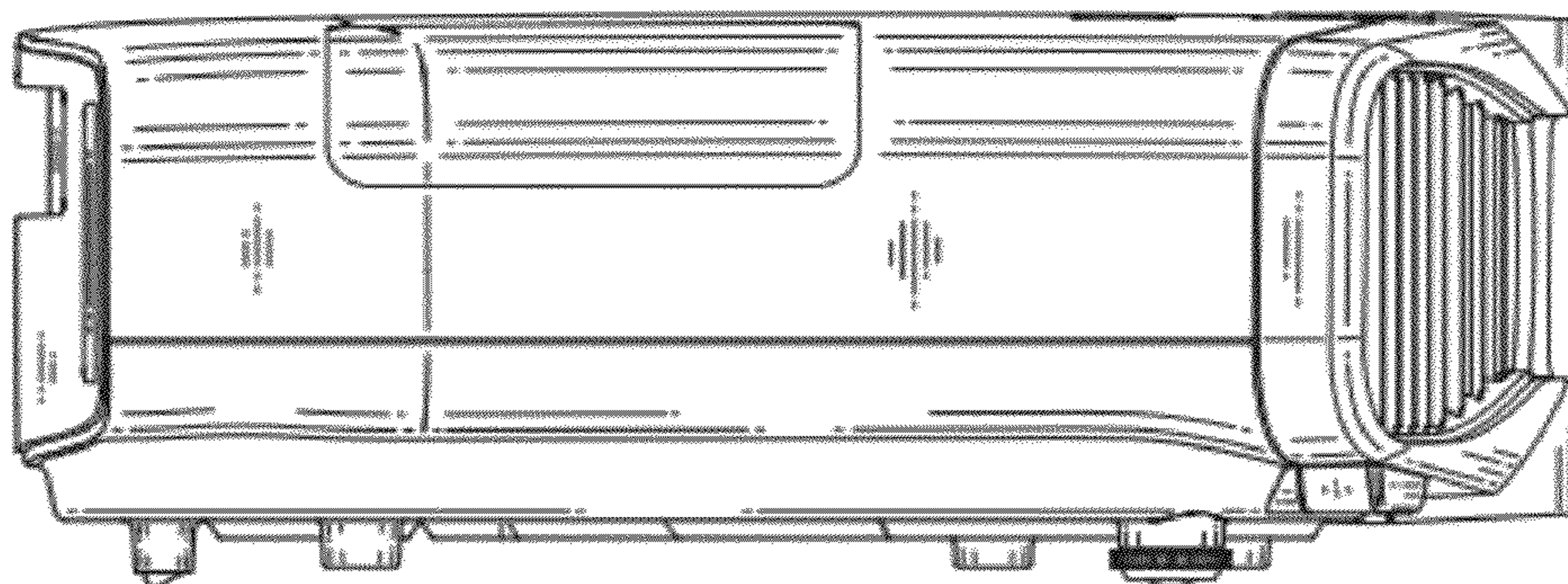

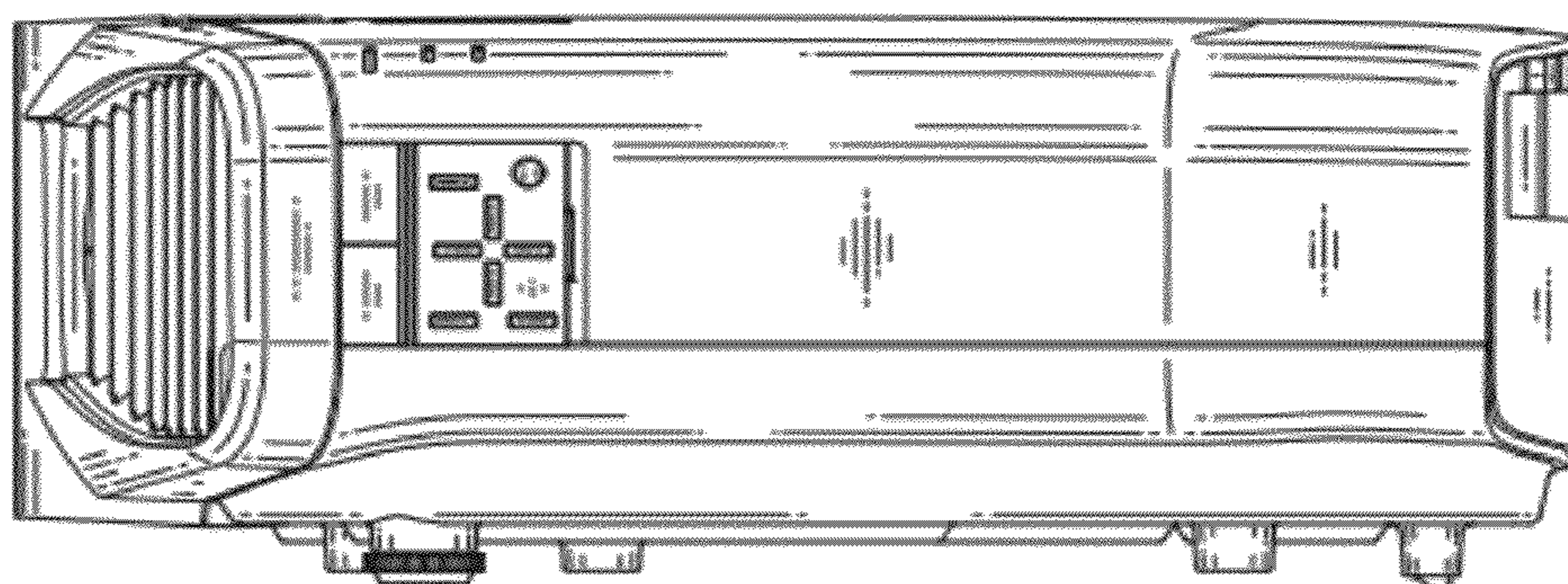

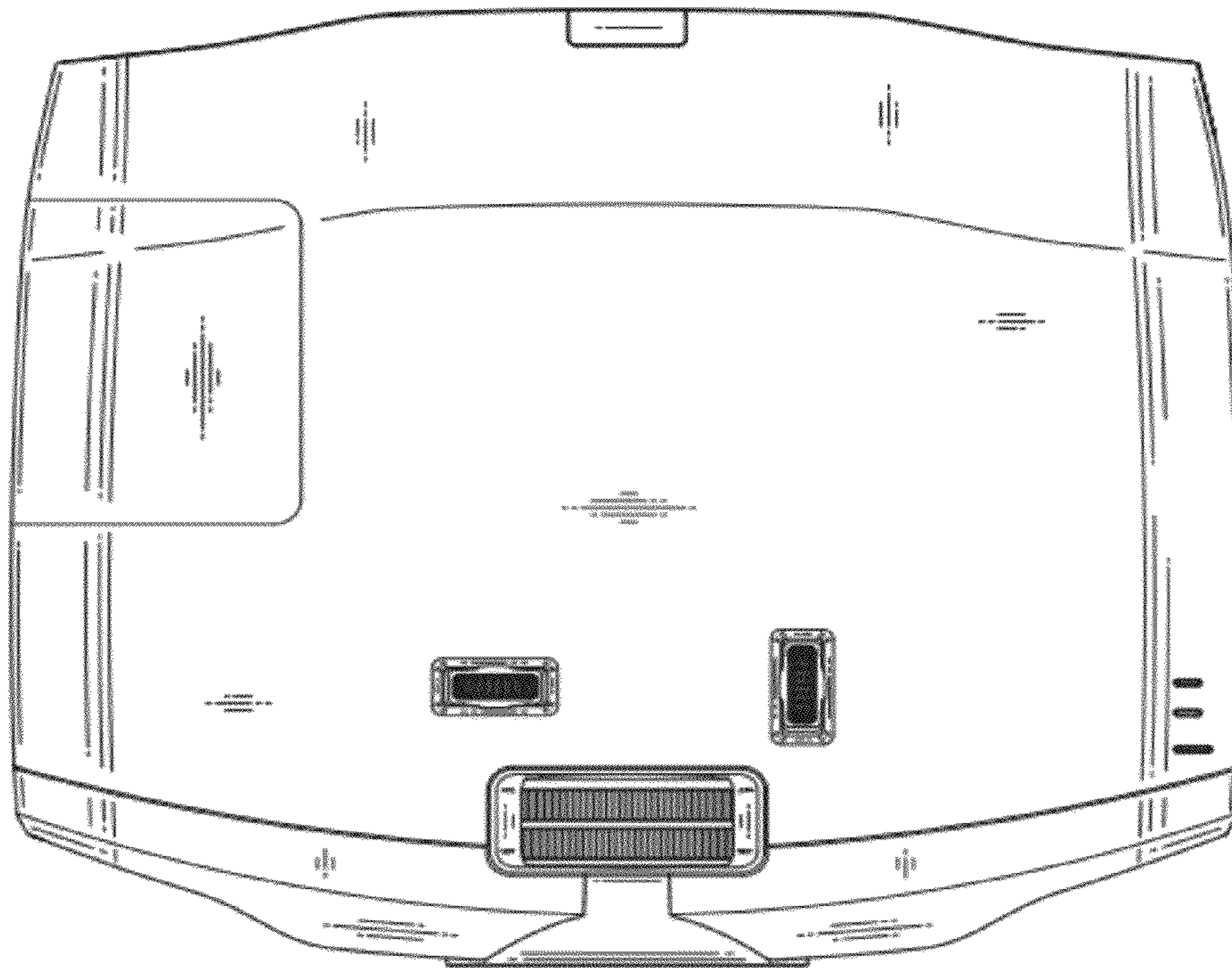

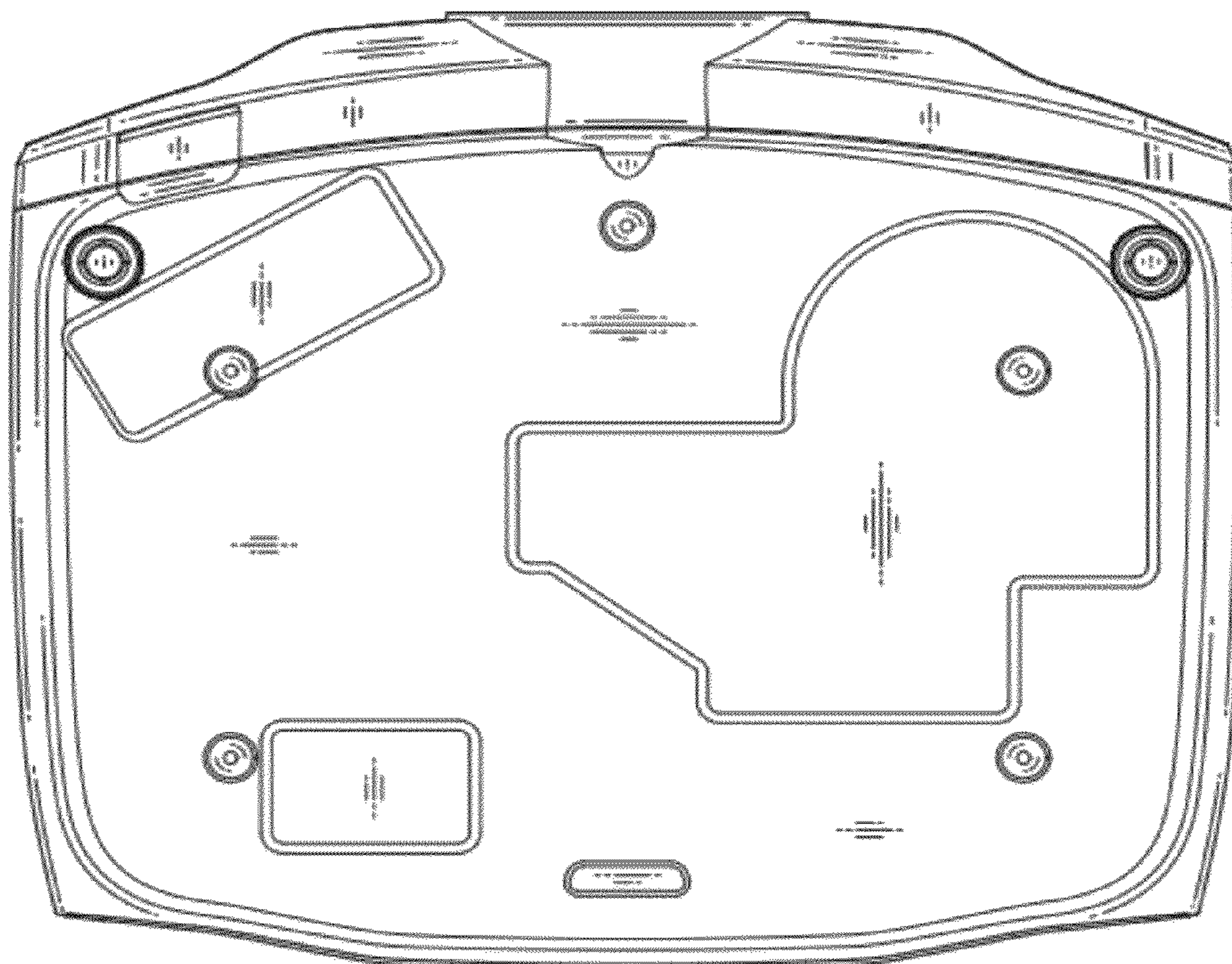

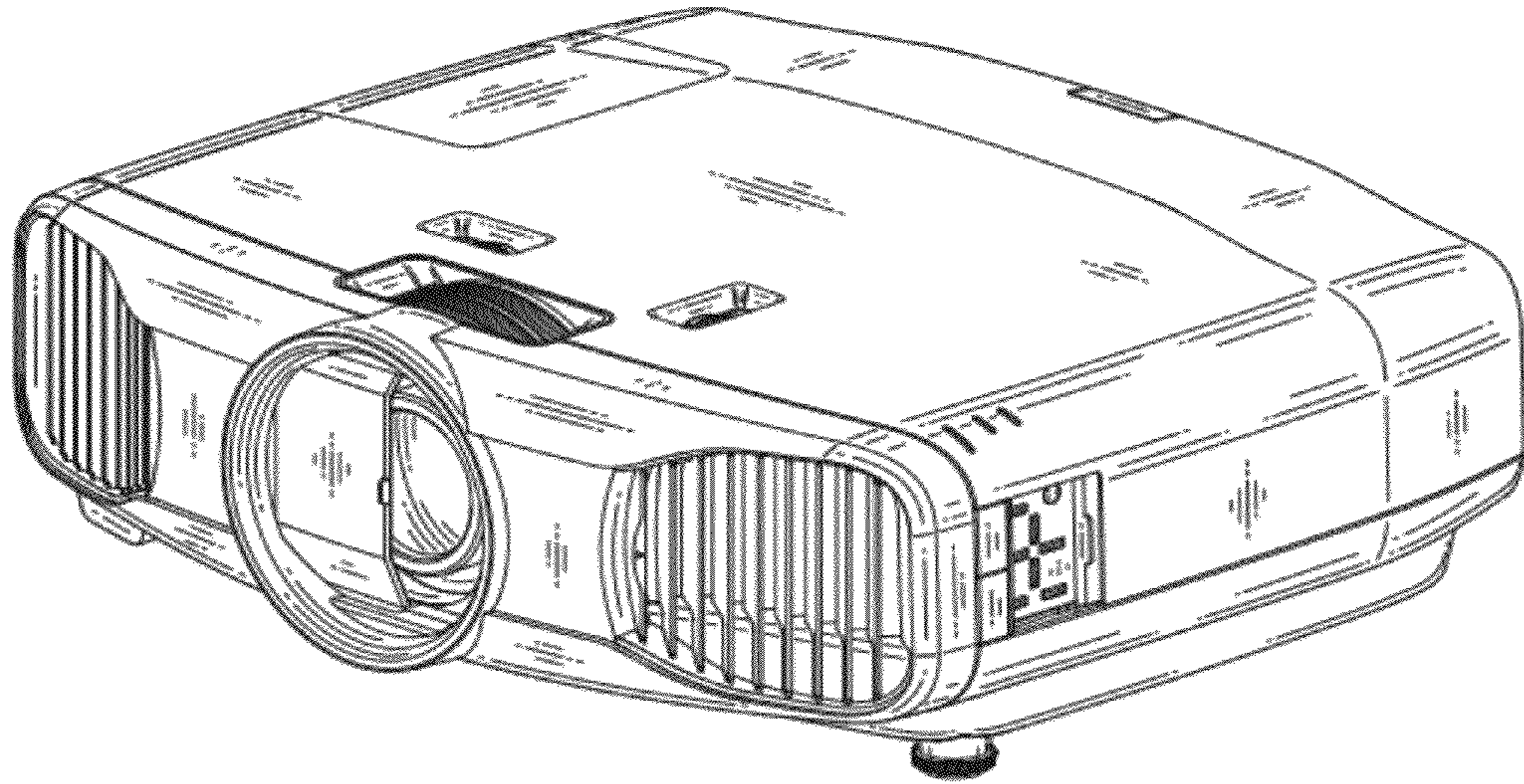

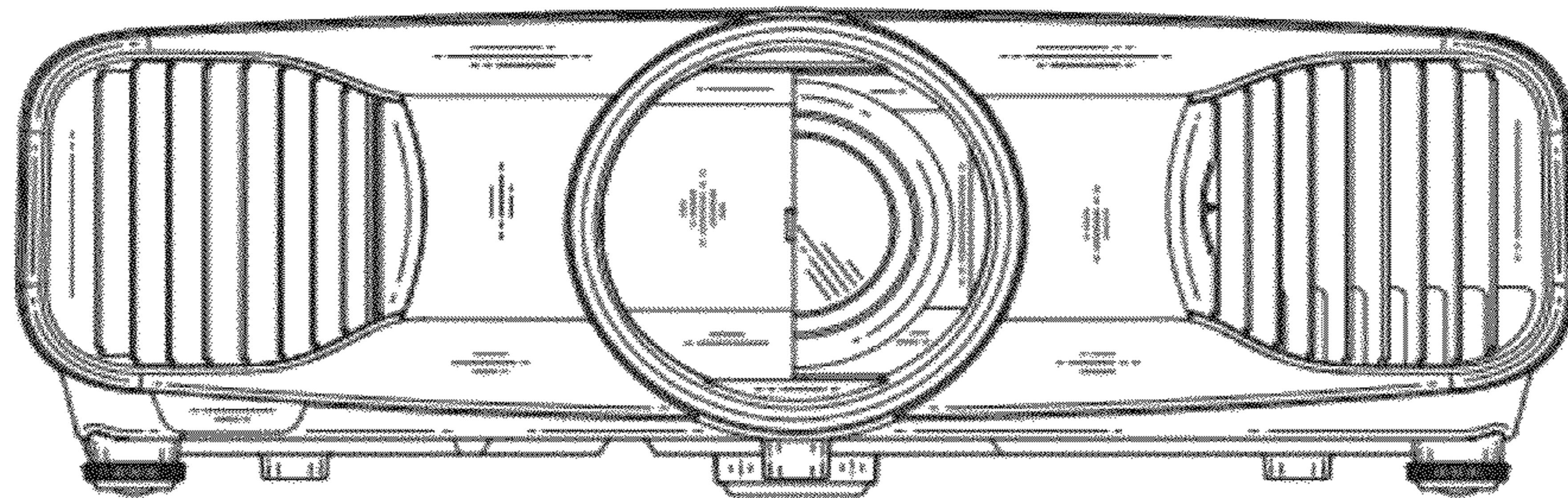

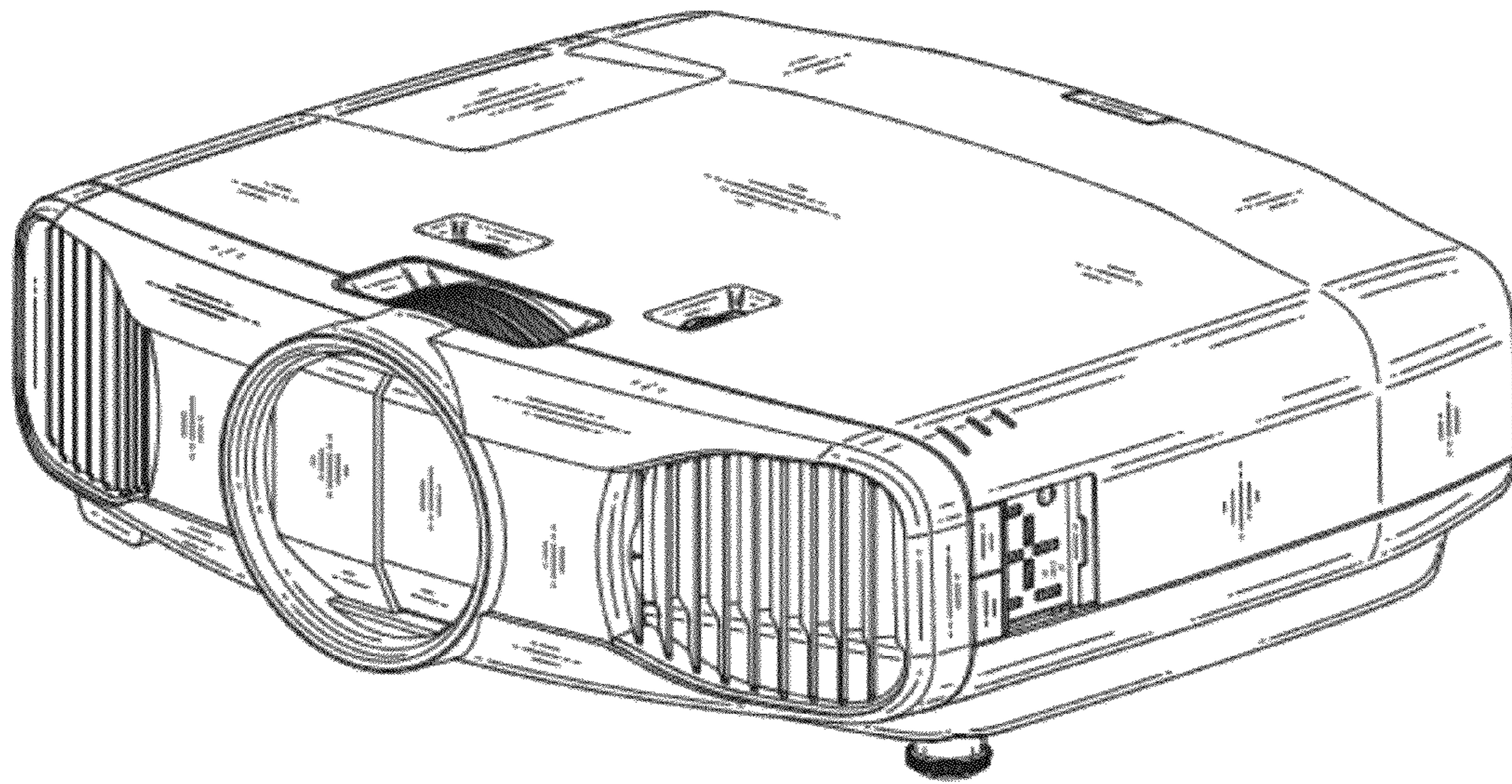

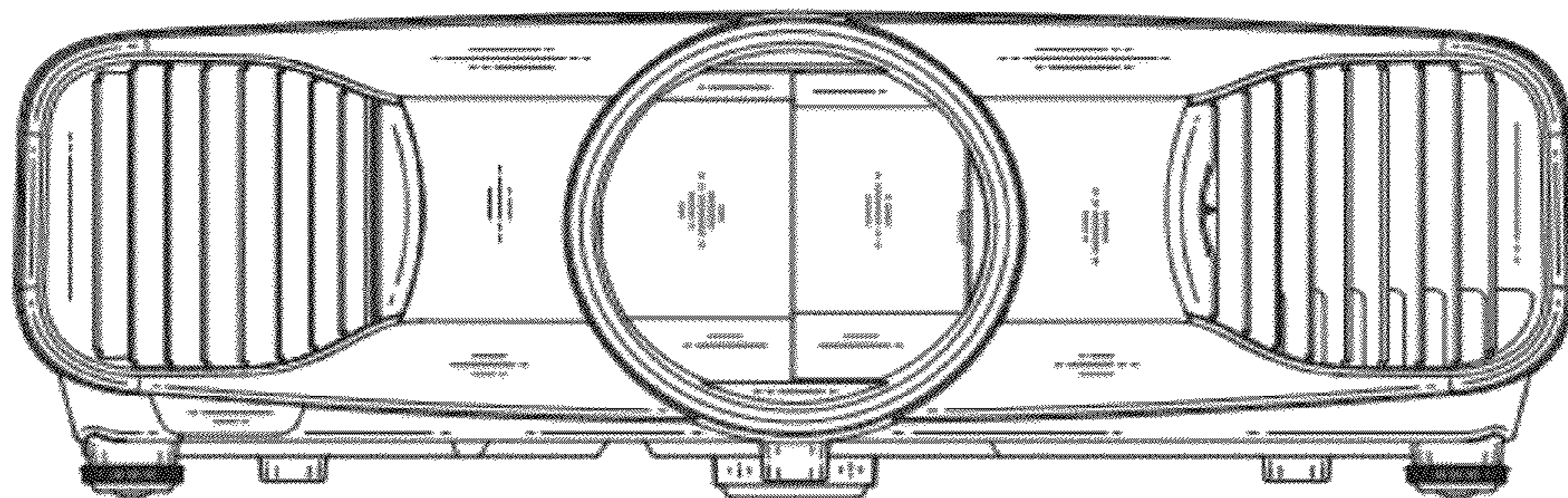
