The ornamental designs for a greeting card, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the greeting card of the present invention, in a closed position.

FIG. 2 is a front view of the greeting card of FIG. 1.

FIG. 3 is a rear view of the greeting card of FIG. 1.

FIG. 4 is a right side view of the greeting card of FIG. 1.

FIG. 5 is a left side view of the greeting card of FIG. 1.

FIG. 6 is a top view of the greeting card of FIG. 1.

FIG. 7 is a bottom view of the greeting card of FIG. 1.

FIG. 8 is a perspective view of the greeting card of FIG. 1, in an open position.

FIG. 9 is a right side view of the greeting card of FIG. 8, the left side of which is a mirror image thereof.

FIG. 10 is a front view of the greeting card of FIG. 8.

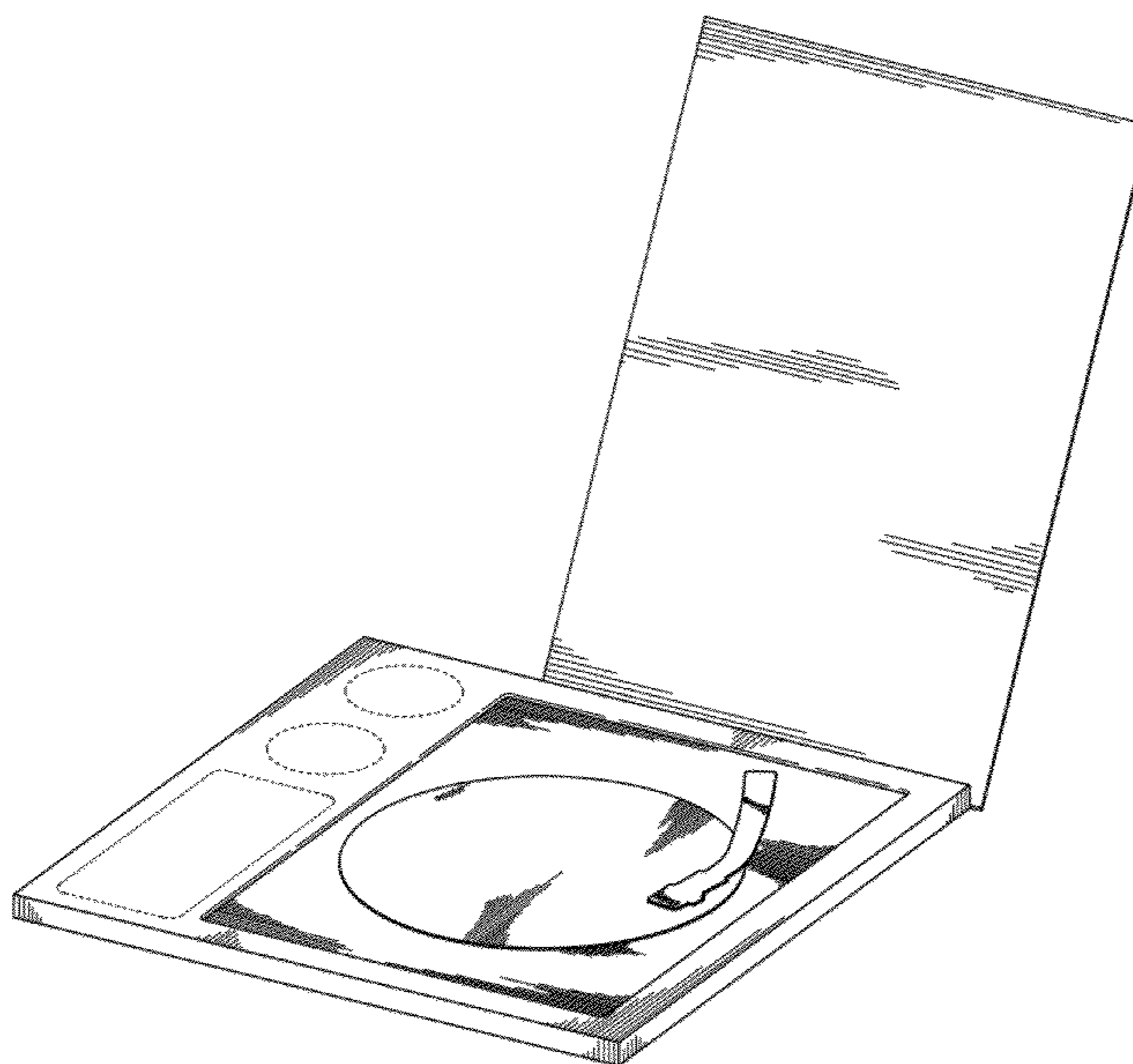
FIG. 11 is a rear view of the greeting card of FIG. 8.

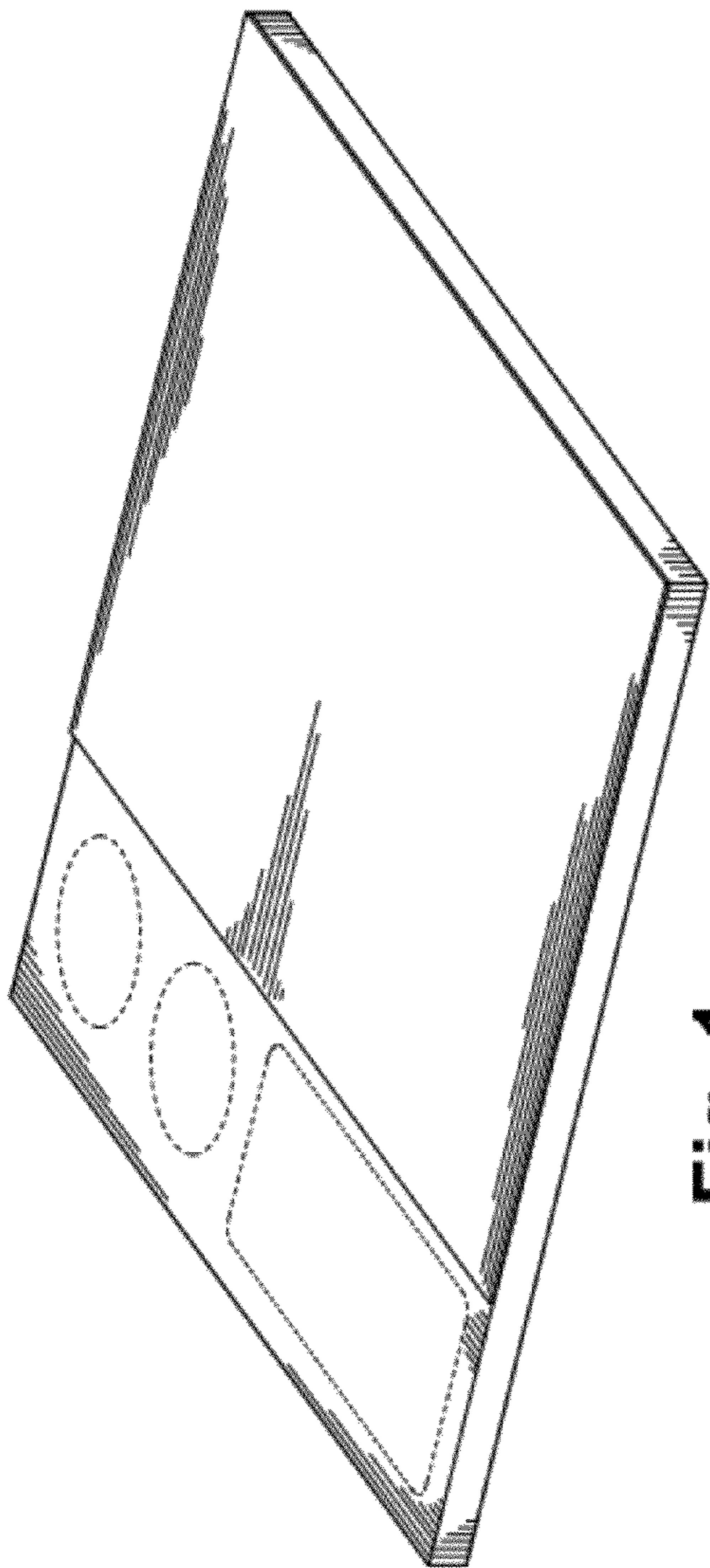

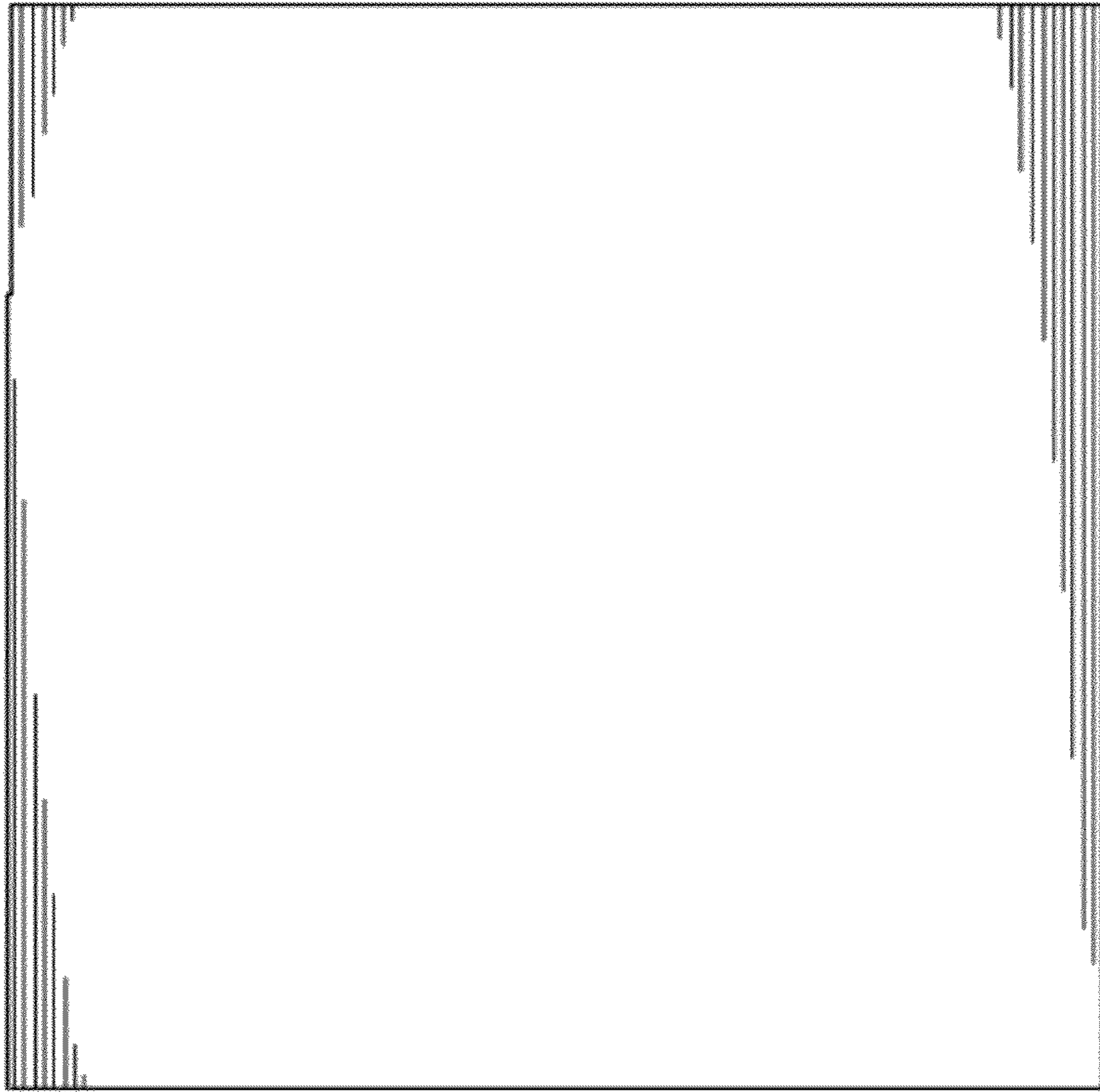

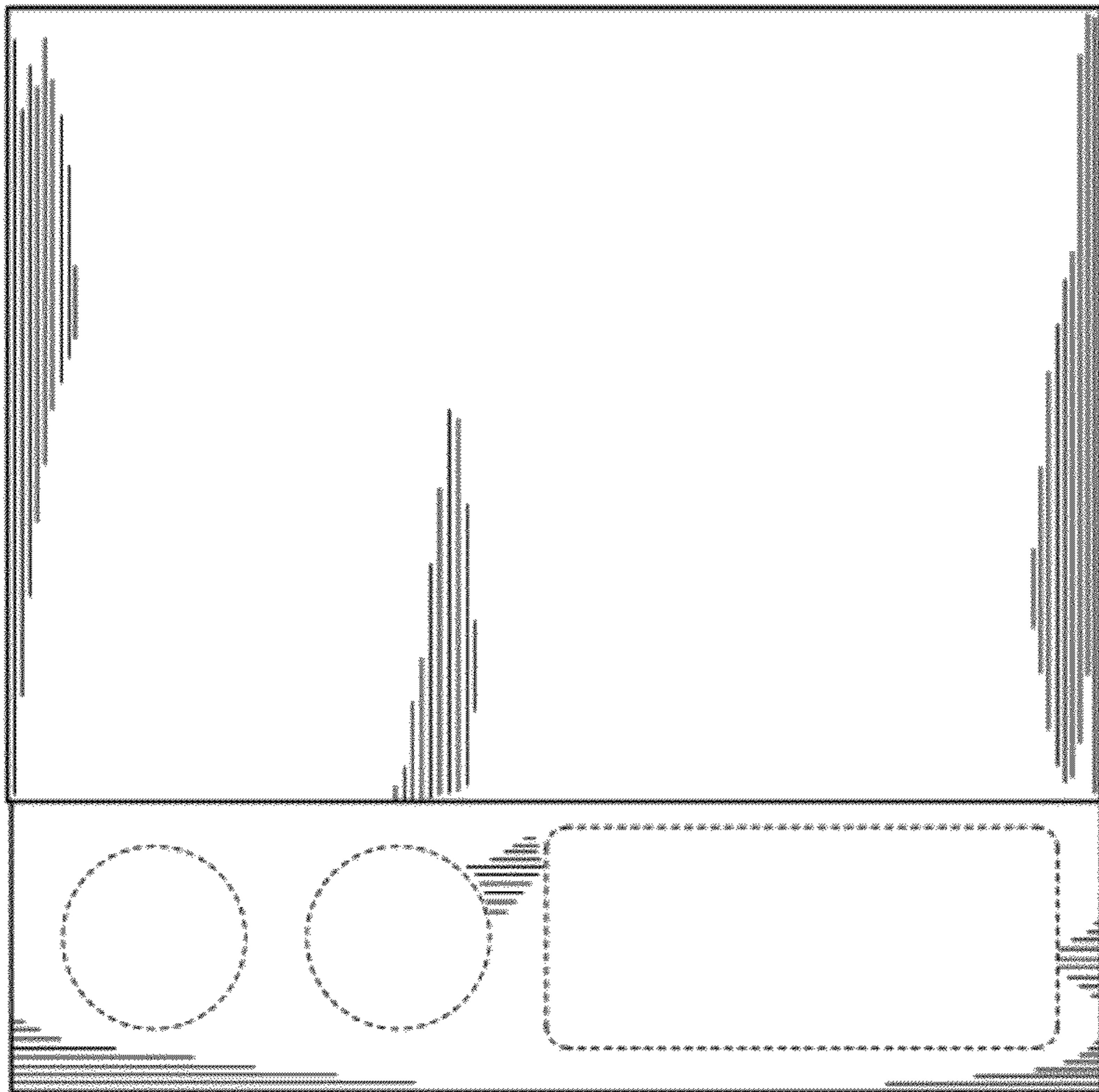

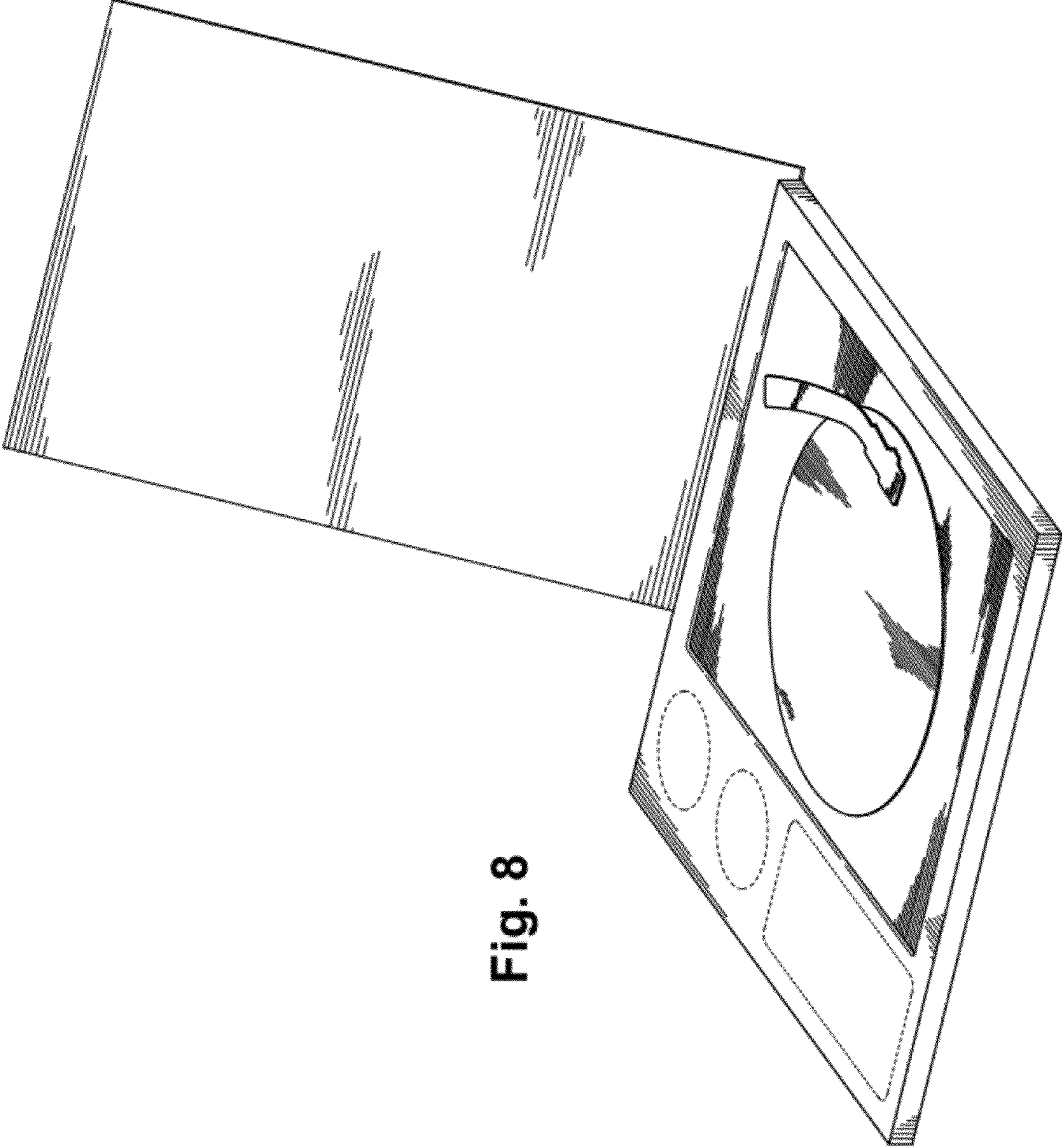

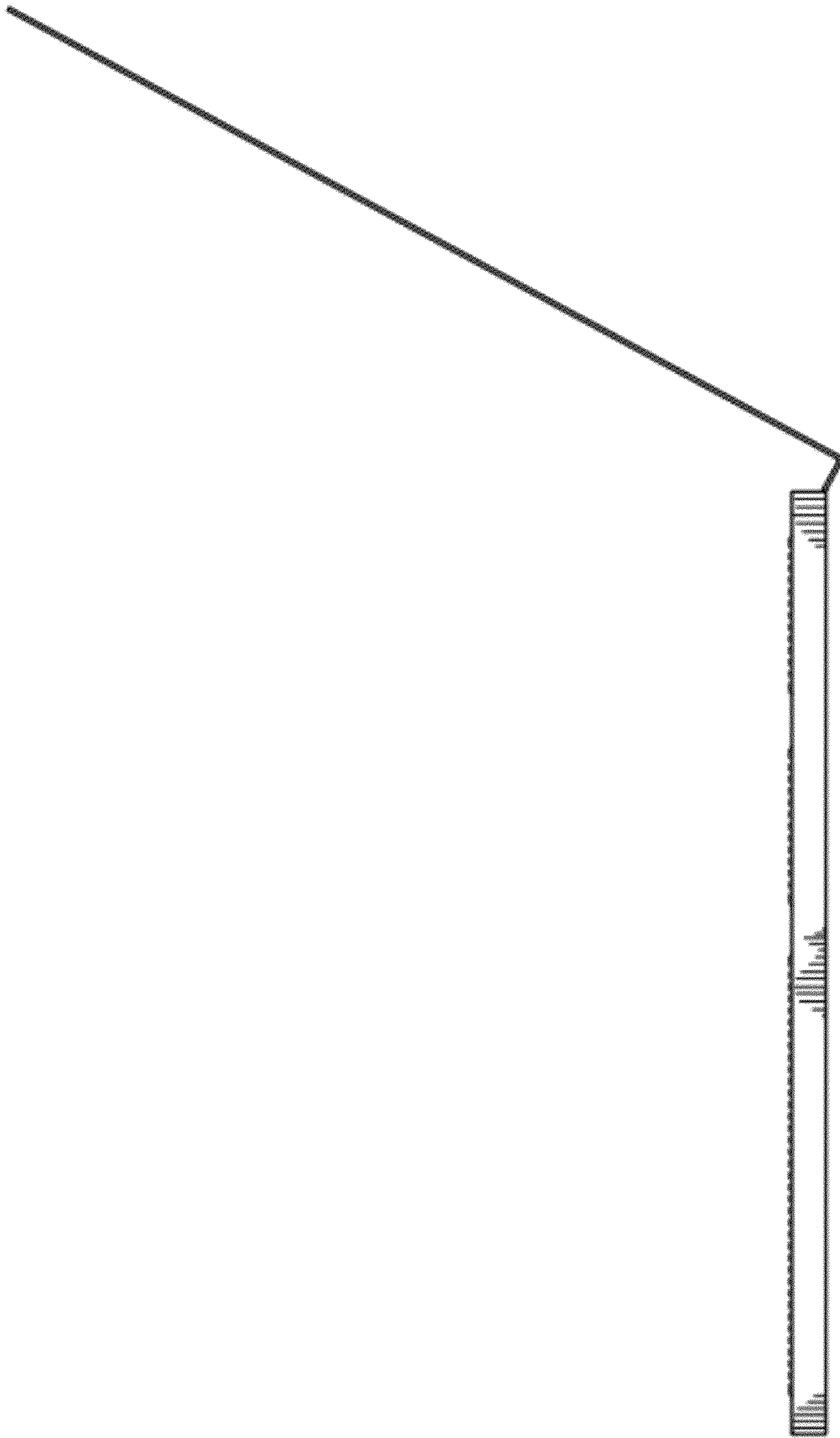

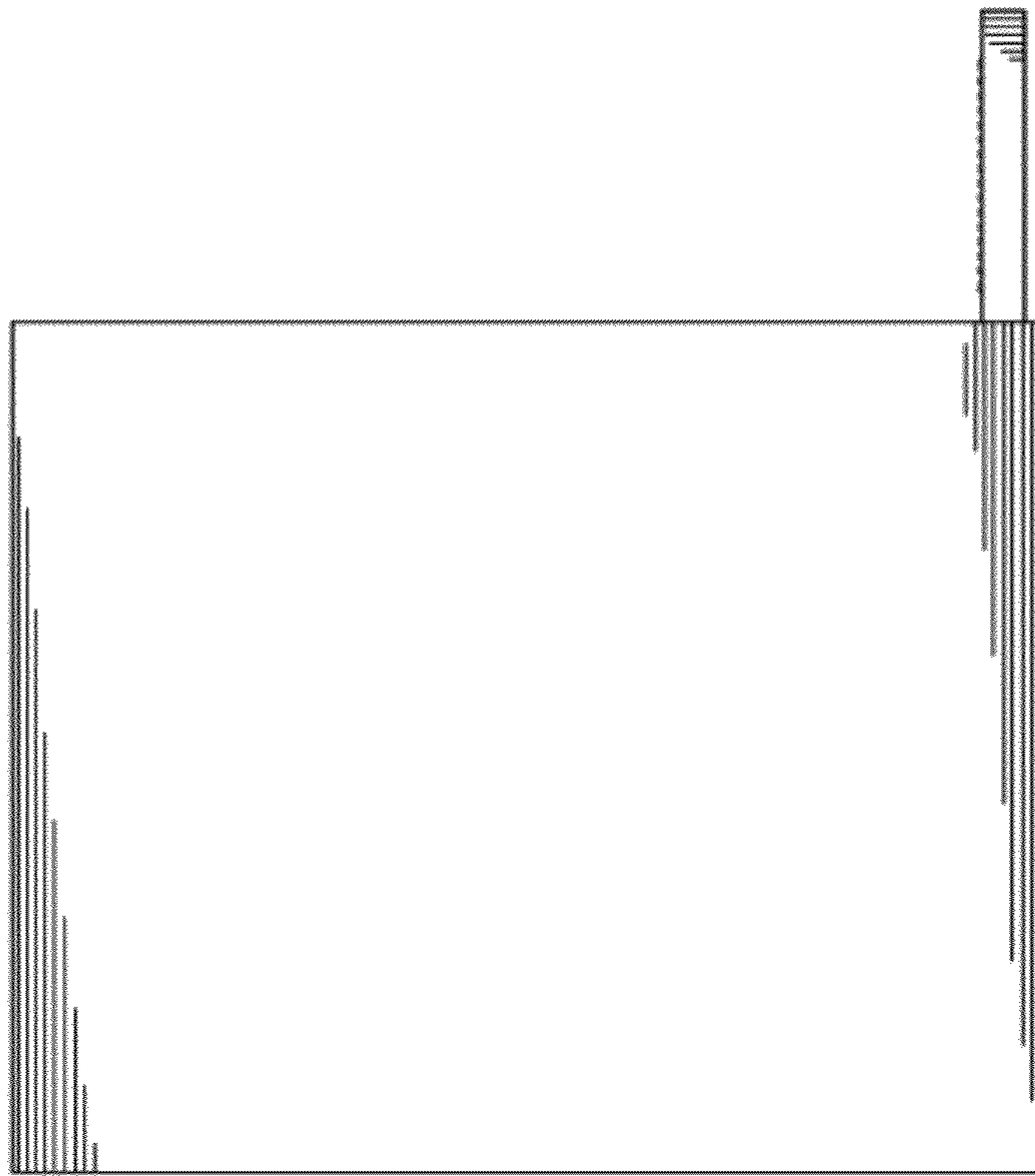

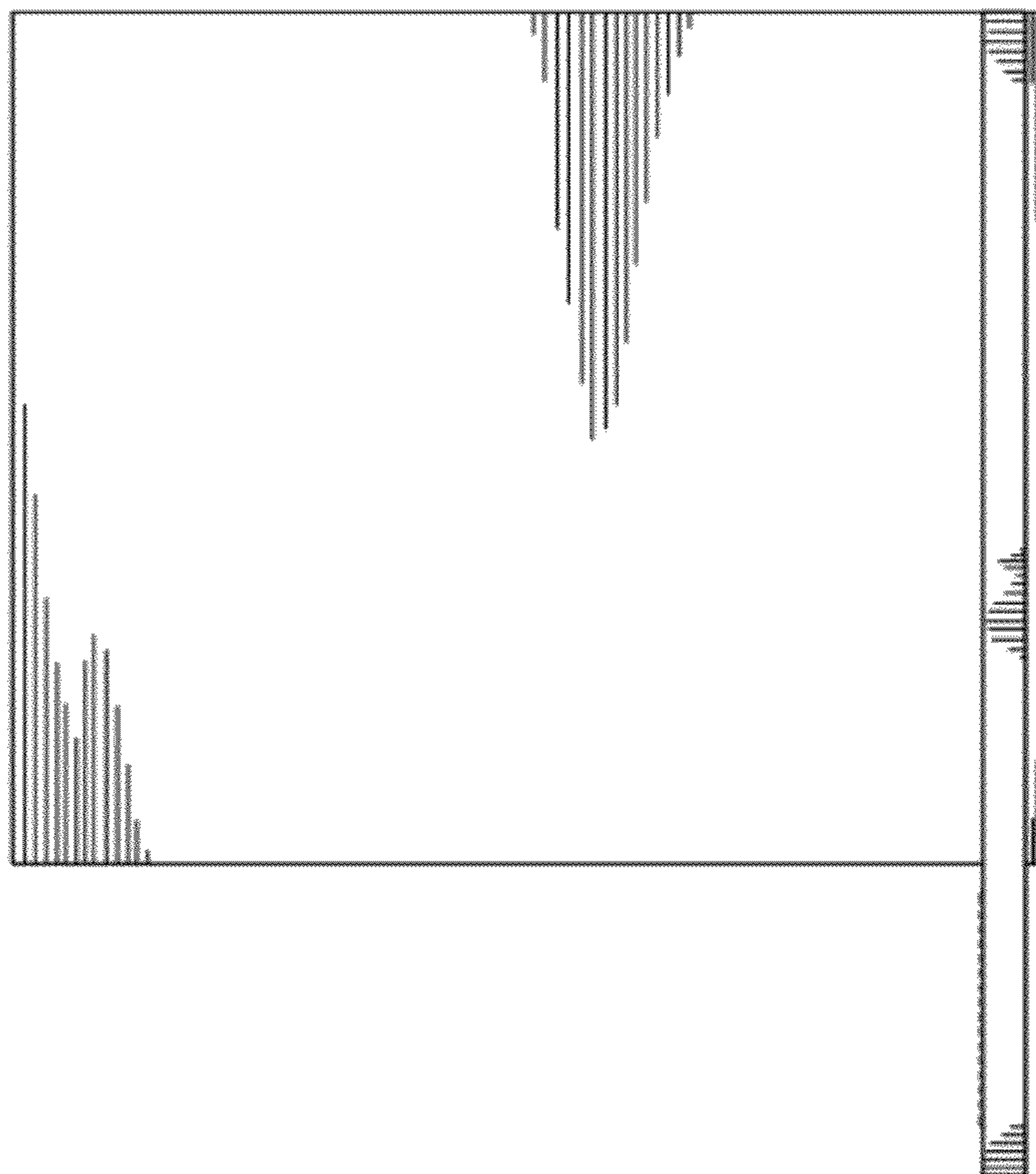

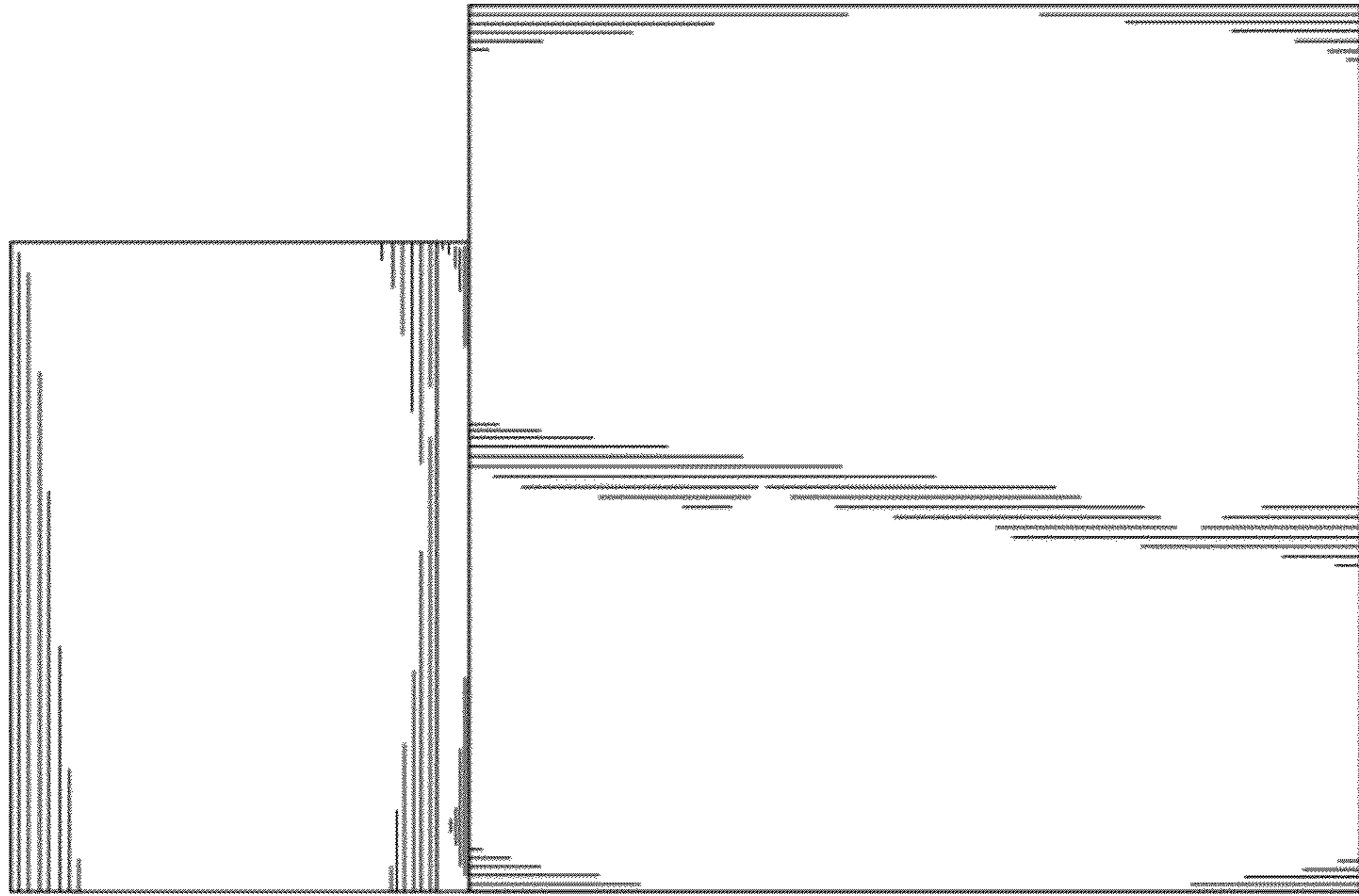

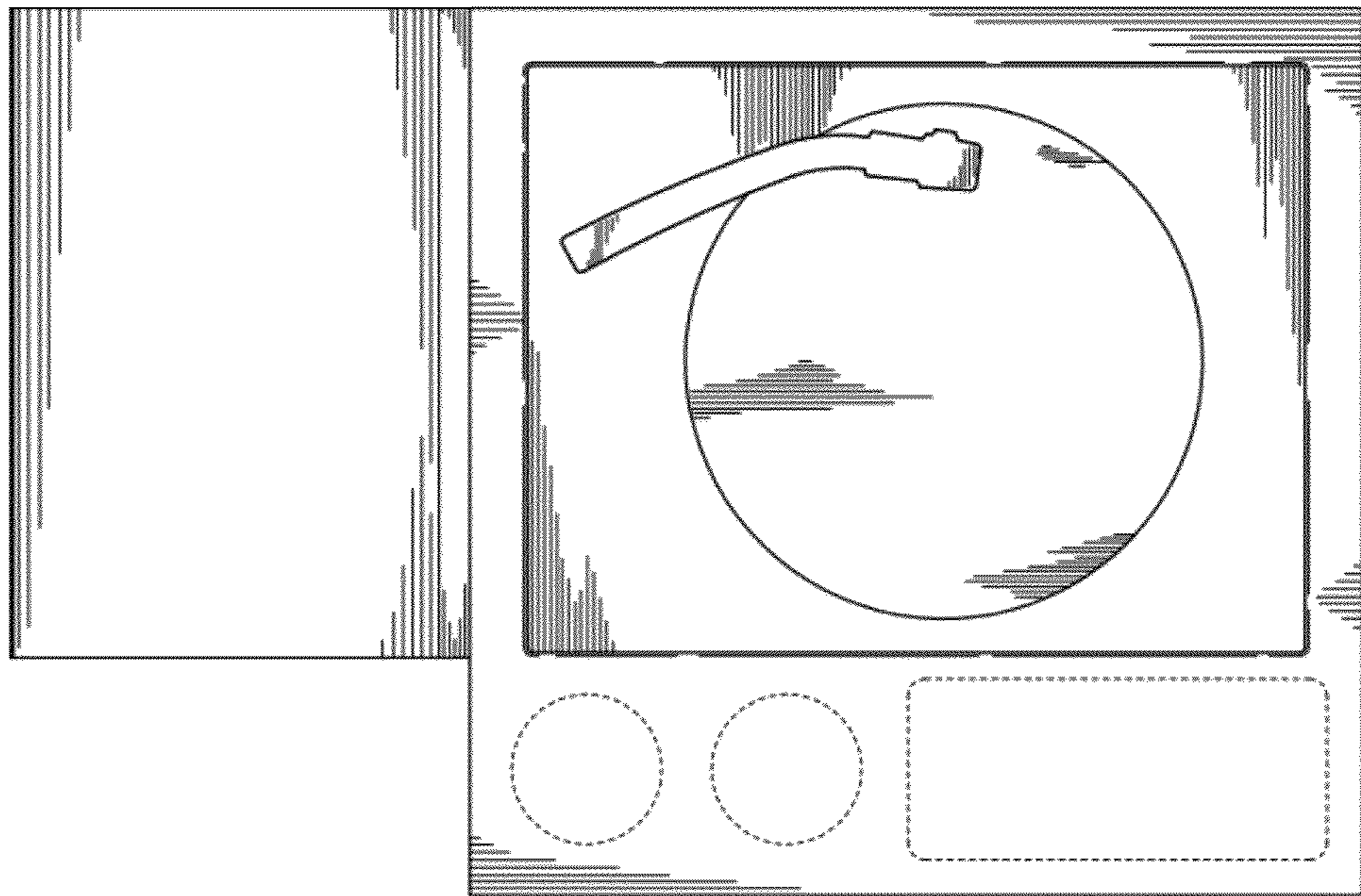
