**DESCRIPTION**

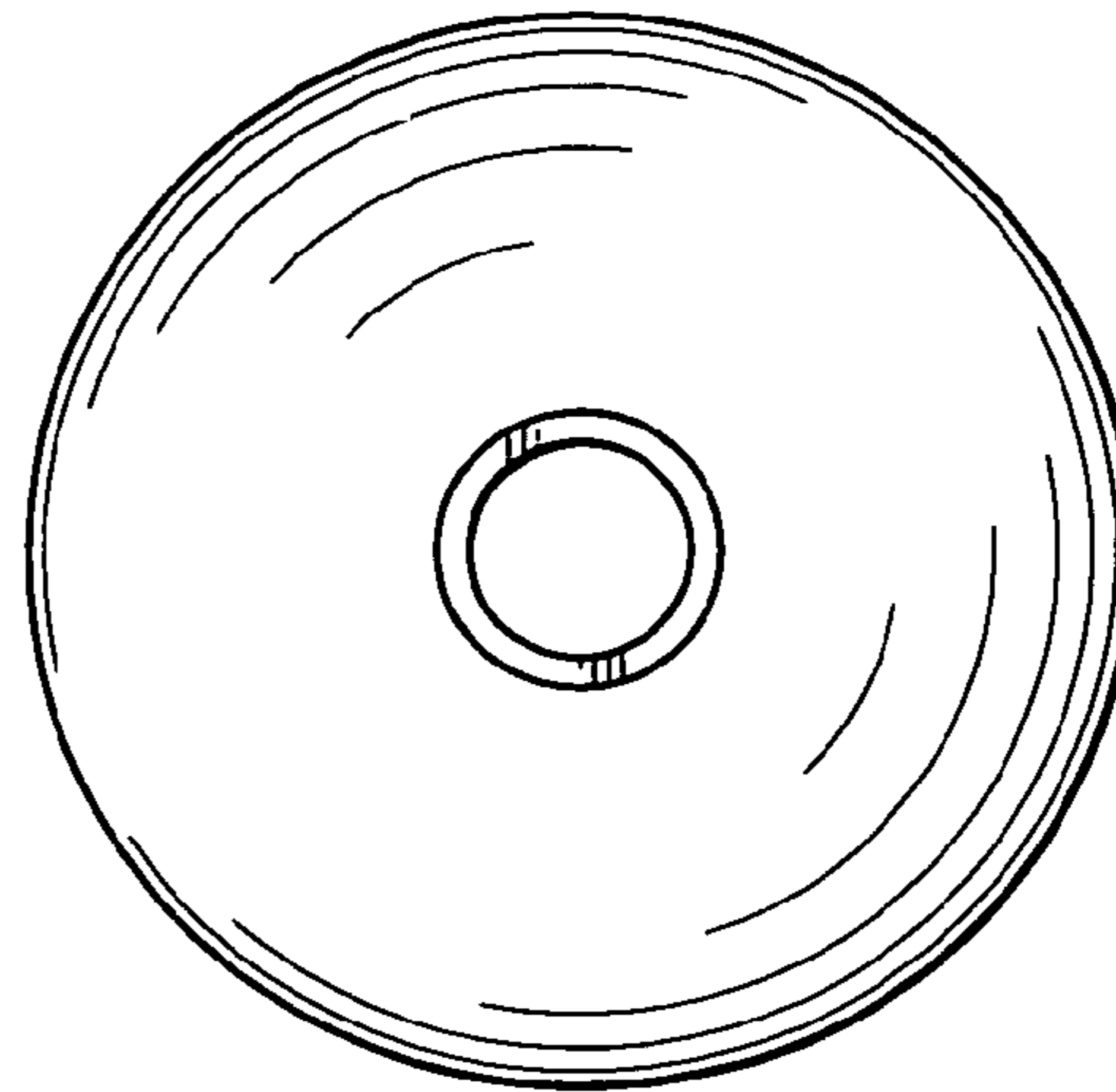
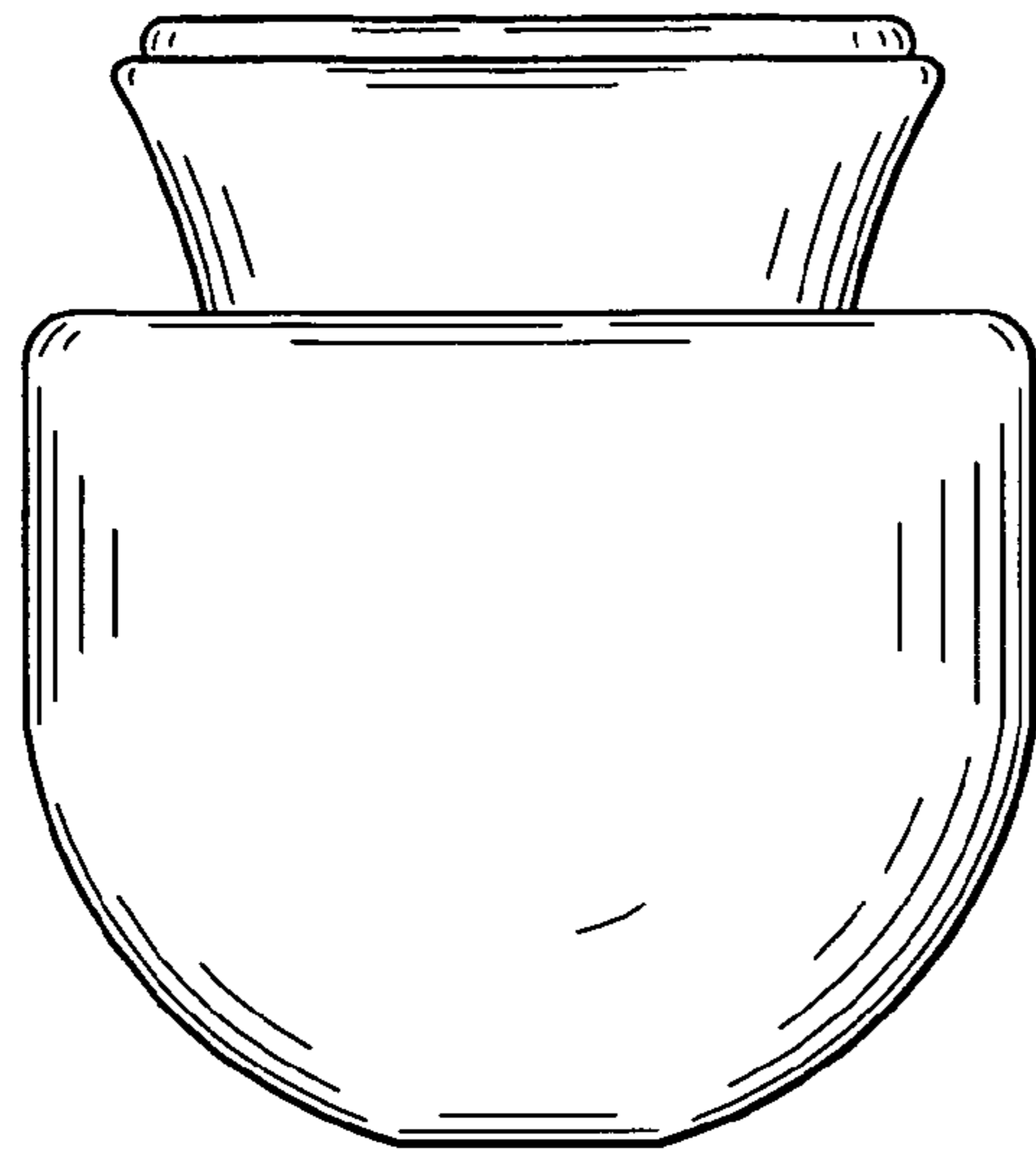
FIG. 1 is a right side elevational view thereof, left side and rear being a mirror image thereof.

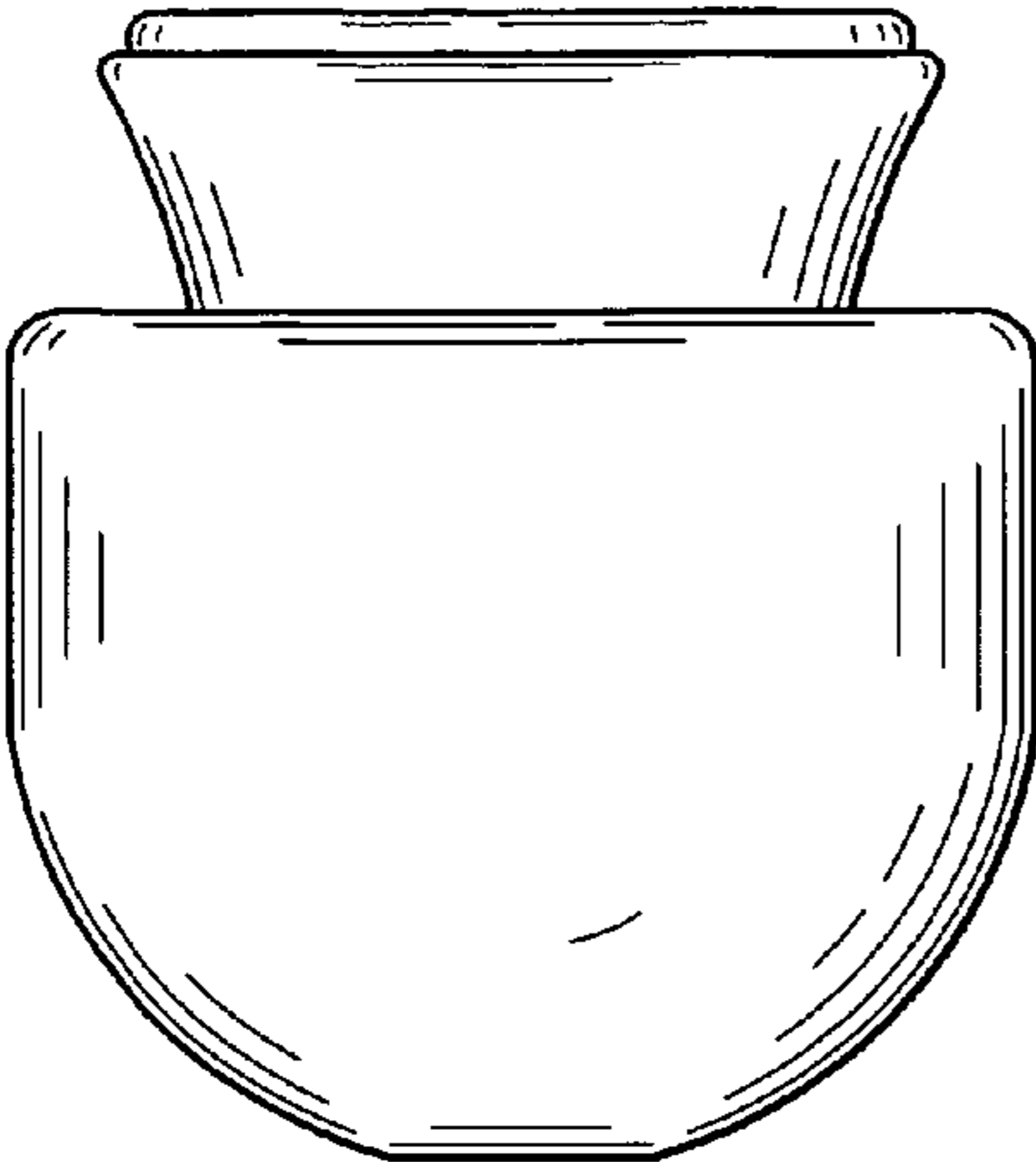

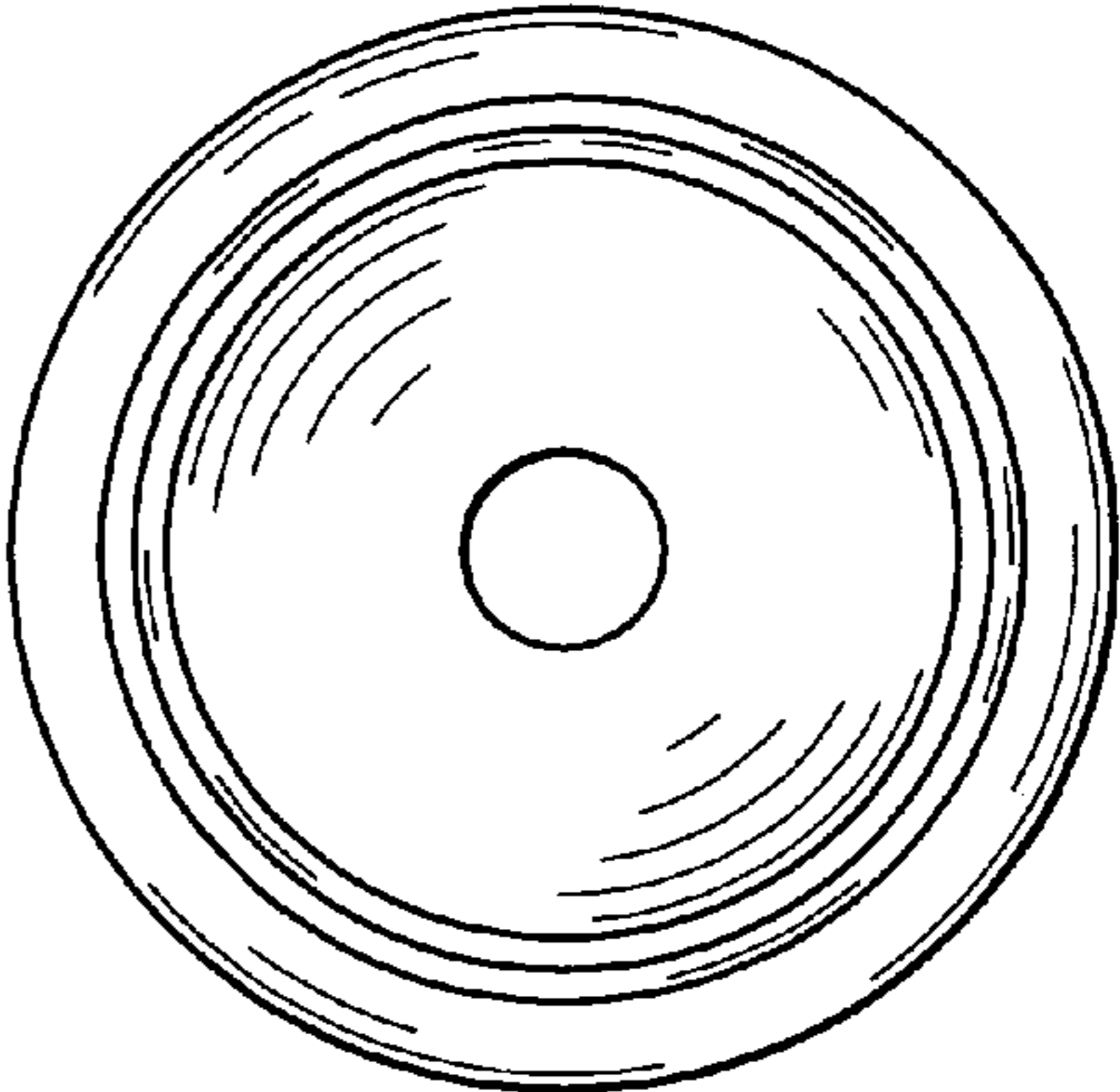

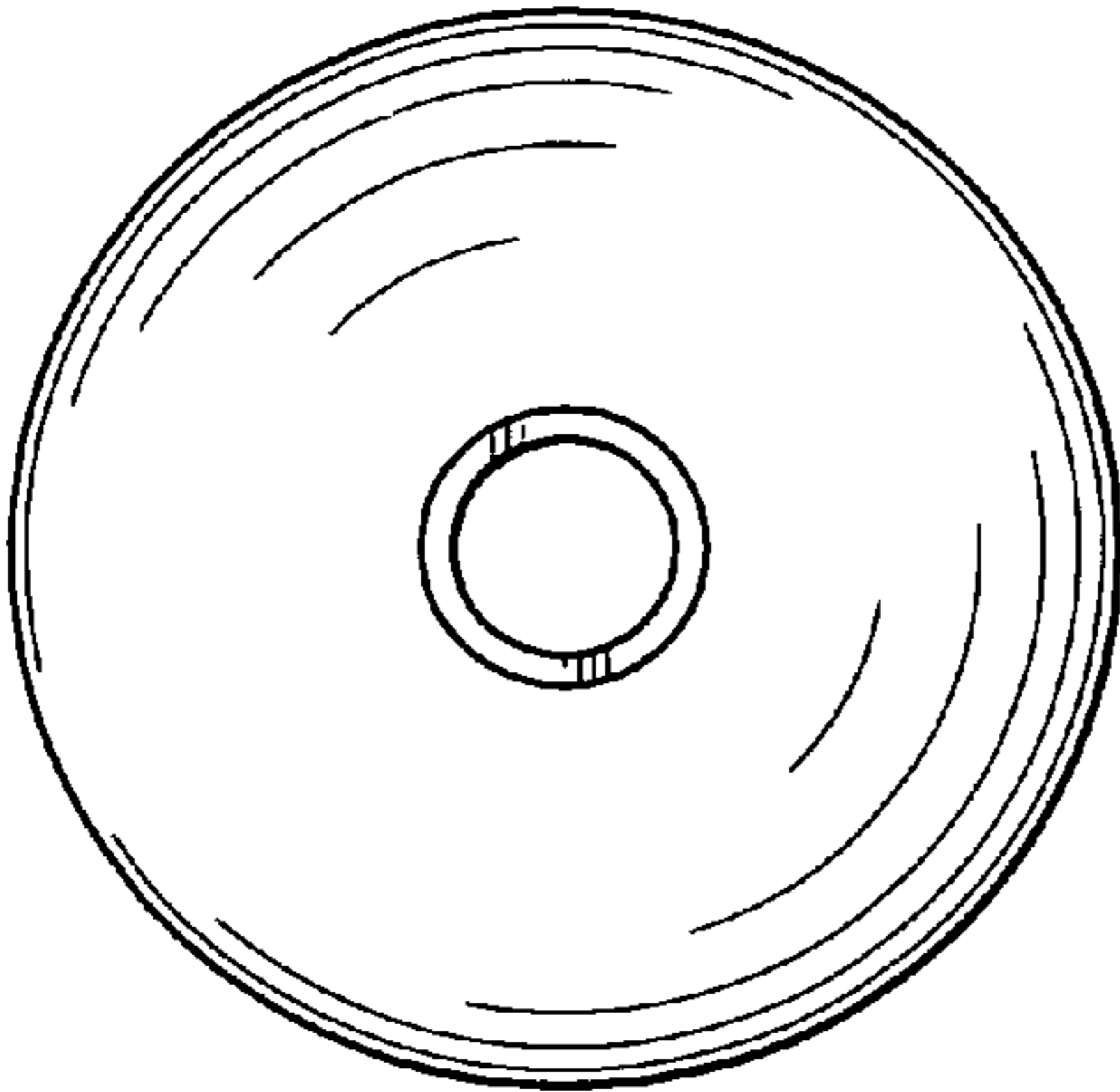

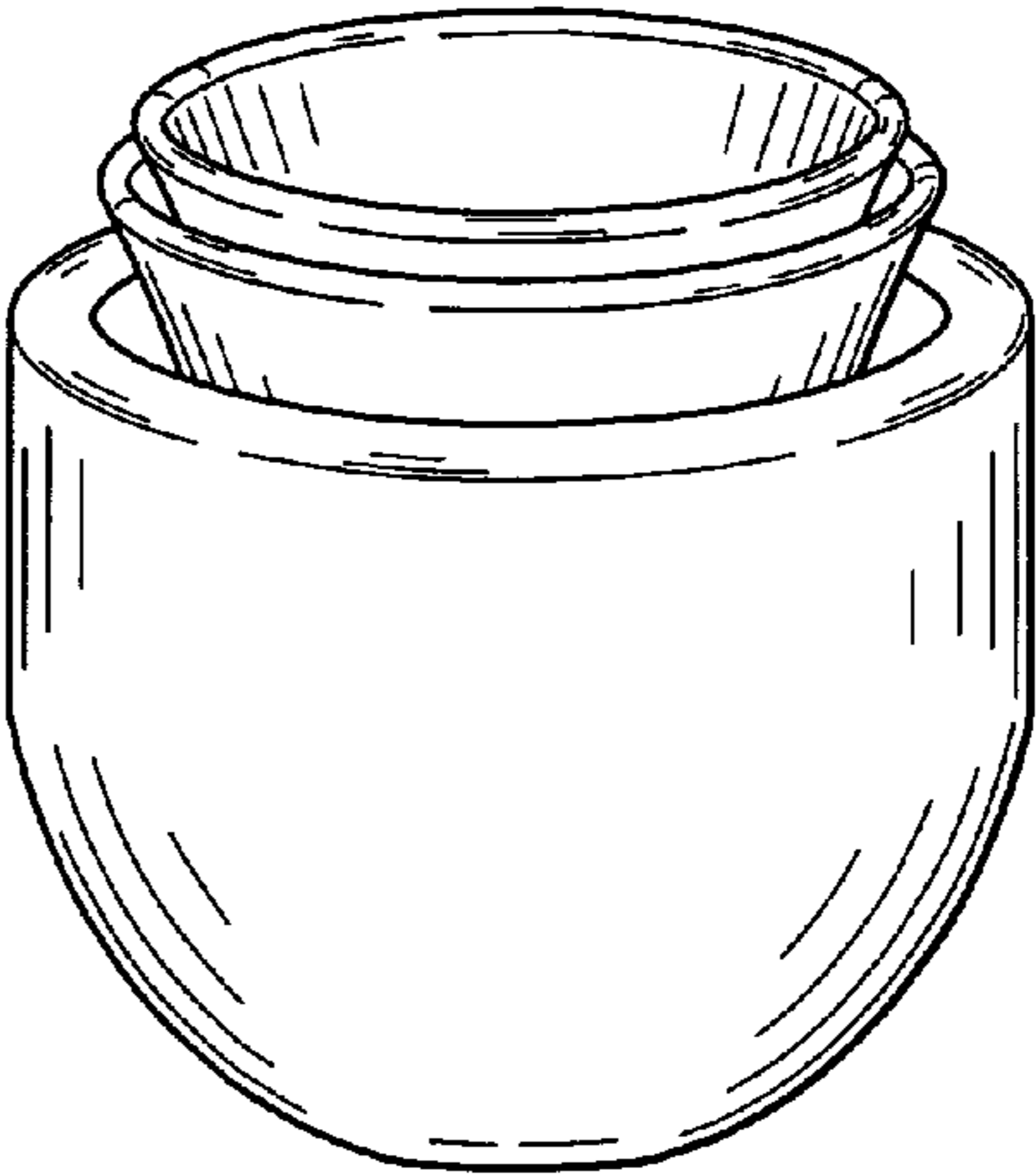
