(57) **CLAIM**

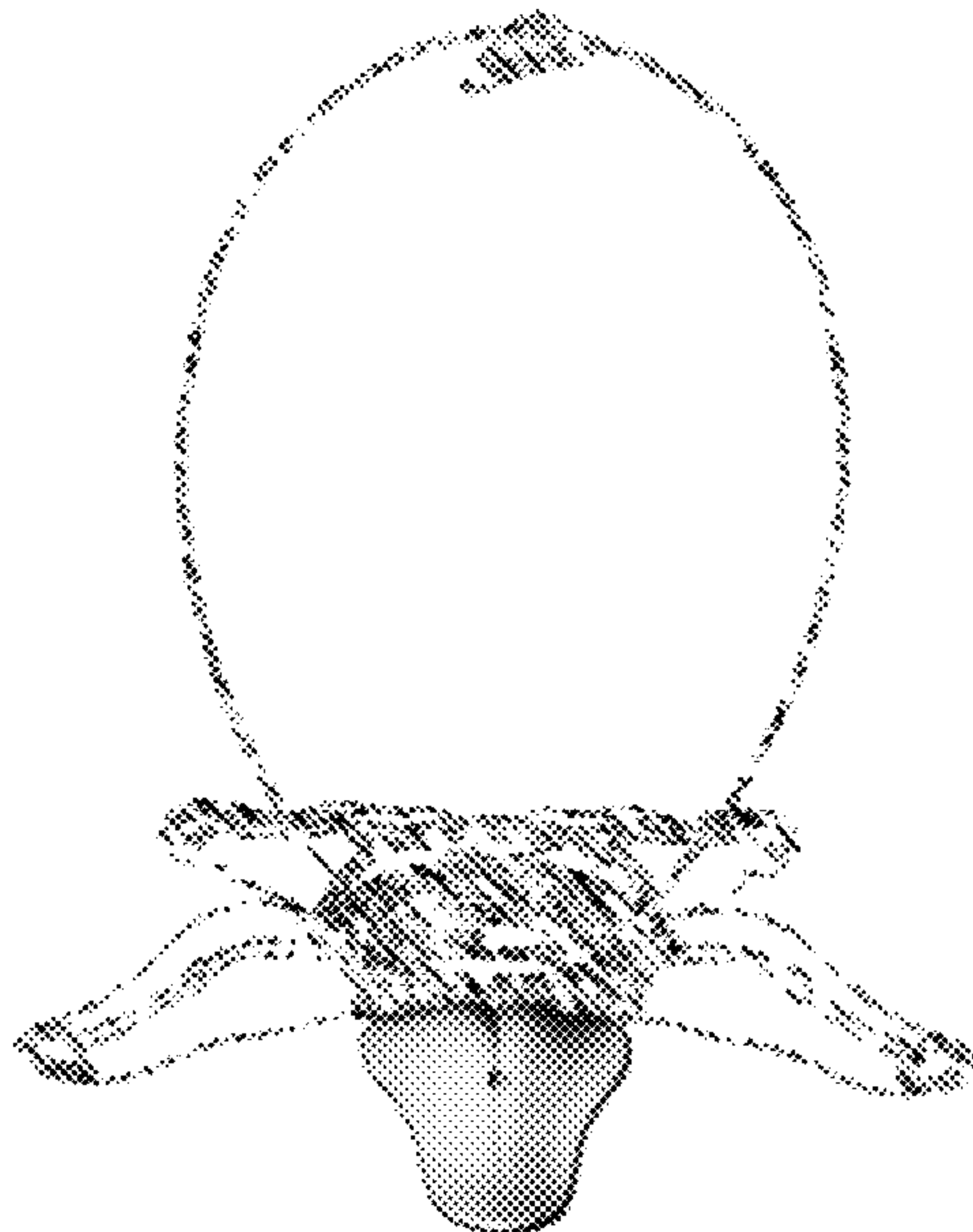
We claim the ornamental design for a hummingbird nectar feeder port in the form of a petal, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hummingbird nectar feeder port in the form of a petal according to our new design. FIG. 2 is a perspective view of the hummingbird feeder port illustrated in FIG. 1; FIG. 3 is a top elevation view of the hummingbird feeder port illustrated in FIG. 2; FIG. 4 is a bottom plan view of the hummingbird feeder port illustrated in FIG. 2; and, FIG. 5 is an end plan view of the hummingbird feeder port illustrated in FIG. 2.

The hummingbird nectar feeder shown in FIG. 1 depicted in broken lines forms no part of the claimed design. We disclaim any color shown in the drawings.

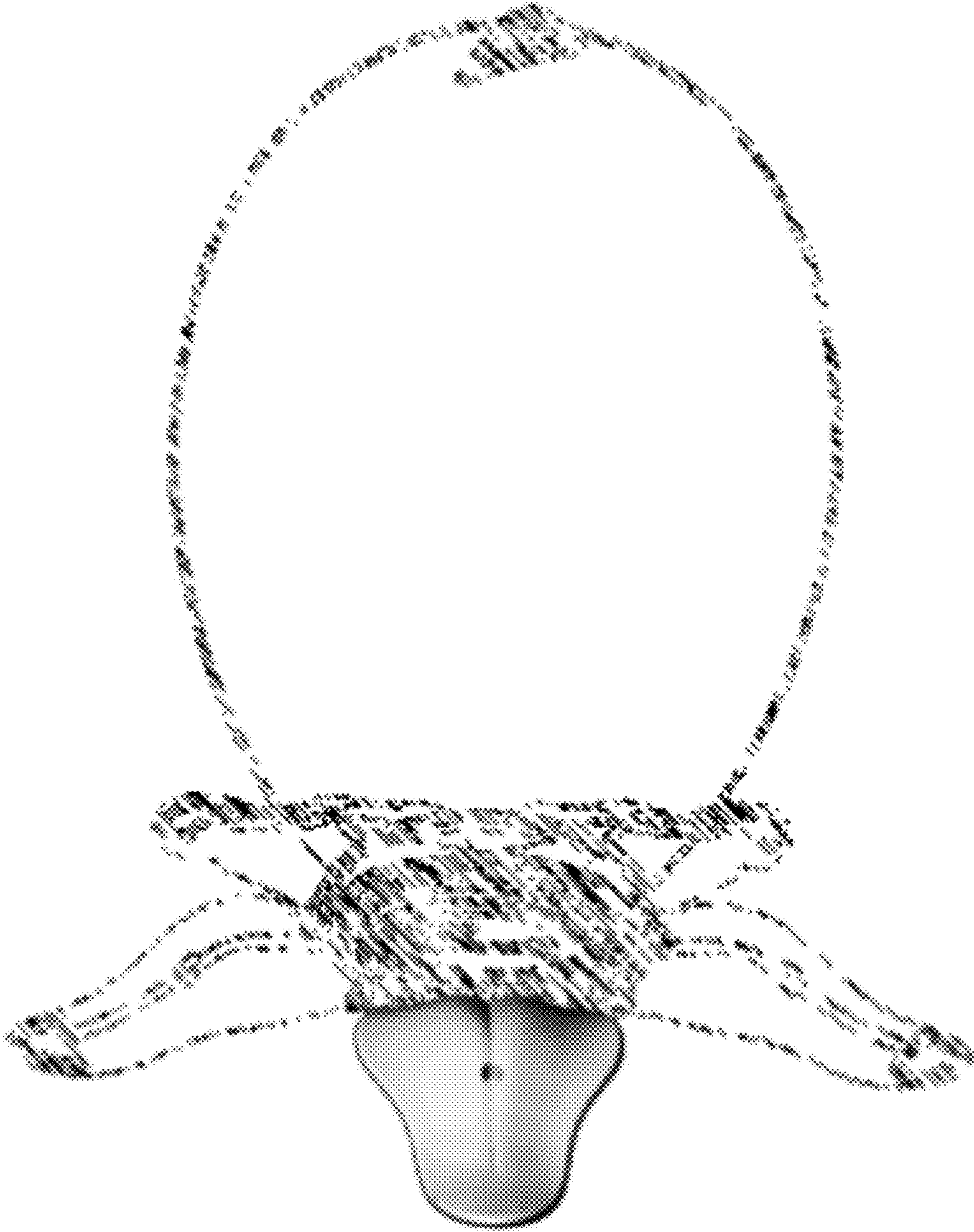

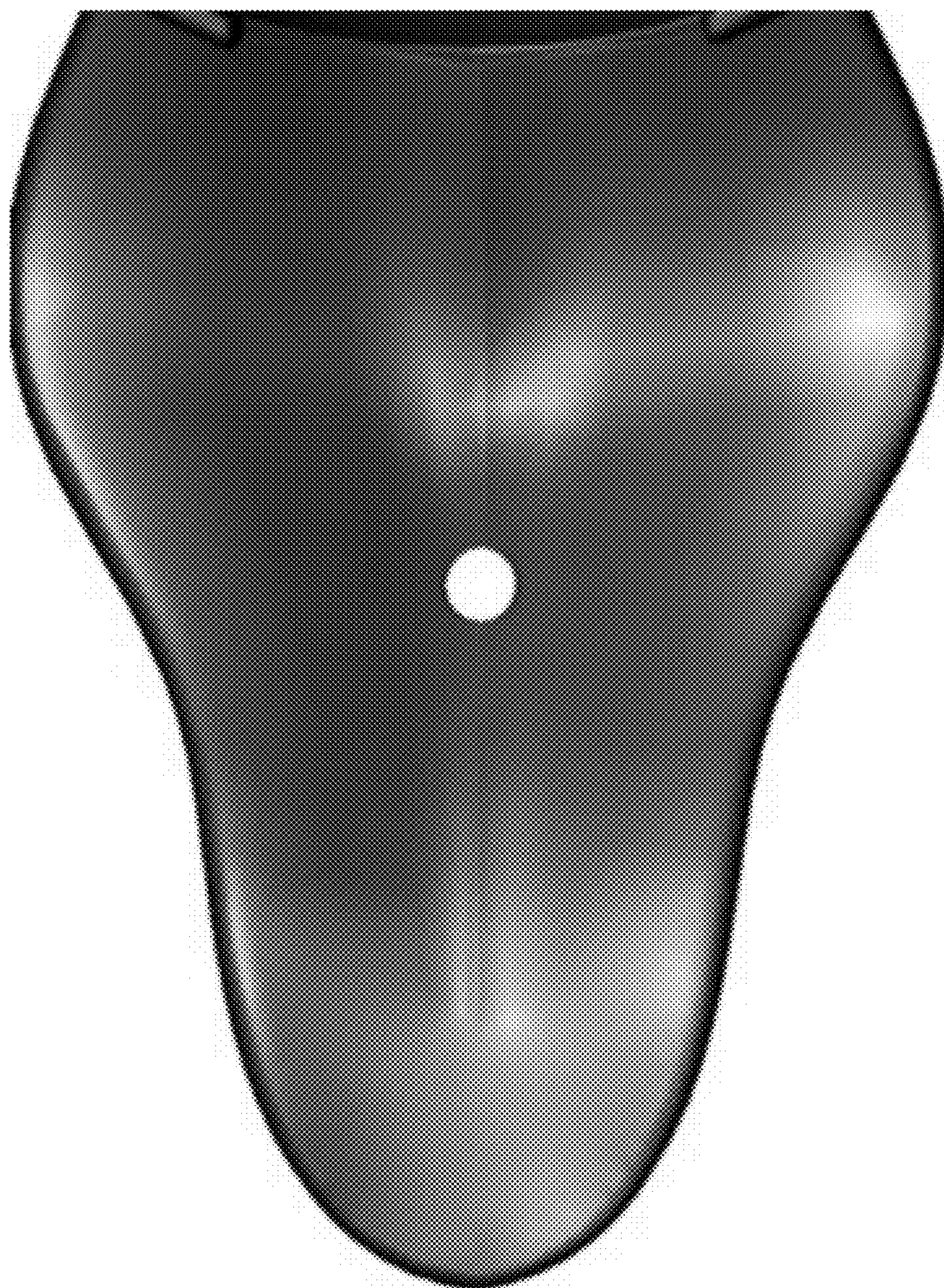

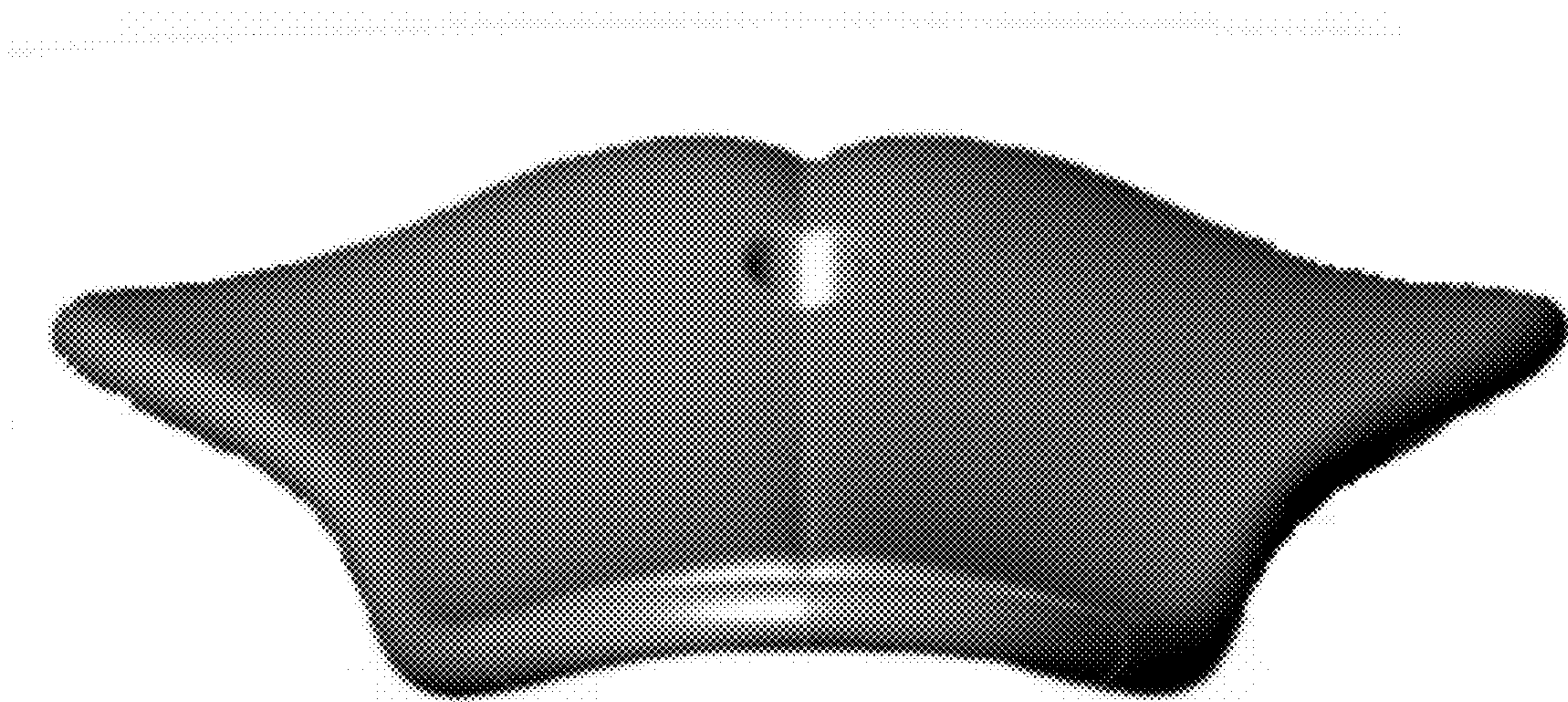
