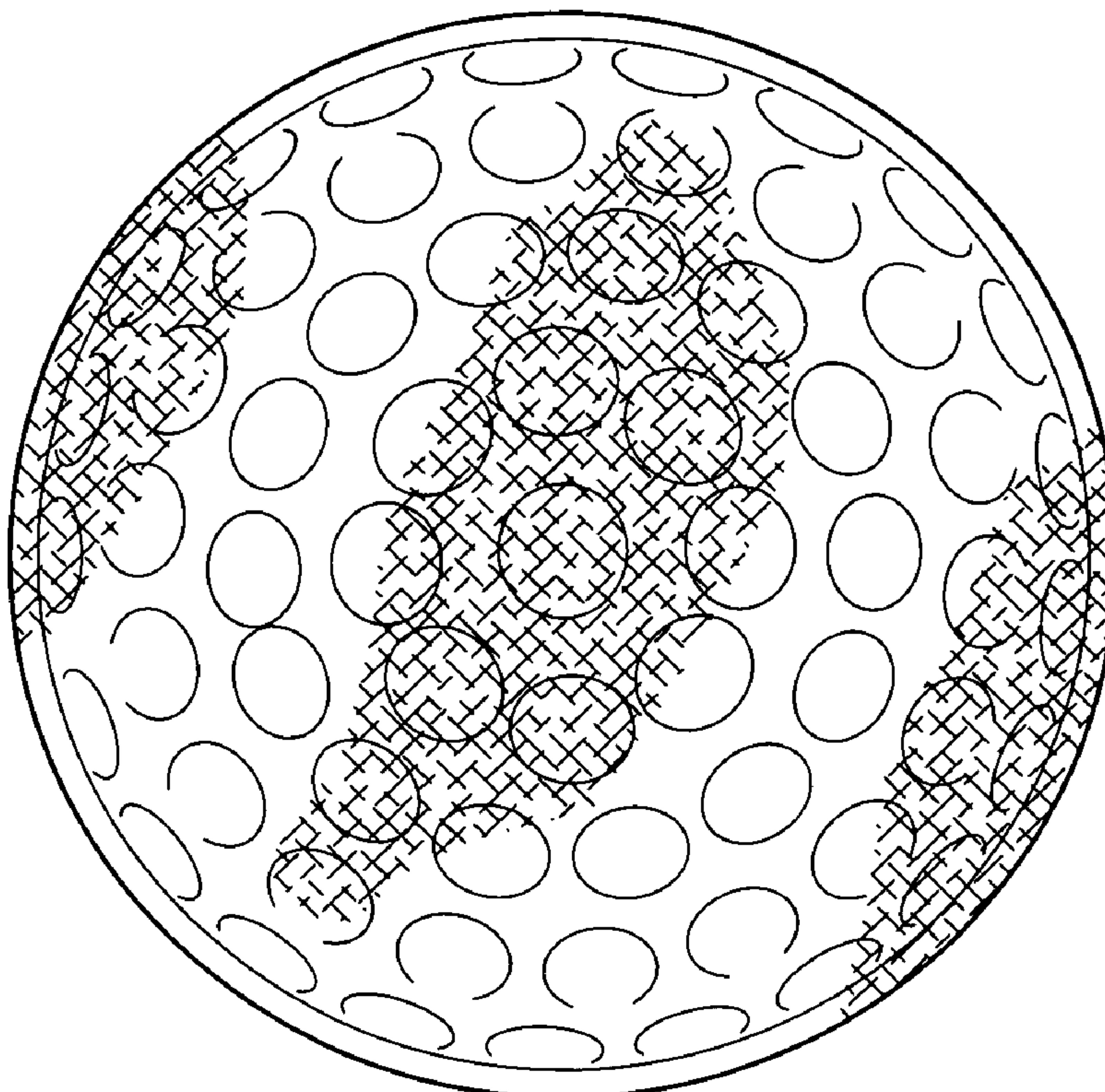
(57) **CLAIM**

The ornamental design for a removably adhesive microfiber screen cleaning cloth, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a removably adhesive microfiber screen cleaning cloth showing my new design; FIG. 2 is a right side elevation view of the embodiment of FIG. 1; FIG. 3 is a front elevation view thereof; and, FIG. 4 is a bottom plan view thereof.

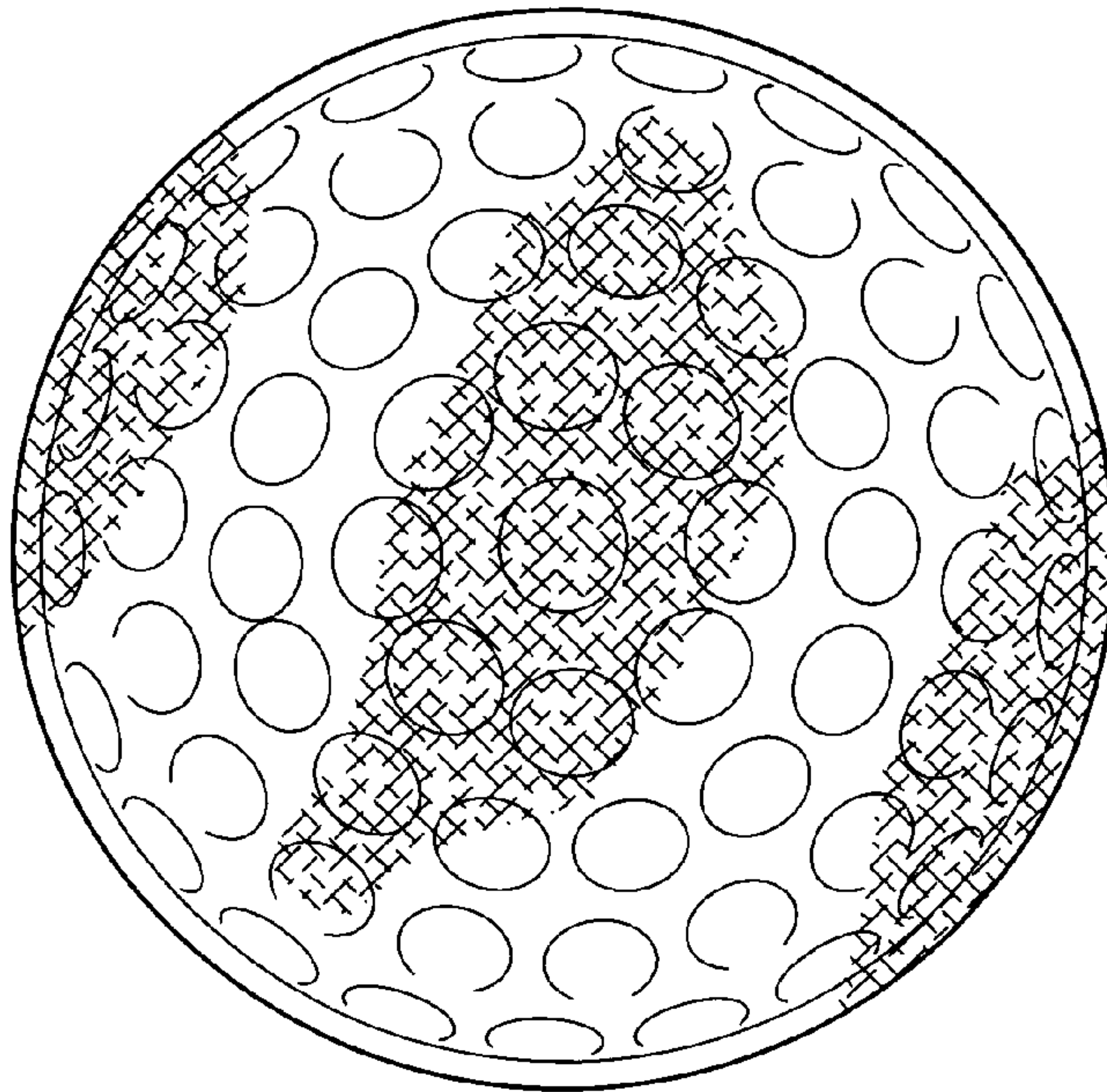

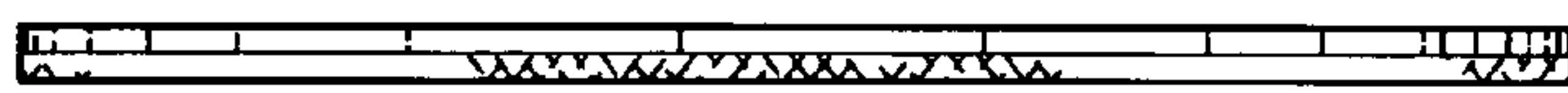

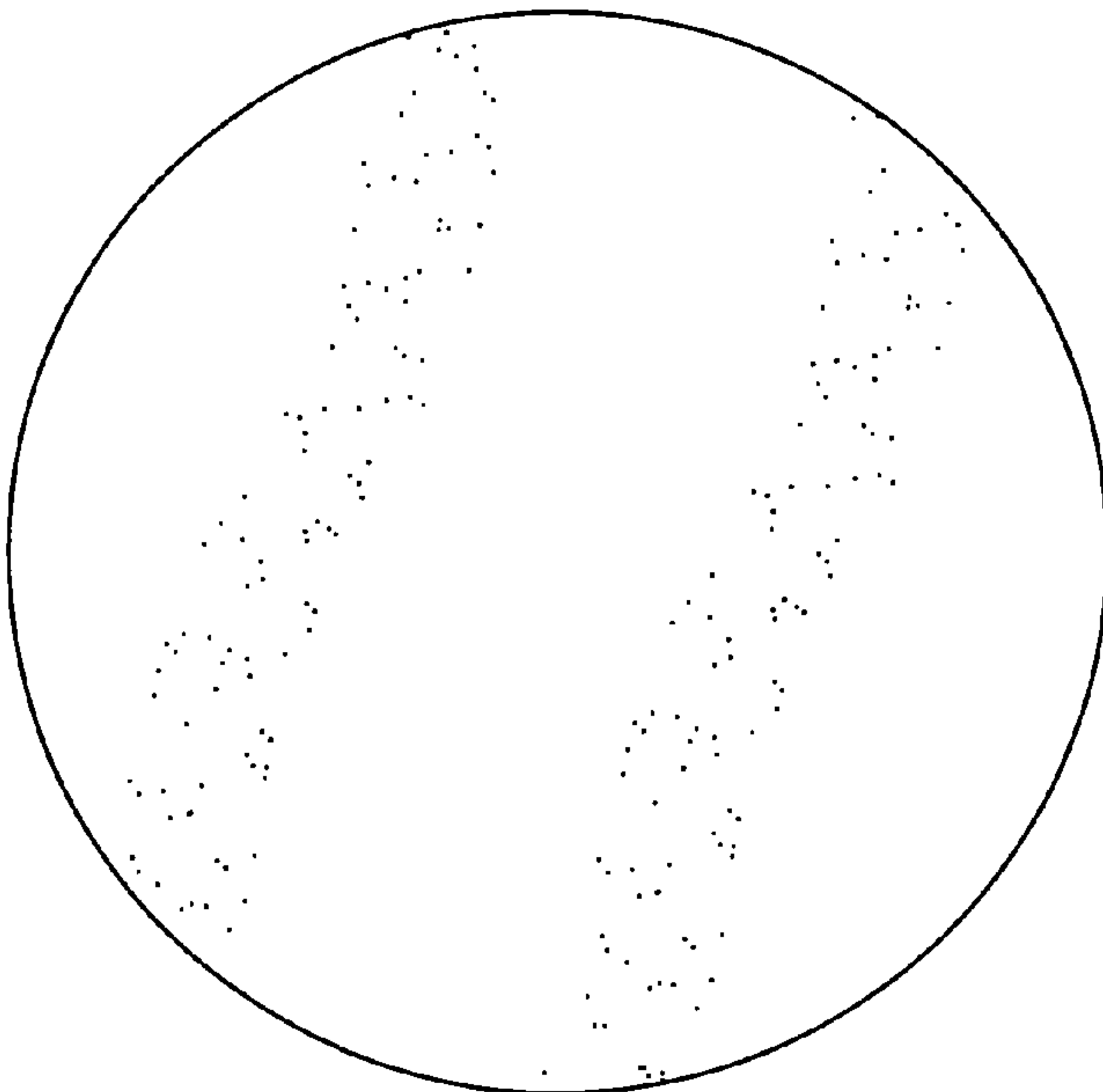
